(57) **CLAIM**

The ornamental design for a cigarette lighter holder with clip,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective top front view of the cigarette lighter holder with clip, showing our new design; FIG. 2 is a perspective bottom front view thereof; FIG. 3 is a front side view thereof; FIG. 4 is a back side view thereof; FIG. 5 is a right side view with the left side view being a mirror image thereof; FIG. 6 is a top side view thereof; and, FIG. 7 is a bottom side view thereof. The dashed lines are intended to show boundary areas and form no part of the claimed design.

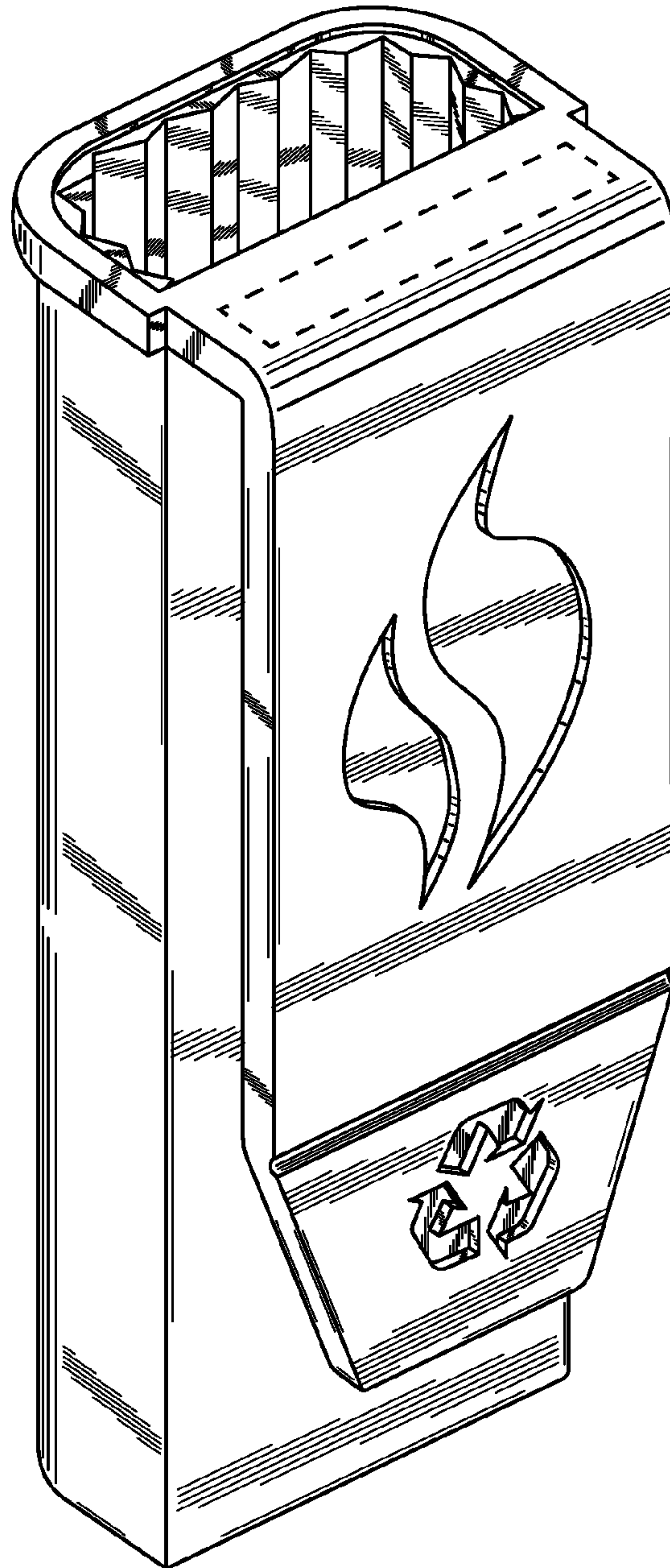

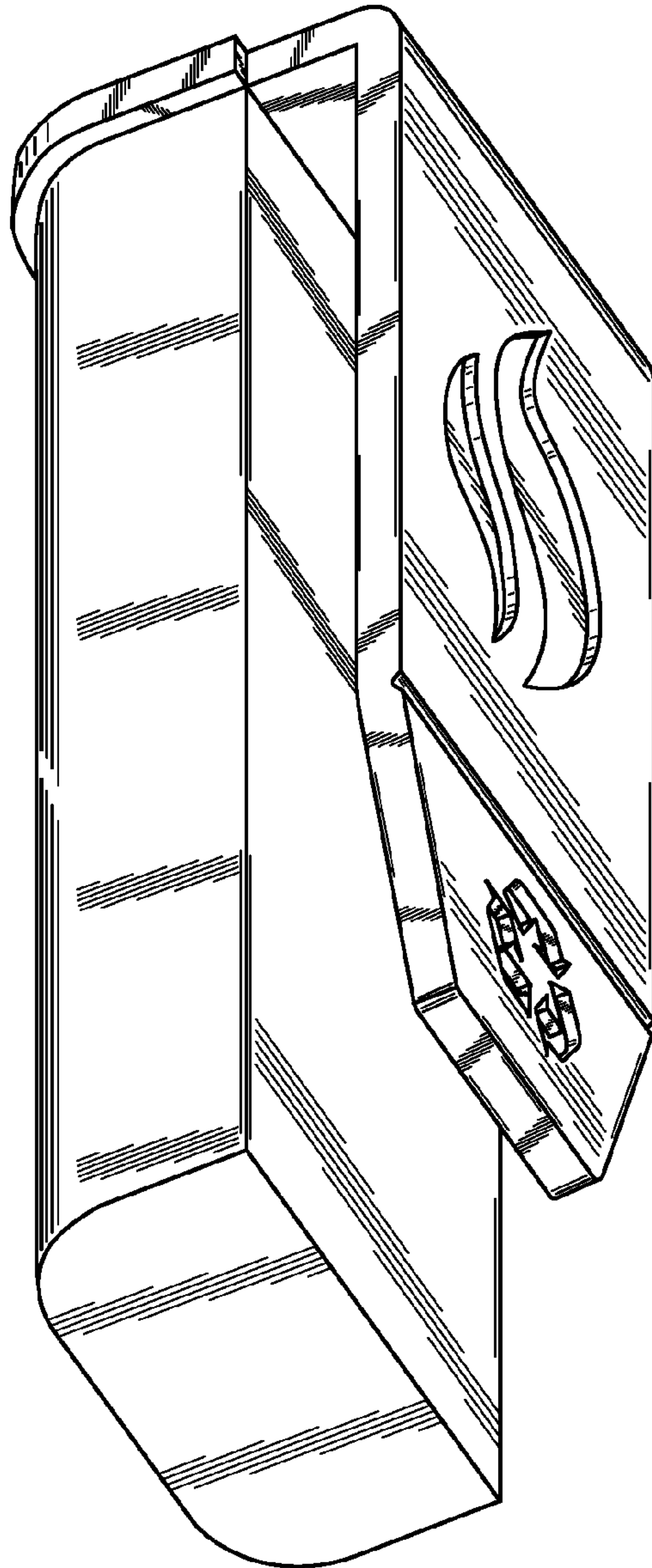

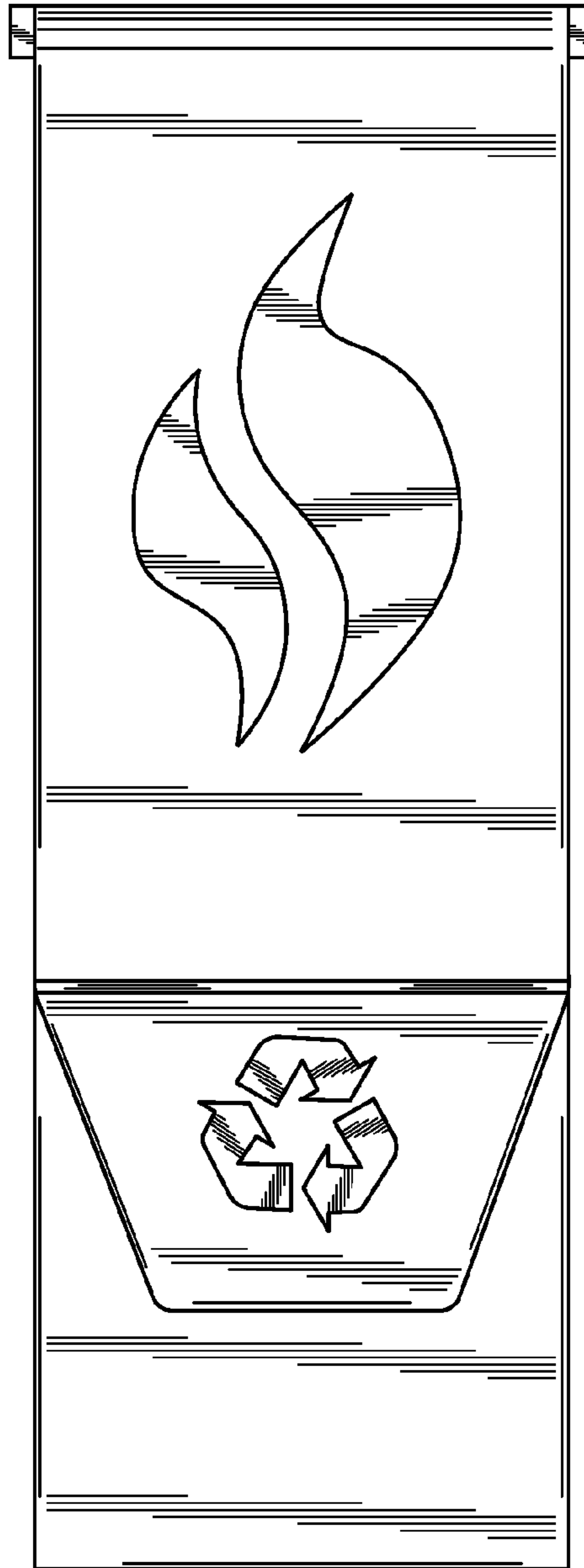

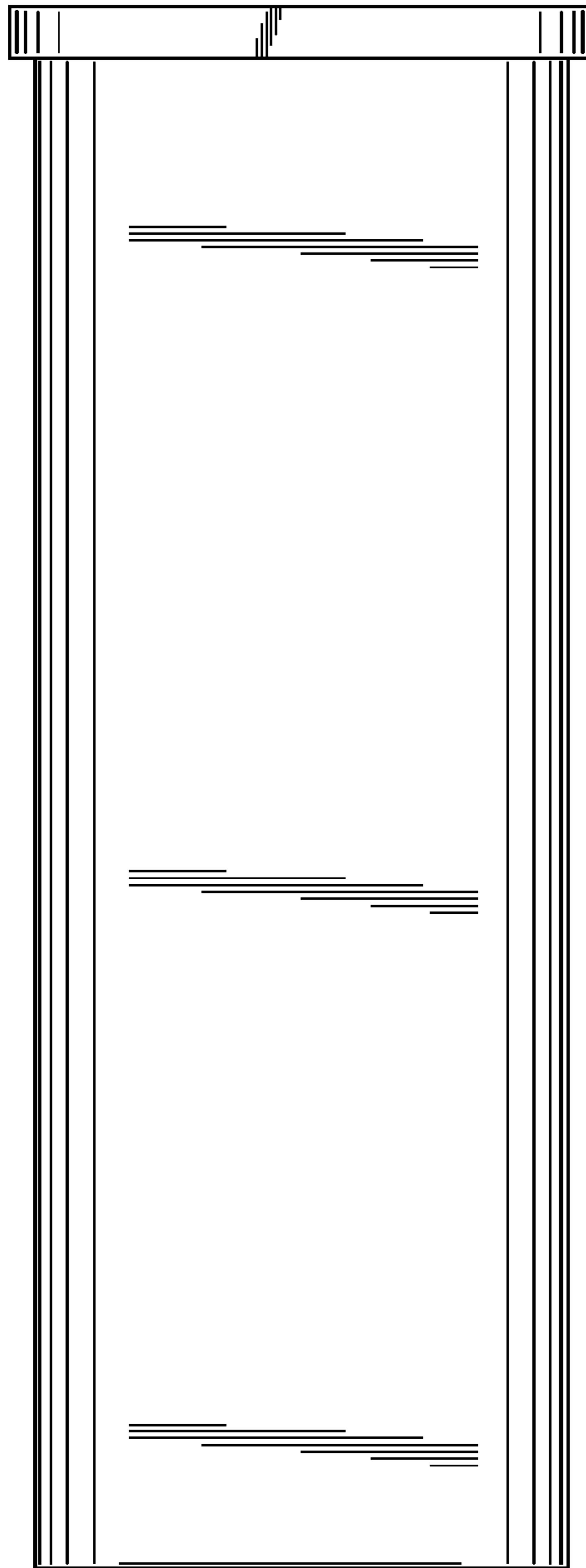

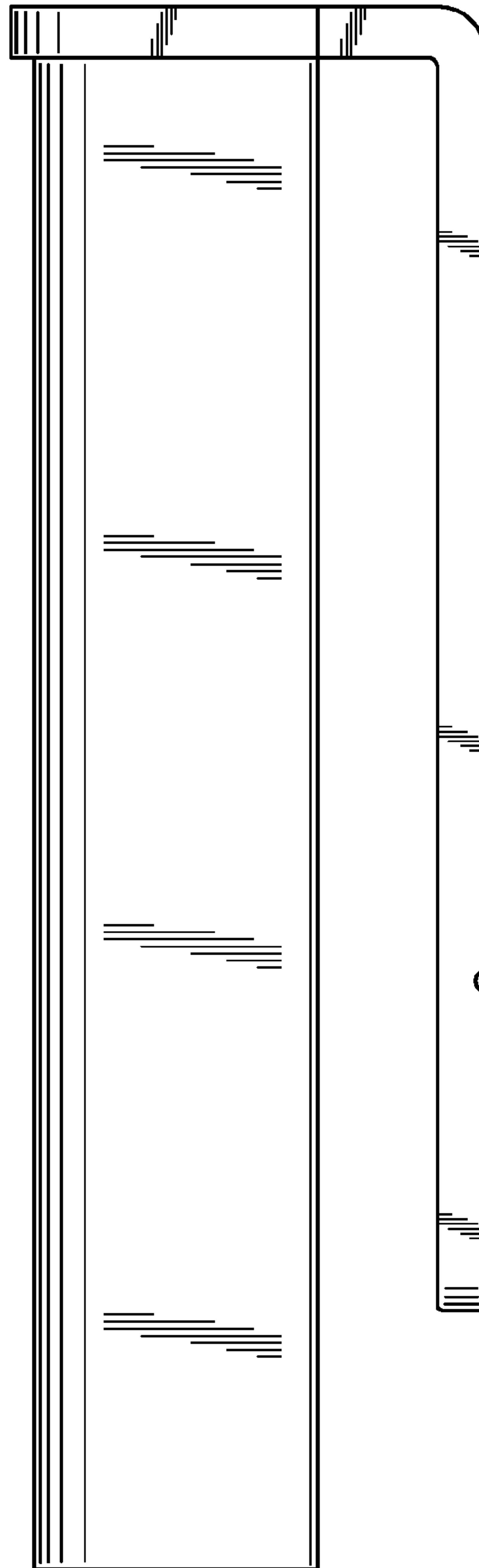

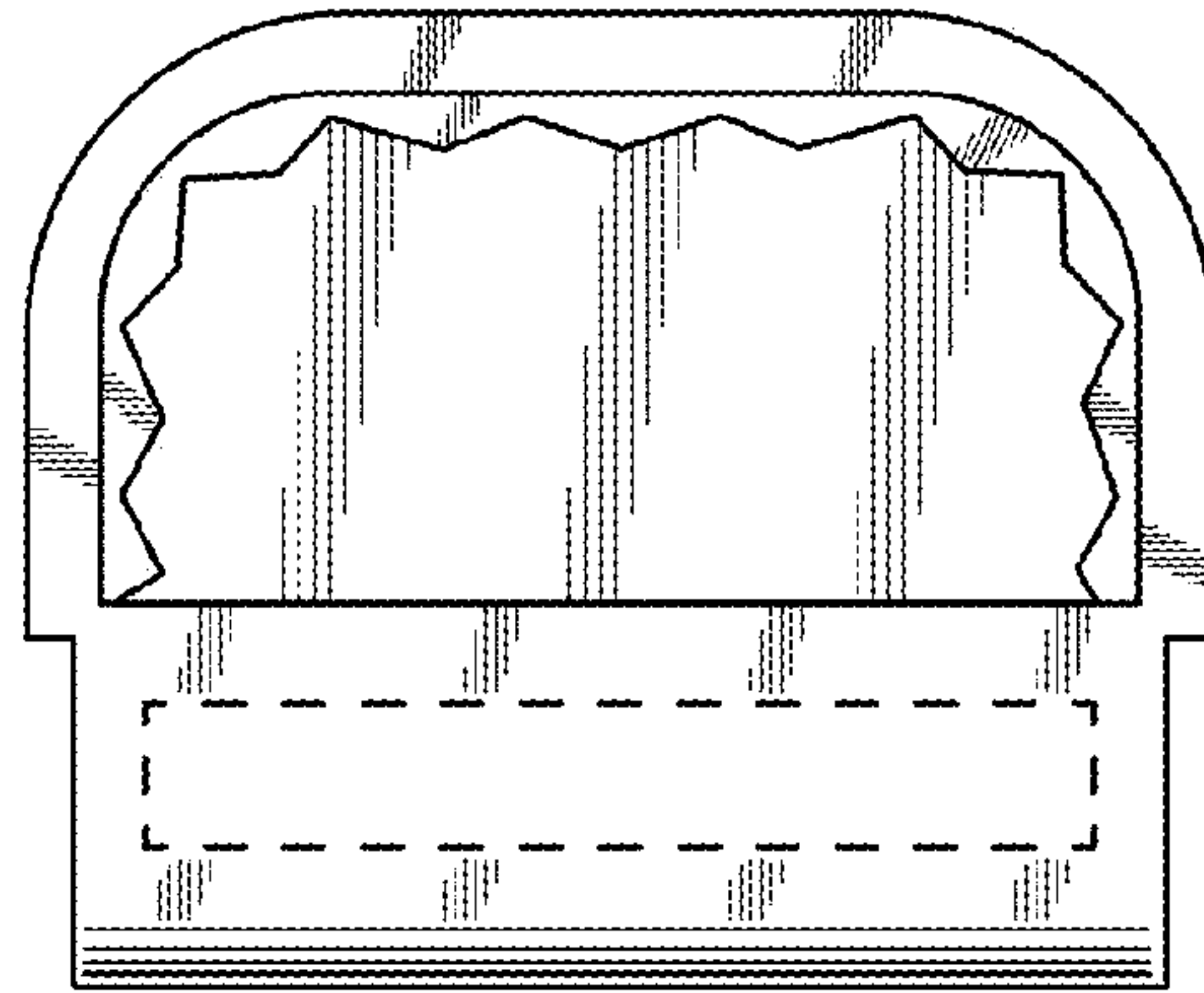

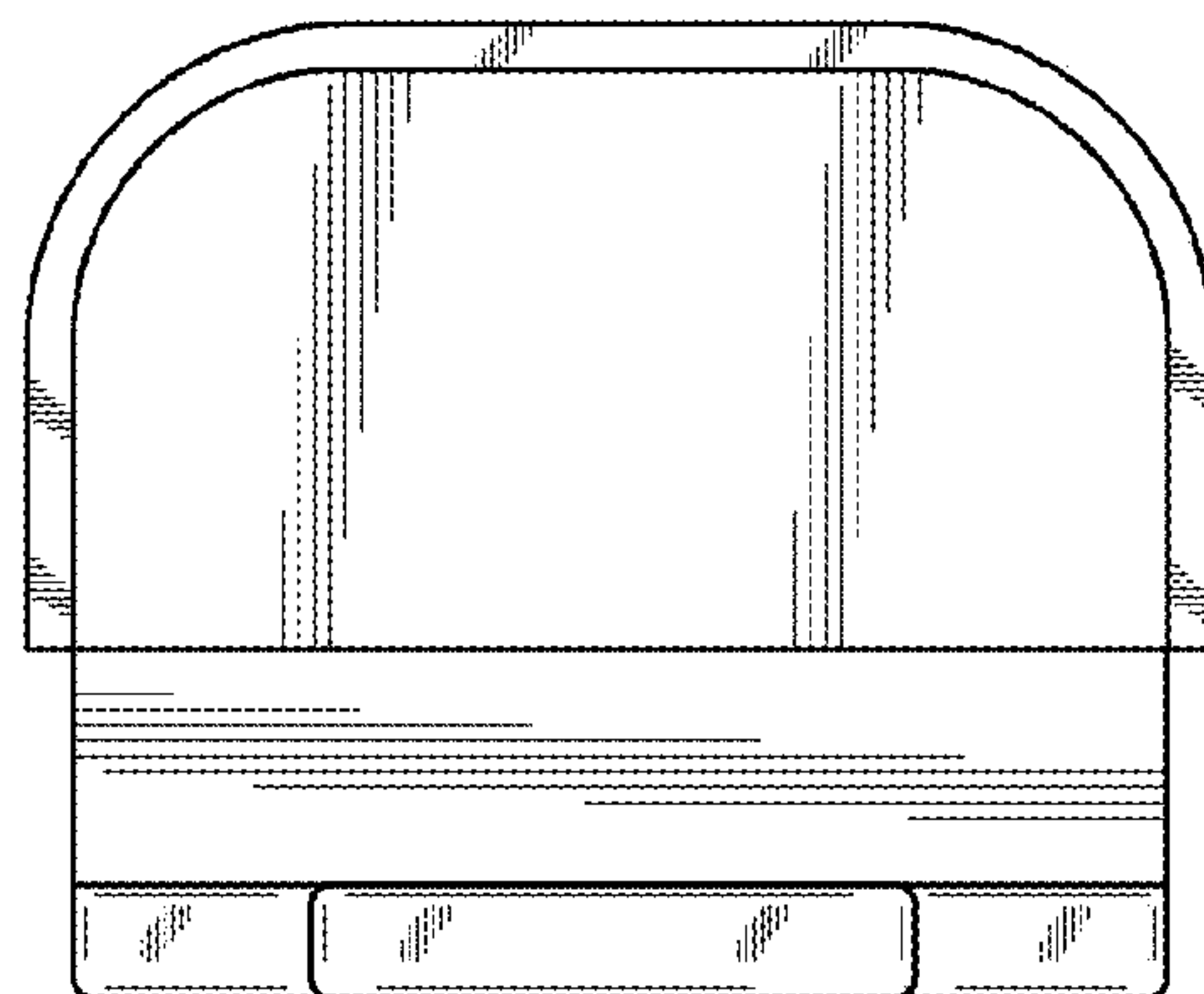
