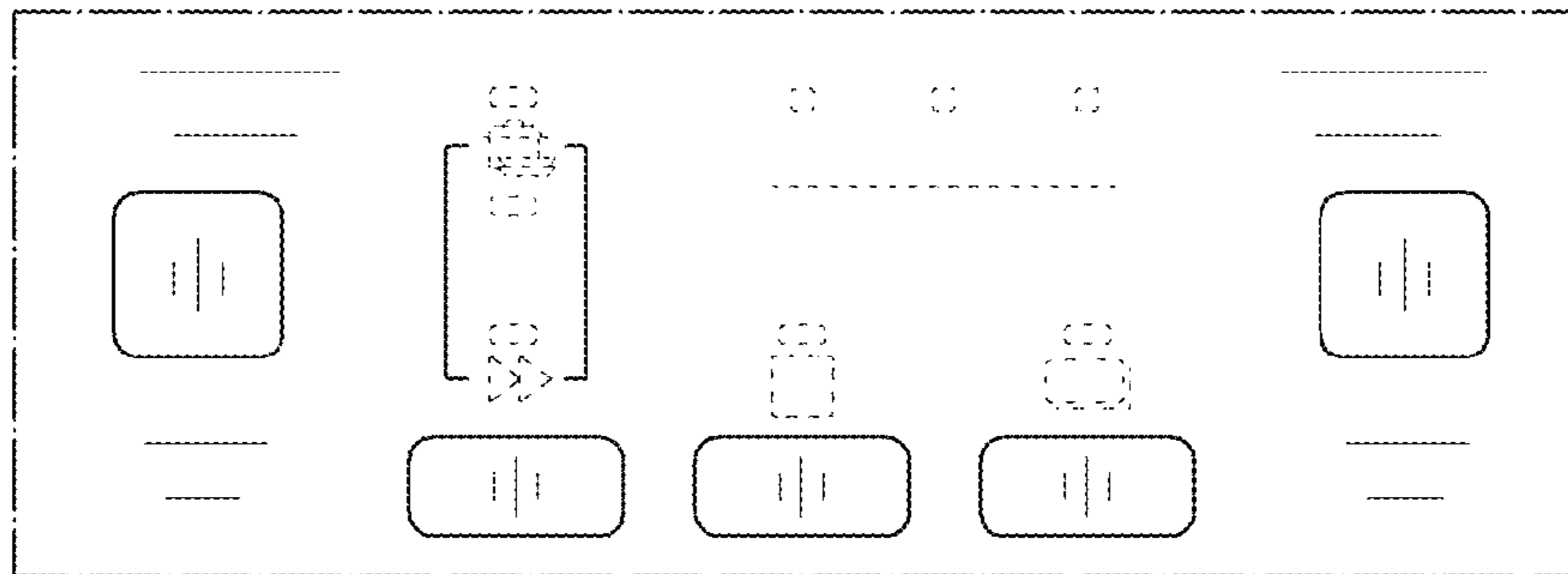
(57) **CLAIM**

The ornamental design for a dishwasher, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a dishwasher, showing our new design;  
FIG. 2 is a front view thereof;

FIG. 5 is a another side view thereof;

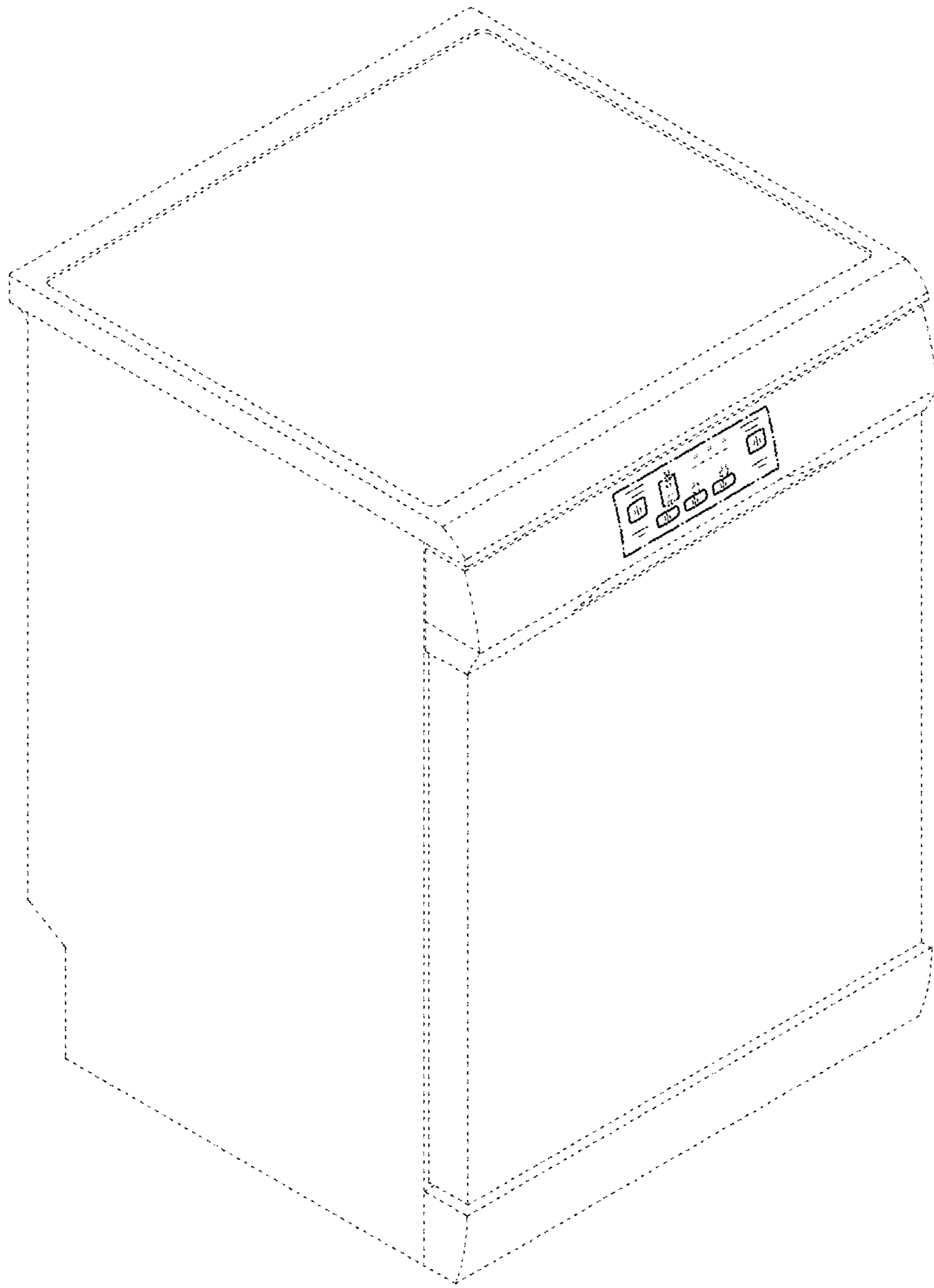

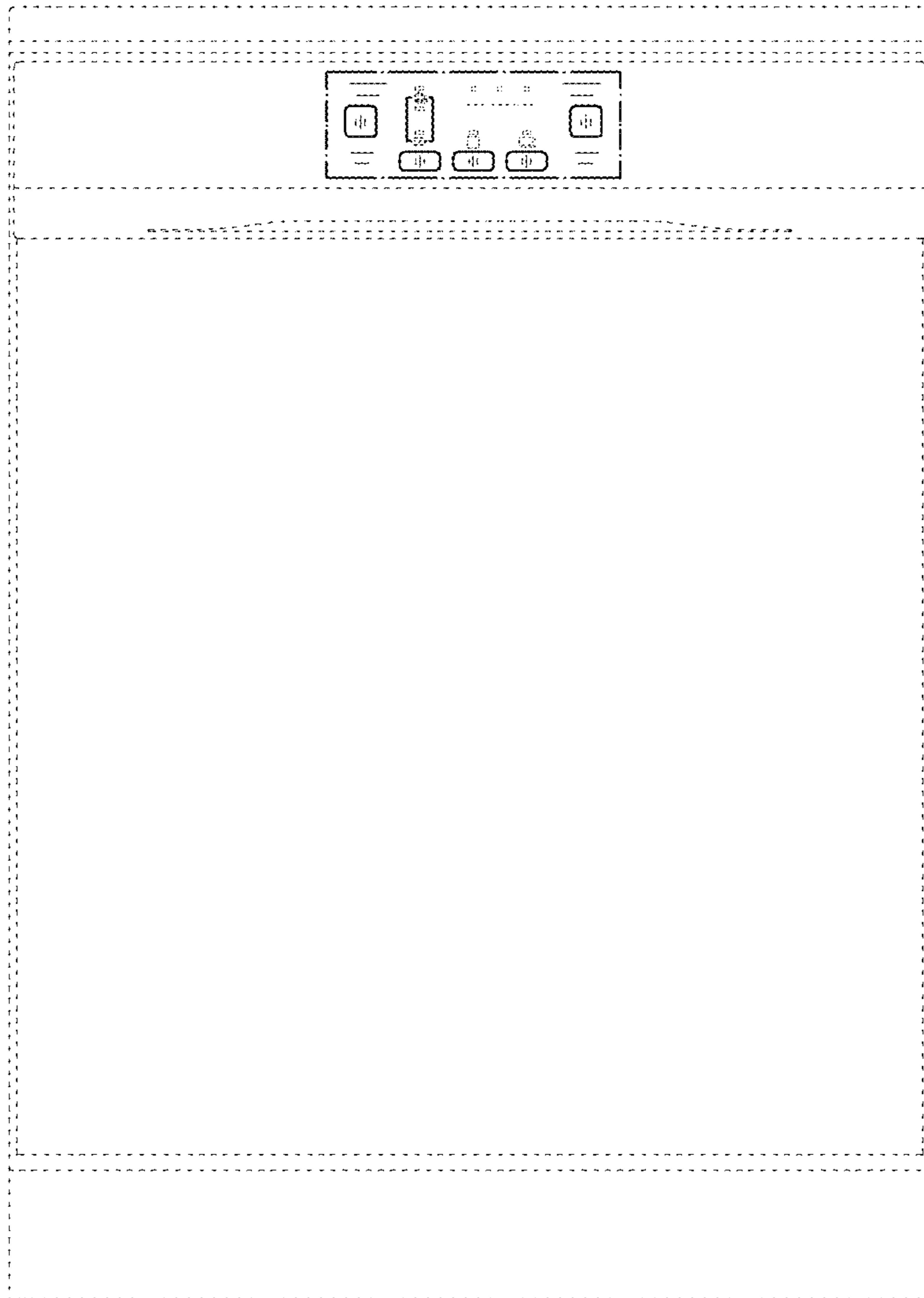

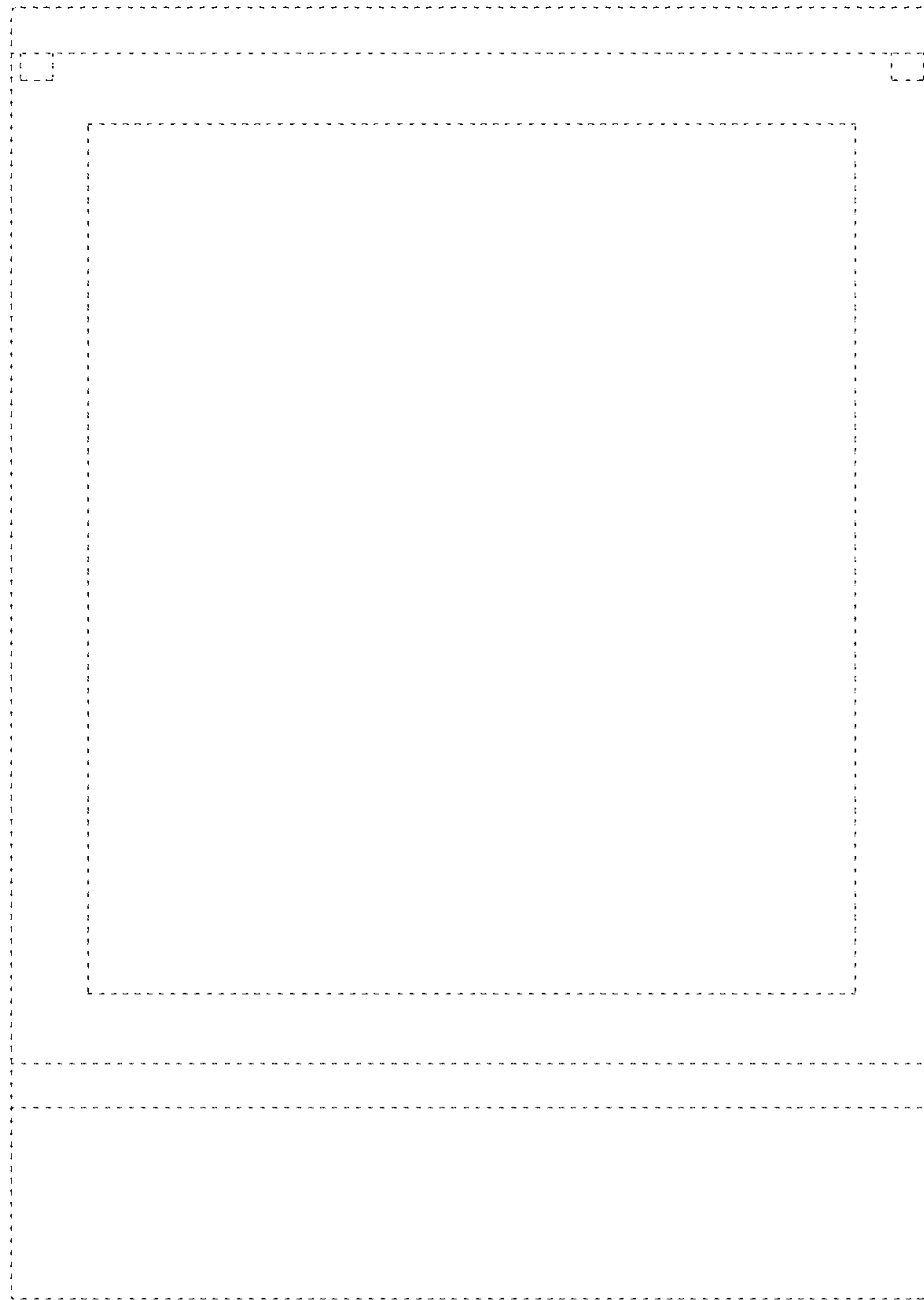

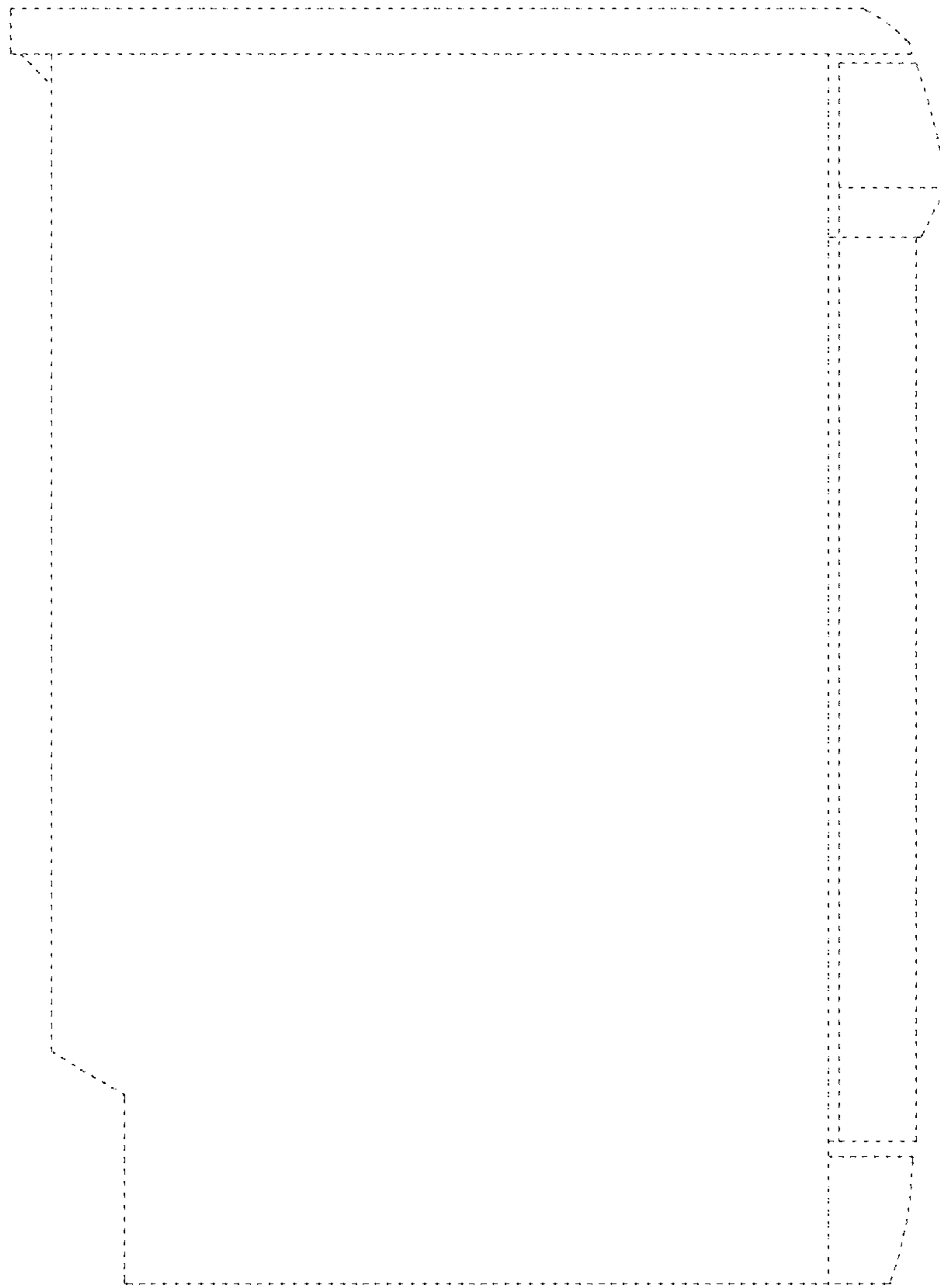

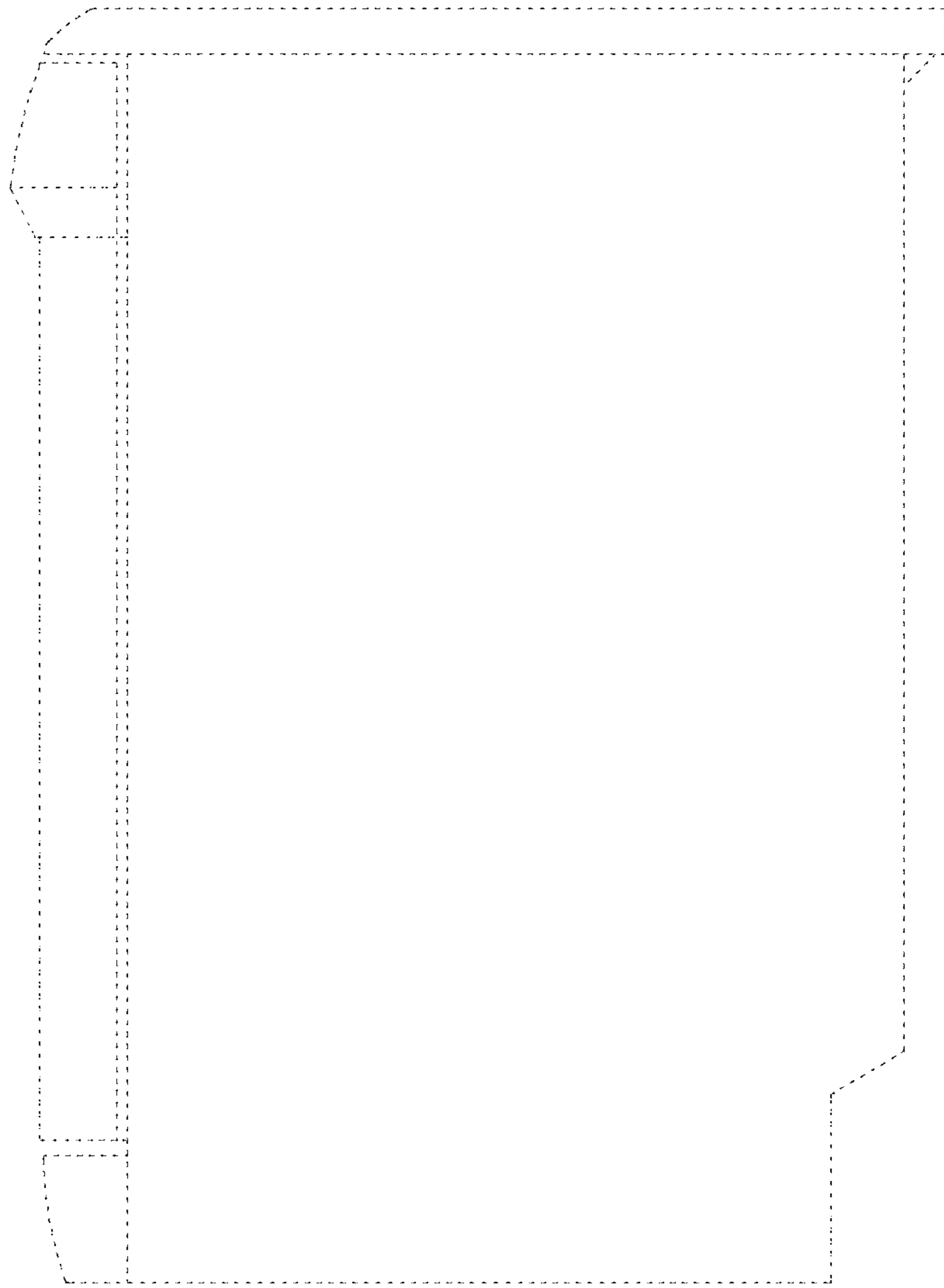

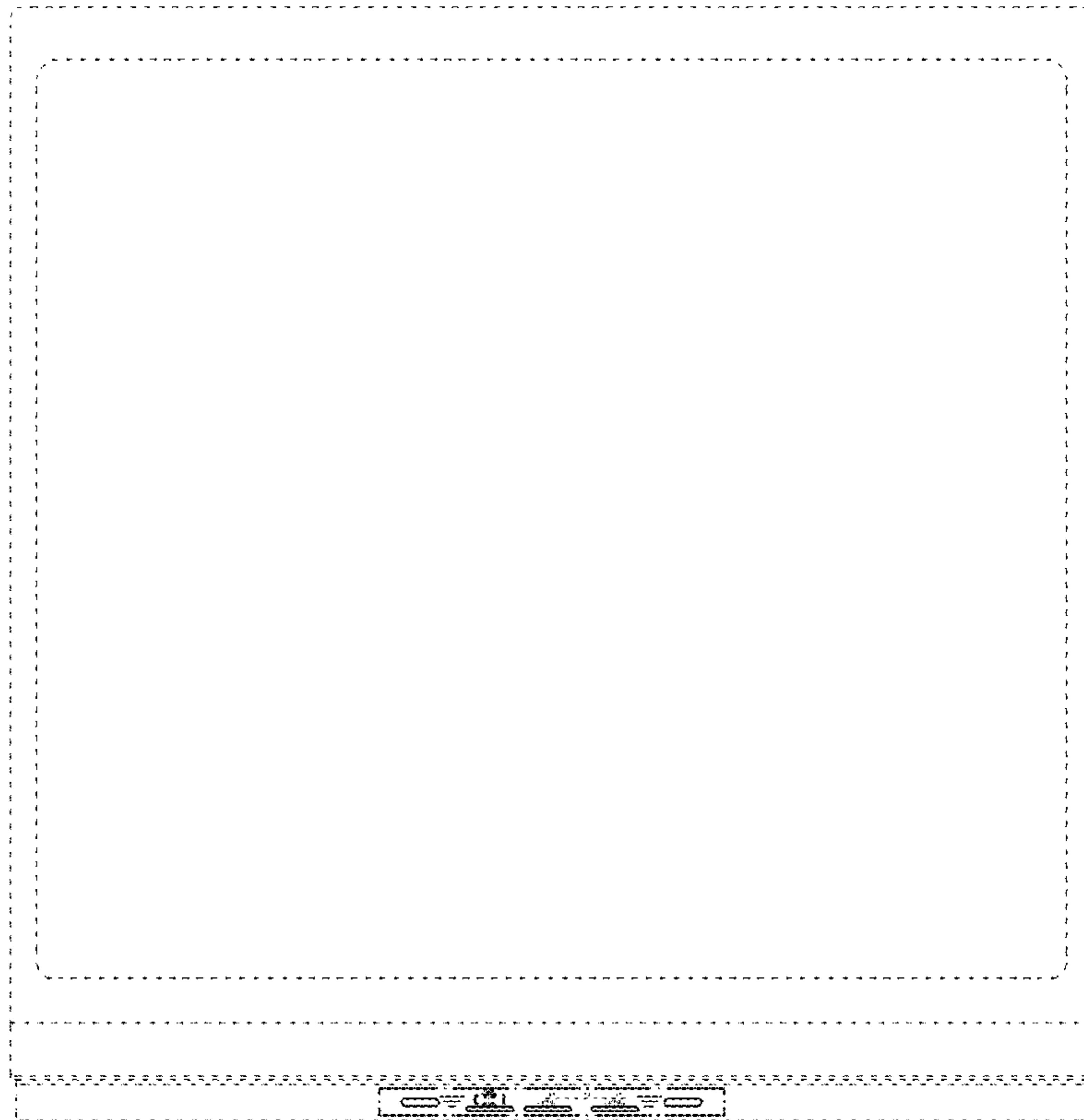

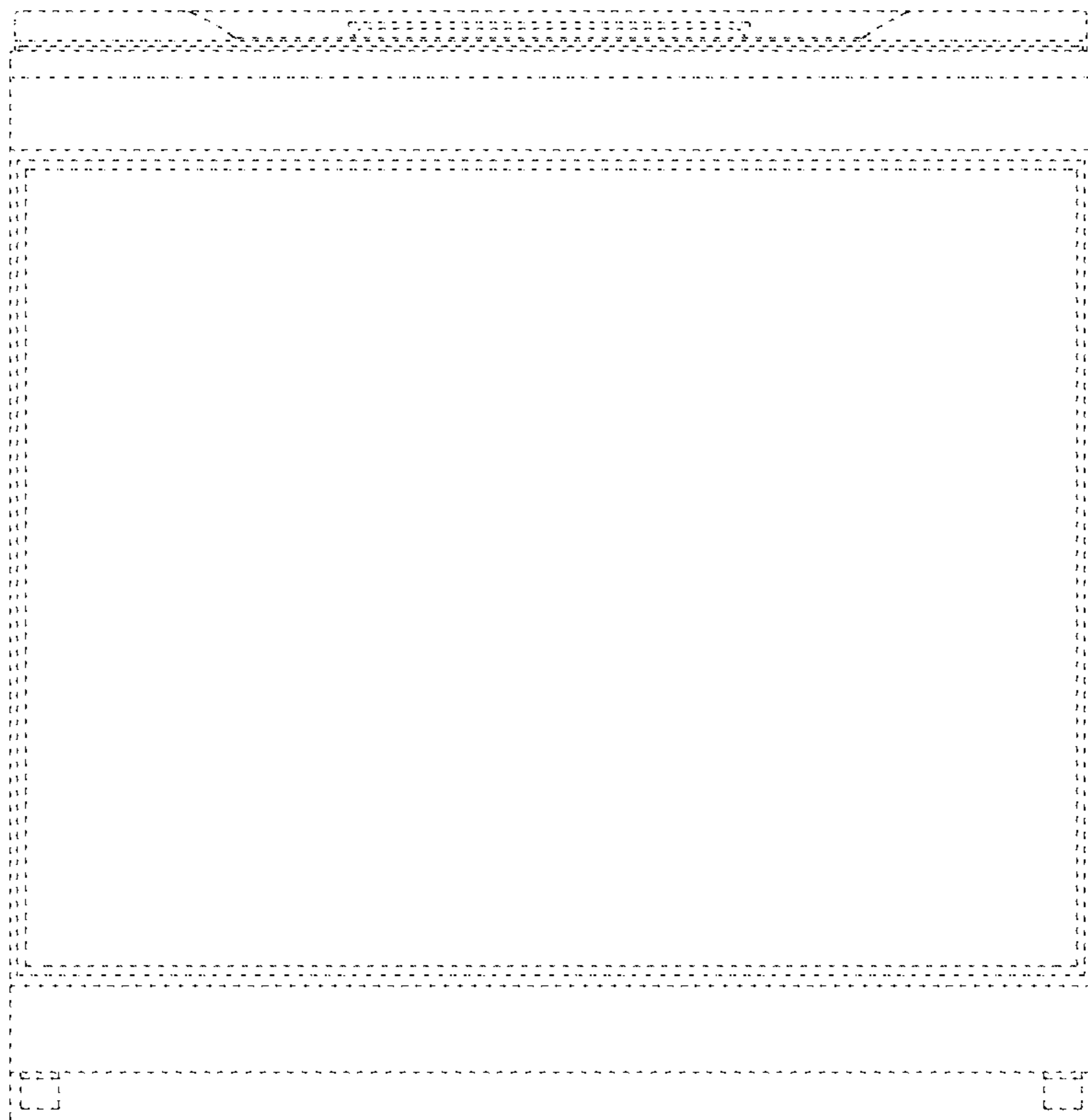
