 FIG. 20 is a bottom plan view thereof.

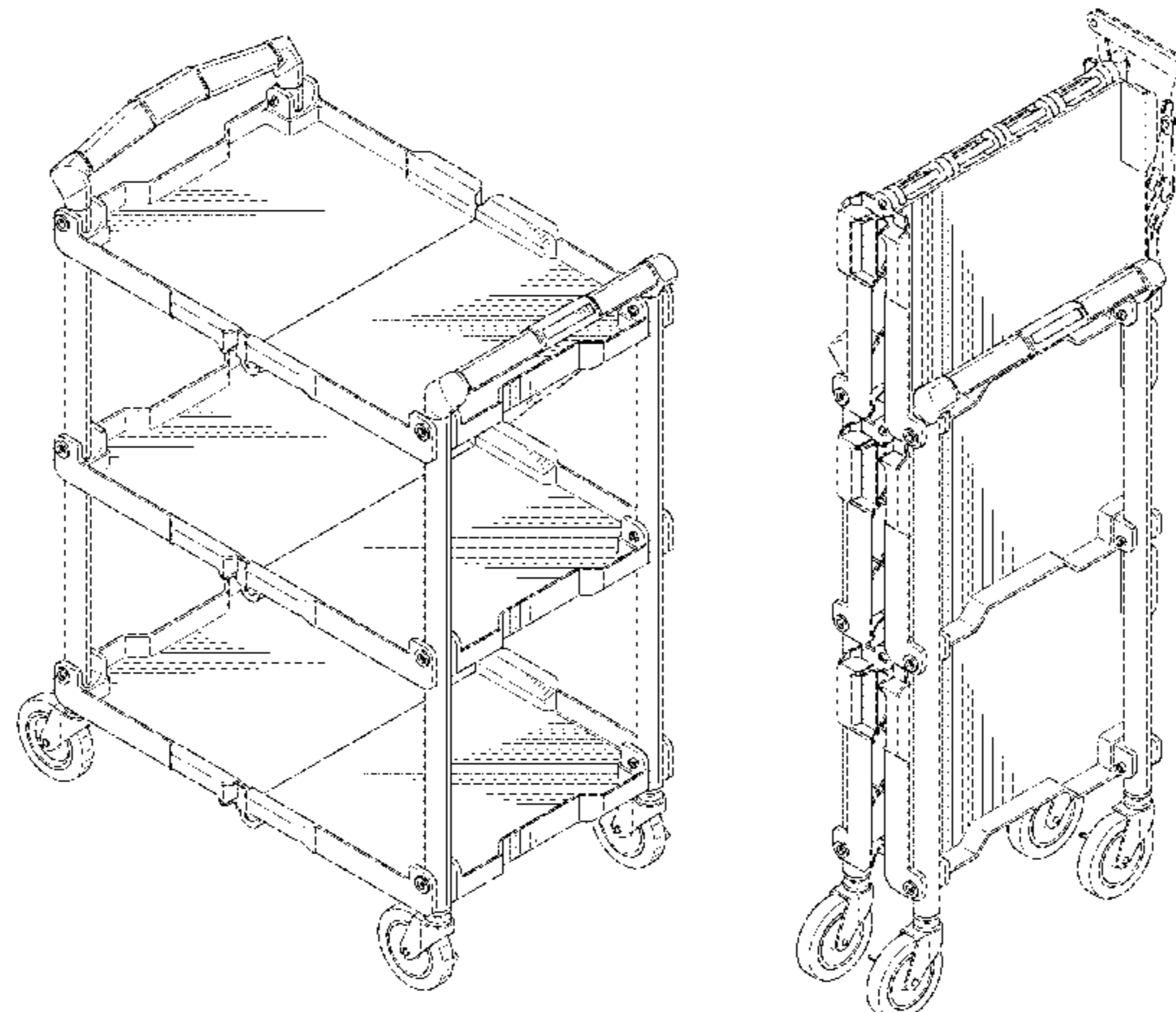

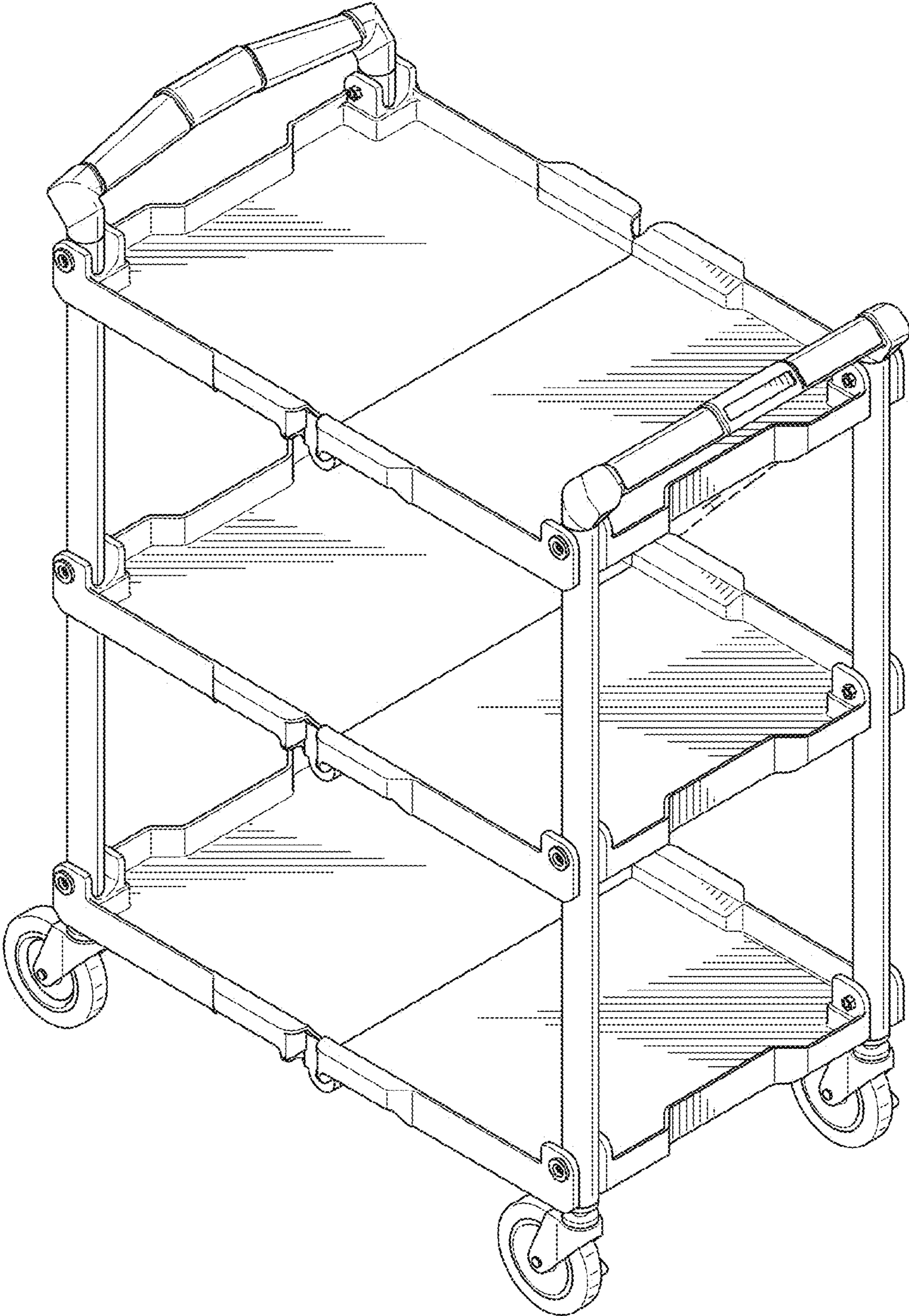

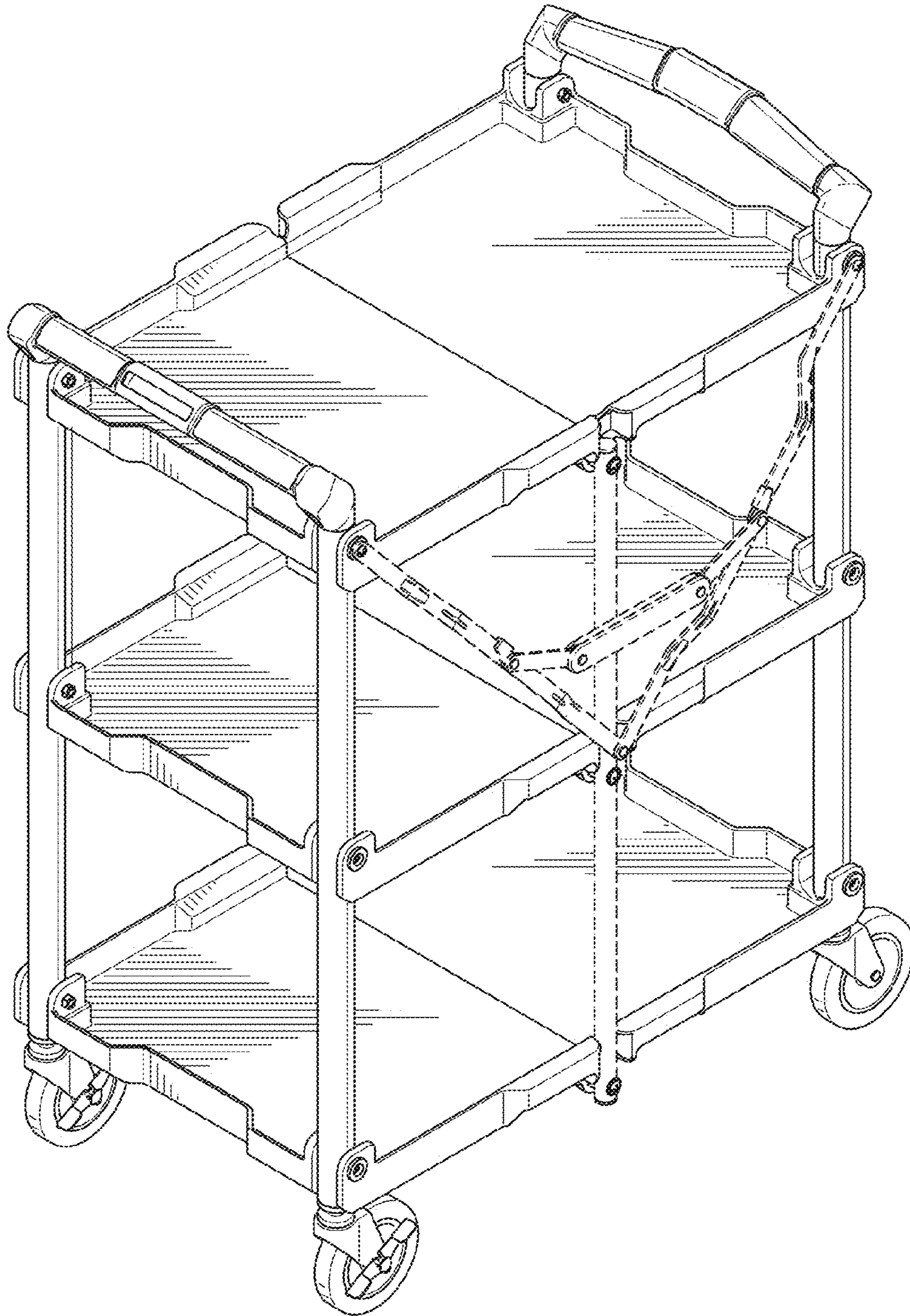

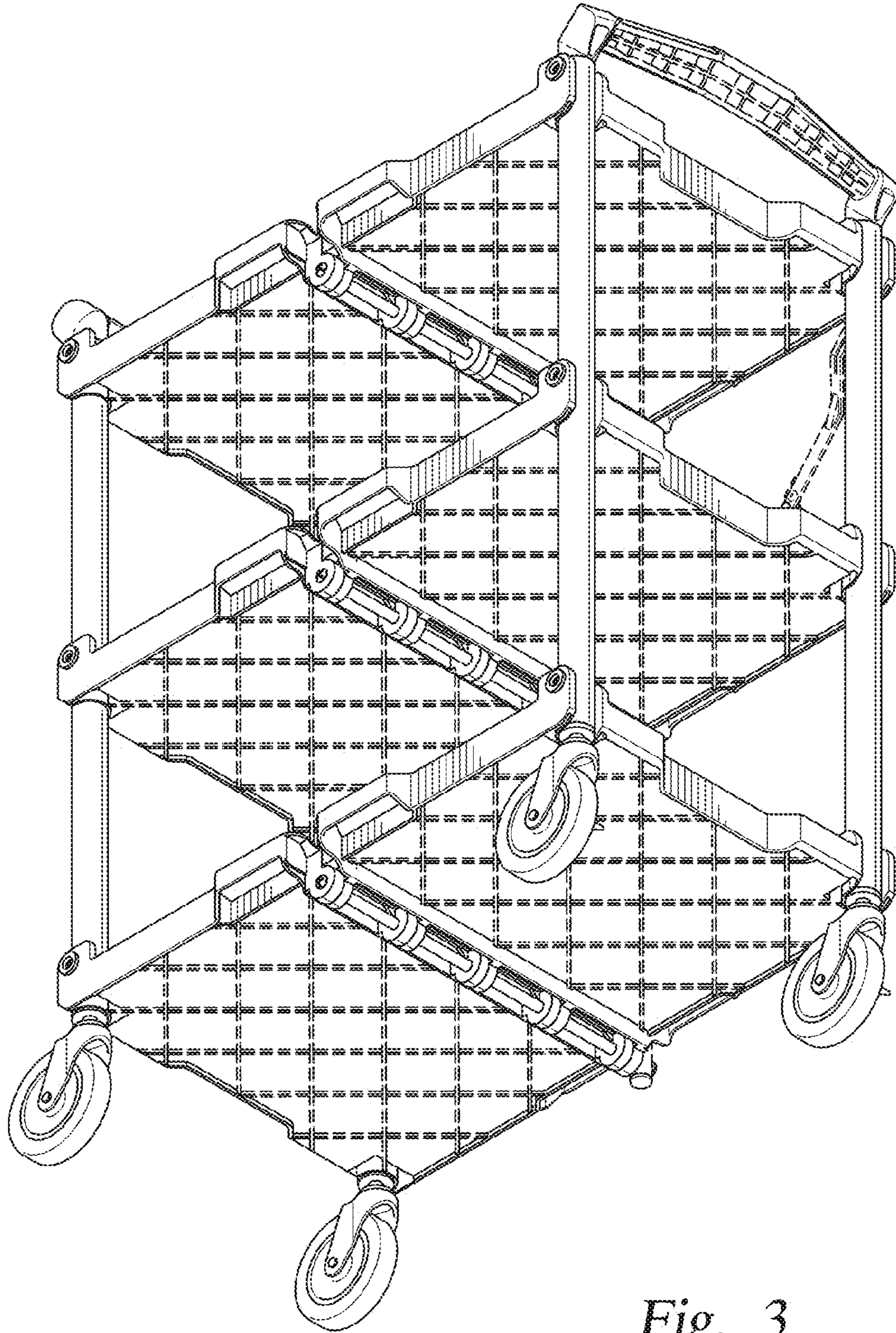

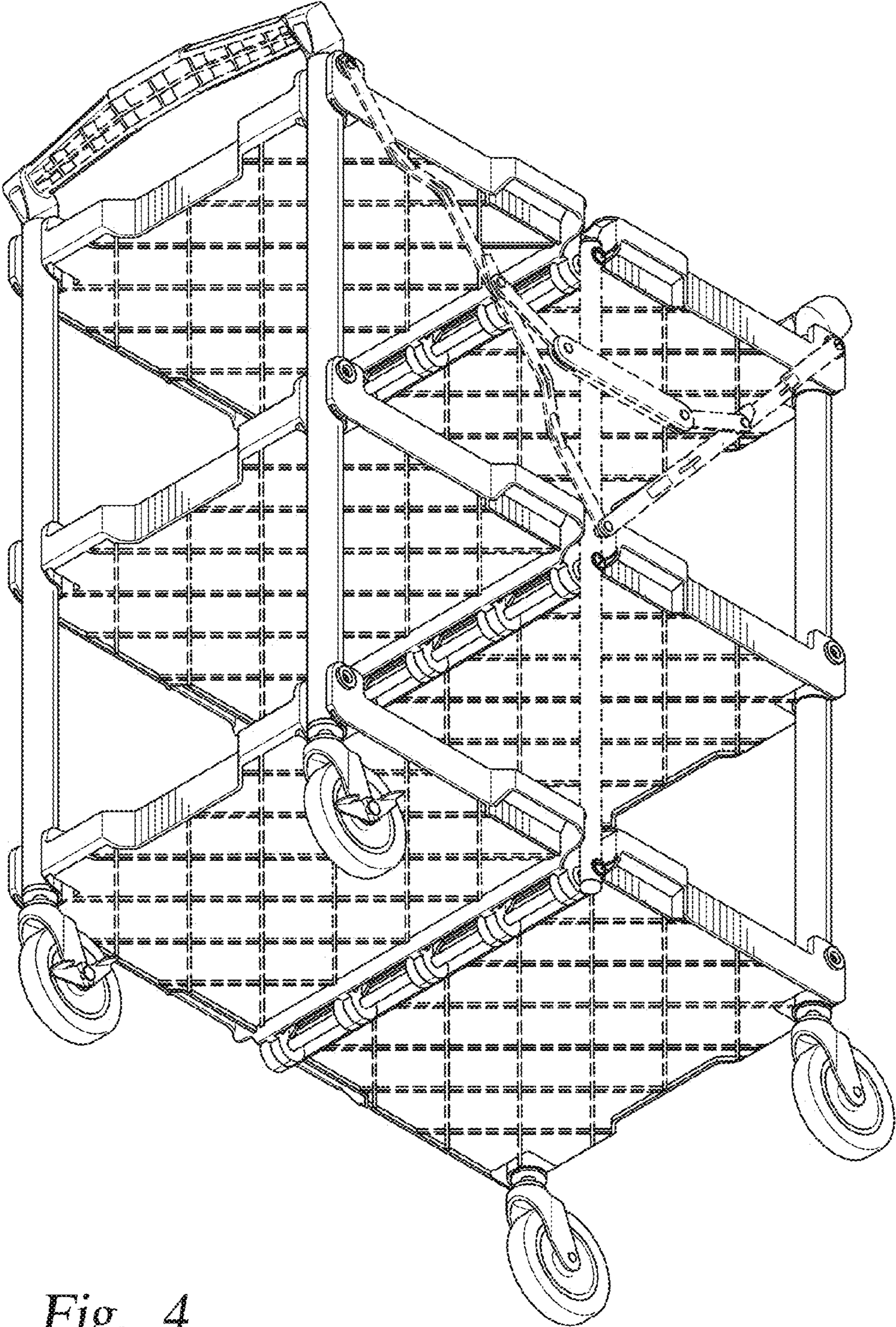

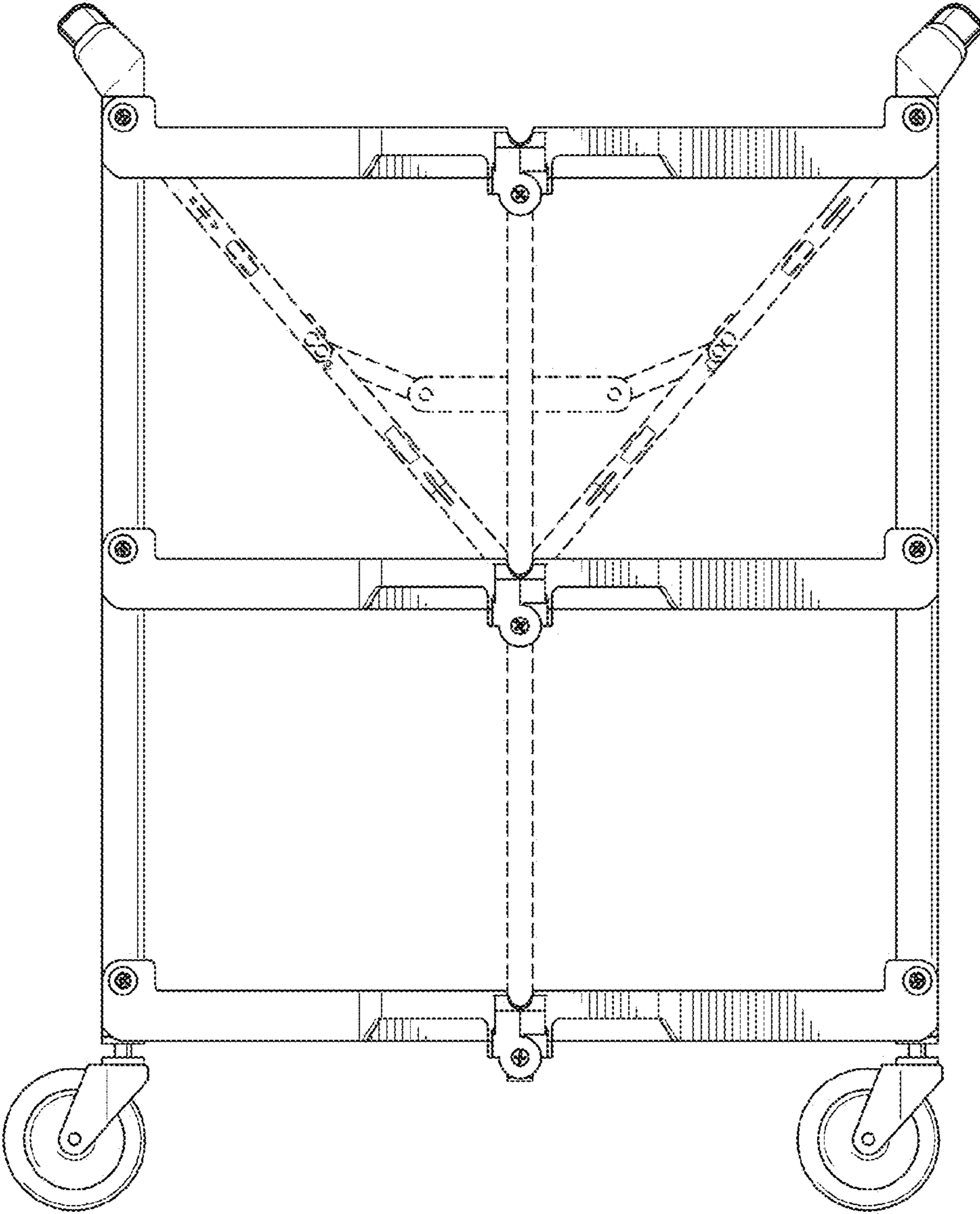

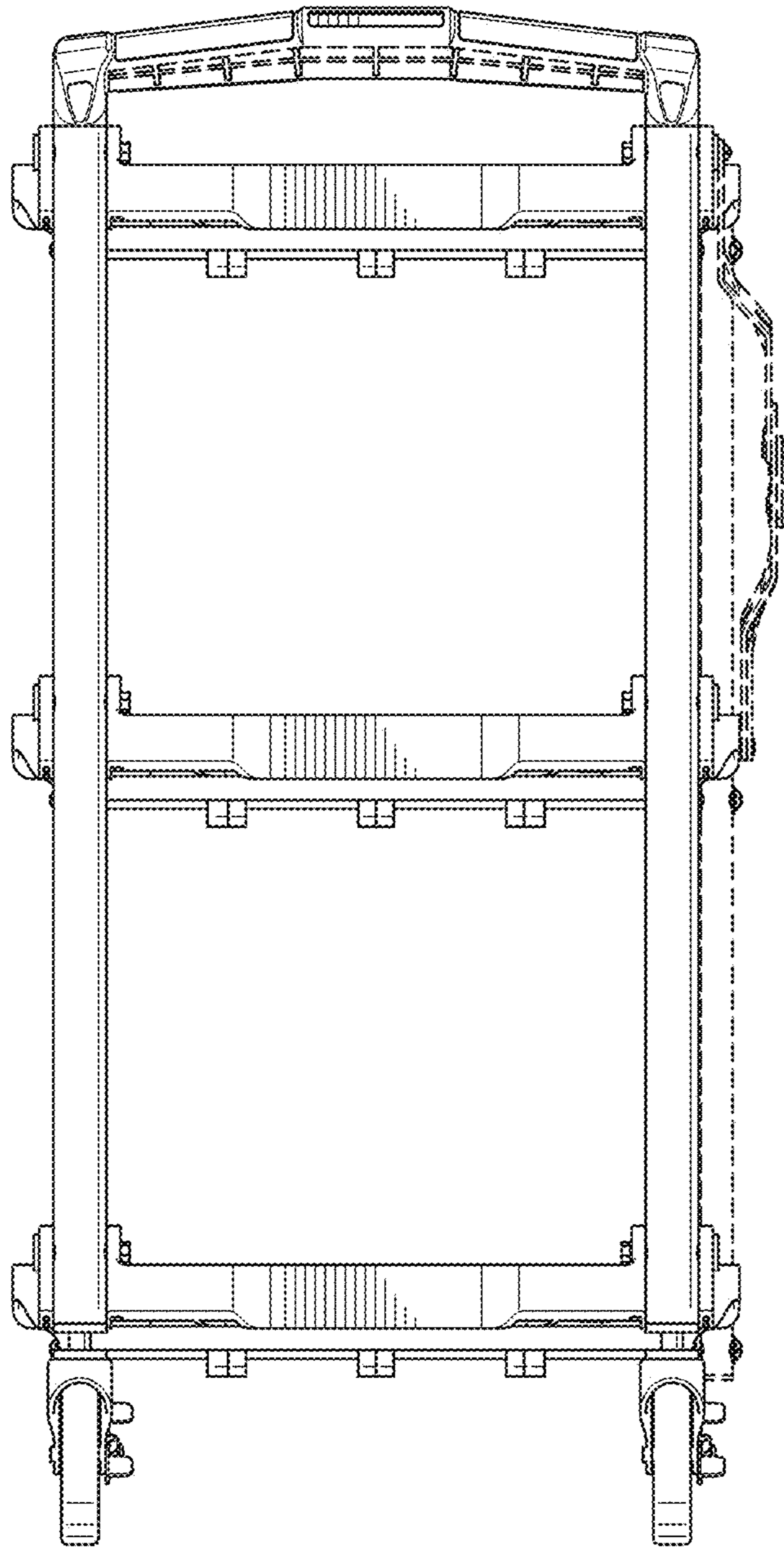

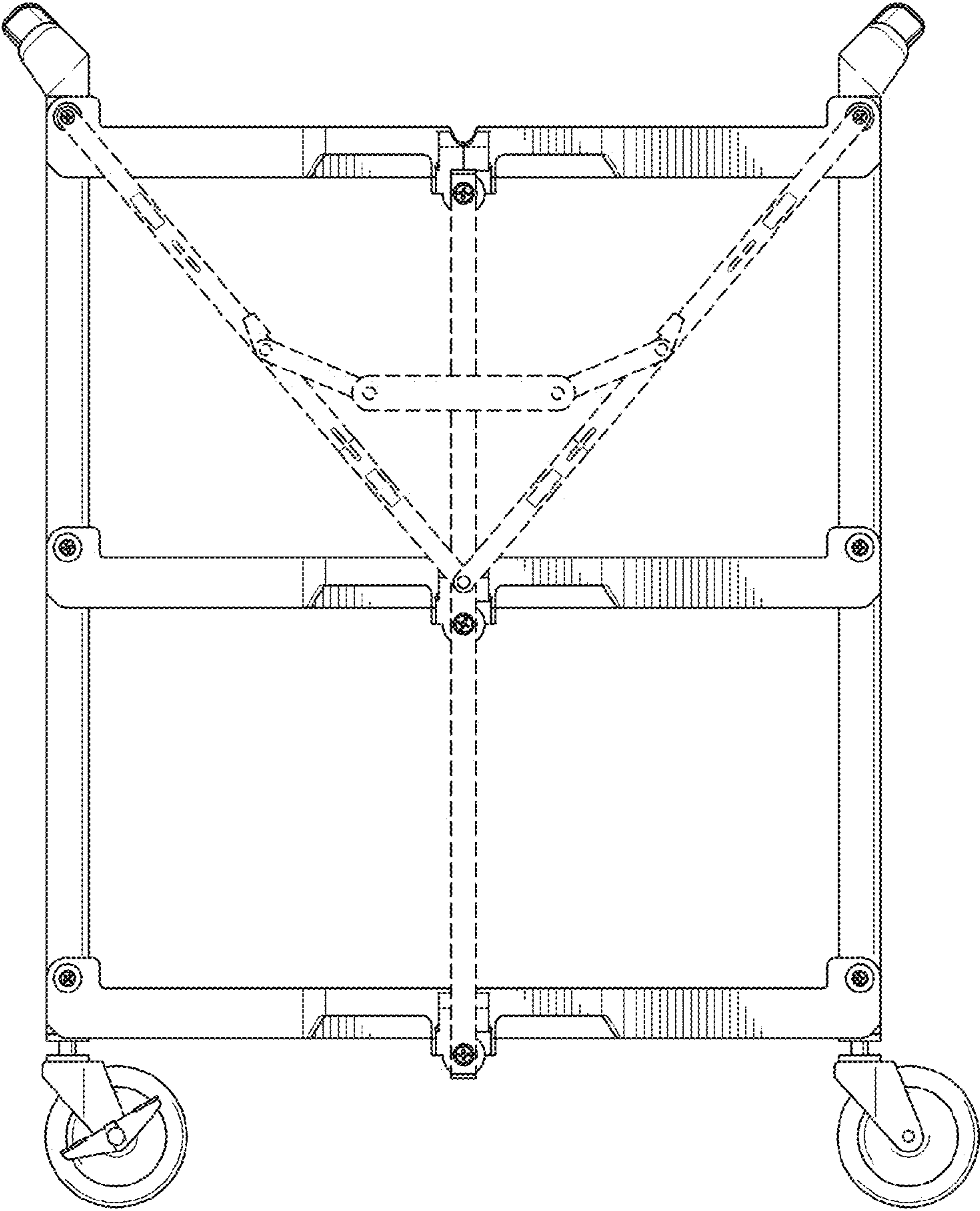

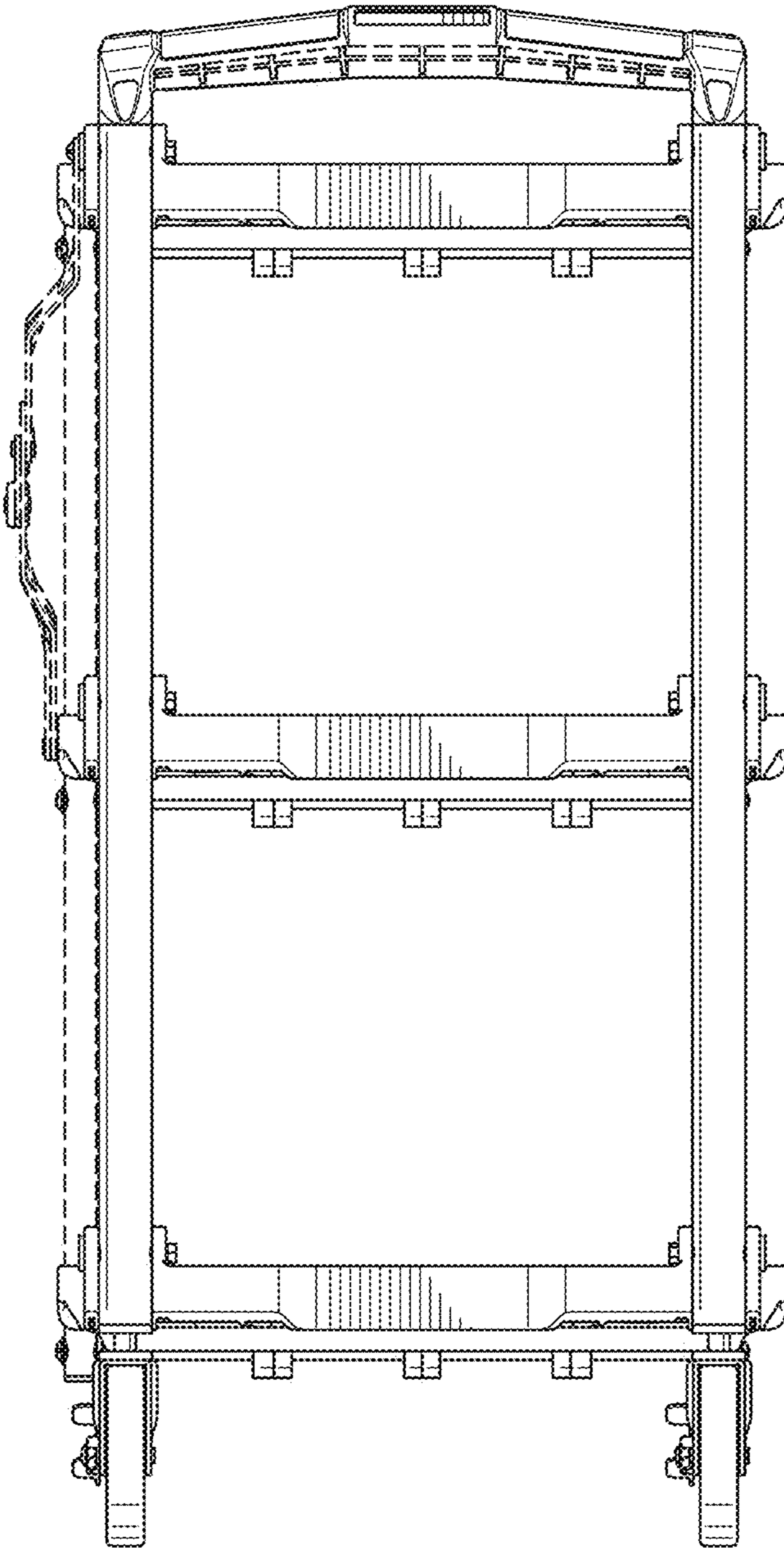

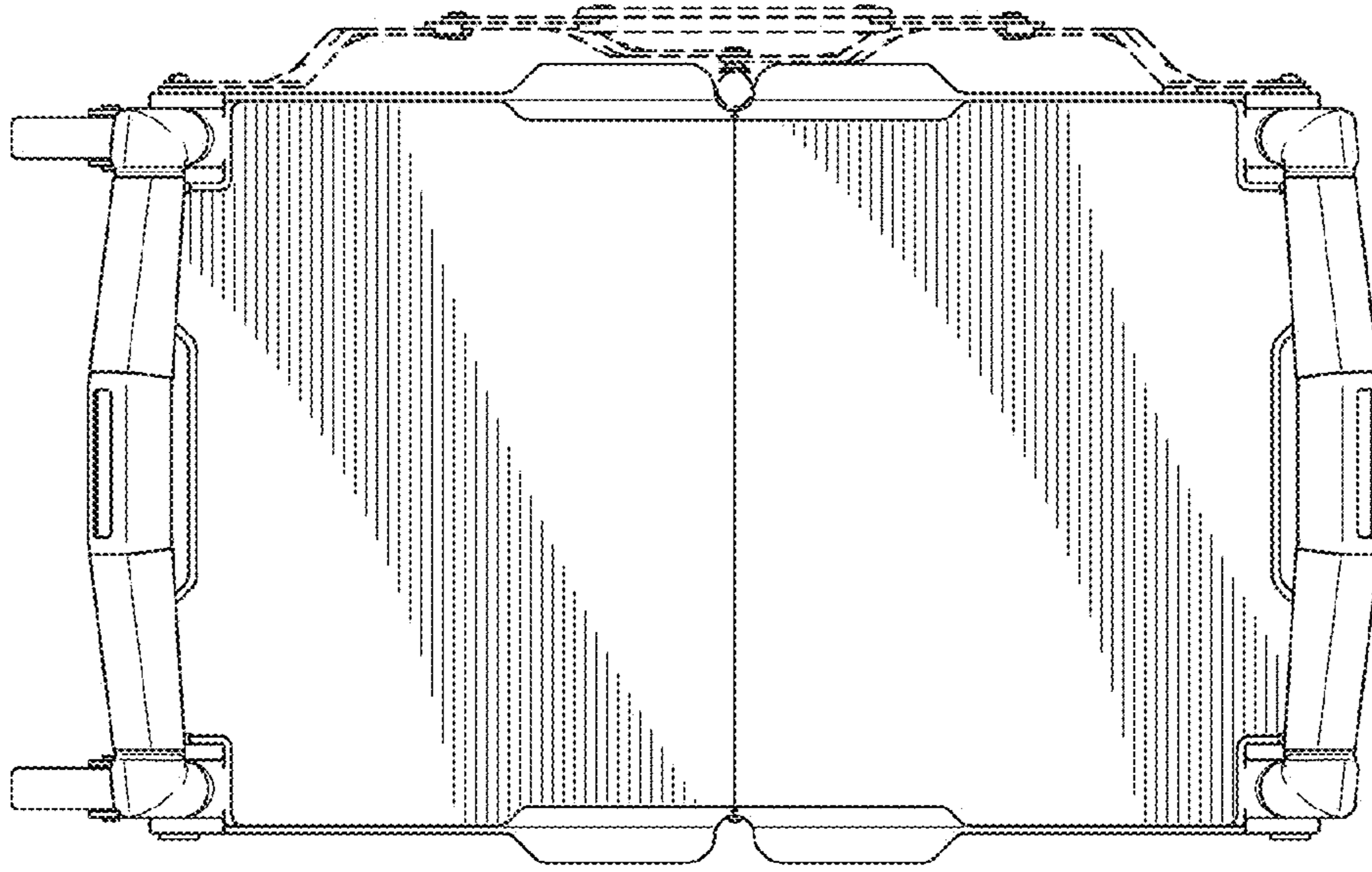

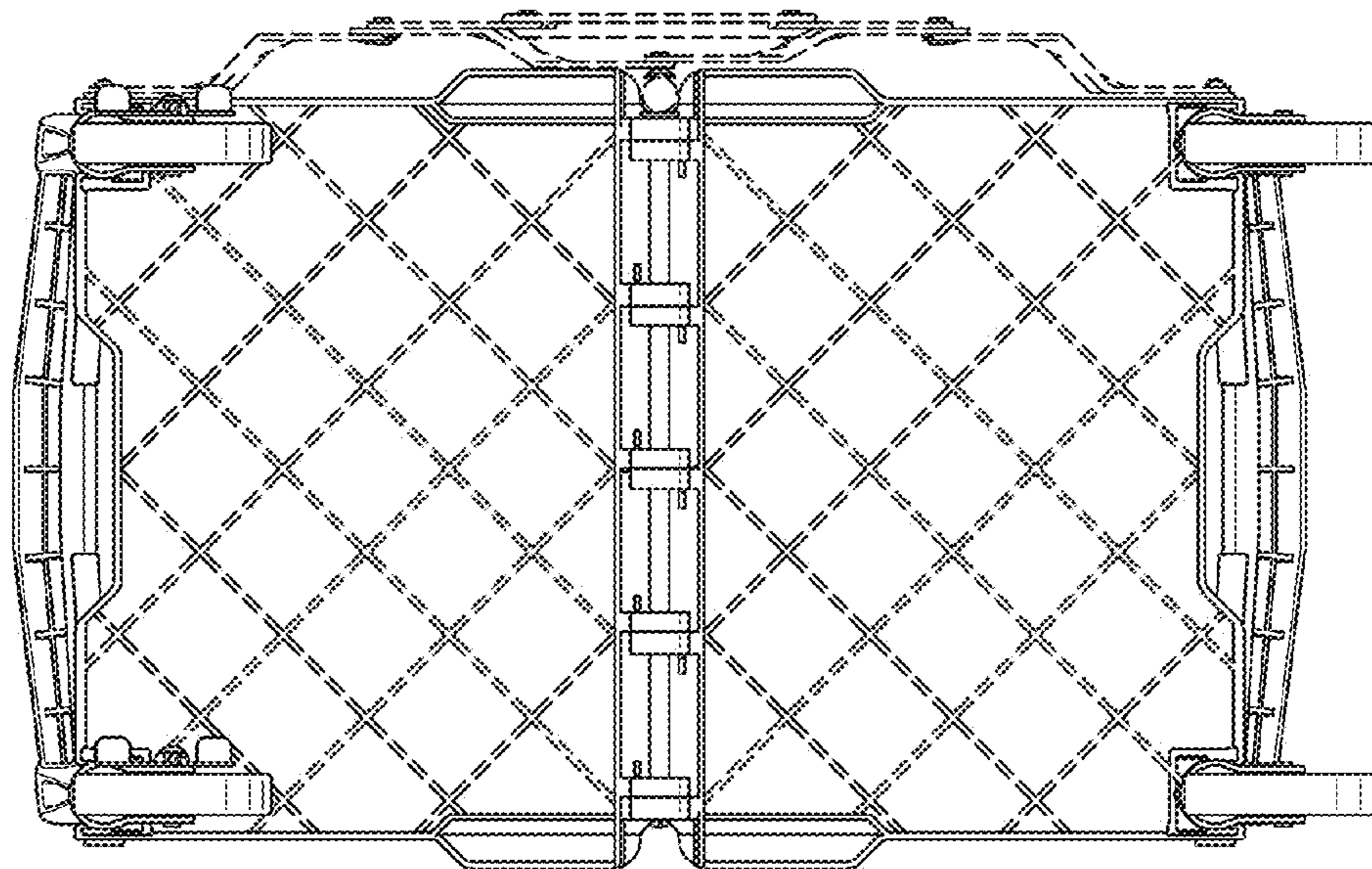

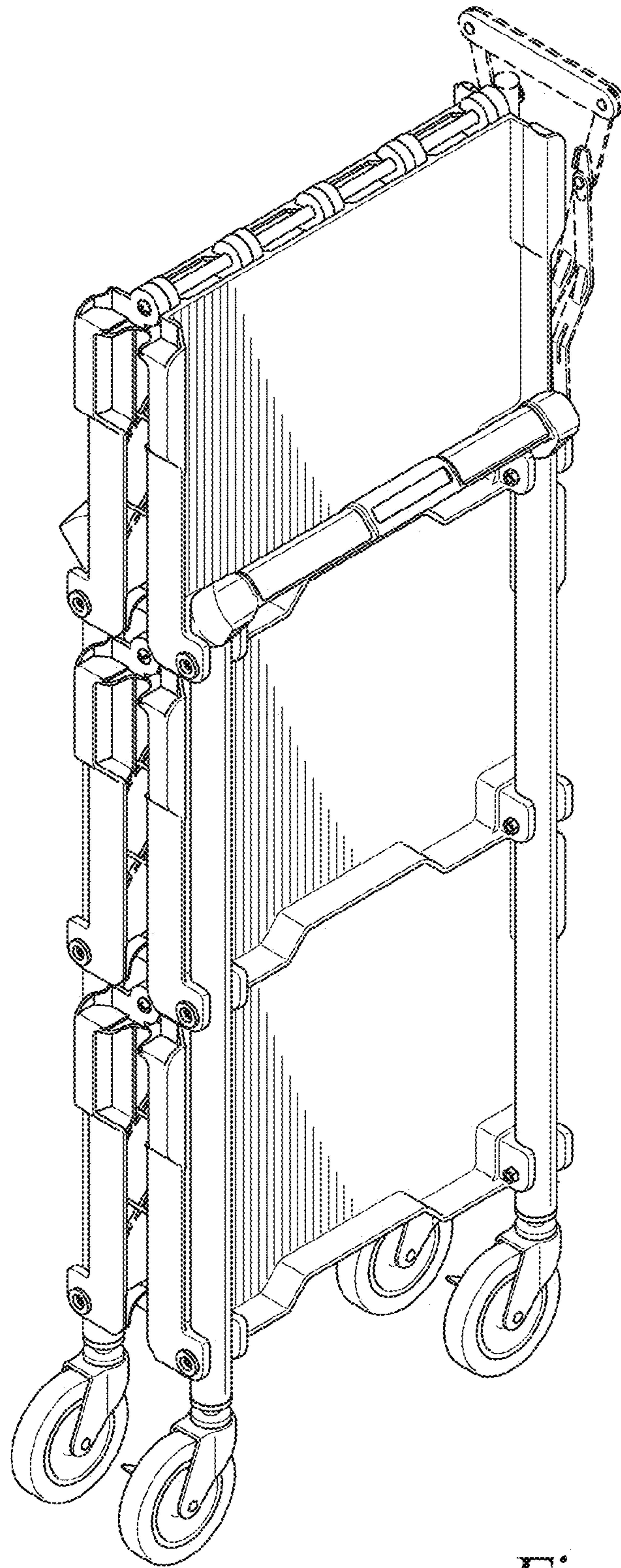

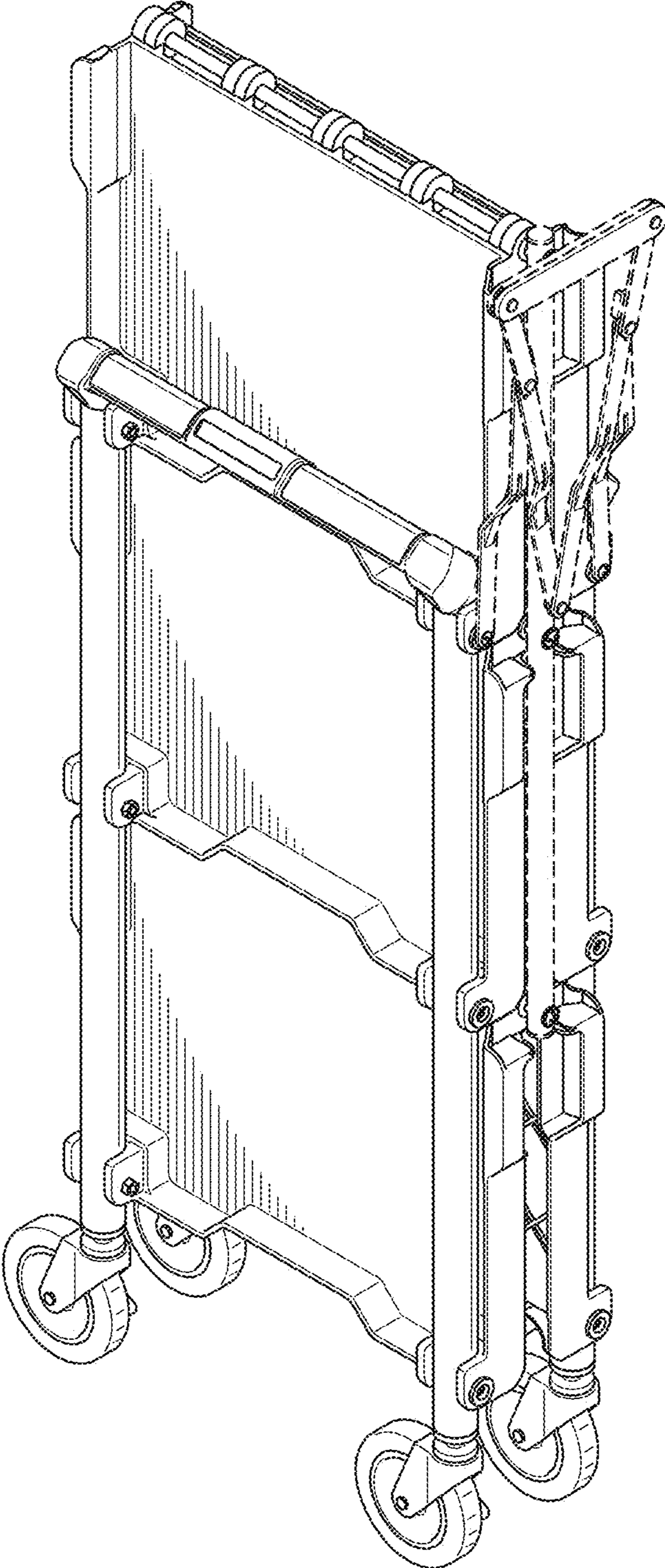

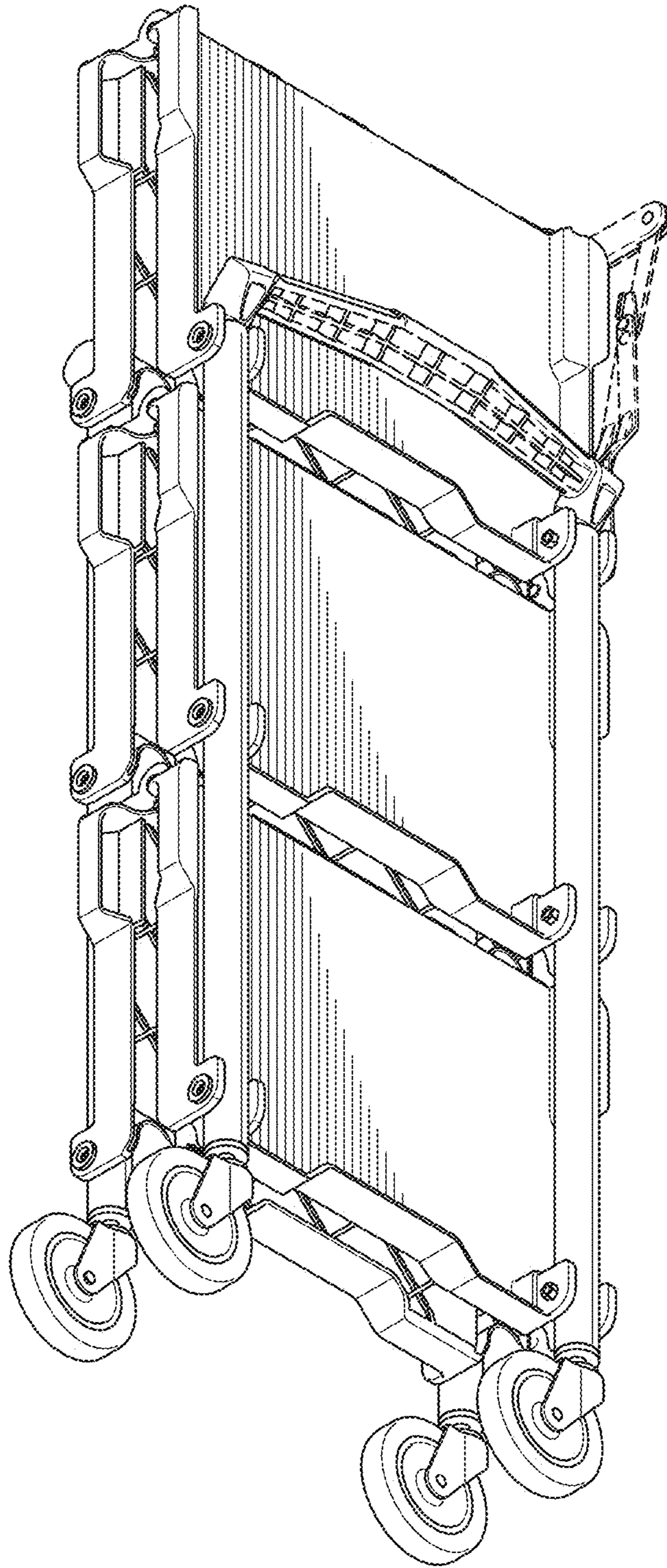

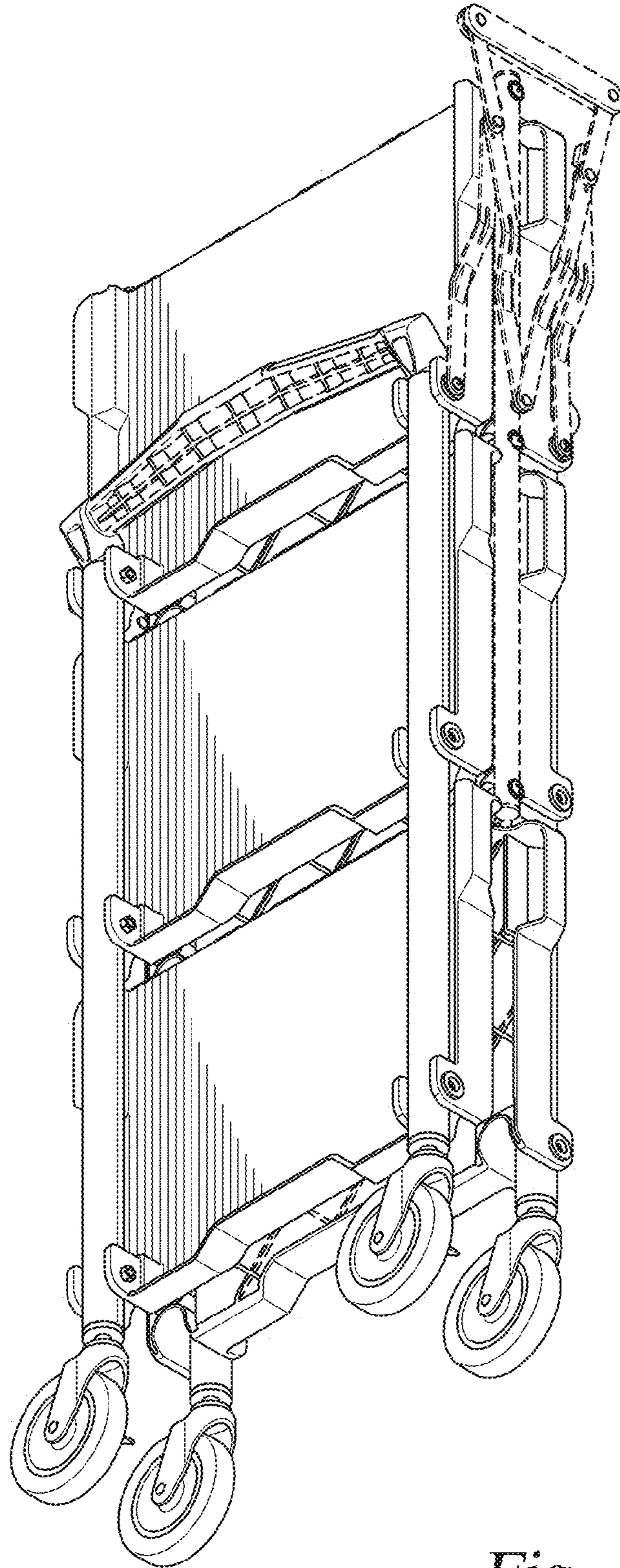

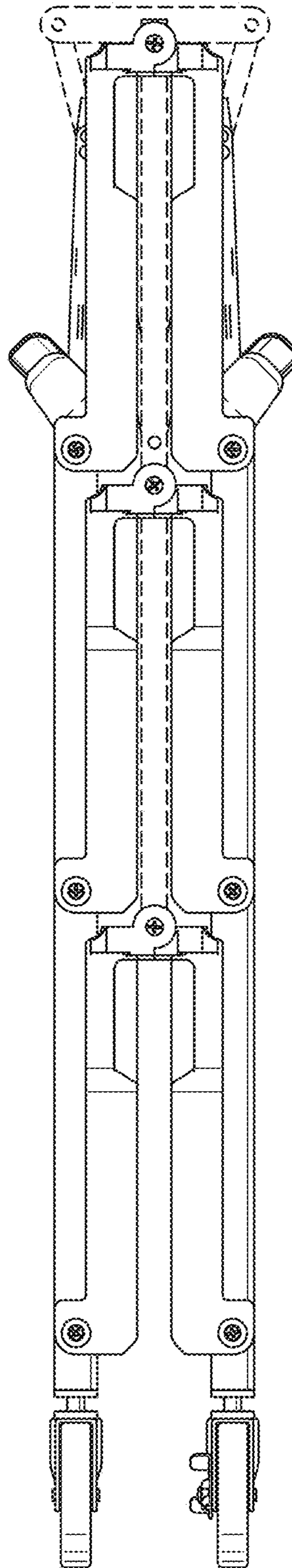

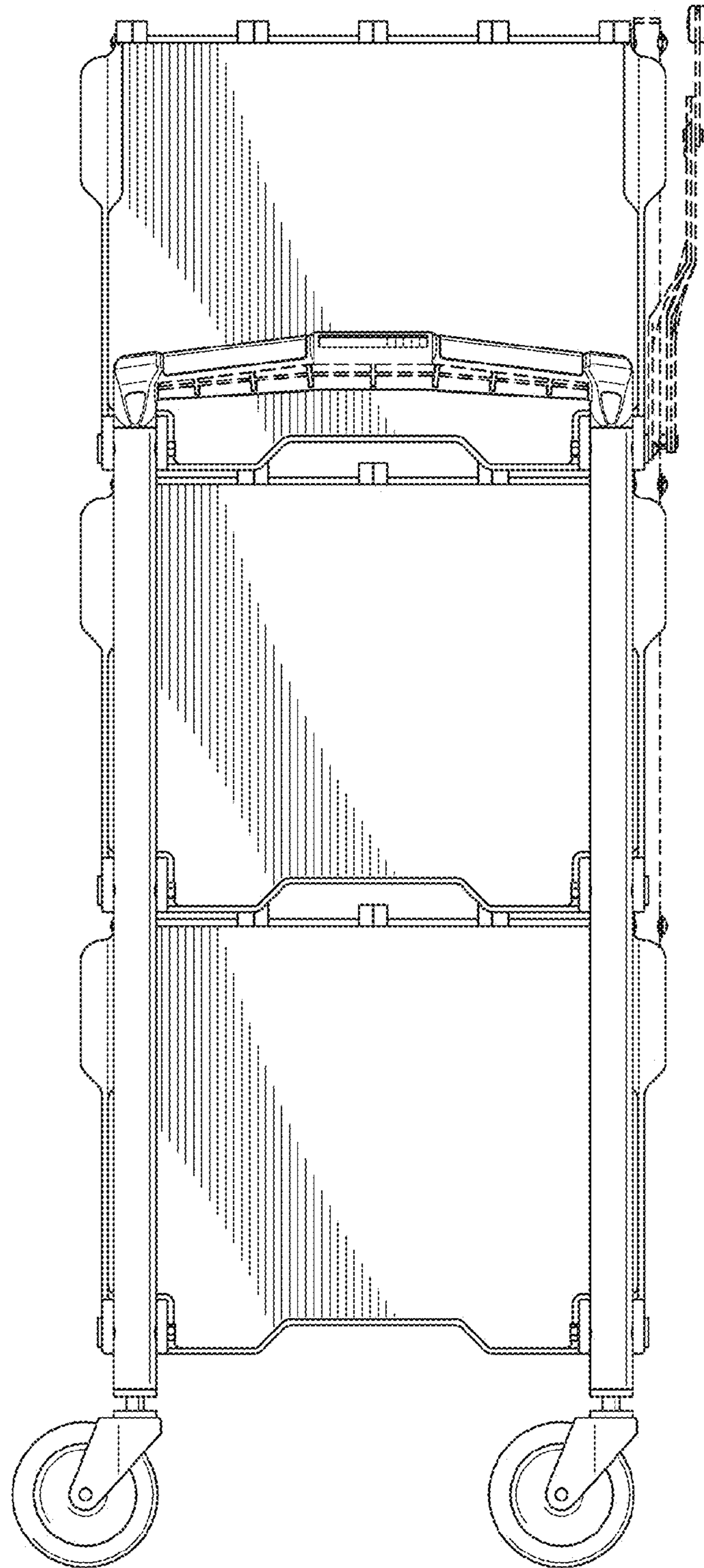

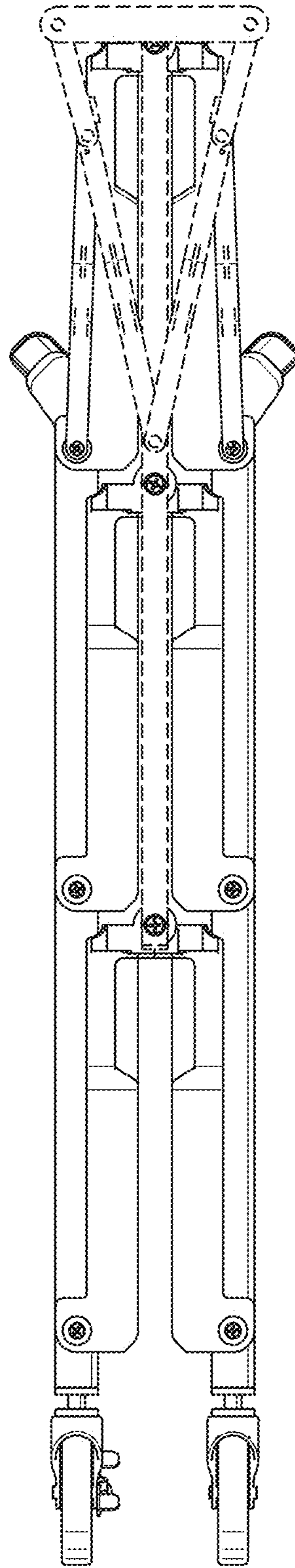

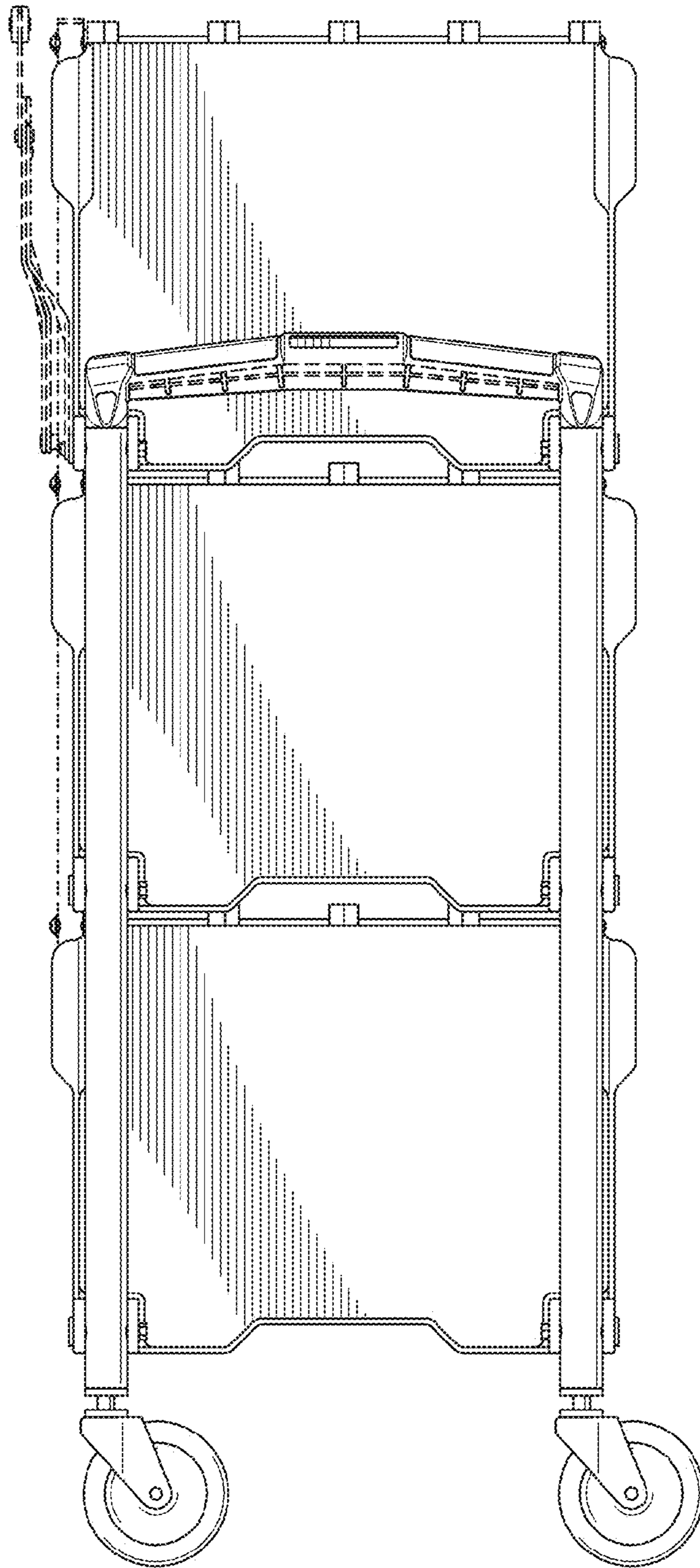

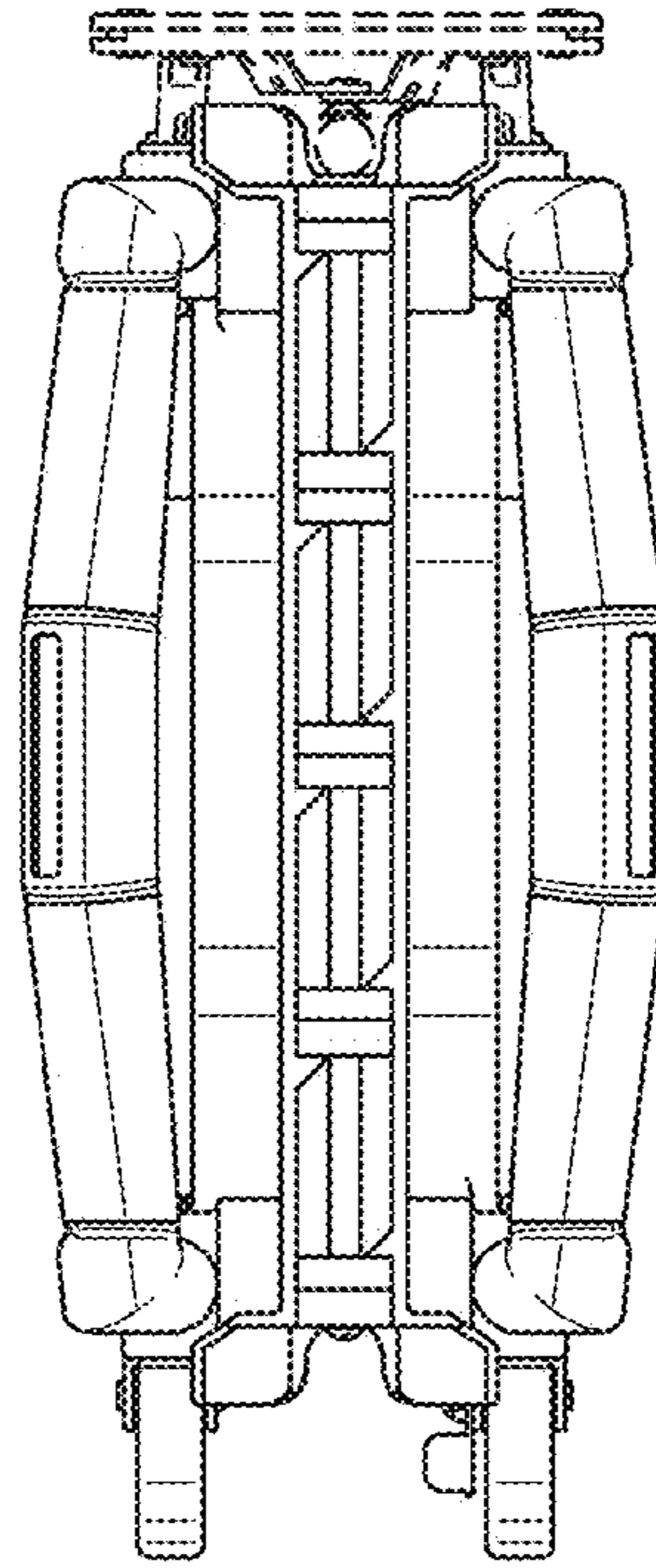
