FIG. 2 is a left elevational view thereof;

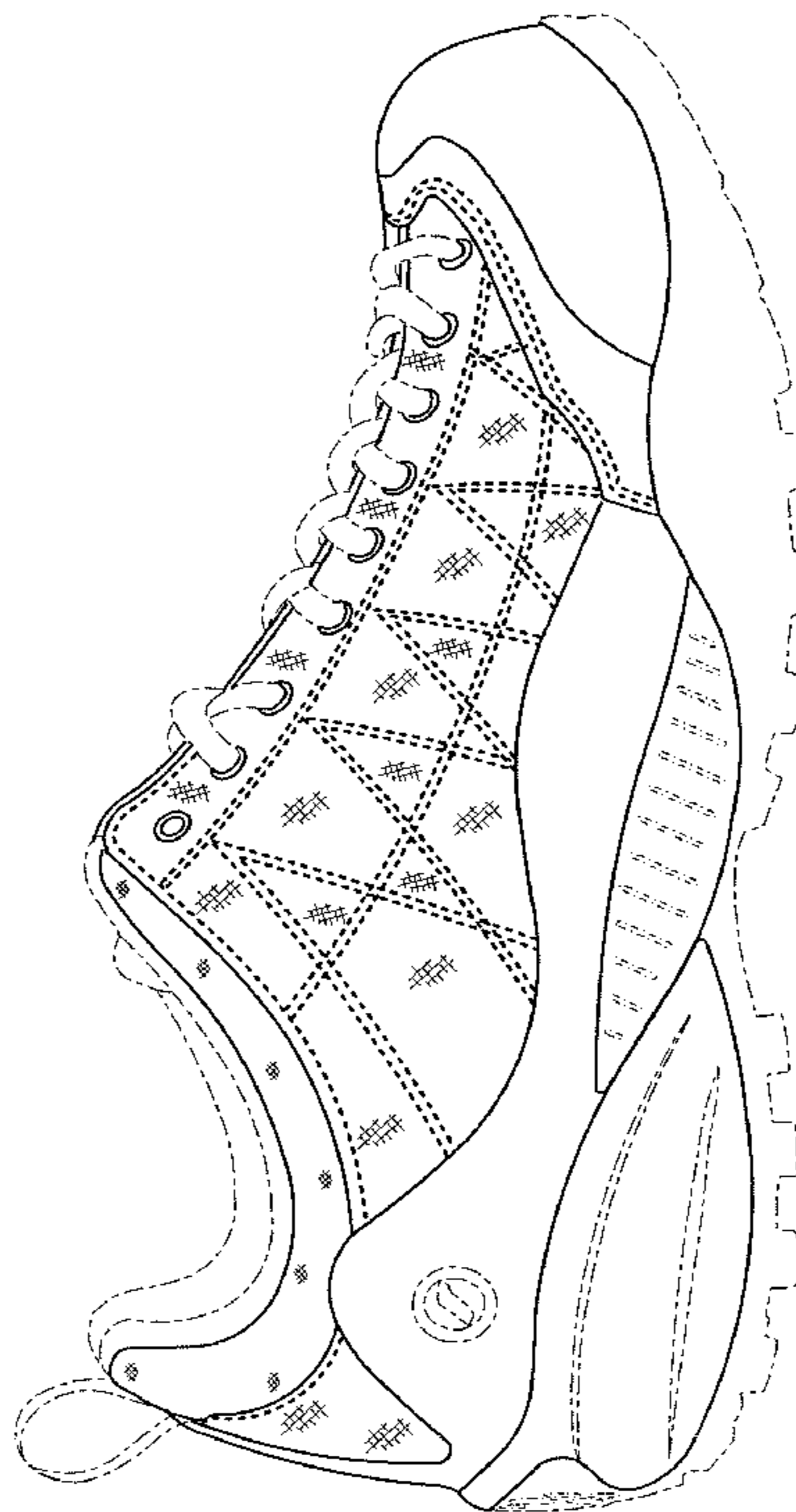
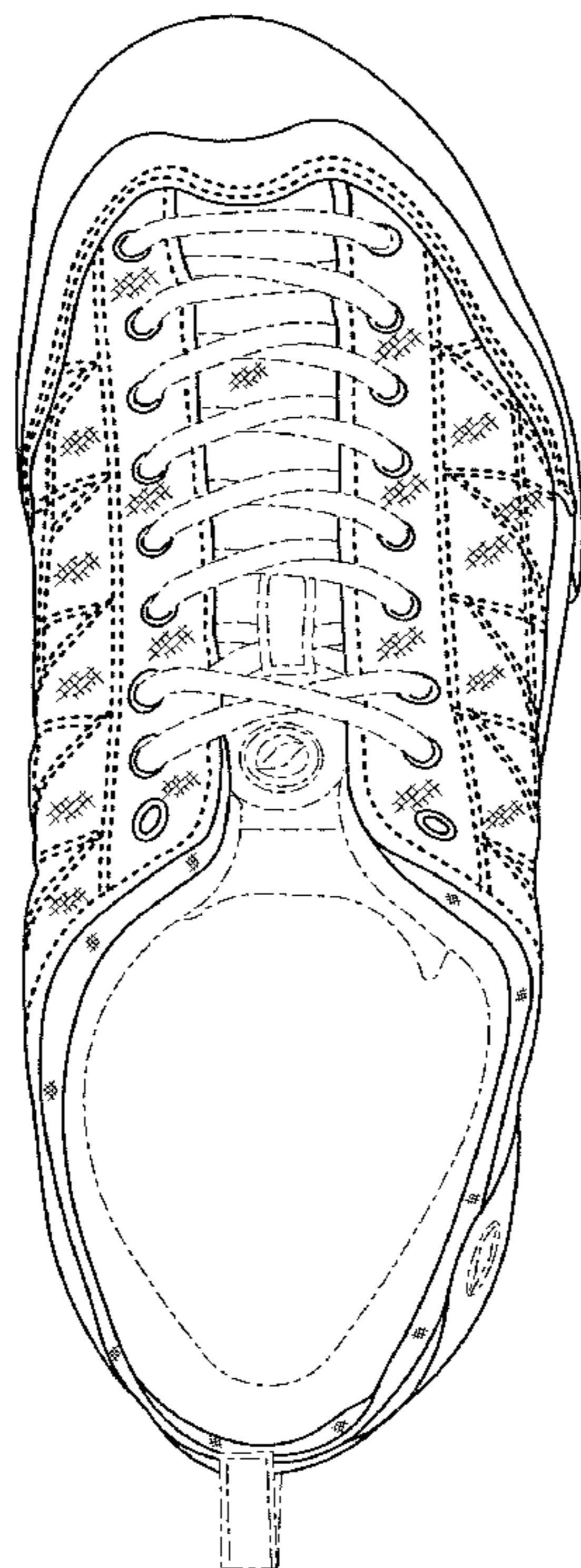
FIG. 3 is a right elevational view thereof;

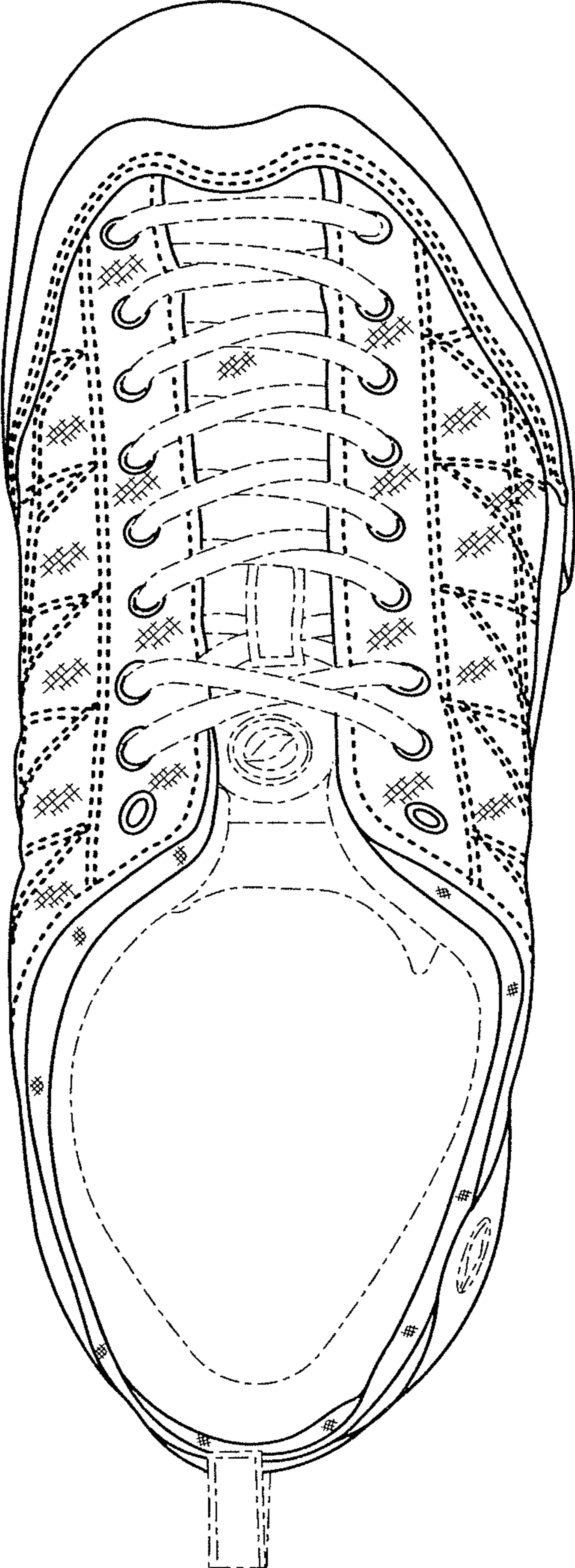

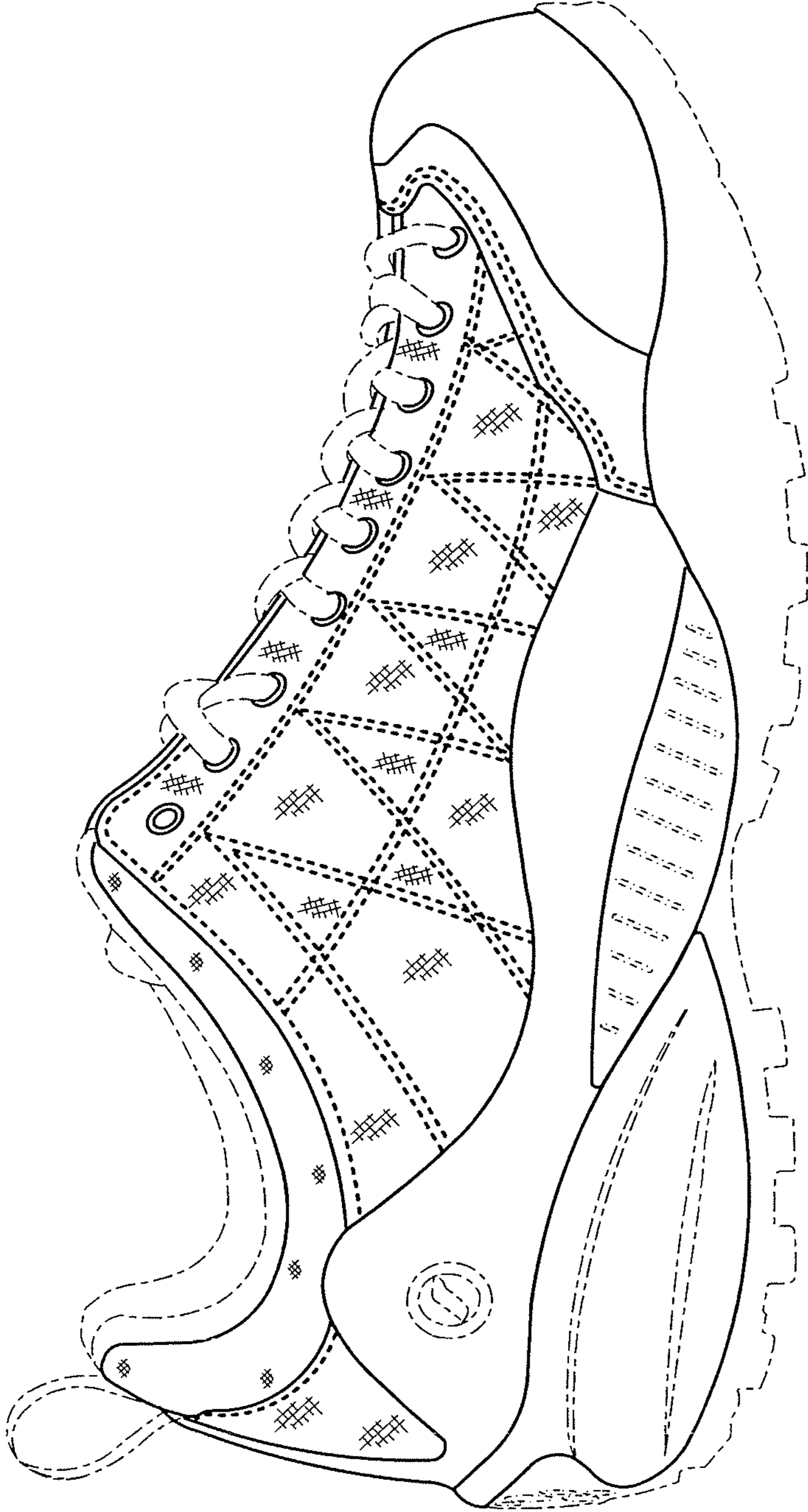

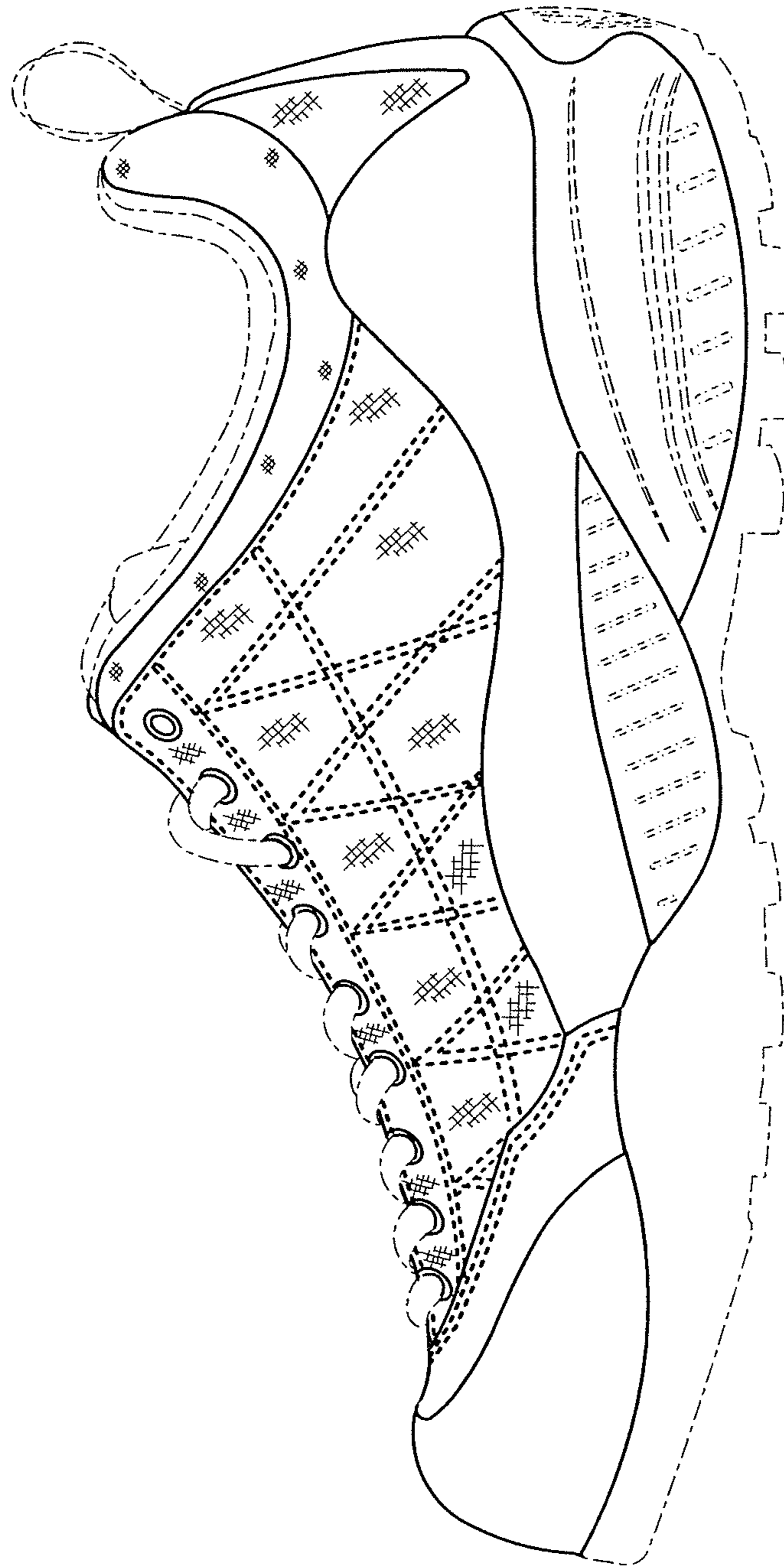

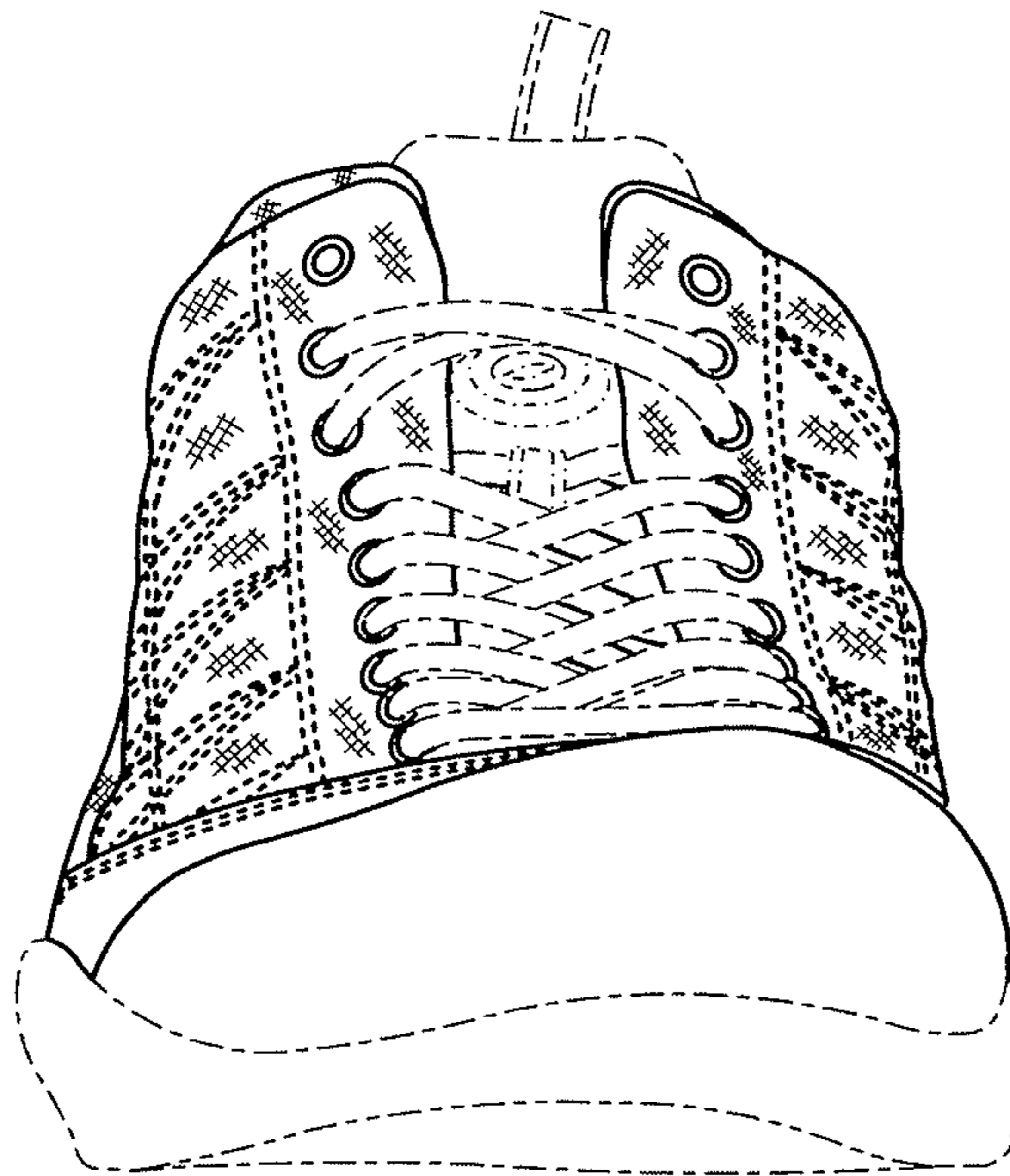

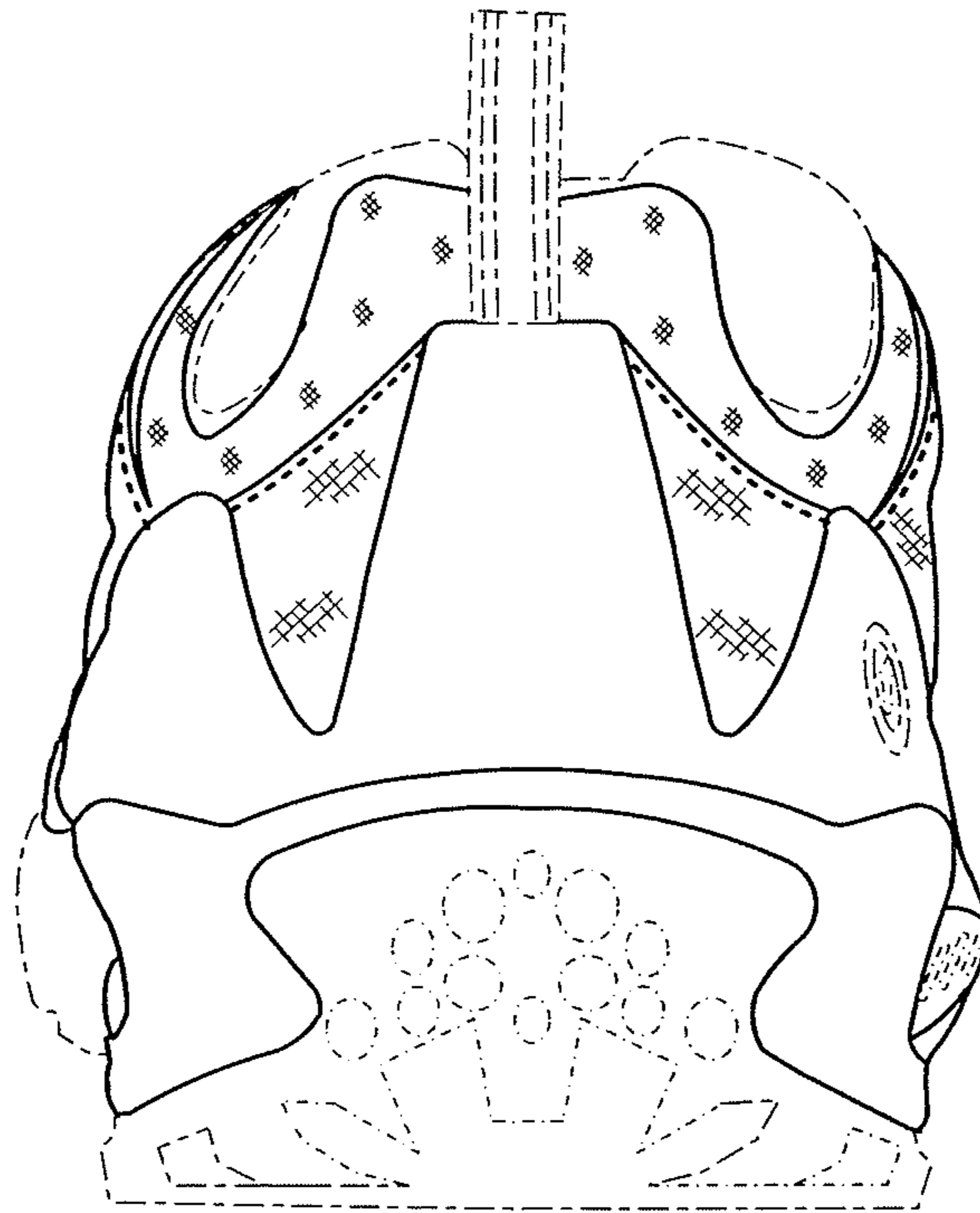
