(57) **CLAIM**

The ornamental design for a portable medication cooling device, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a portable medication cooling device showing a lid portion and a container portion in assemblage;

FIG. 2 is an exploded view of a portable medication cooling device, showing the lid portion, the container portion and the freezable tube portion;

FIG. 3 is a top perspective view of the lid portion;

FIG. 4 is an bottom perspective view of FIG. 3;

FIG. 5 is a front view of FIG. 3;

FIG. 6 is a rear view of FIG. 3;

FIG. 7 is a left-hand side view of FIG. 3;

FIG. 8 is a right-hand side view of FIG. 3;

FIG. 9 is a top view of FIG. 3;

FIG. 10 is a bottom view of FIG. 3;

FIG. 11 is a cross-sectional view taken along line 11-11 in FIG. 5;

FIG. 12 is a cross-sectional view taken along line 12-12 in FIG. 6;

FIG. 13 is a top perspective view of the freezable tube;

FIG. 14 is a bottom perspective view of FIG. 13;

FIG. 15 is a front view of FIG. 13, wherein a rear view is a mirror image of the front view;

FIG. 16 is a left-hand side view of FIG. 13, wherein a right-hand side view is a mirror image of the left-hand side view;

FIG. 17 is a top view of FIG. 13;

FIG. 18 is a bottom view of FIG. 13;

FIG. 19 is a cross-sectional view taken along line 19-19 in FIG. 15, wherein a cross-section of the rear, right-hand side, and left-hand side views are mirror image of the cross section of the front view;

FIG. 20 is a top perspective view of the container;

FIG. 21 is a front view of FIG. 20, wherein a rear view is a mirror image of the front view;

FIG. 22 is a left-hand side view of FIG. 20, wherein a right-hand side view is a mirror image of the left-hand side view;

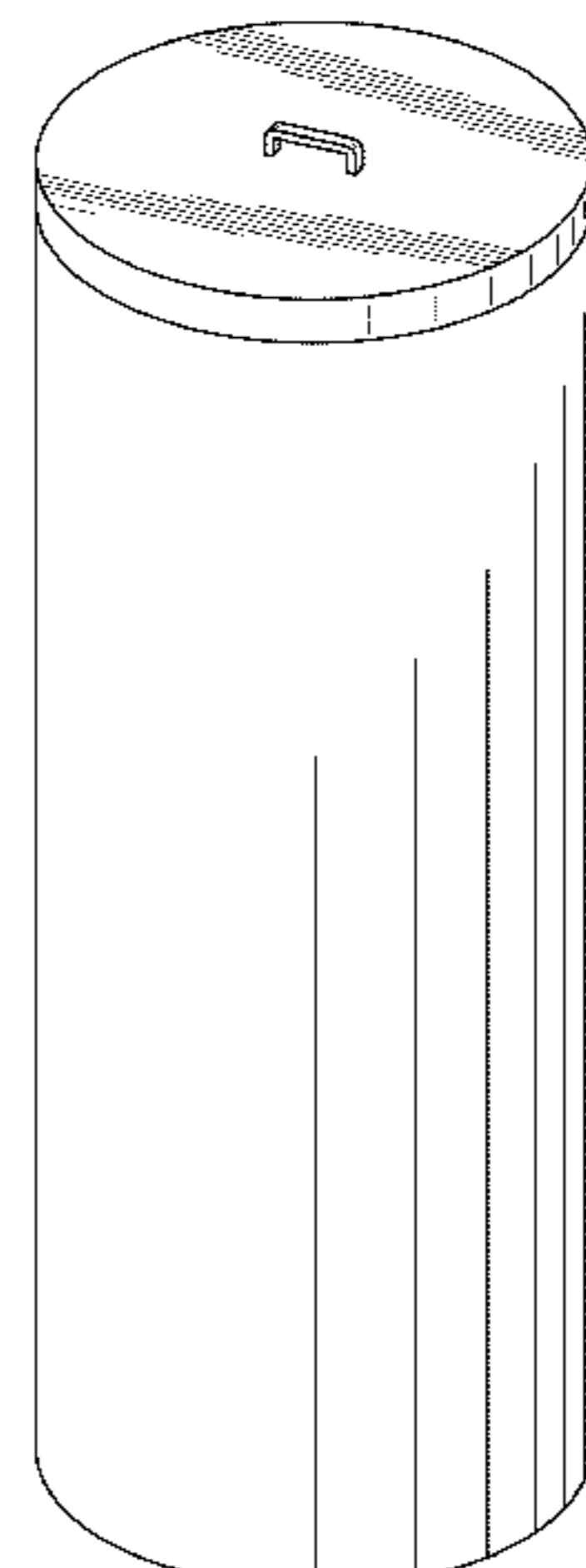
FIG. 23 is a top view of FIG. 20;

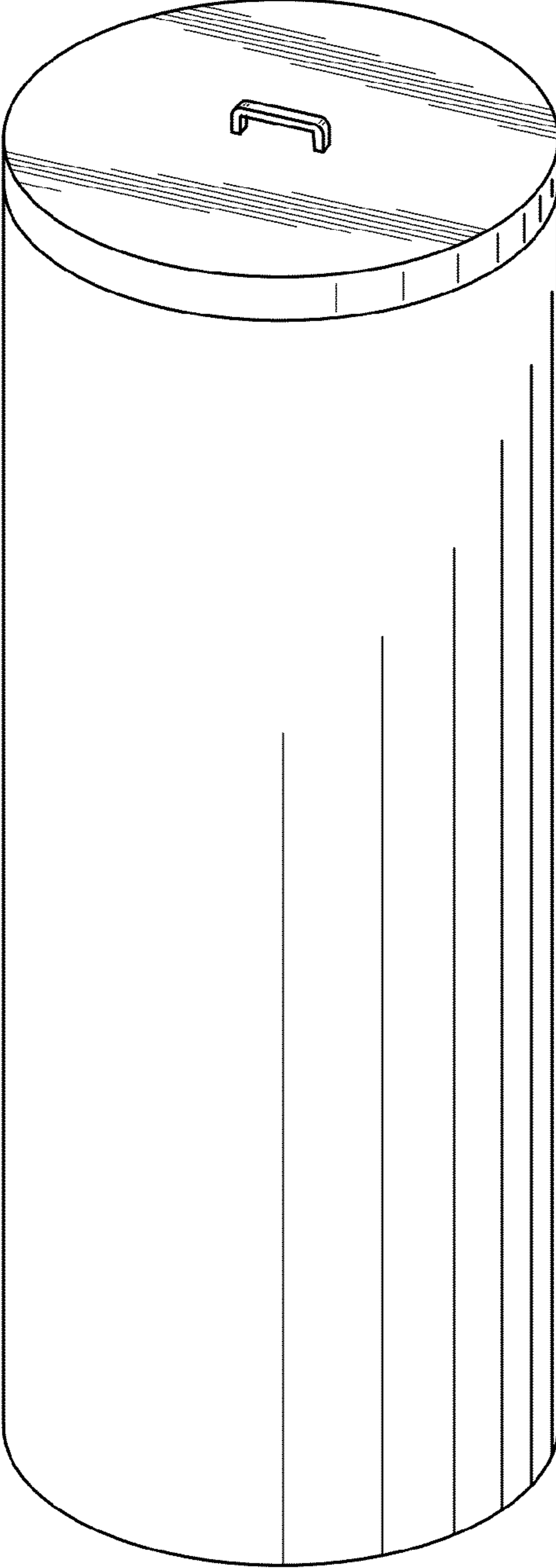

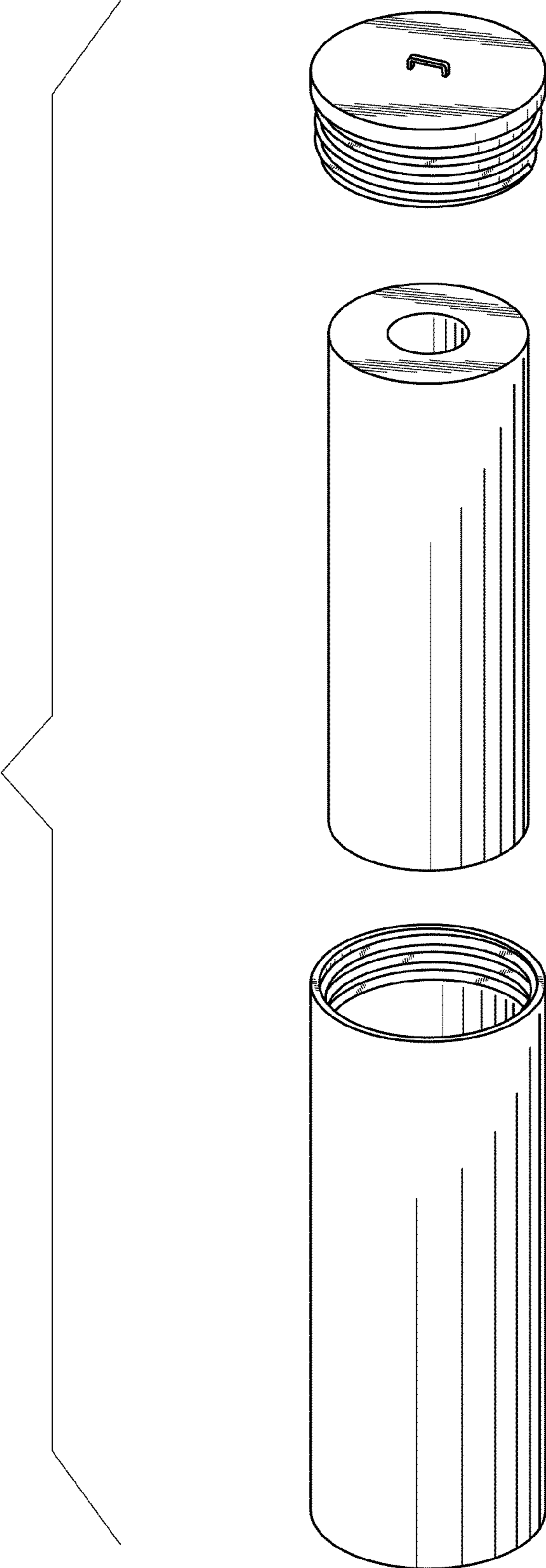

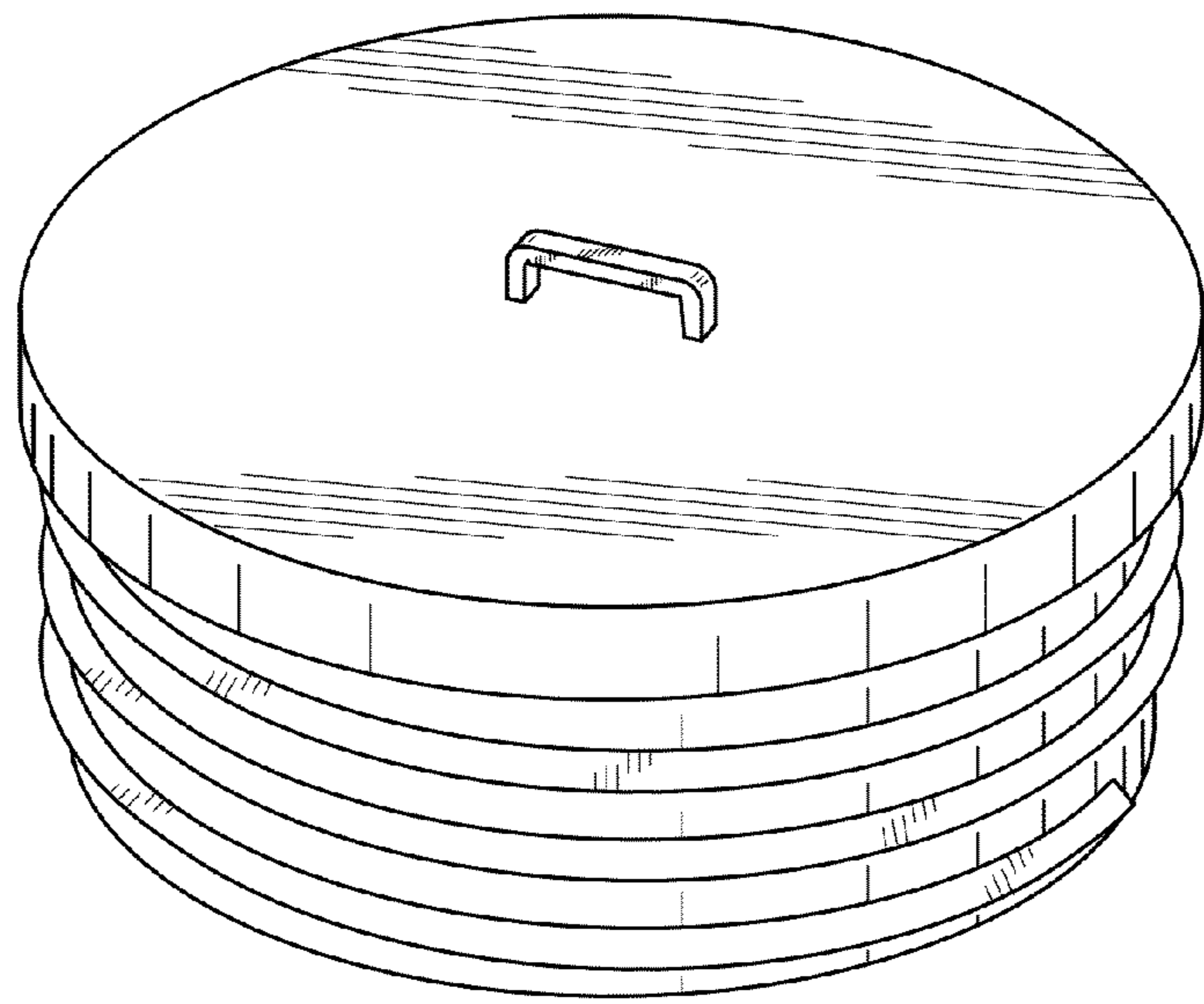

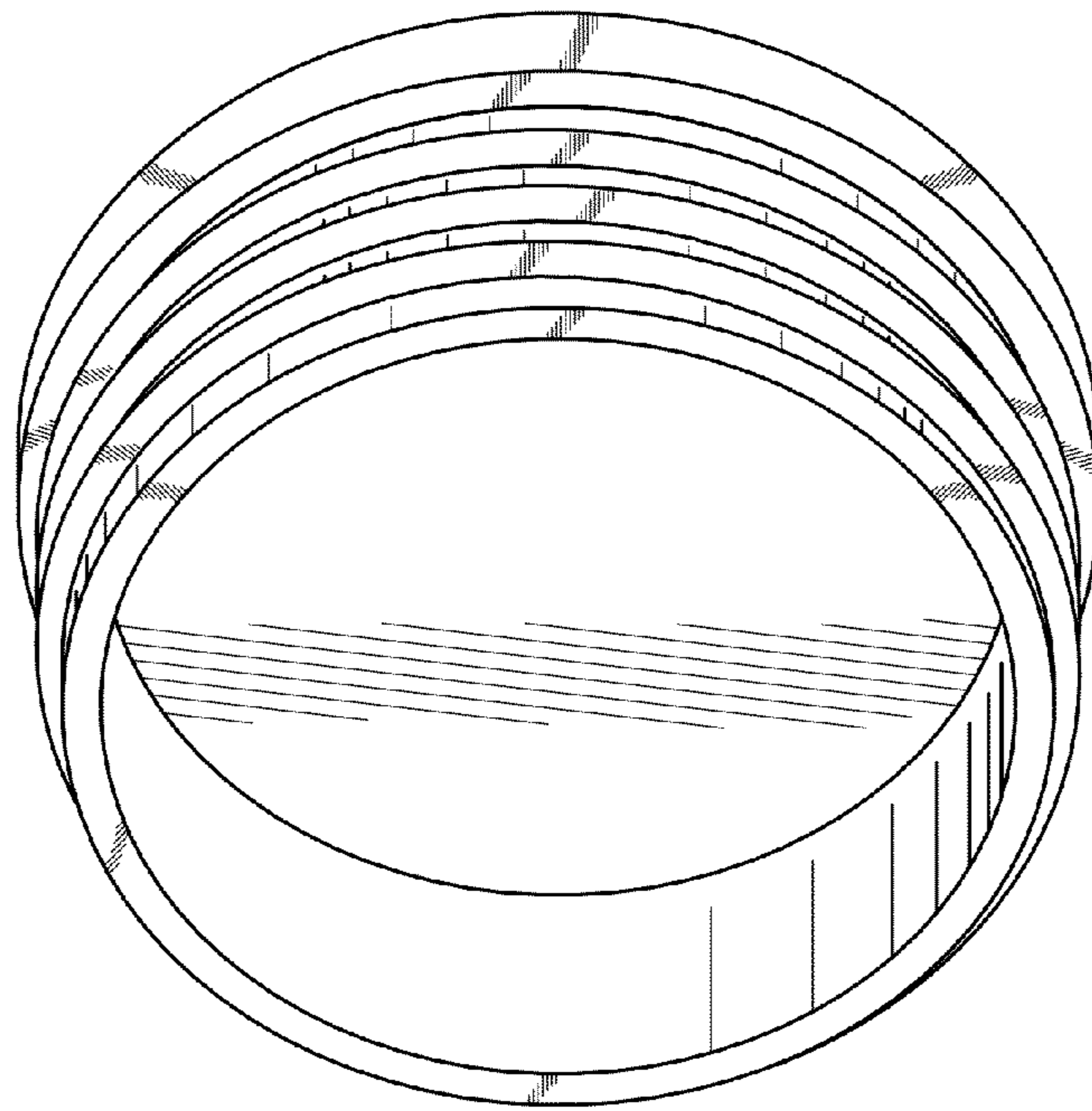

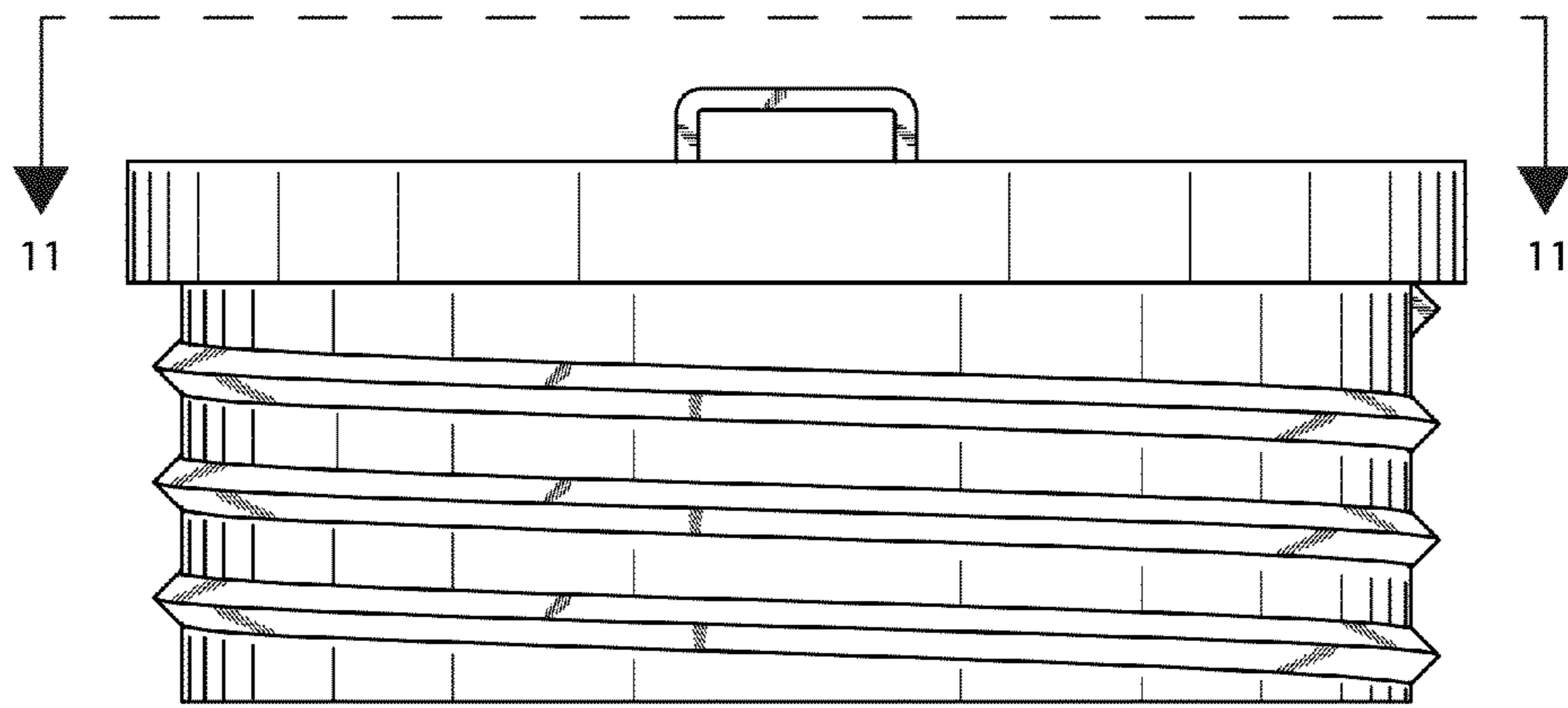

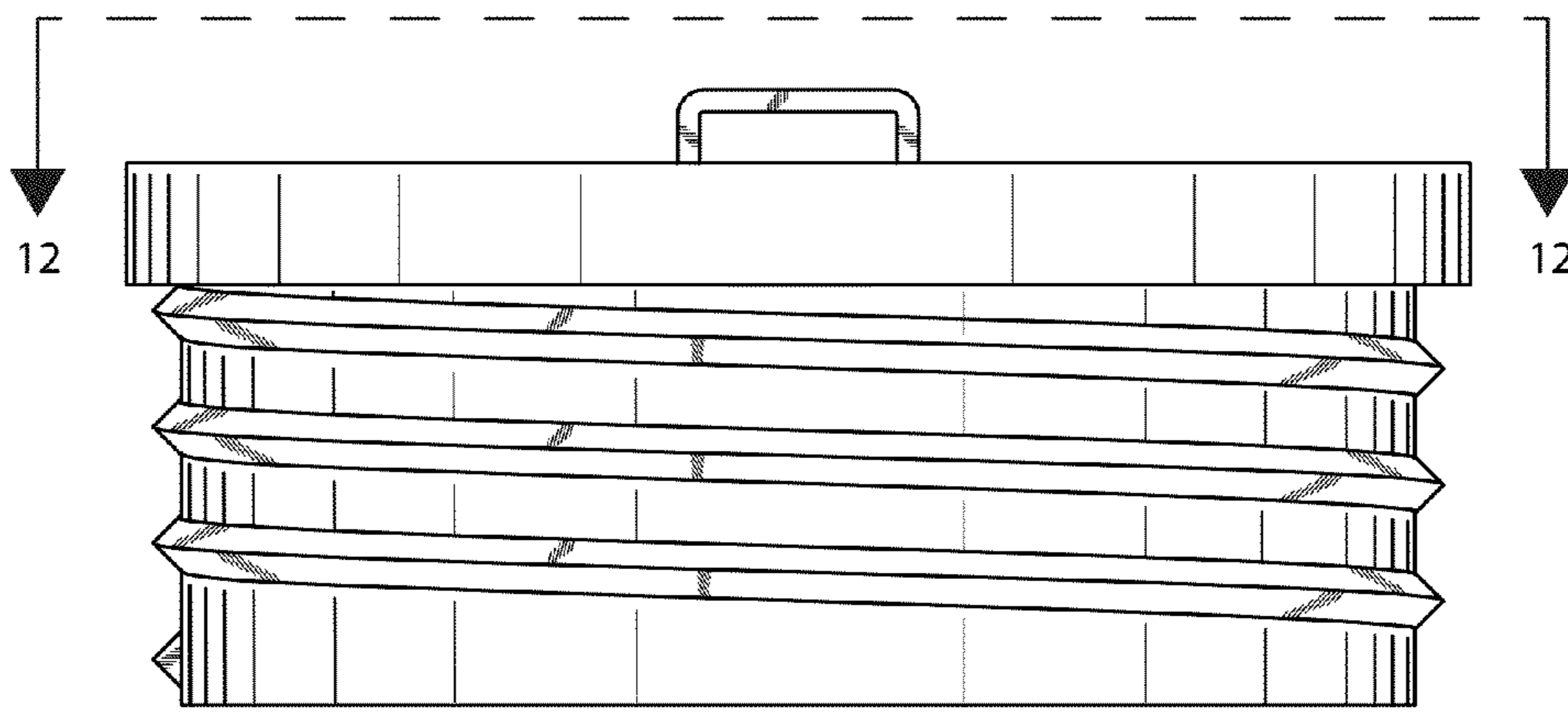

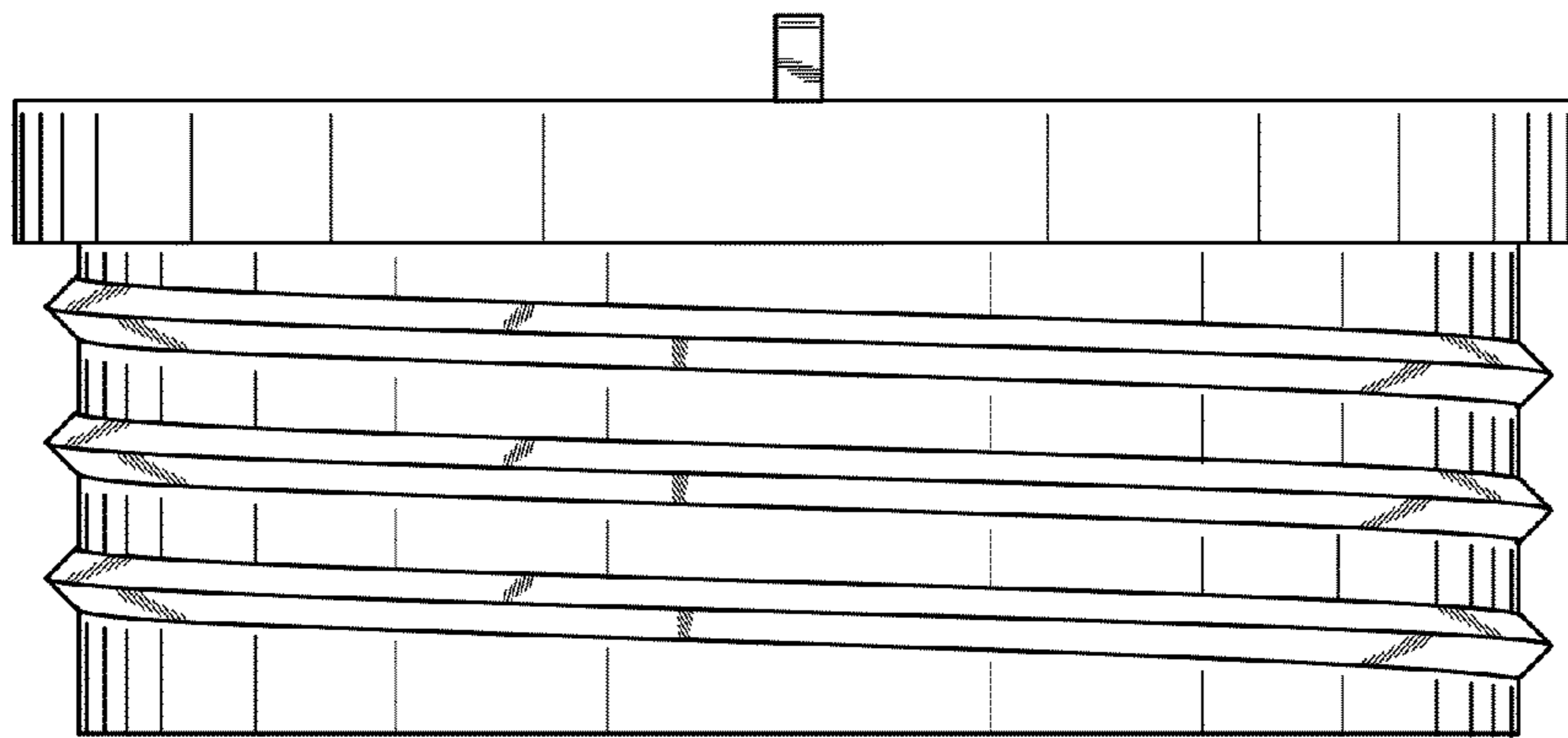

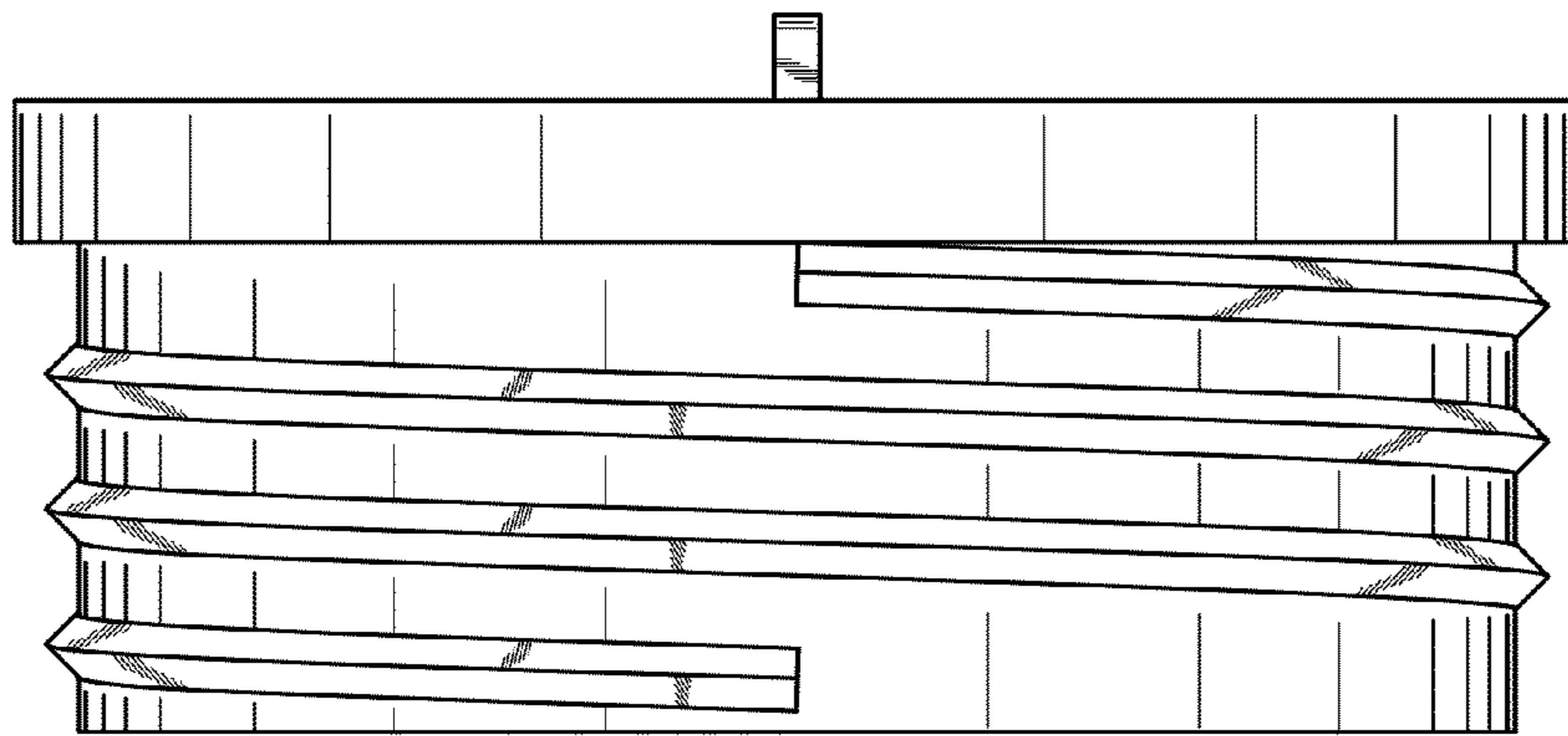

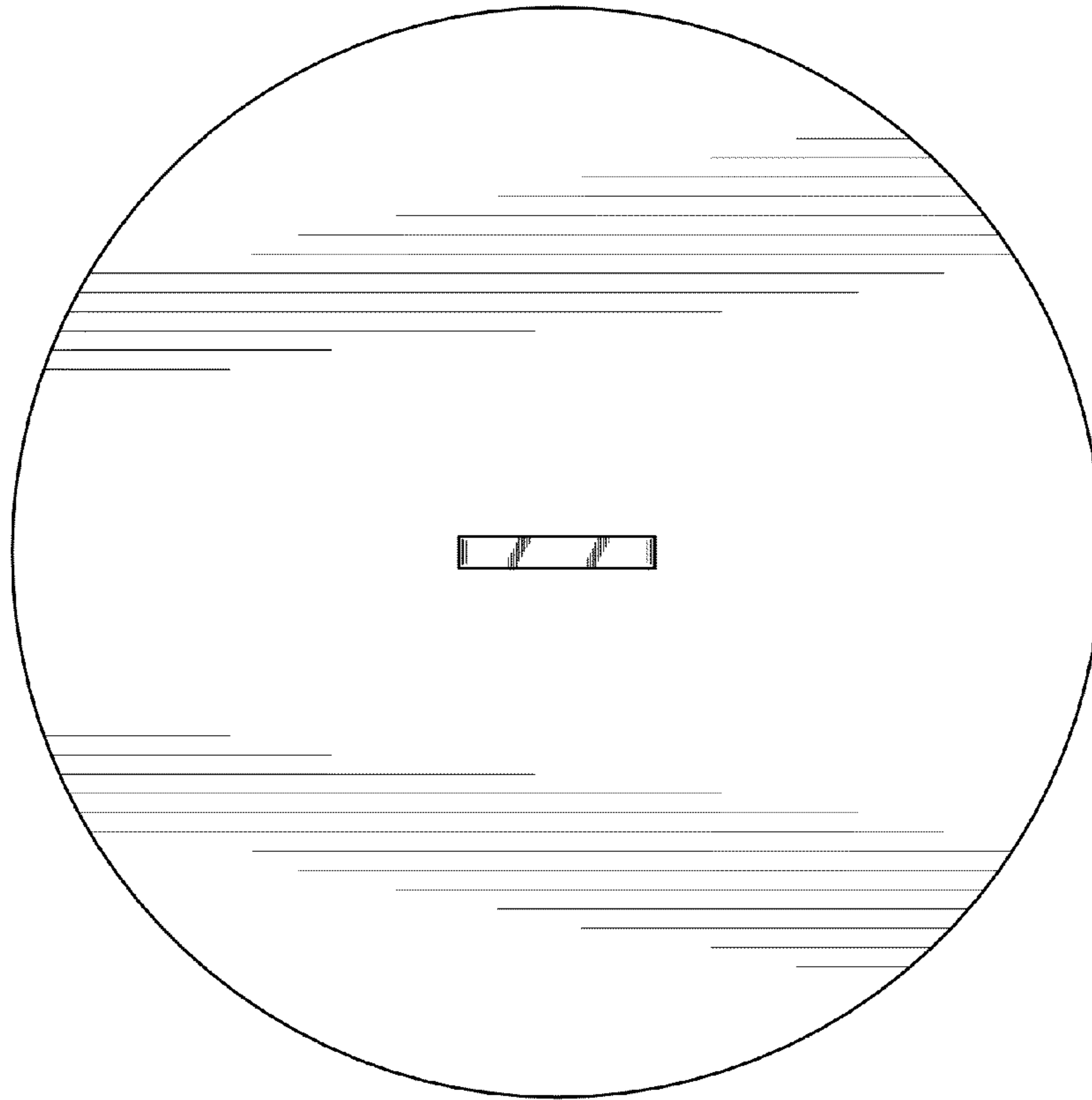

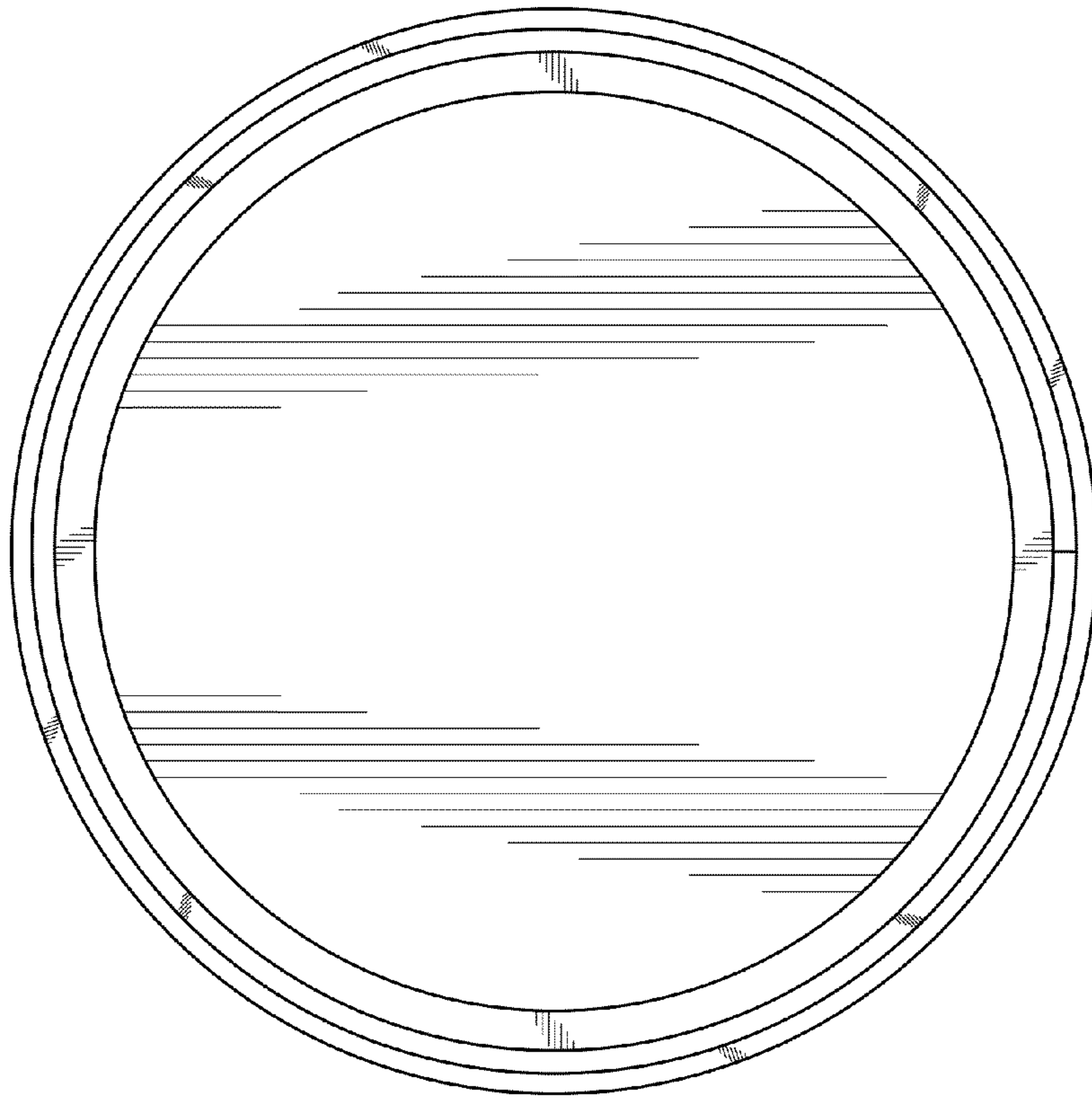

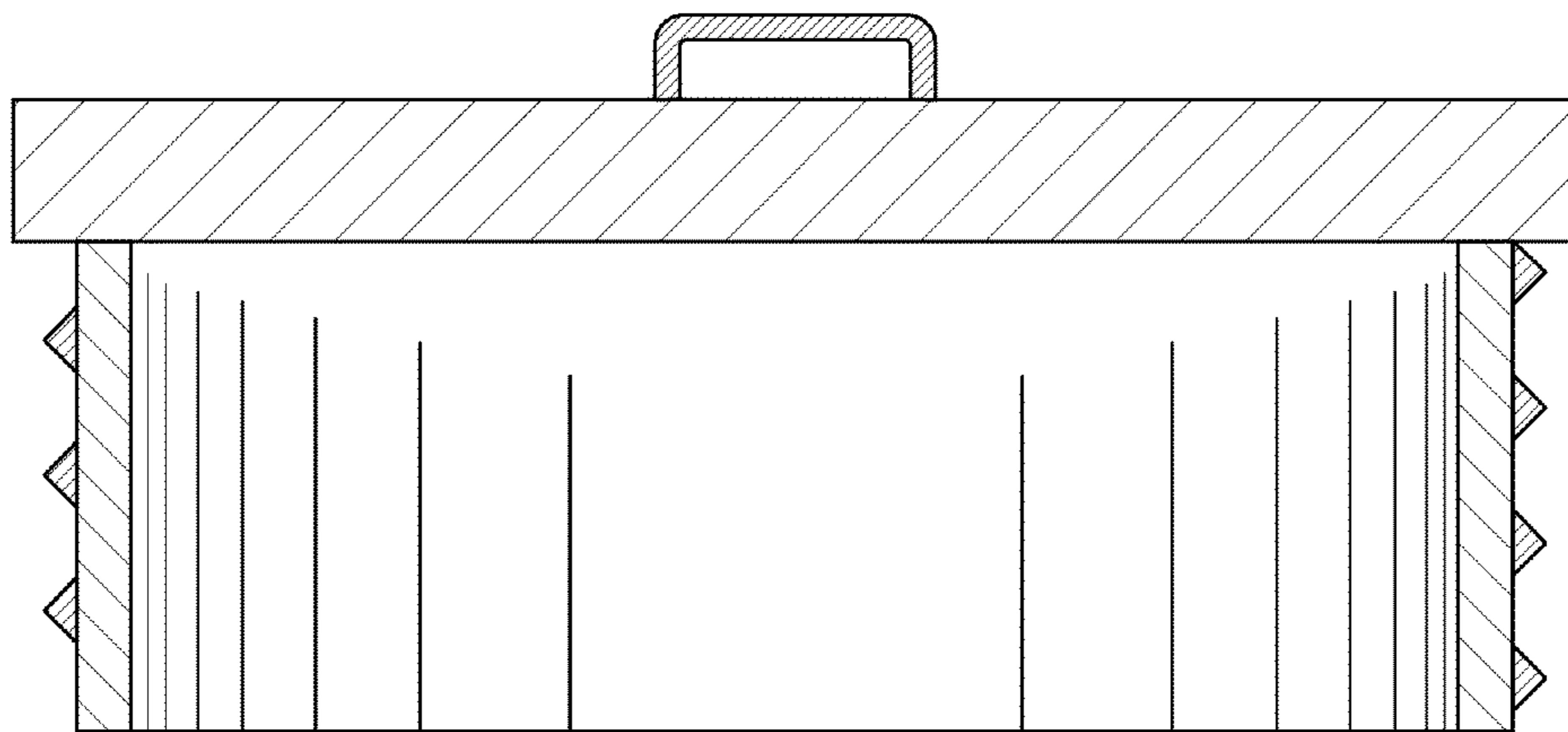

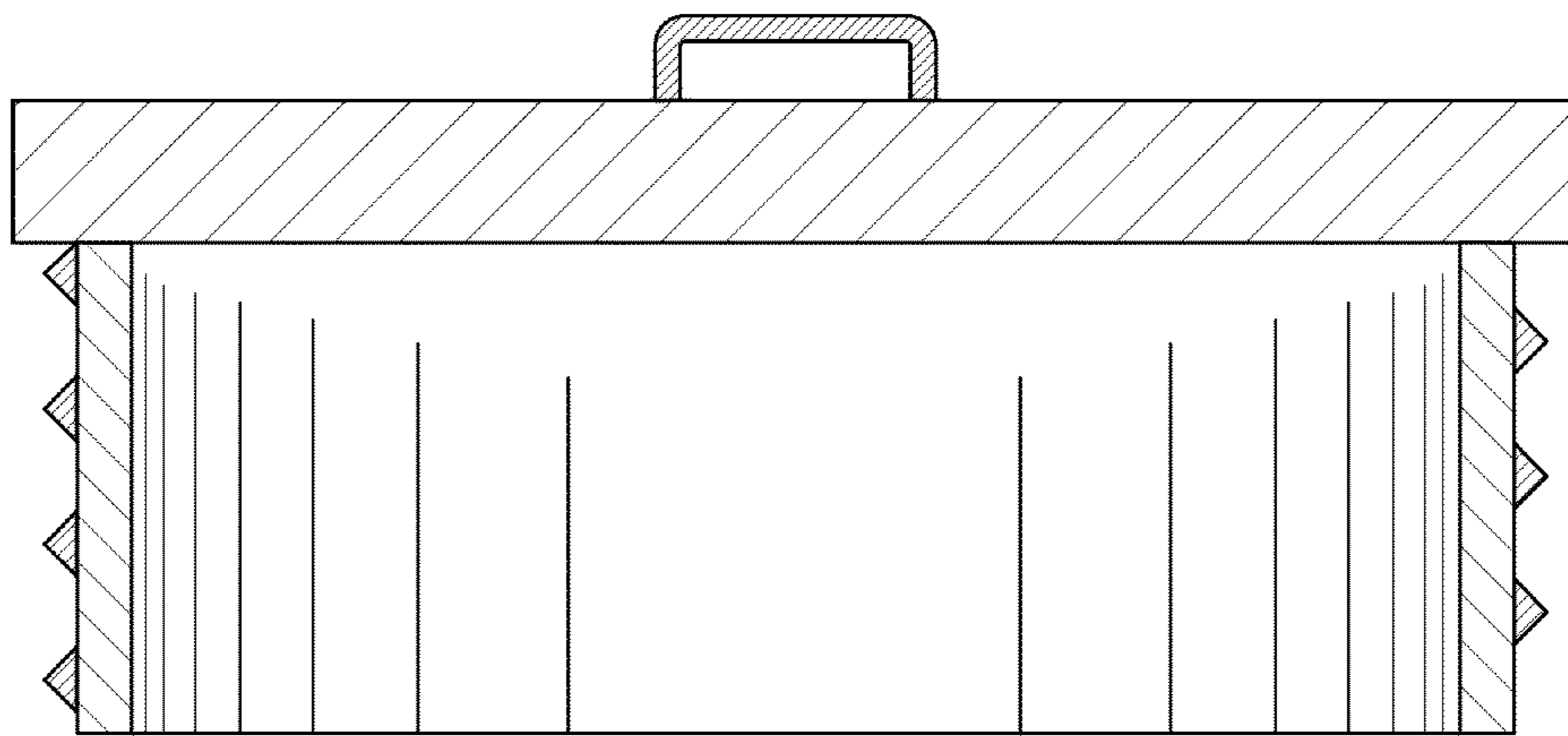

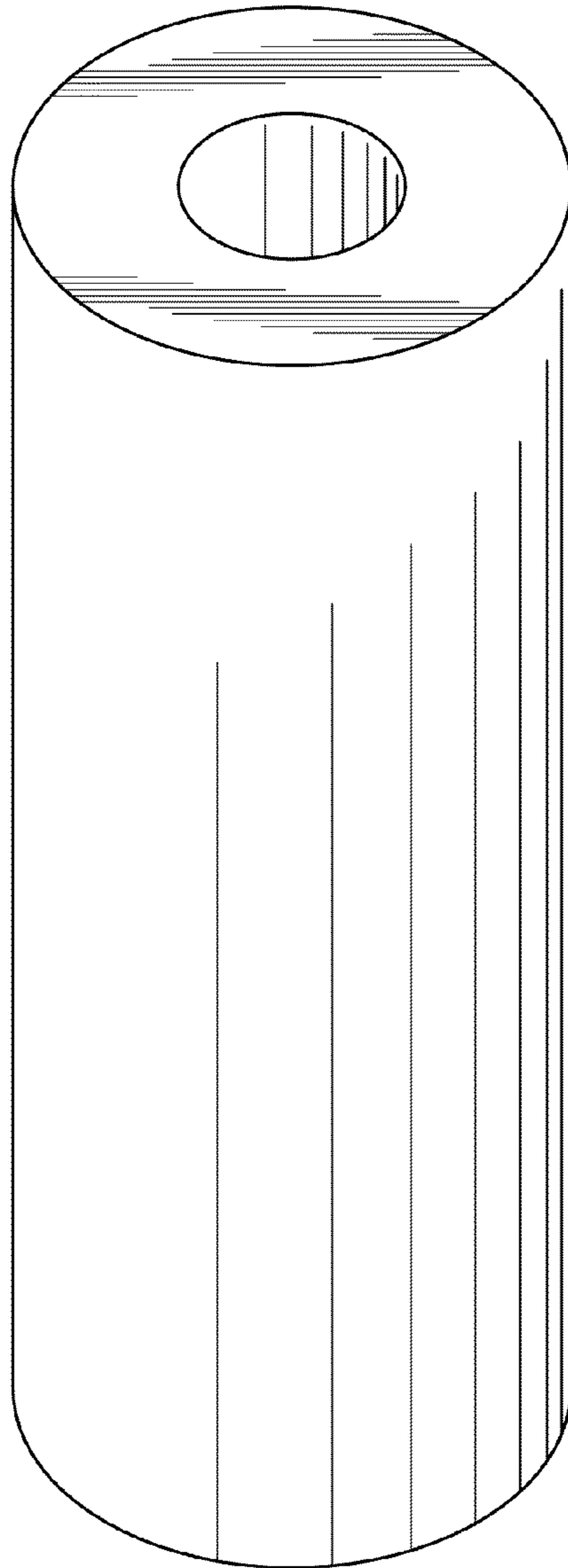

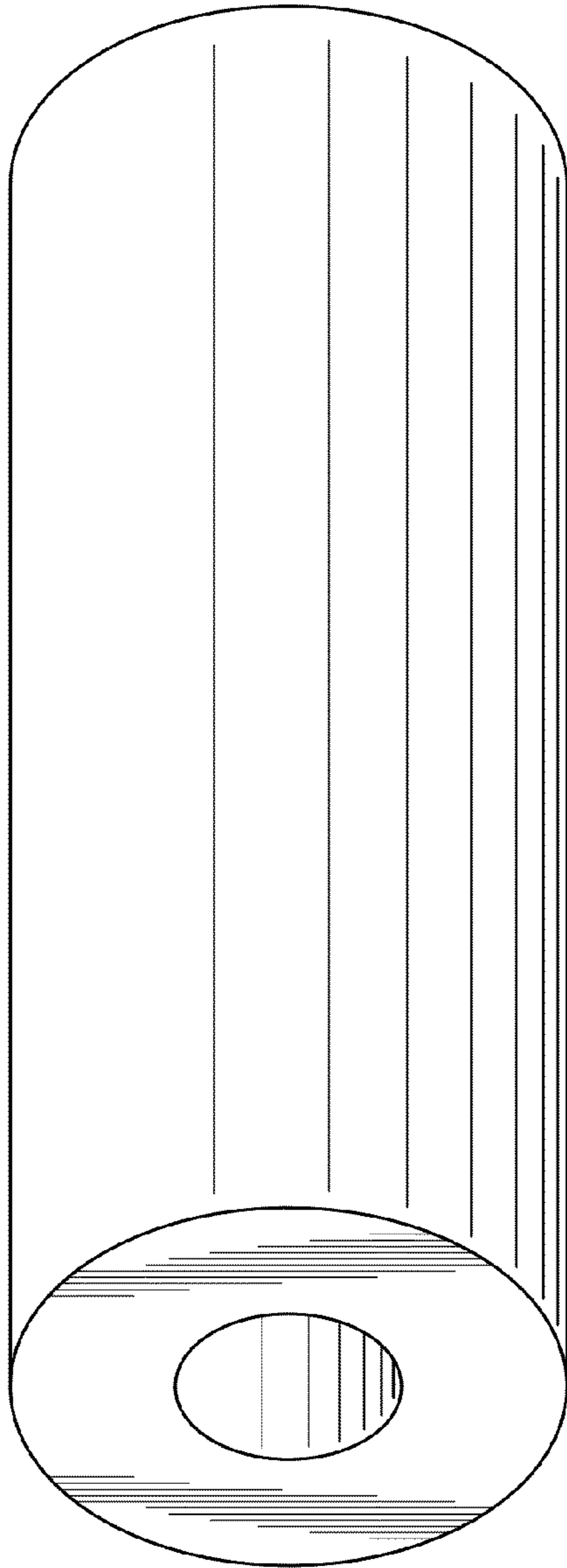

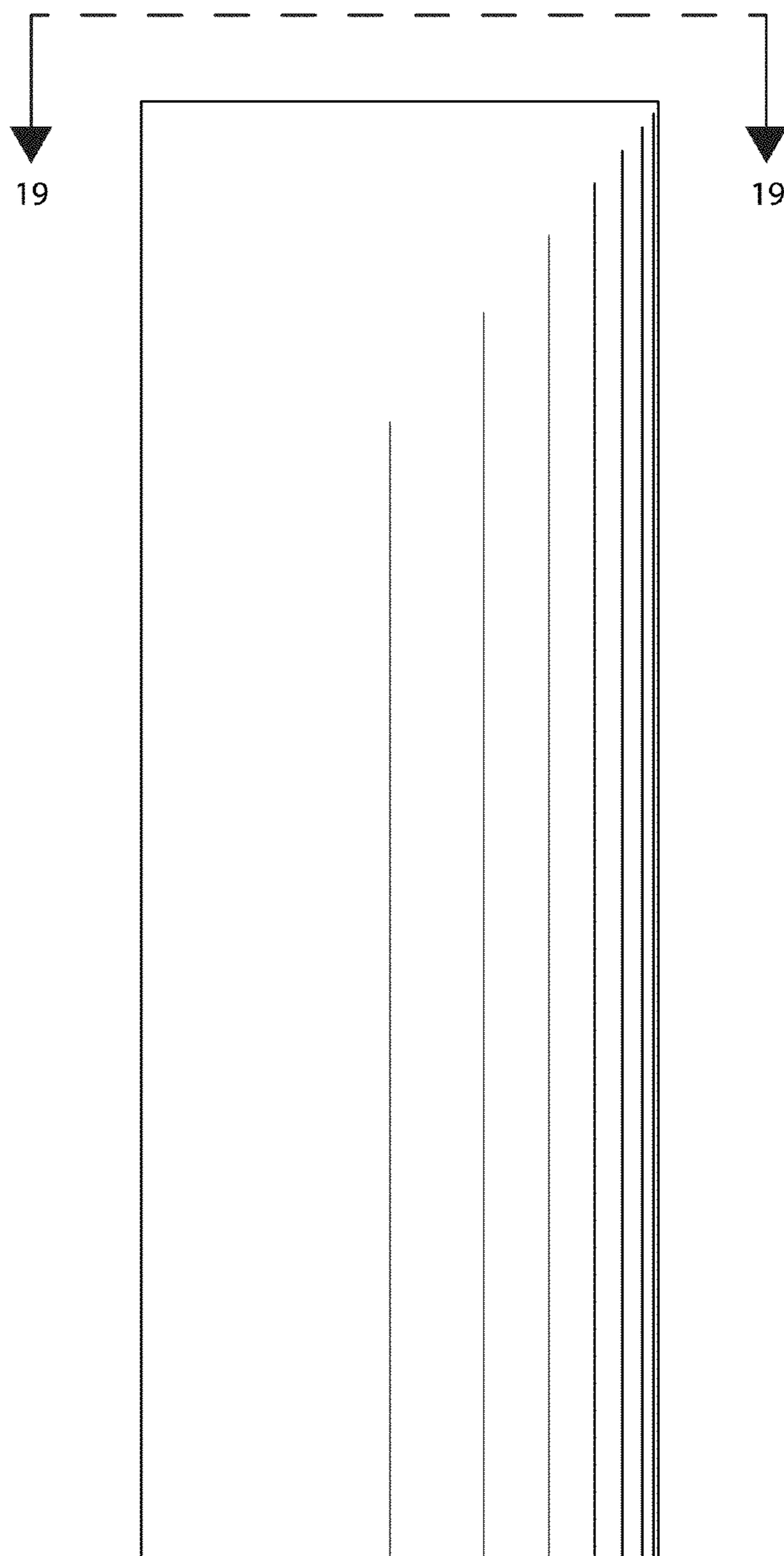

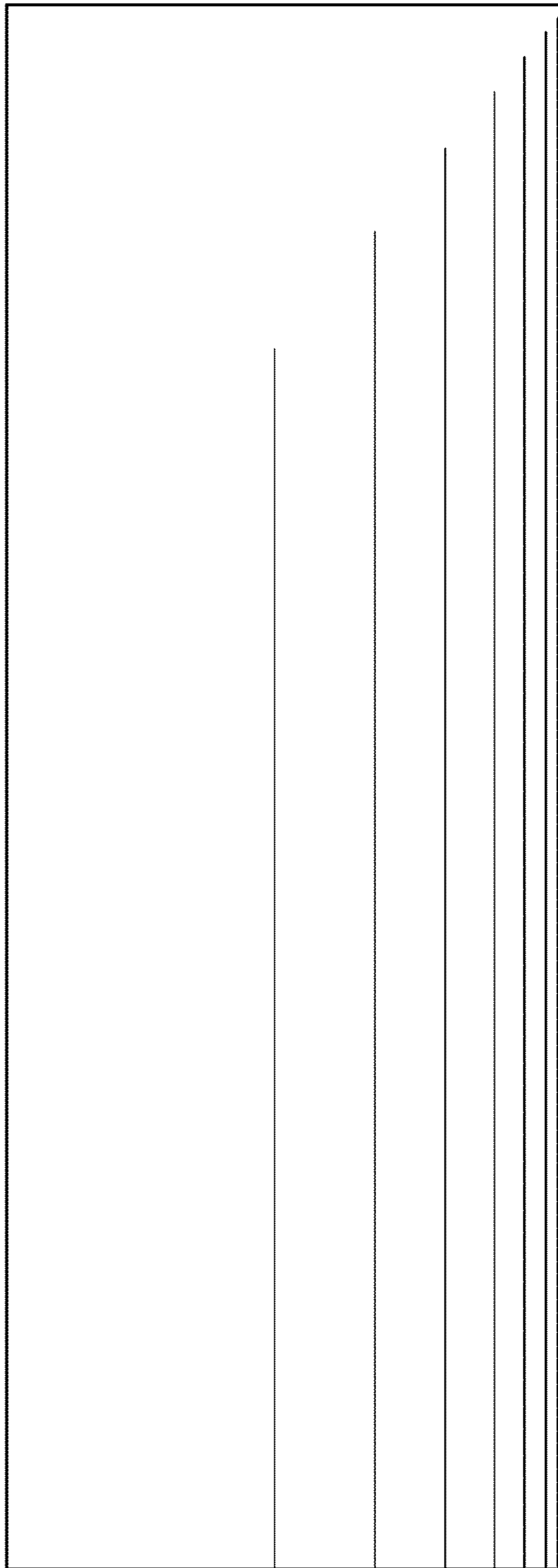

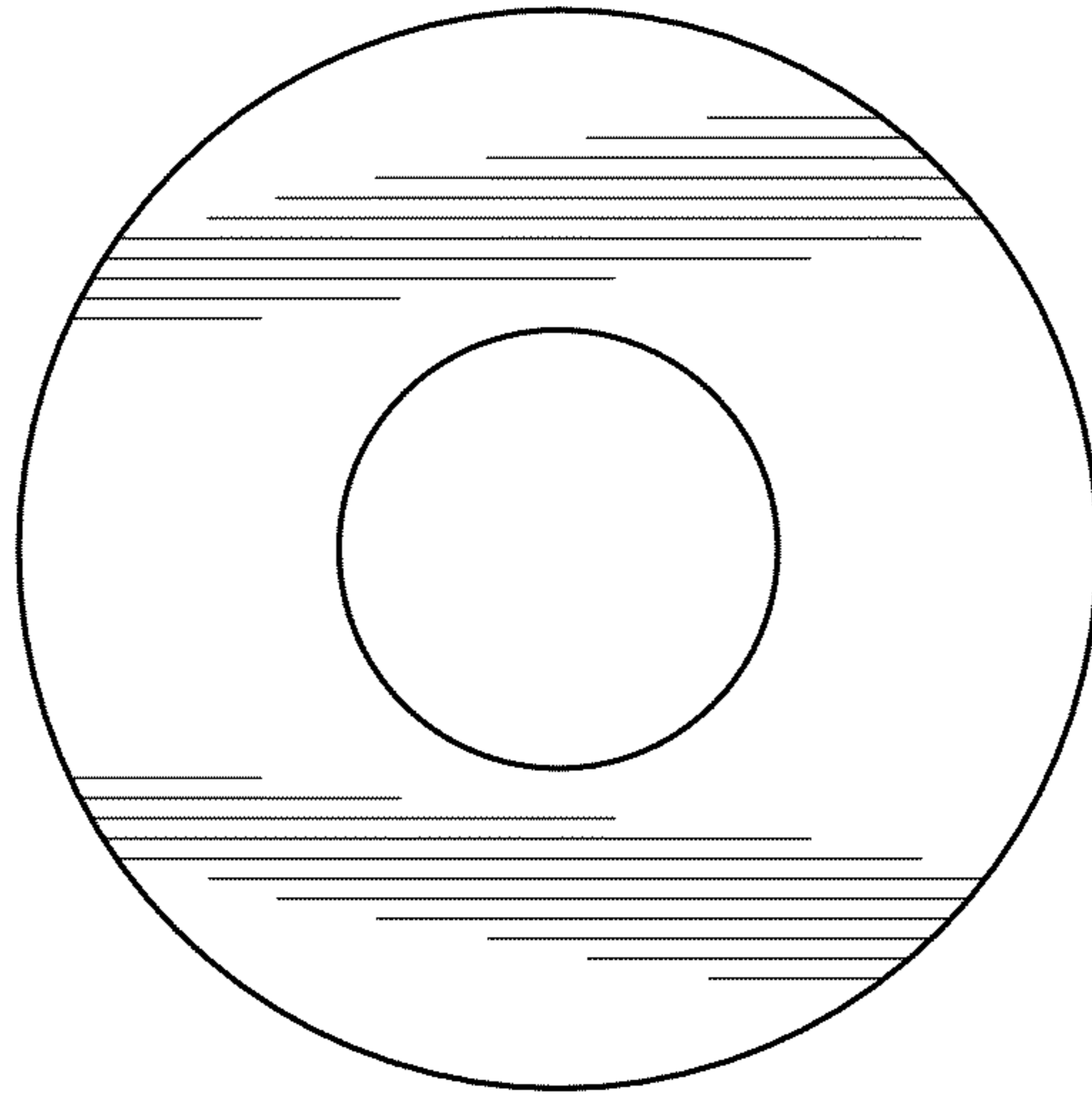

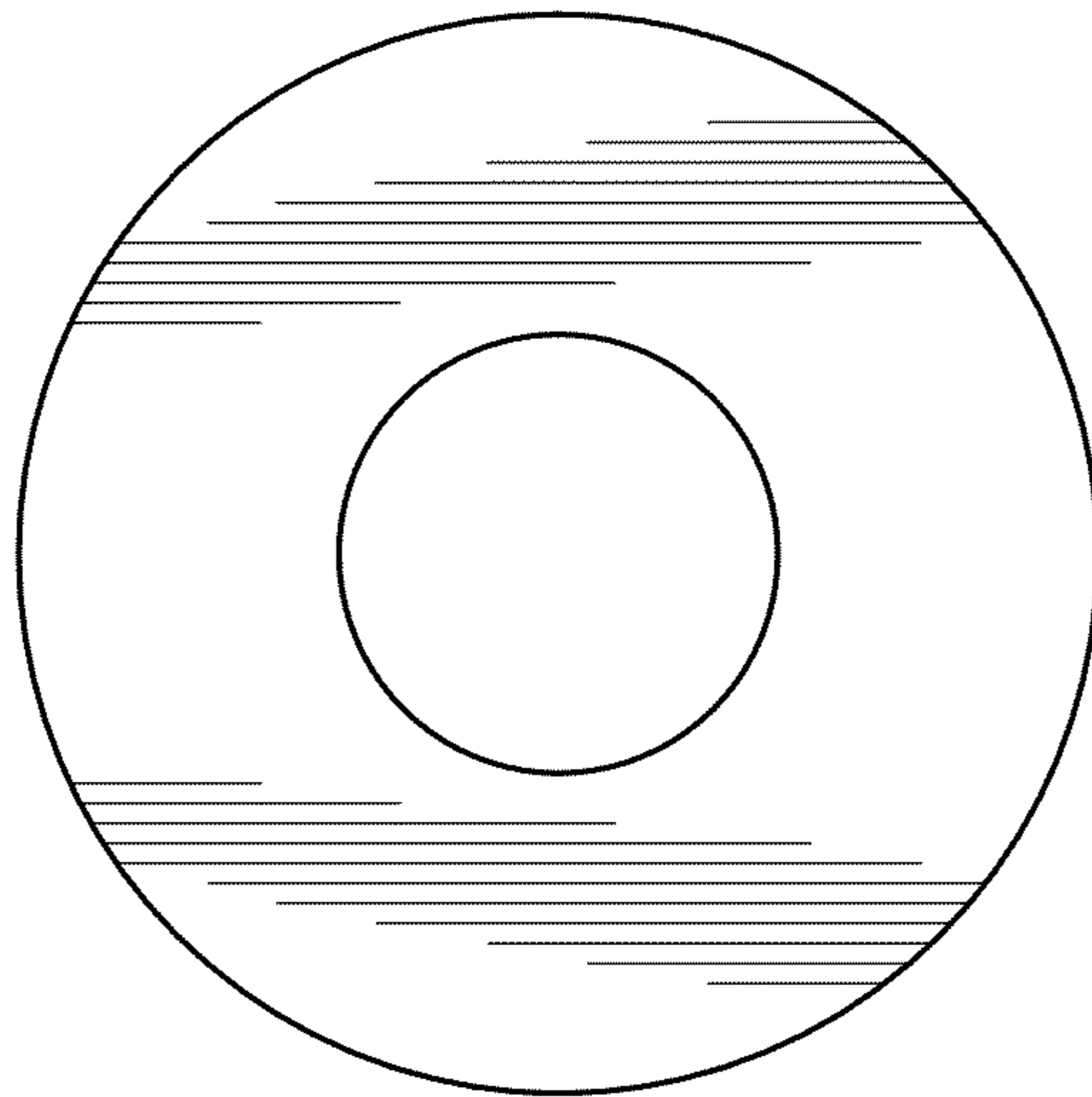

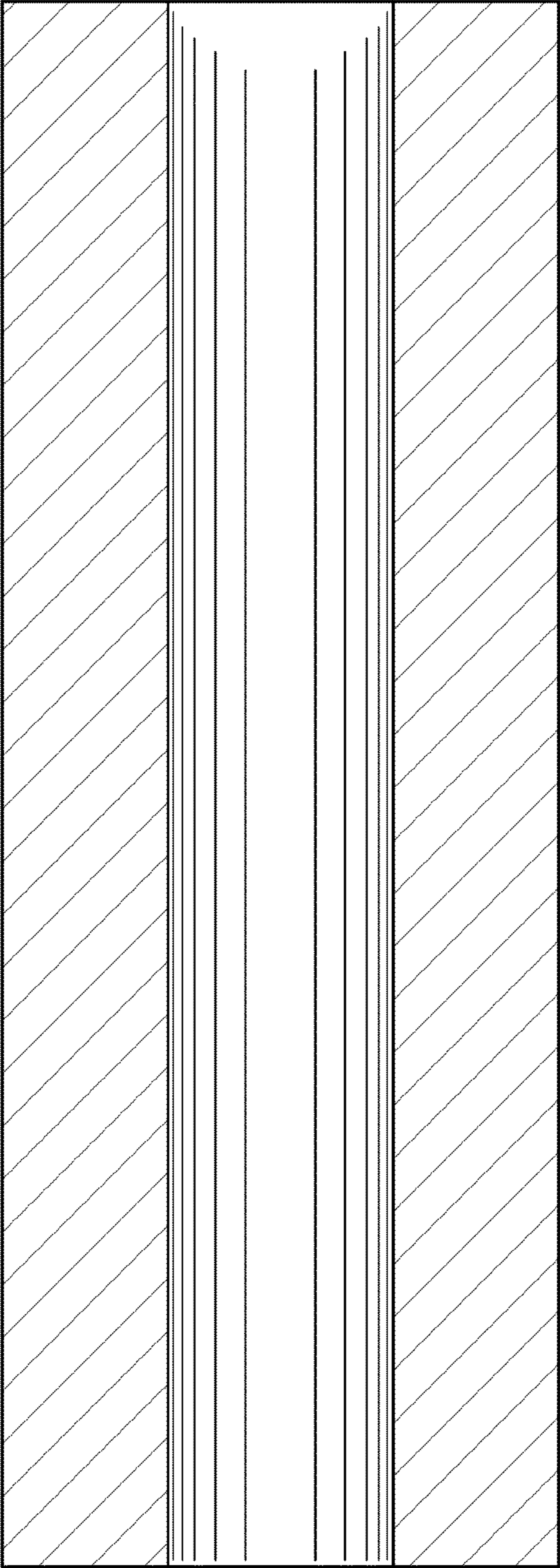

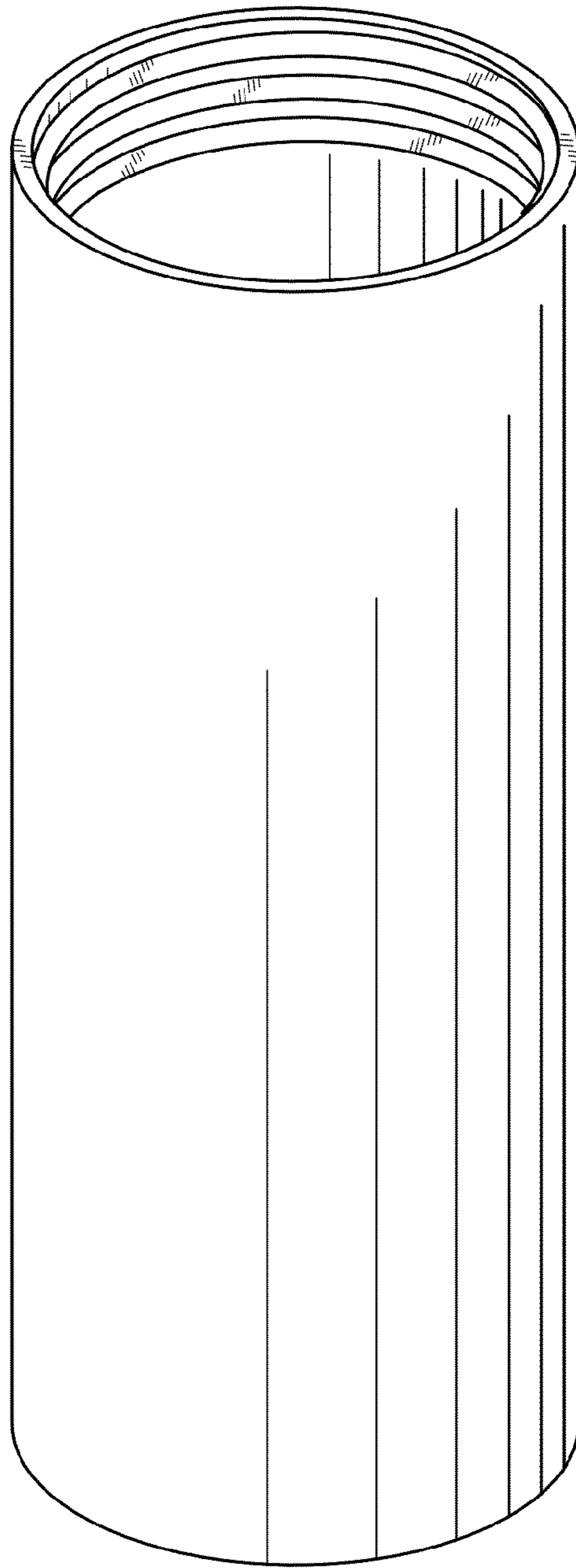

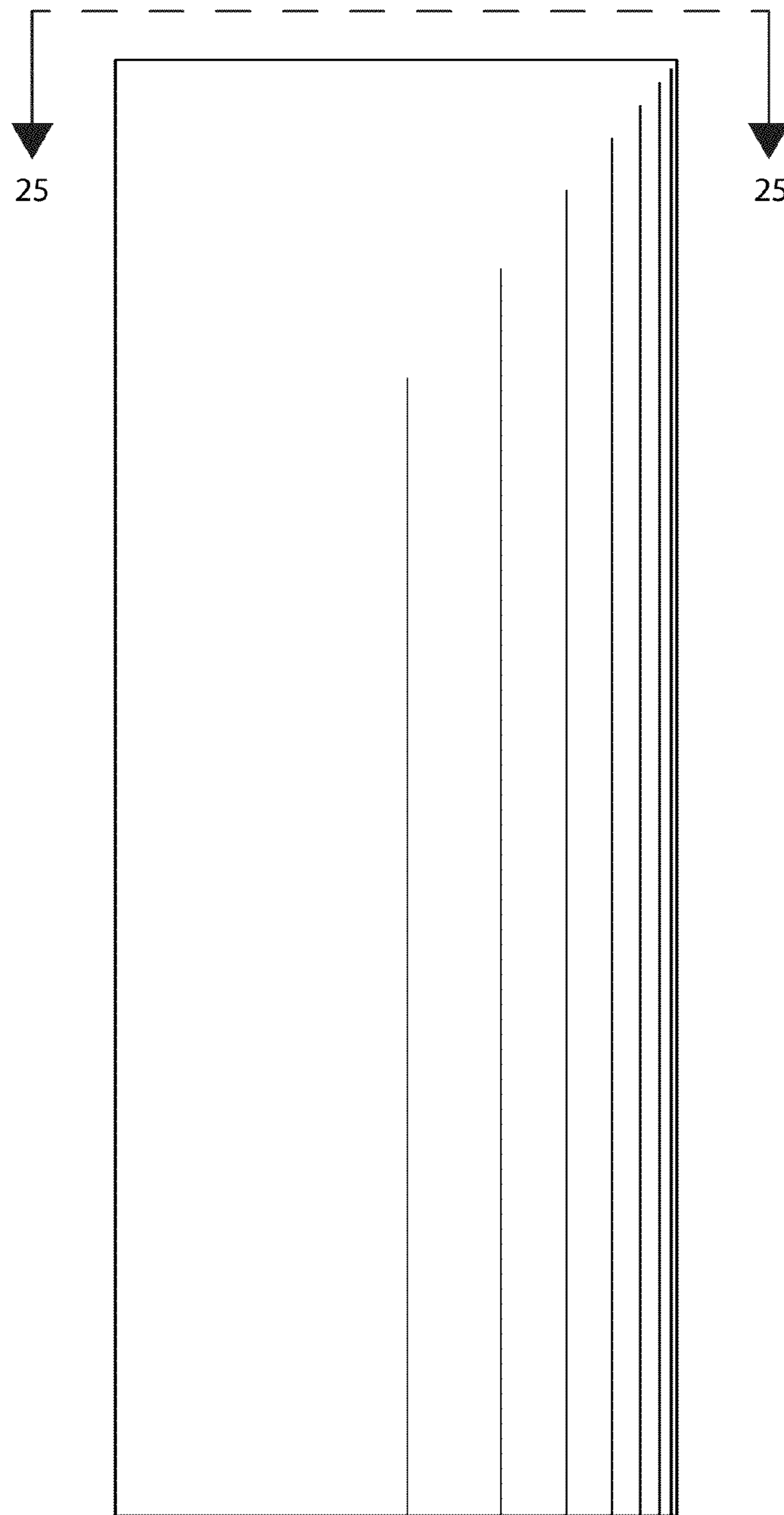

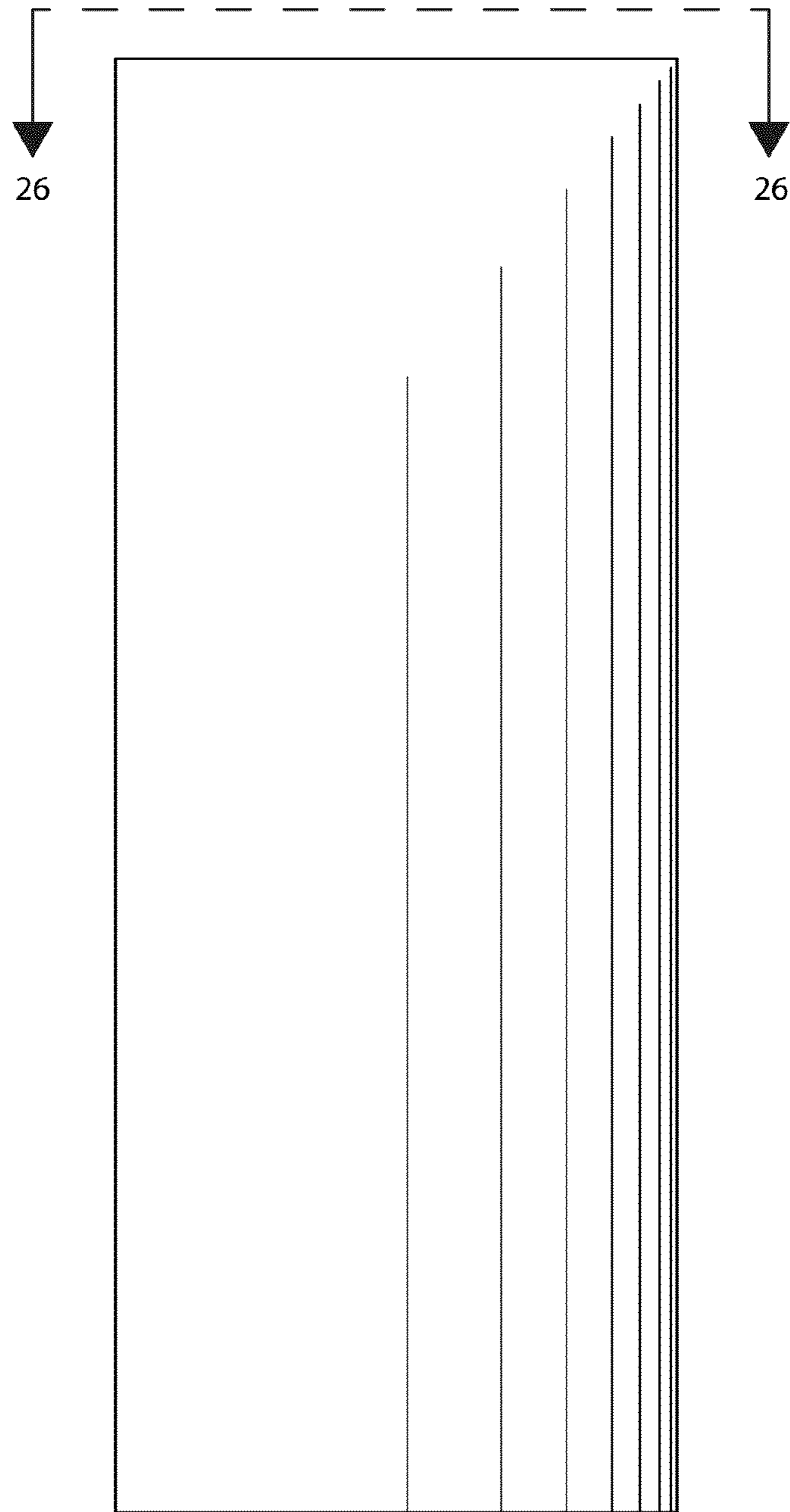

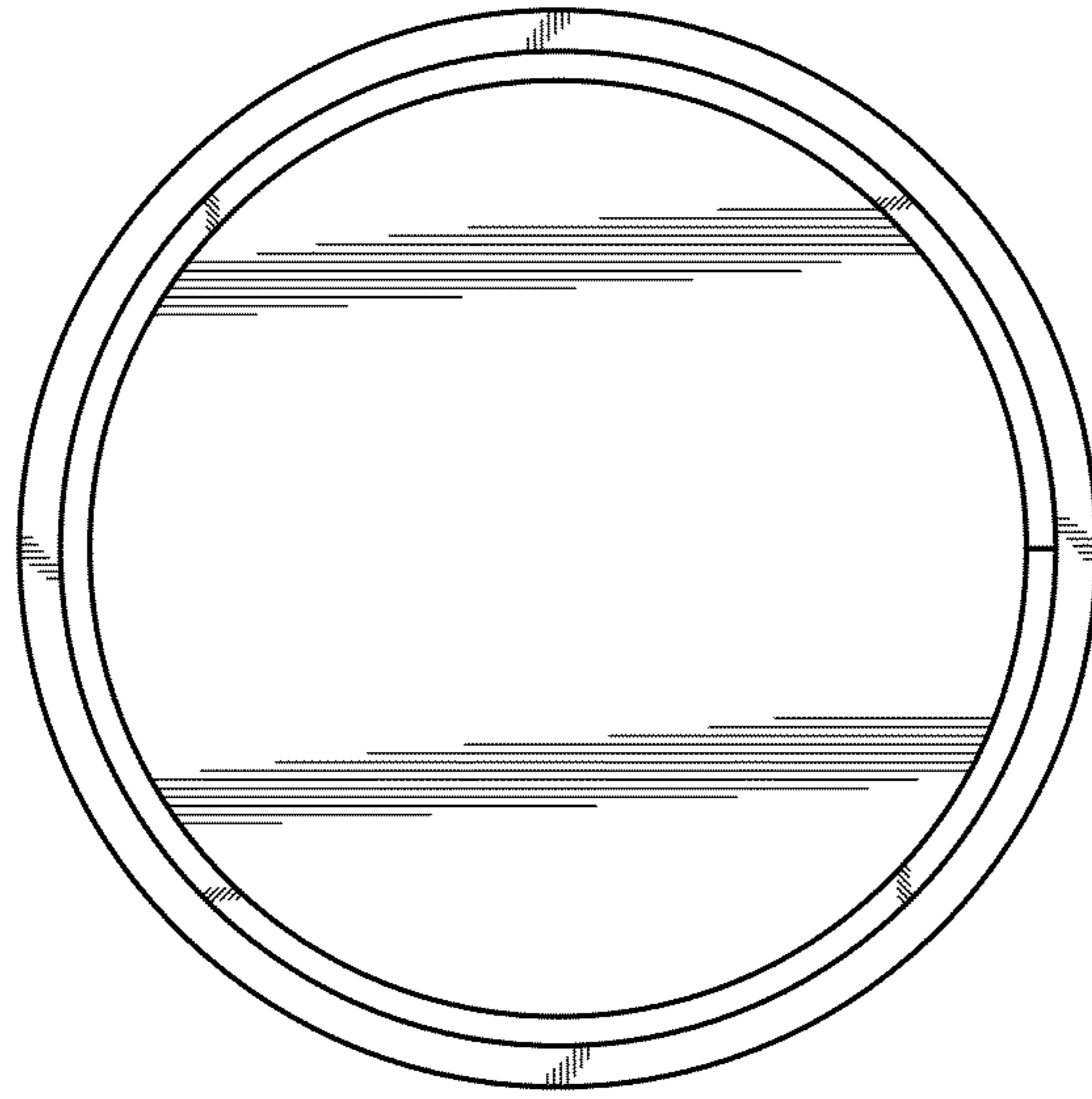

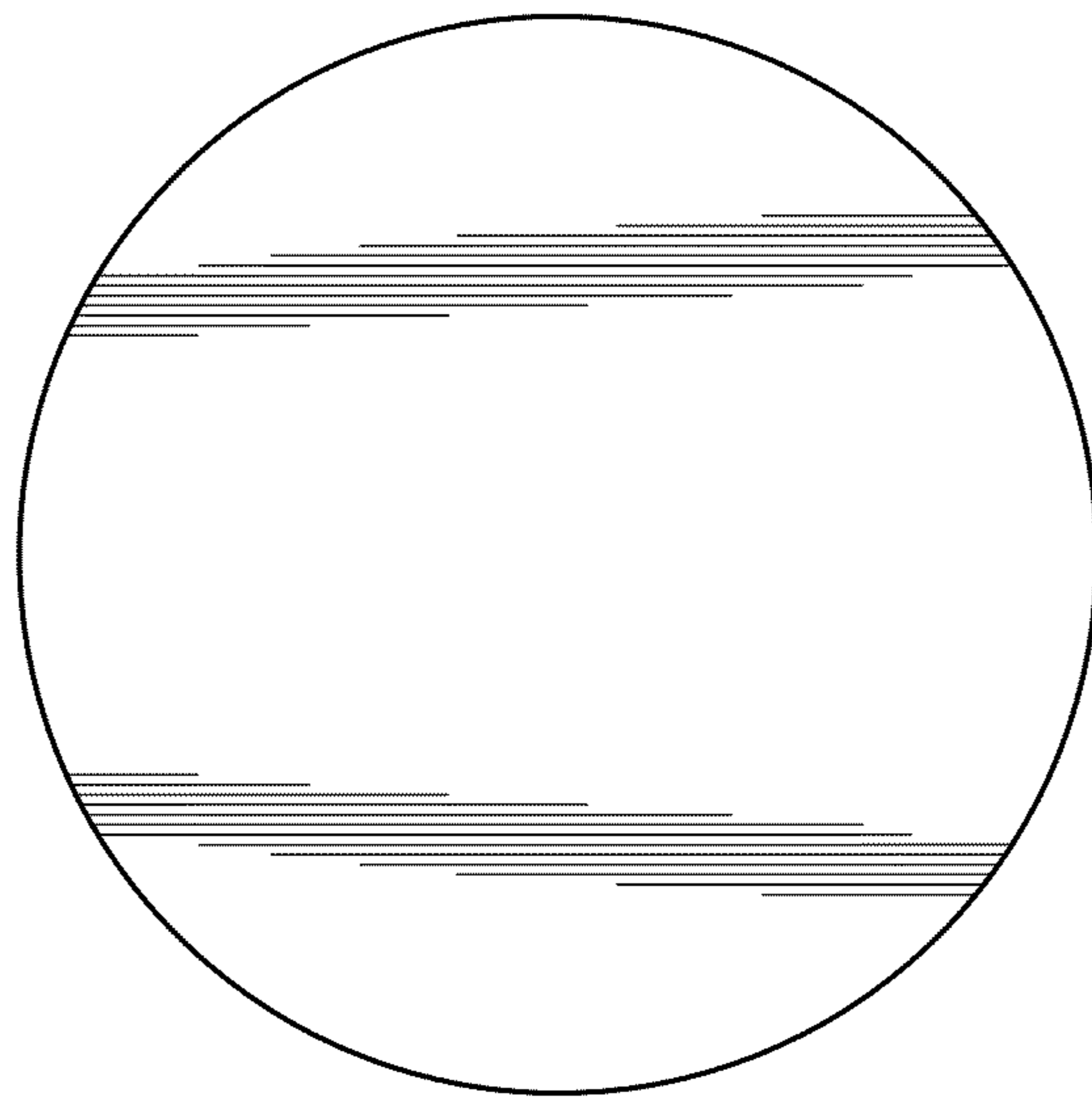

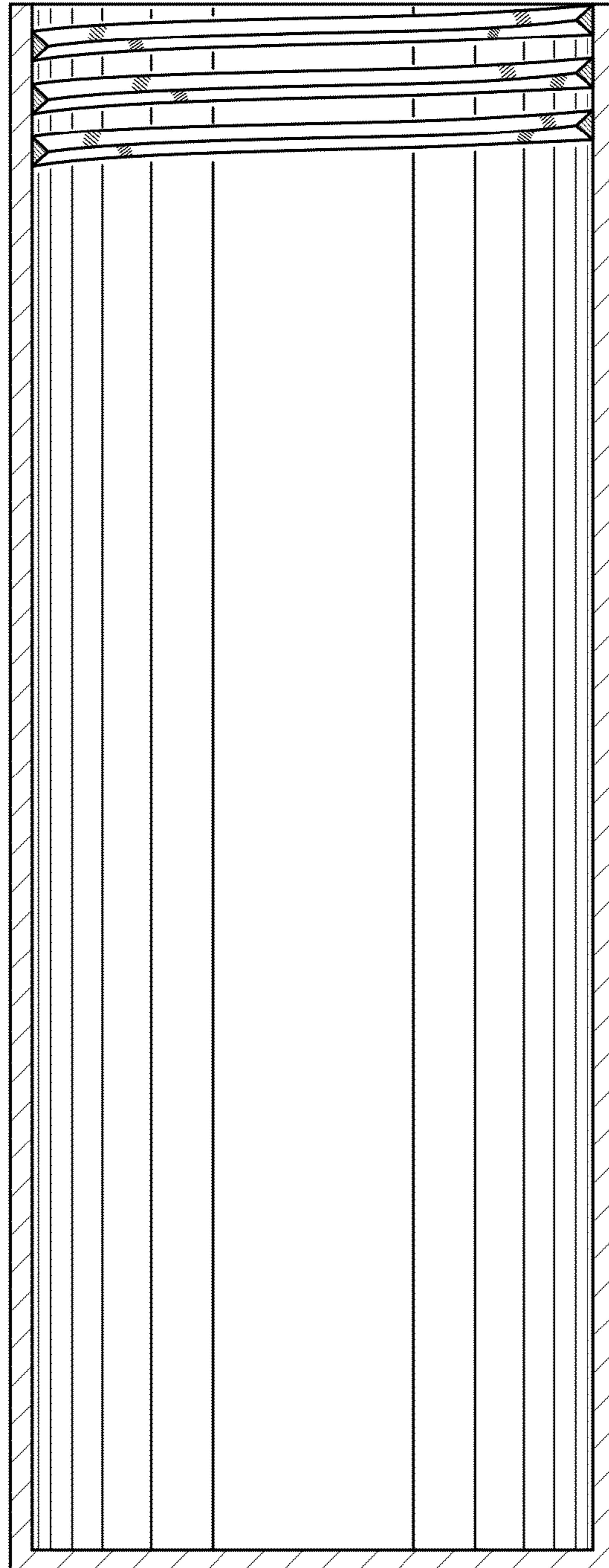

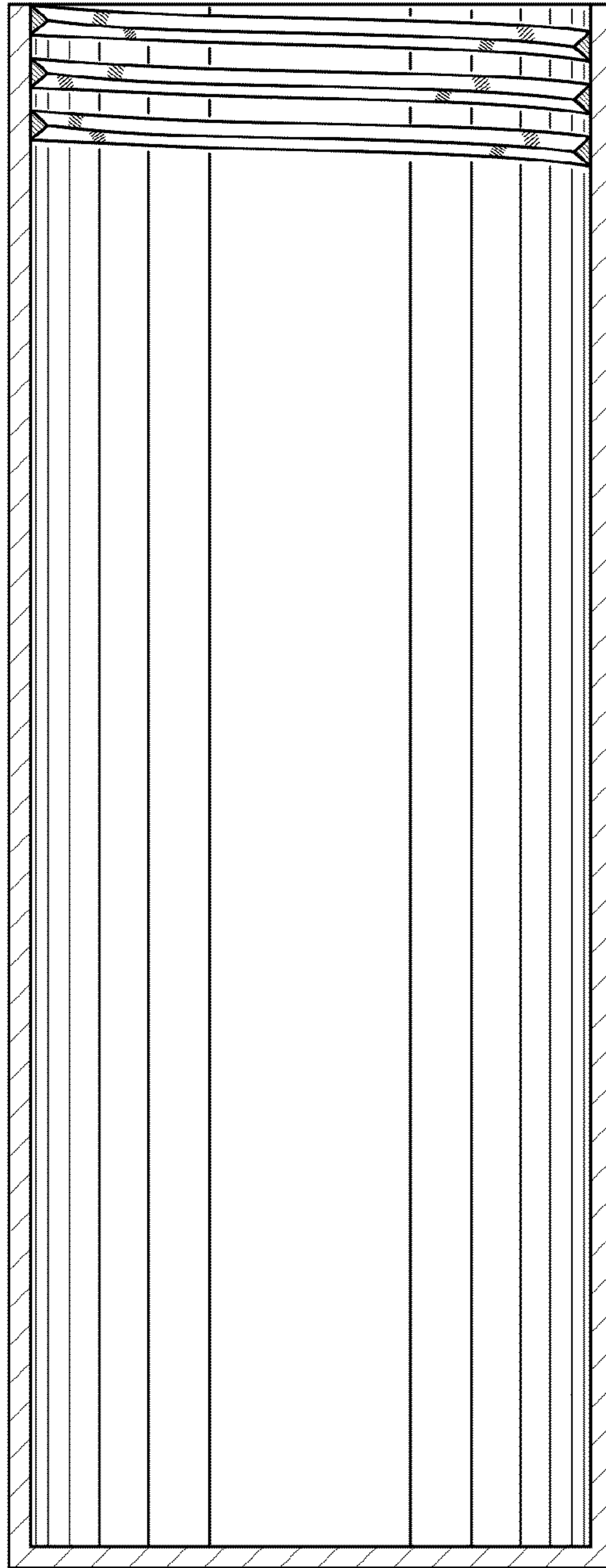
