(57) **CLAIM**

The ornamental design for a personal workspace furniture, as shown and described.

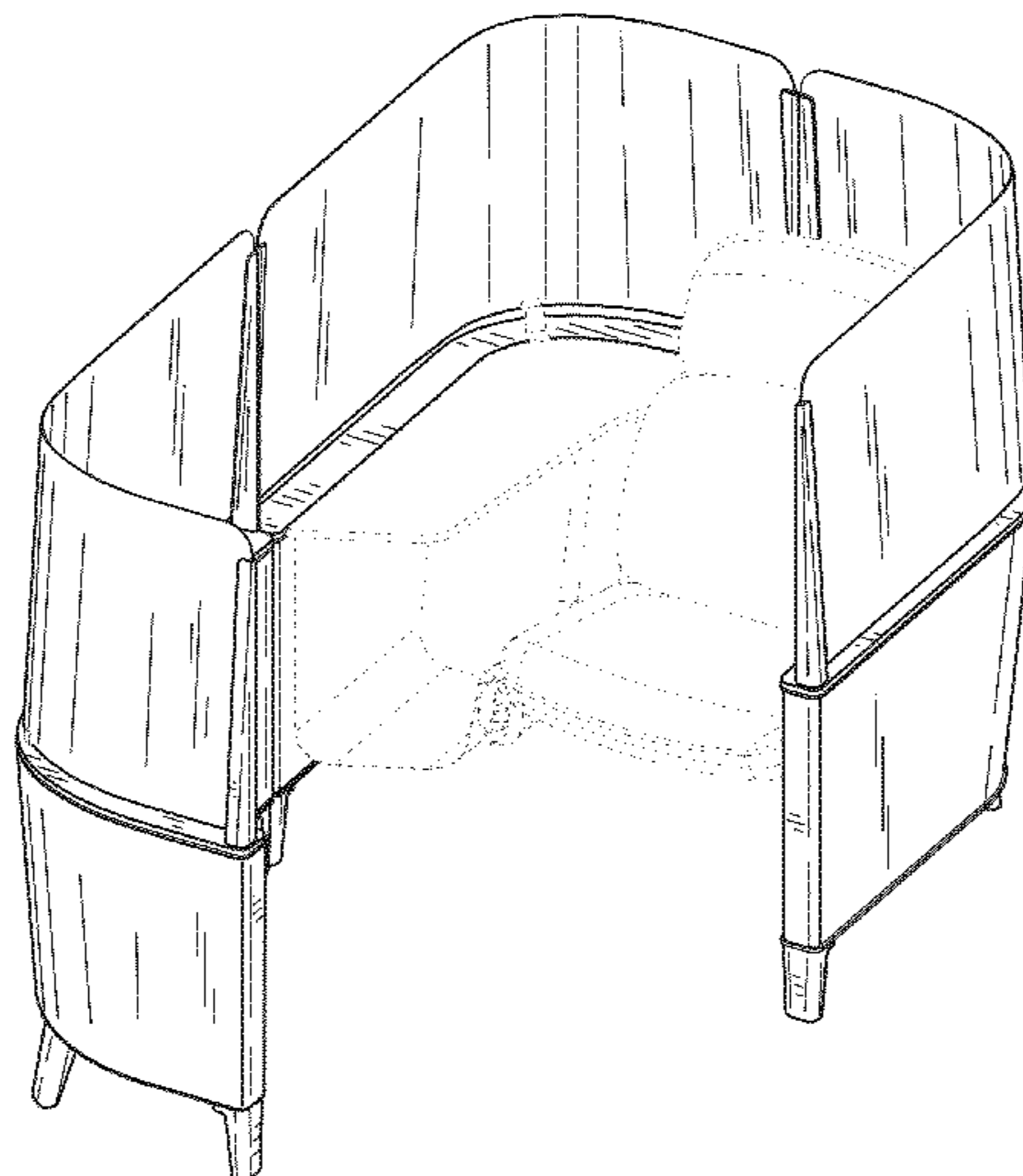
**DESCRIPTION**

FIG. 1 is a top, right, front perspective view of a personal workspace furniture embodying our new design; FIG. 2 is a right side elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

The broken line representations in the figures illustrate unclaimed environment, and thus form no part of the claimed design. The dash-dot-dash lines define boundaries of the claimed design and form no part of the claimed design.

The nature of this product is a walled enclosure or personal workspace furniture for surrounding a seating area, for example, including a chair and table or desk top.

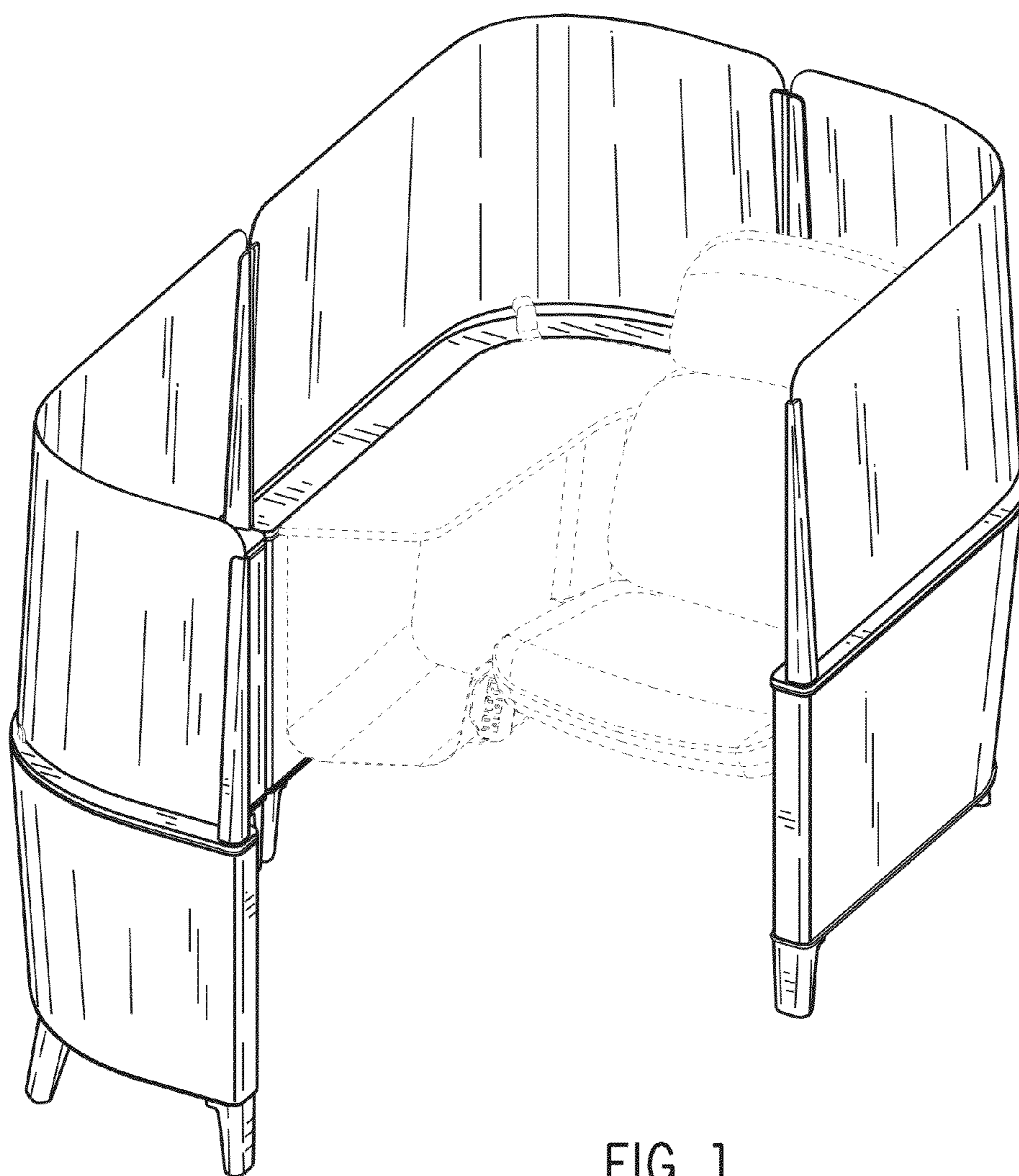

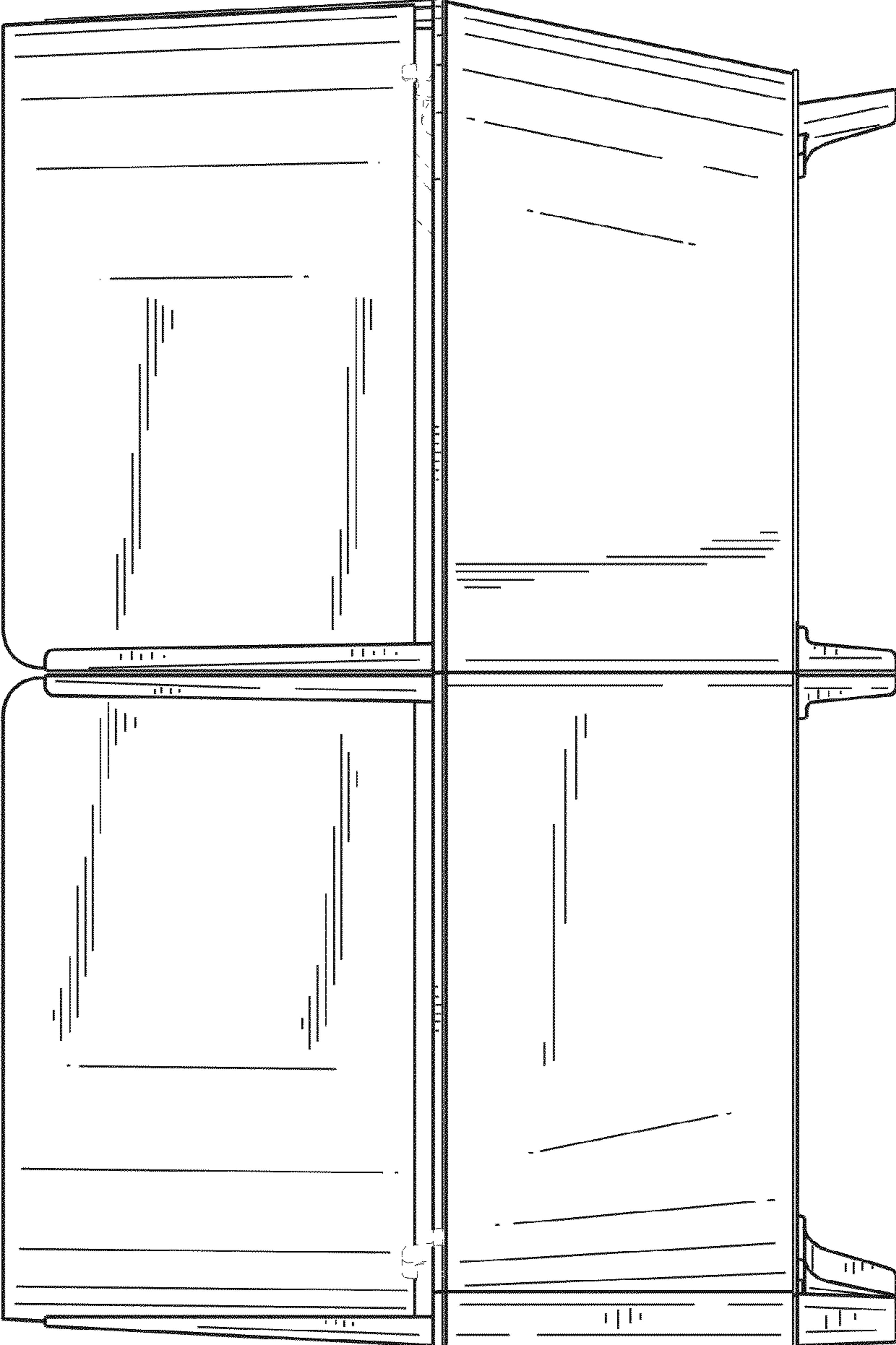

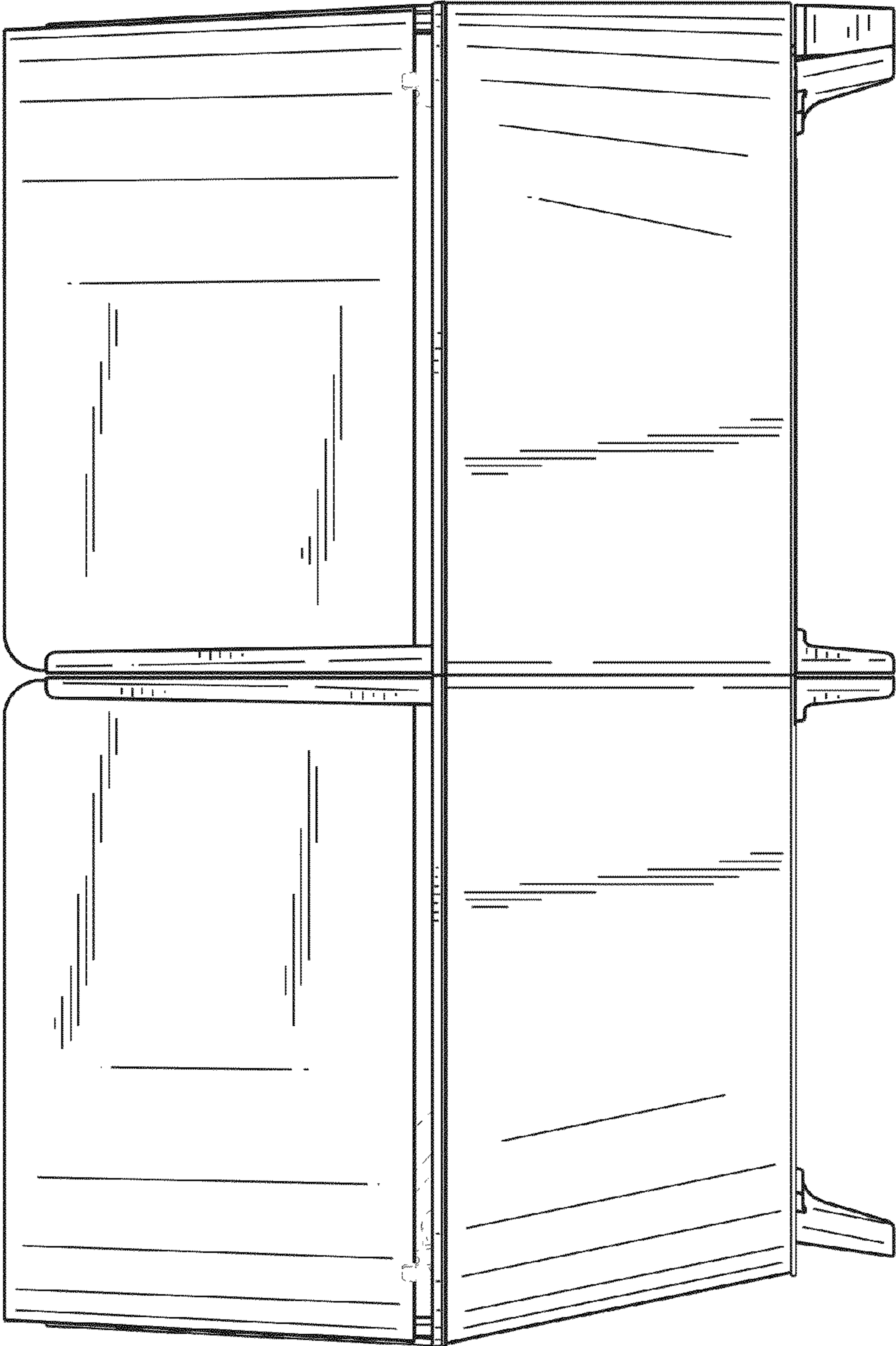

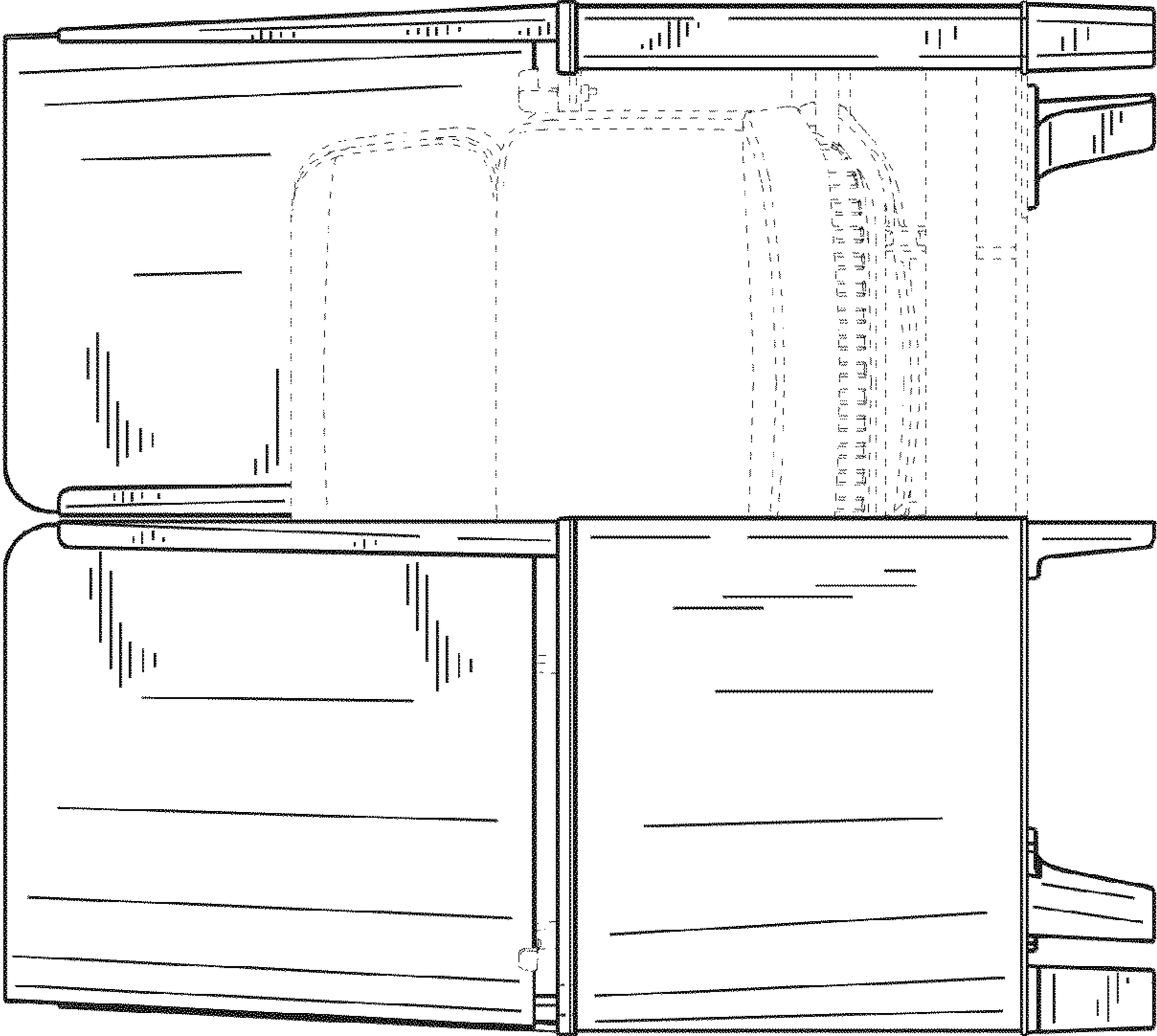

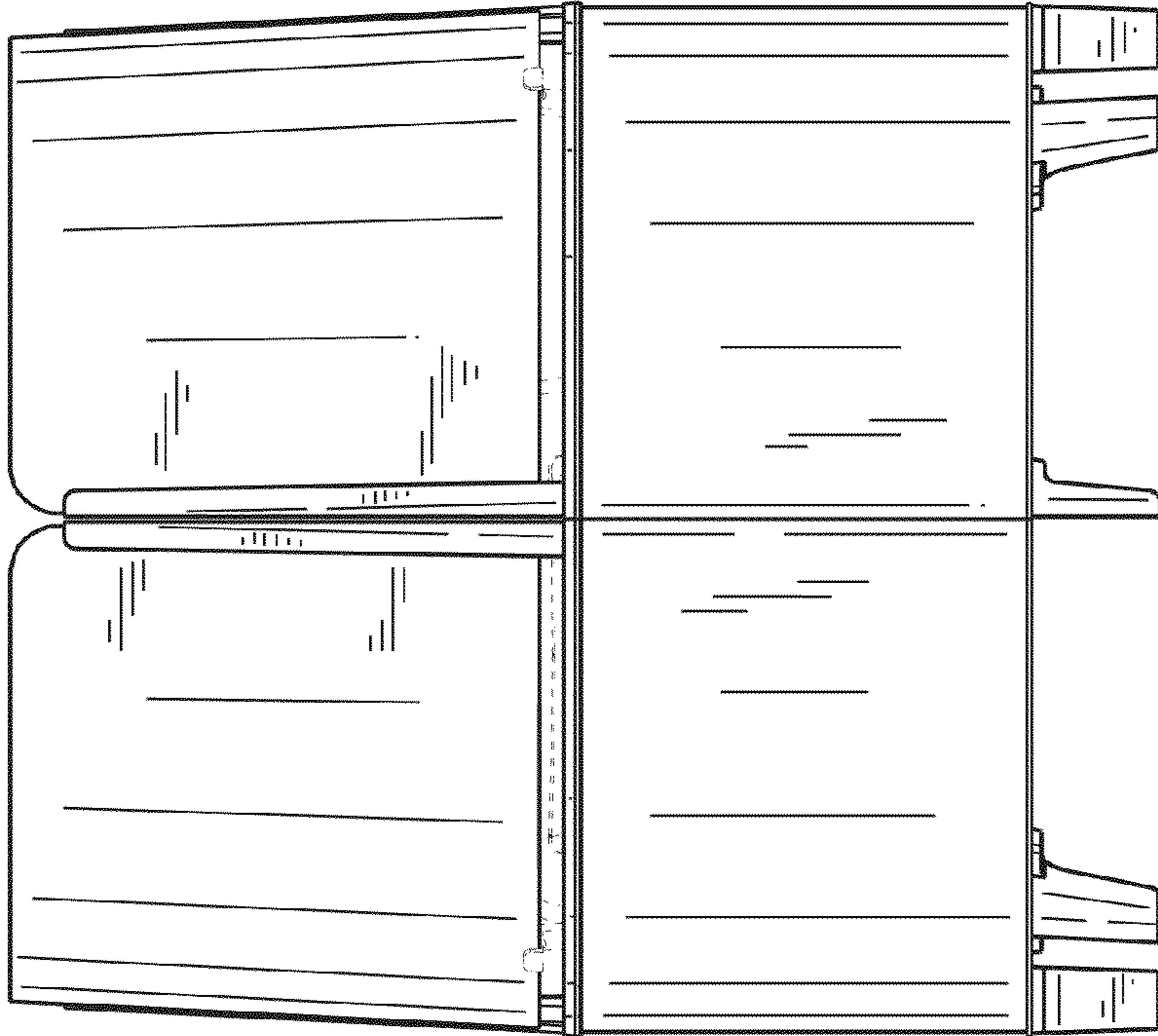

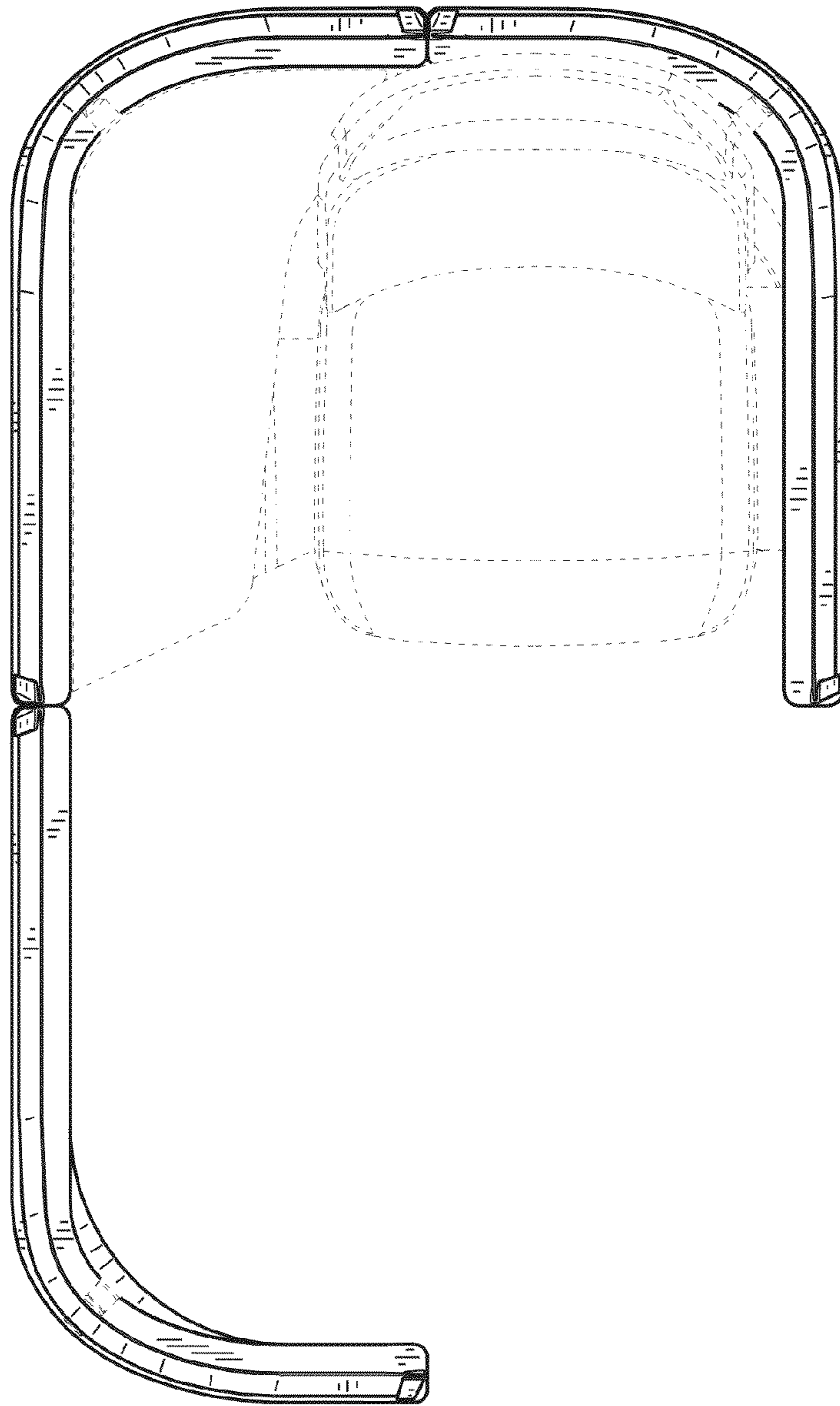

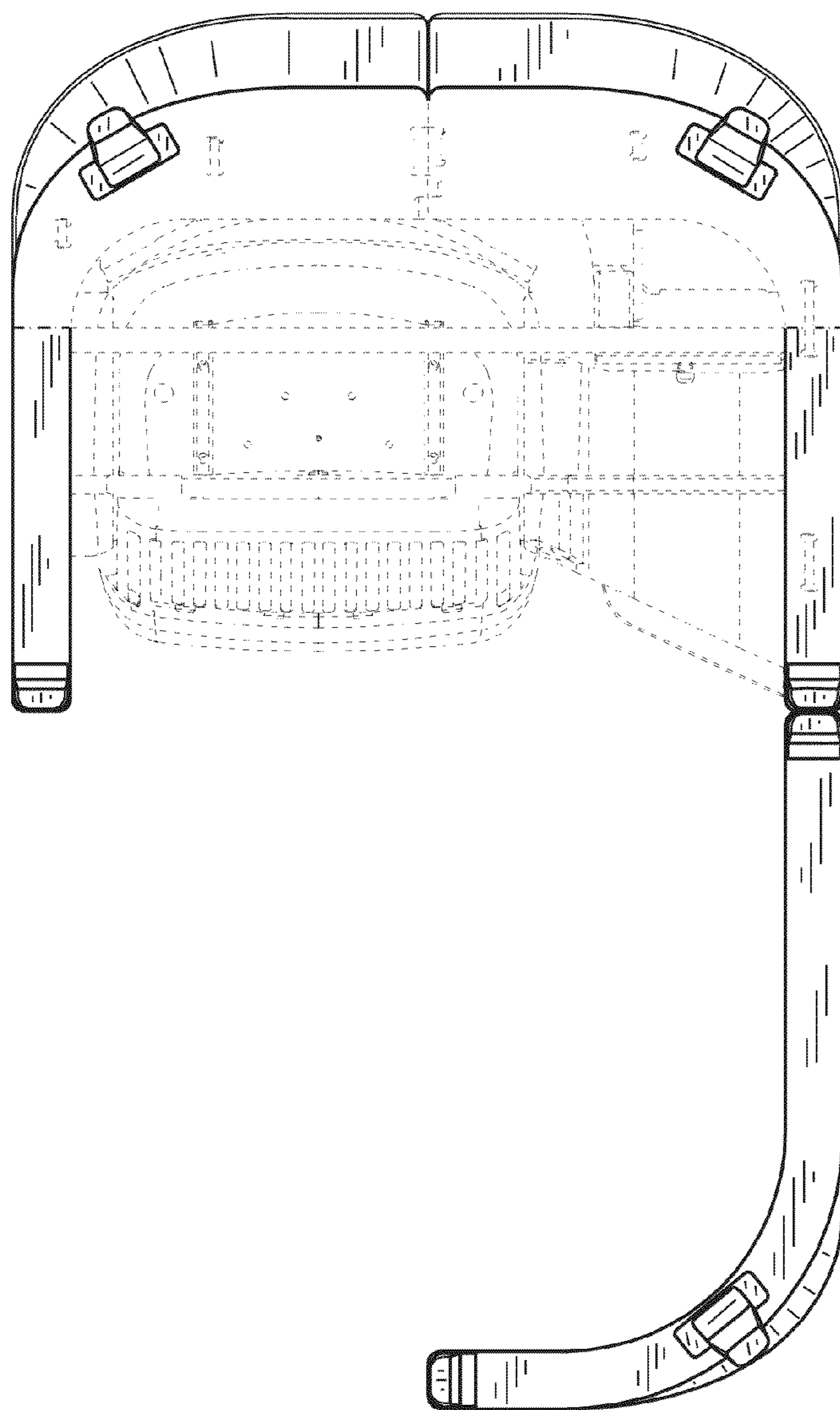
