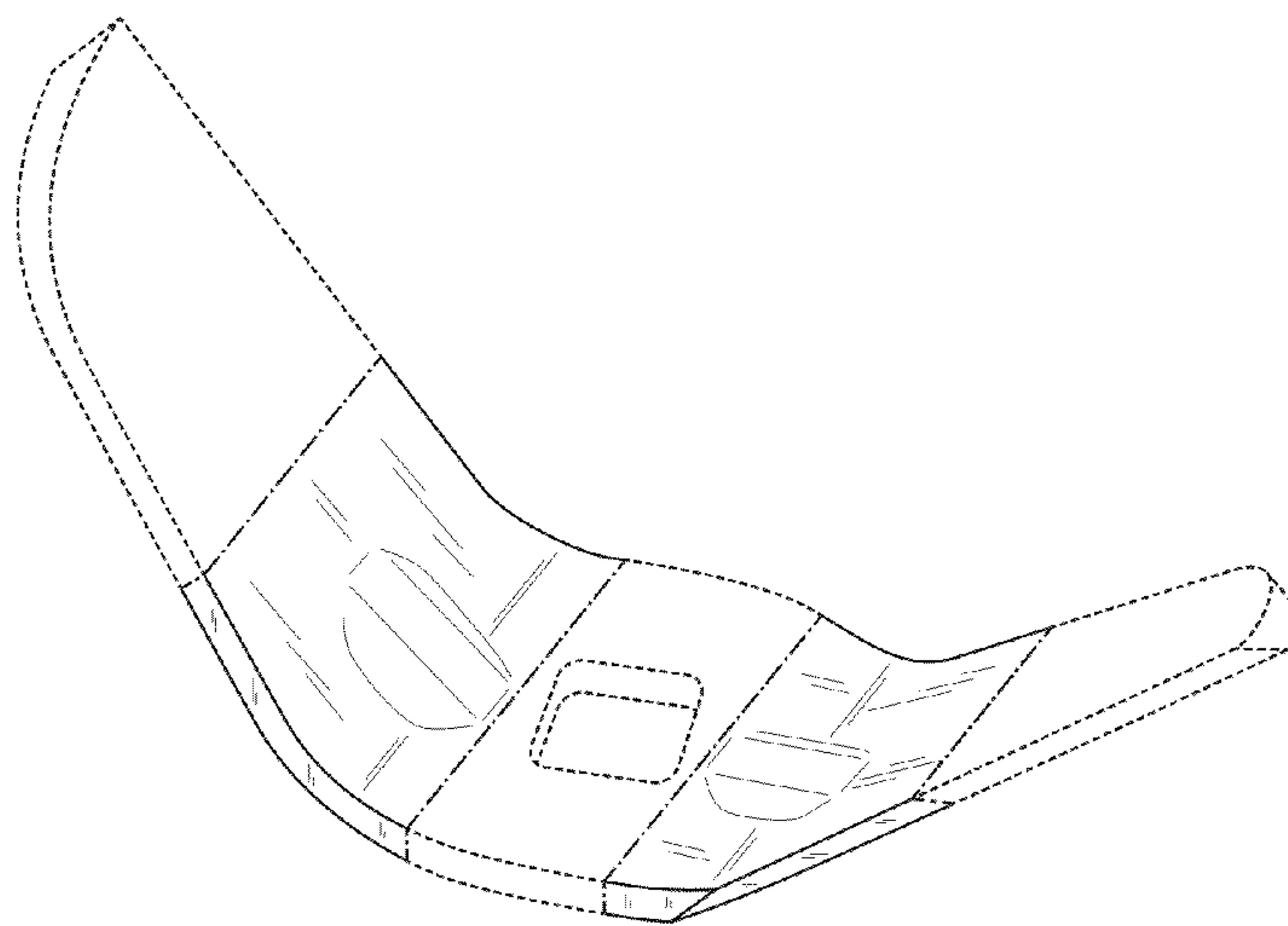
(57) **CLAIM**  
The ornamental design for a blade, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right side perspective view of a blade showing my new design;  
FIG. 2 is a bottom, front, right side perspective view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a rear elevational view thereof;  
FIG. 6 is a front elevational view thereof;  
FIG. 7 a right side elevational view thereof; and,  
FIG. 8 is a left side elevational view thereof.  
The dashed broken lines represent unclaimed portions of the blade and form no part of the claimed design. The dash-dot-dash broken lines define boundaries of the claimed design and form no part of the claimed design.

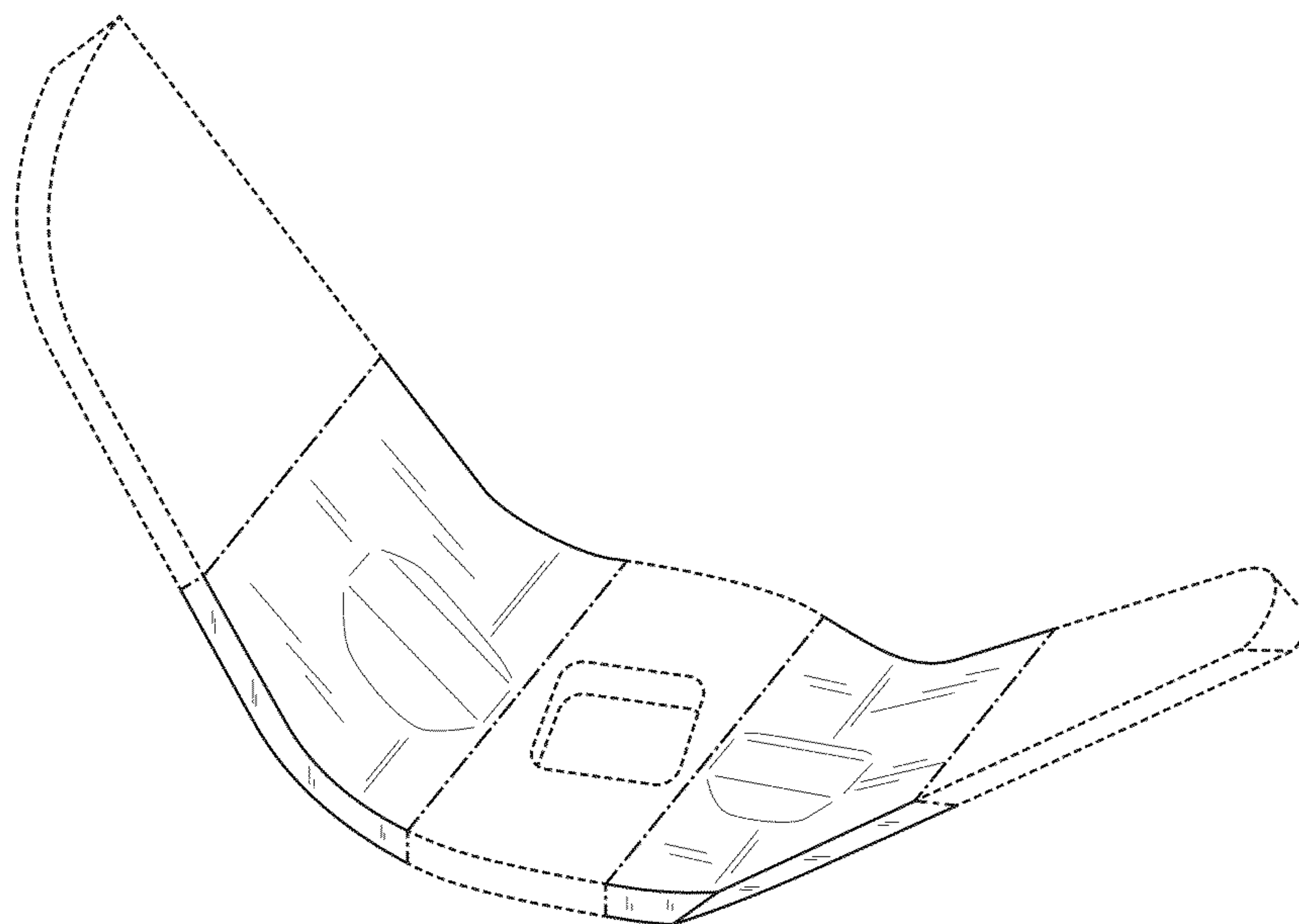

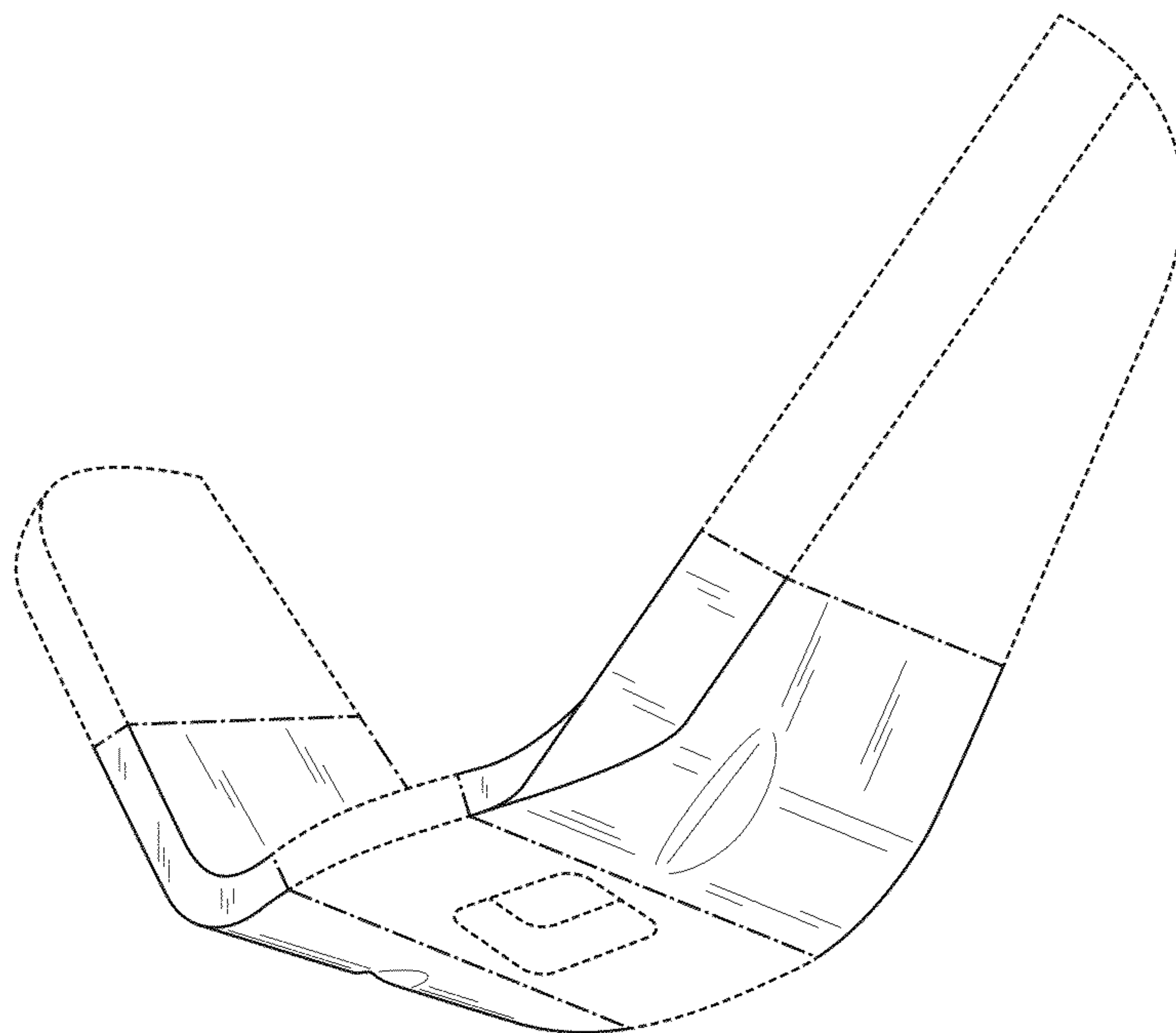

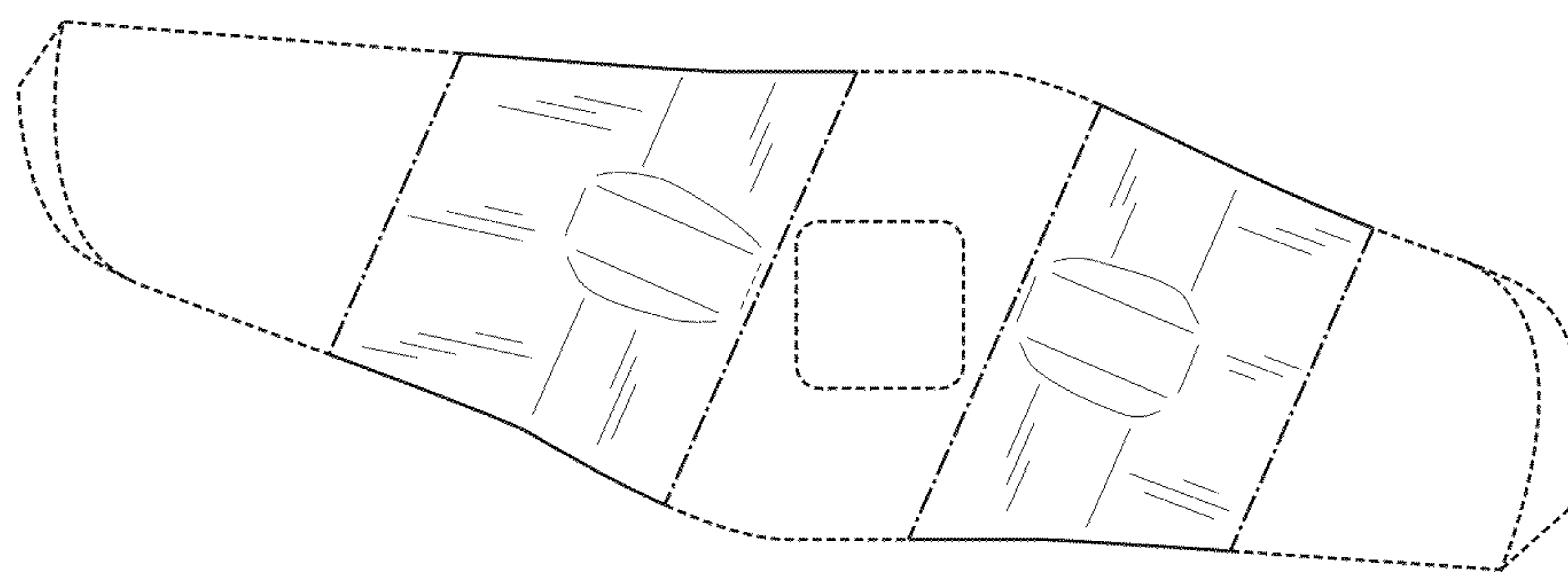

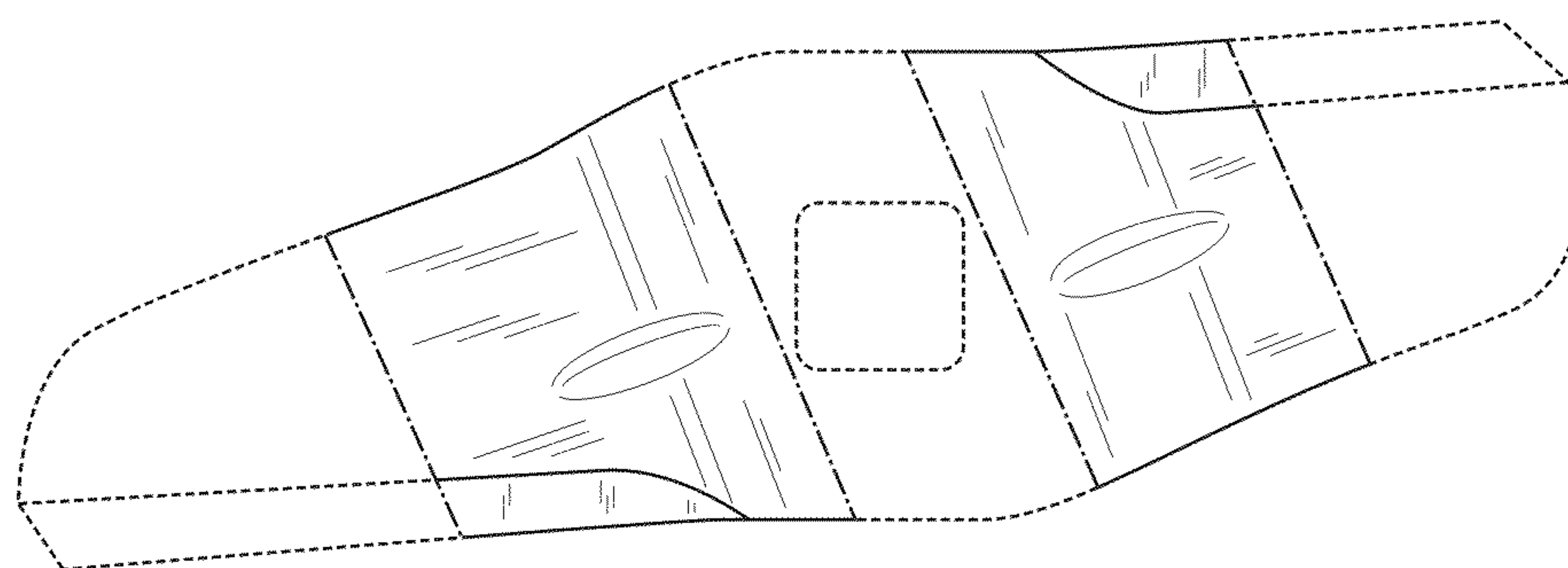

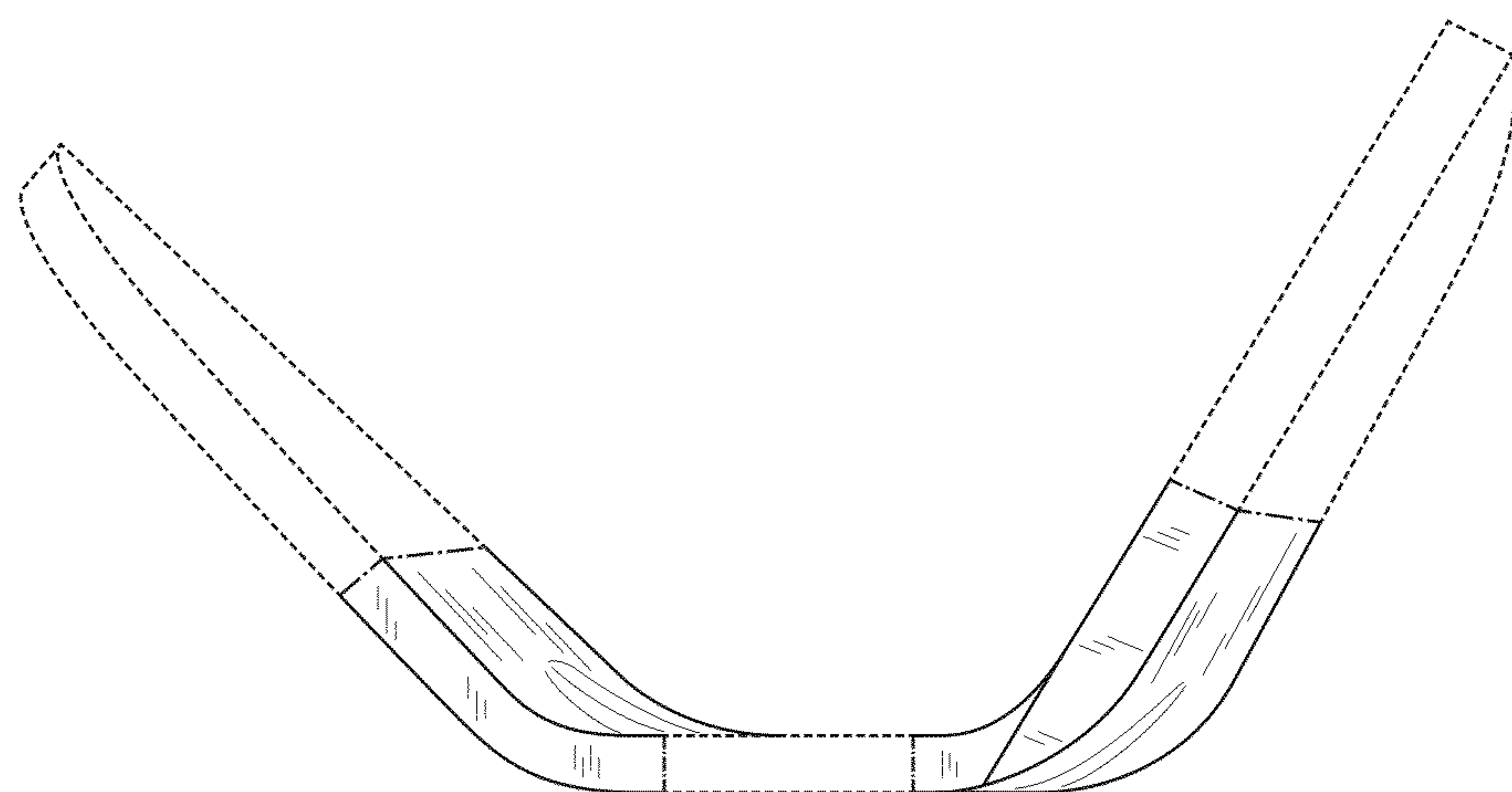

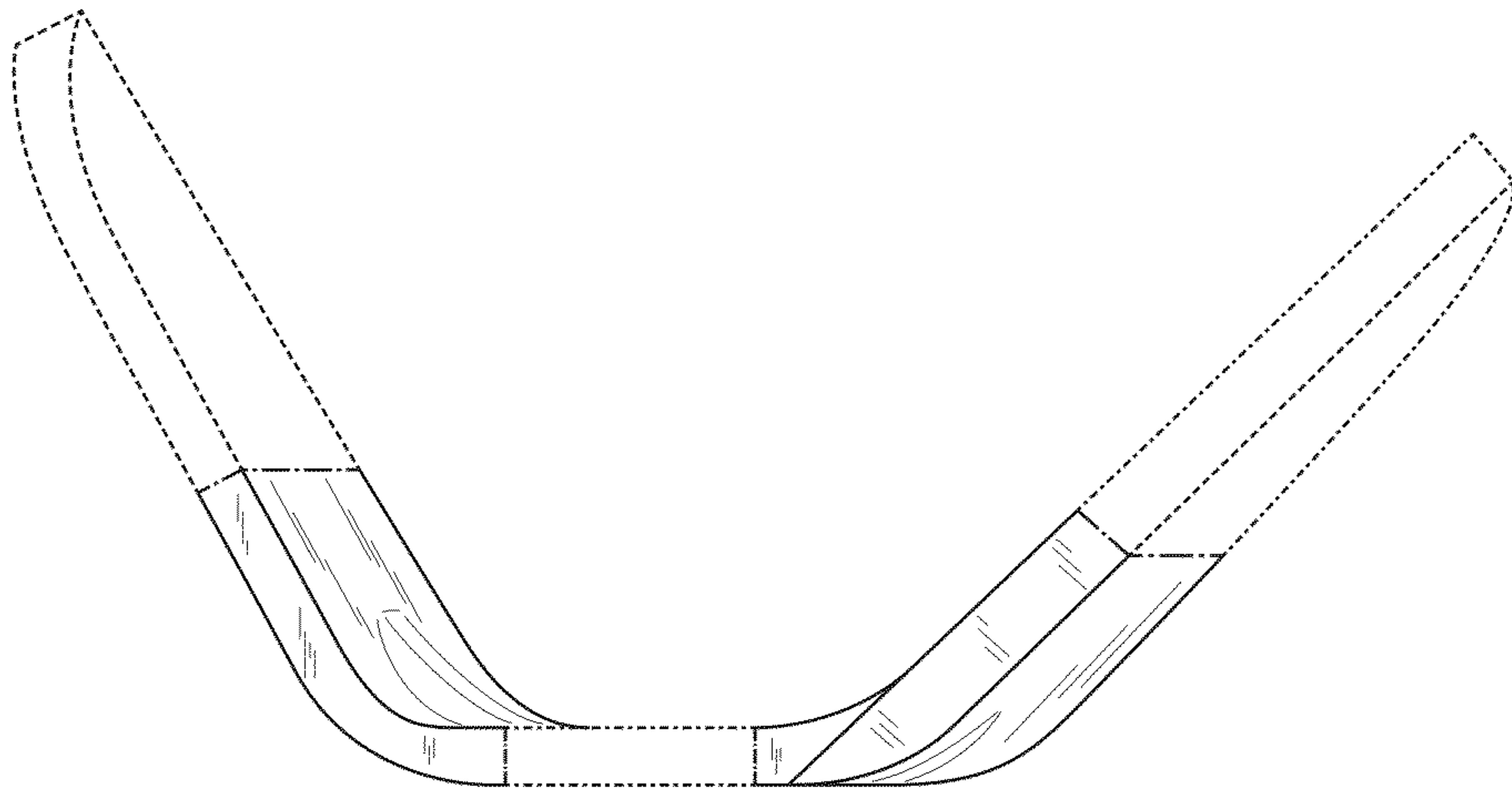

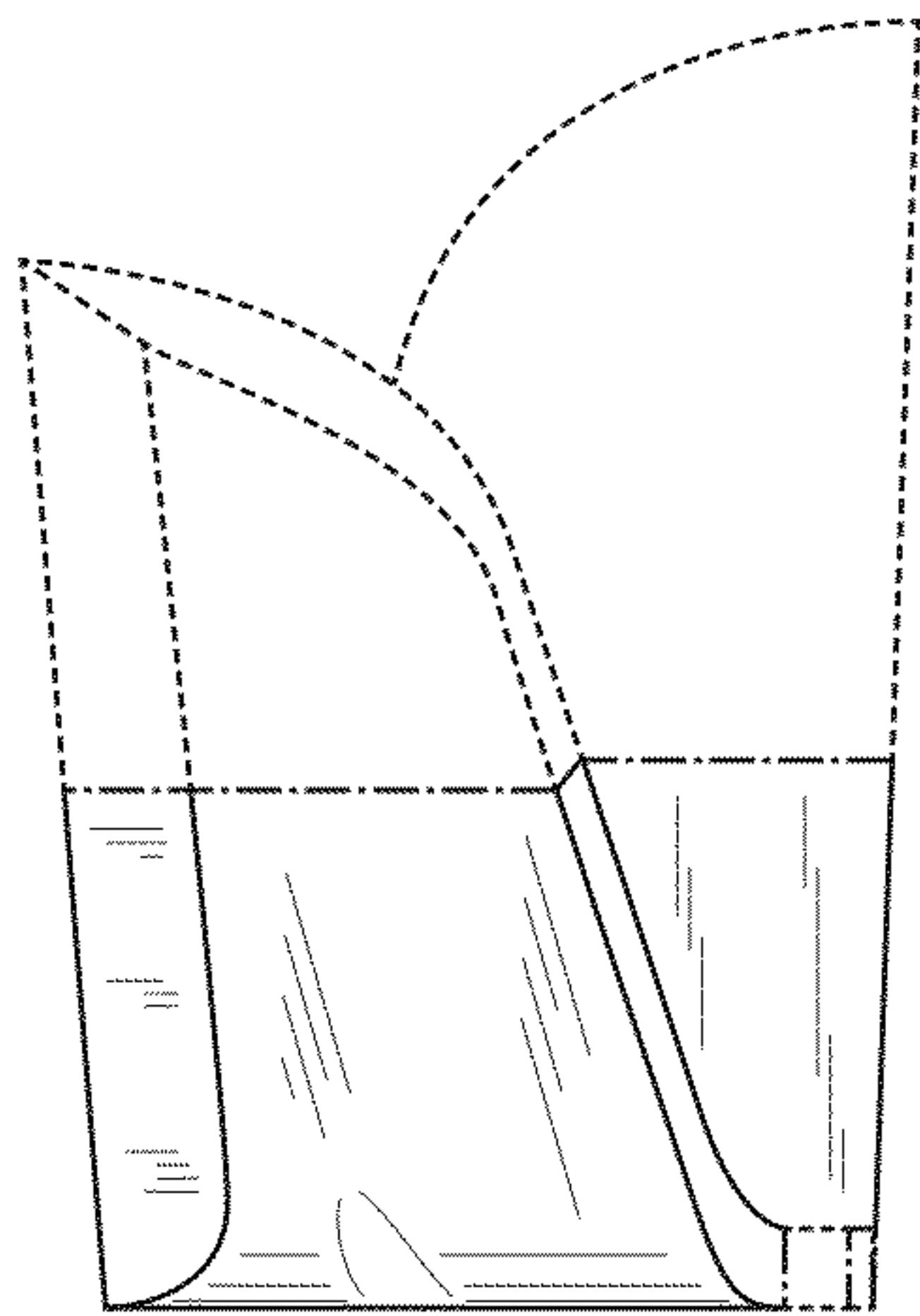

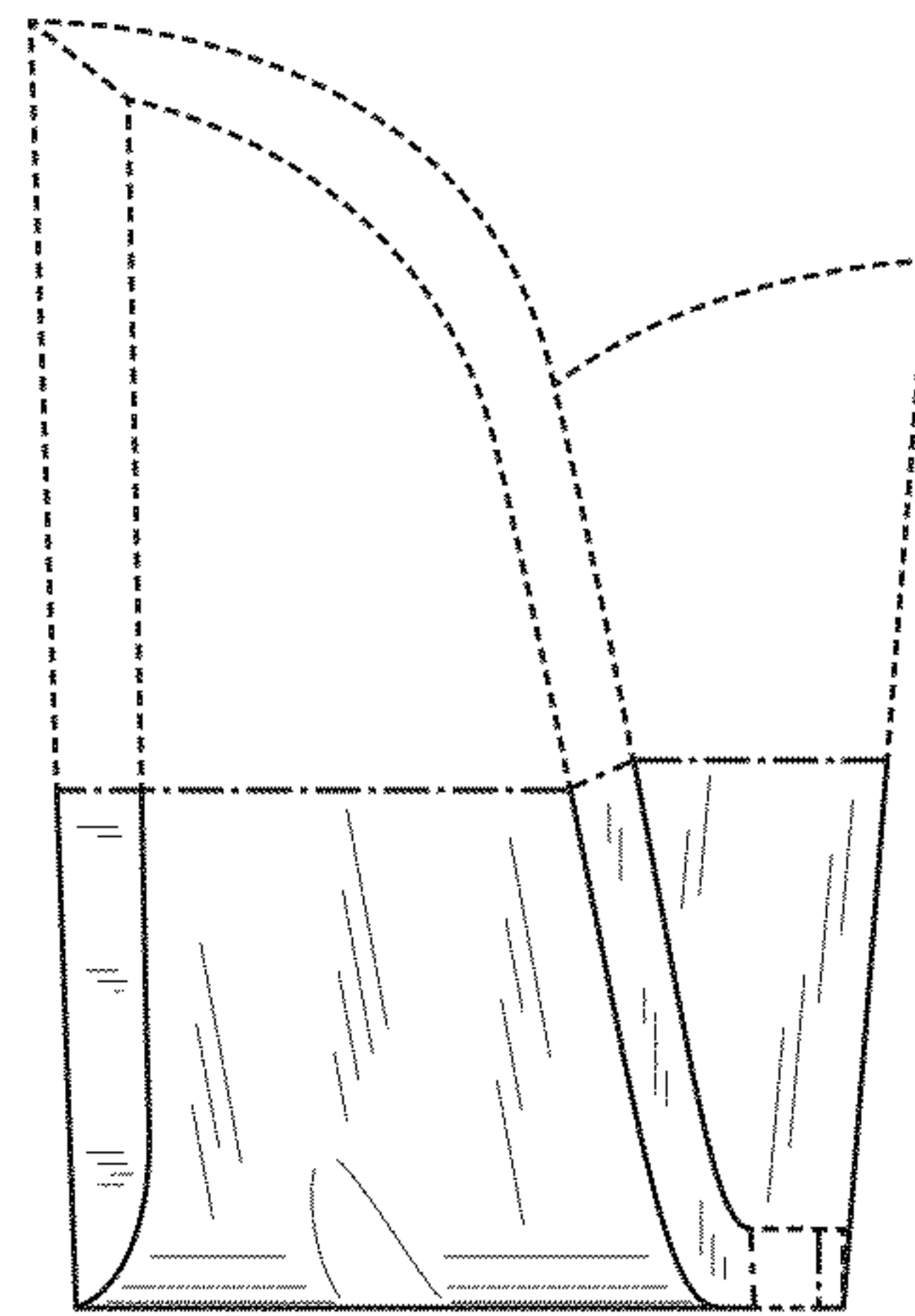
