(57) **CLAIM**

I claim the ornamental design for the cap for container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the cap for a container showing the new design;

FIG. 2 is a front plan view of the cap of FIG. 1;

FIG. 3 is a rear plan view of the cap of FIG. 1;

FIG. 4 is a right plan view of the cap of FIG. 1; the left plan view being a mirror image thereof;

FIG. 5 is a top plan view of the cap of FIG. 1;

FIG. 6 is a bottom plan view of the cap of FIG. 1.

FIG. 7 is a perspective view of the cap of FIG. 1, in a stacked configuration;

FIG. 8 is a perspective view of the cap for a container showing an alternative embodiment of the new design of FIG. 1;

FIG. 9 is a front plan view of the cap of FIG. 8;

FIG. 10 is a rear plan view of the cap of FIG. 8;

FIG. 11 is a right plan view of the cap of FIG. 8; the left plan view being a mirror image thereof;

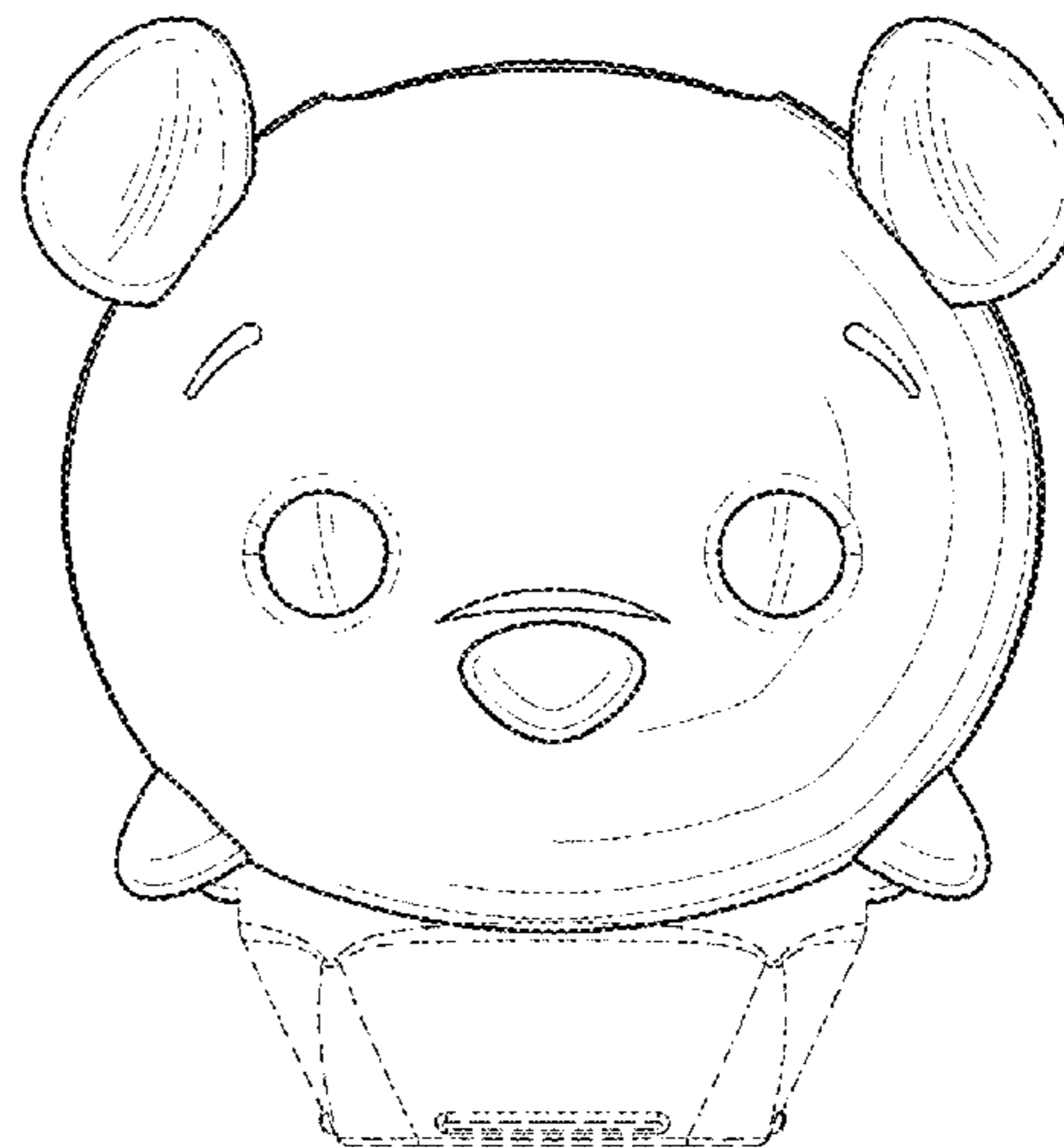
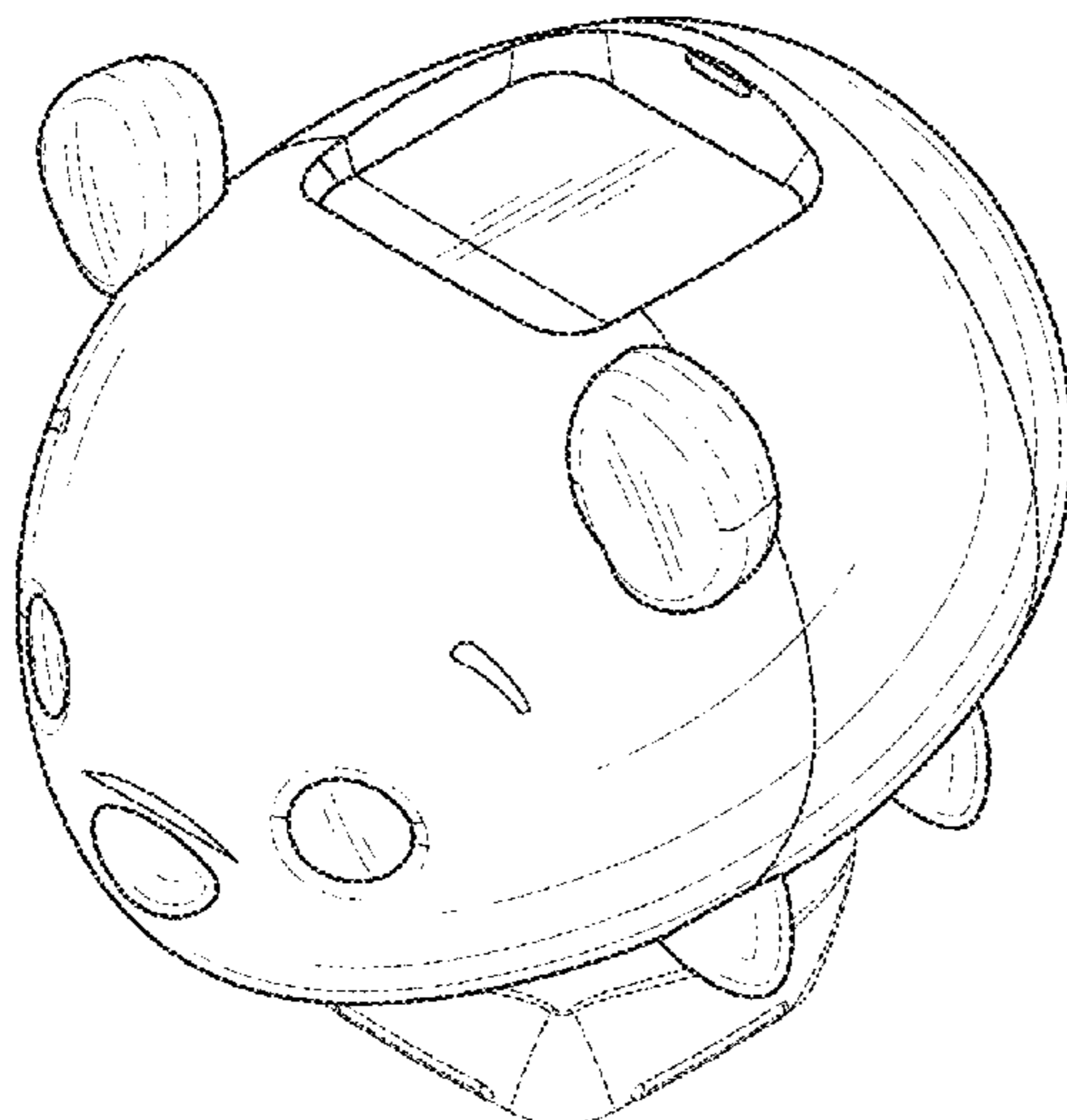
FIG. 12 is a top plan view of the cap of FIG. 8;

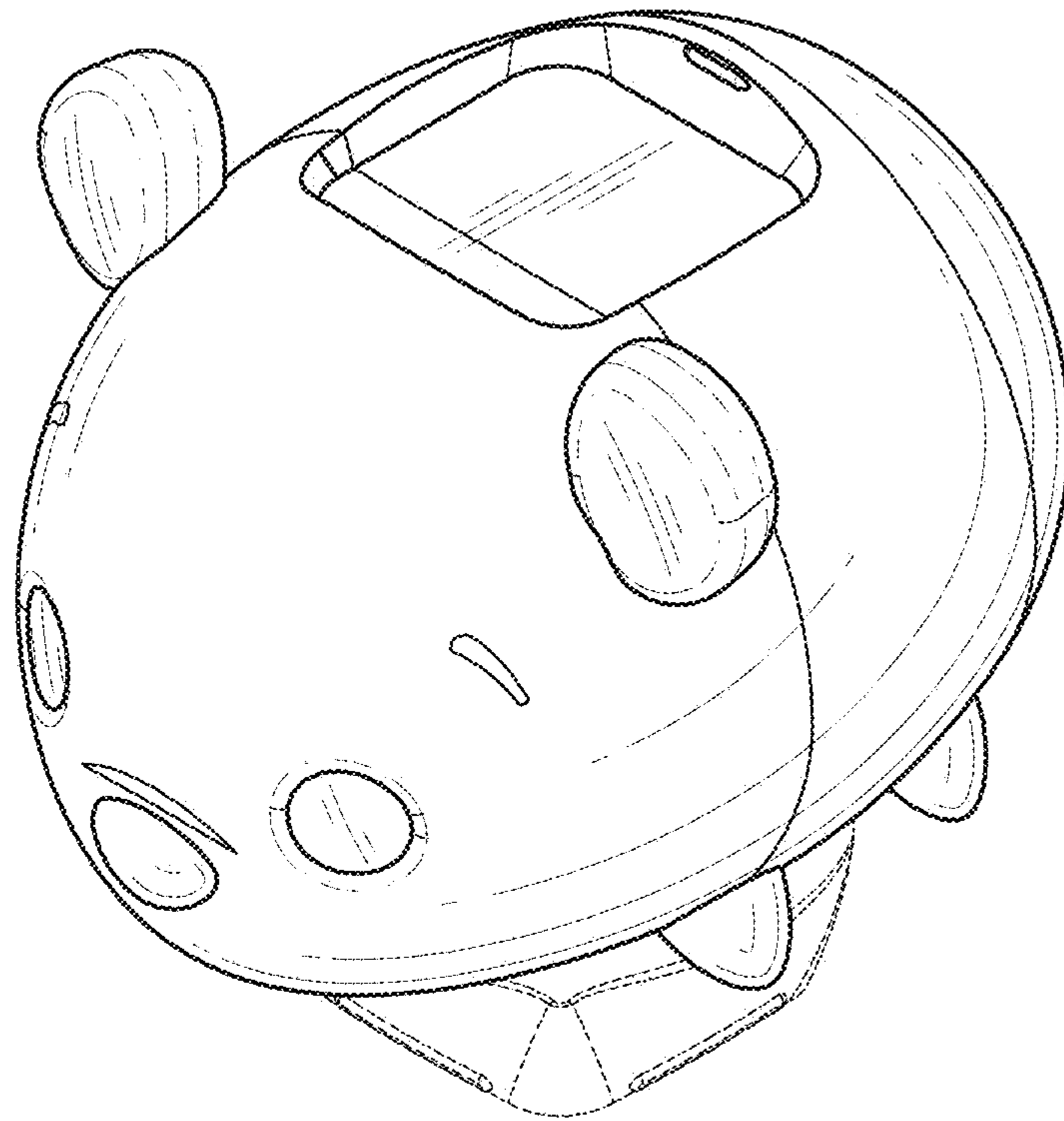

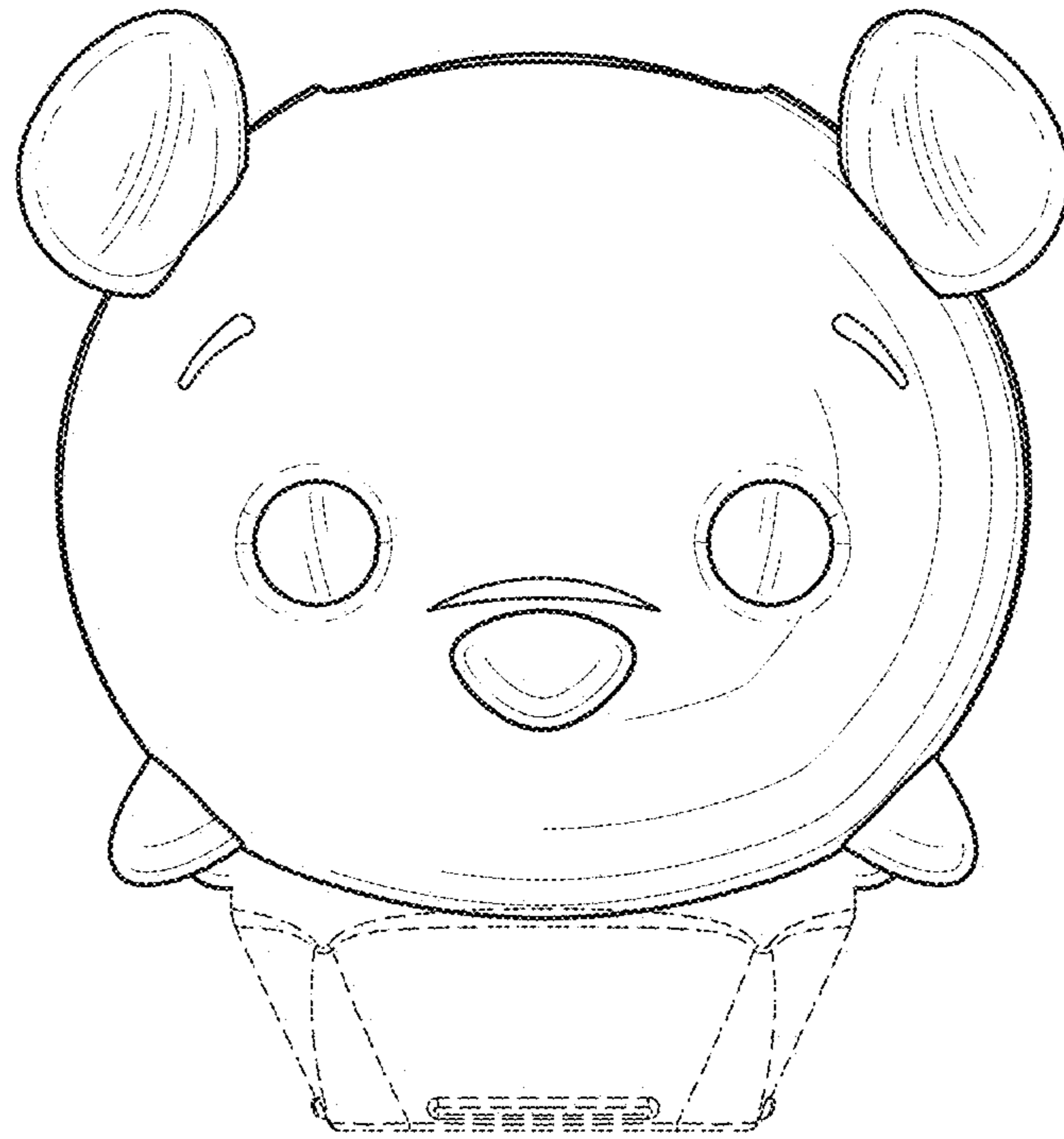

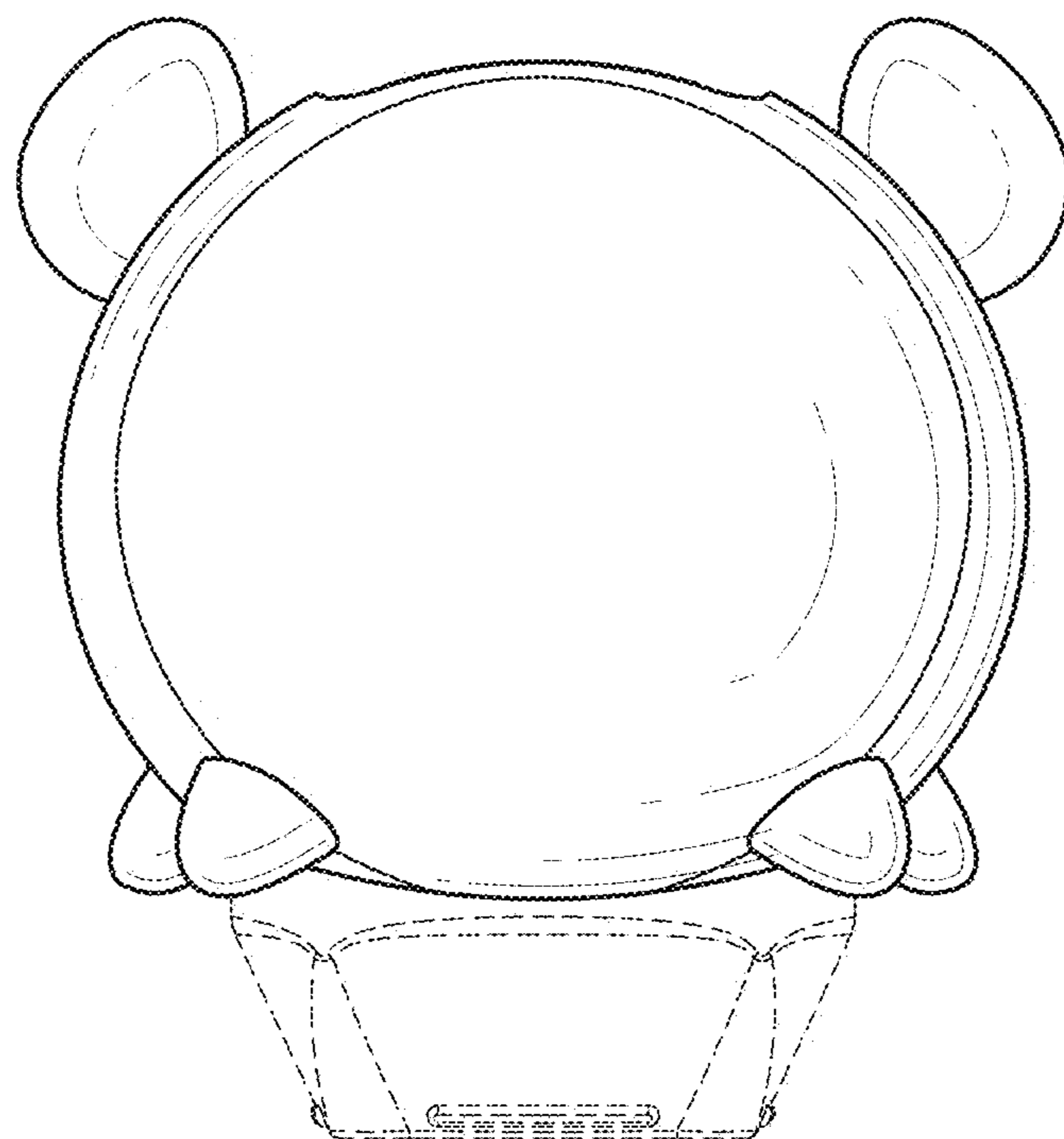

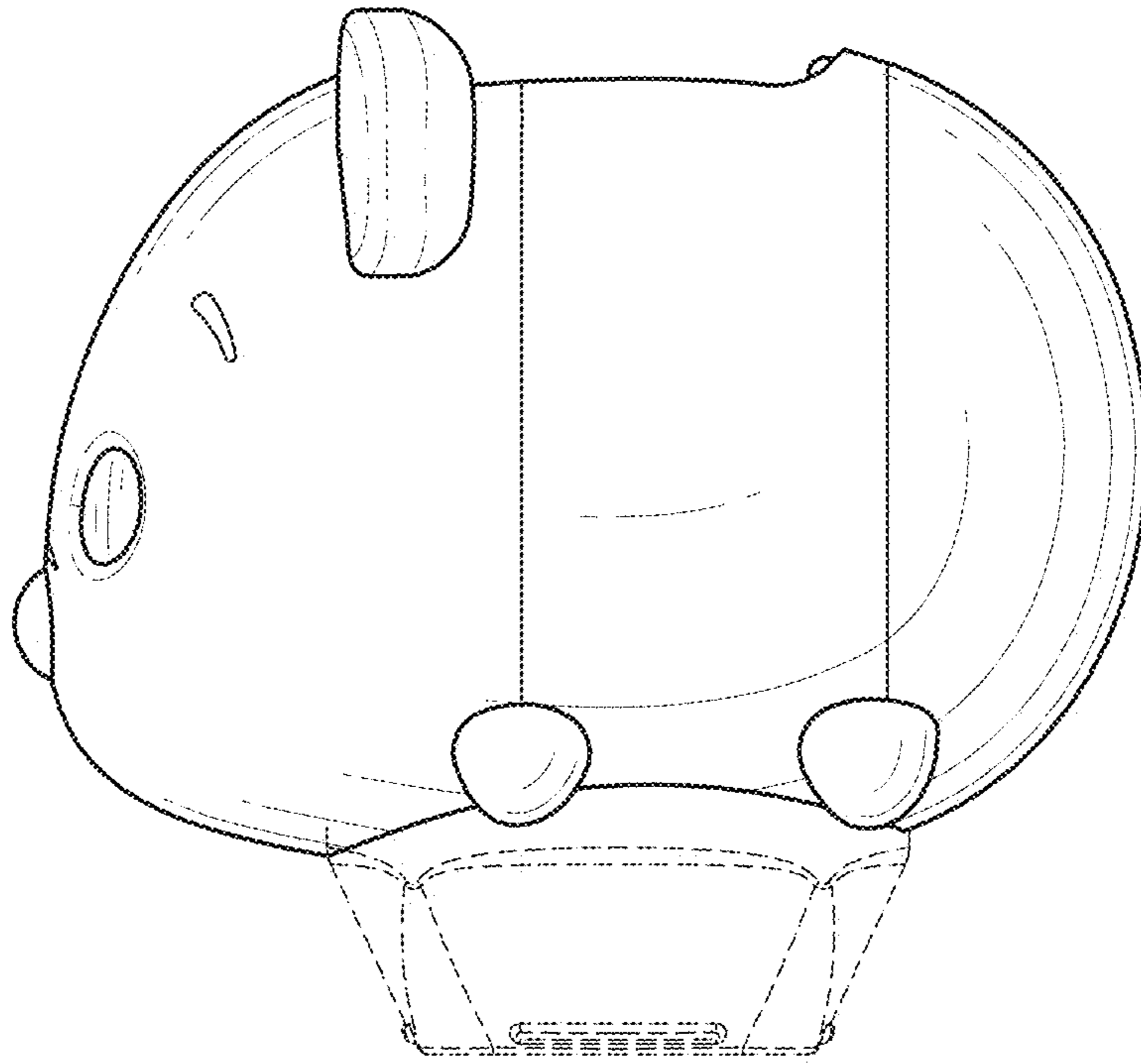

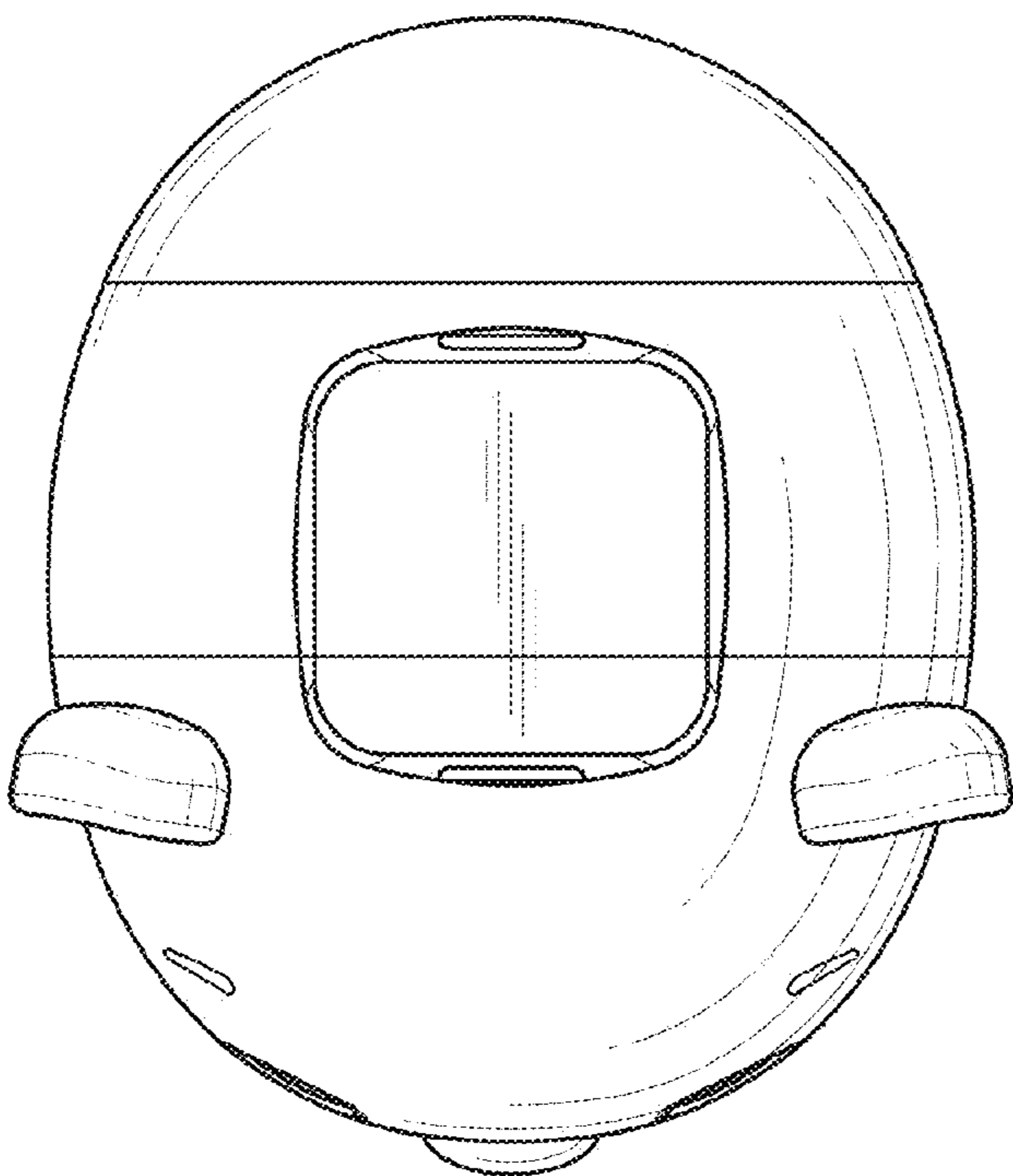

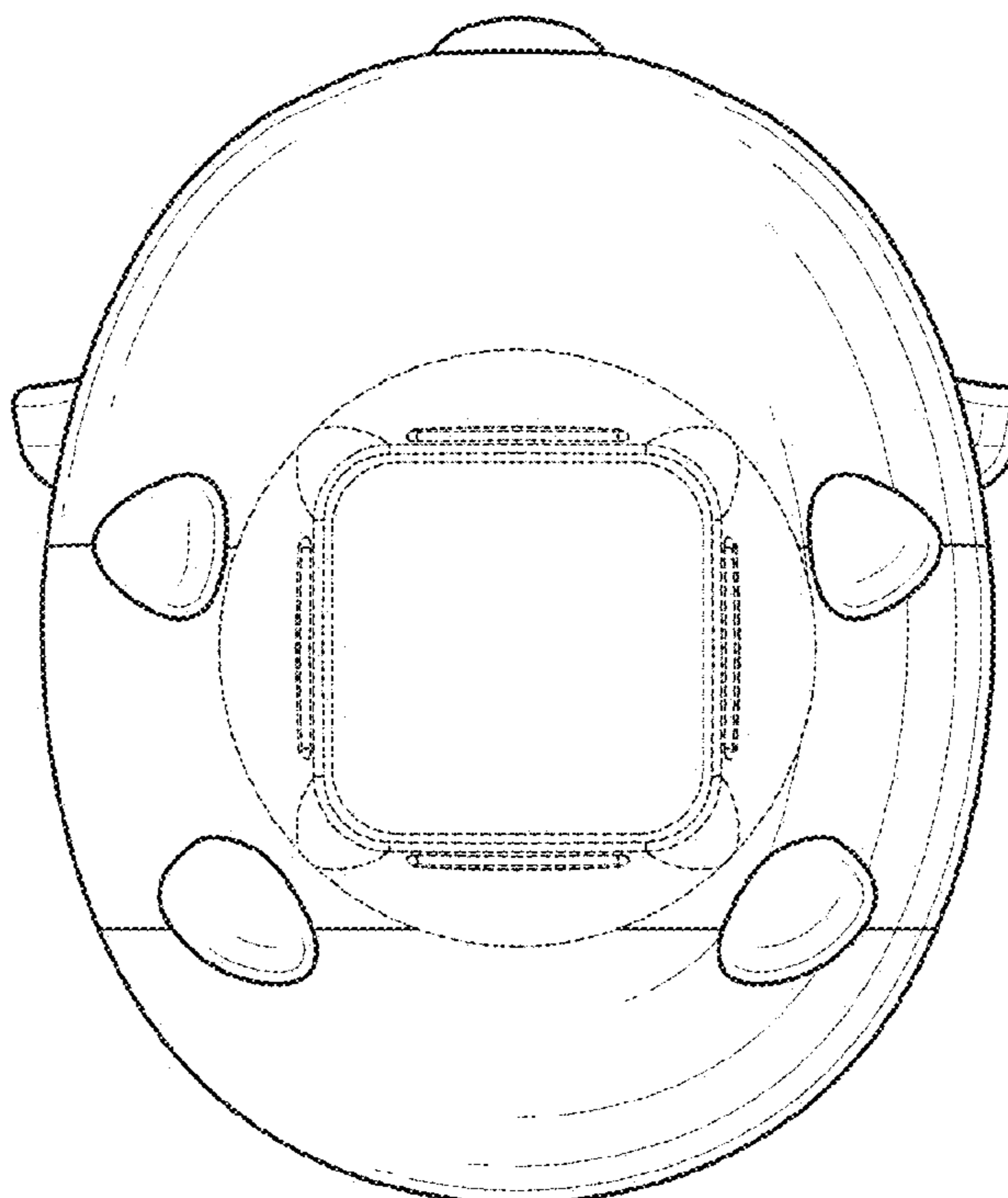

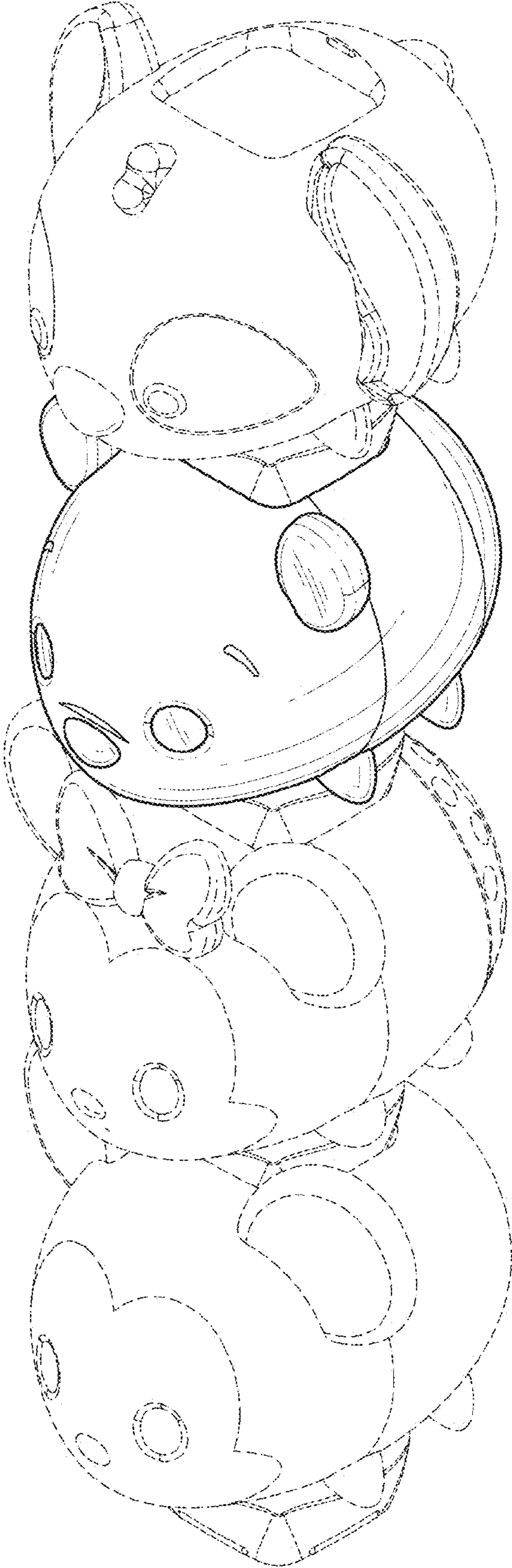

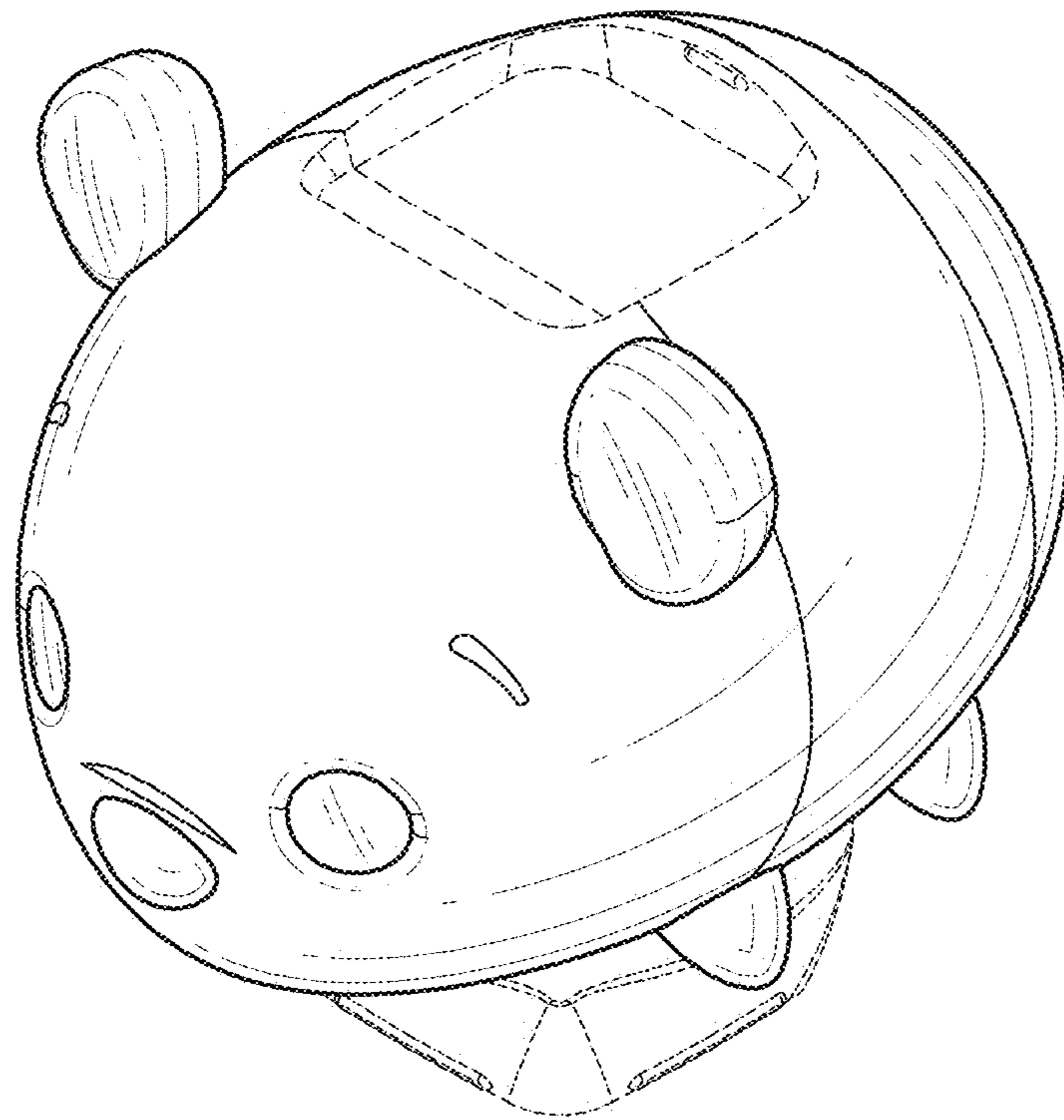

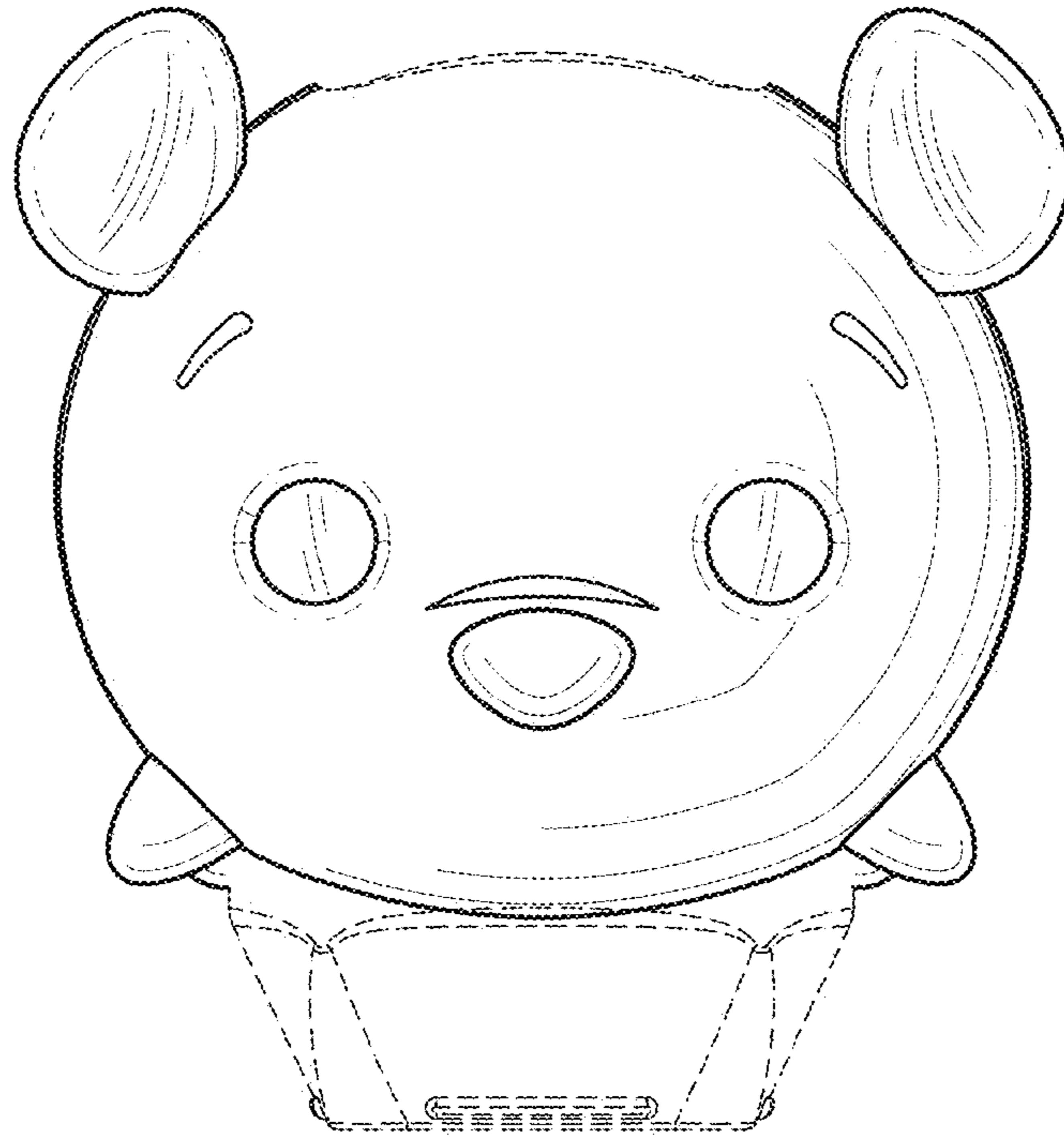

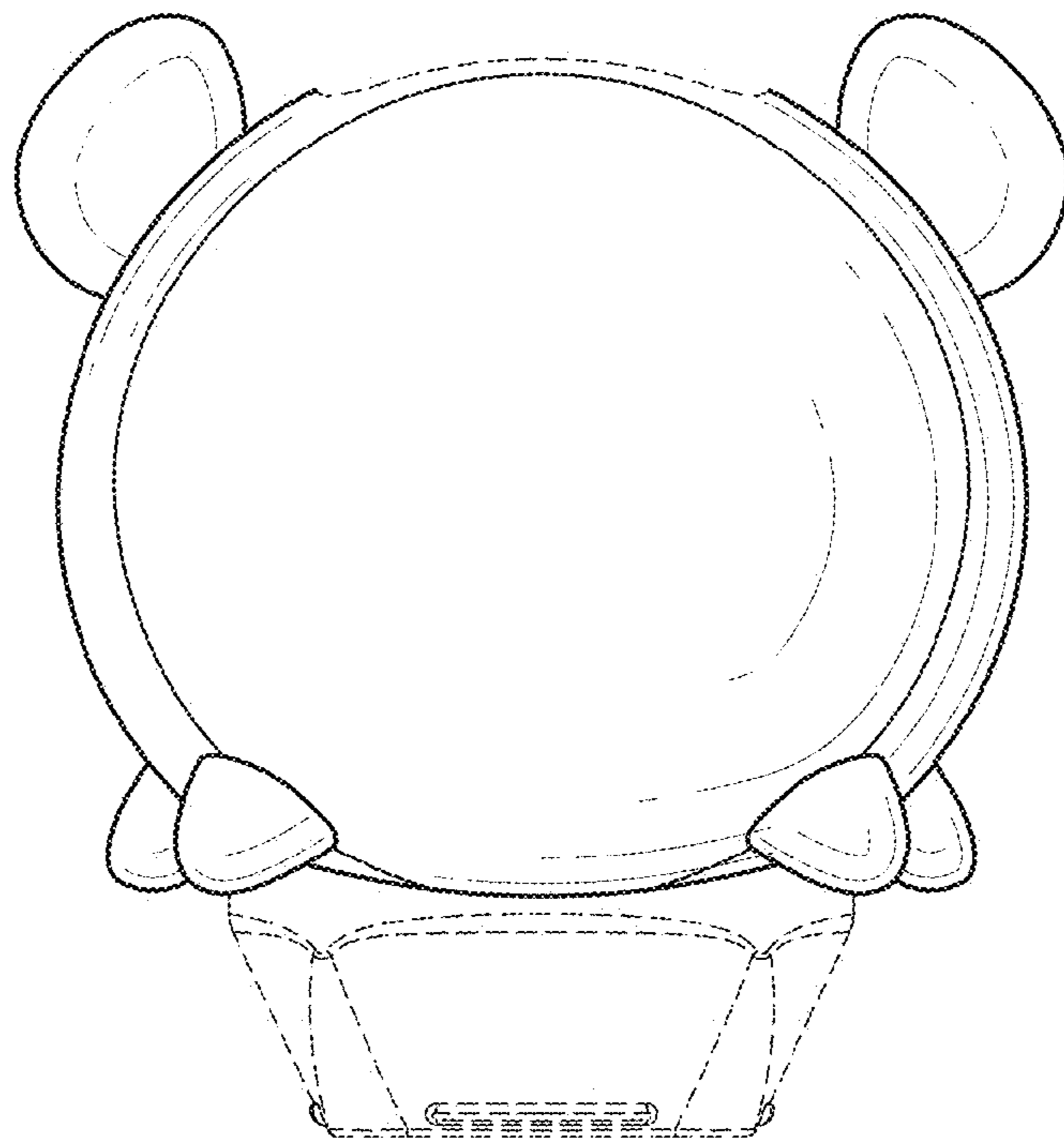

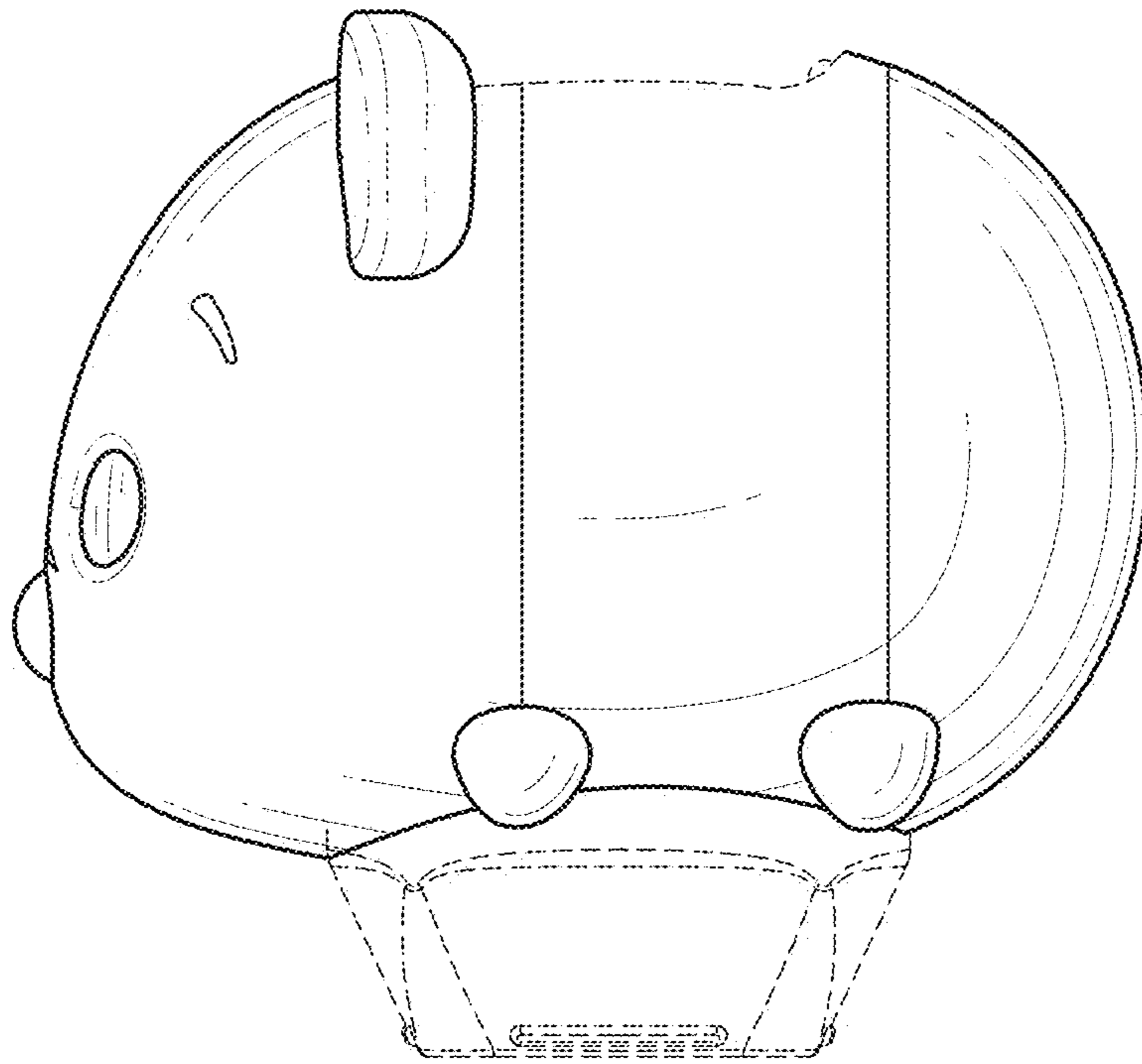

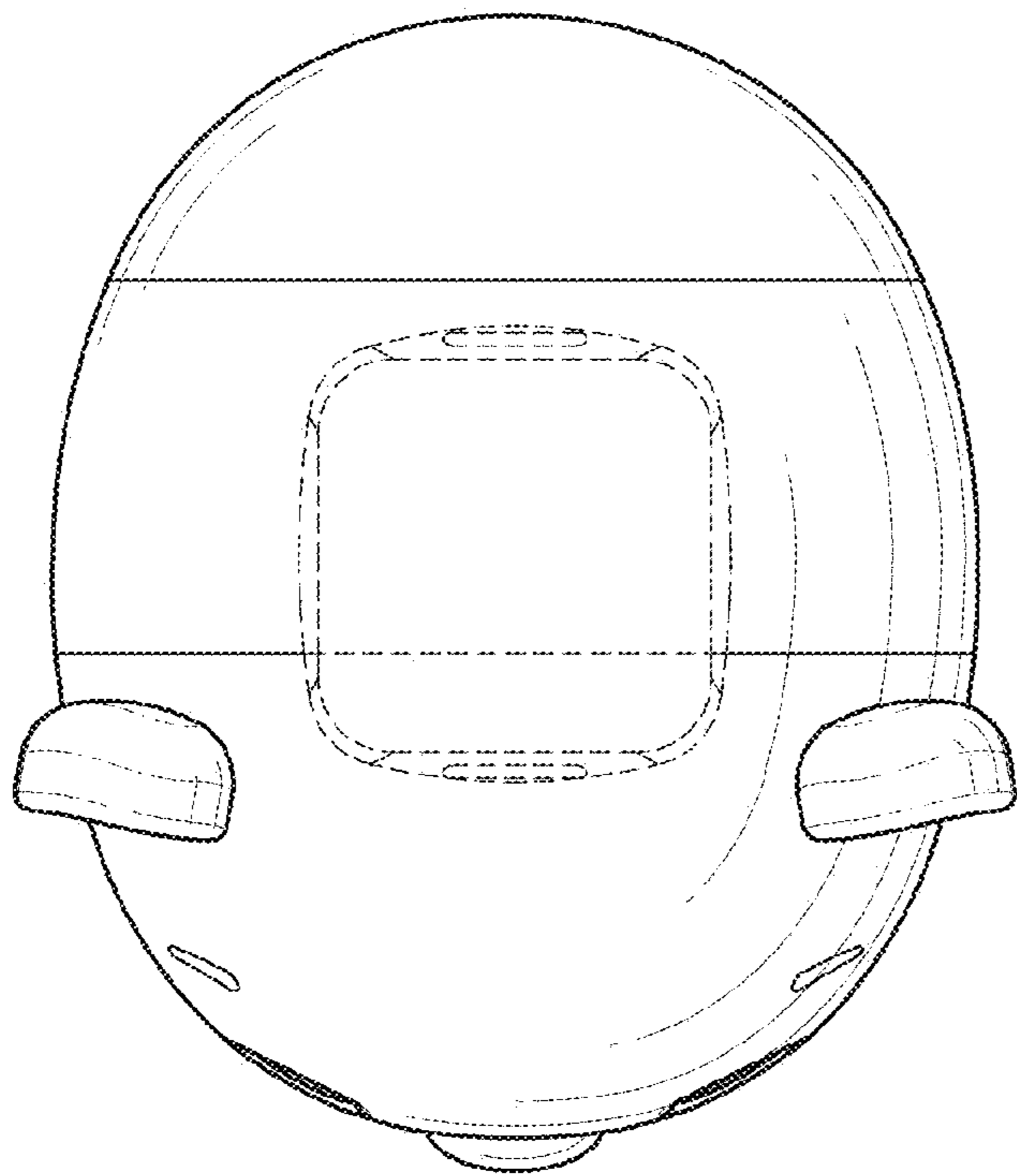

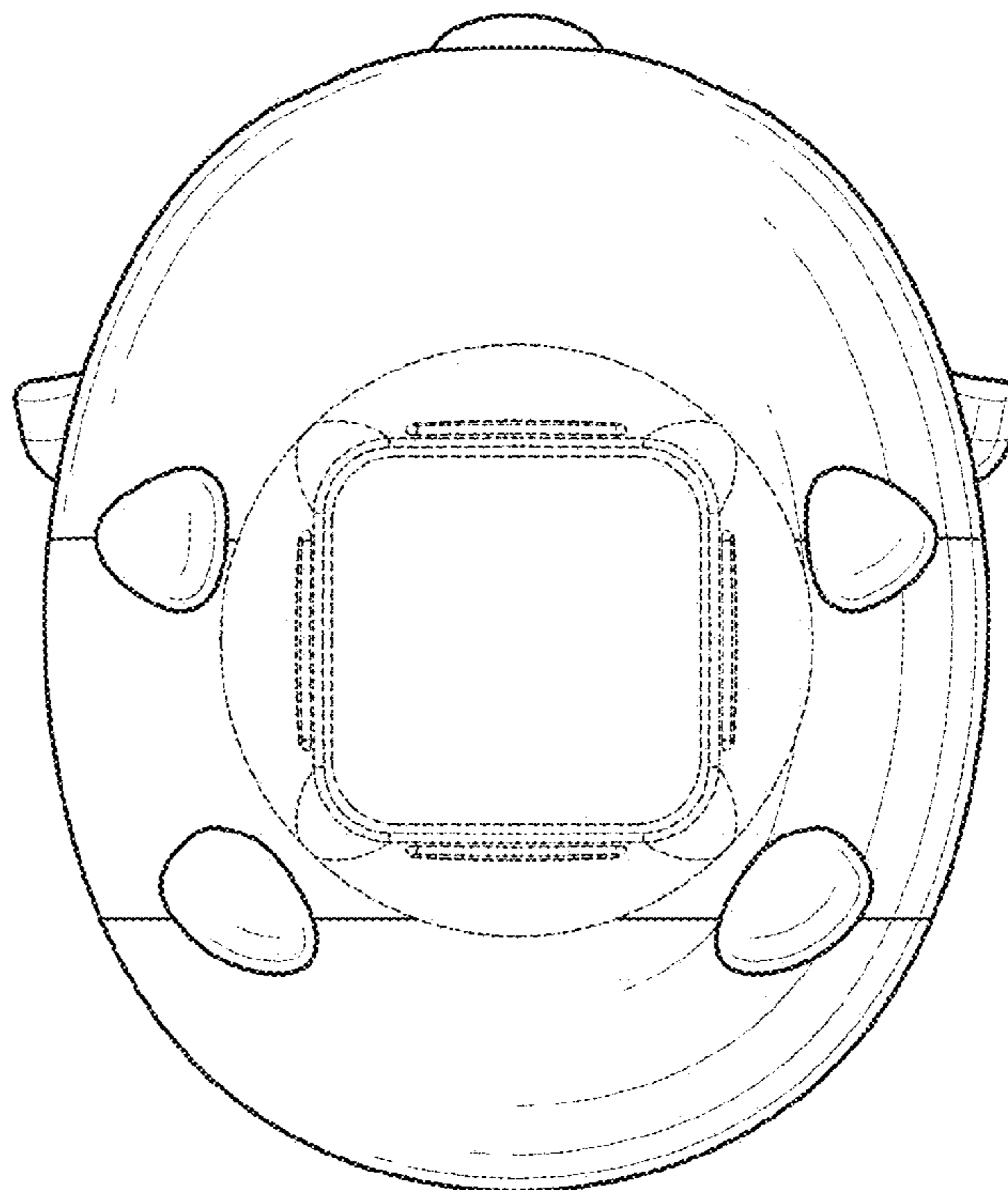




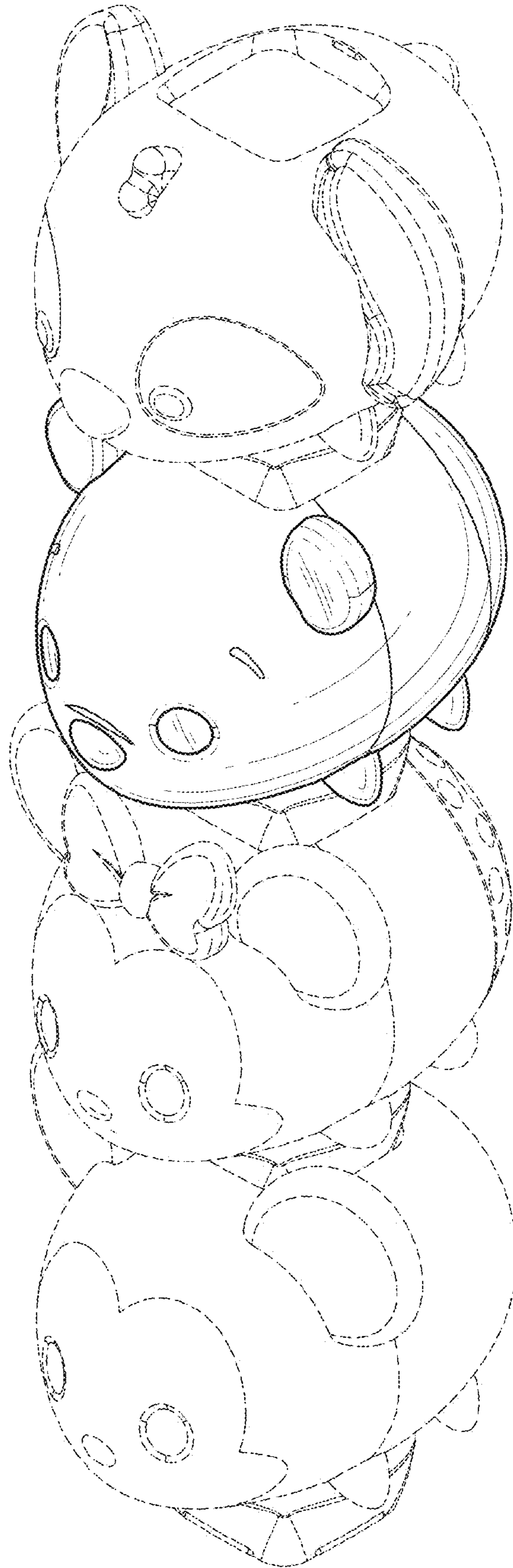
