The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, right side perspective view showing the bottle; FIG. 2 is front elevation view of the bottle shown in FIG. 1; FIG. 3 is a rear elevation view of the bottle shown in FIG. 1; FIG. 4 is a left side view of the bottle shown in FIG. 1; FIG. 5 is a right side view of the bottle shown in FIG. 1; FIG. 6 is a top plan view of the bottle shown in FIG. 1; FIG. 7 is a bottom plan view of the bottle shown in FIGS. 1; and, FIG. 8 is a bottom, left side perspective view of the bottle shown in FIG. 1, The broken lines shown in FIGS. 1-8 are included to show unclaimed subject matter only and form no part of the claimed design.

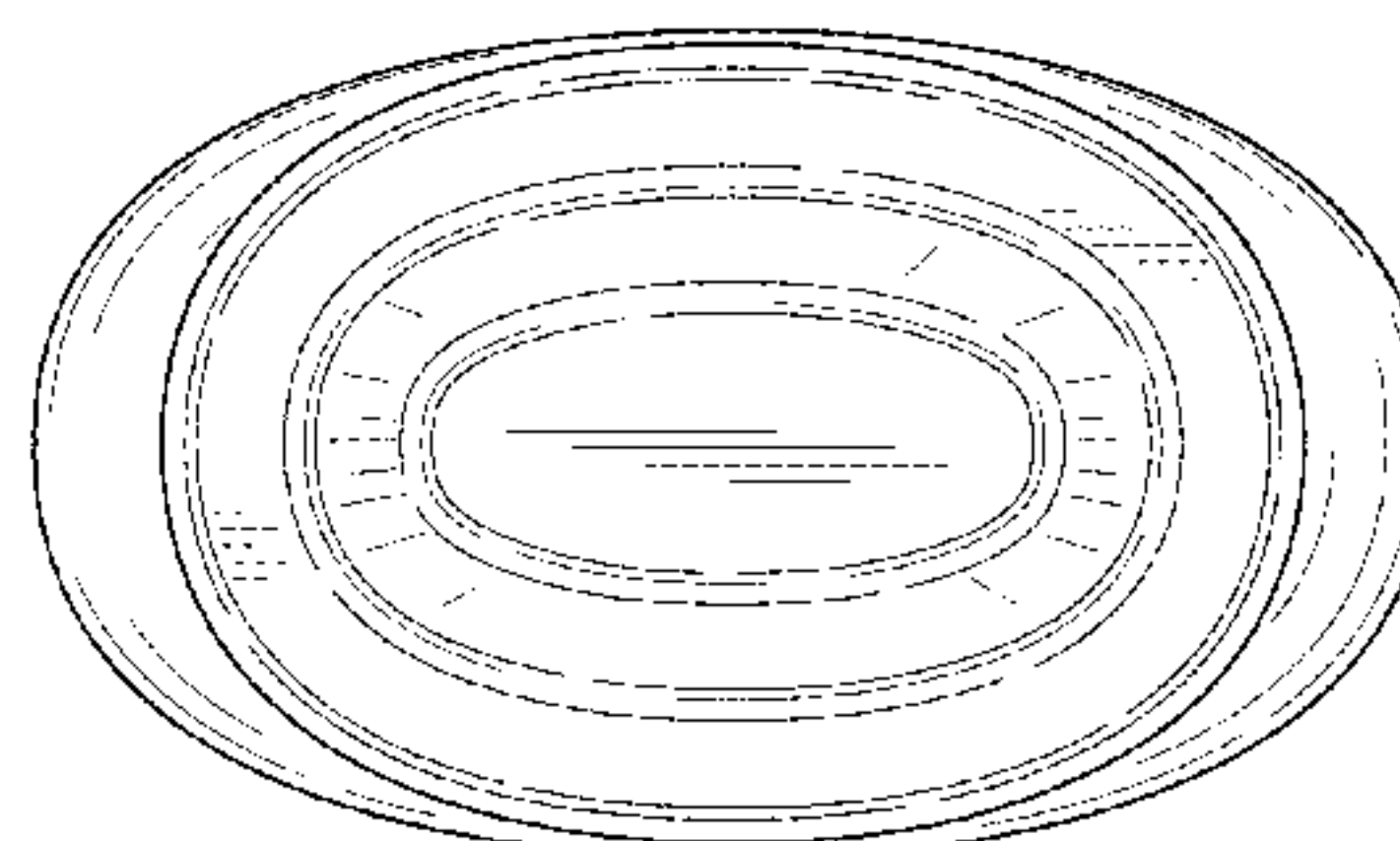
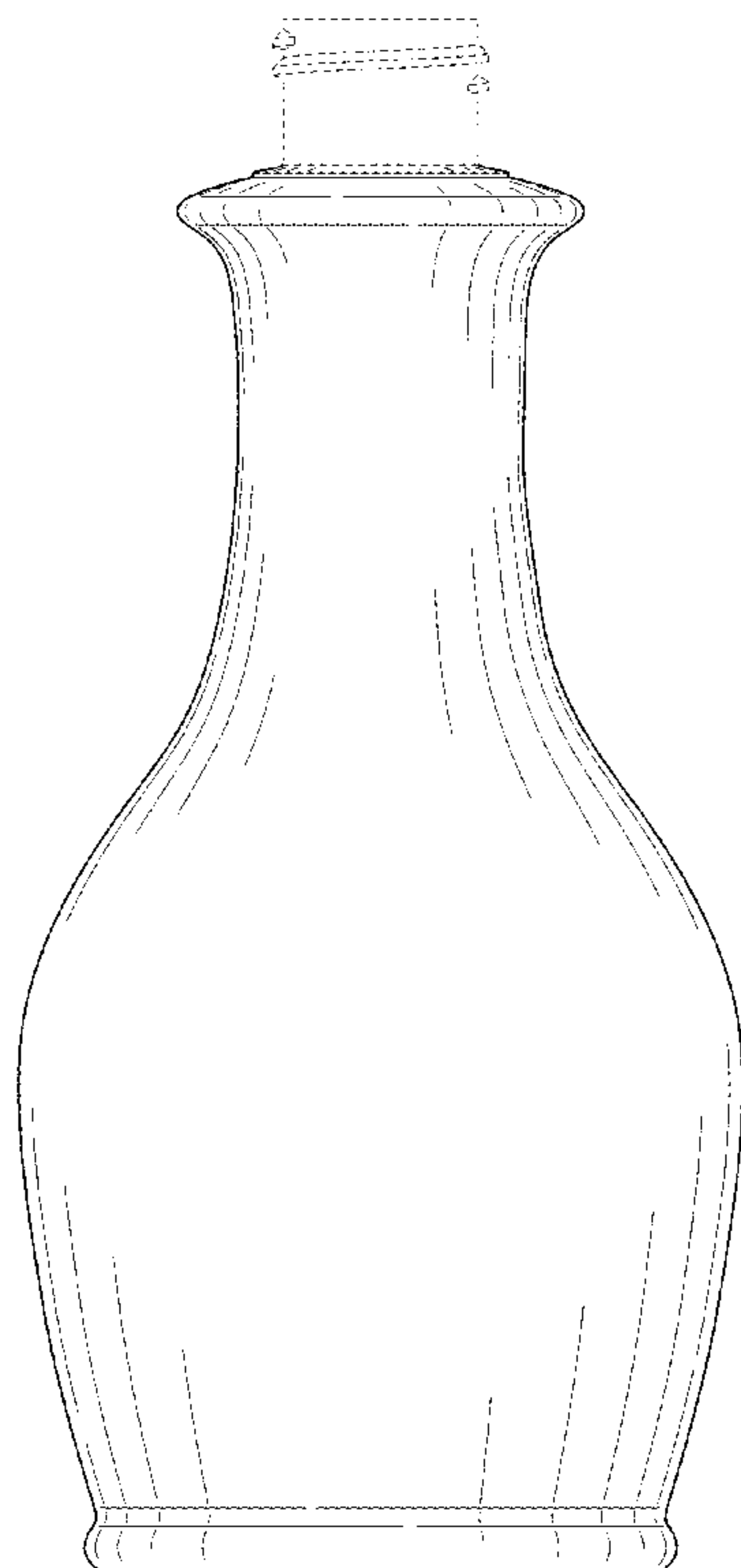

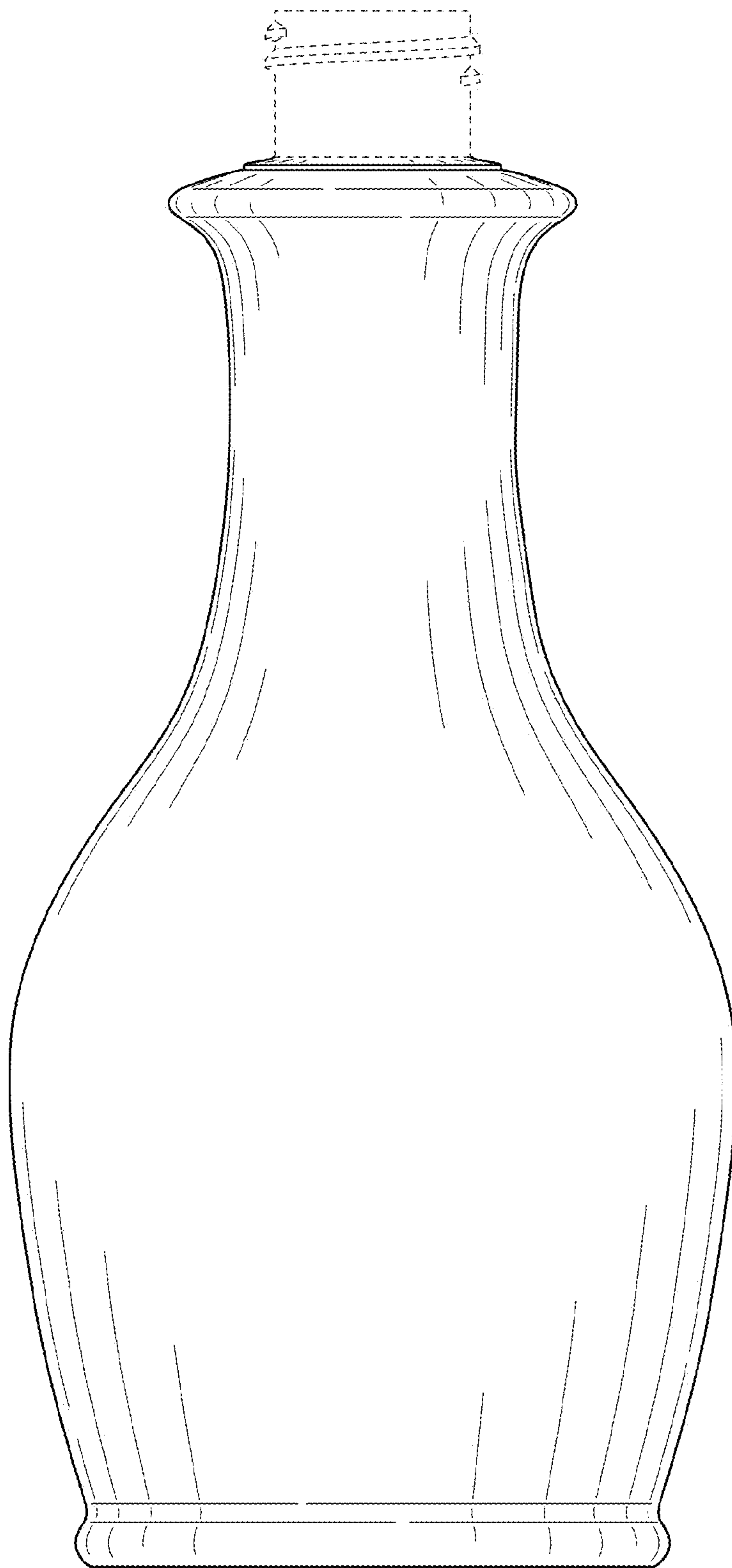

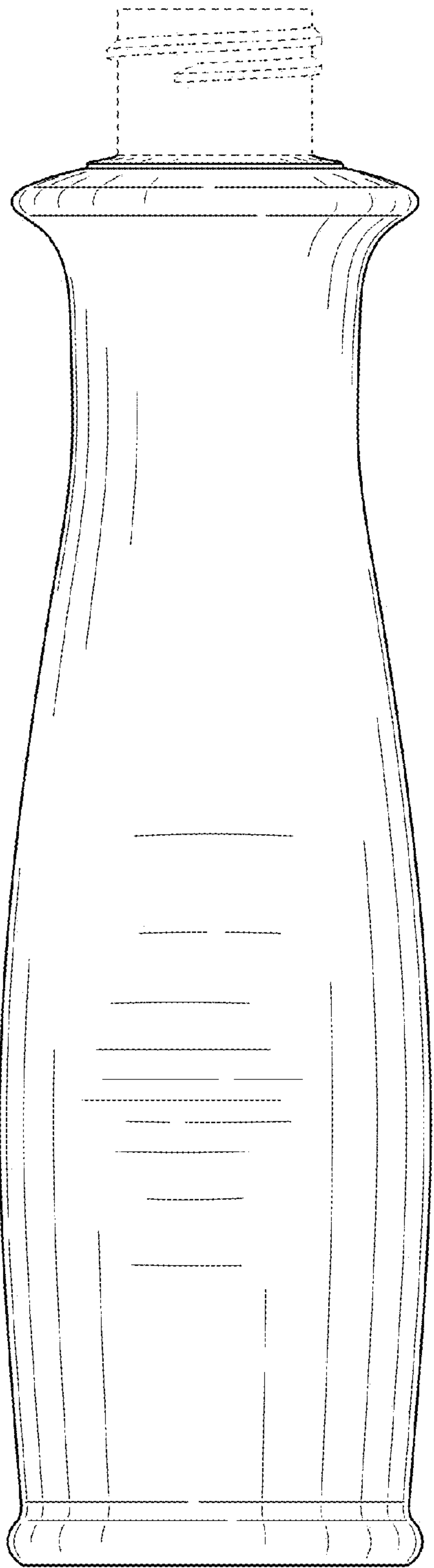

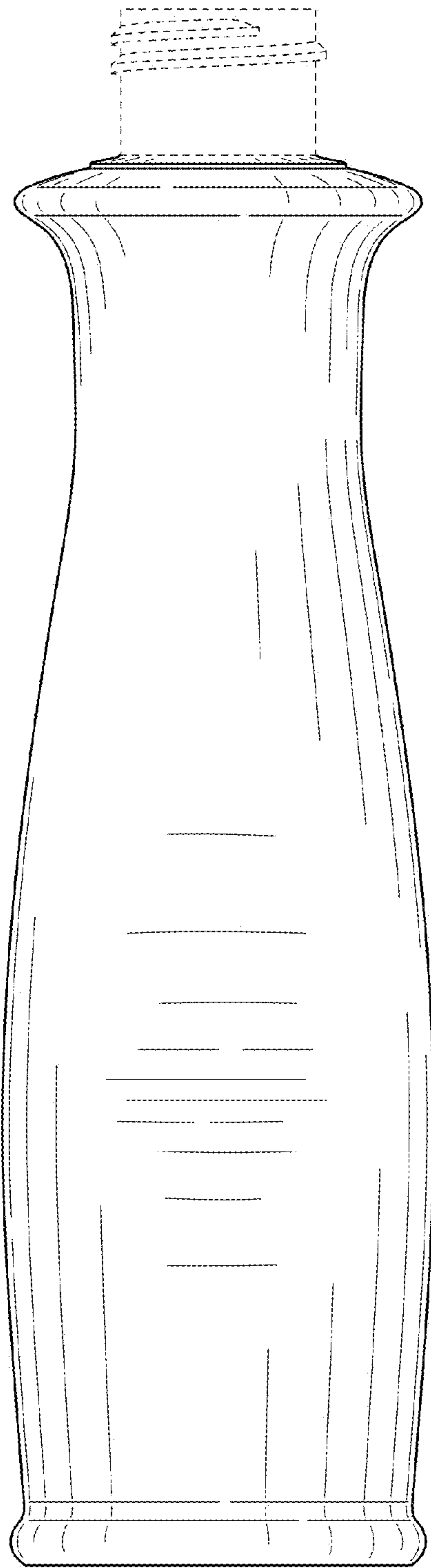

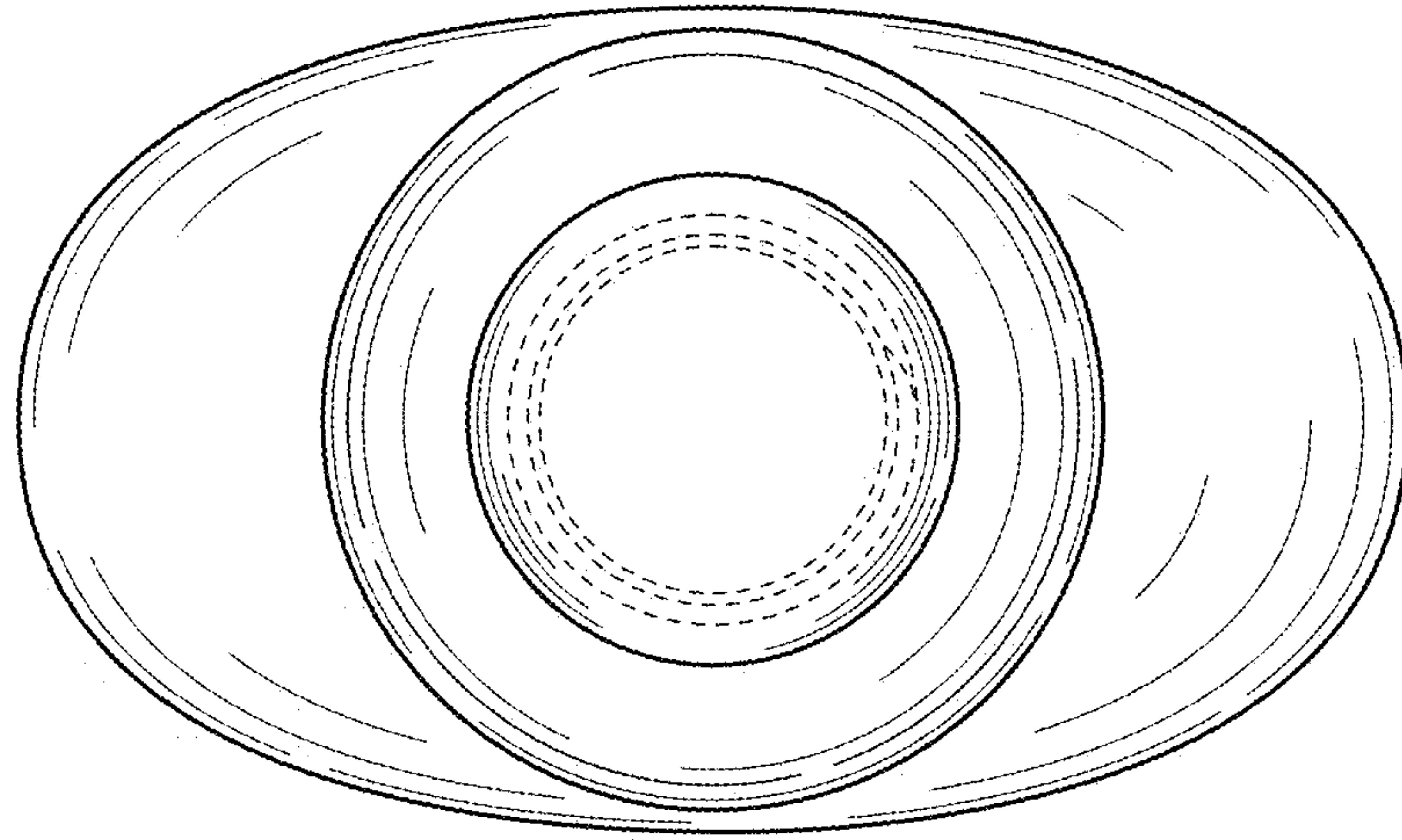

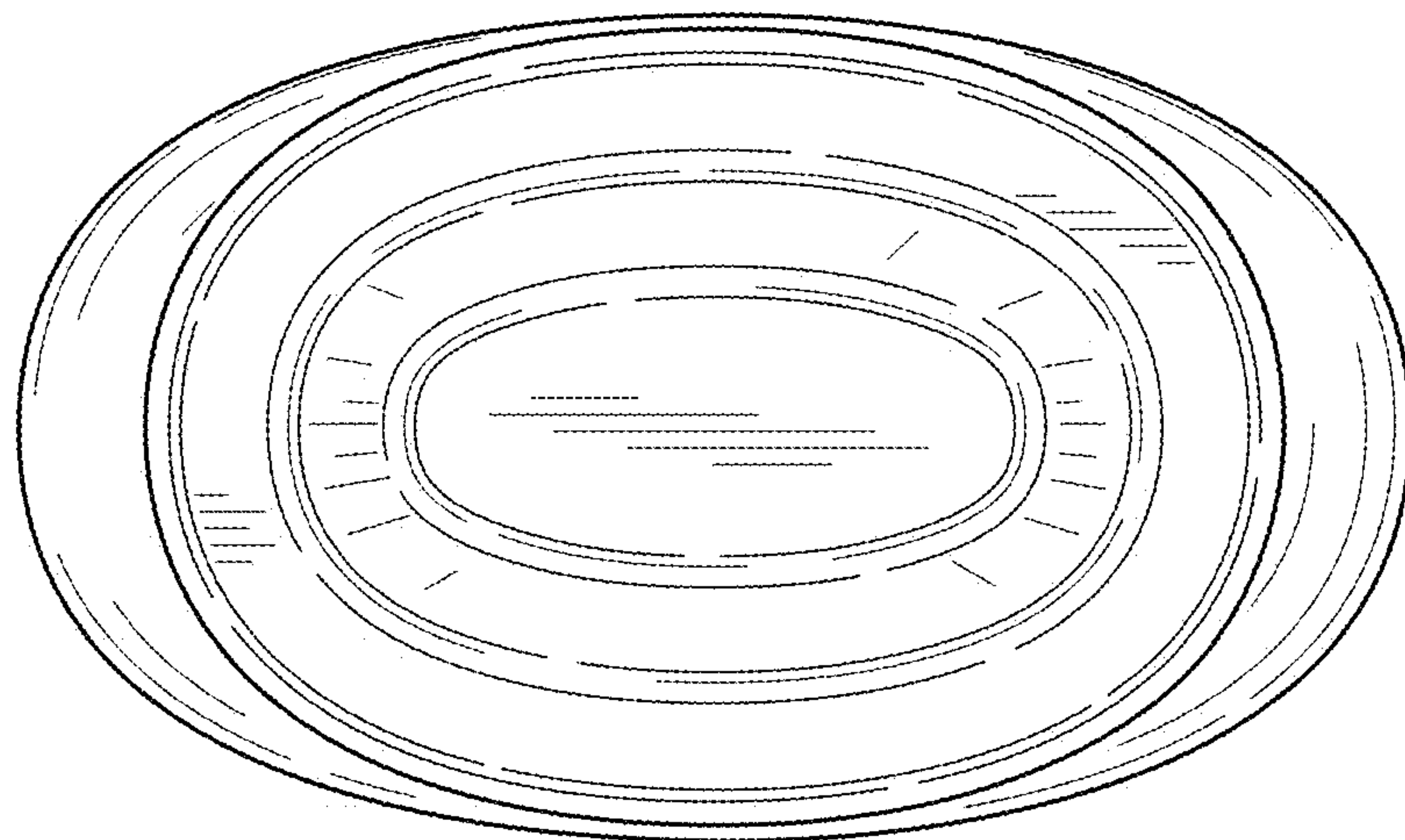

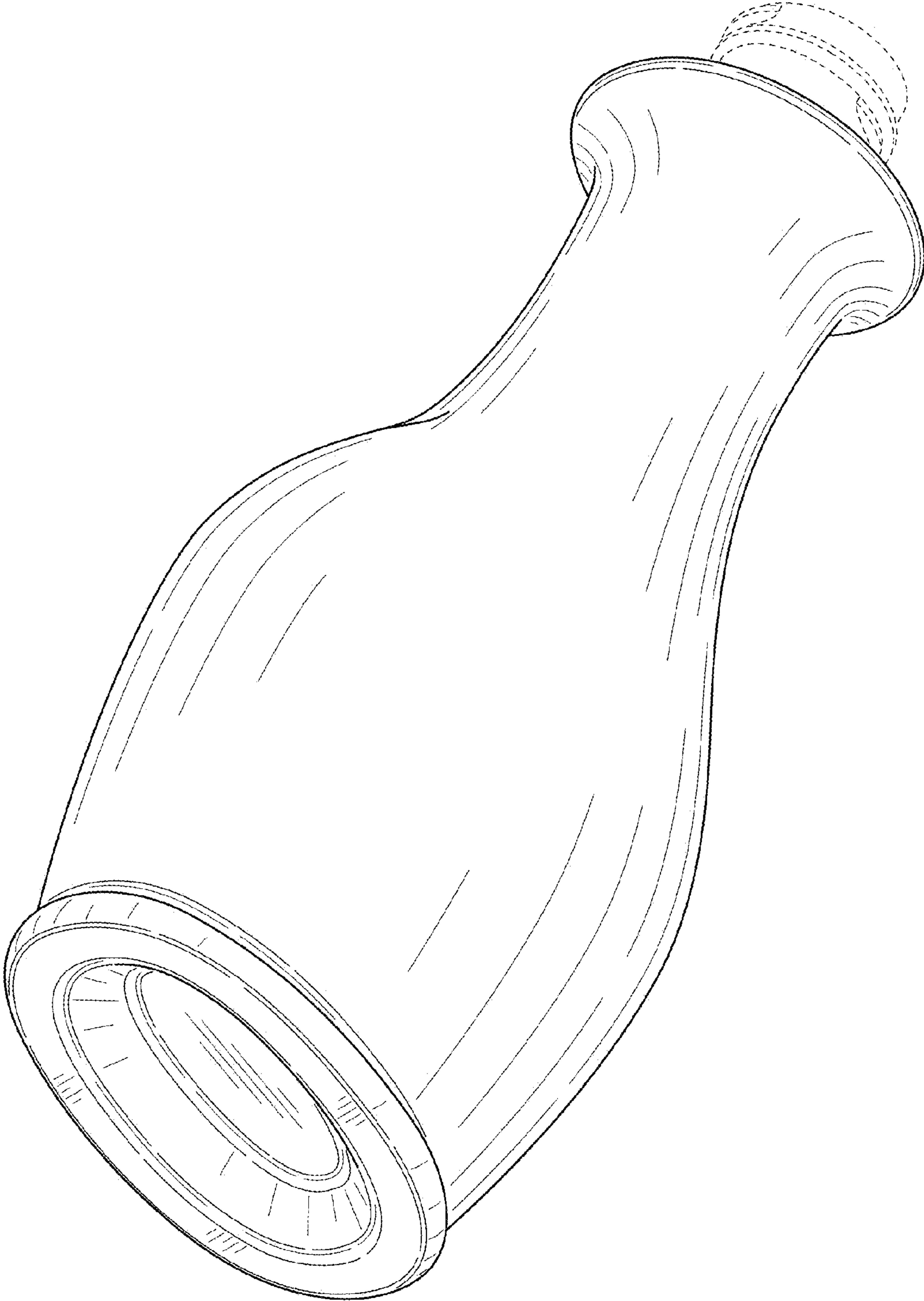
