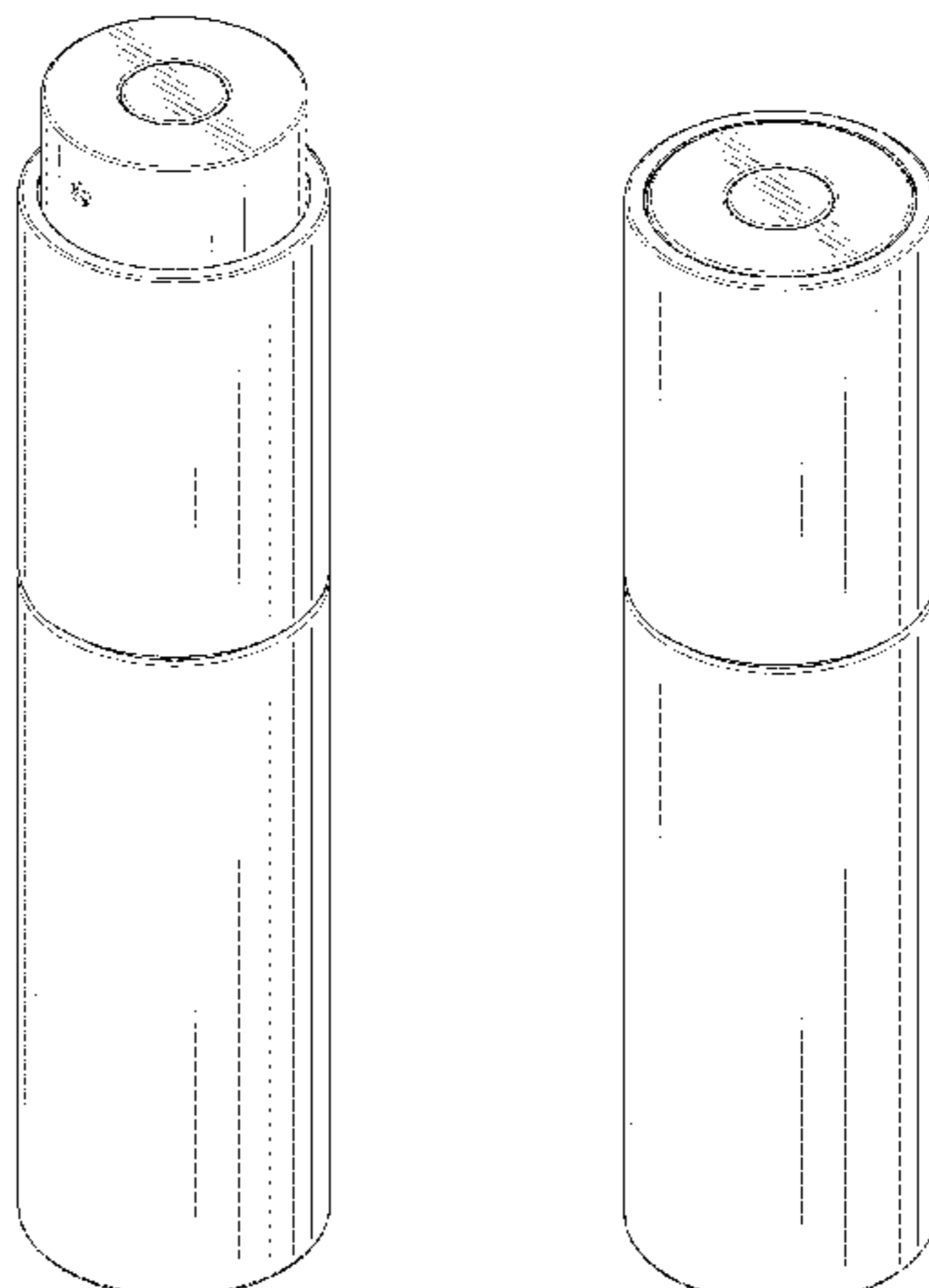
(57) **CLAIM**

The ornamental design for a cosmetic container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a cosmetic container showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a top view thereof;  
FIG. 7 is a bottom view thereof; and,  
FIG. 8 is a perspective view similar to FIG. 1 but showing the head element in a retracted position.  
The broken lines showing the nozzle outlet are for illustrative purposes only and form no part of the claimed design.

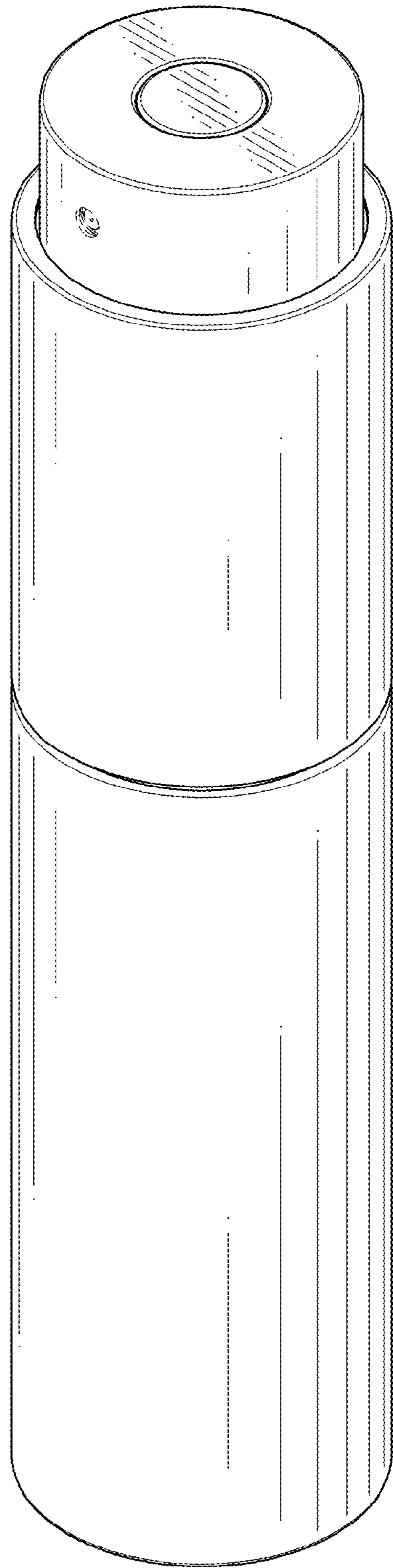

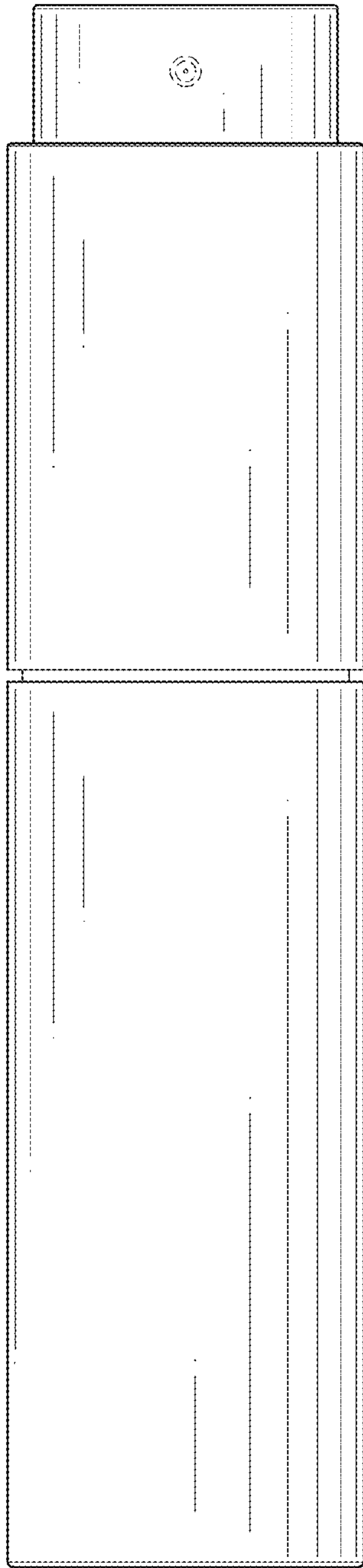

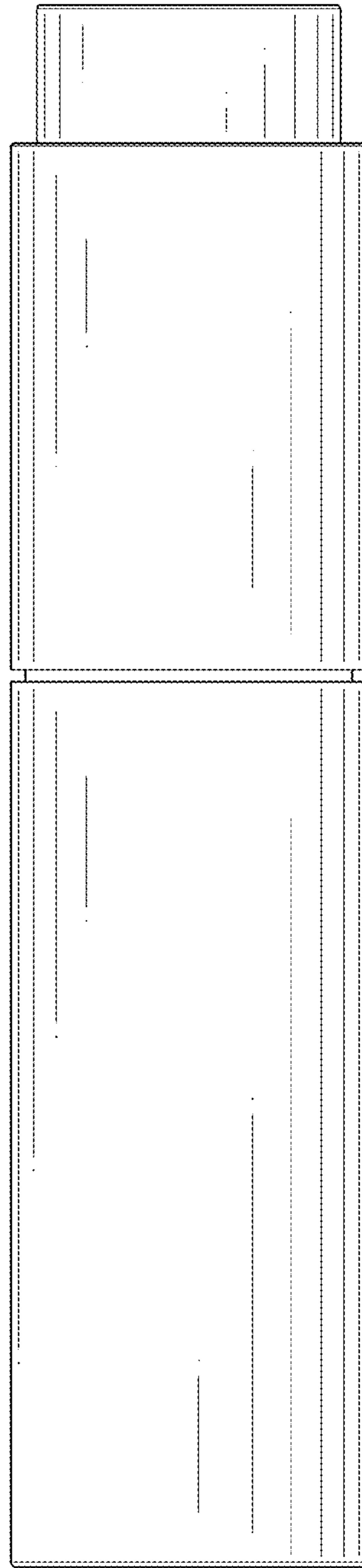

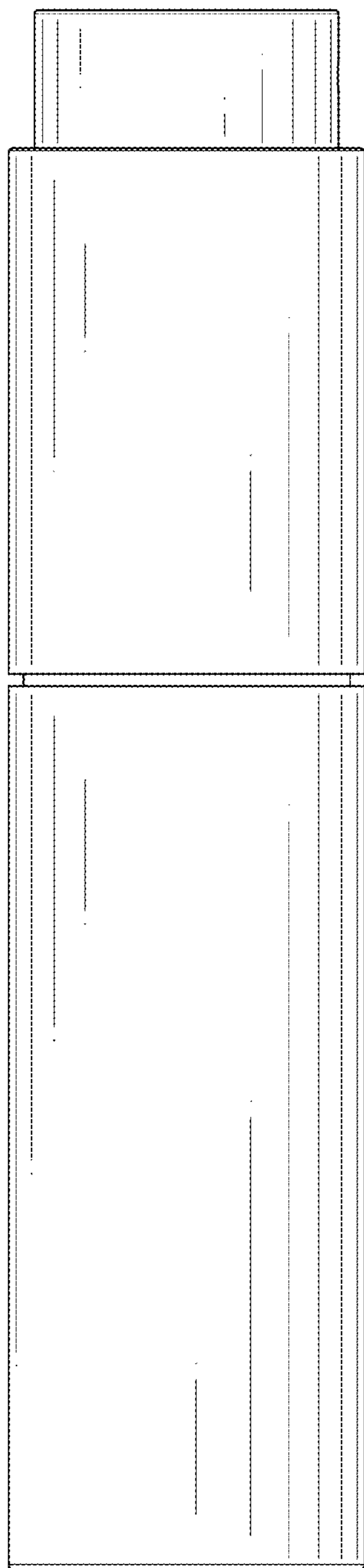

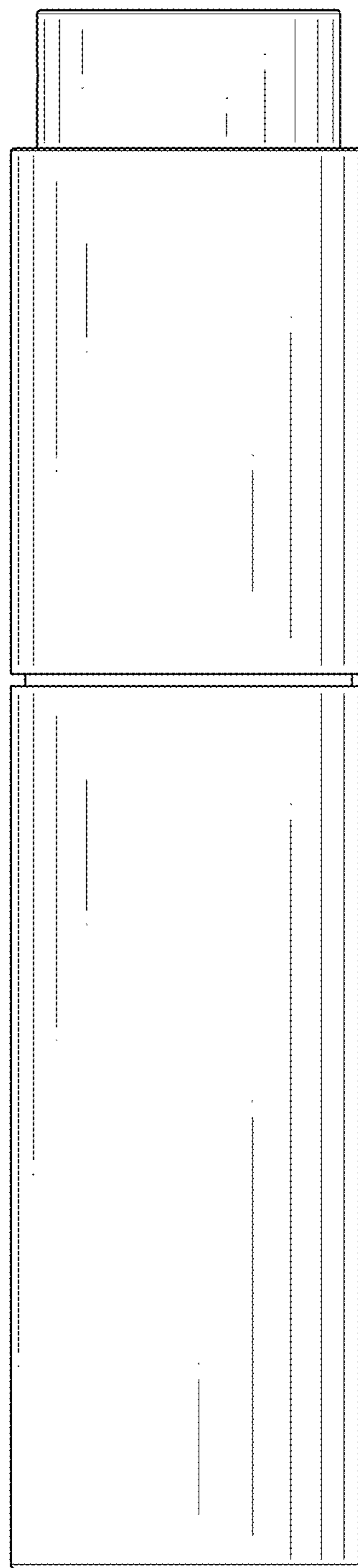

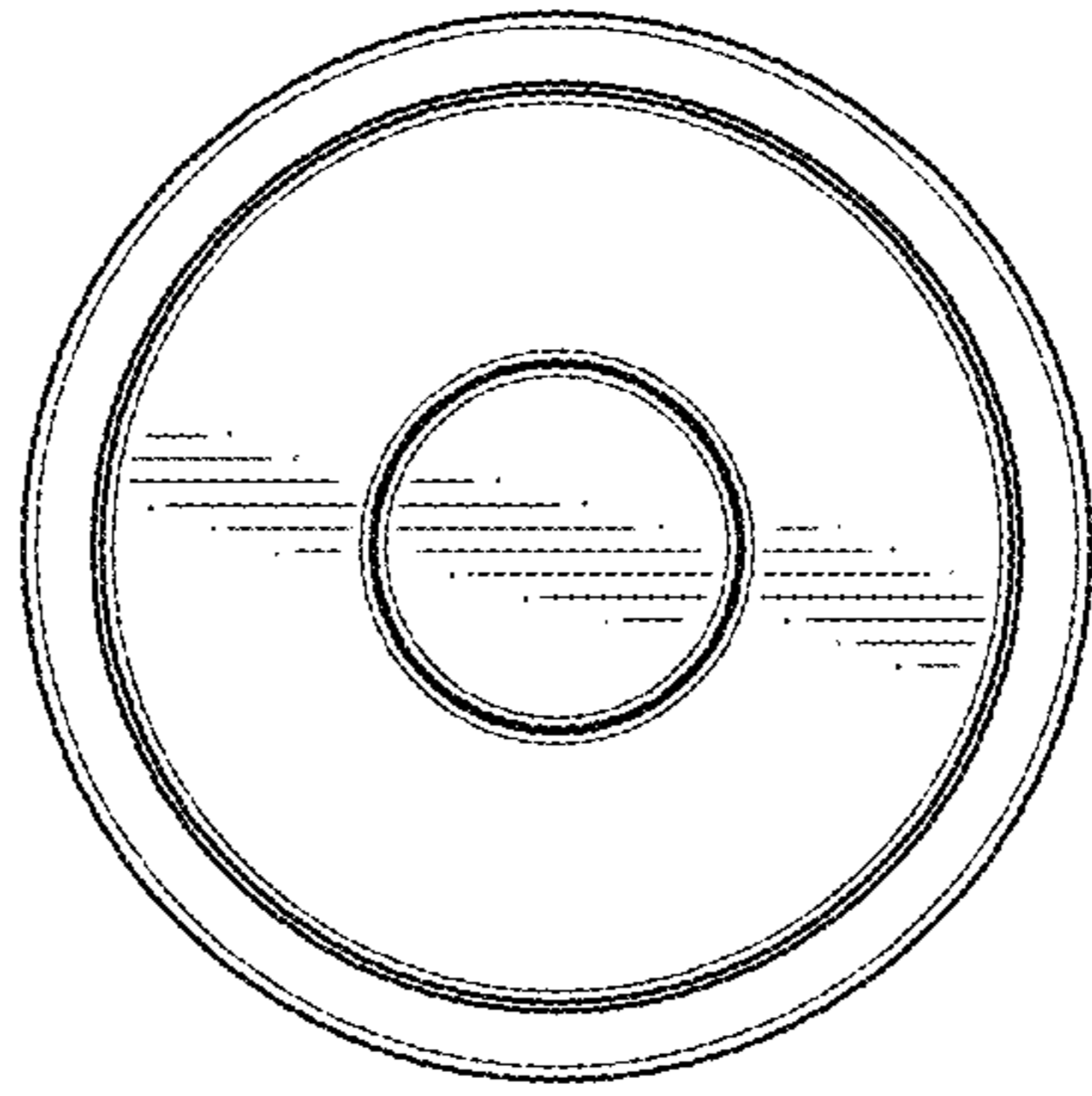

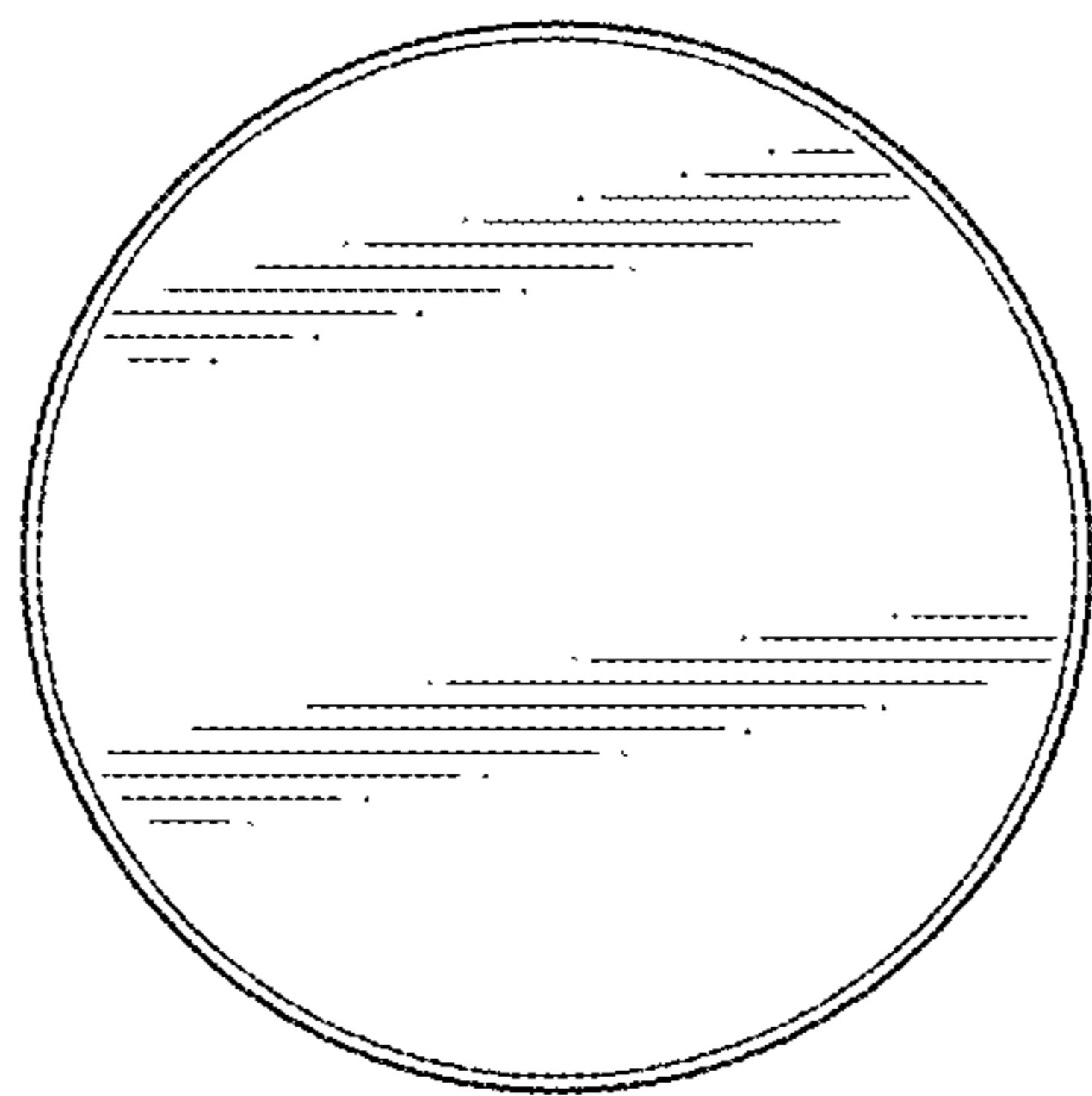

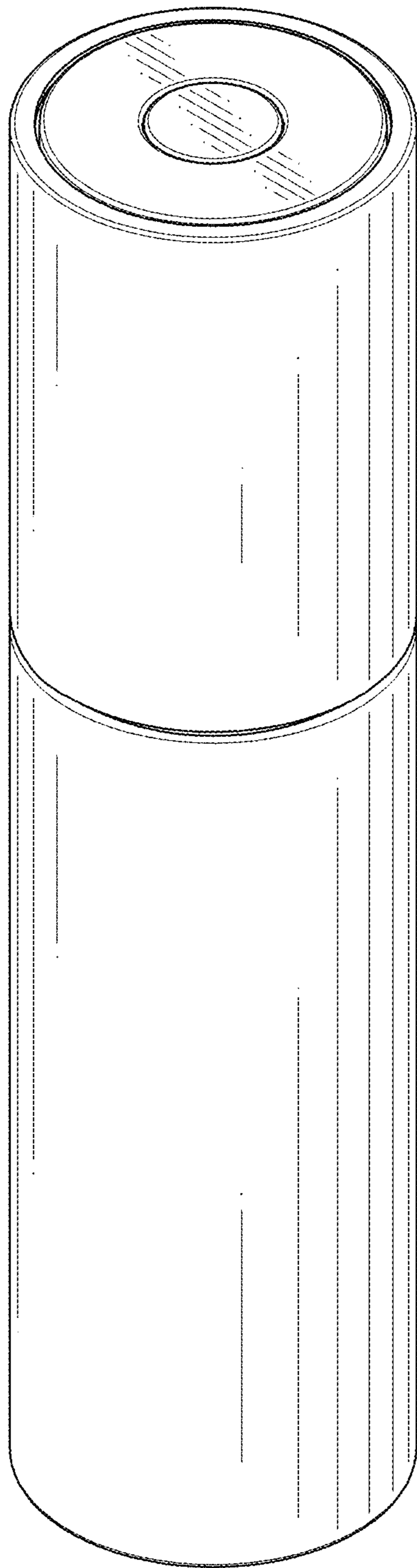
