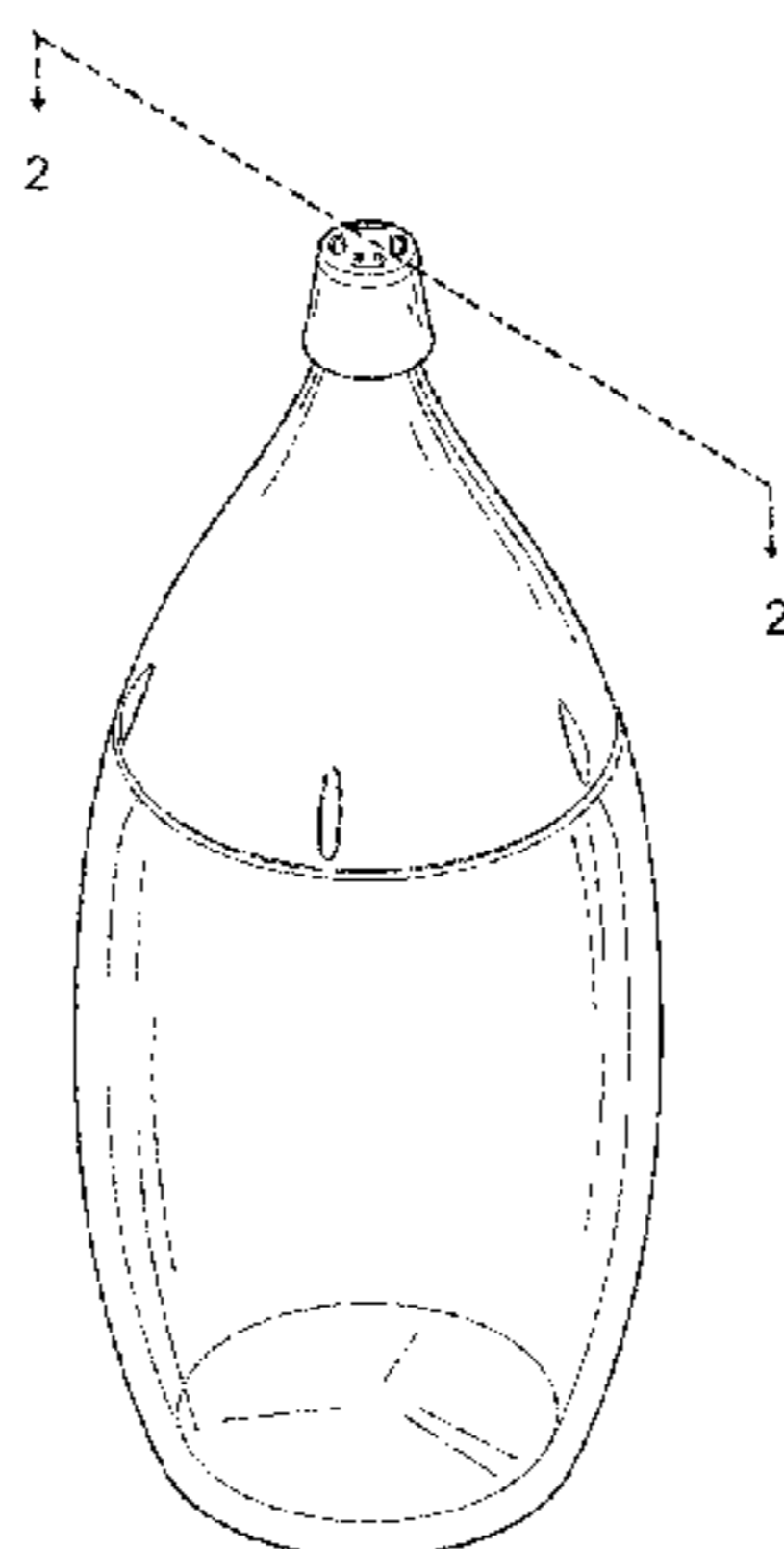
(57) **CLAIM**

The ornamental design for a bottle kit, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, side perspective view of a bottle kit in accordance with our new design; and, FIG. 2 is an exploded side sectional view thereof according to line 2-2 shown in FIG. 1. 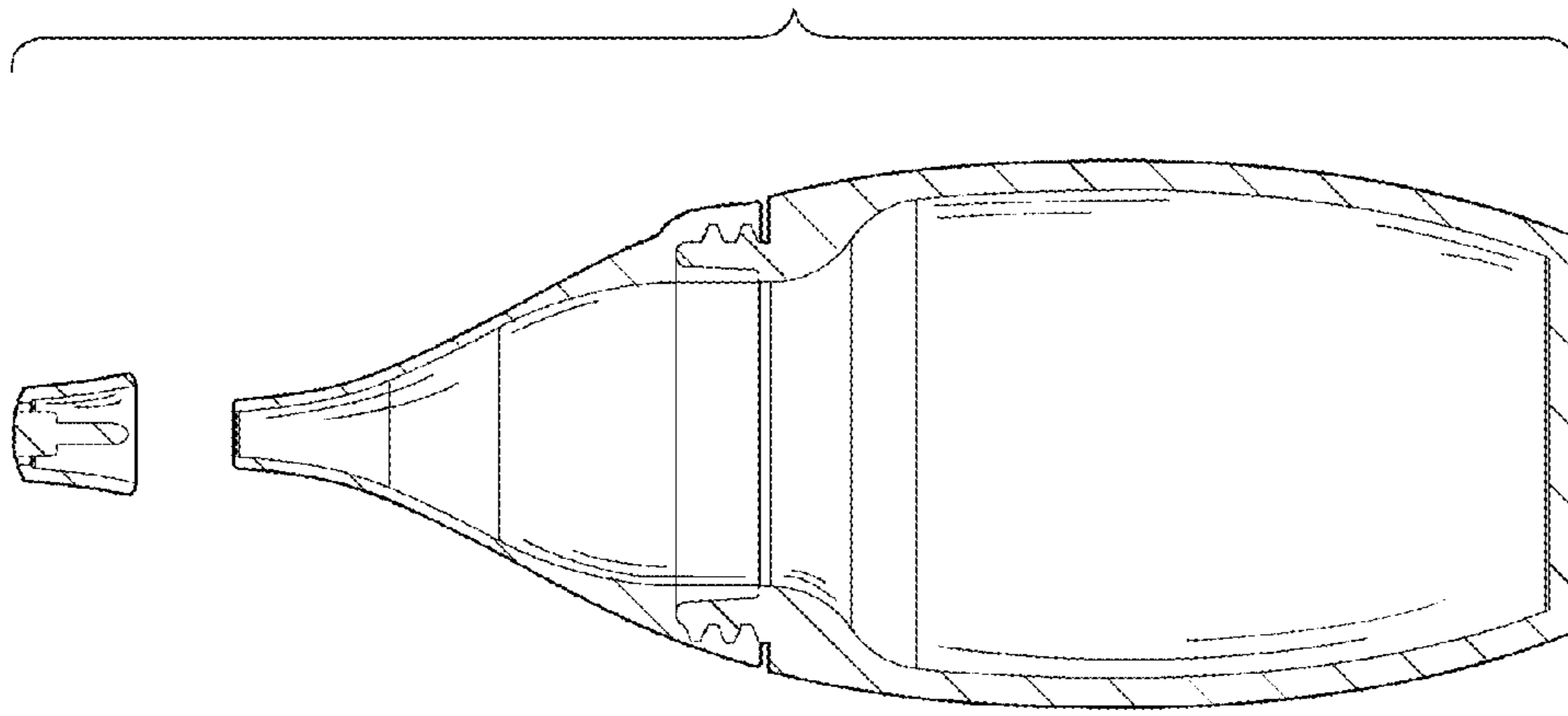

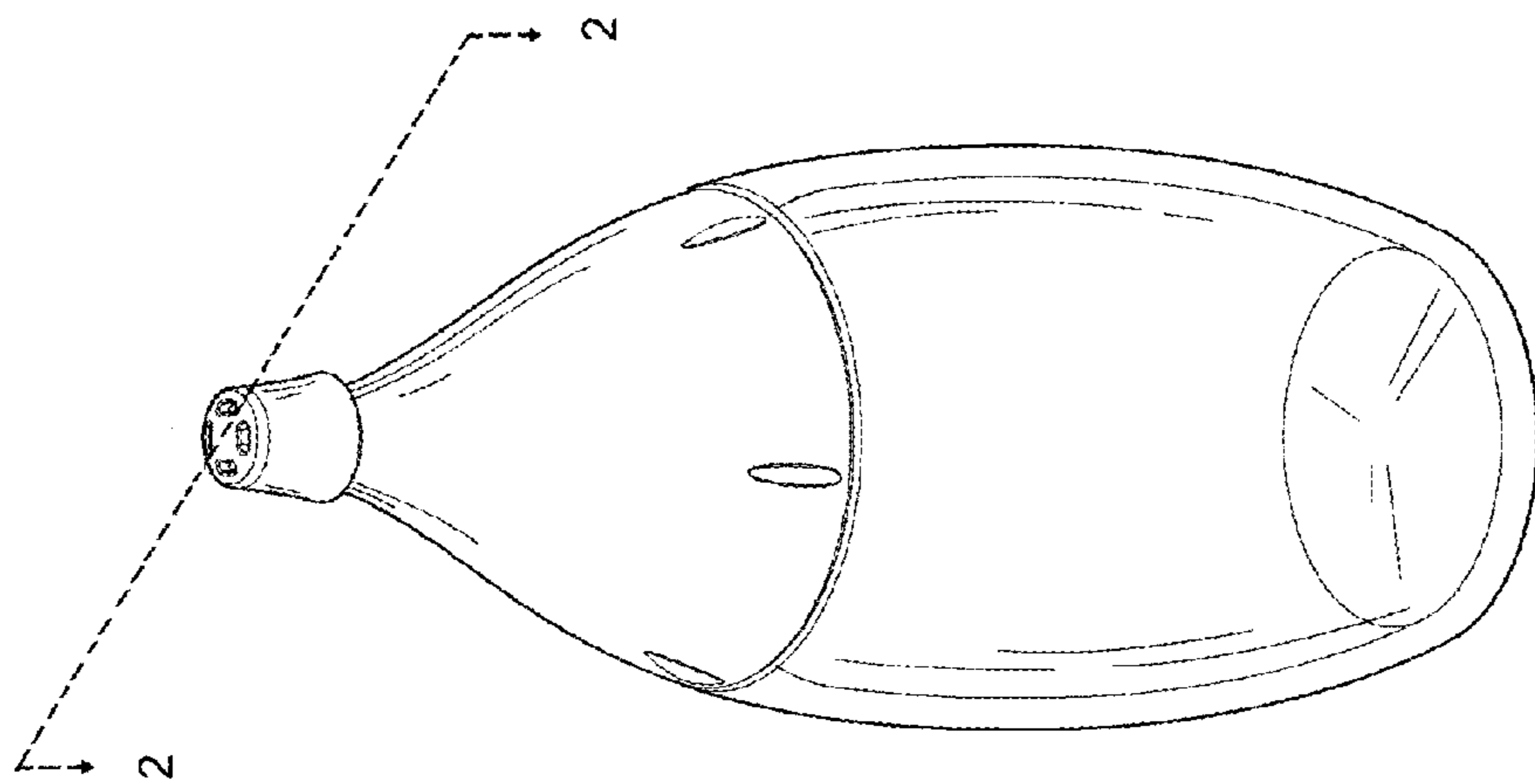
