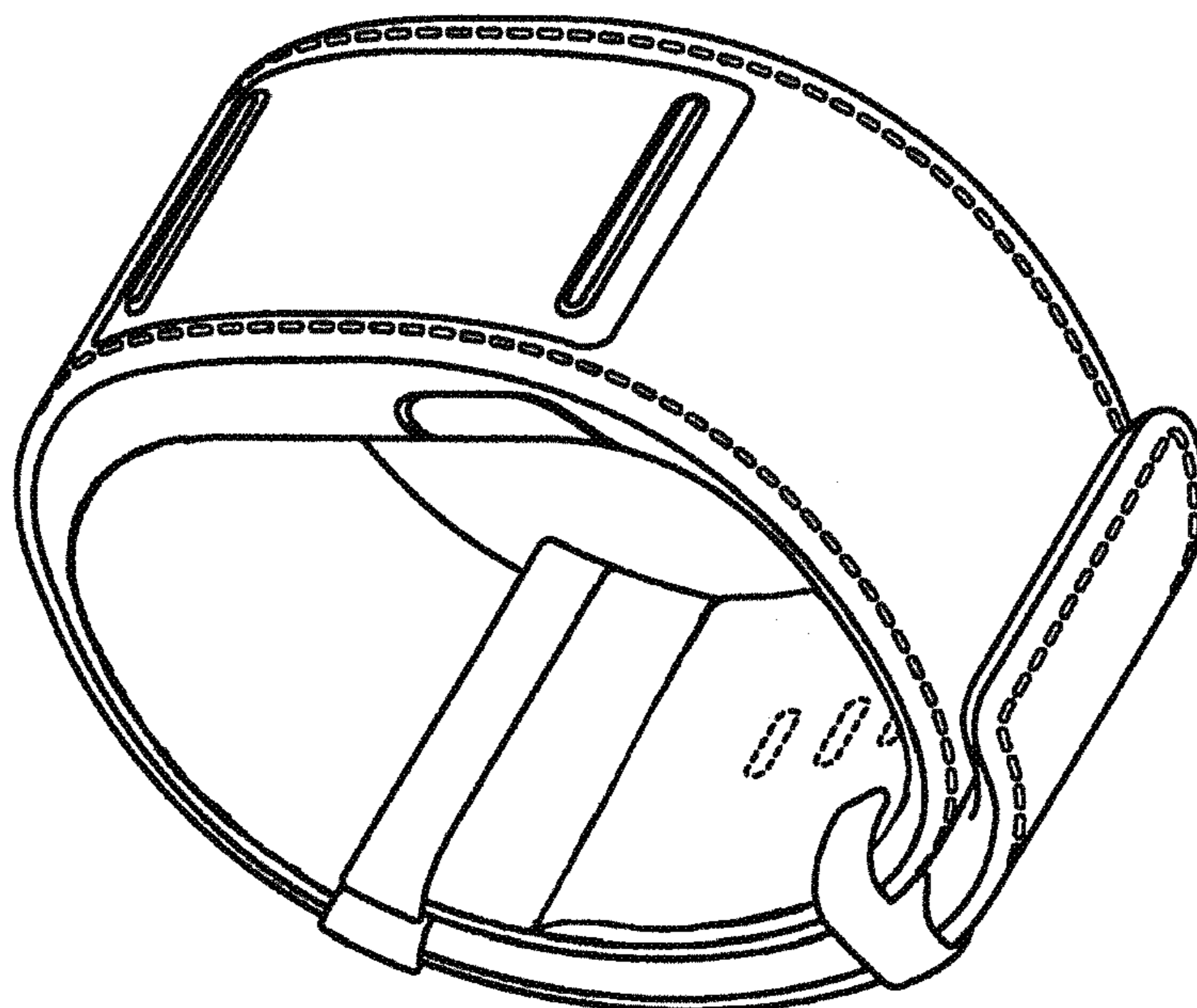
(57) **CLAIM**

The ornamental design for identification bracelet (or wrist strap) with biometric detection, as shown and described.

DESCRIPTION

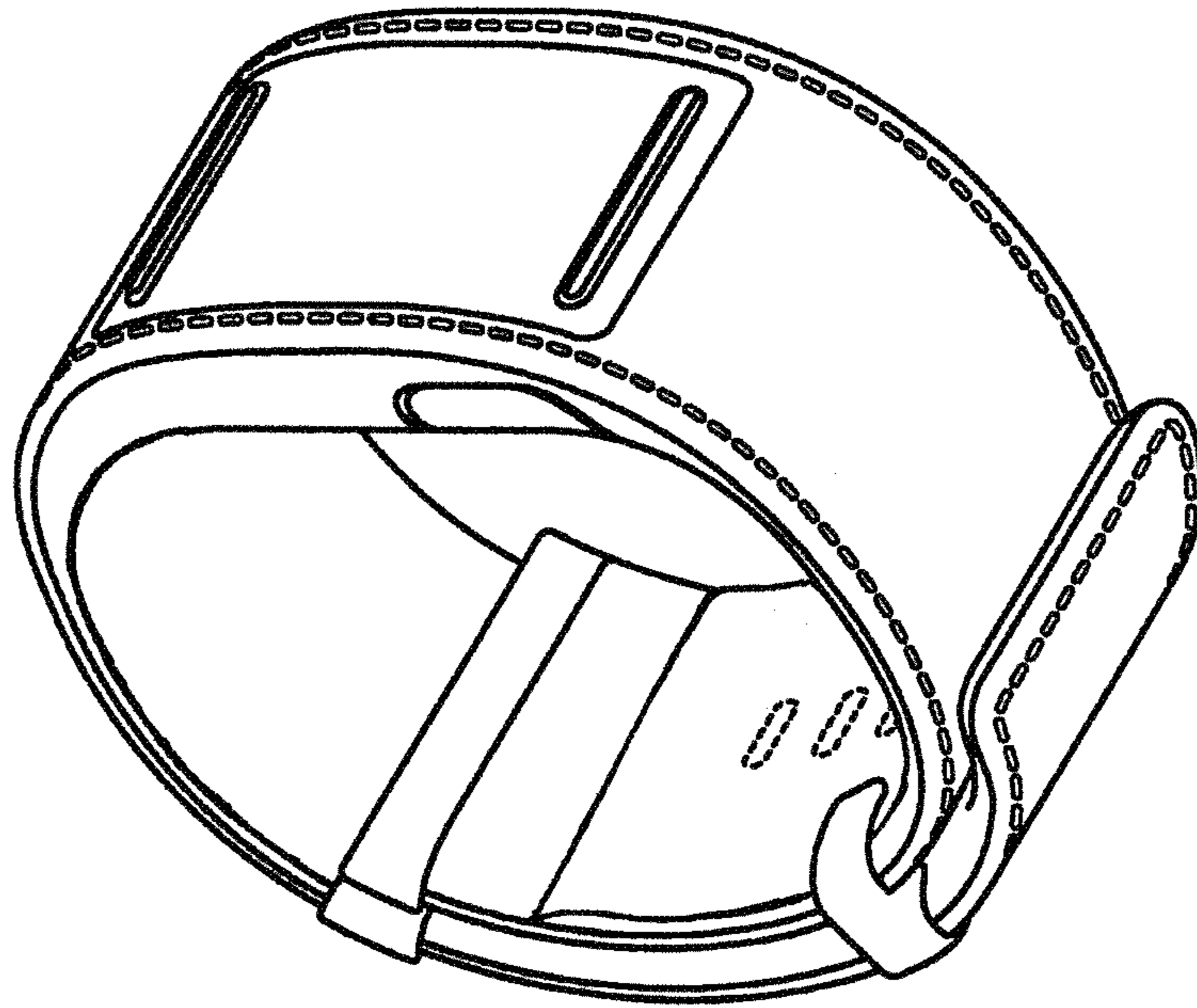

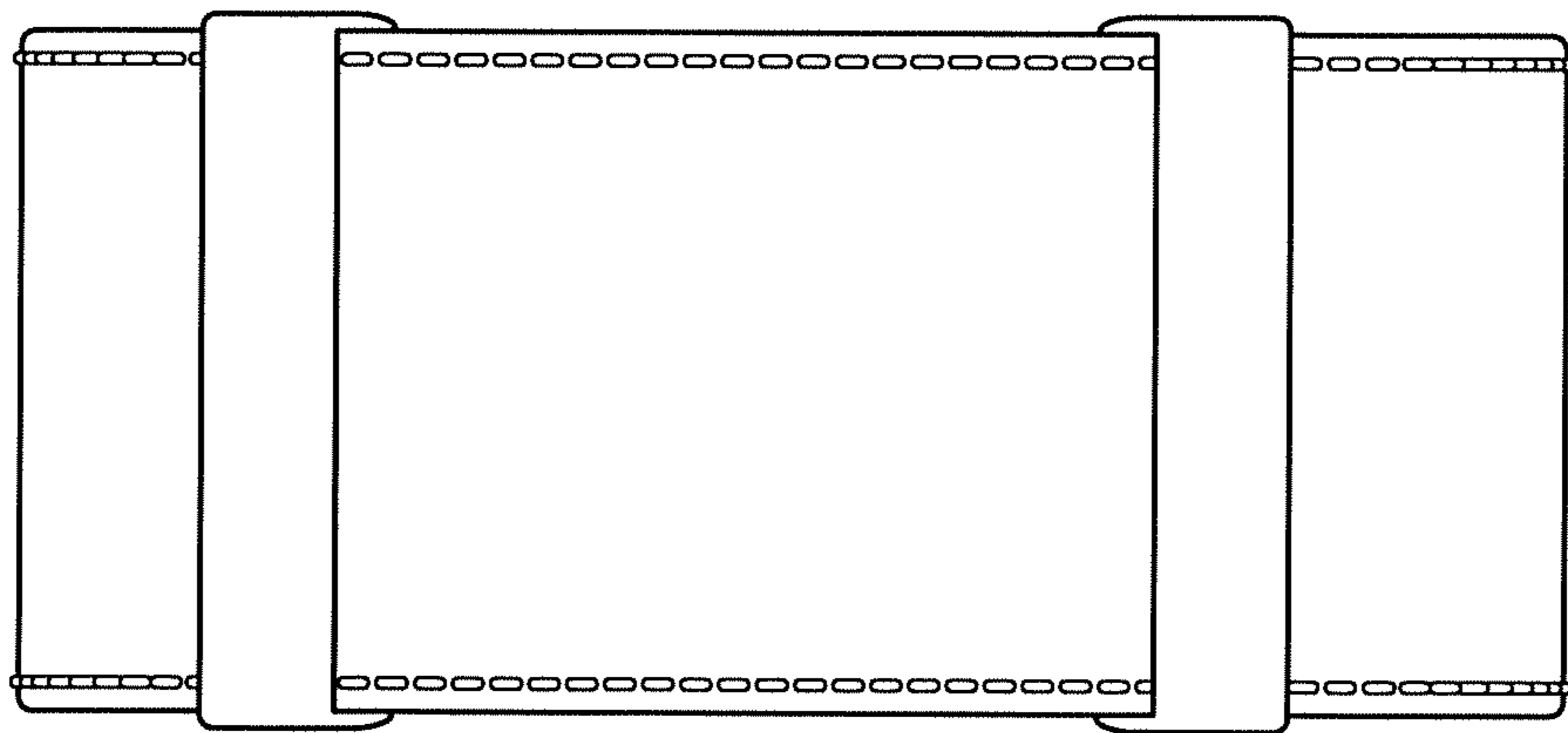

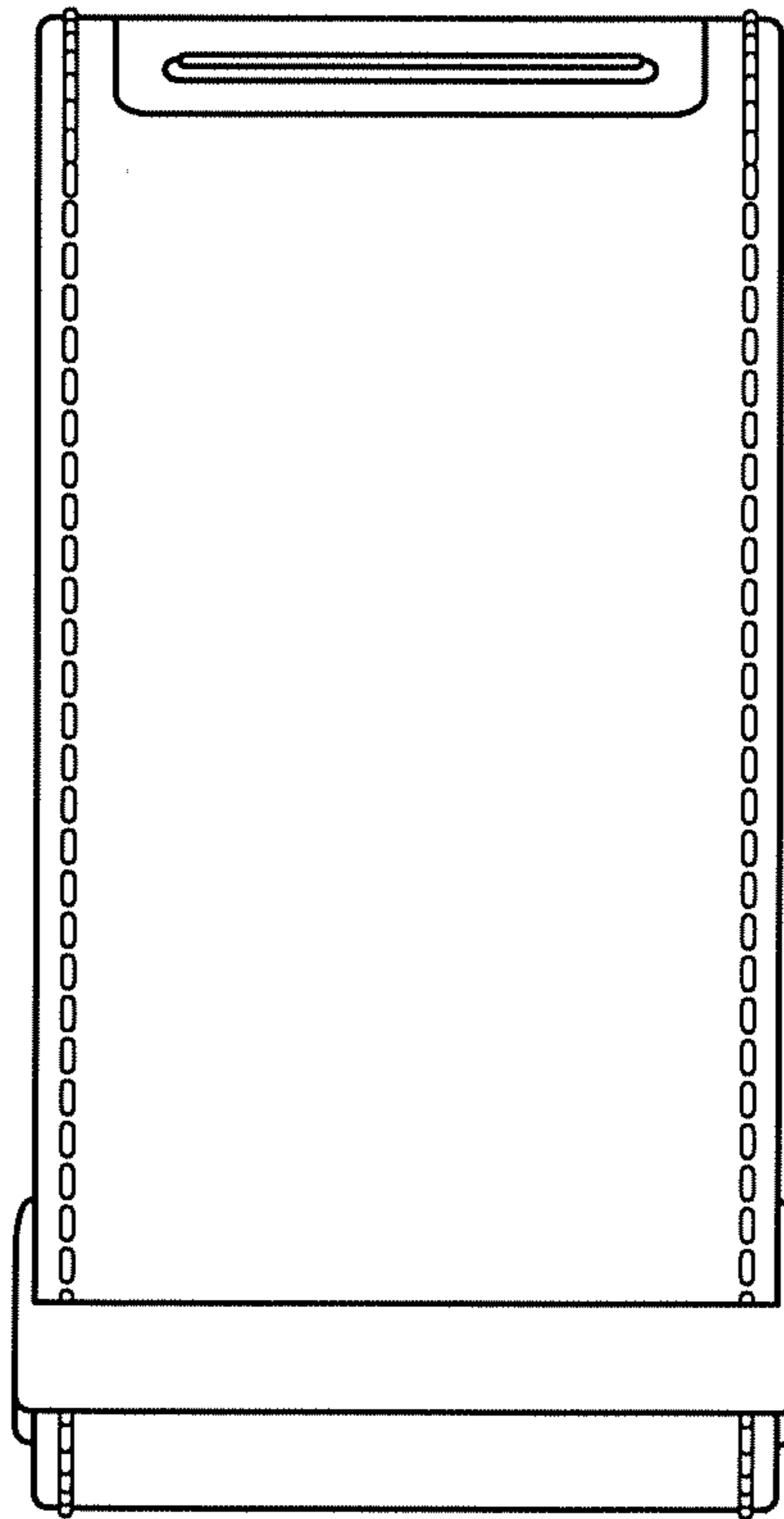

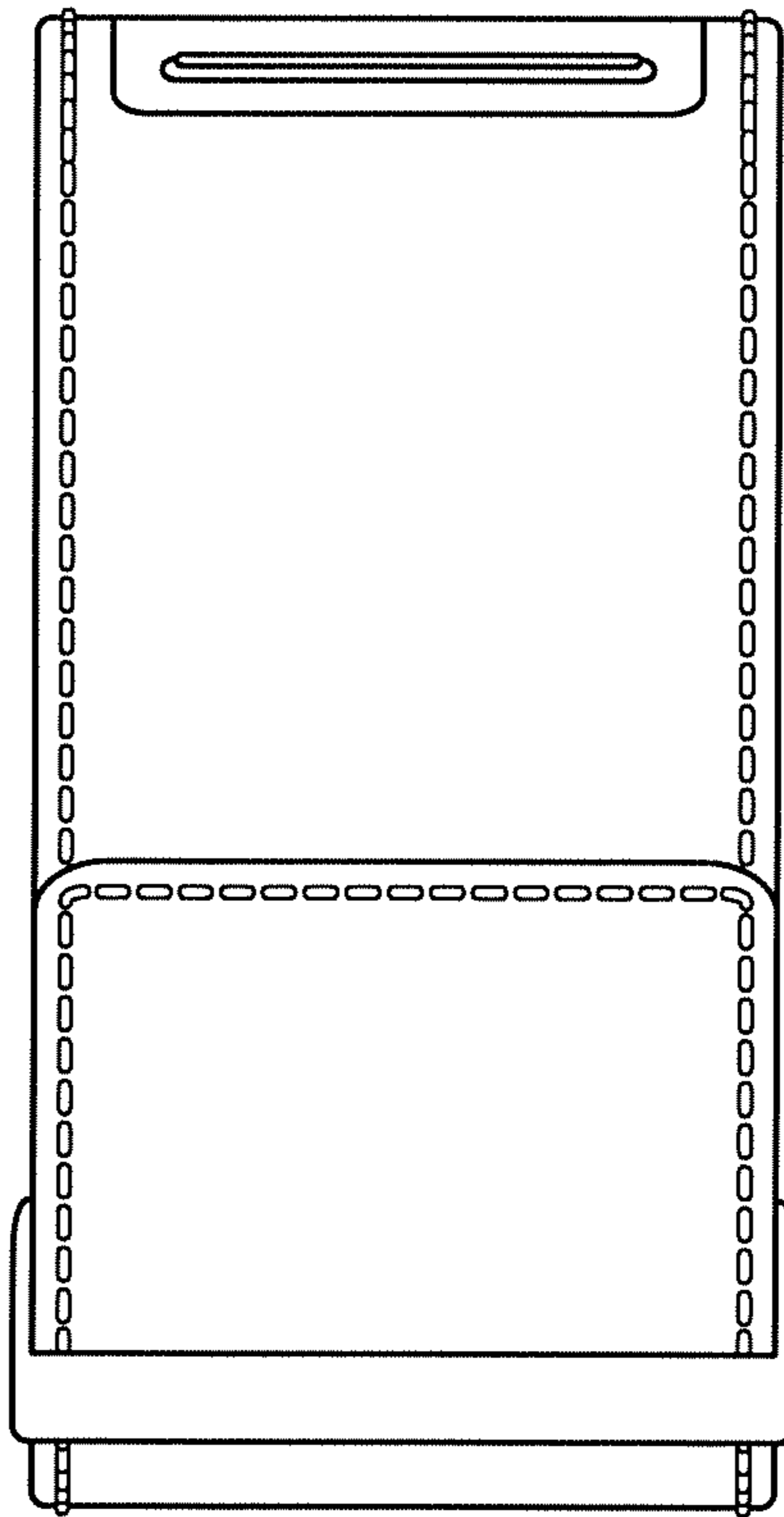

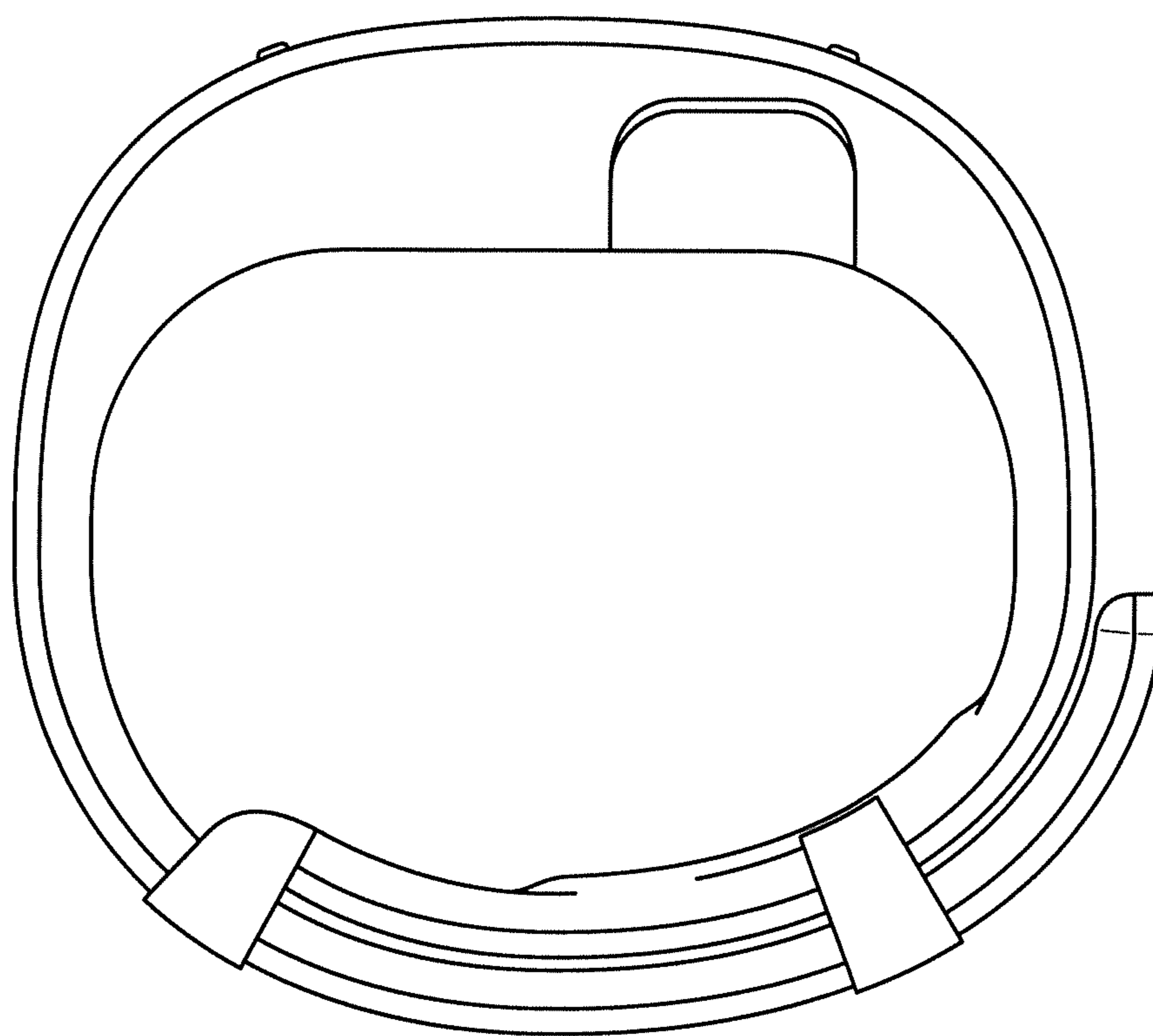
