The ornamental design for a steering wheel for automobile, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the front side of a steering wheel for automobile.

FIG. 2 is a front elevation view thereof.

FIG. 3 is a top plan view thereof.

FIG. 4 is a bottom plan view thereof; and,

FIG. 5 is a right side elevation view thereof.

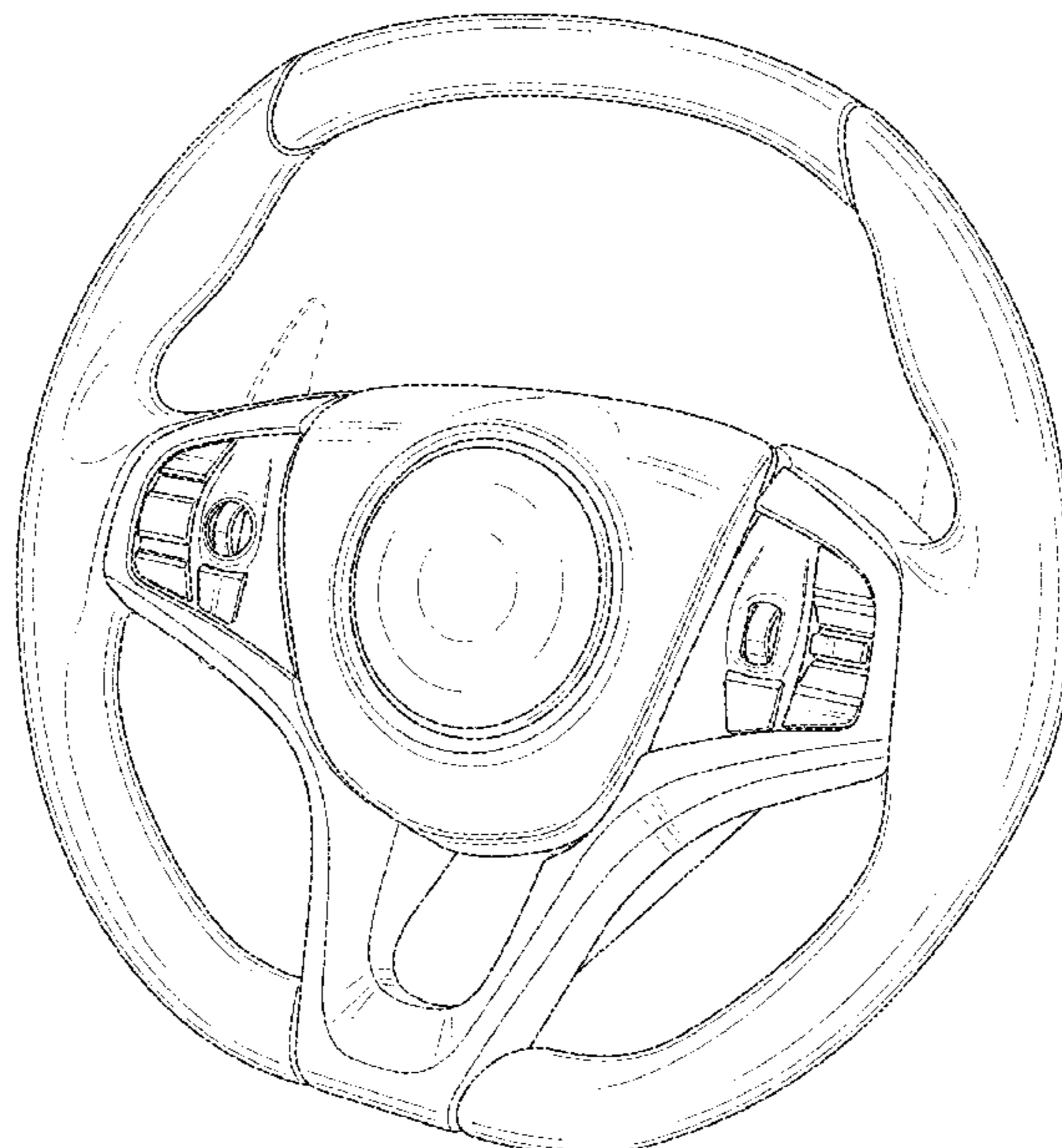

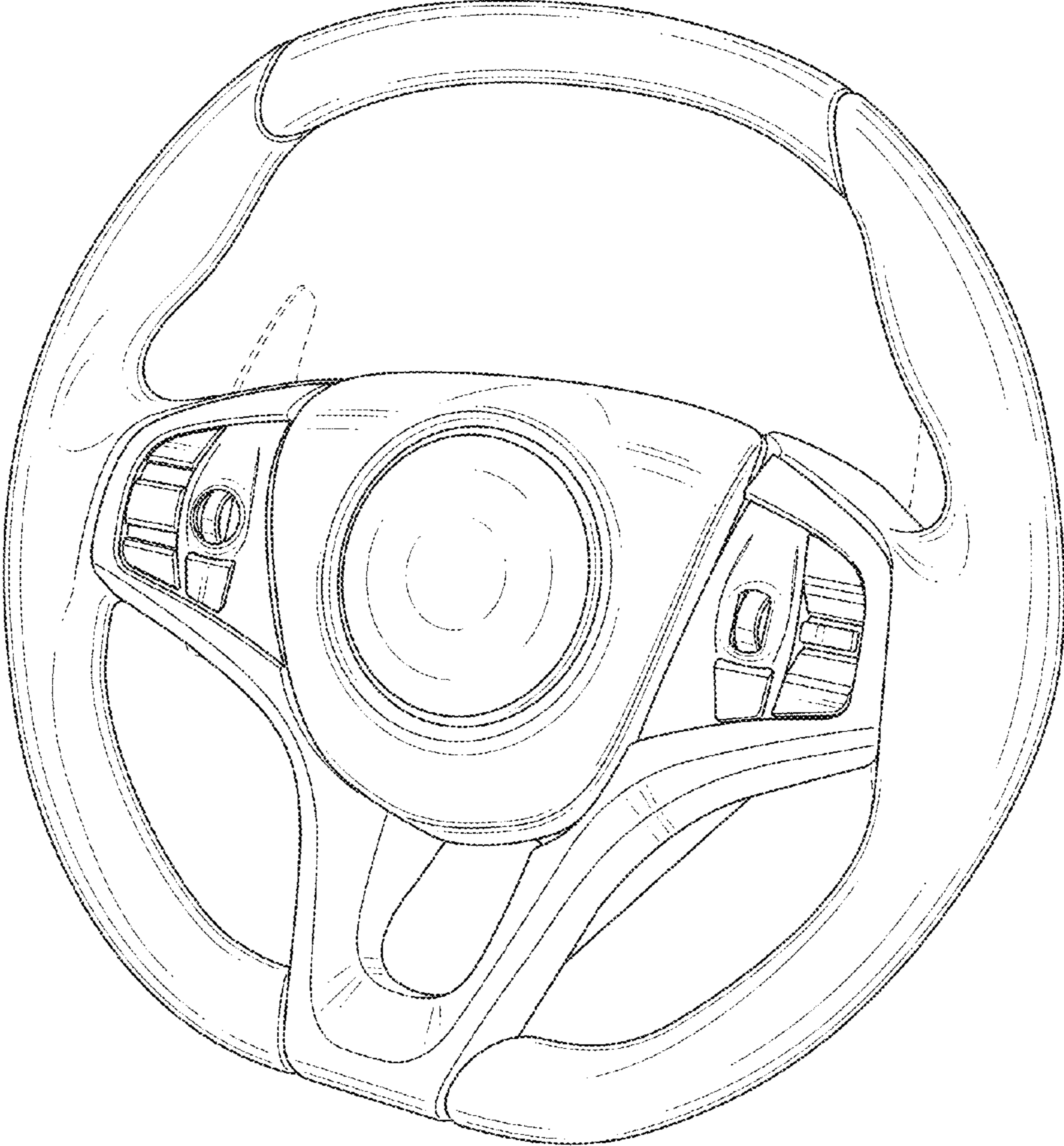

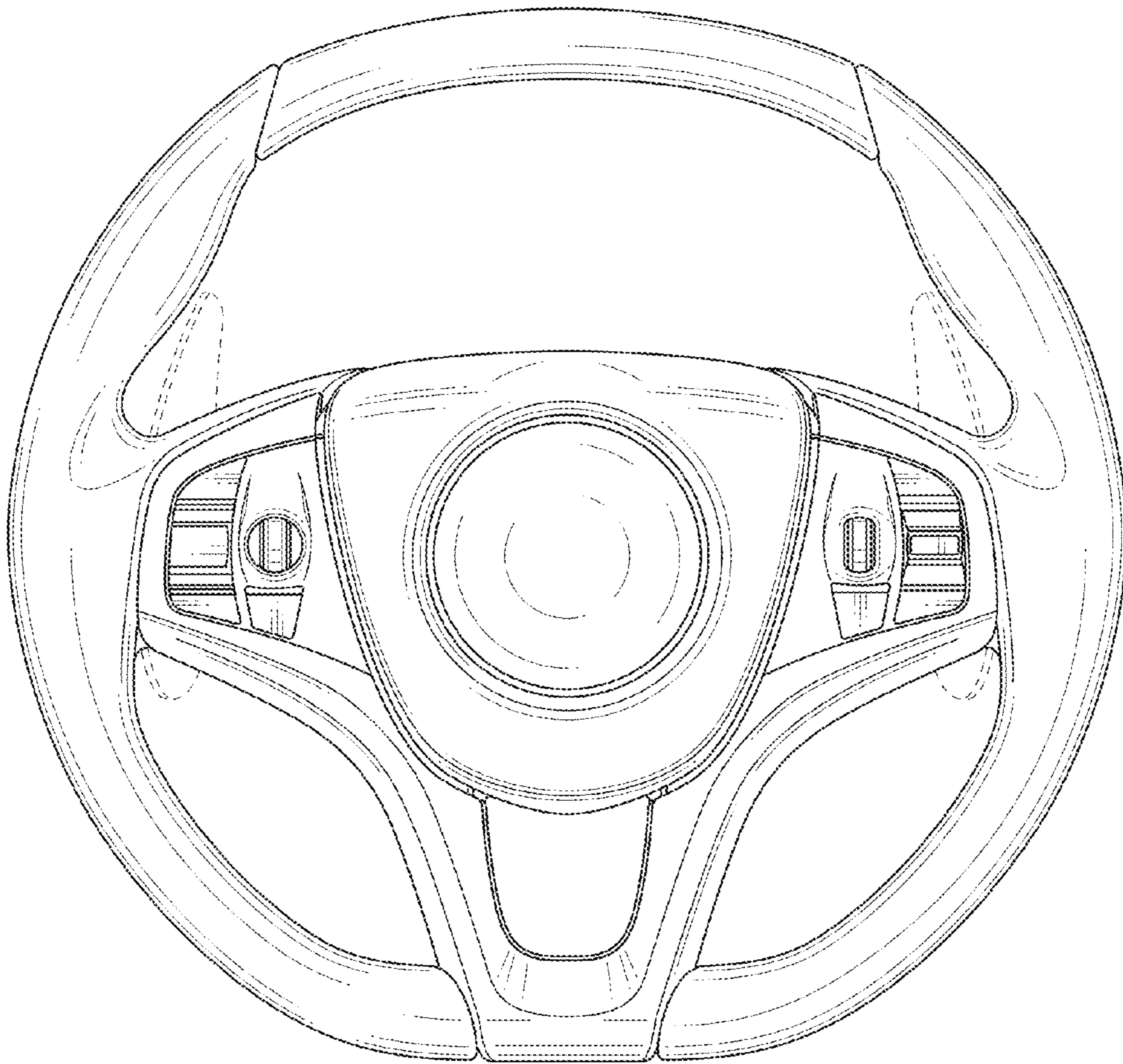

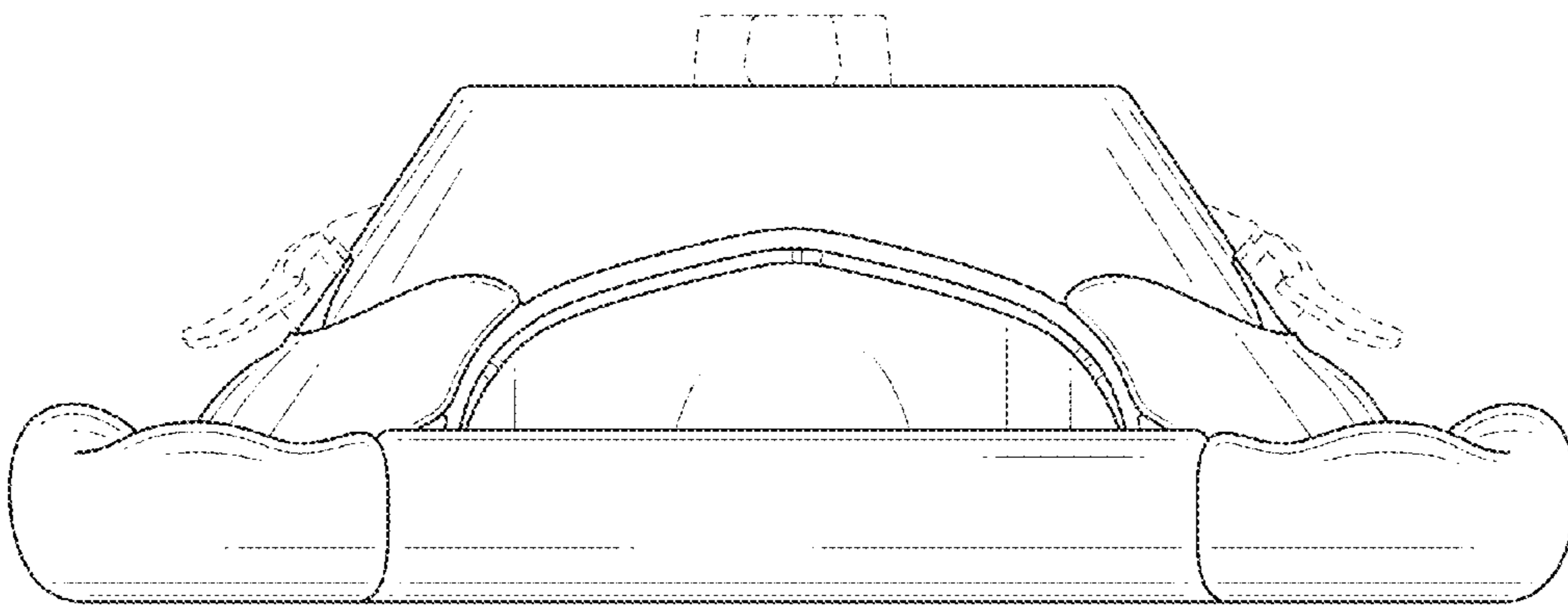

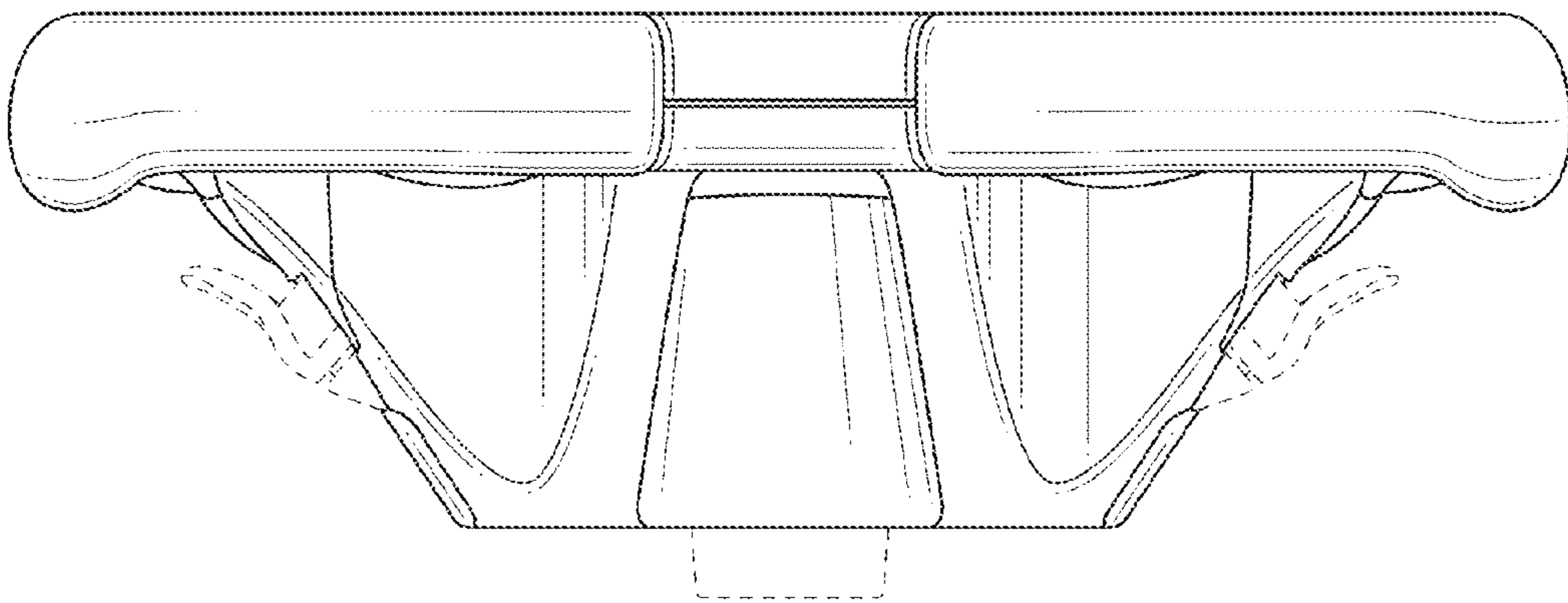
