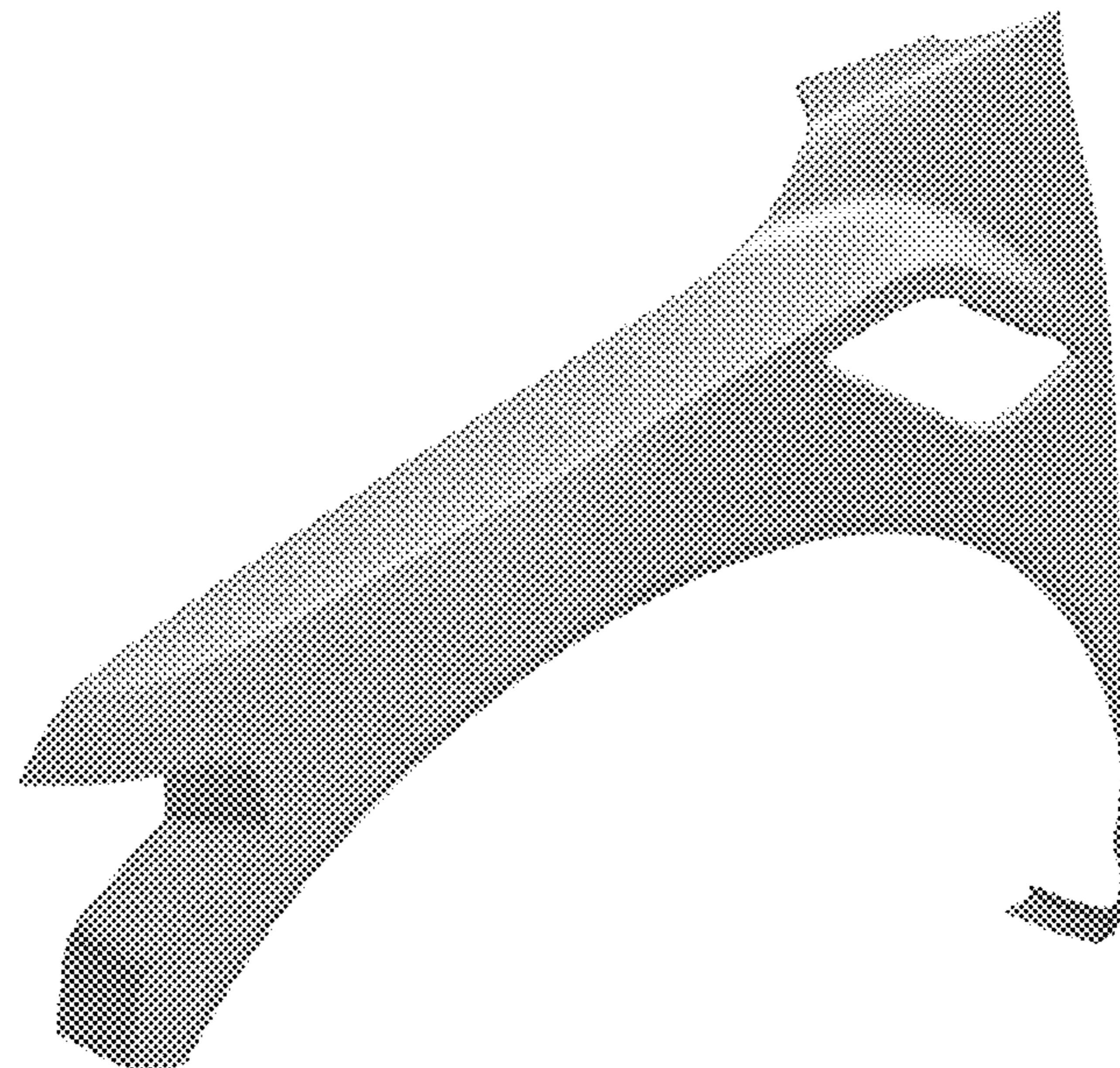
(57) **CLAIM**

The ornamental design for a motor vehicle front fender, as shown and described.

DESCRIPTION

FIG. 1 is a front and left side perspective view of the motor vehicle front fender showing our new design;

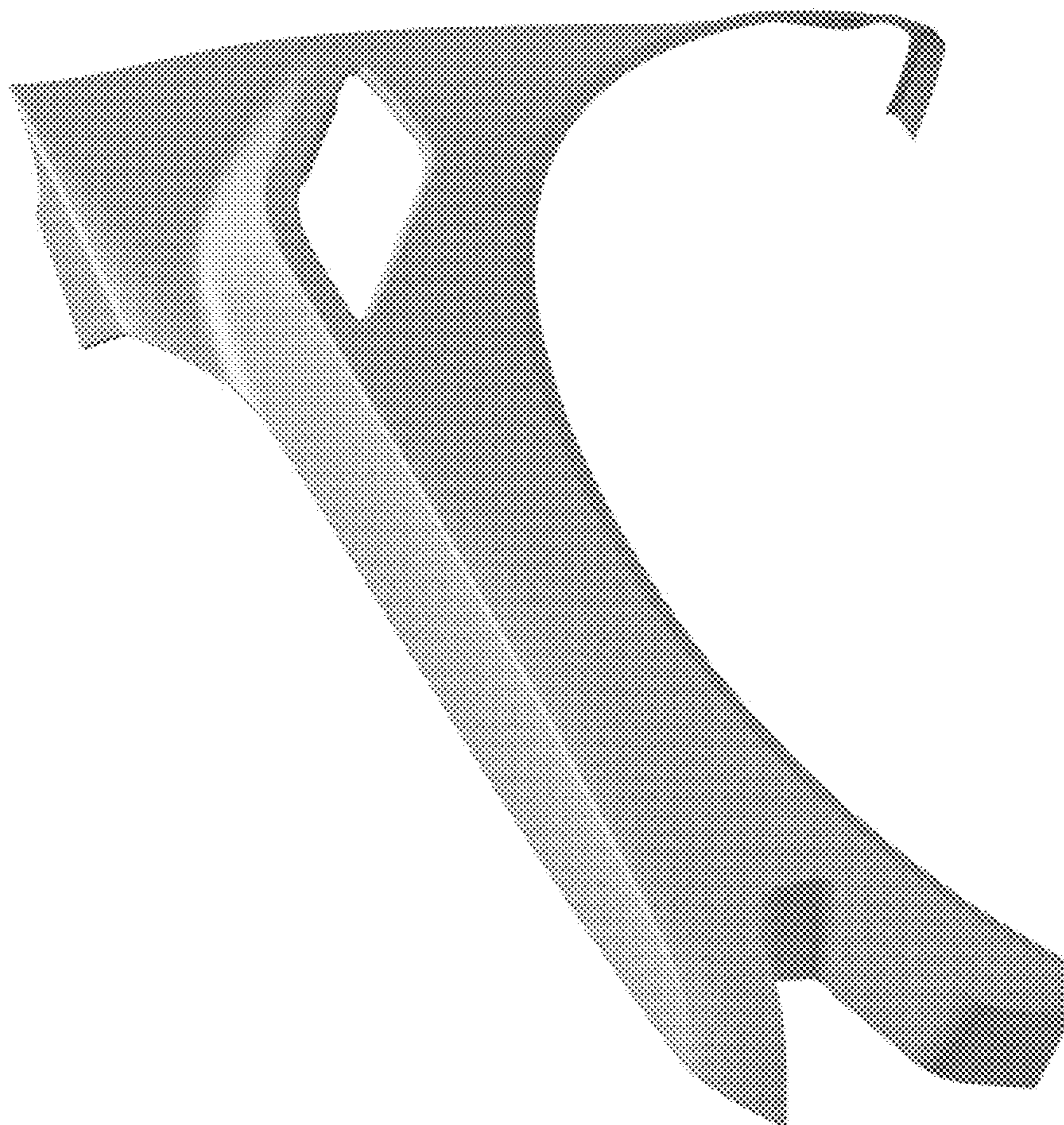

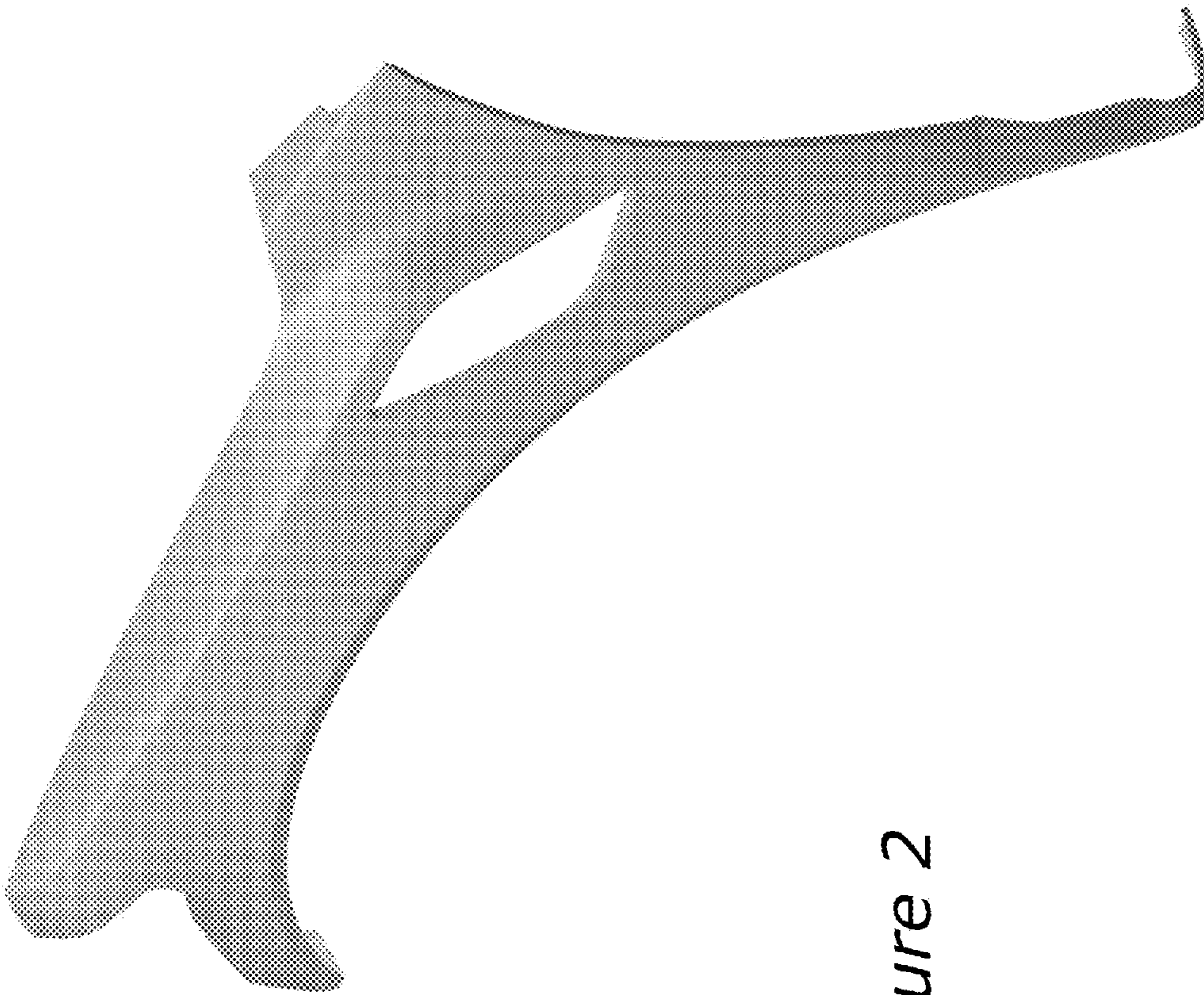

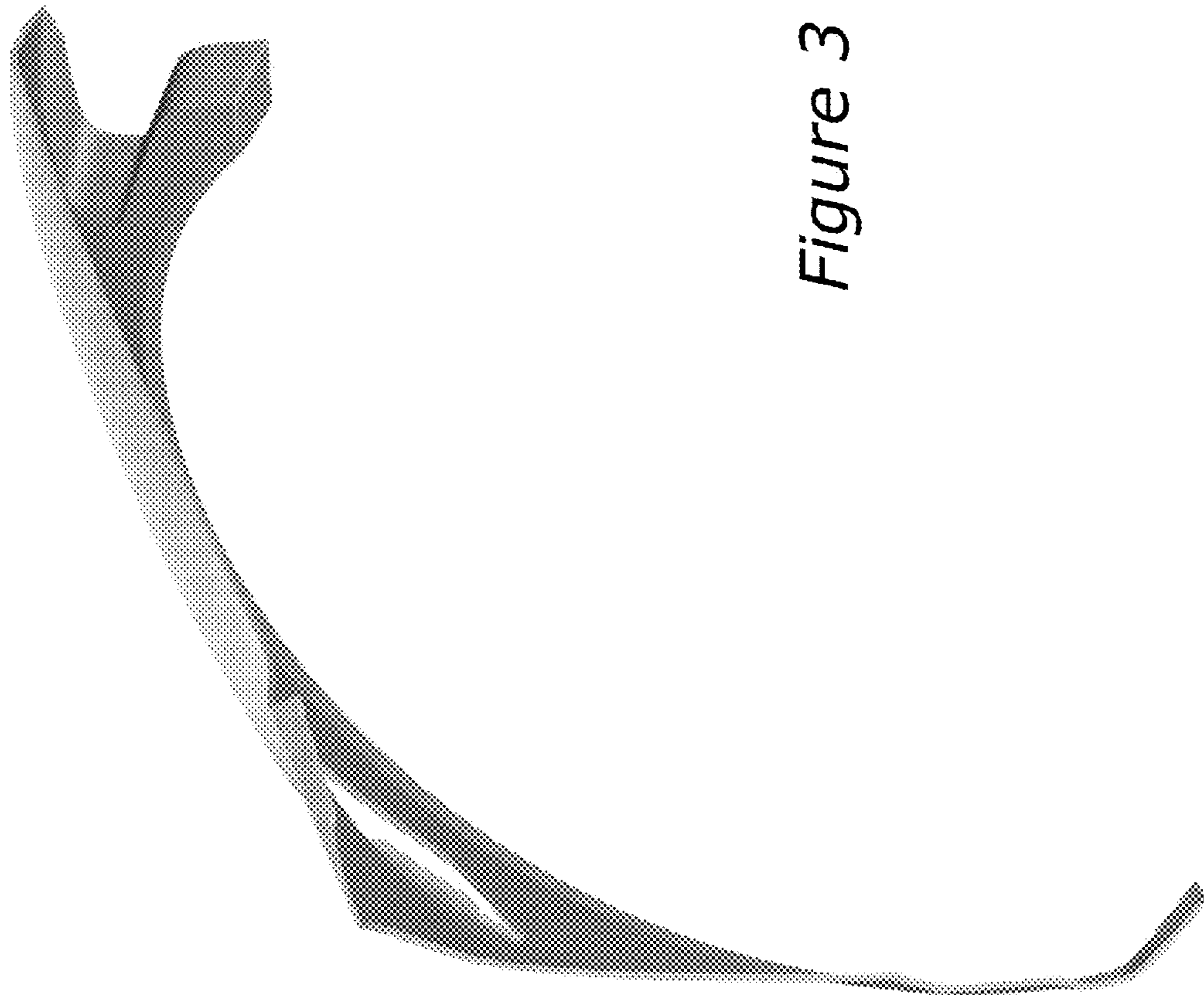
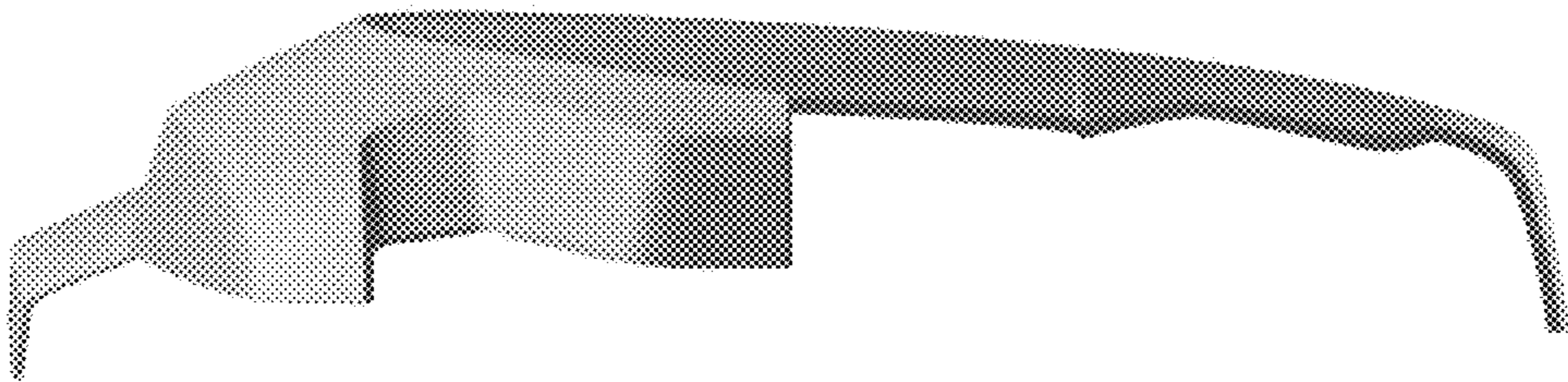

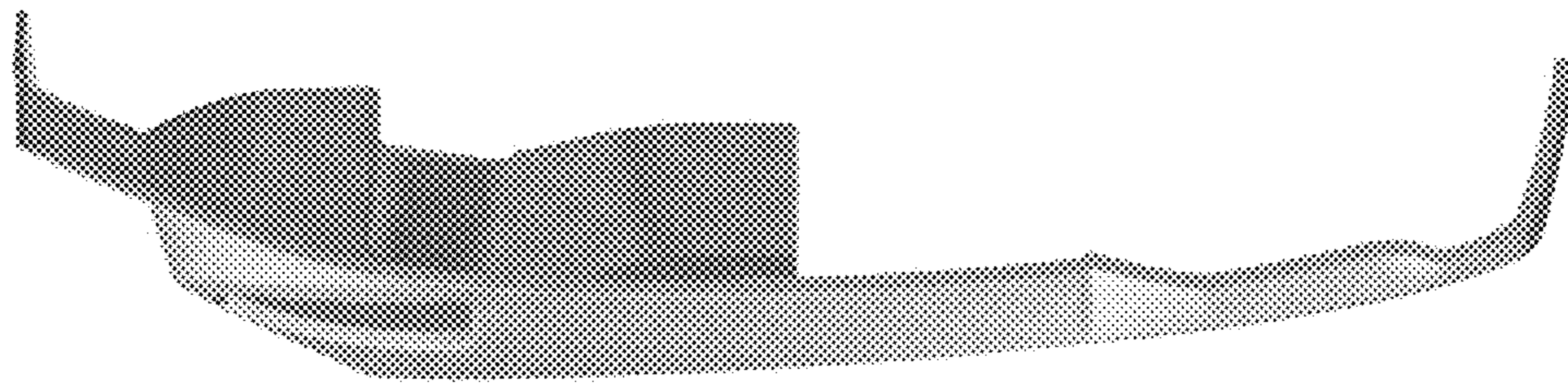

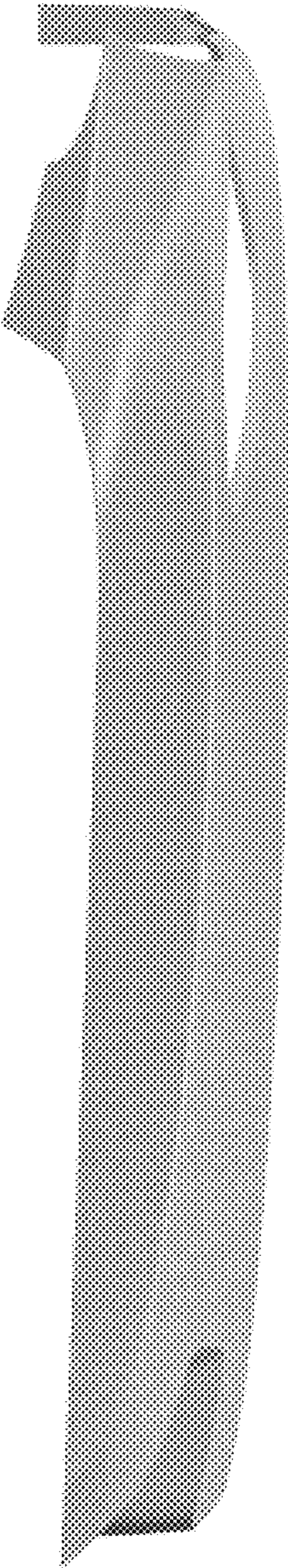

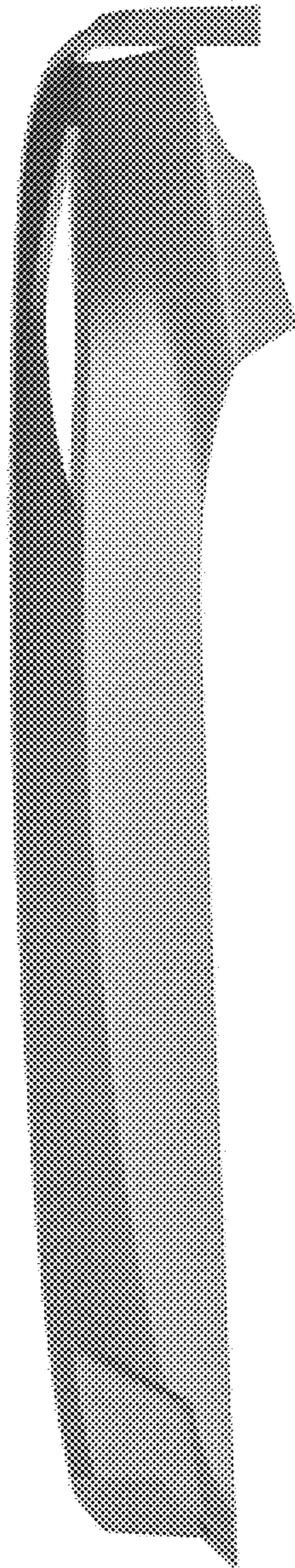
