DESCRIPTION

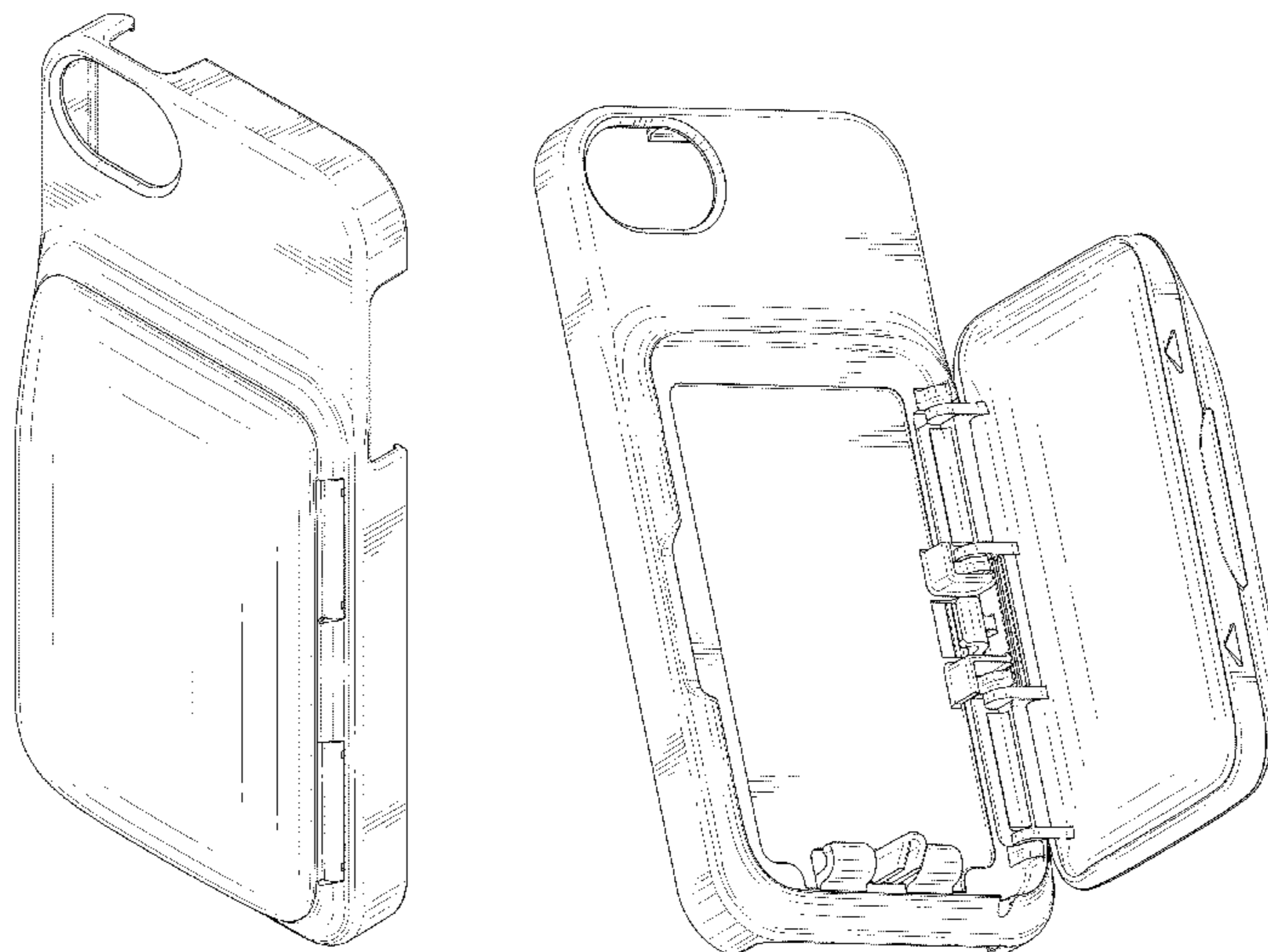
FIG. 1 is a first front side perspective view of a combo earphone case showing the new design, with the door in a closed position;

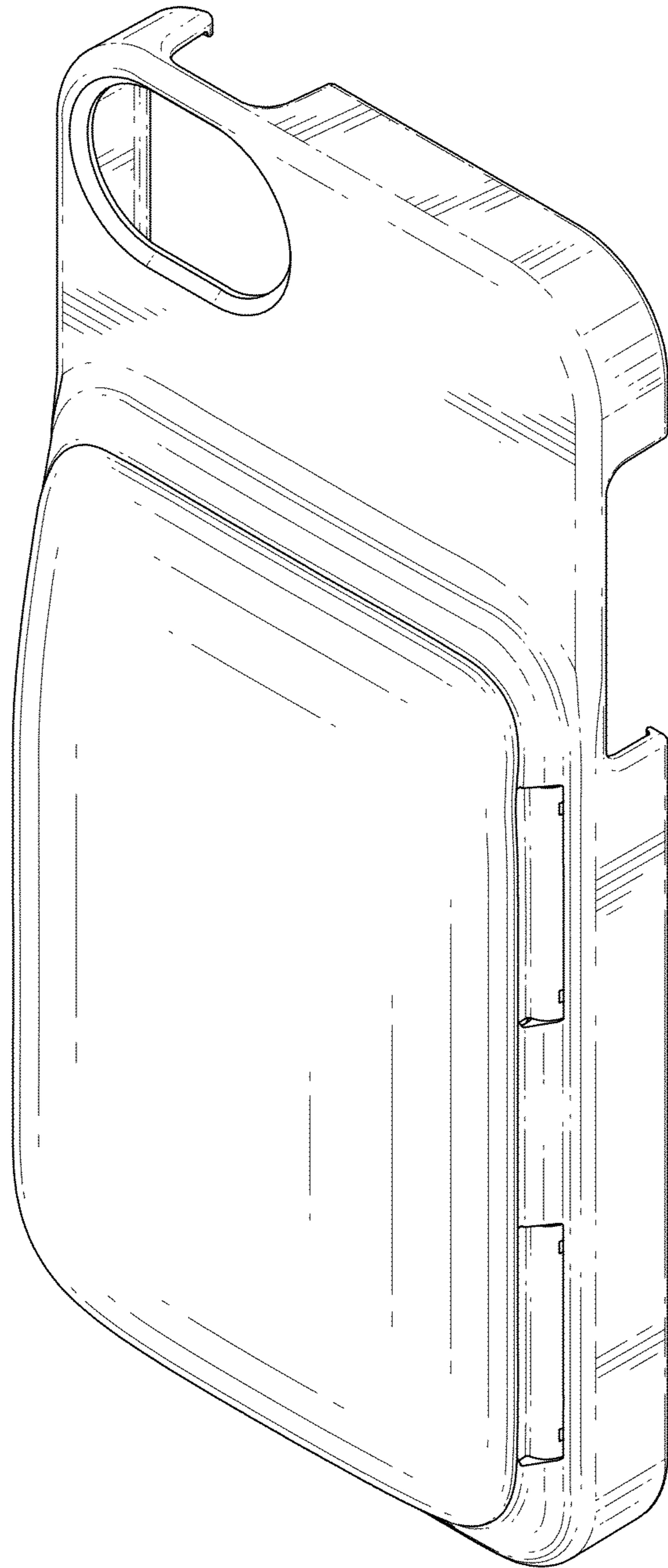

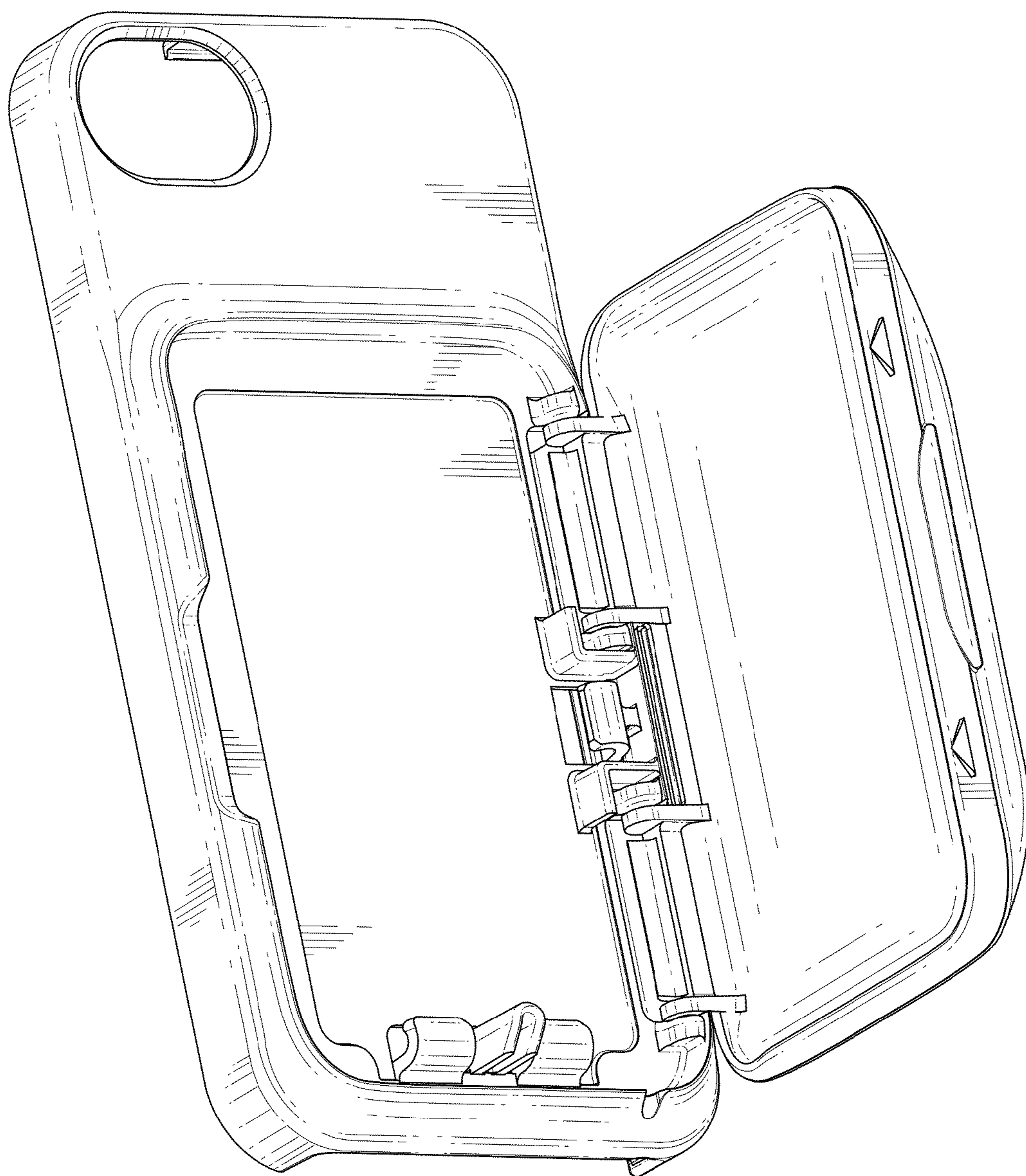

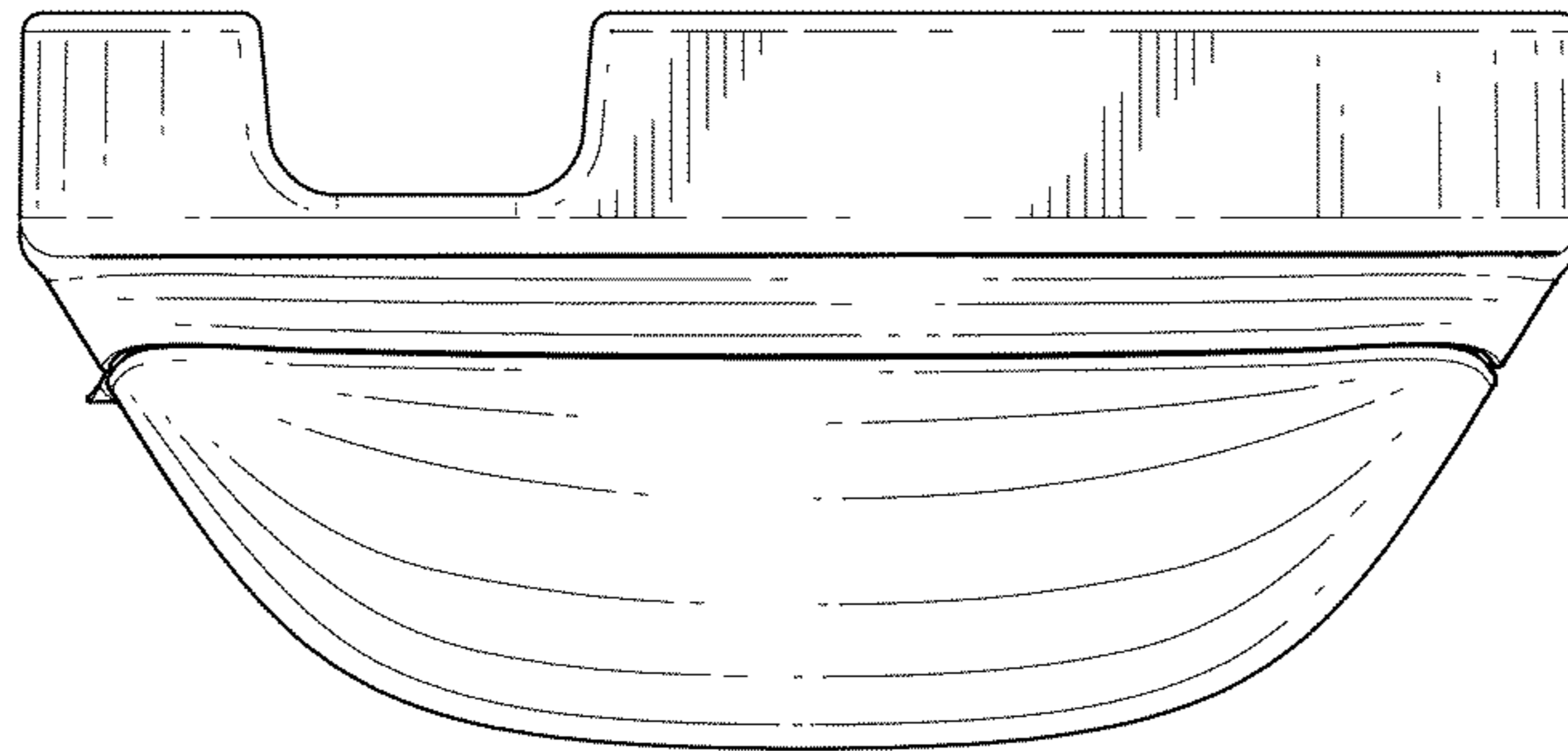

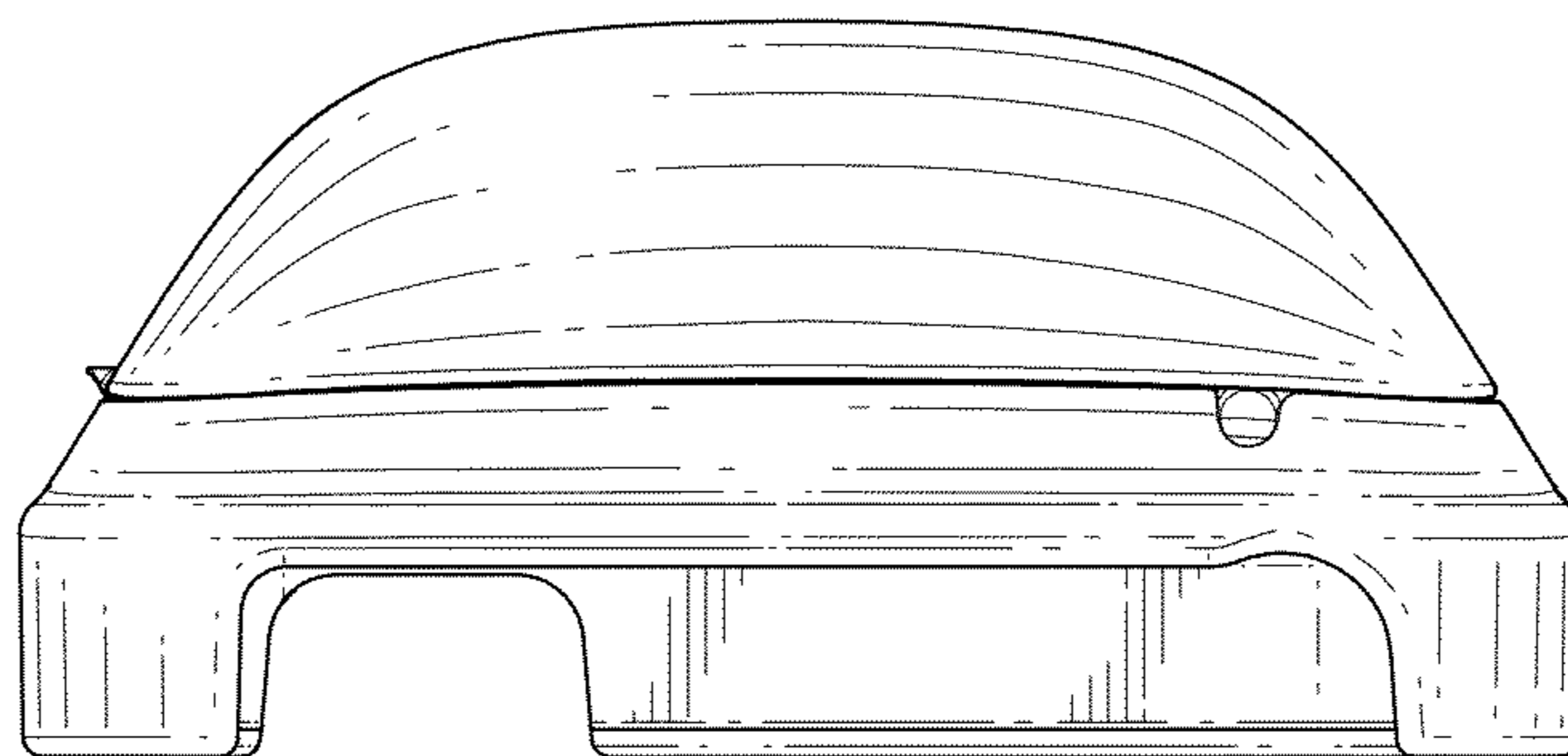

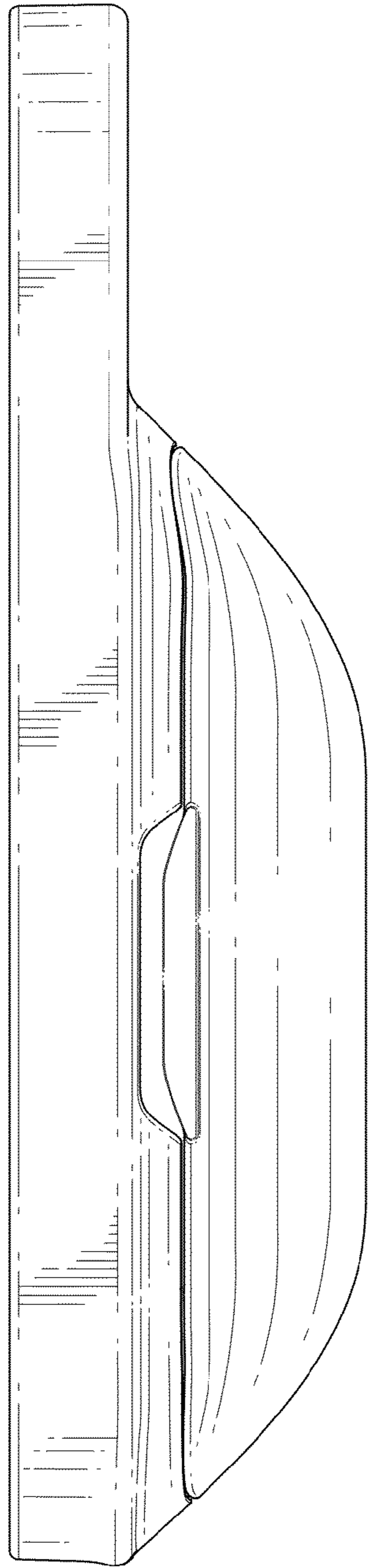

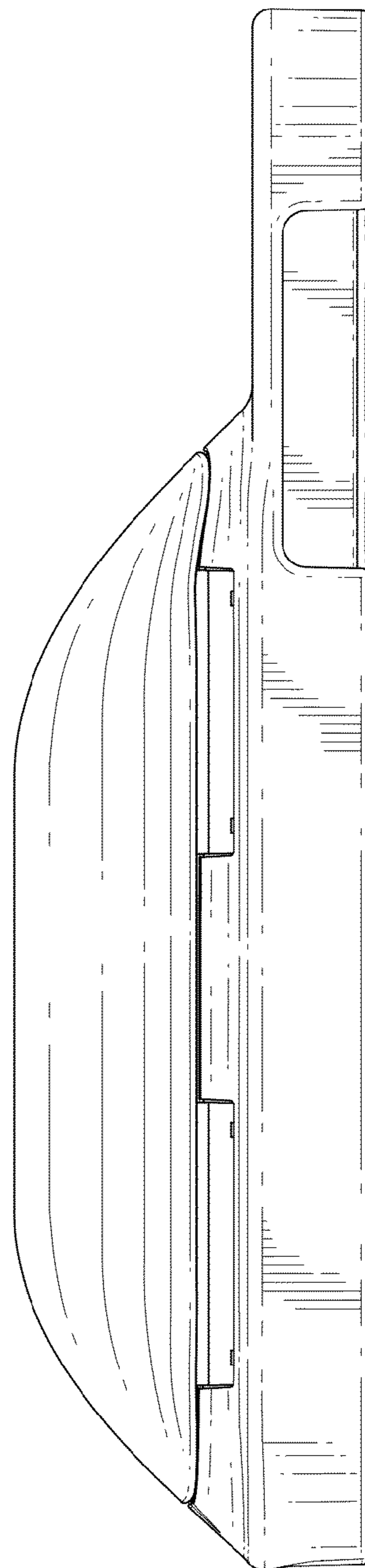

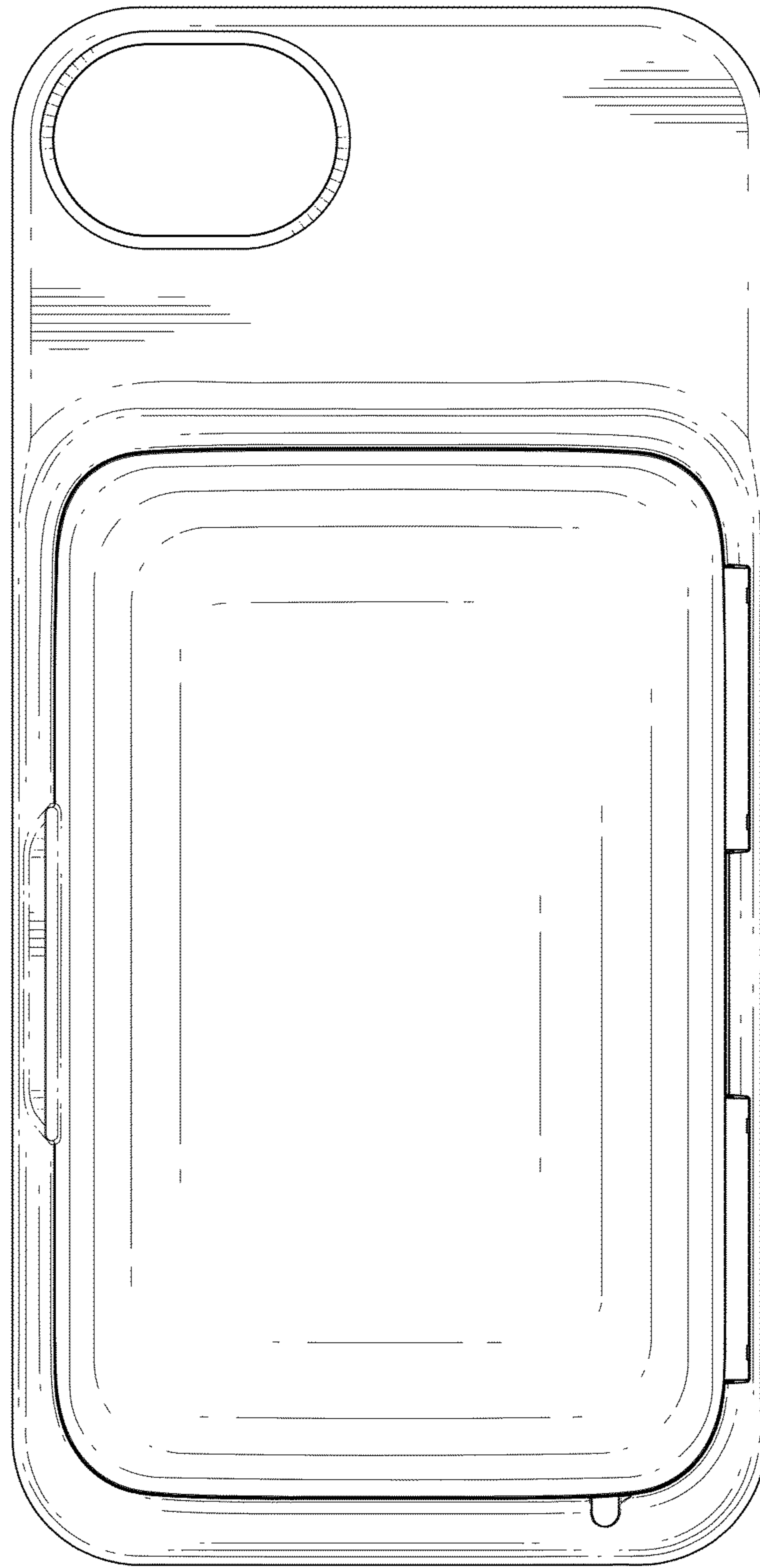

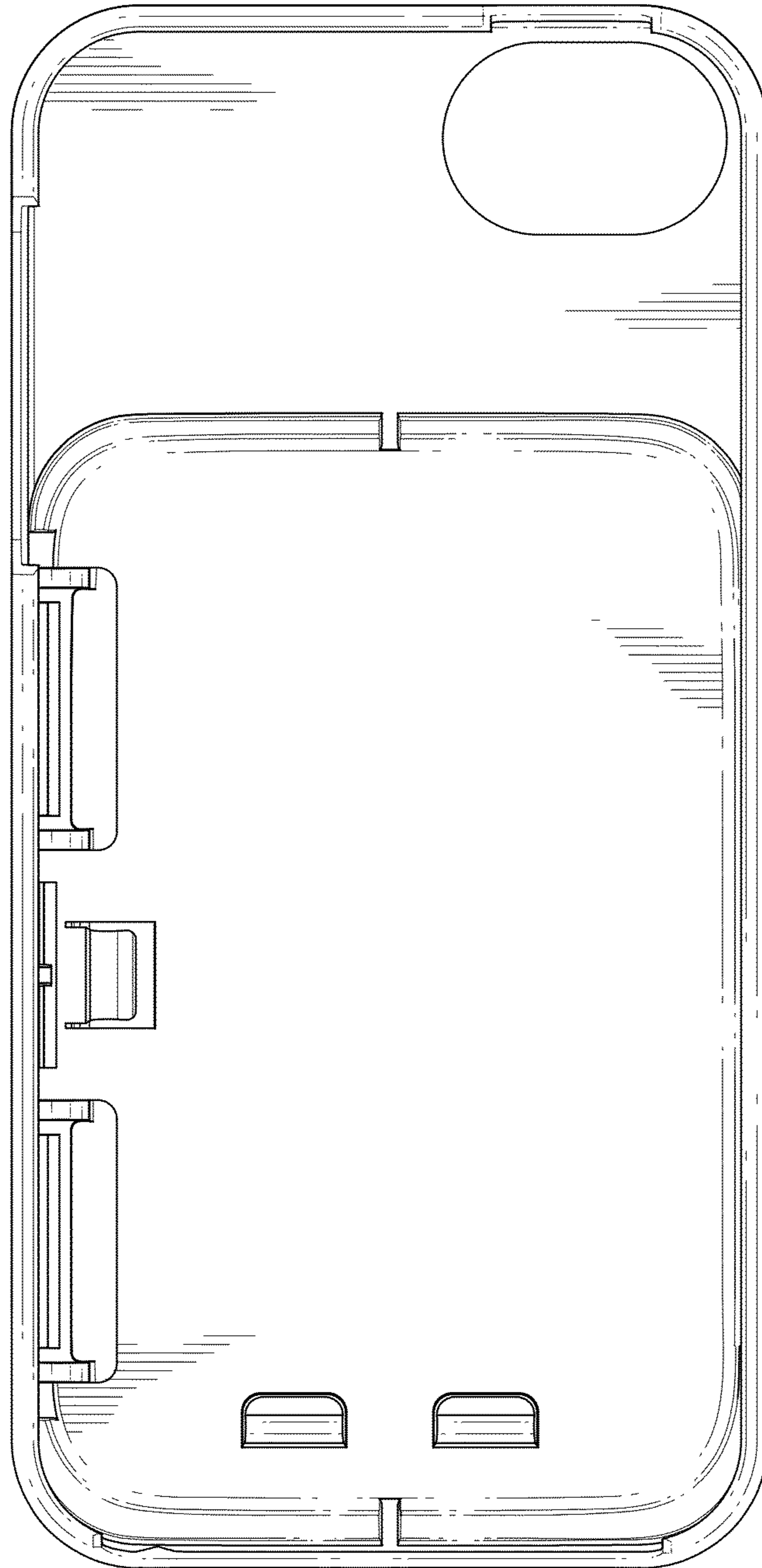

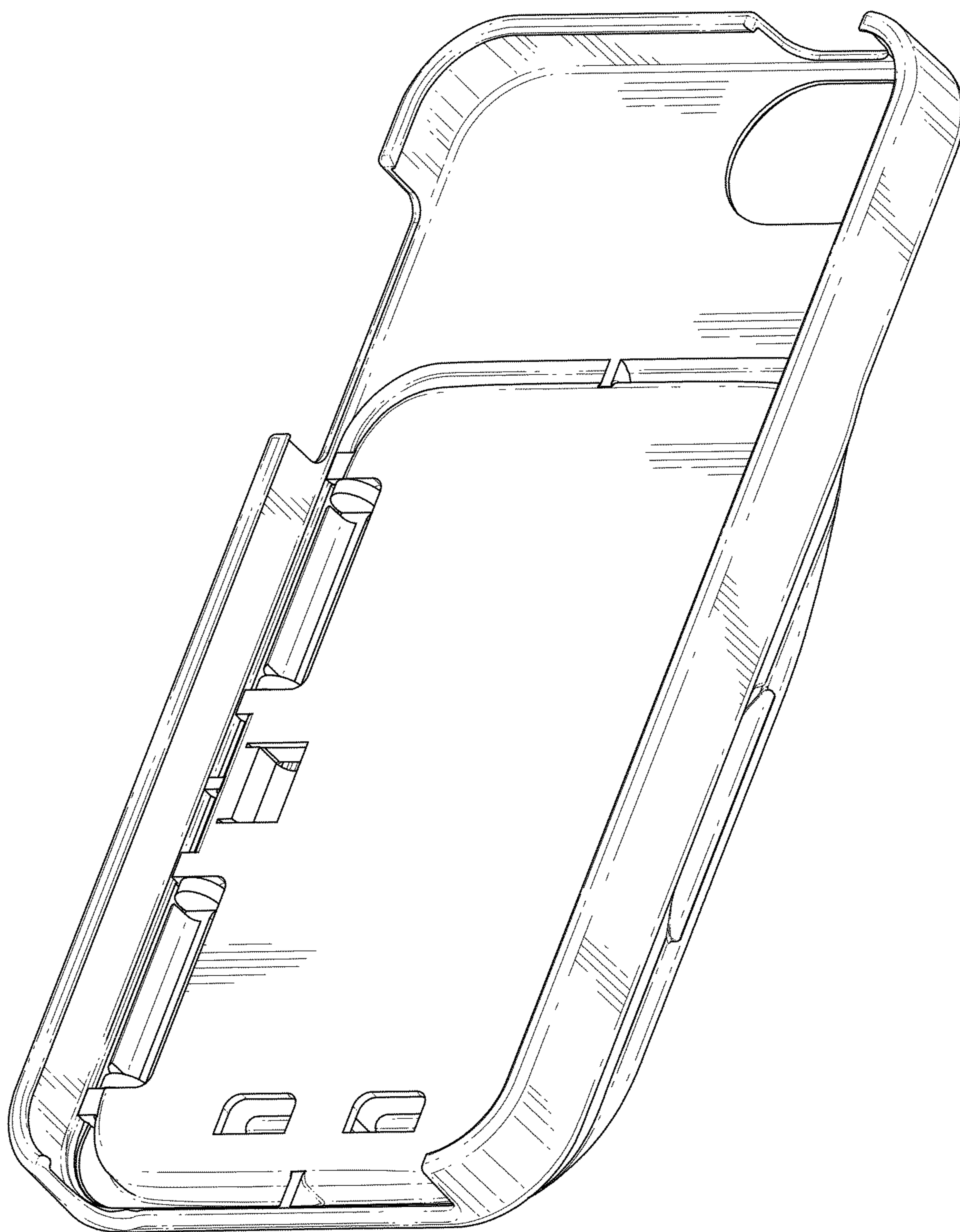
