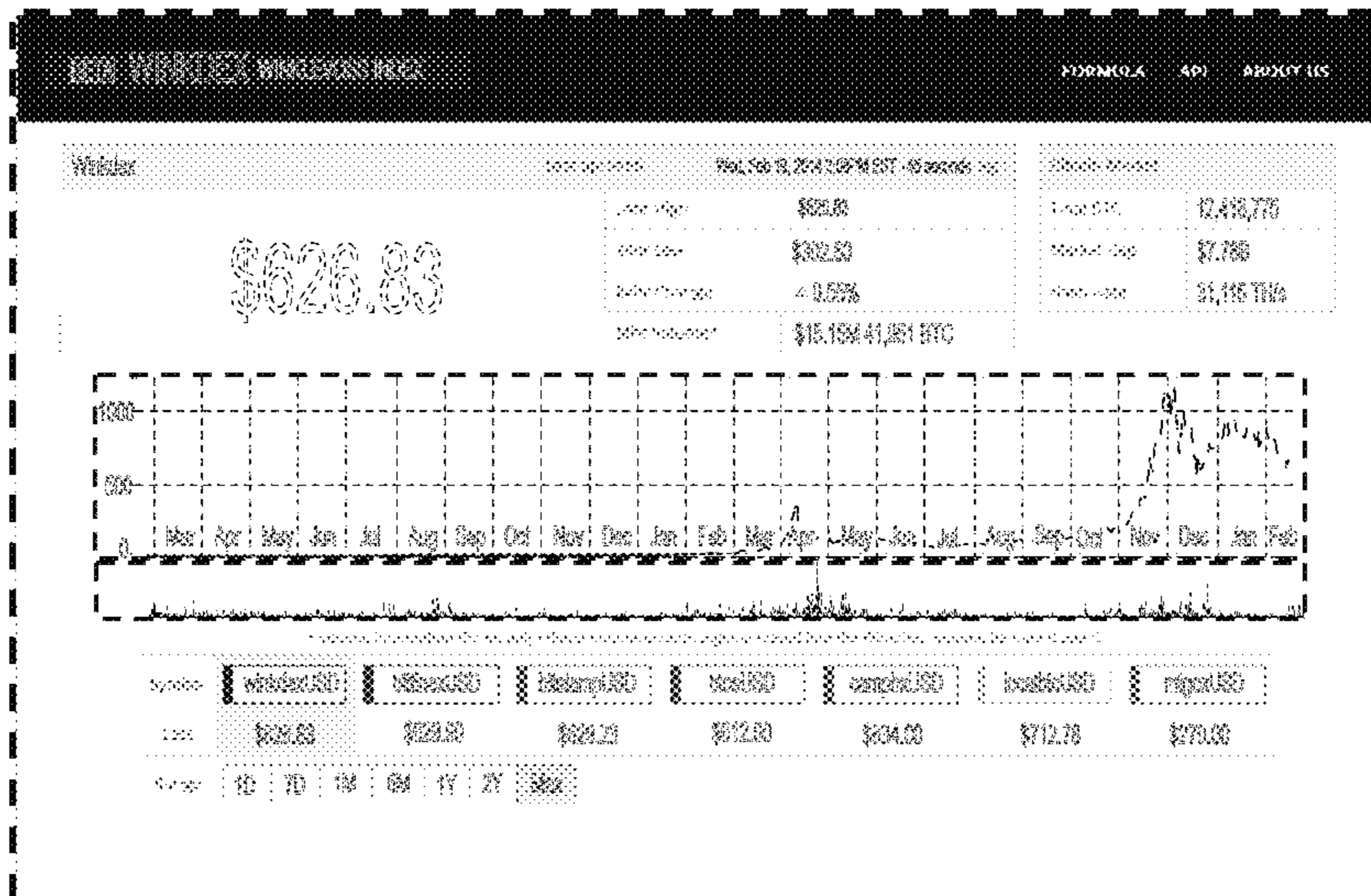
(57) **CLAIM**

The ornamental design for a display screen portion with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen portion with graphical user interface showing my new design; FIG. 2 is a front view of a second embodiment thereof; FIG. 3 is a front view of a third embodiment thereof; FIG. 4 is a front view of a fourth embodiment thereof; FIG. 5 is a front view of a fifth embodiment thereof; FIG. 6 is a front view of a sixth embodiment thereof; and, FIG. 7 is a front view of a seventh embodiment thereof. The outermost broken line illustrates the border of the display screen and forms no part of the claimed design. The remaining broken lines shown within the Graphical User Interface, including heavy, medium and light weight broken lines, black broken lines and white broken lines, and the broken line showing of graphs illustrate portions of the Graphical User Interface and form no part of the claimed design.

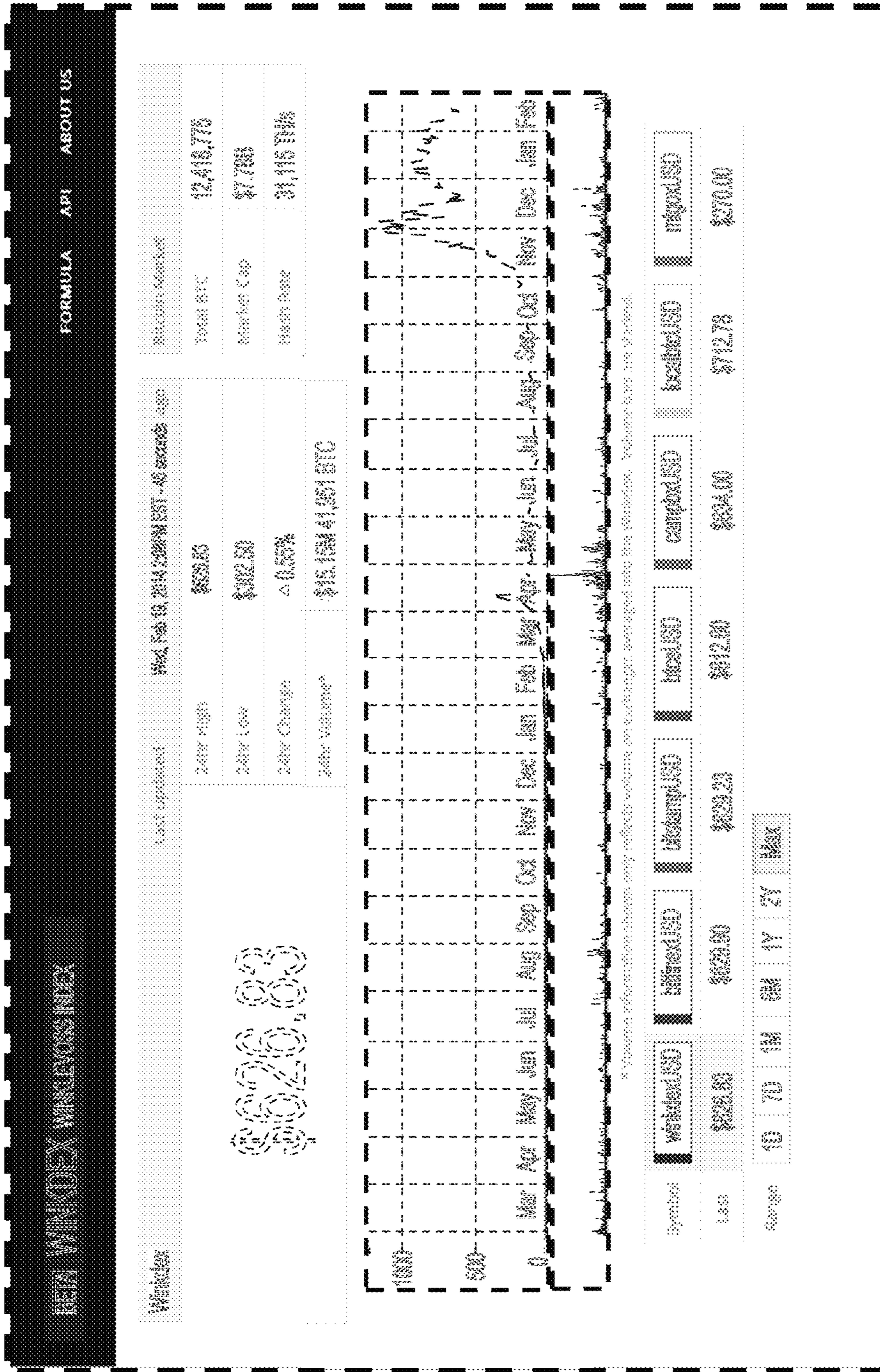

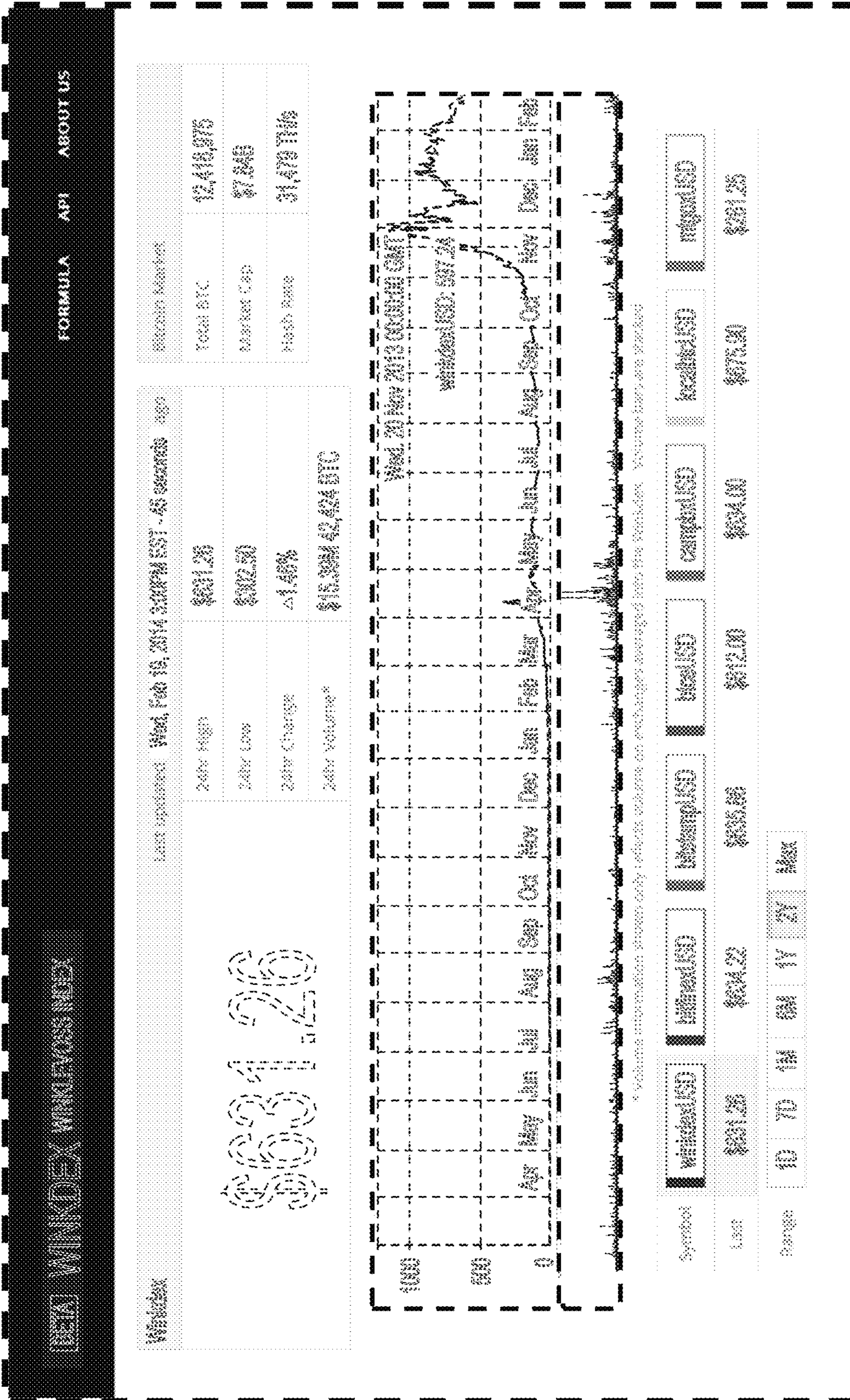

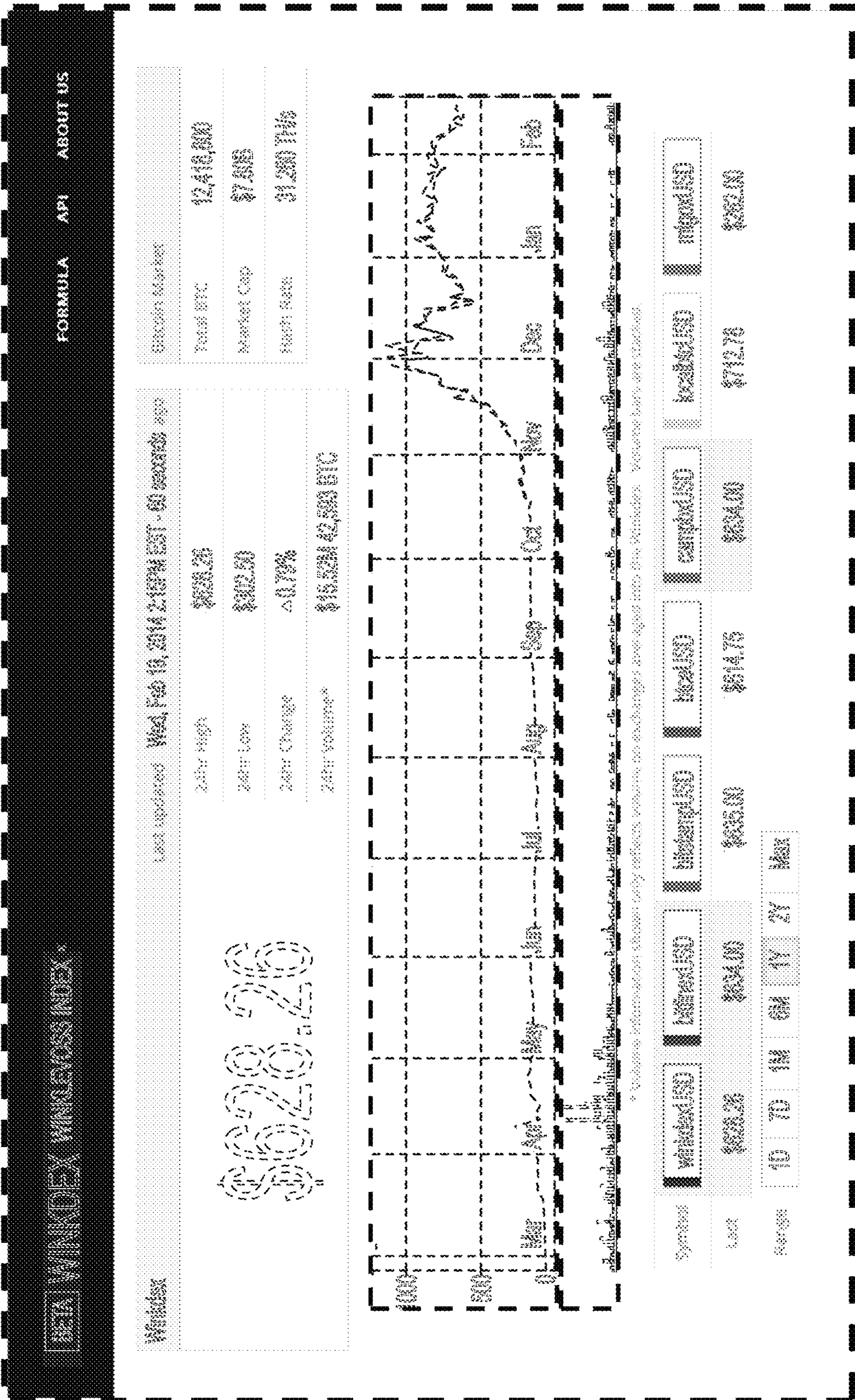

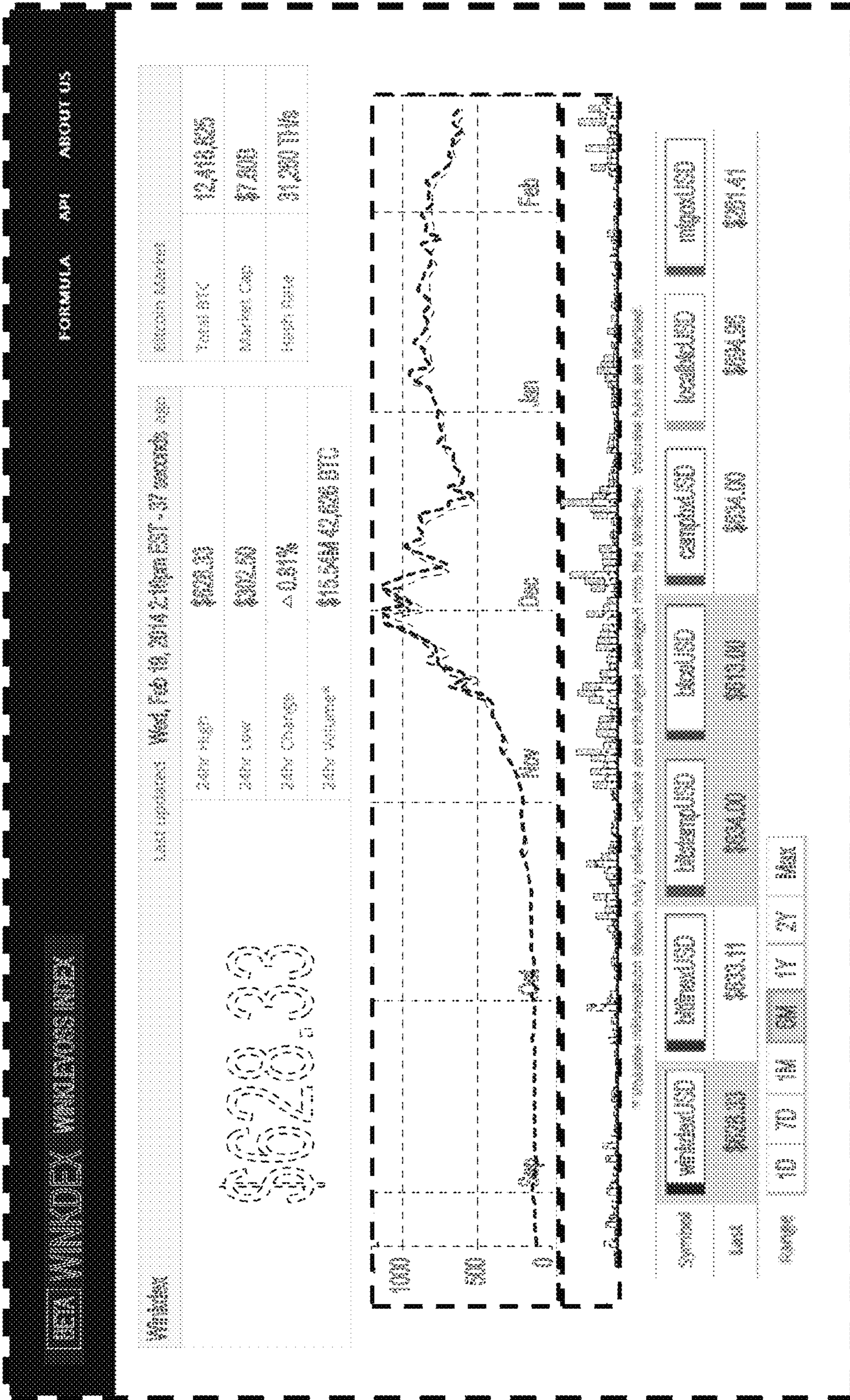

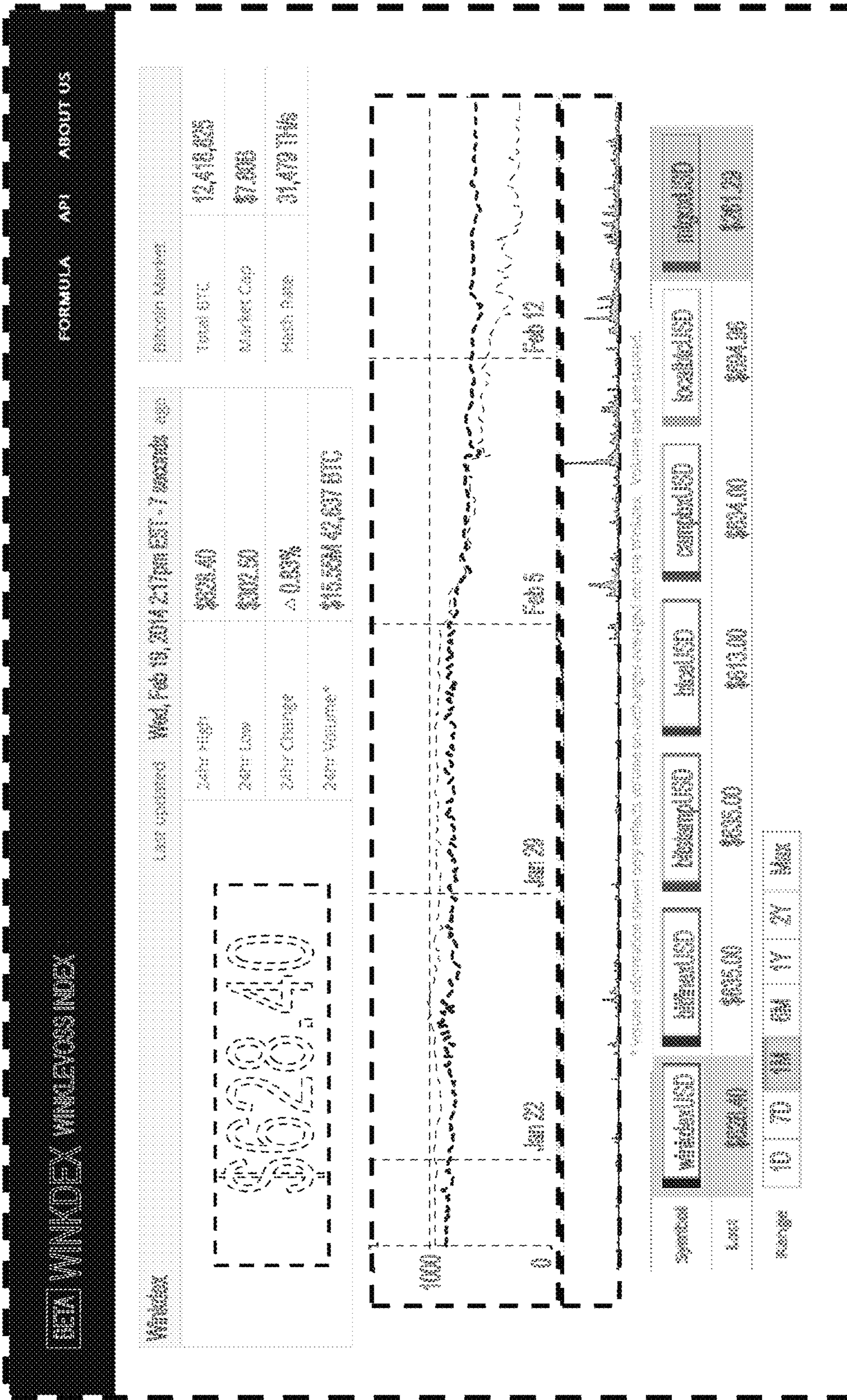

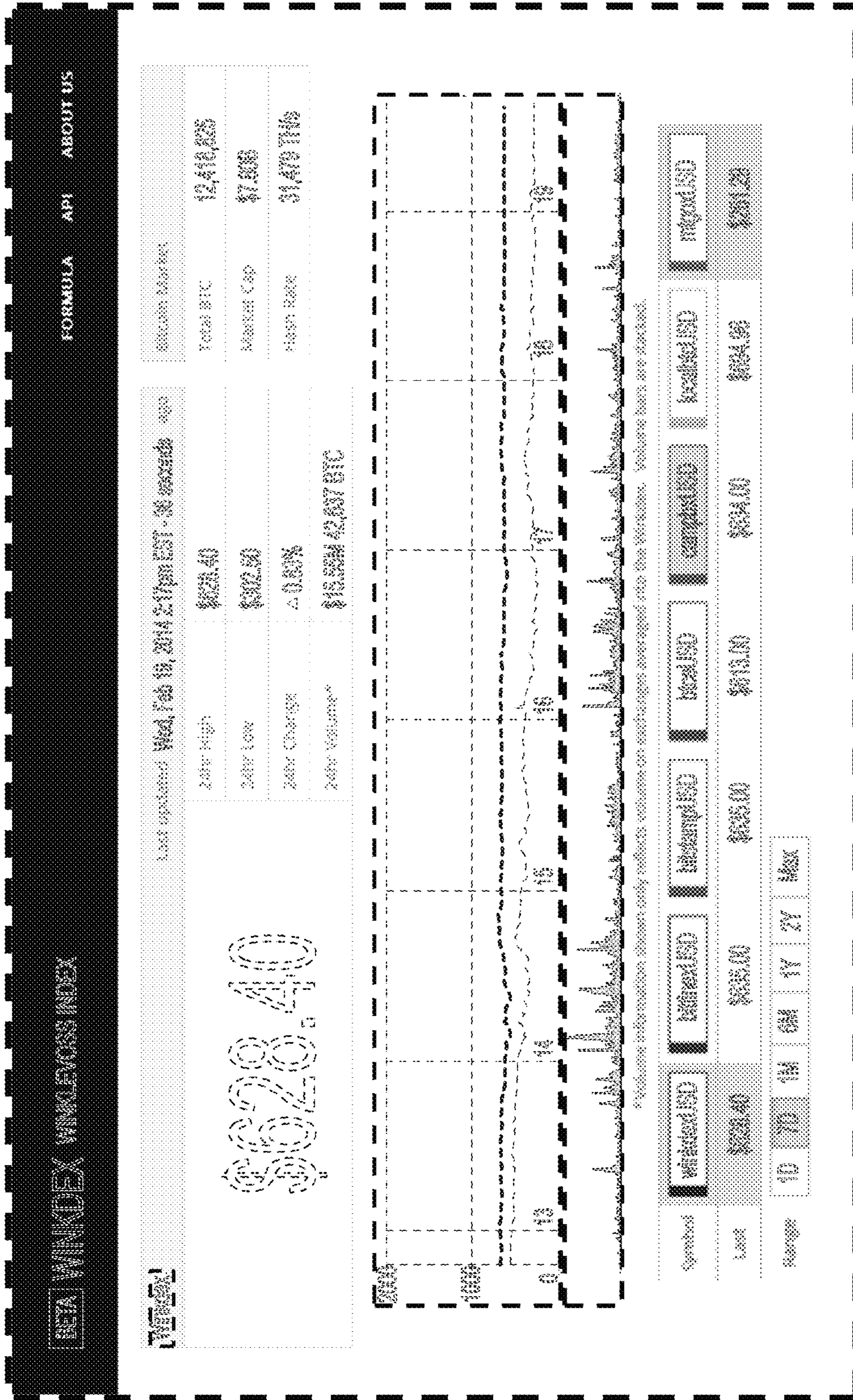

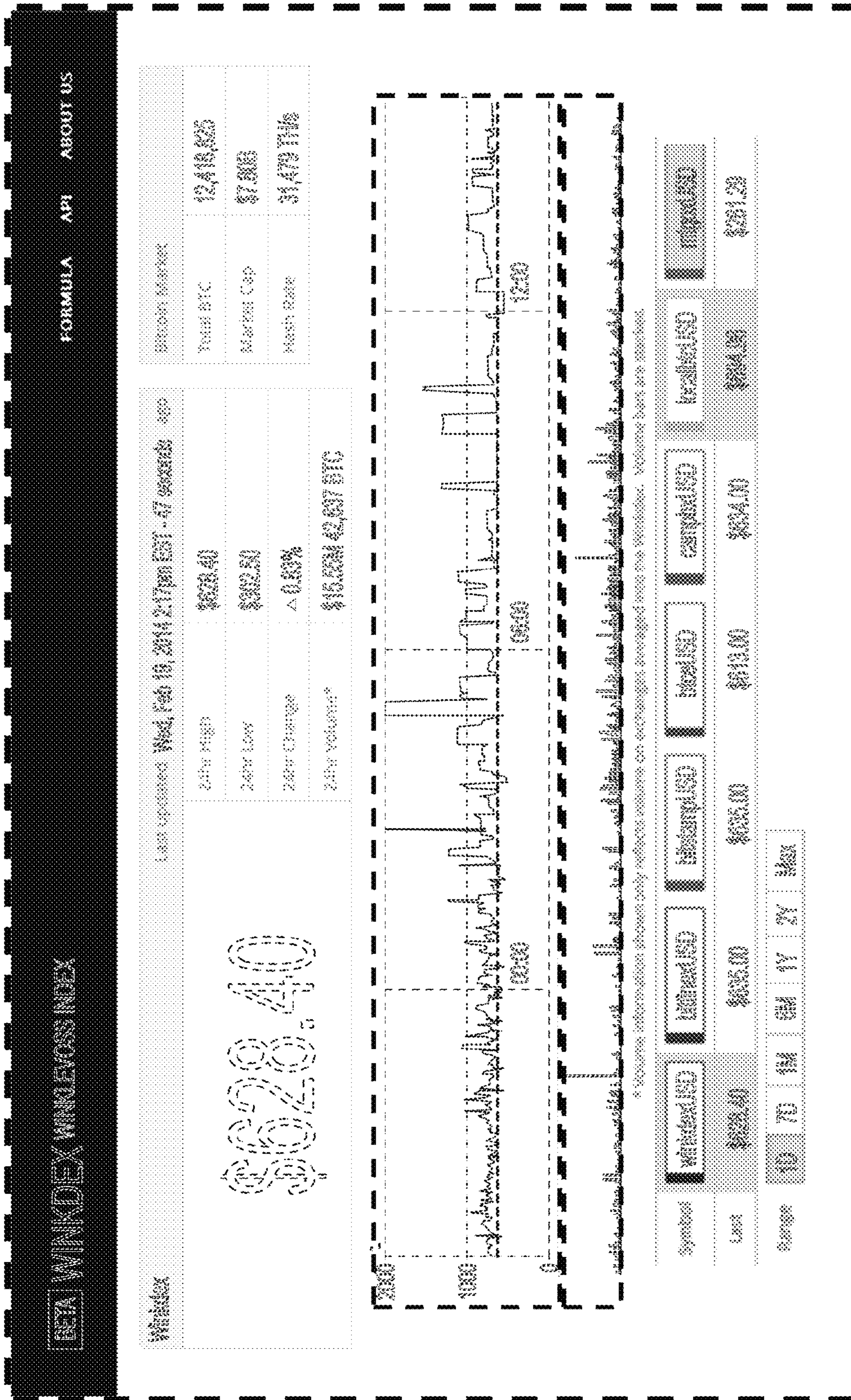
