(57) **CLAIM**

The ornamental design for a portable electronic terminal with graphical user interface, as shown and described.

DESCRIPTION

The FIGURE is a front view of a portable electronic terminal with graphical user interface showing the new design. The oblique line shading indicates a transparent panel through which the graphical user interface is seen and forms part of the claimed design. The broken lines shown in the drawings represent portions of the portable electronic terminal with graphical user interface that form no part of the claimed design.
