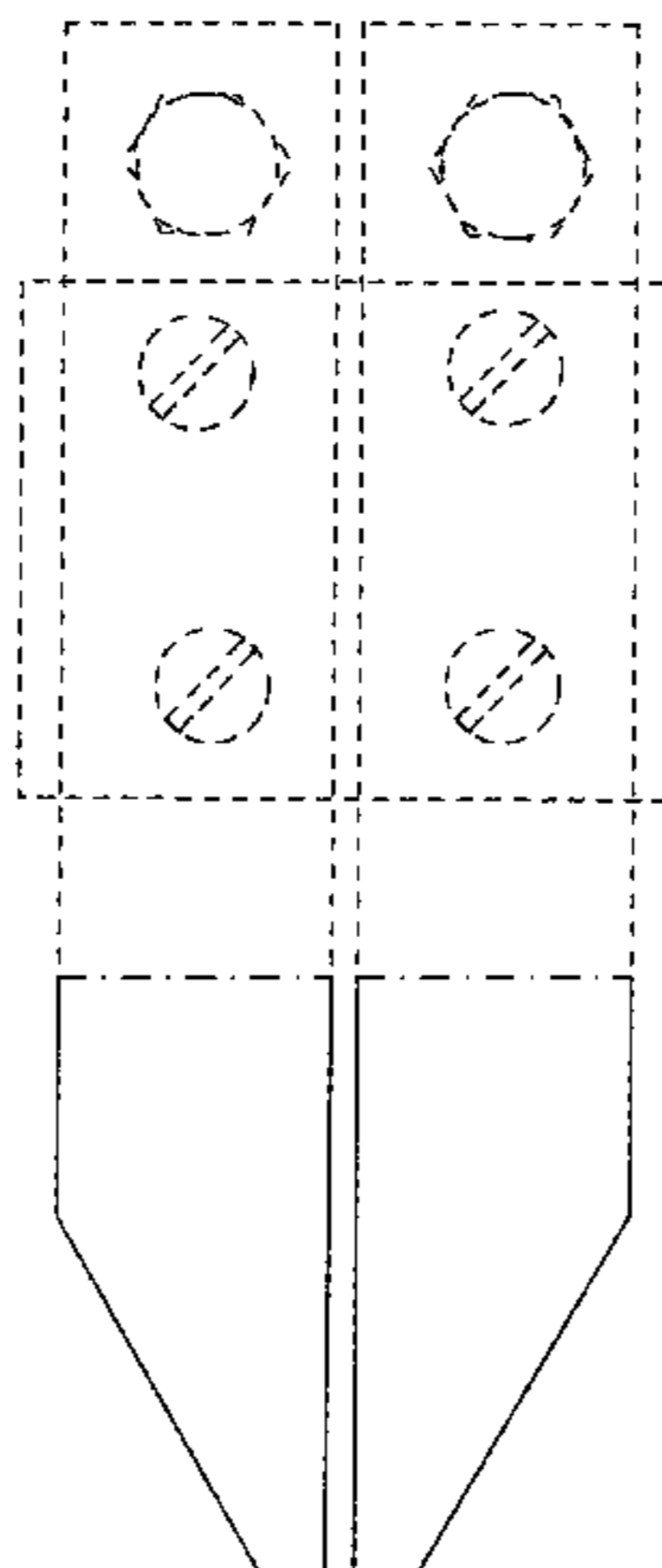

DESCRIPTION

FIG. 1 is a top plan view of a first embodiment of electrodes for resistance welding;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a bottom plan view thereof; and,
FIG. 4 is a right side elevation view thereof thereof.

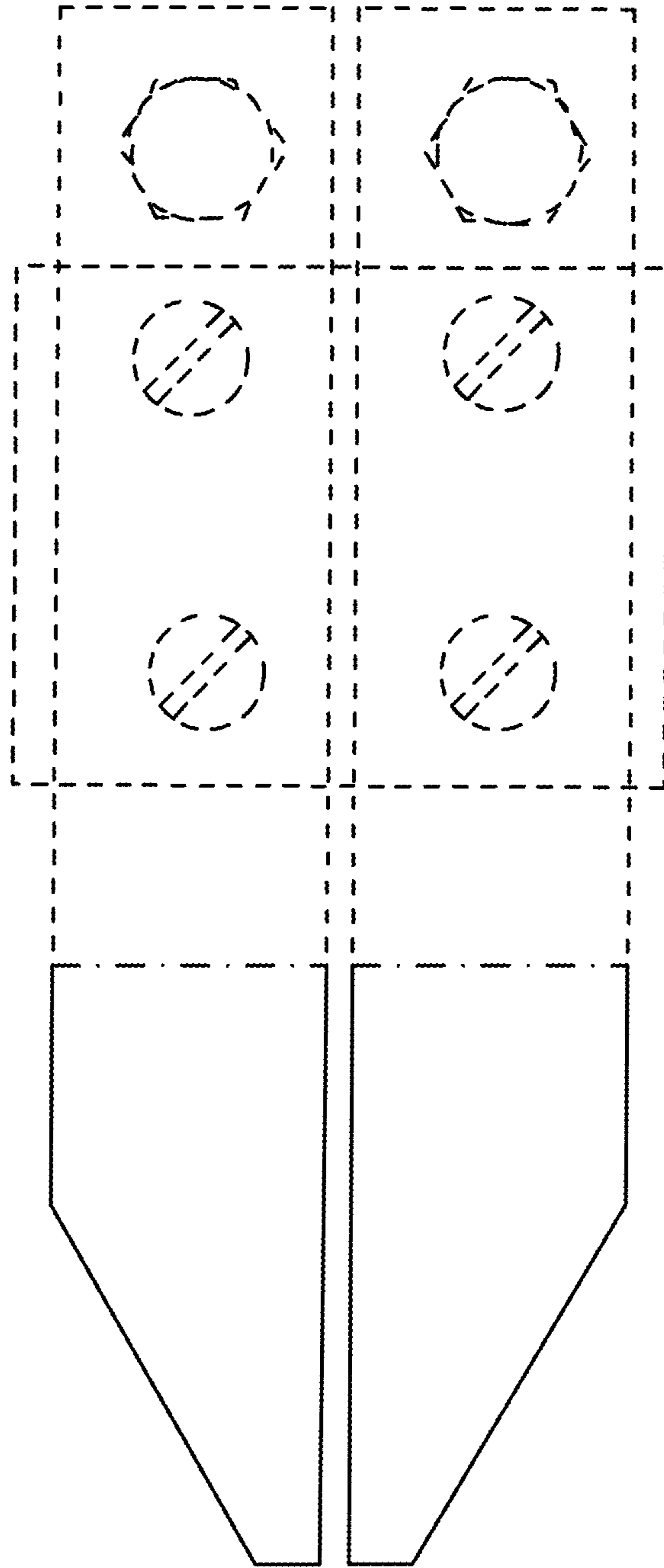

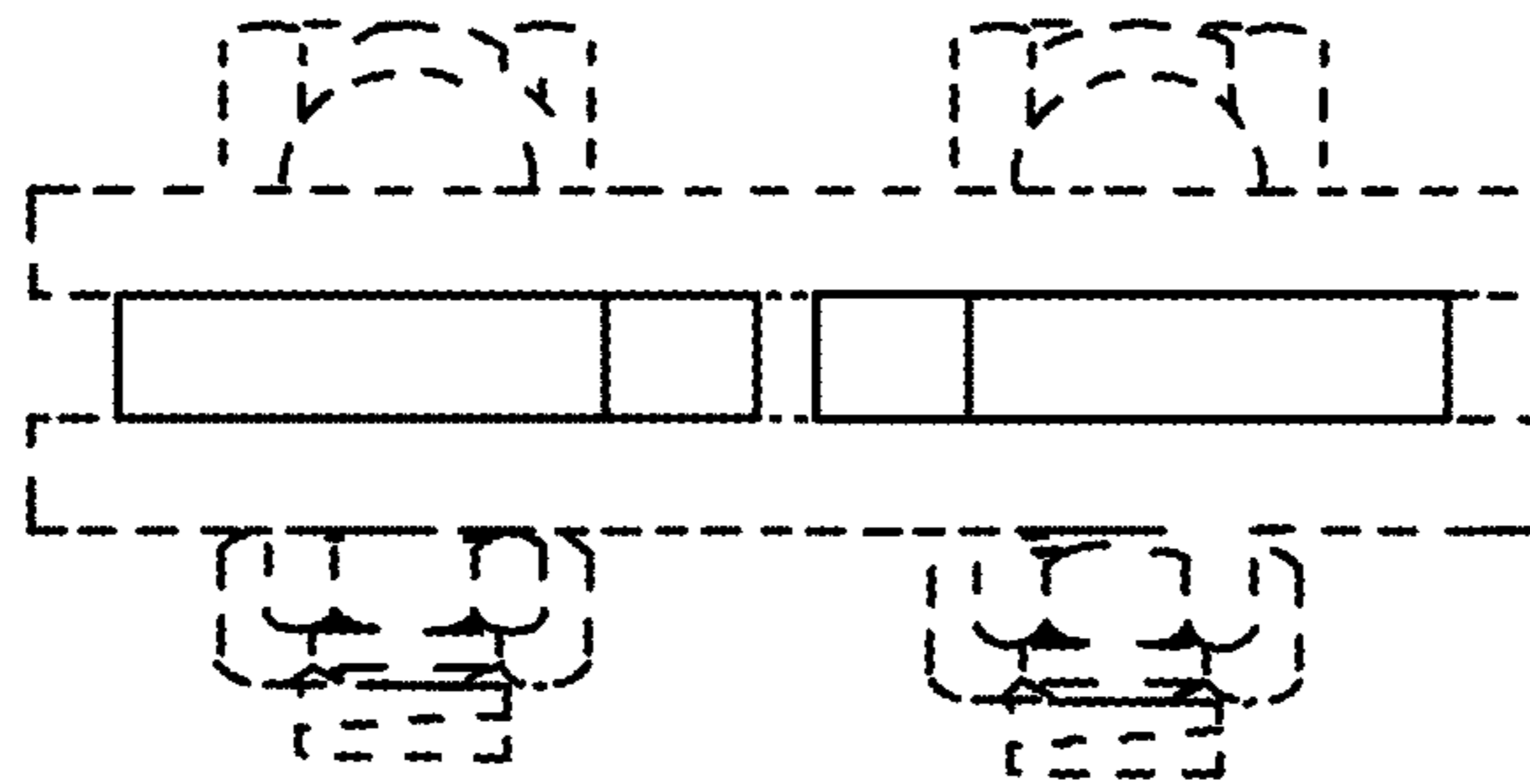

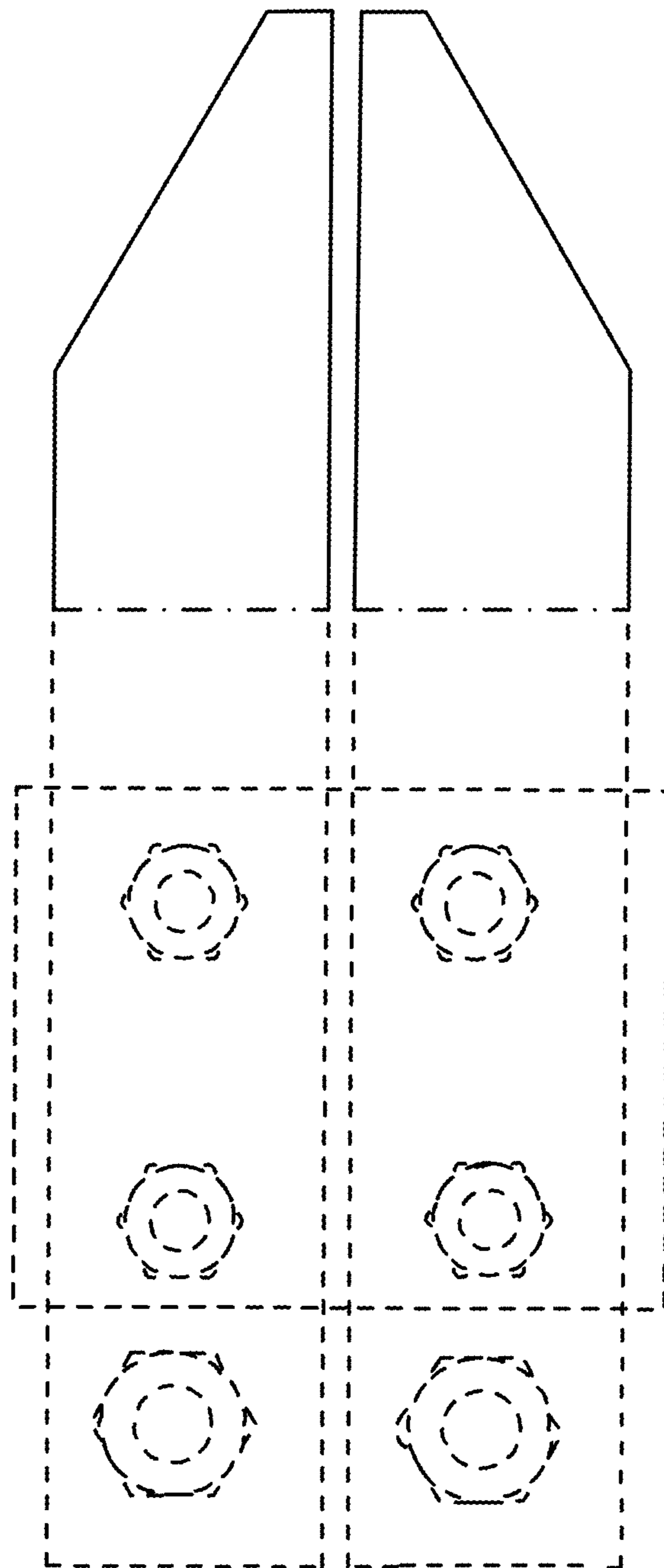
