CLAIM

The ornamental design for a file folder, as shown and described.

DESCRIPTION

The broken lines in the drawings are included for the purpose of showing portions of the file folder that form no part of the claimed design.

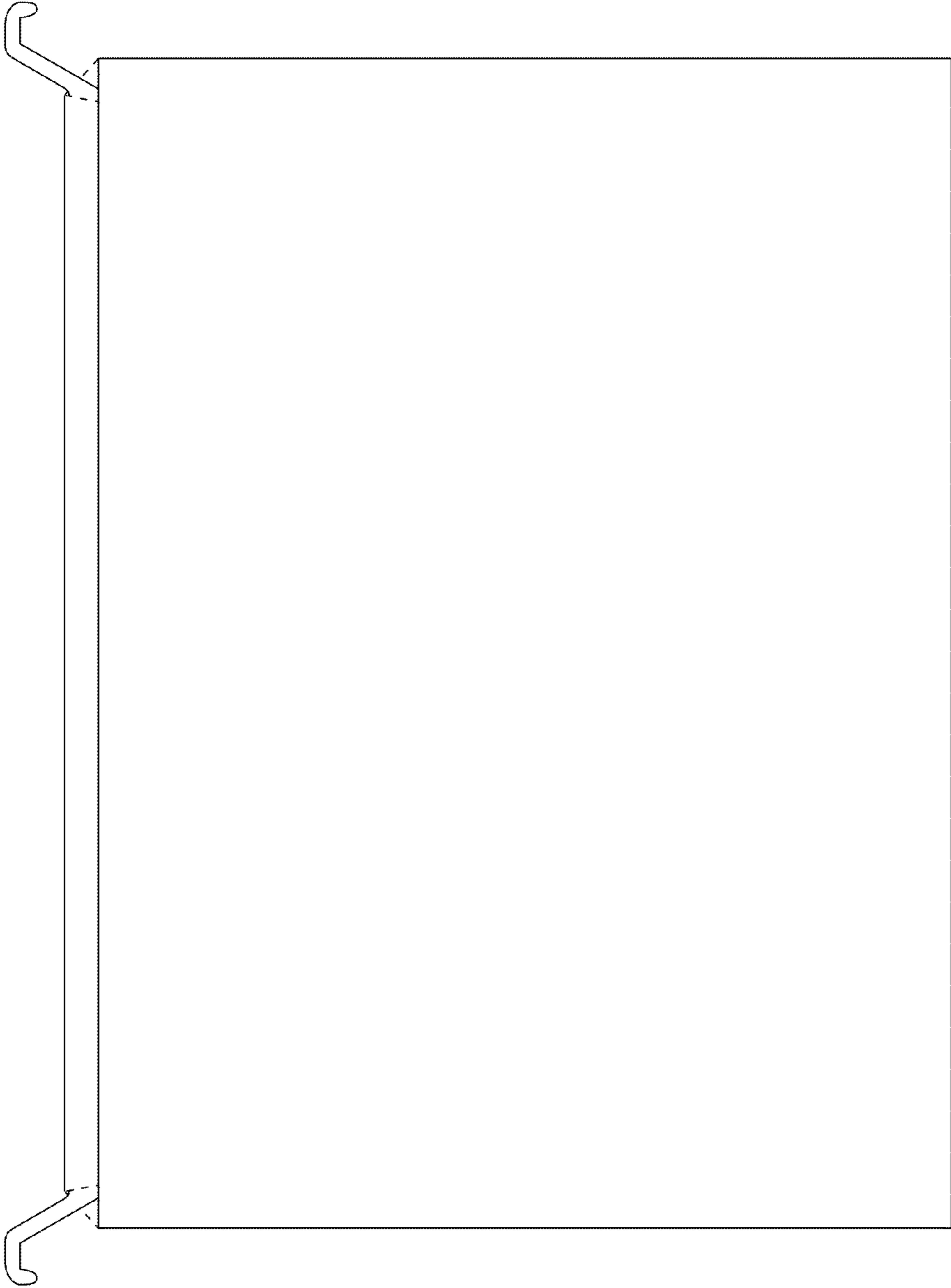

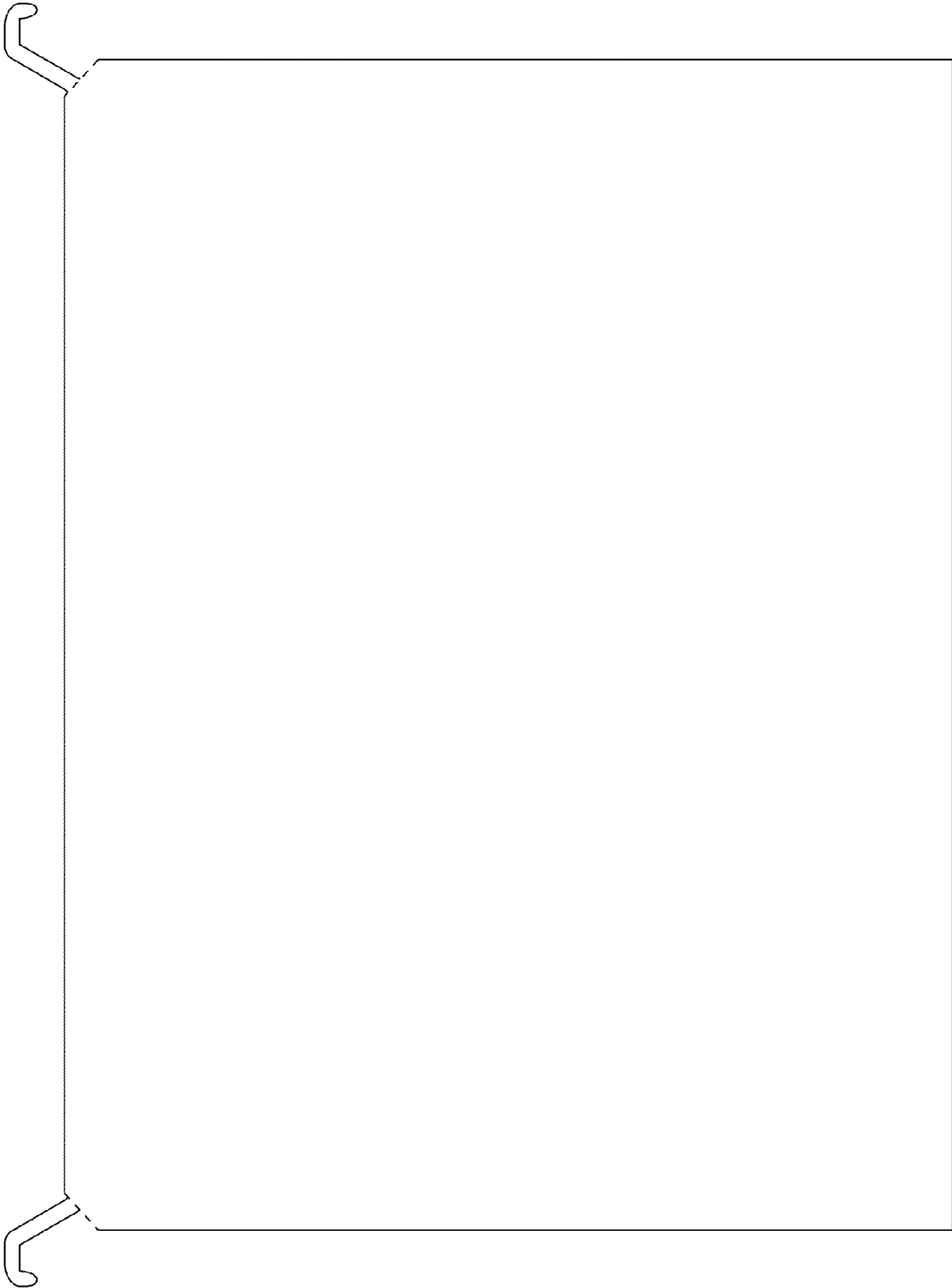

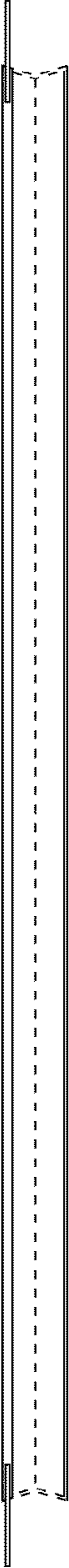

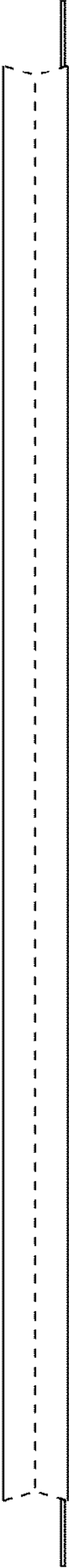

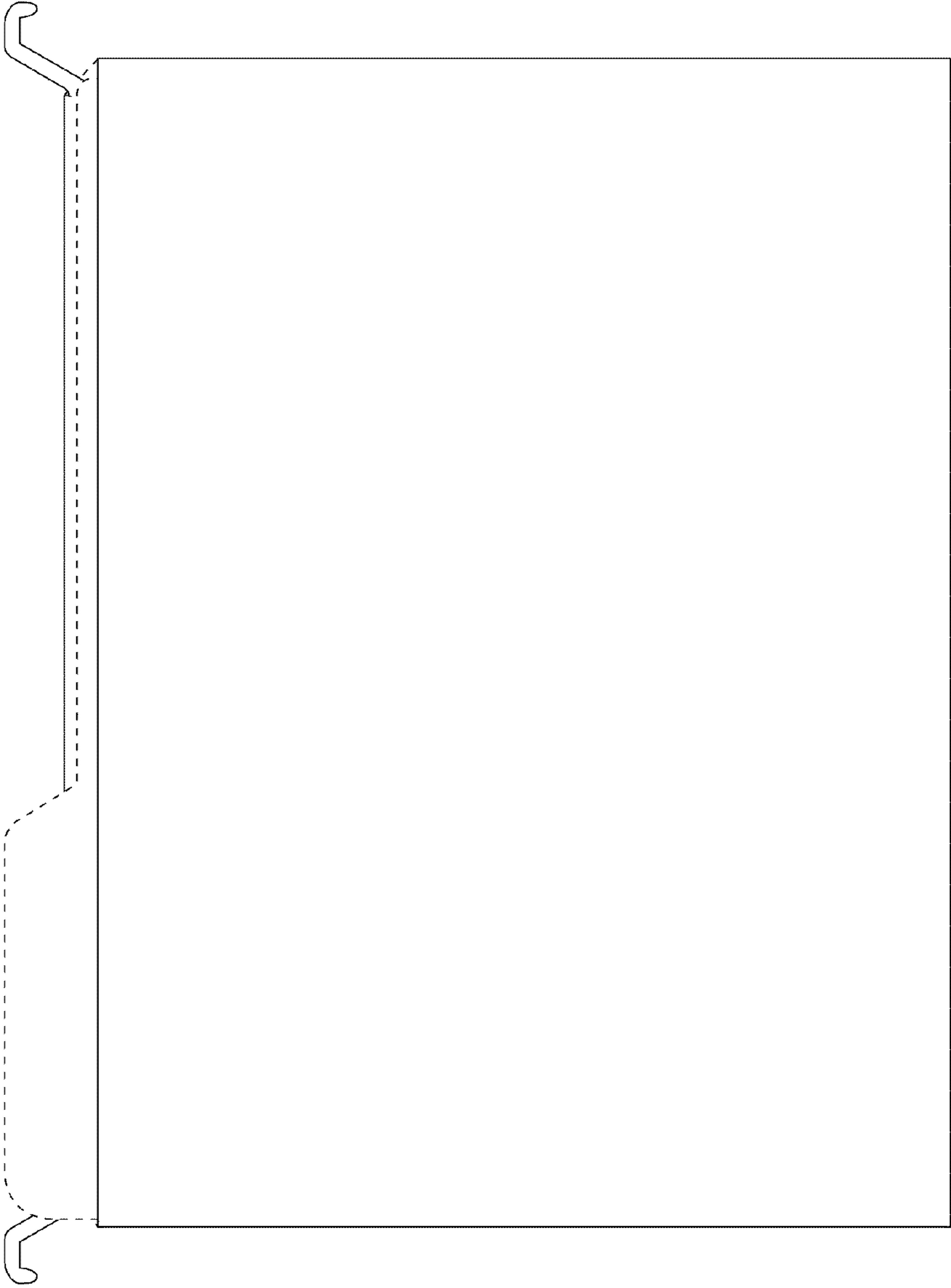

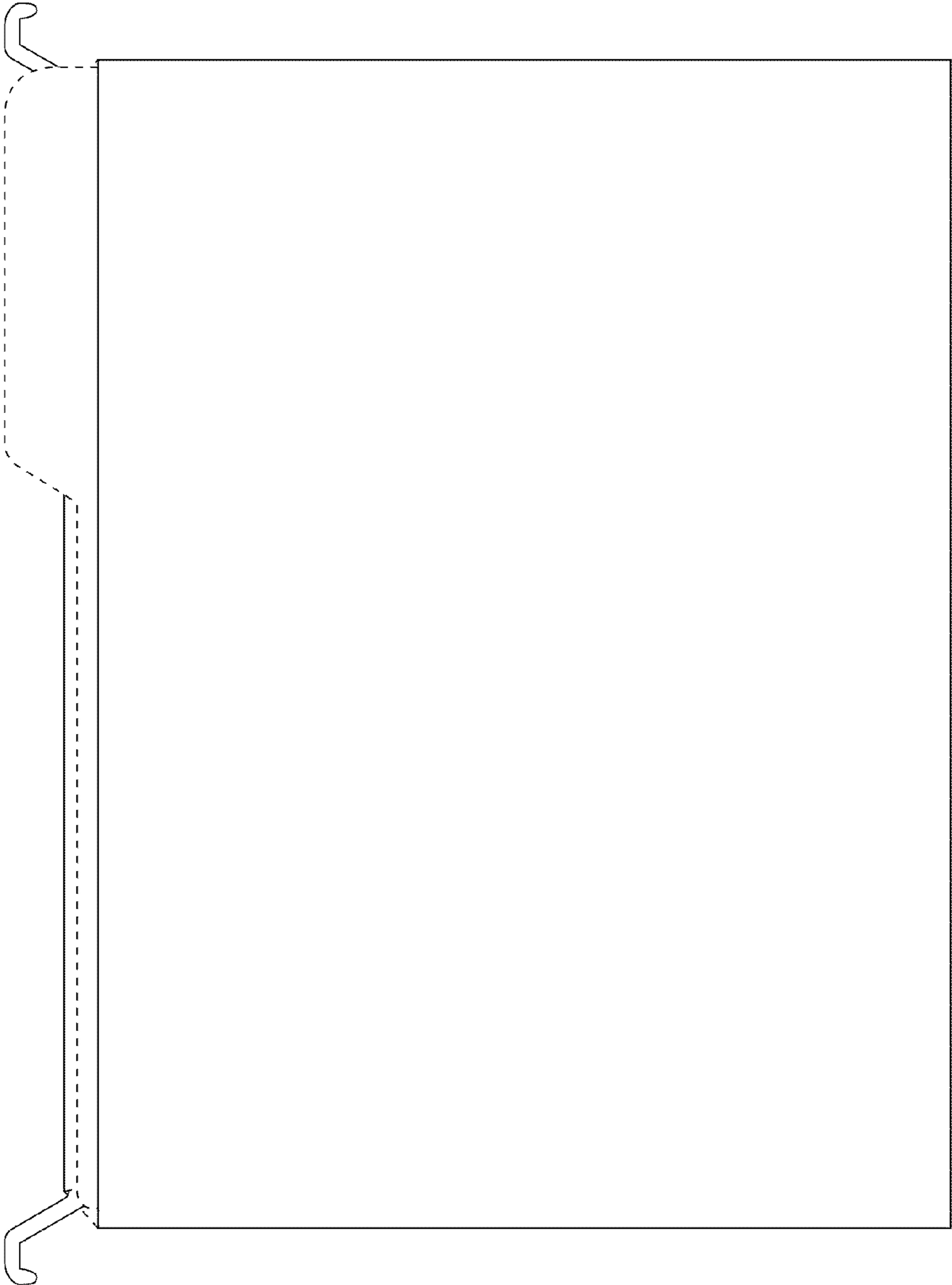

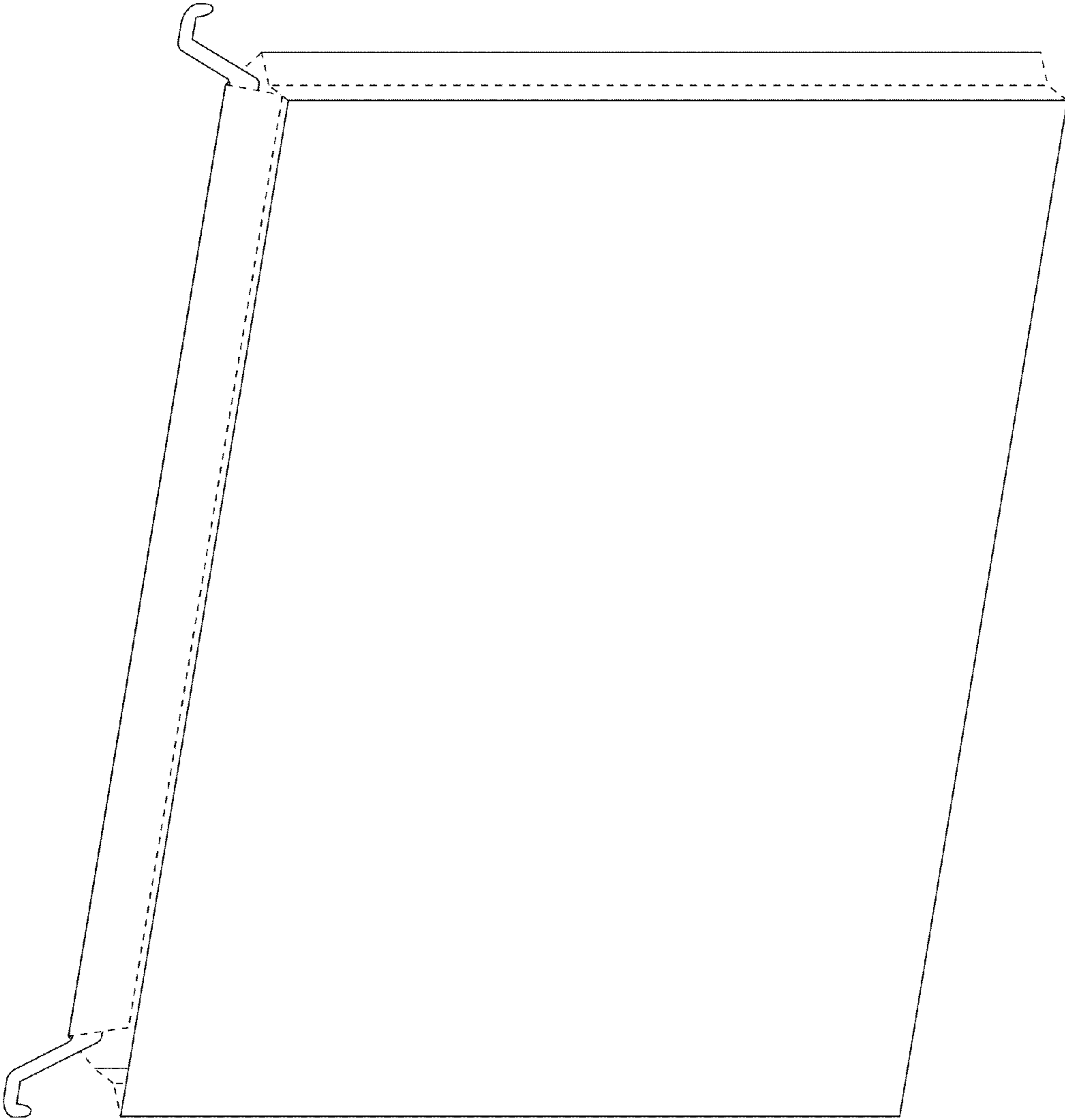

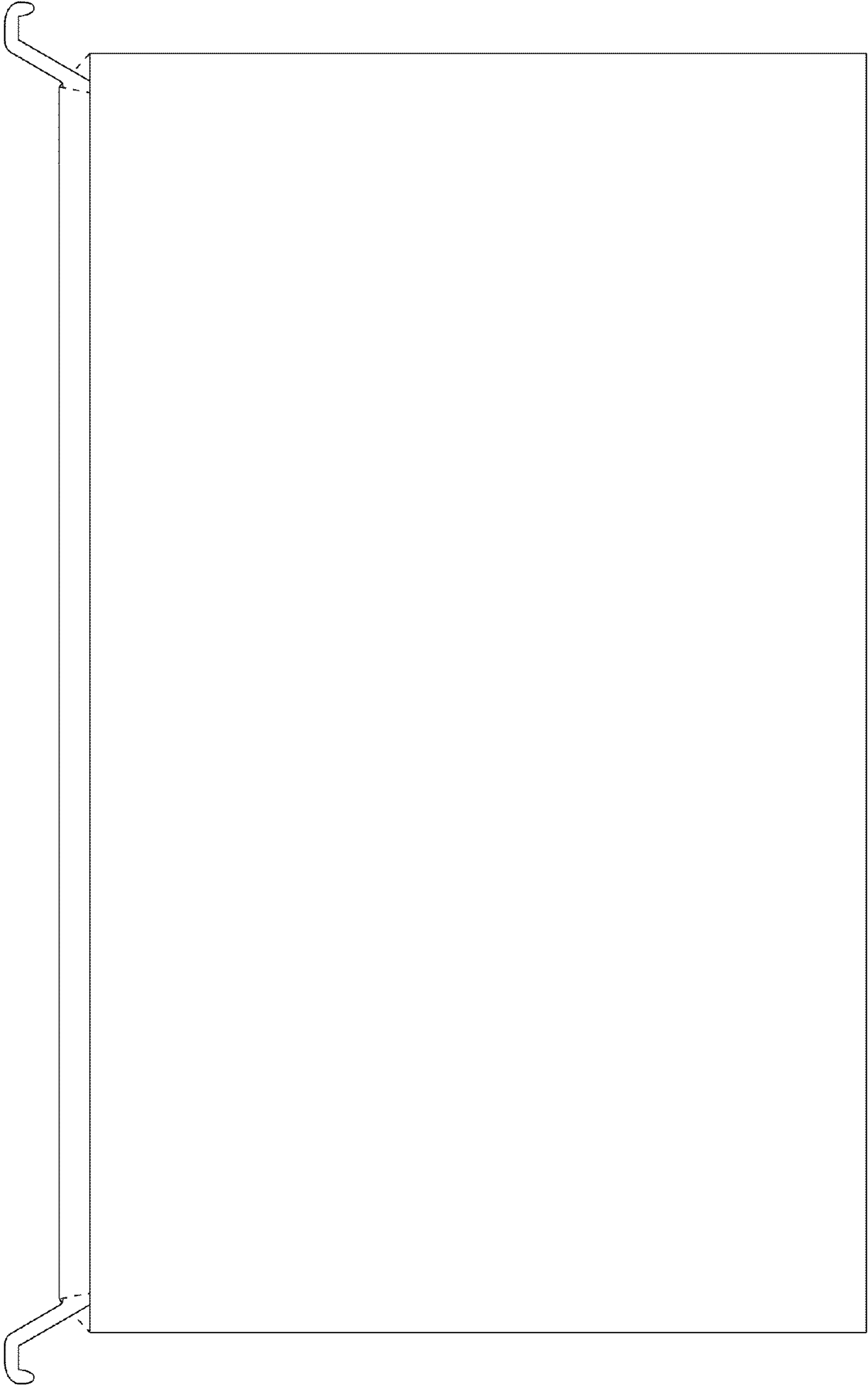

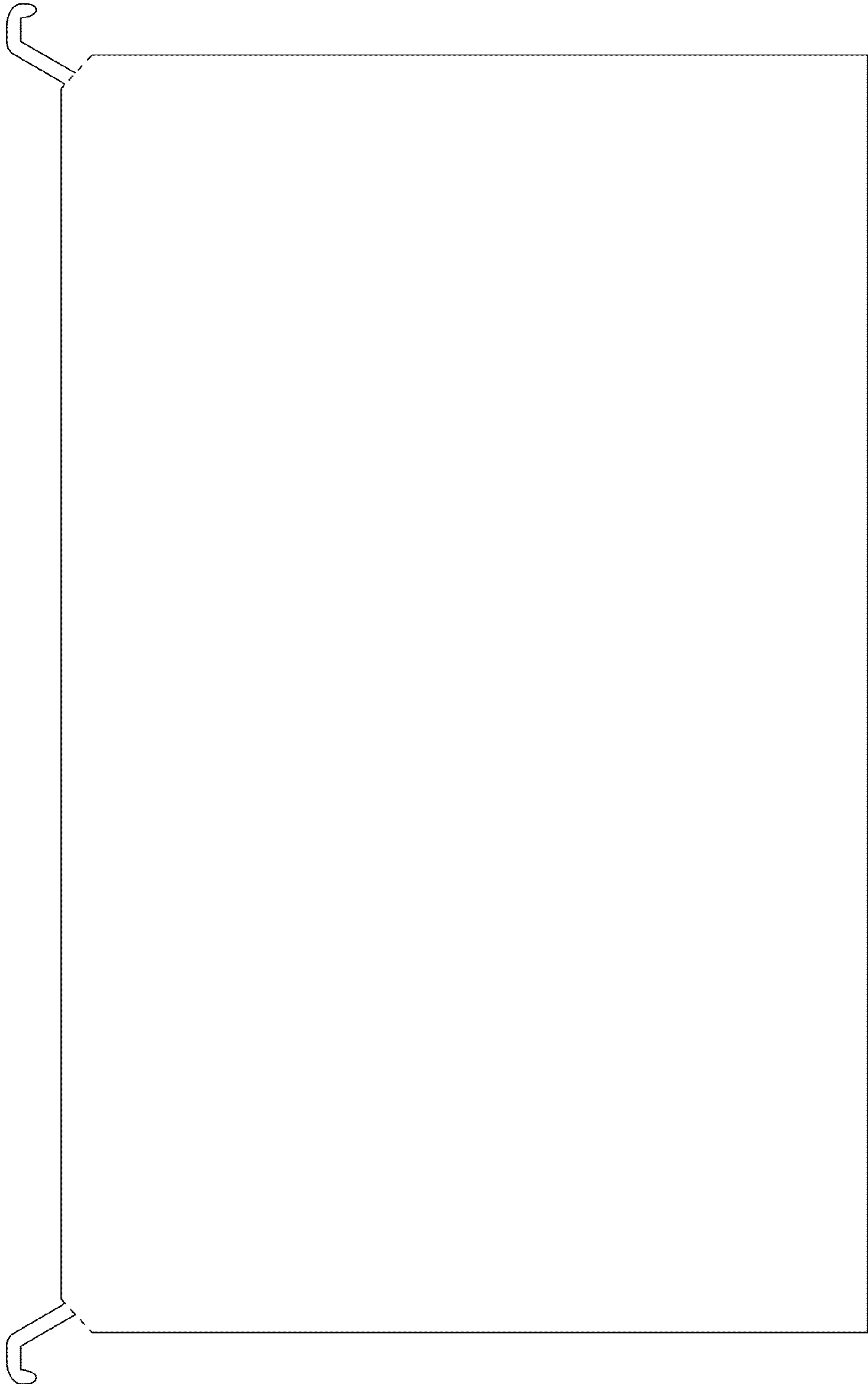

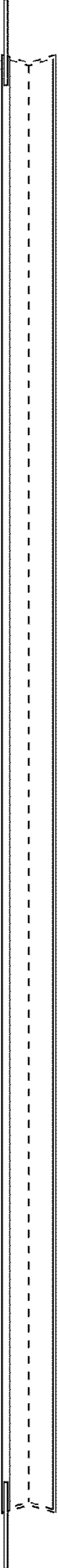

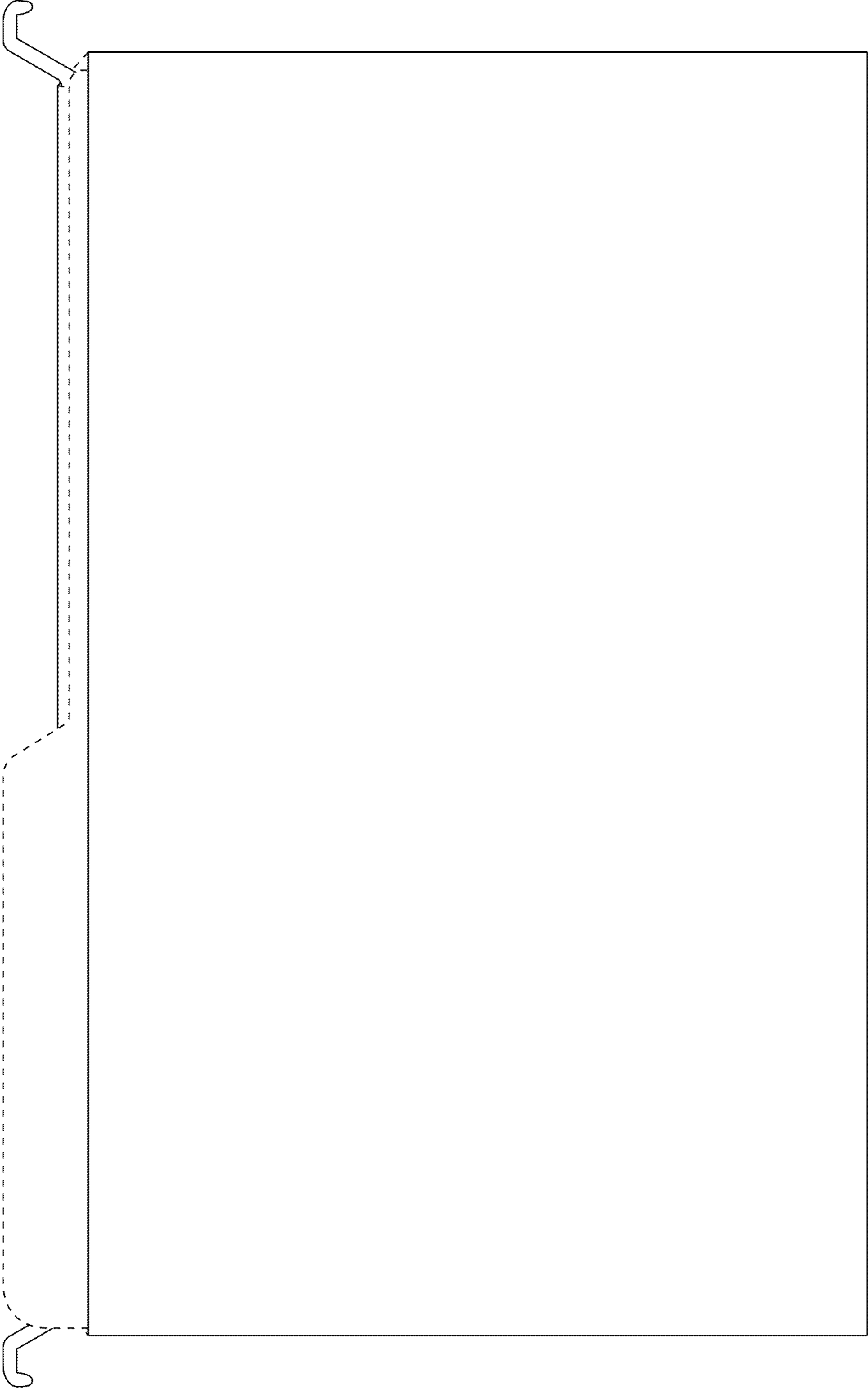

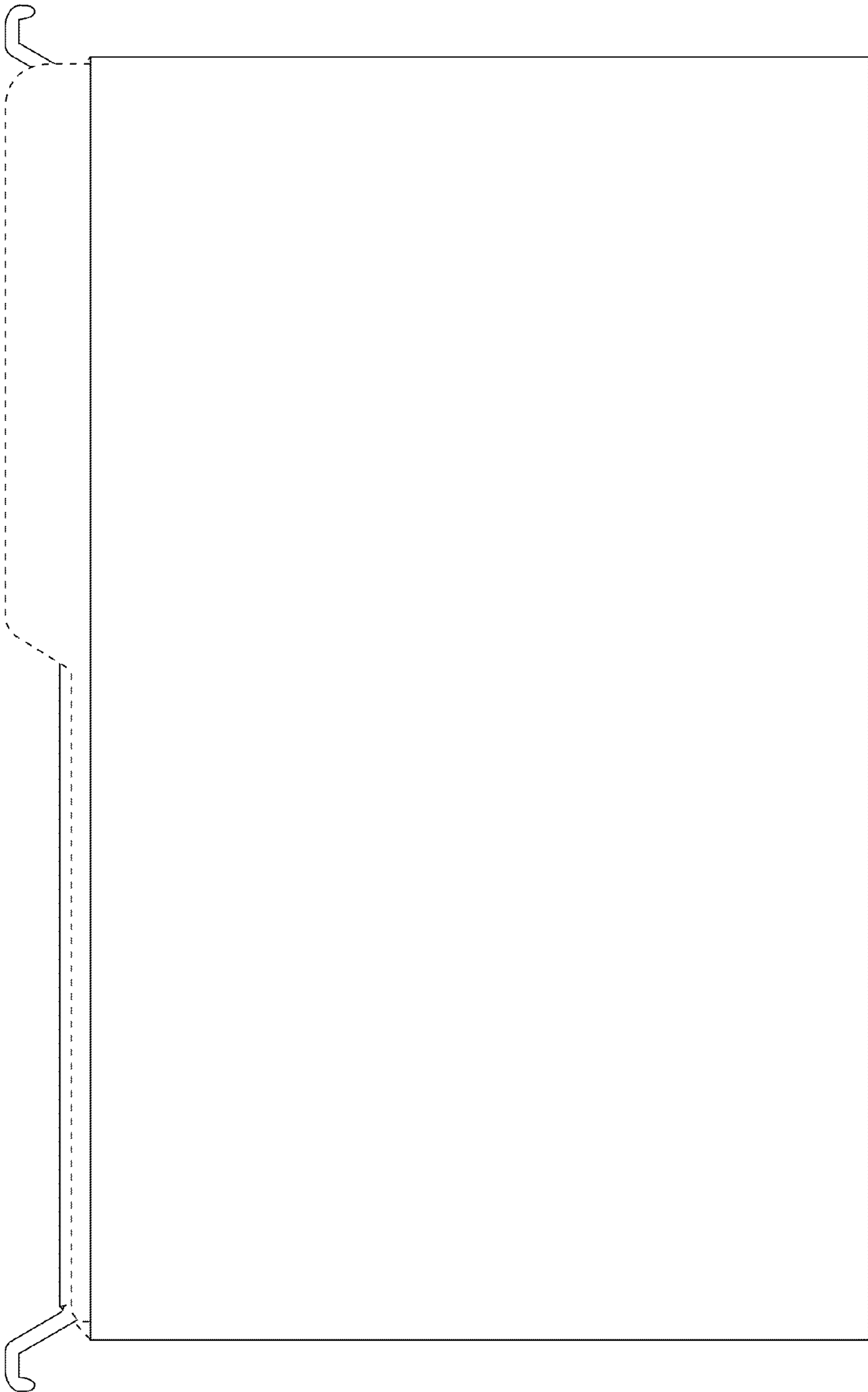

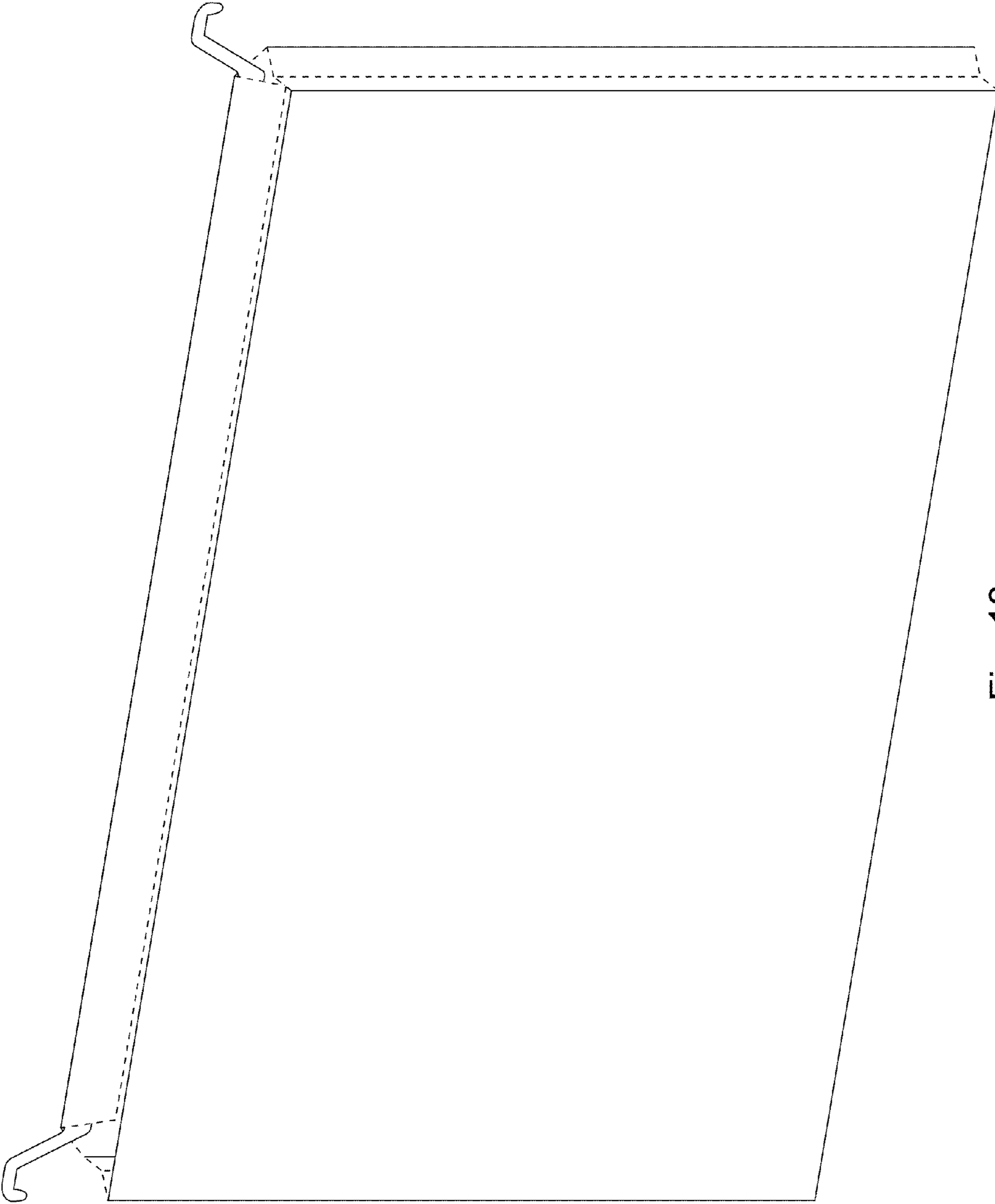

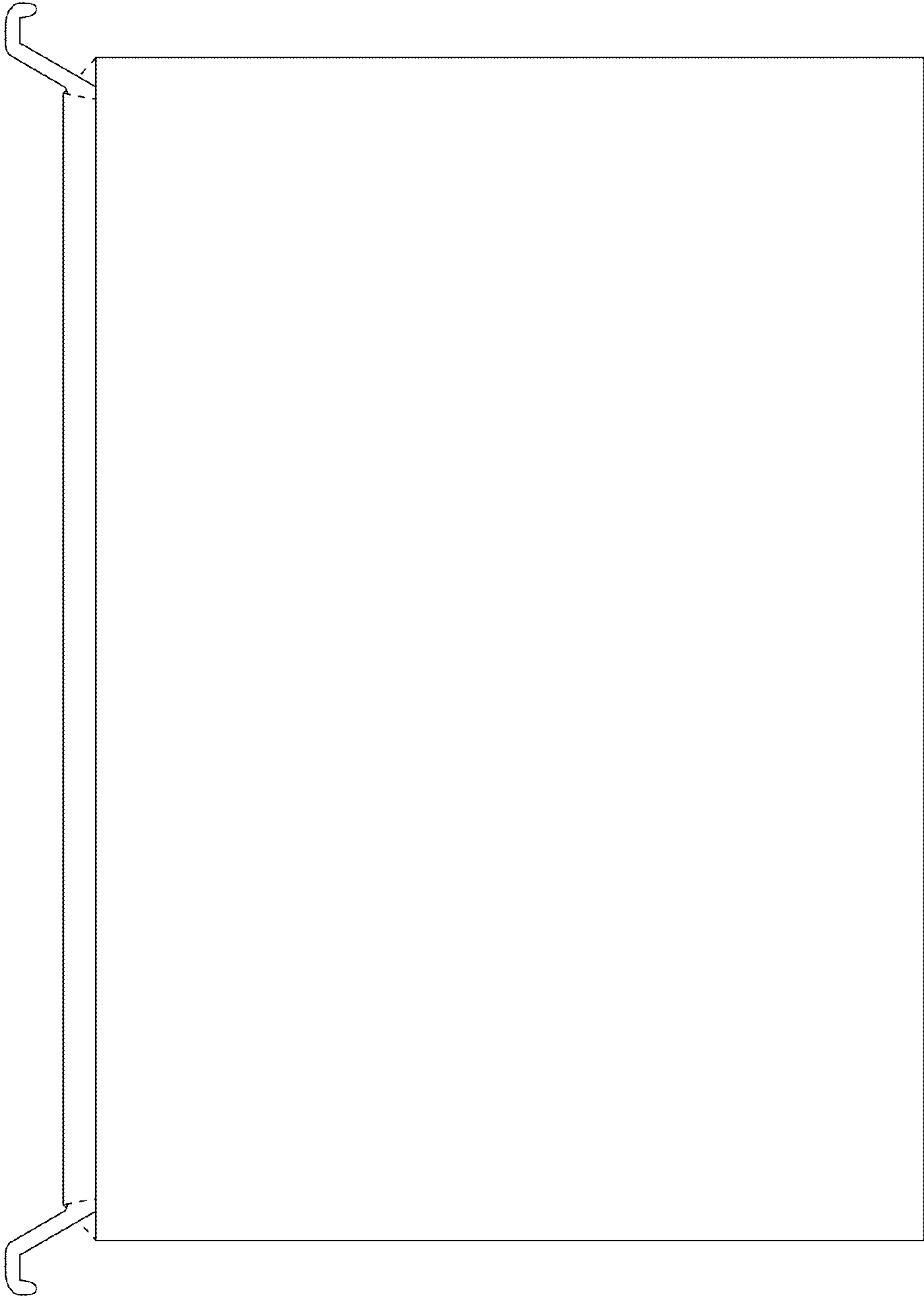

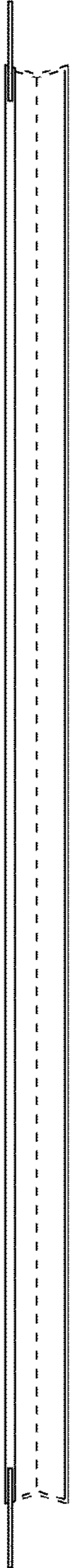

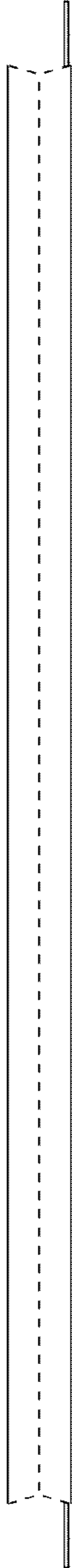

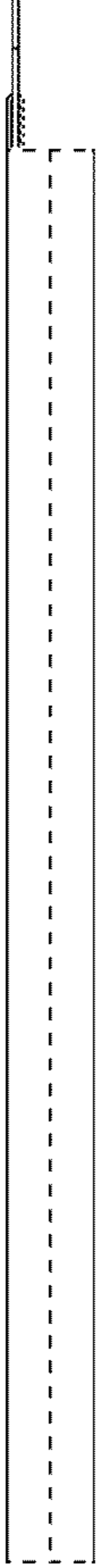

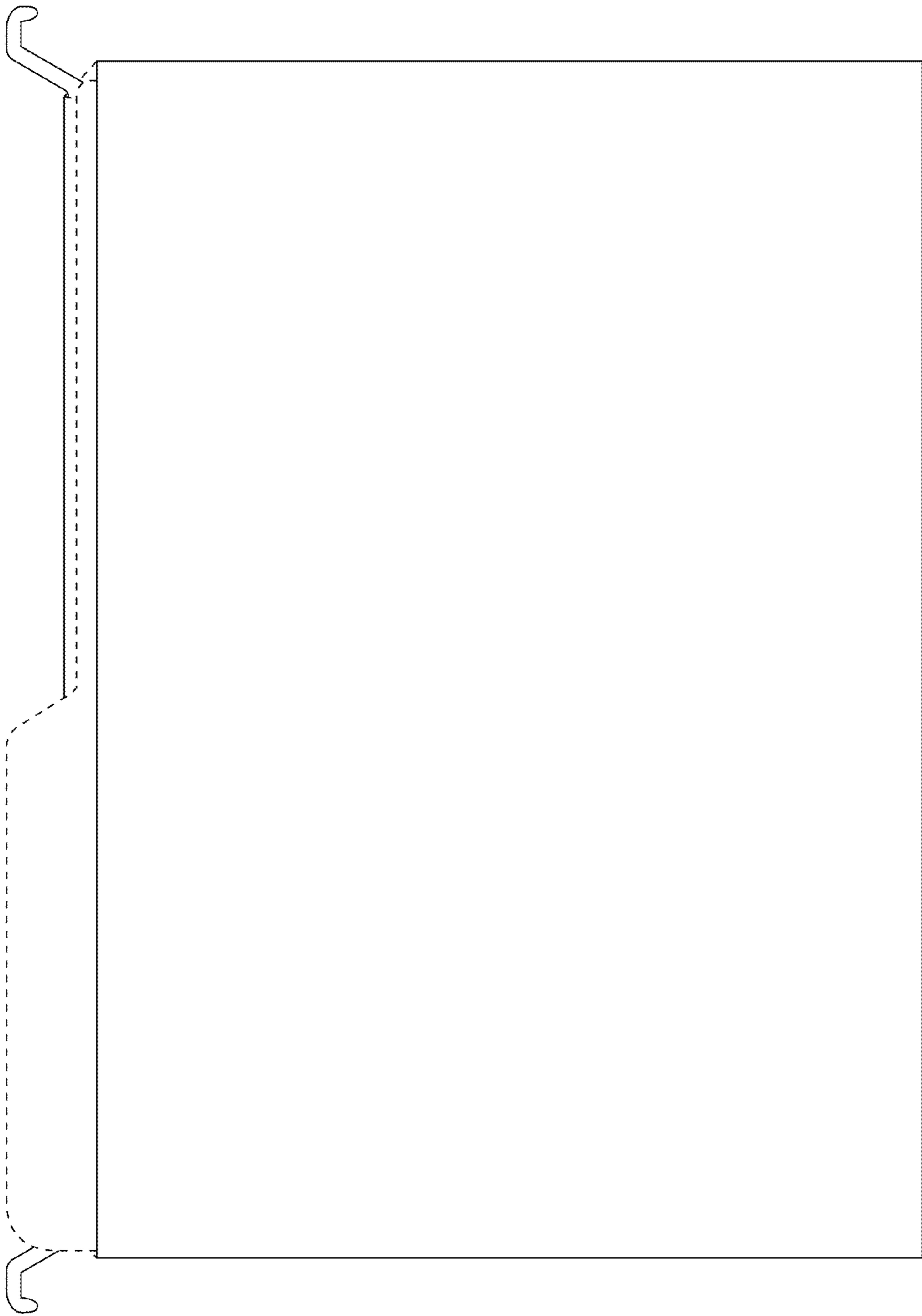

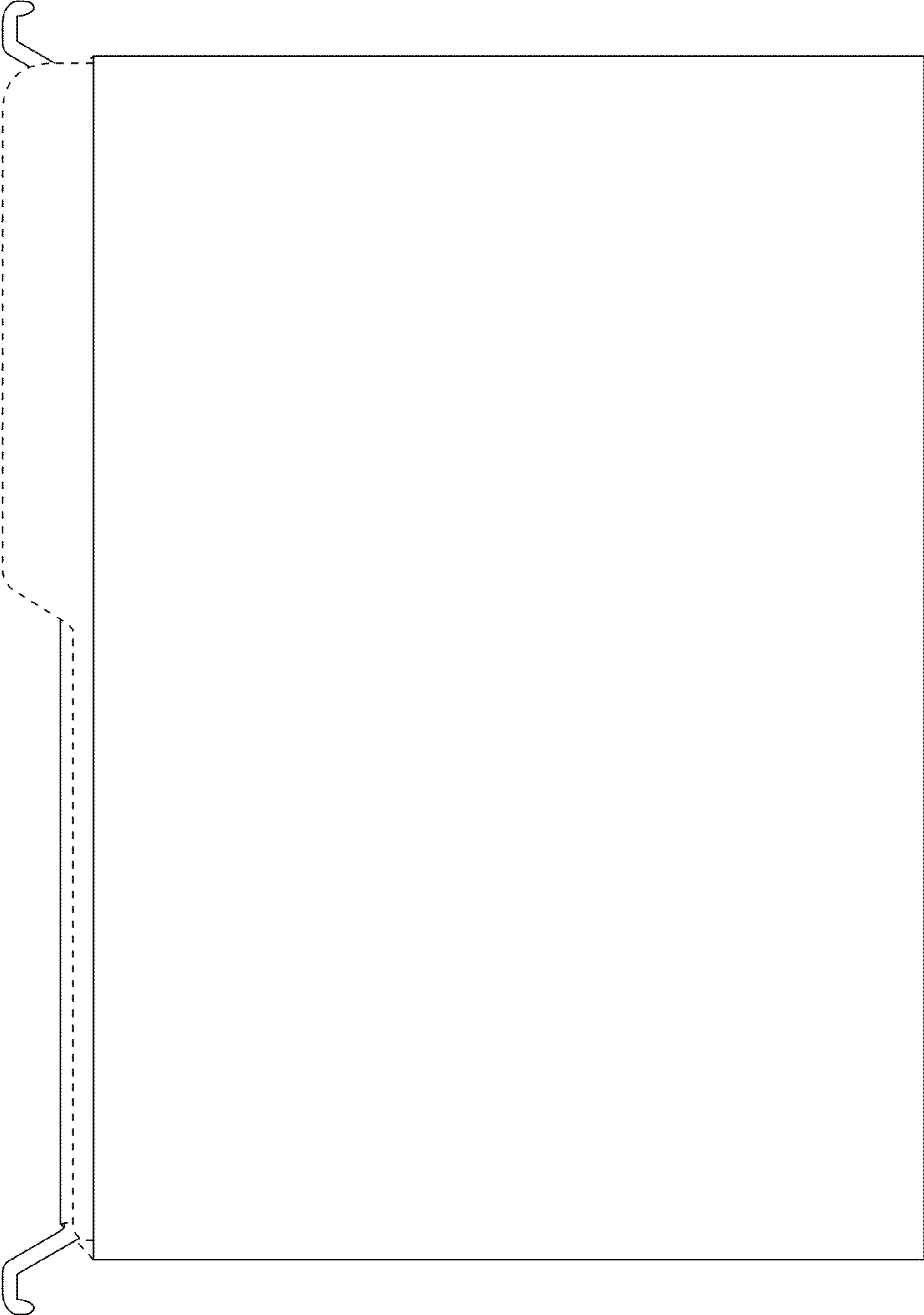

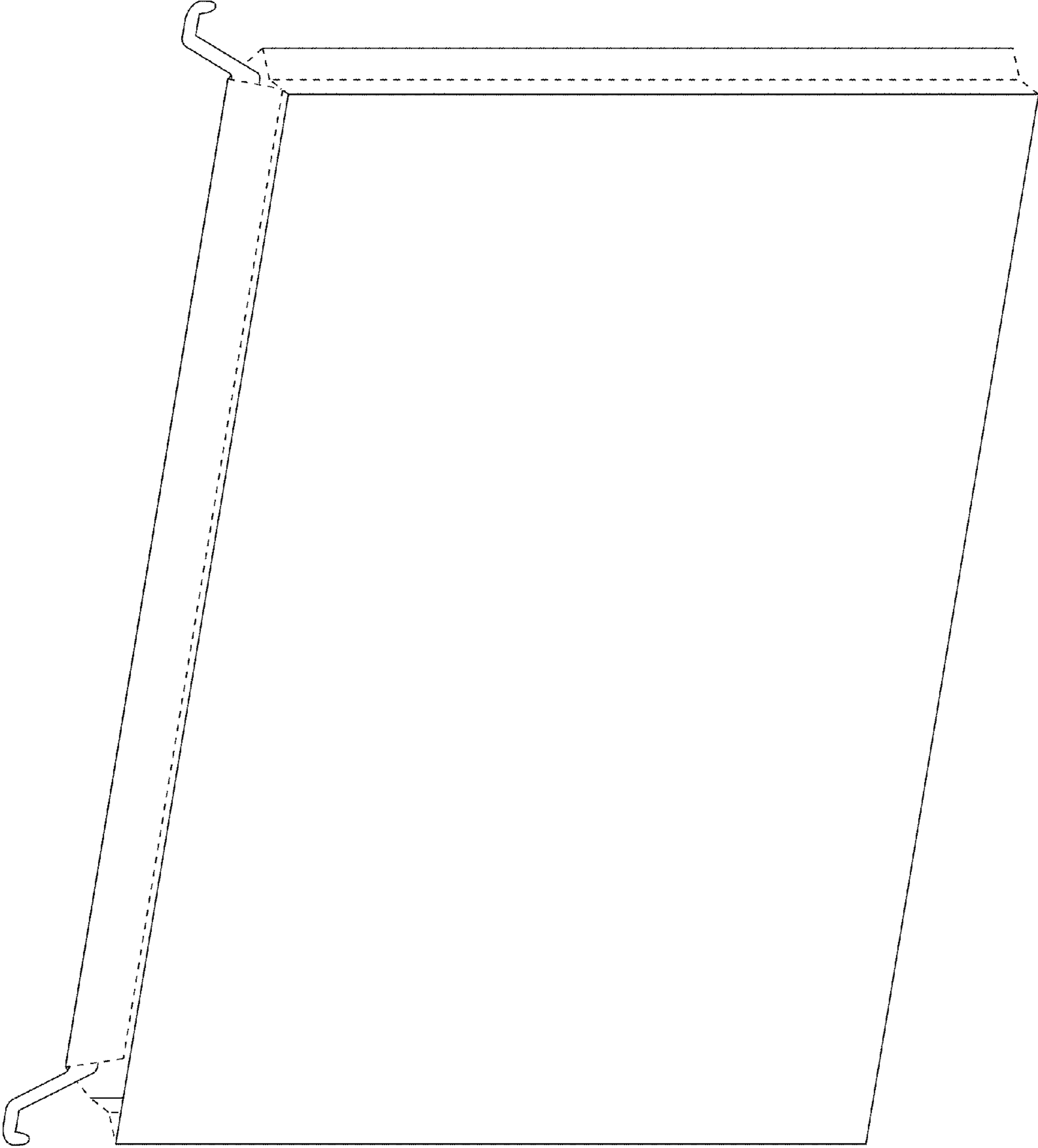

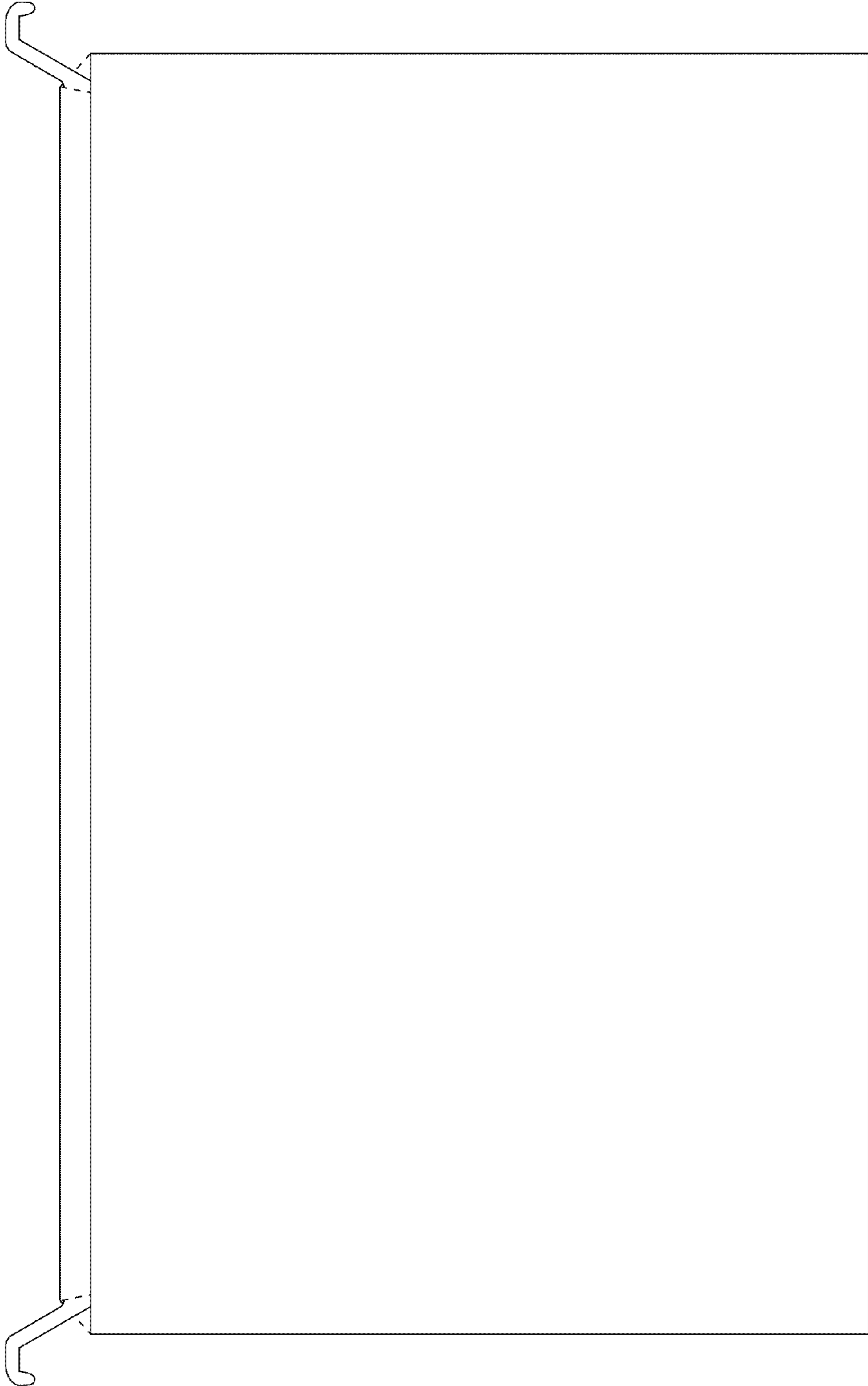

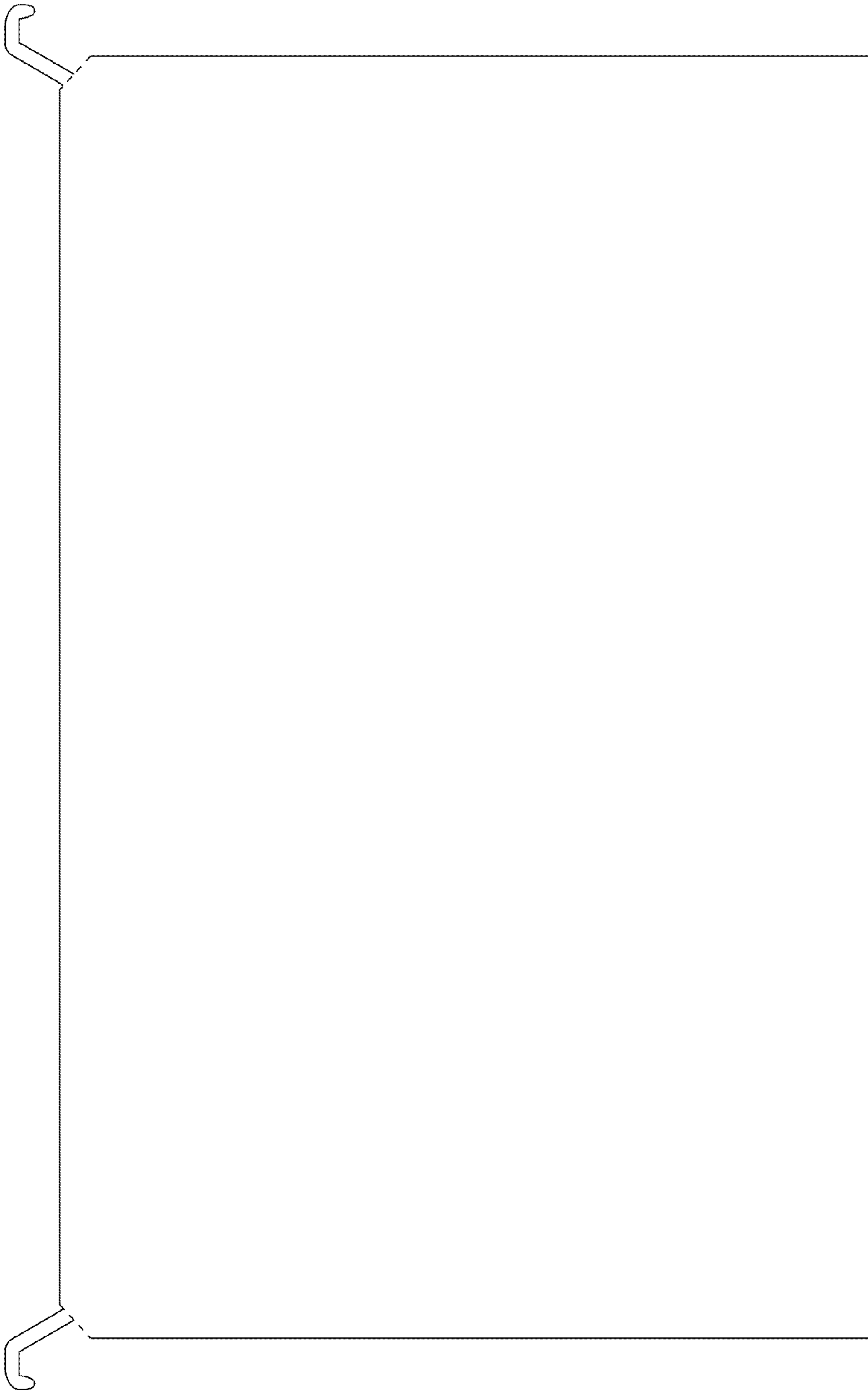

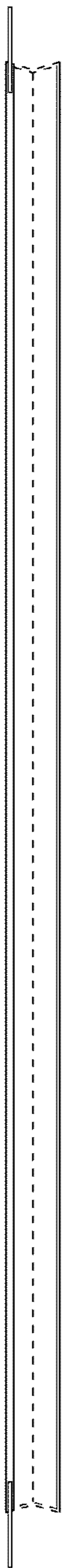

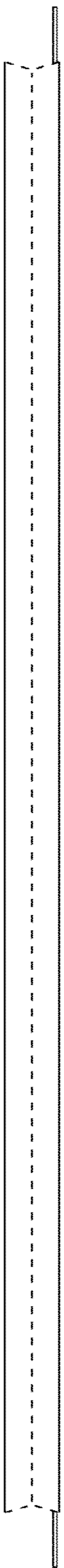

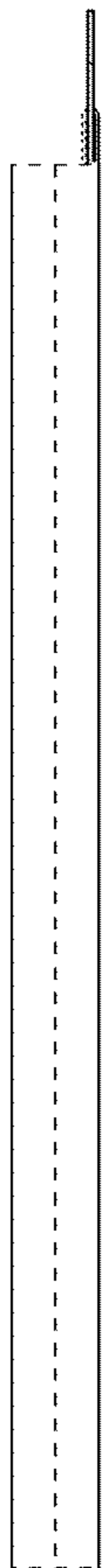

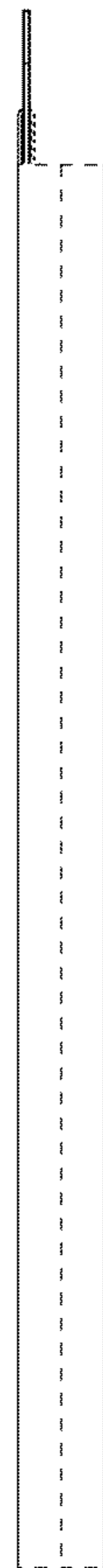

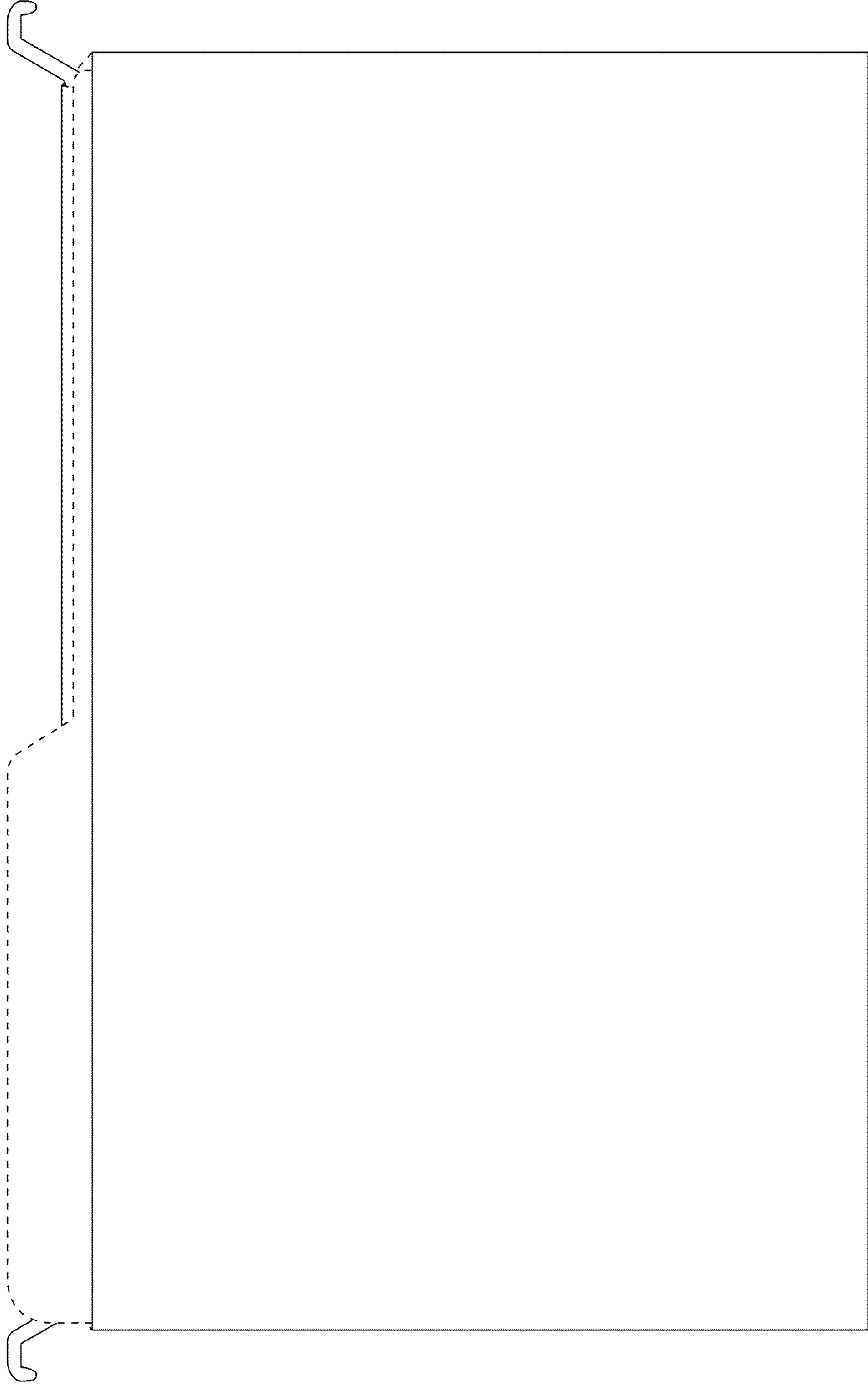

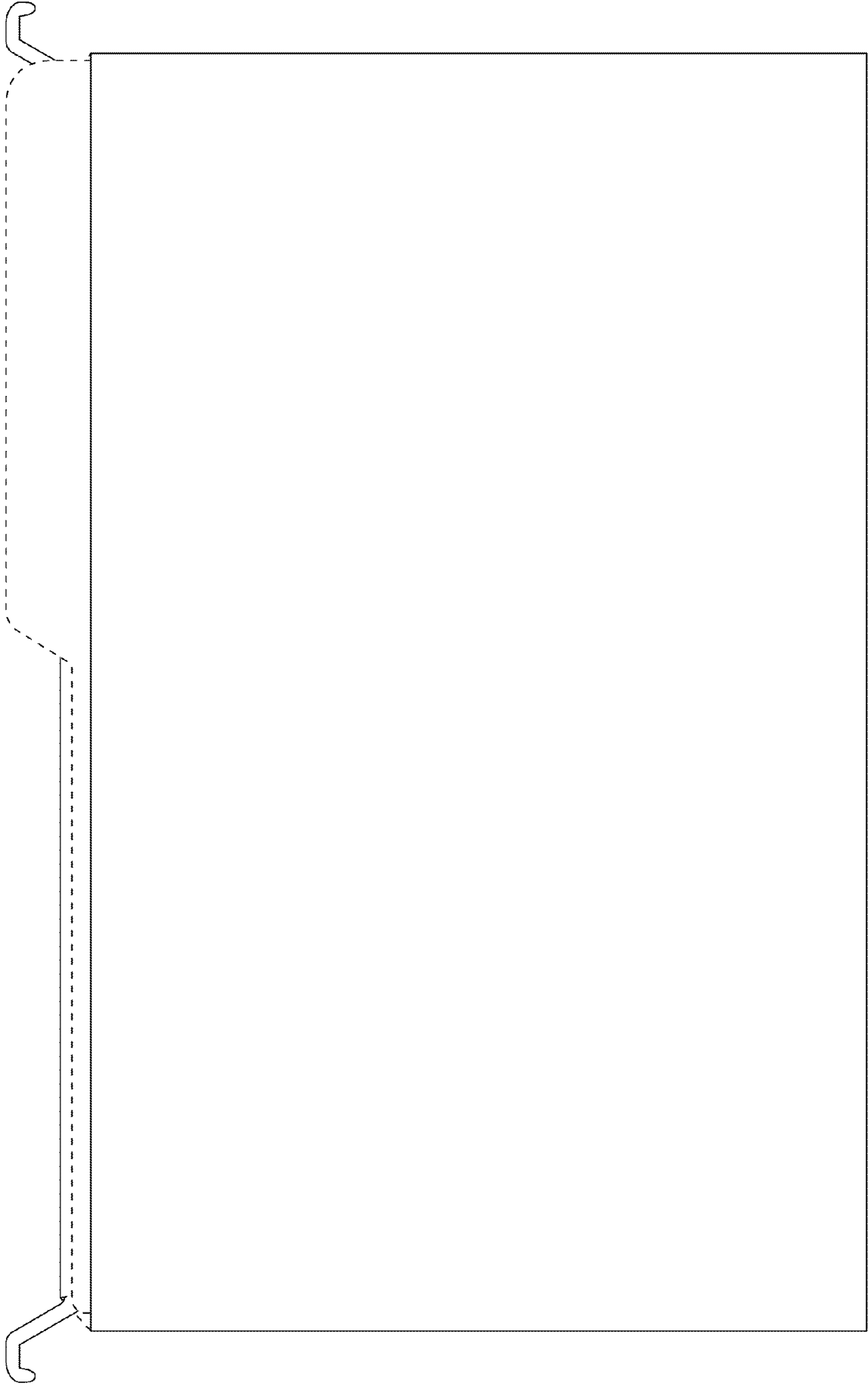

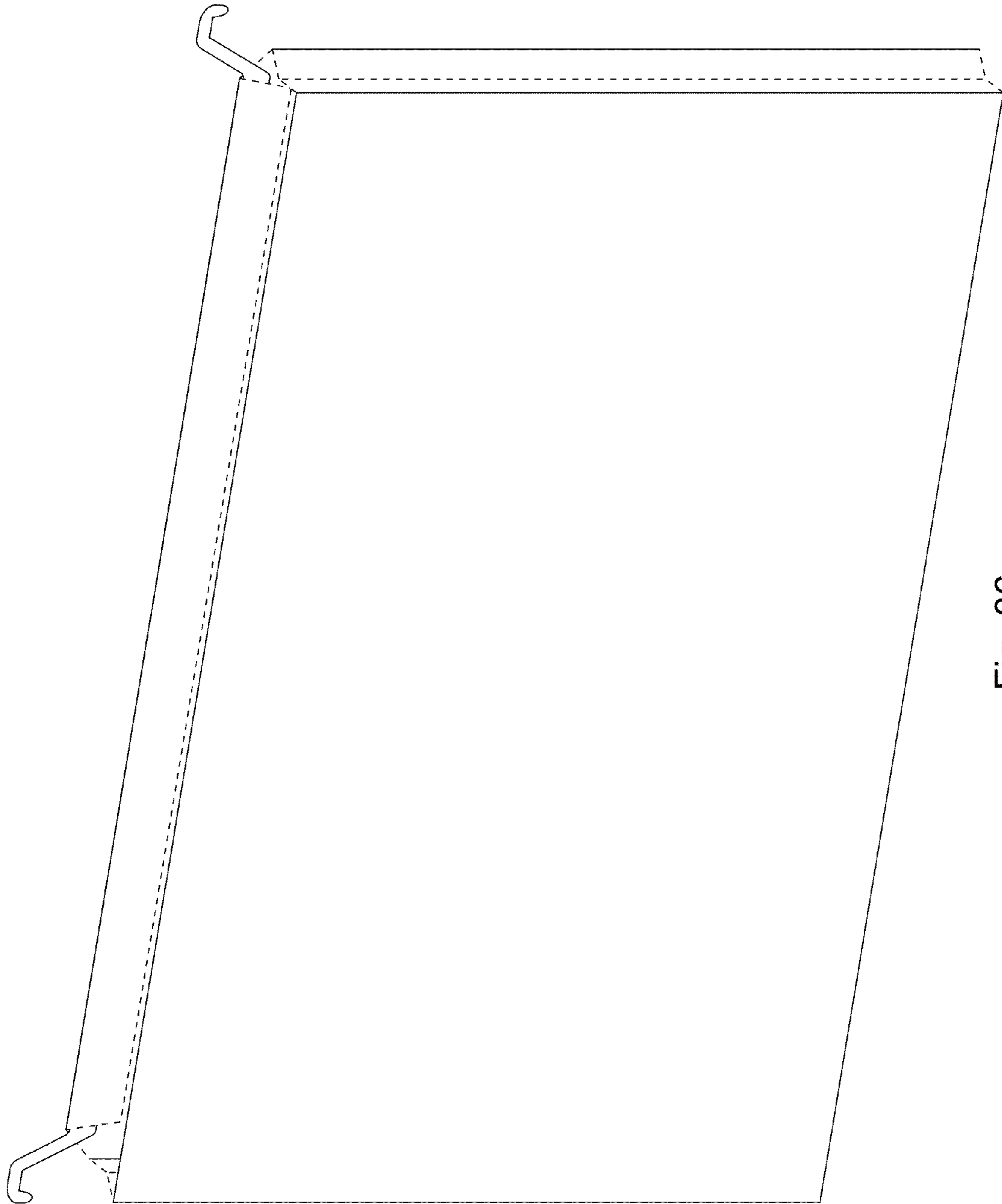
