The broken lines that appear within the bounds of the claimed article of FIGS. 1 and 2 depict a portion of the pattern and form a part of the claimed design.

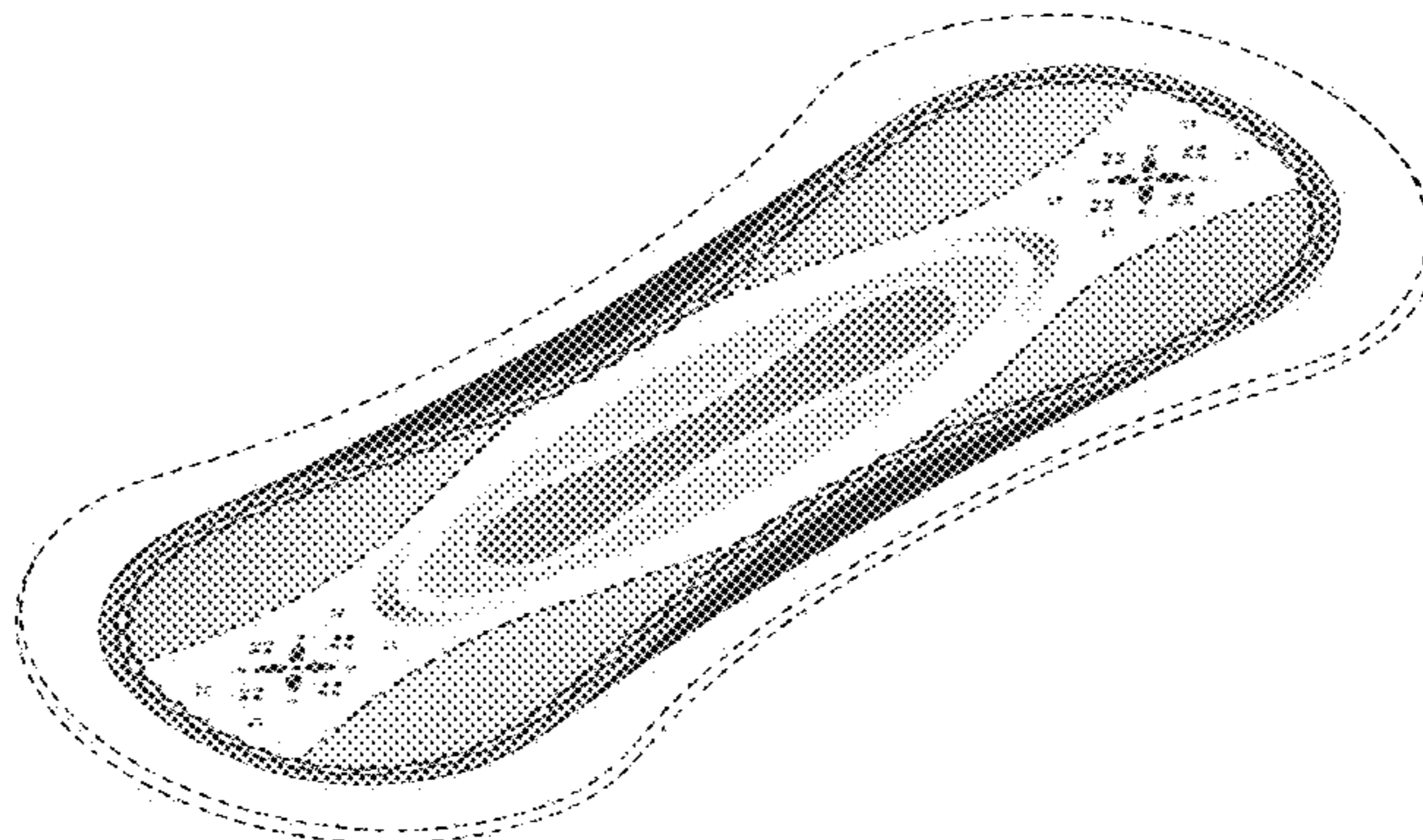

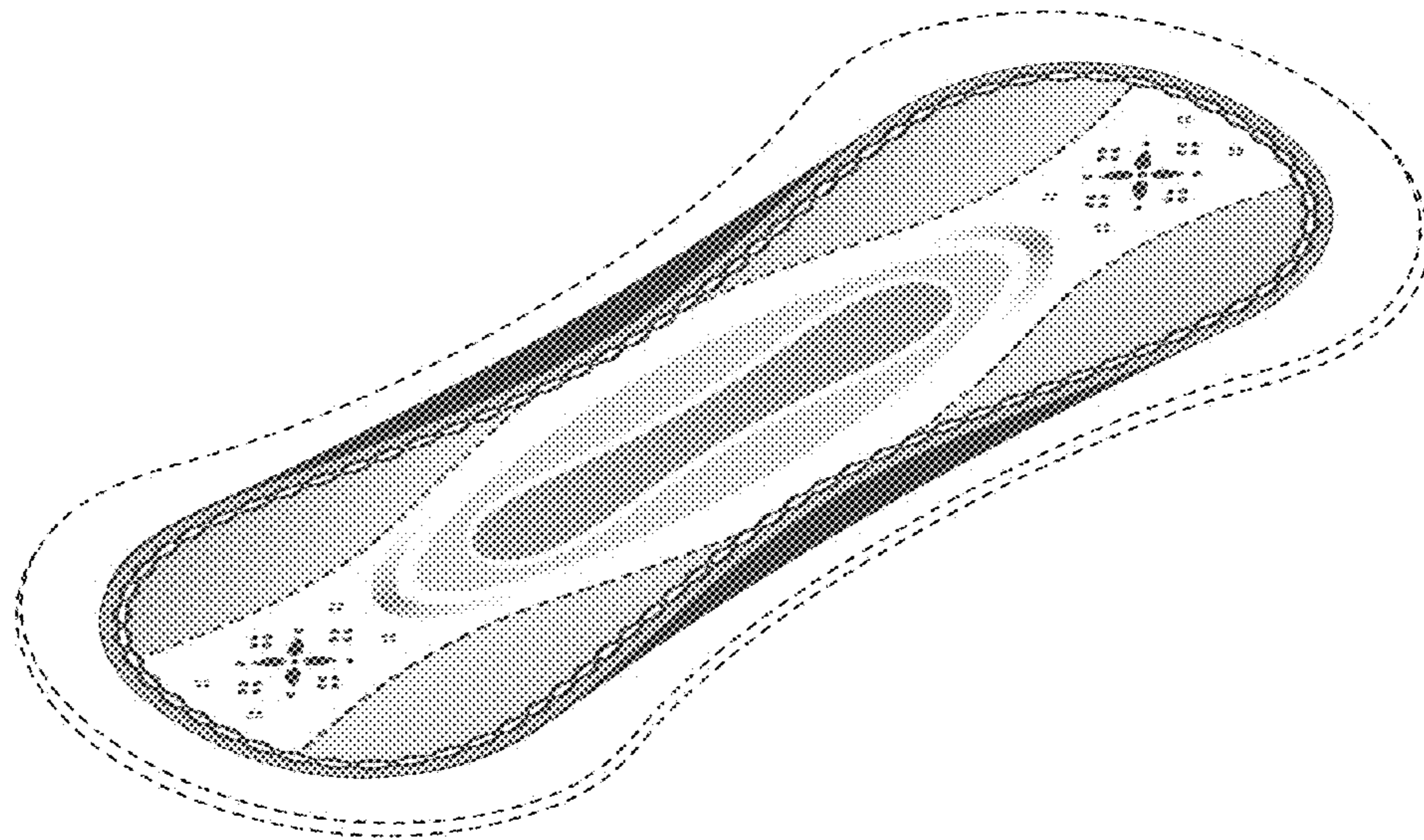

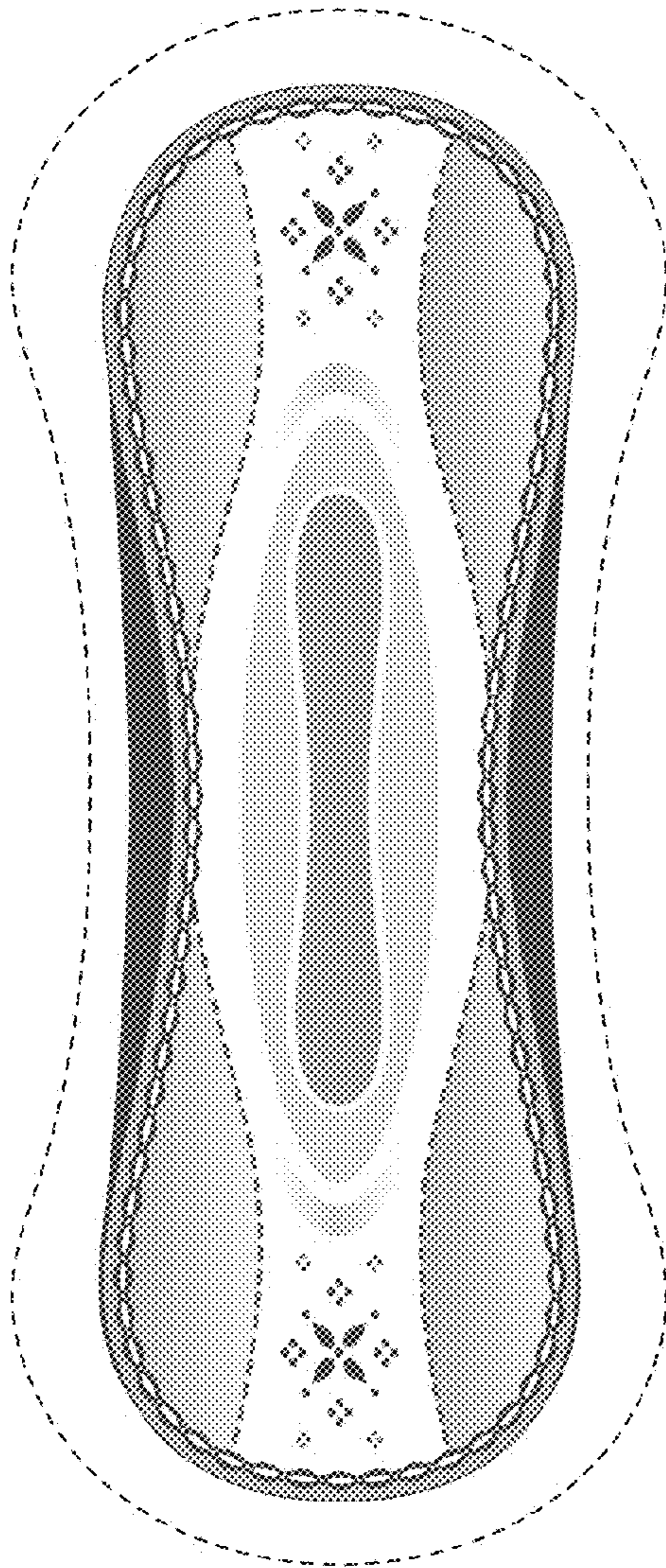

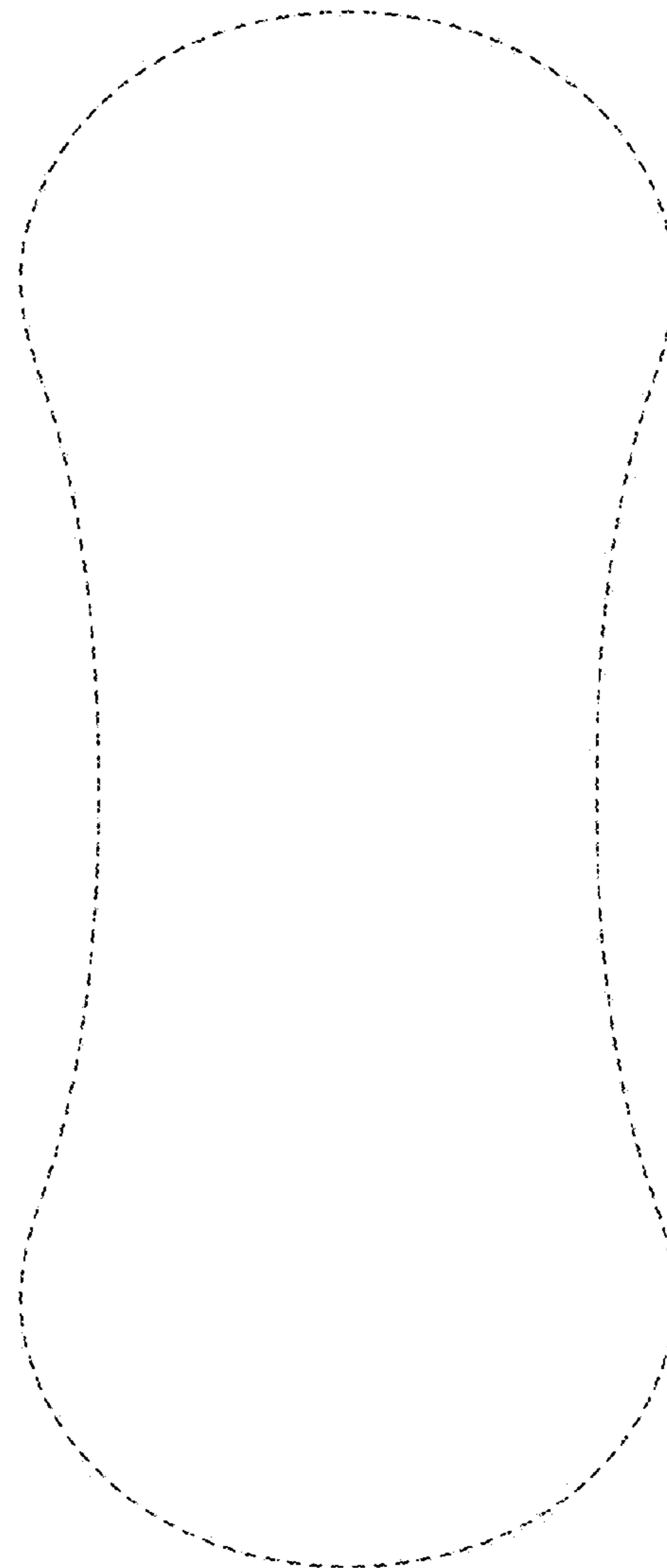

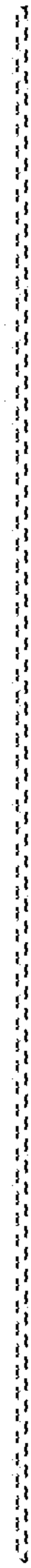

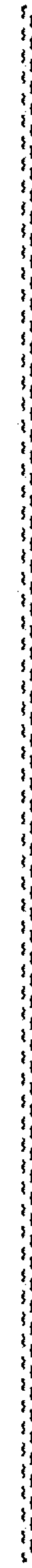

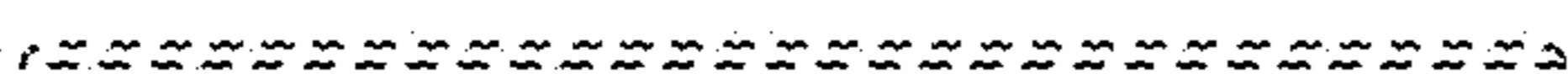
