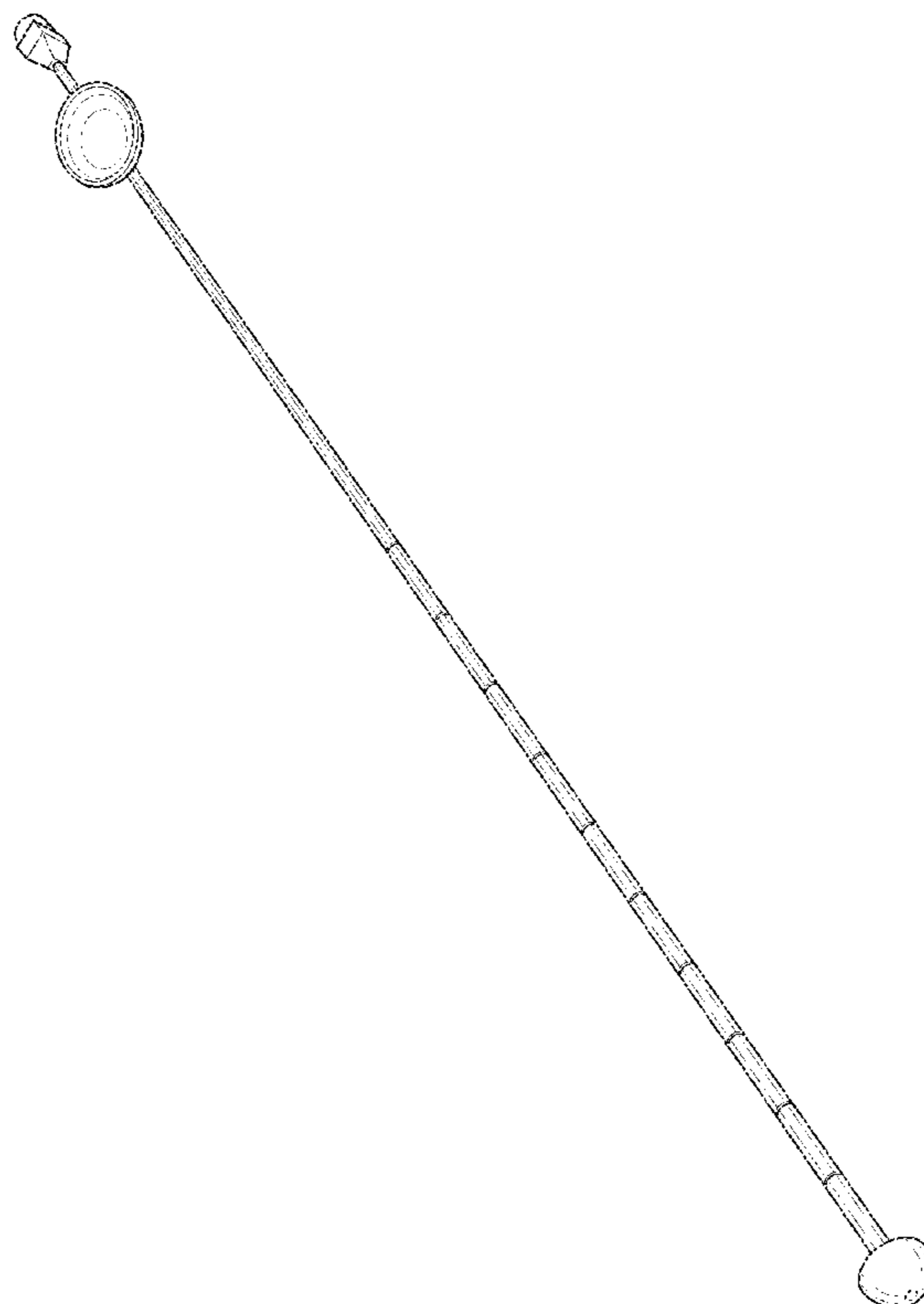
(57) **CLAIM**

I claim the ornamental design for an anesthesia delivery device with hemispherical tip, as shown and described.

DESCRIPTION

FIG. 1 is a top side perspective view of the anesthesia delivery device with hemispherical tip of the present invention; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a rear elevation view thereof; FIG. 7 is a front elevation view thereof; and, FIG. 8 is a top side, perspective, magnified view of the hemispherical tip of the device of FIG. 1. The broken lines showing the anesthetic exit port in the hemispherical tip of the device are included for the purpose of illustrating structure that form no part of the claimed design.

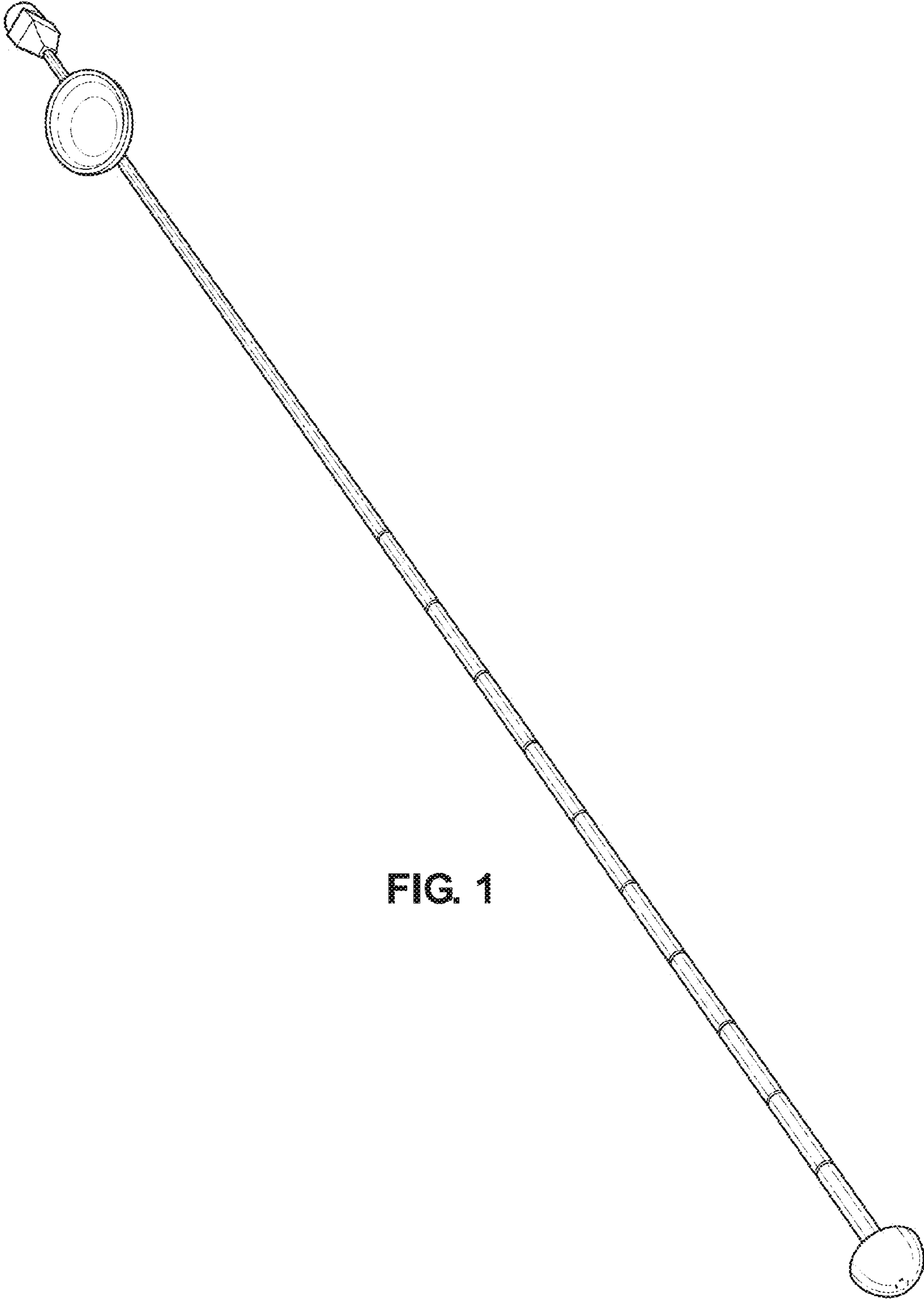

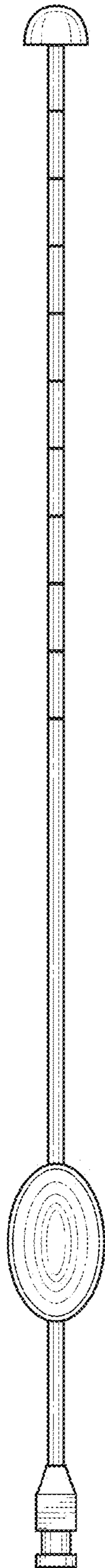

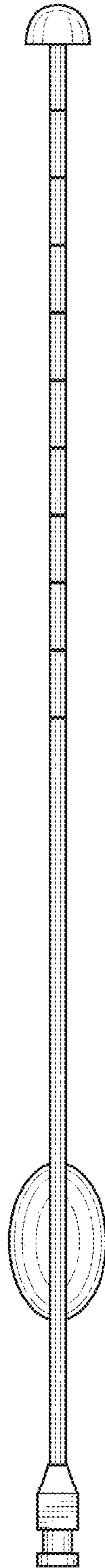

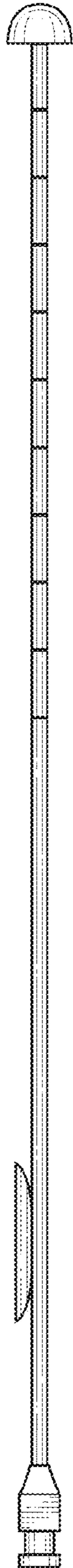

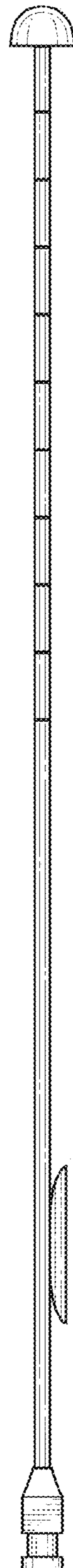

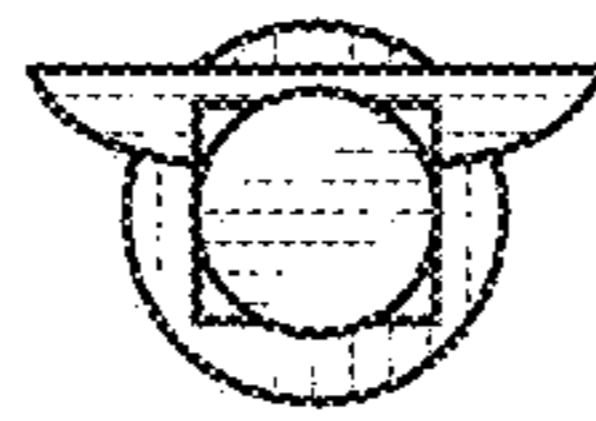

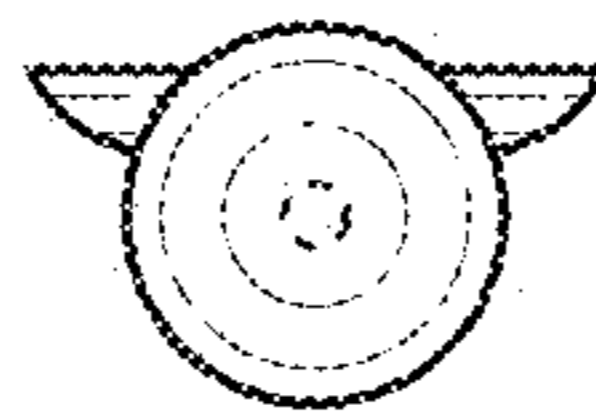

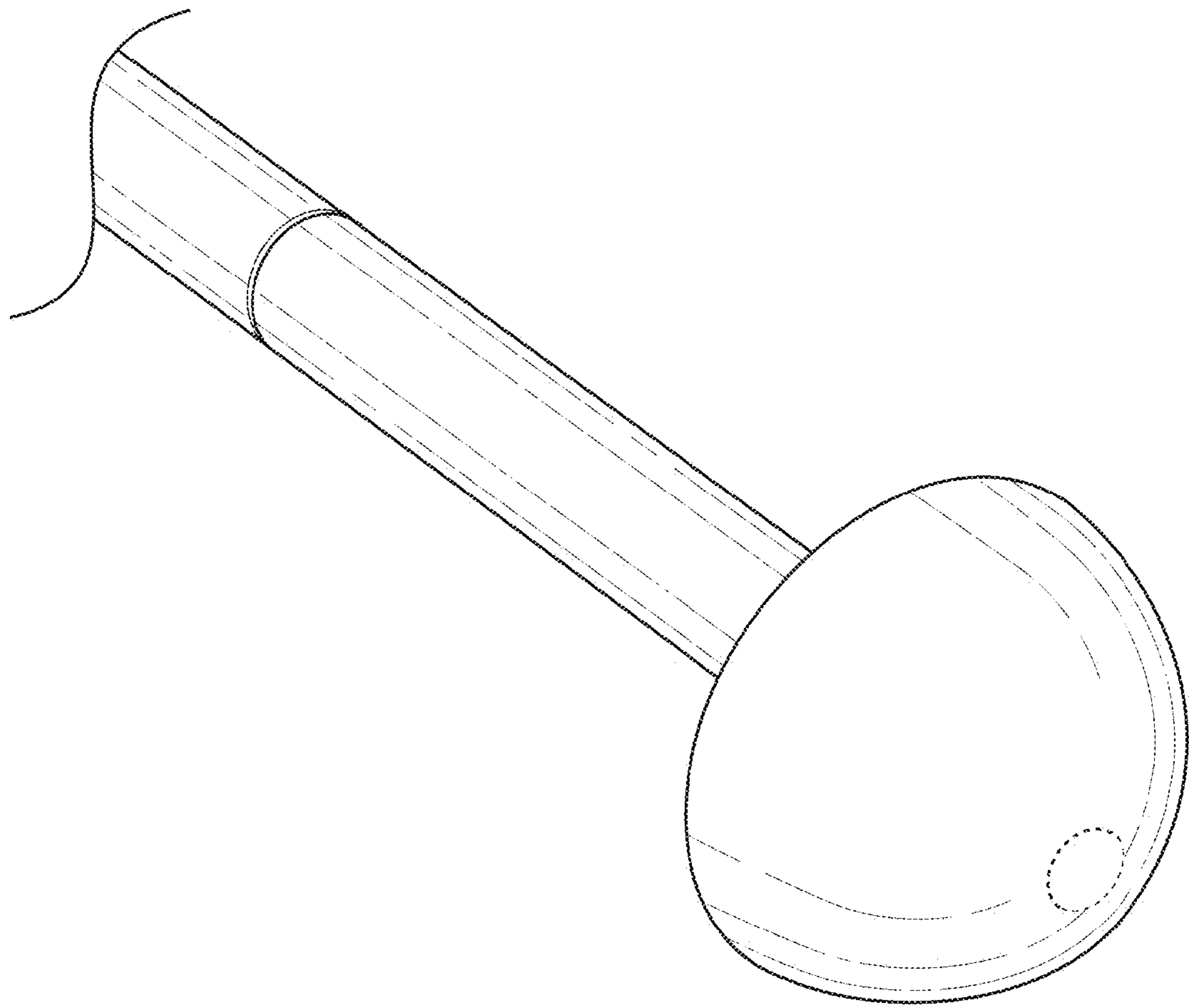
