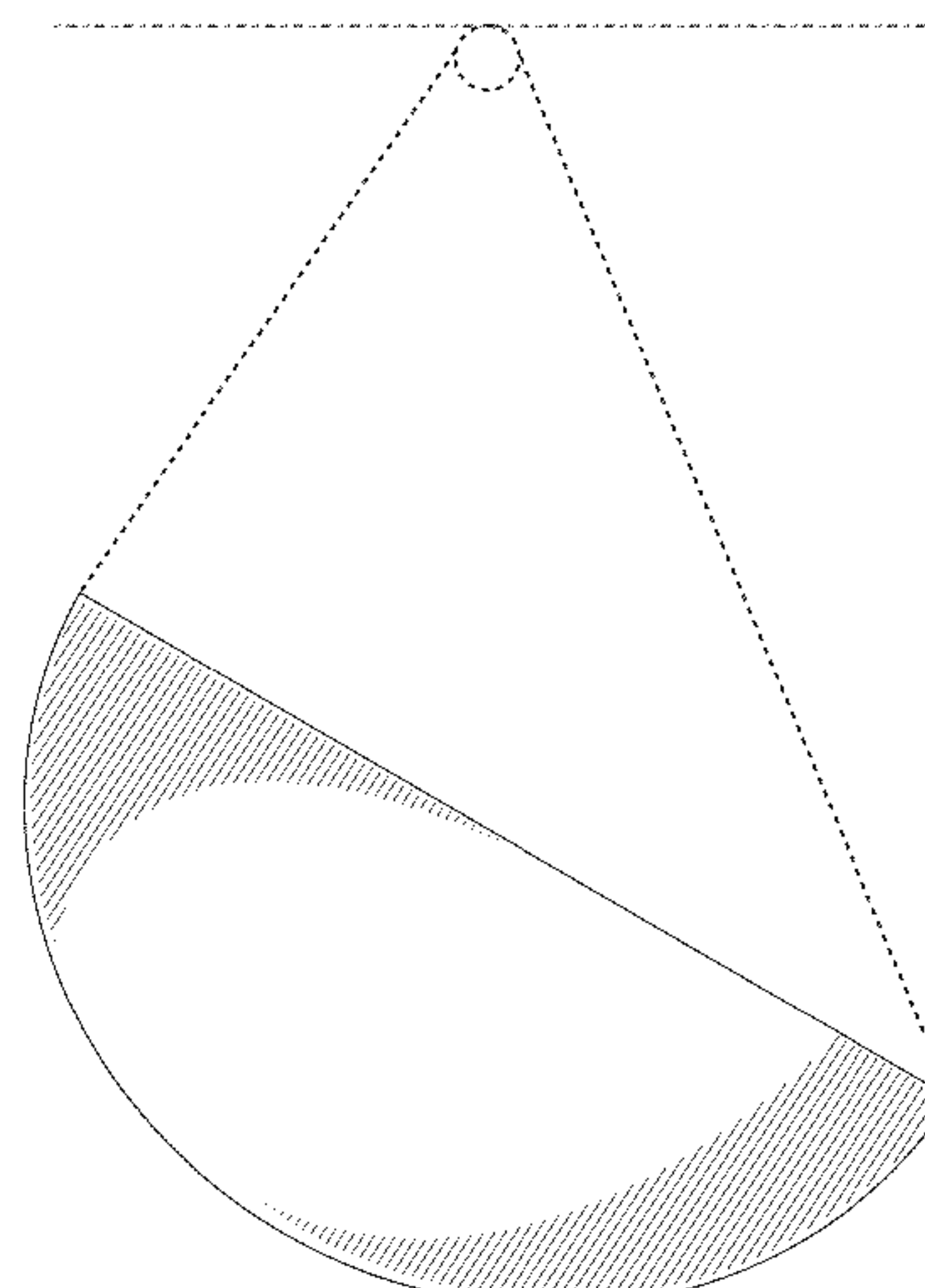
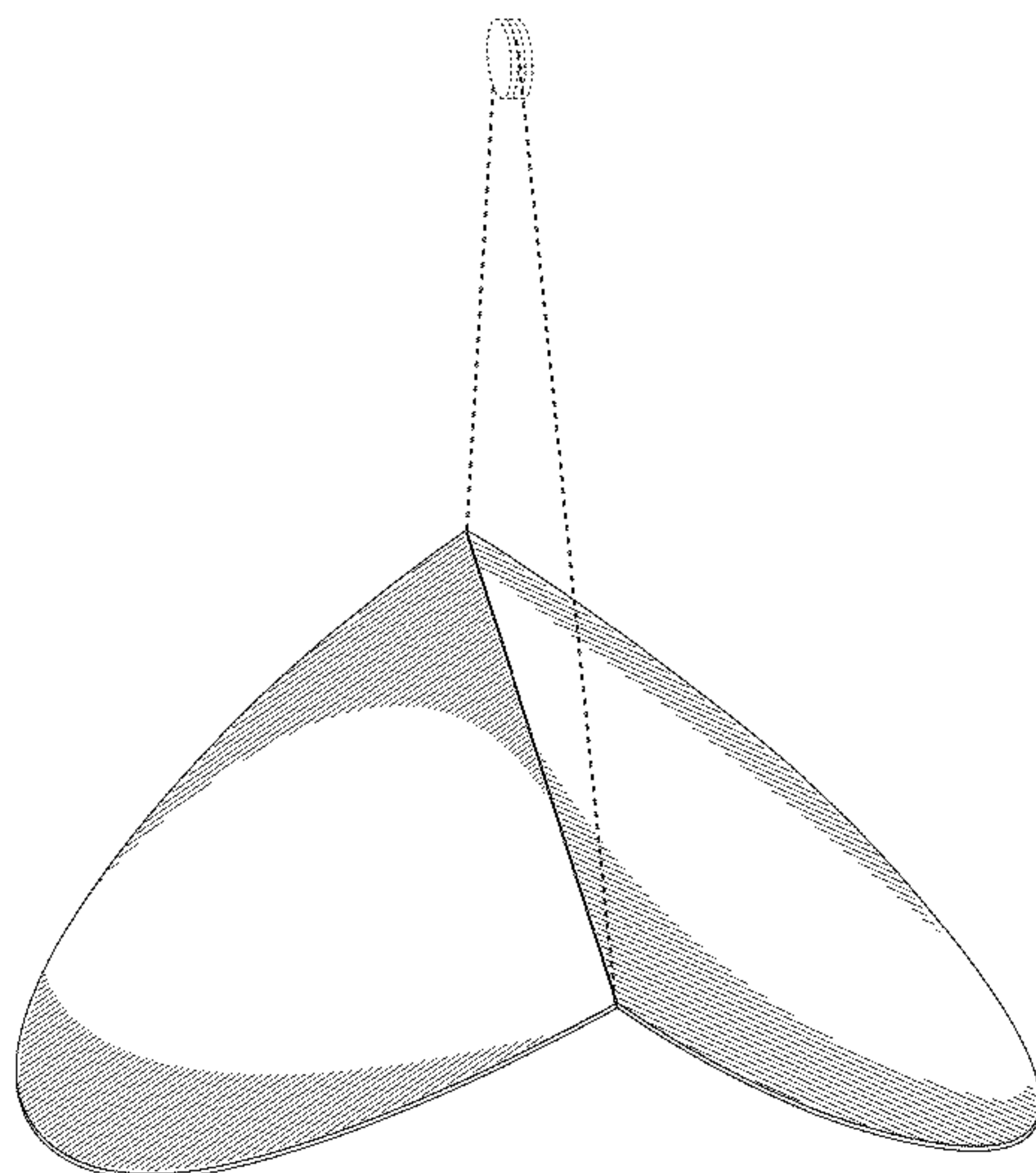
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a back side perspective view of a lighting fixture in accordance with the present invention;
FIG. 2 is a left side view thereof;

FIG. 4 is a right side view thereof;
FIG. 5 is a back side view thereof;
FIG. 6 is a top view thereof; and,

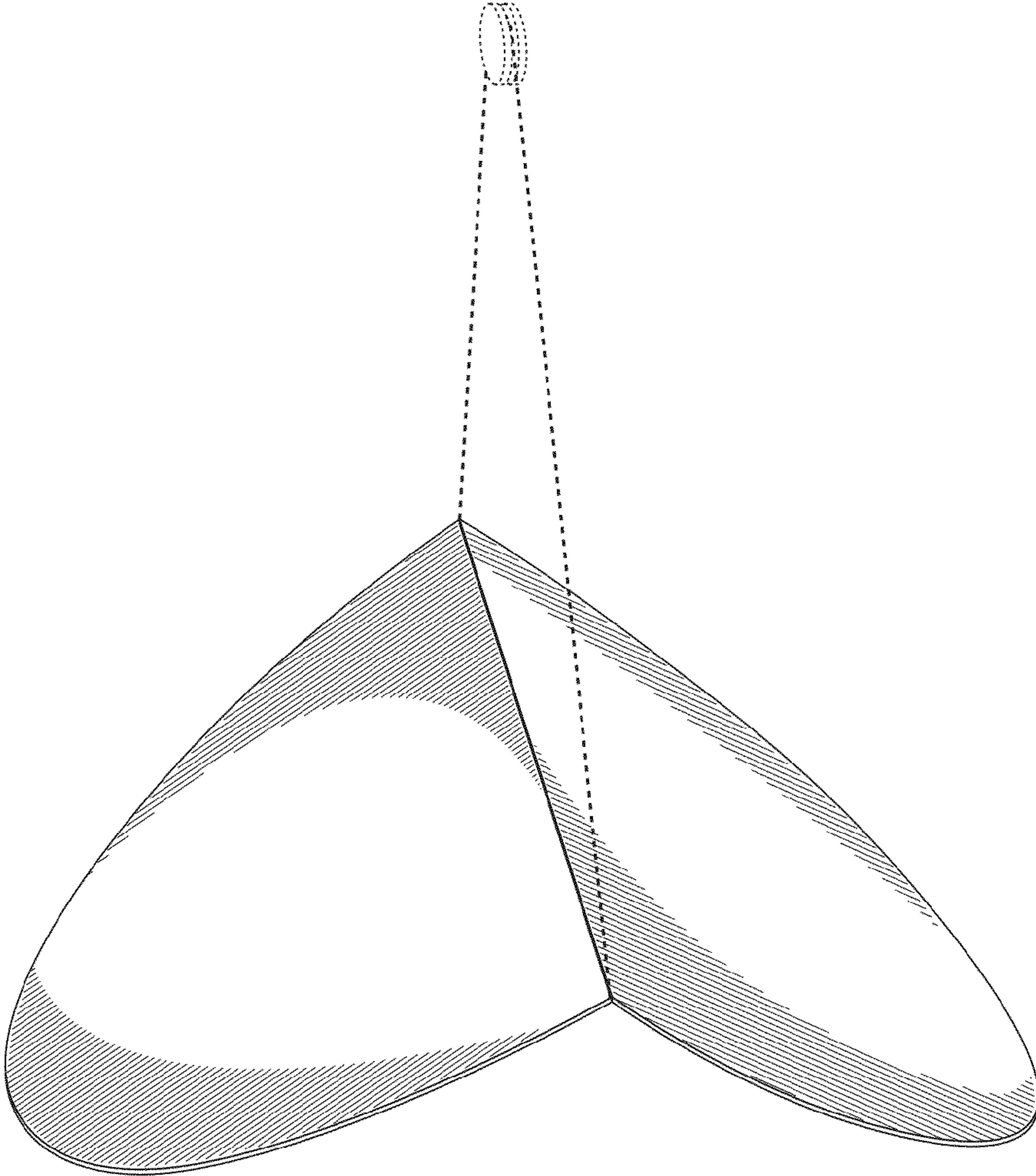

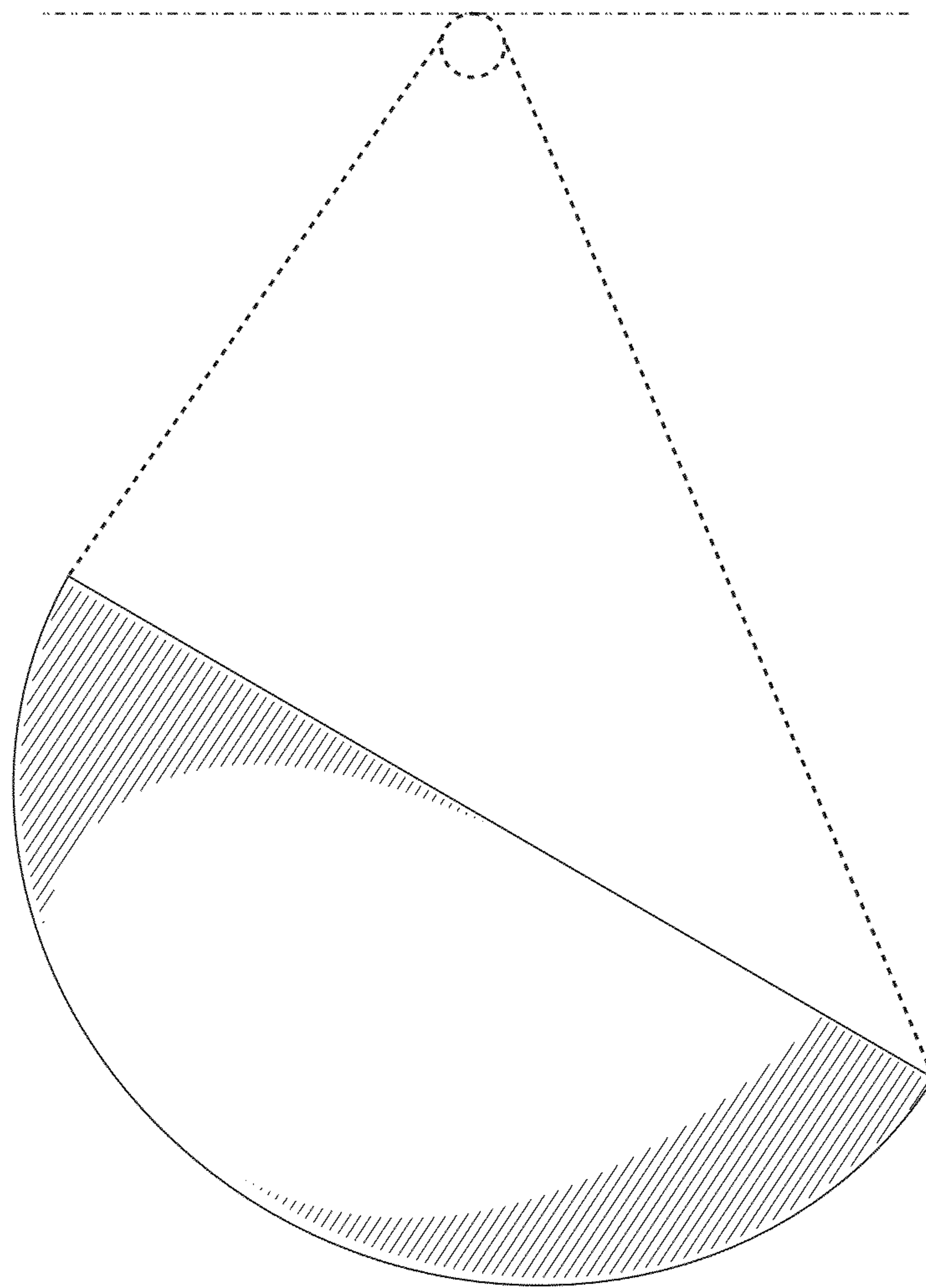

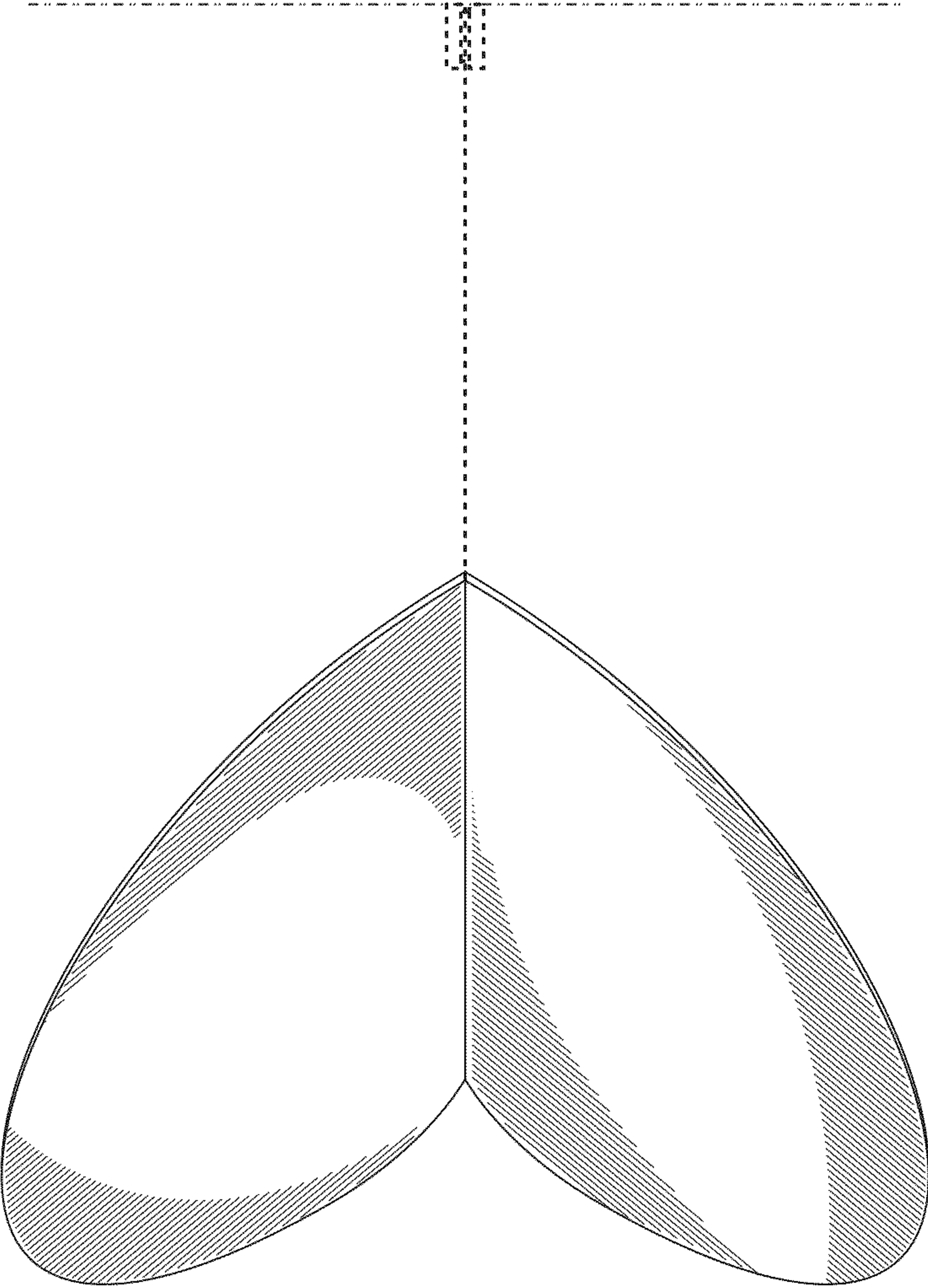

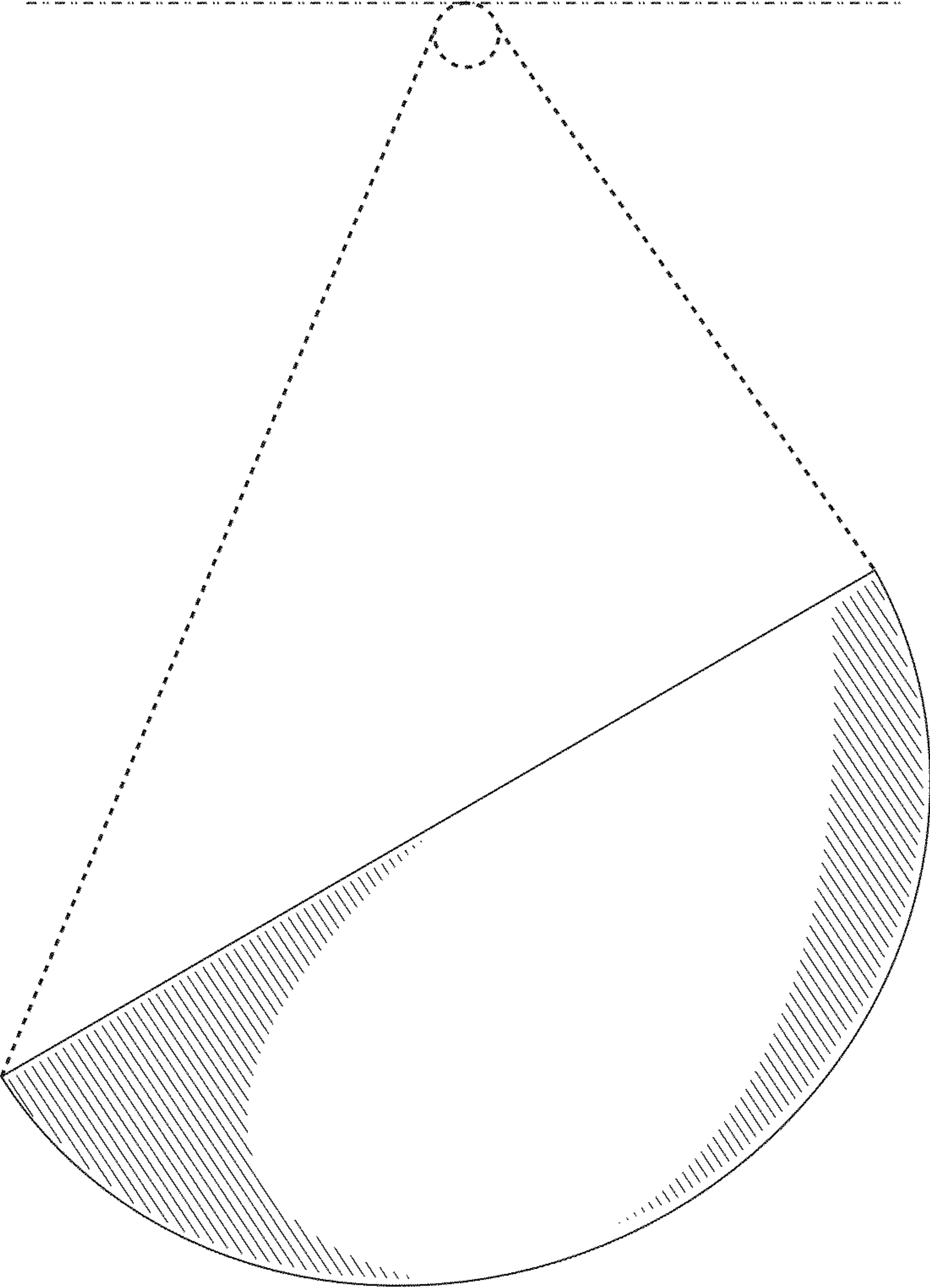

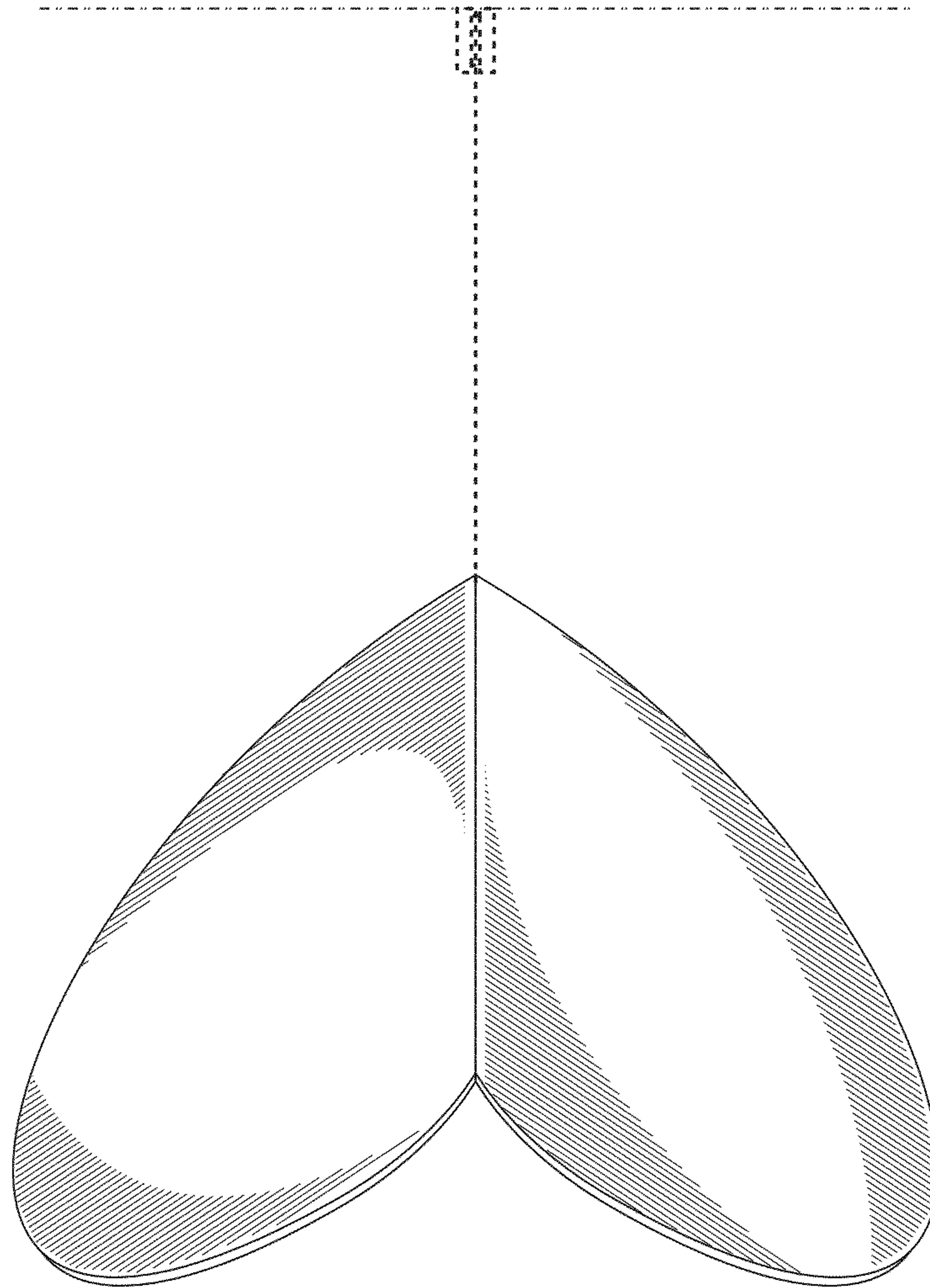

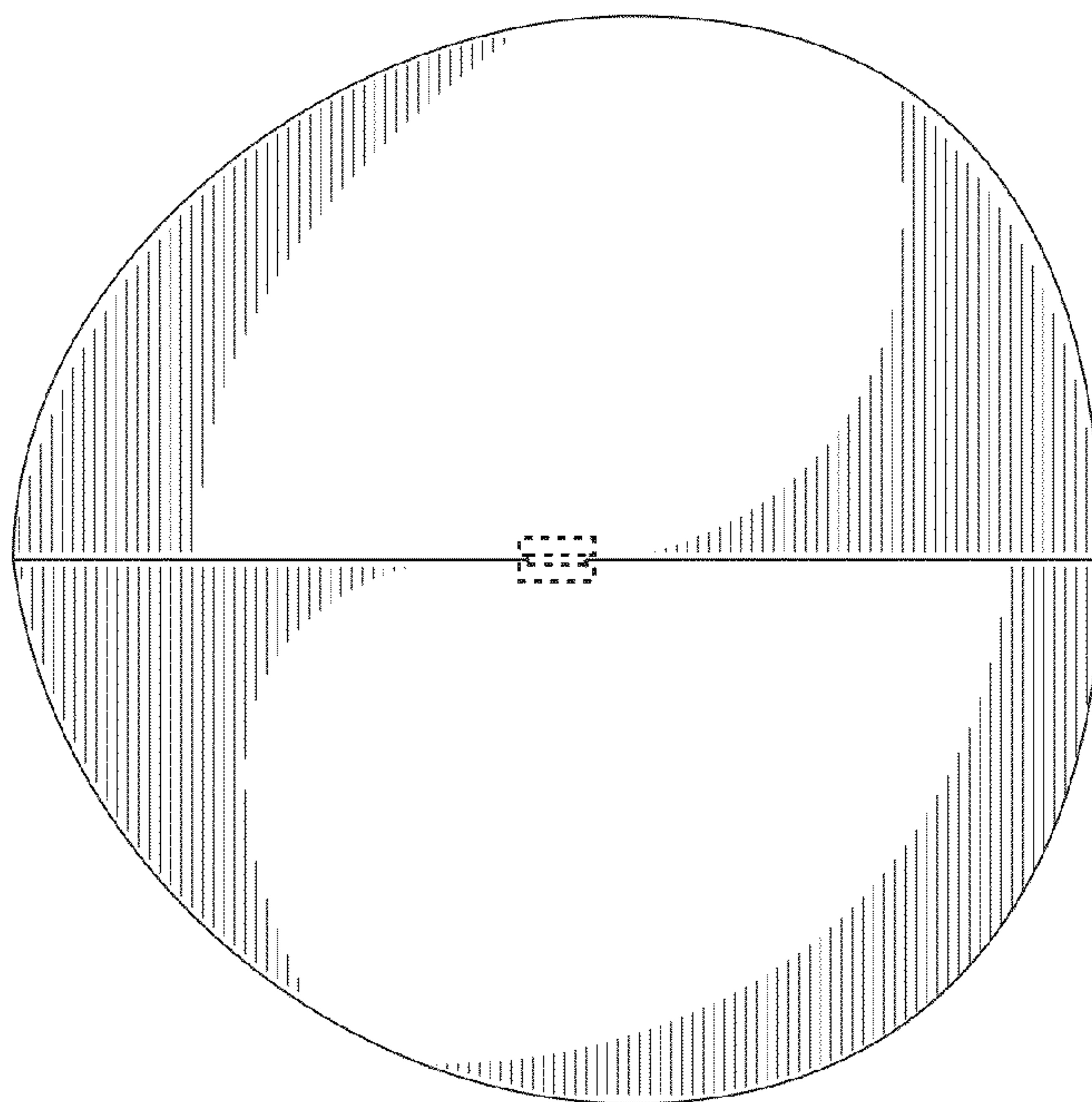

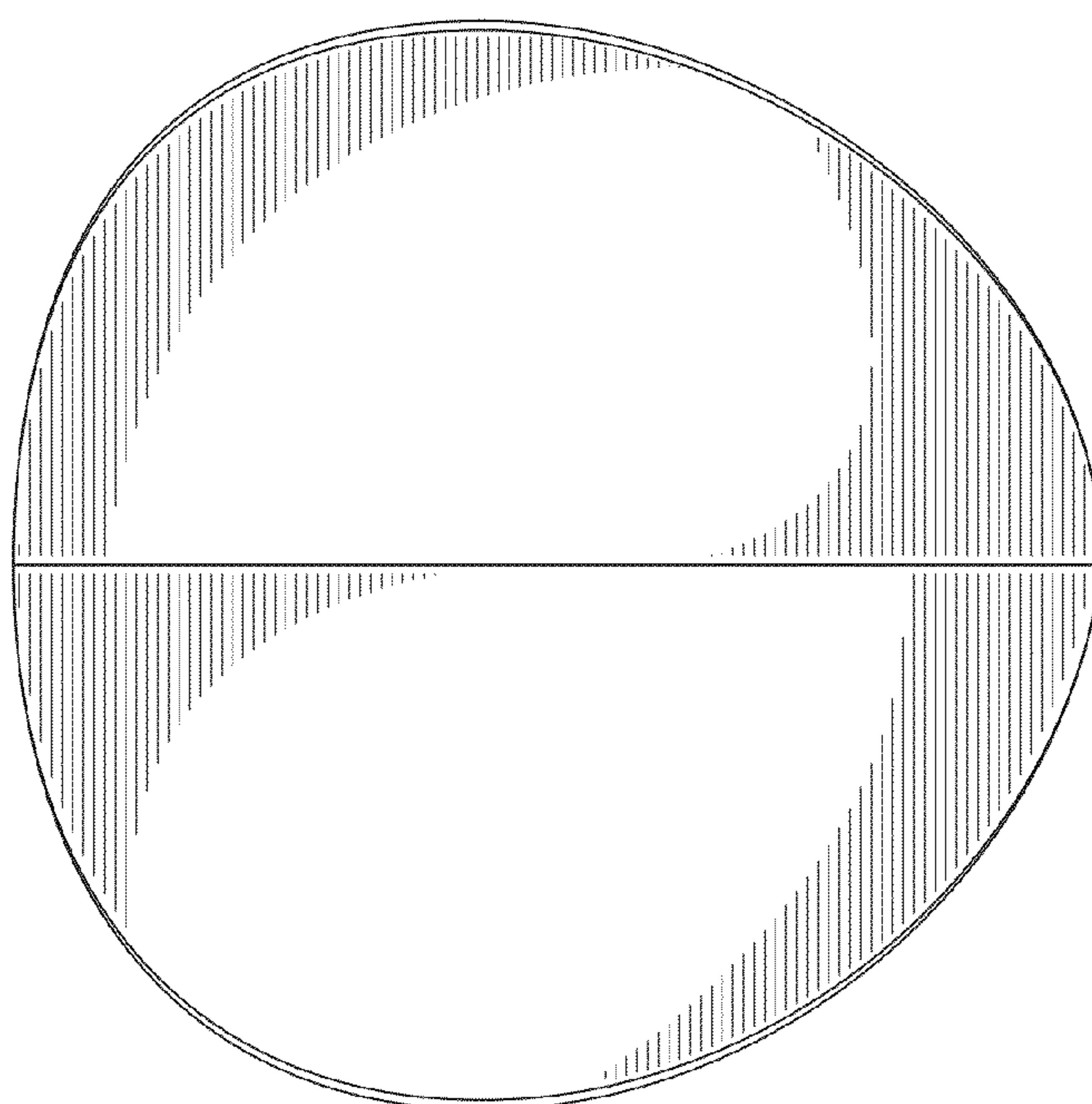
