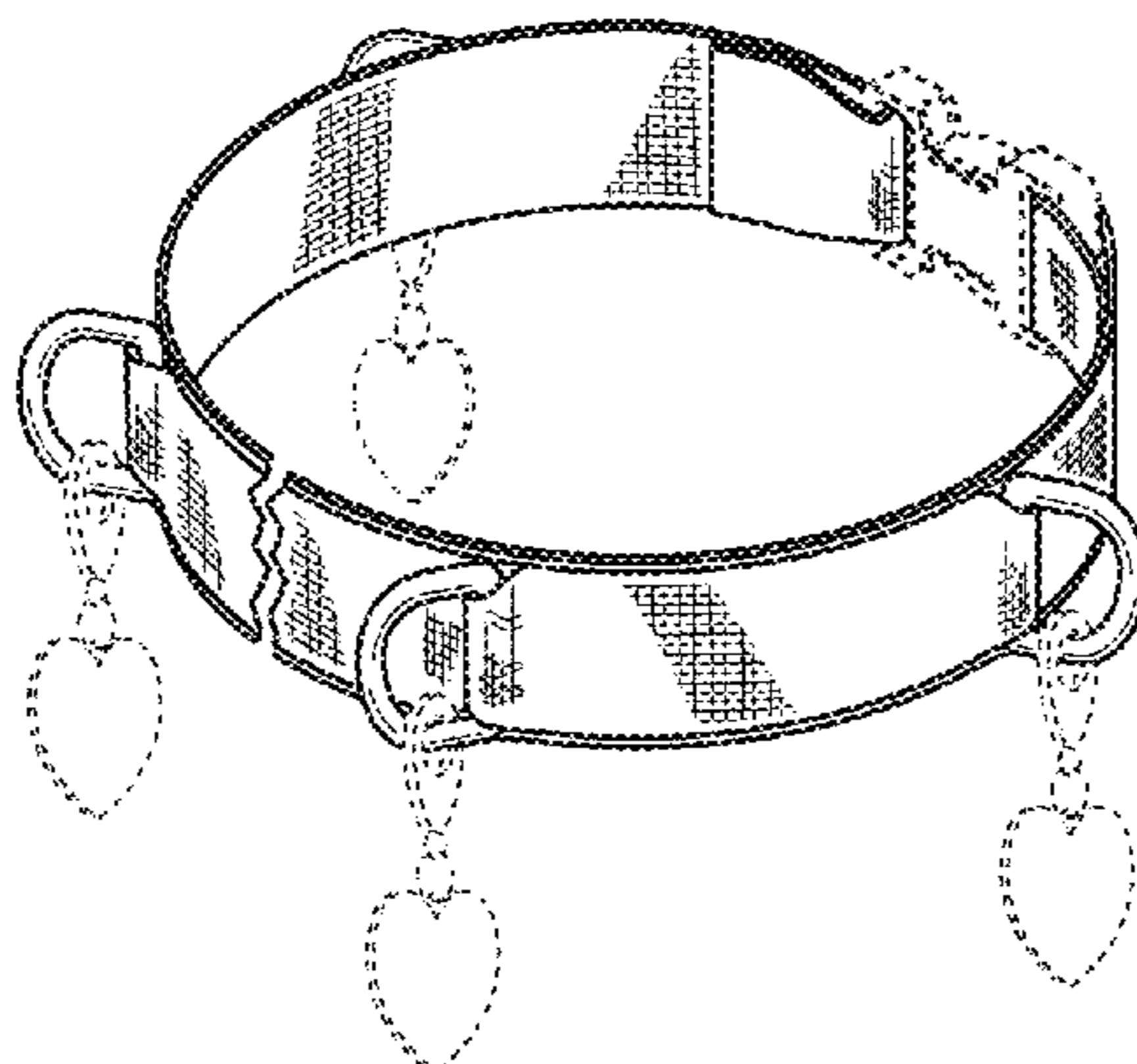
(57) **CLAIM**

The ornamental design for a pet collar, as shown and described.

DESCRIPTION

FIG. 1 is an upper perspective view of a pet collar, arranged in a closed configuration, showing my new design;
FIG. 2 is an upper perspective view thereof, arranged in an open configuration;
FIG. 3 is a front elevational view thereof;

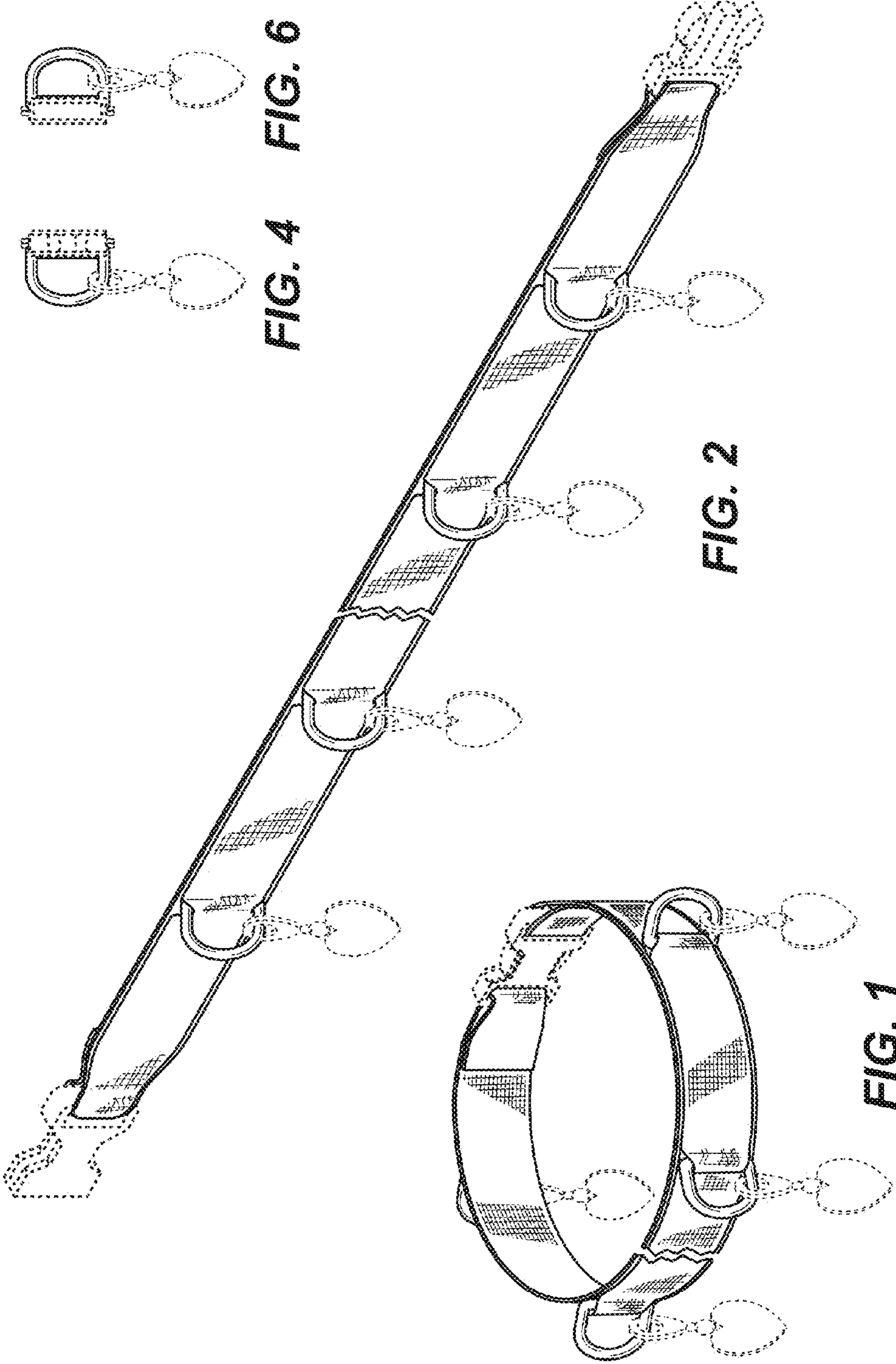


FIG. 4 FIG. 6

FIG. 4 is a right side elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a left side elevational view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.
The broken line showing of a fastener and collar charms illustrates portions of the pet collar and forms no part of the claimed design.
The pet collar is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design.

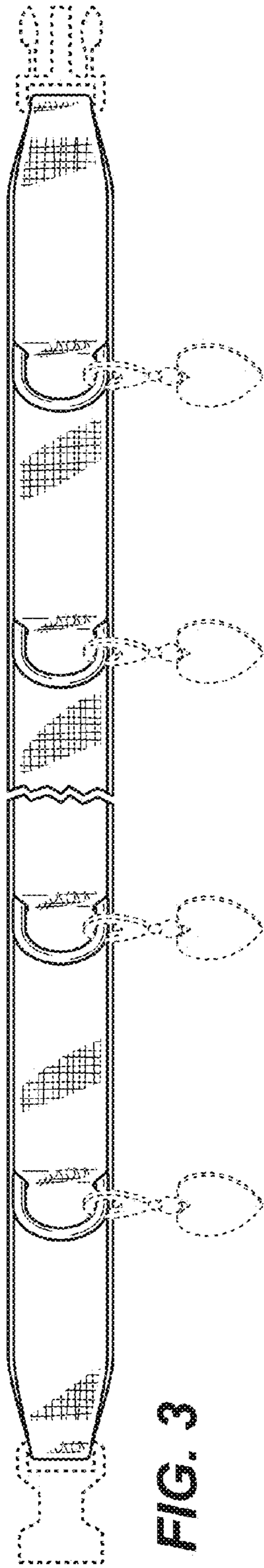

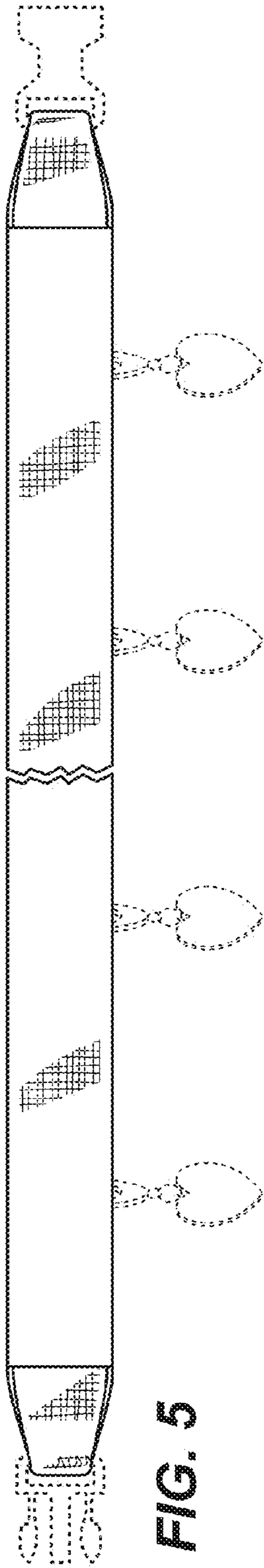

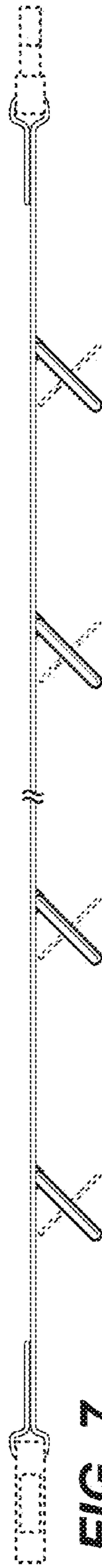

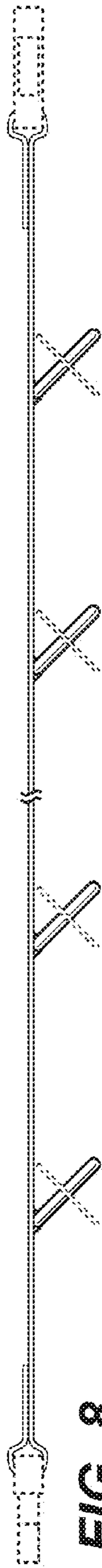
