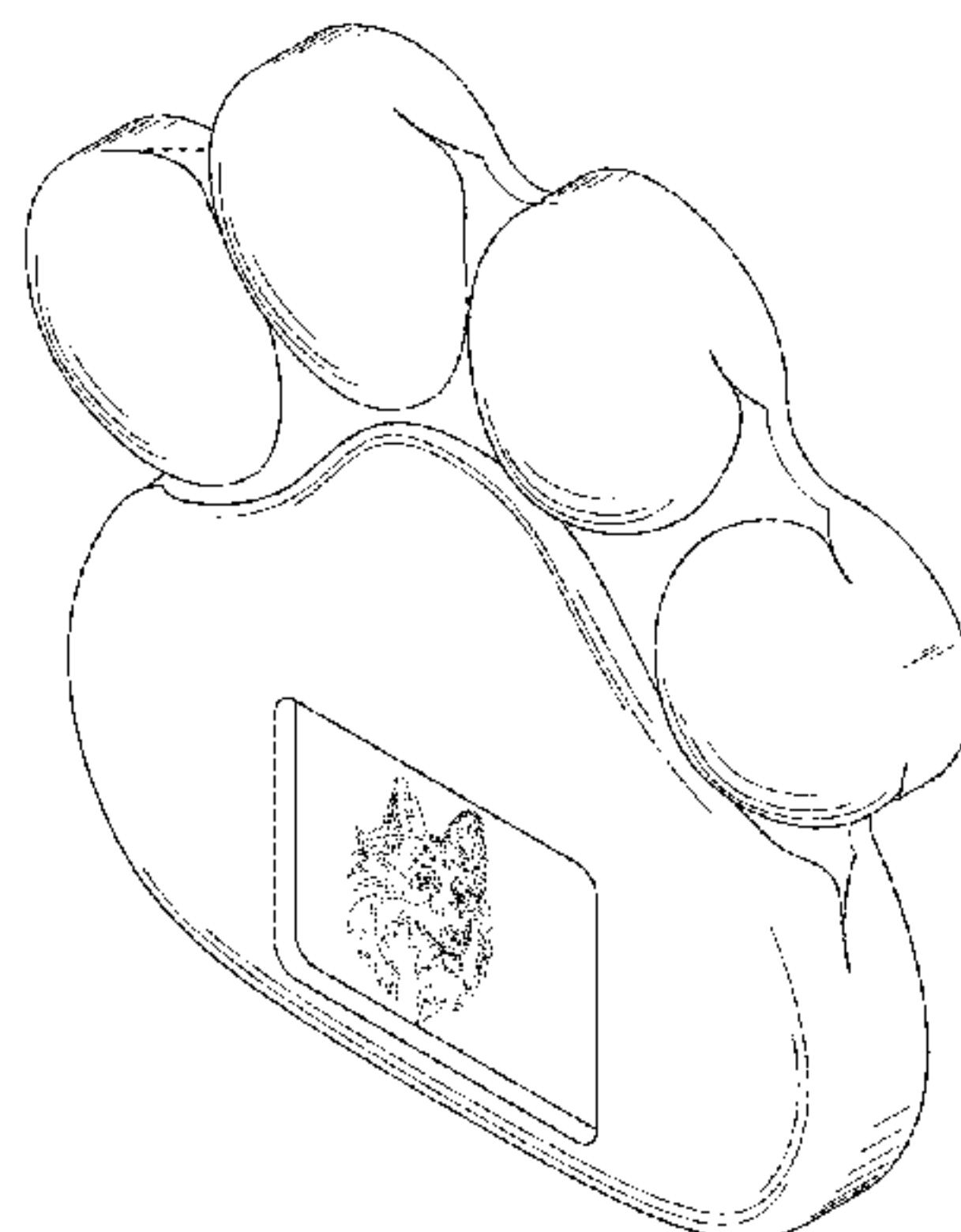
(57) **CLAIM**

The ornamental design for a memorial display case, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a memorial display case;
FIG. 2 is a front elevation view thereof, shown in use;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left side elevation view thereof, the right side elevation view being a mirror image thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.
The broken lines shown in the drawings illustrate portions of the memorial display case that form no part of the claimed design.

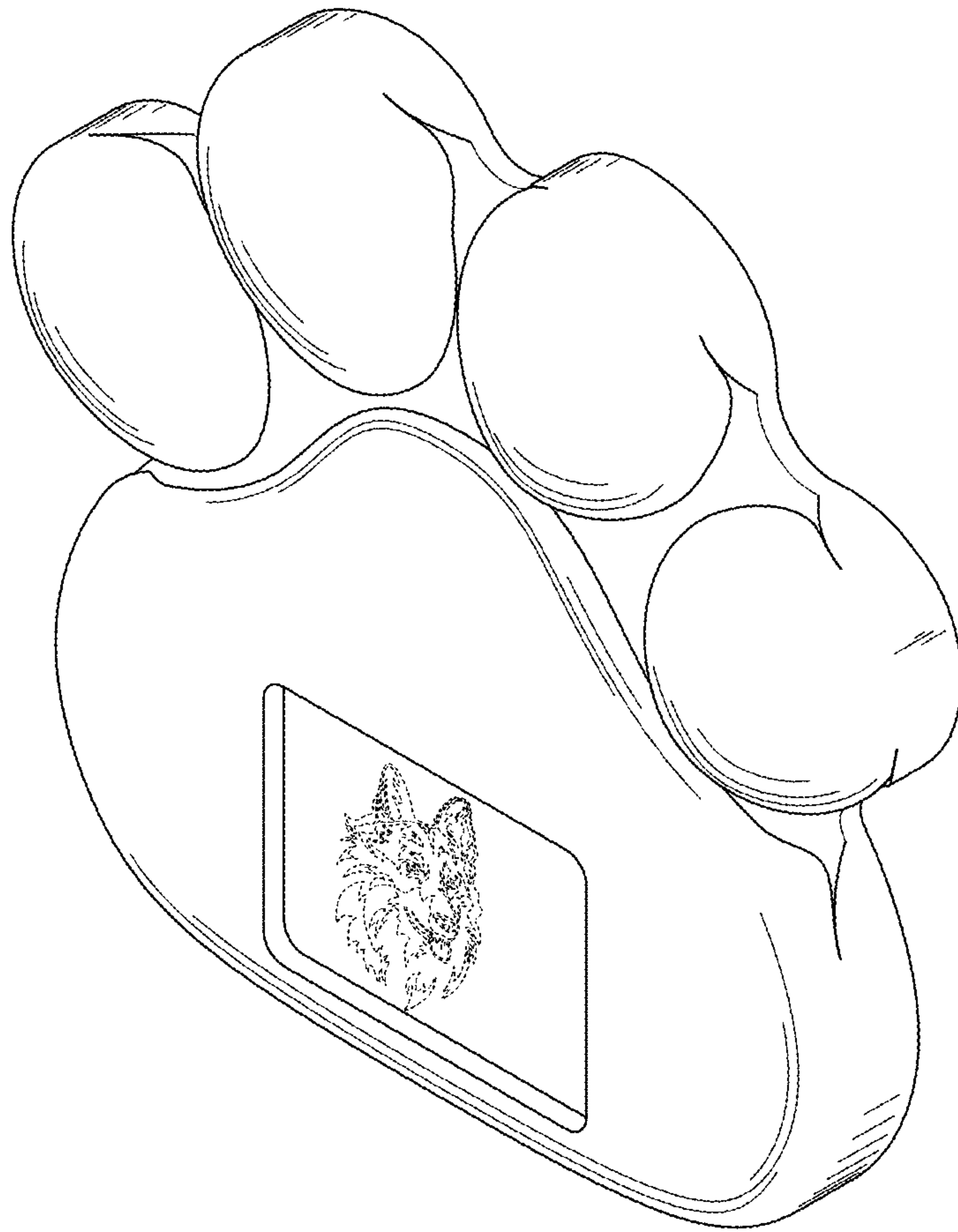

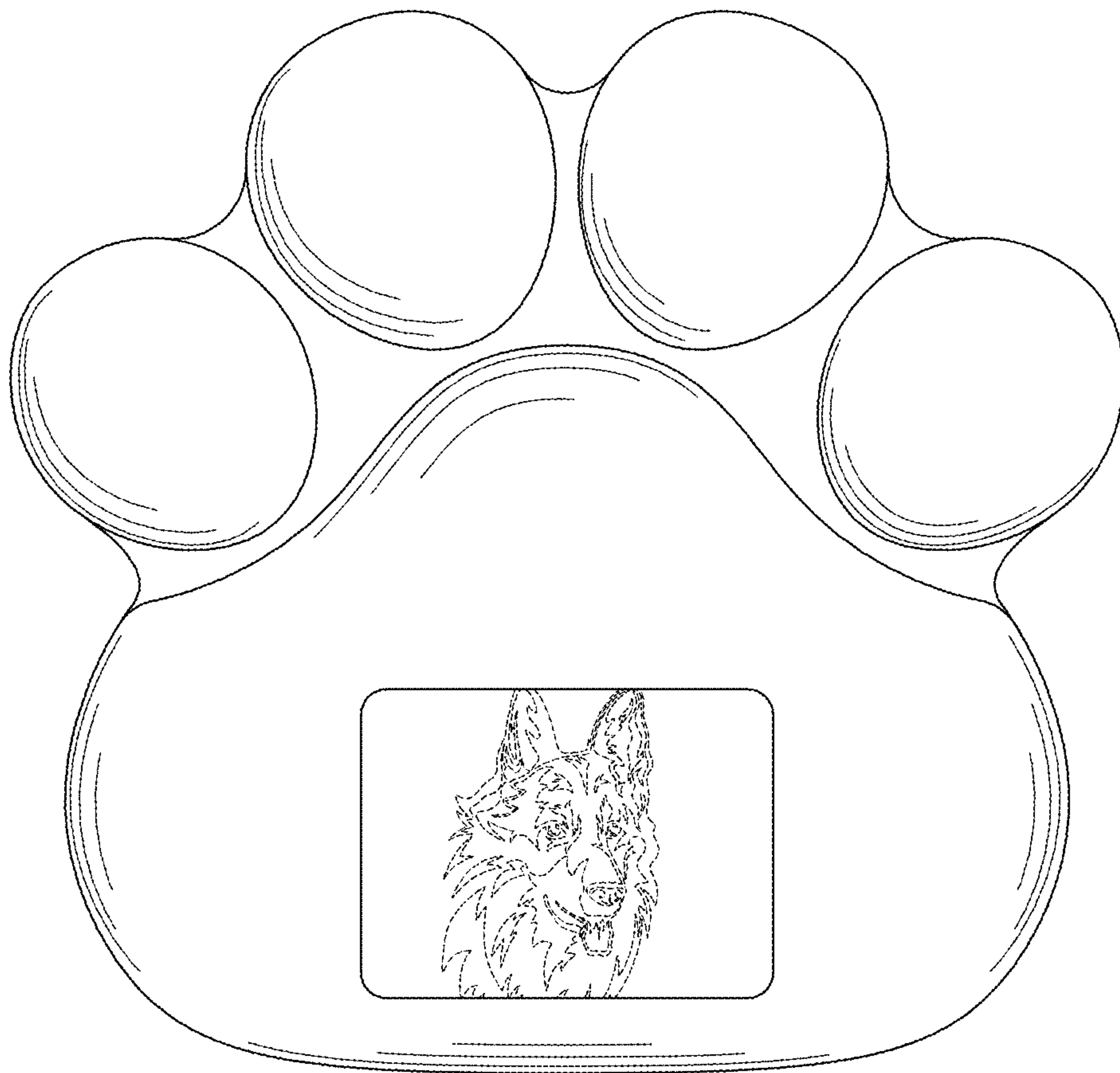

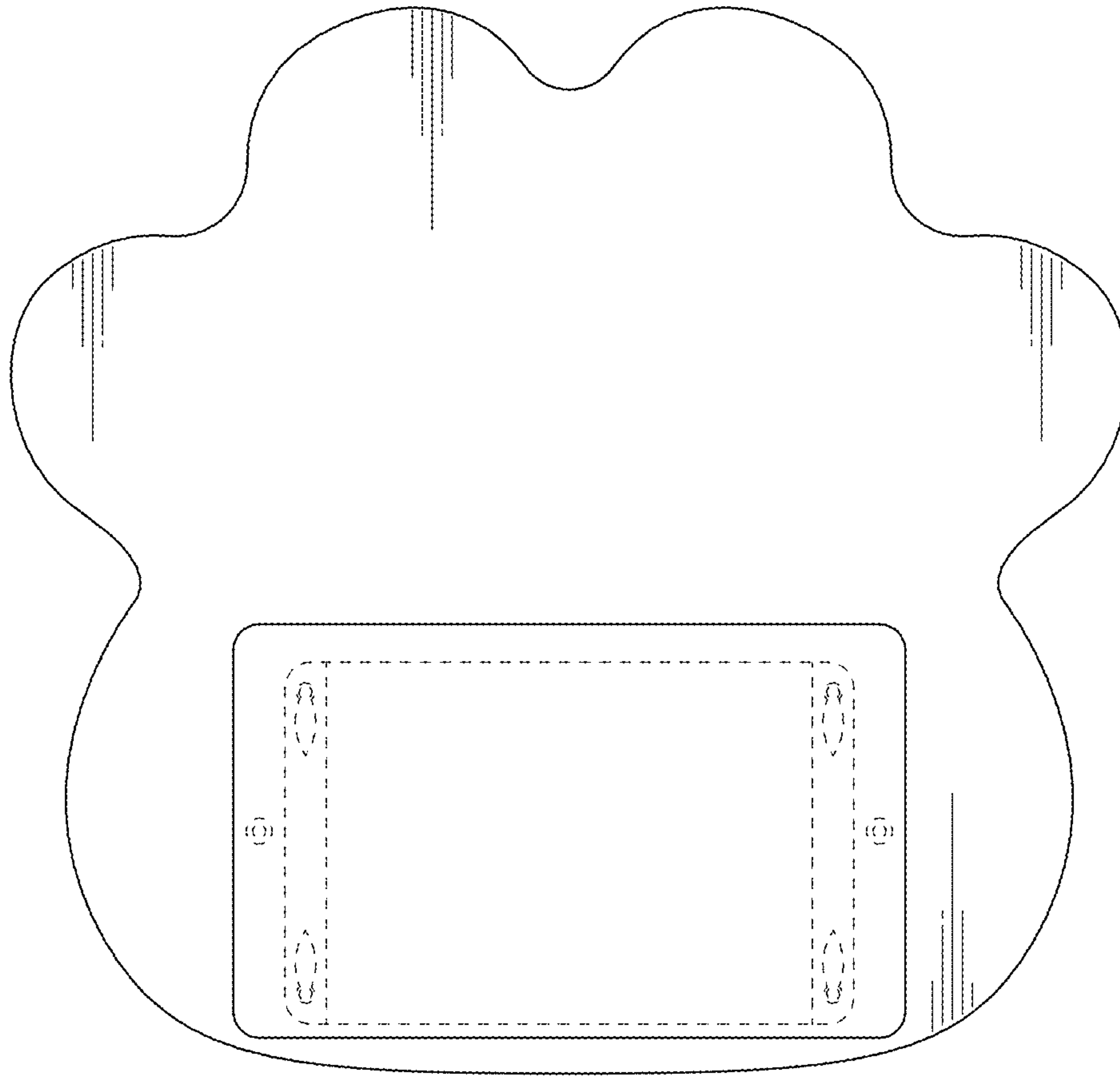

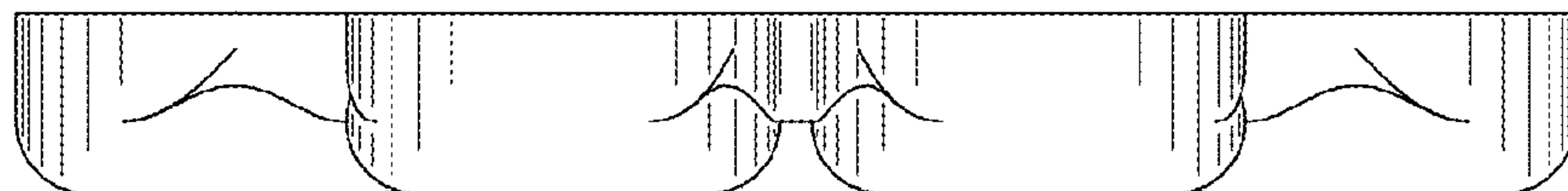
