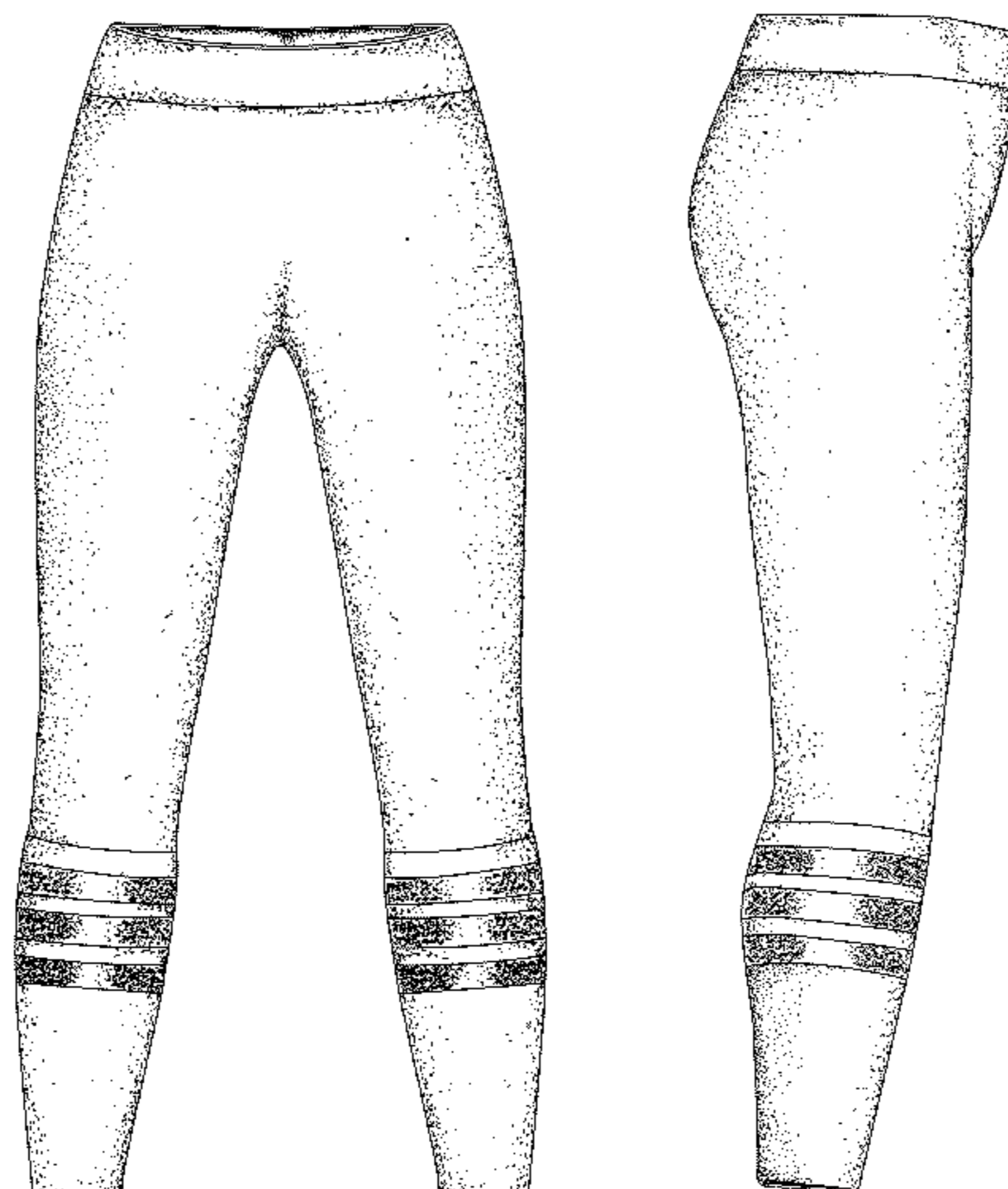
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front elevational view of a sockpants garment showing my new design;

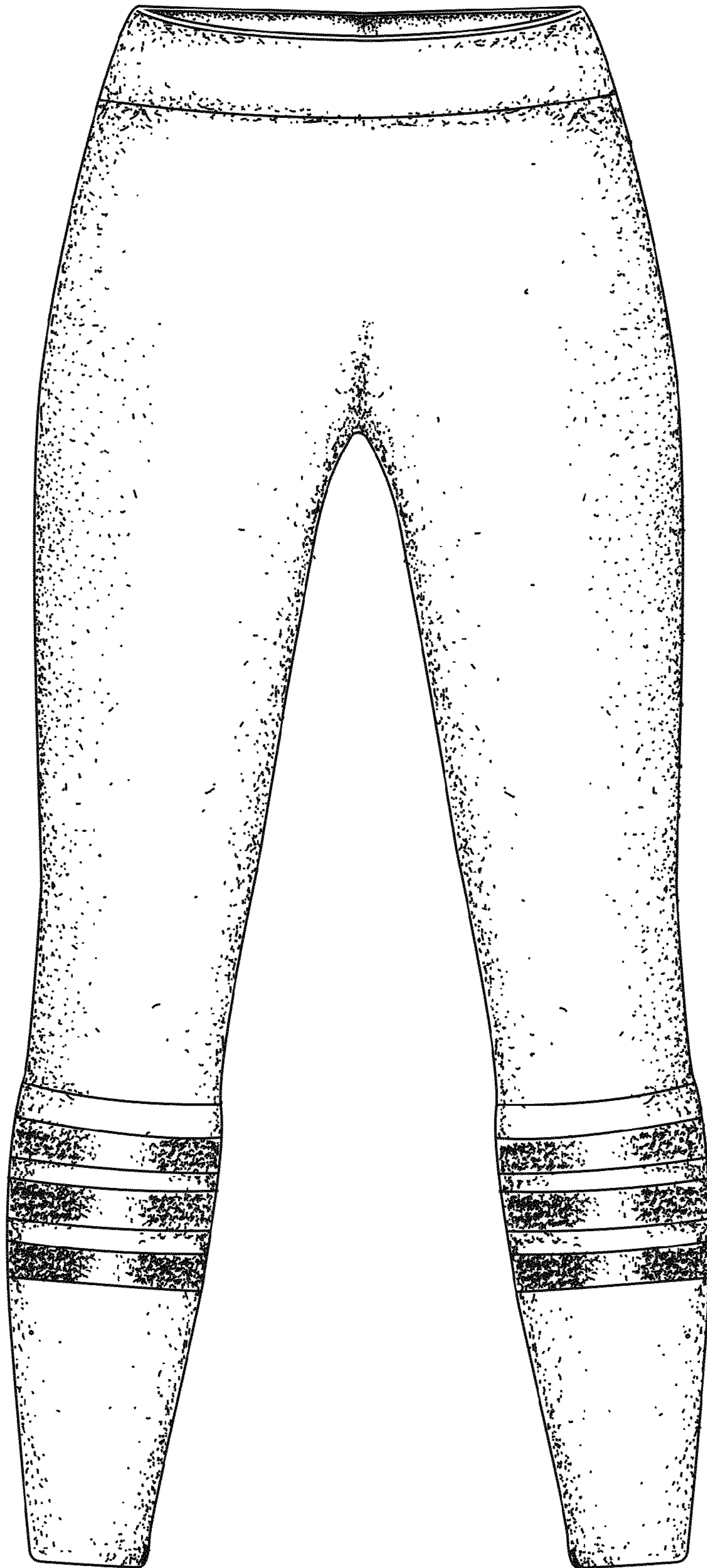

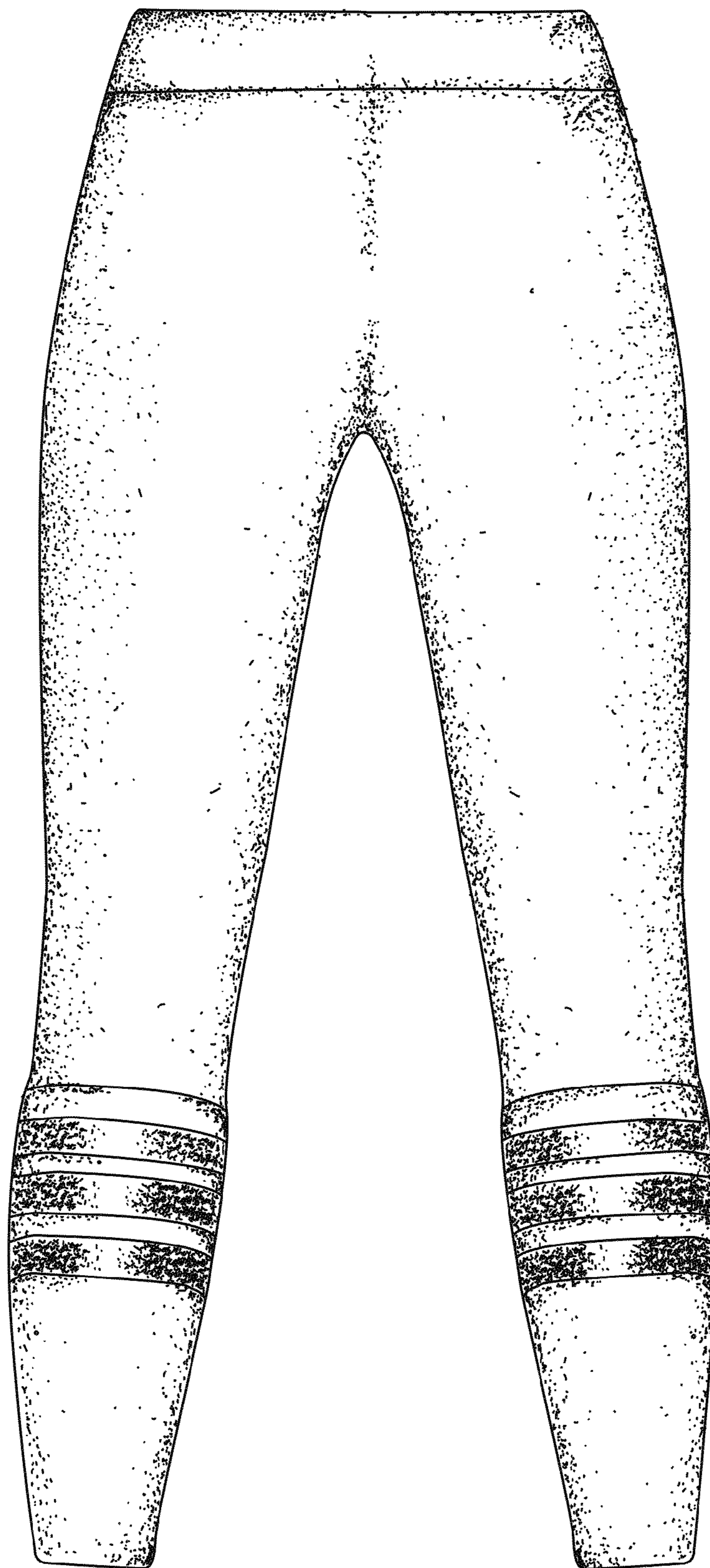

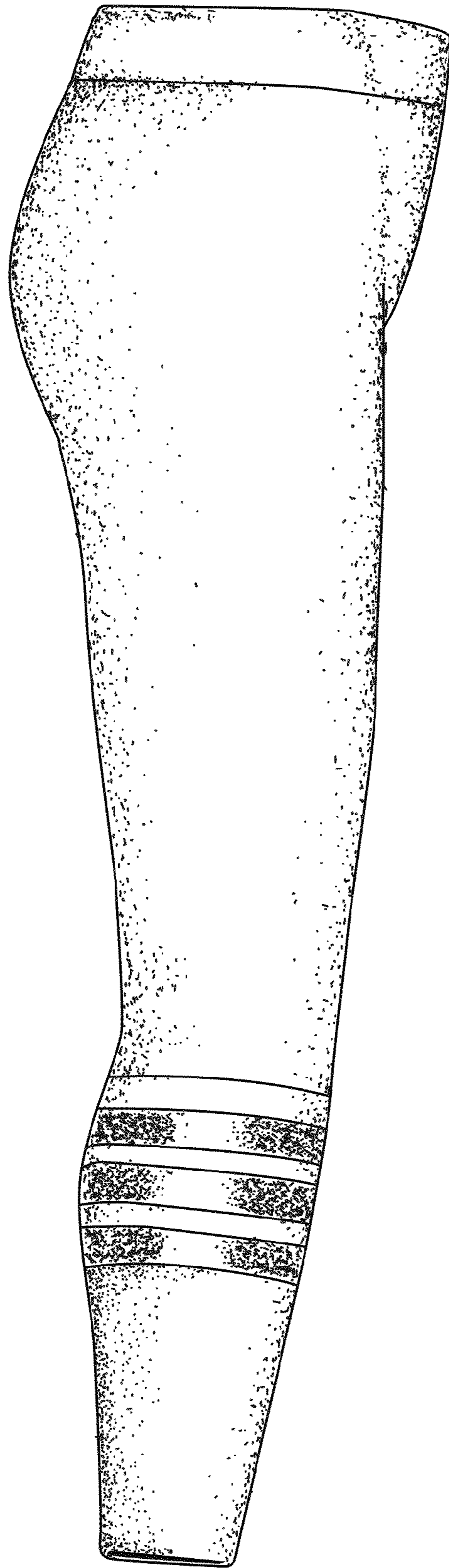

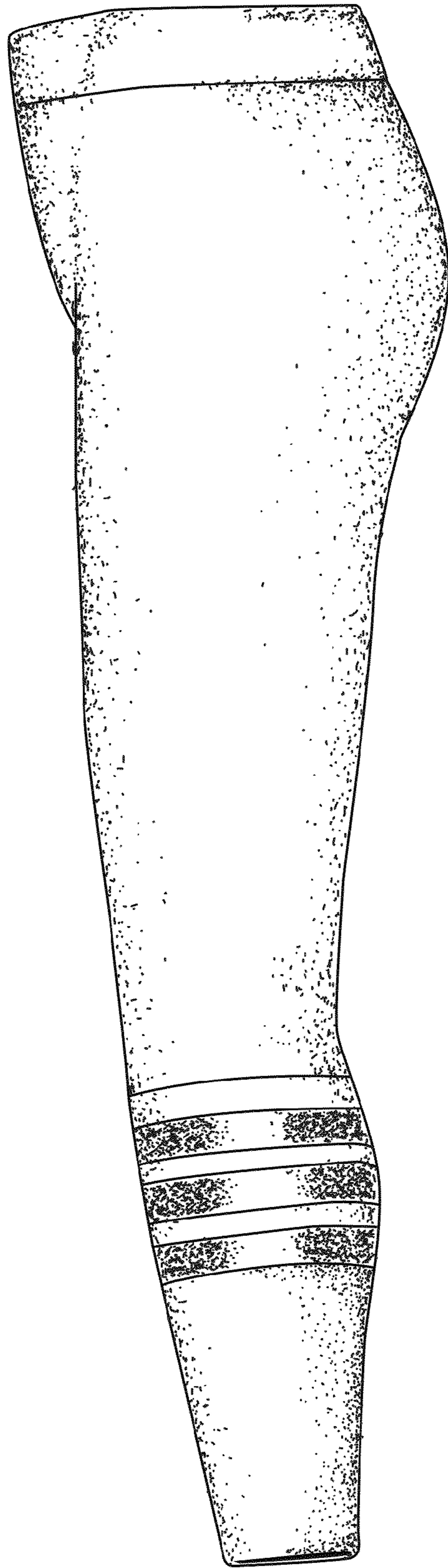

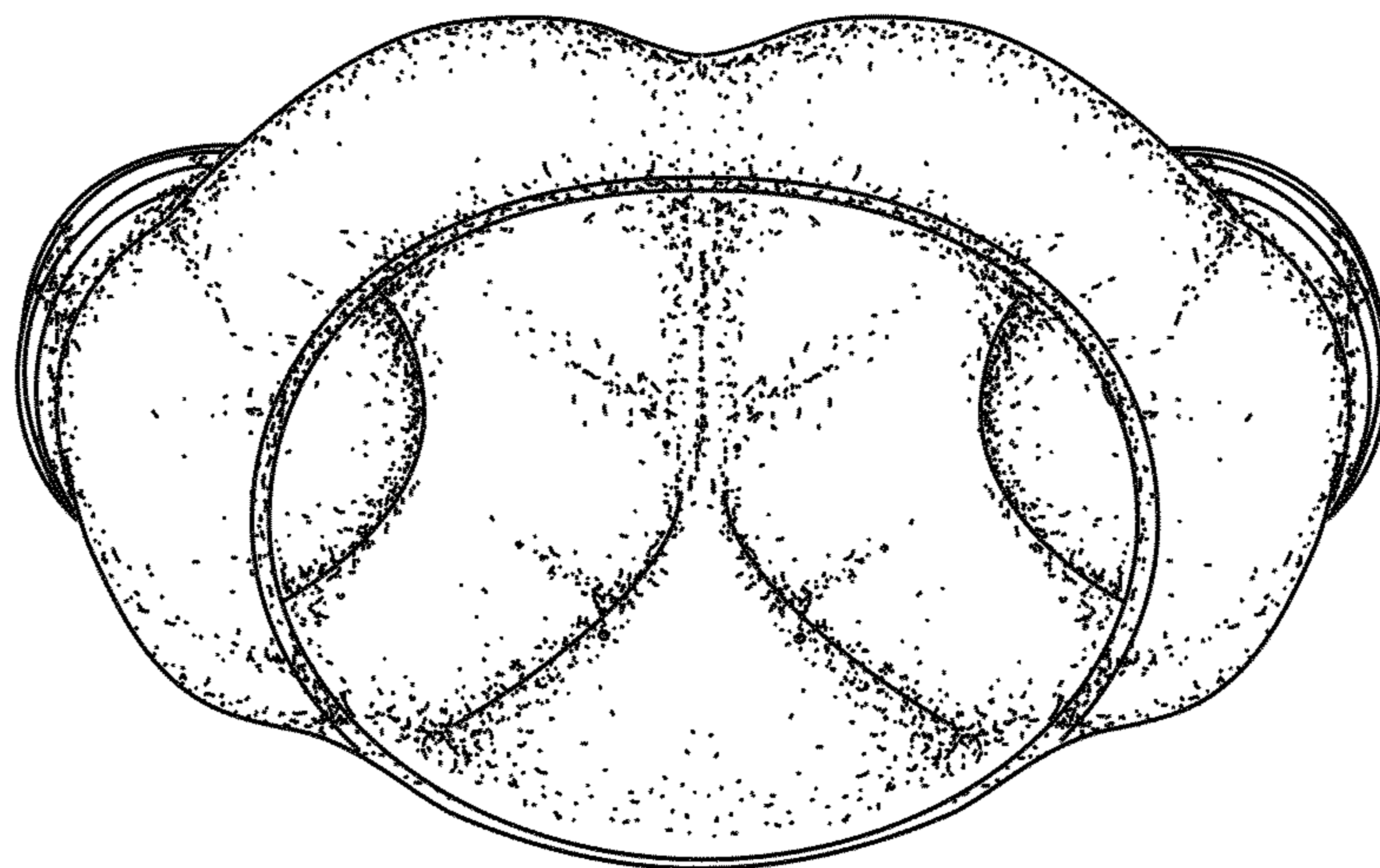

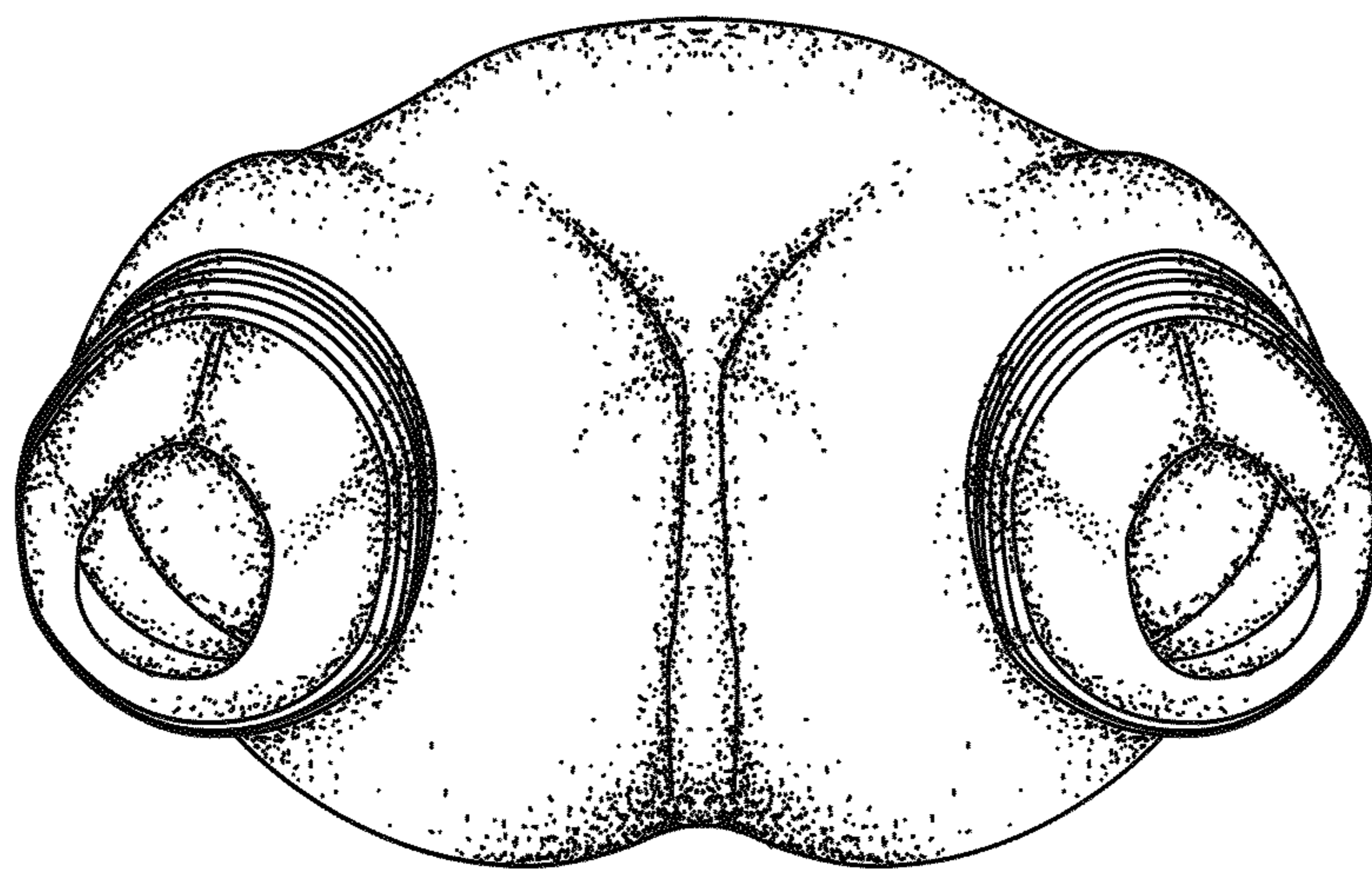

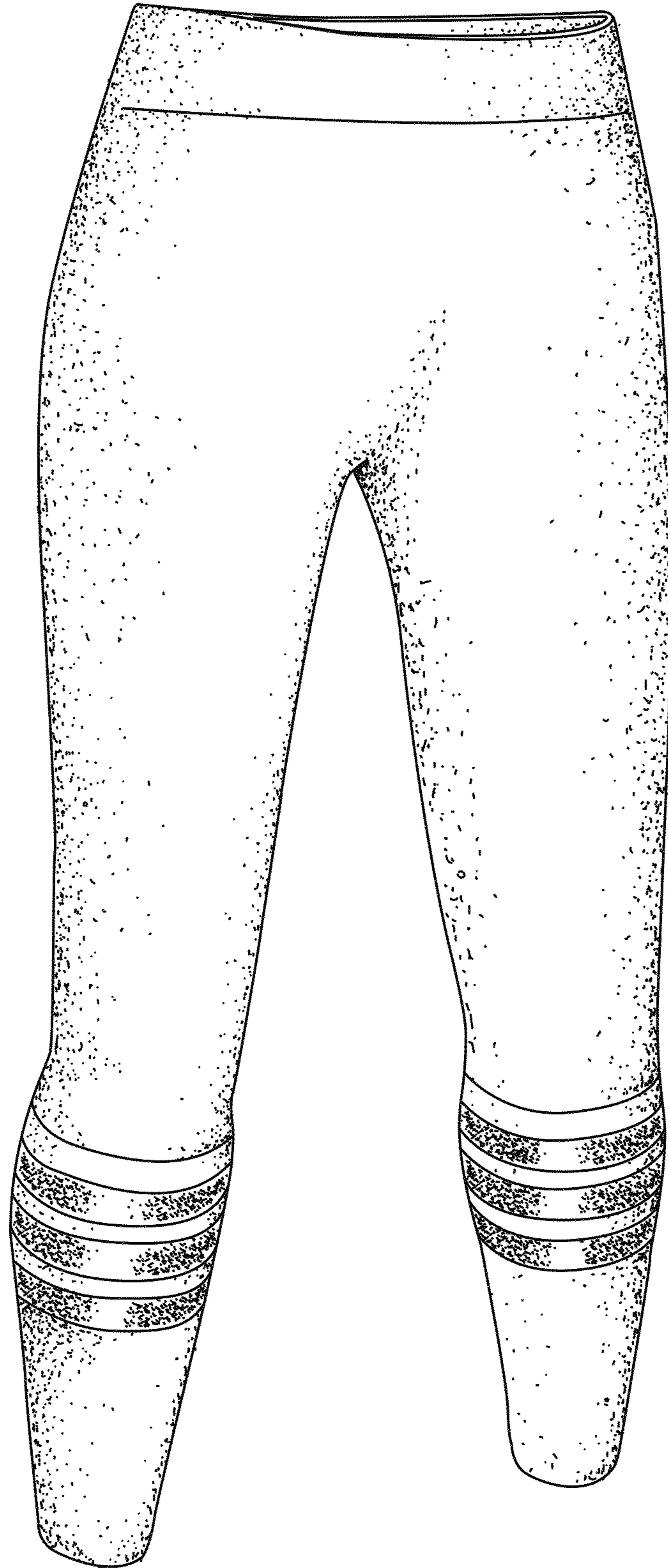
