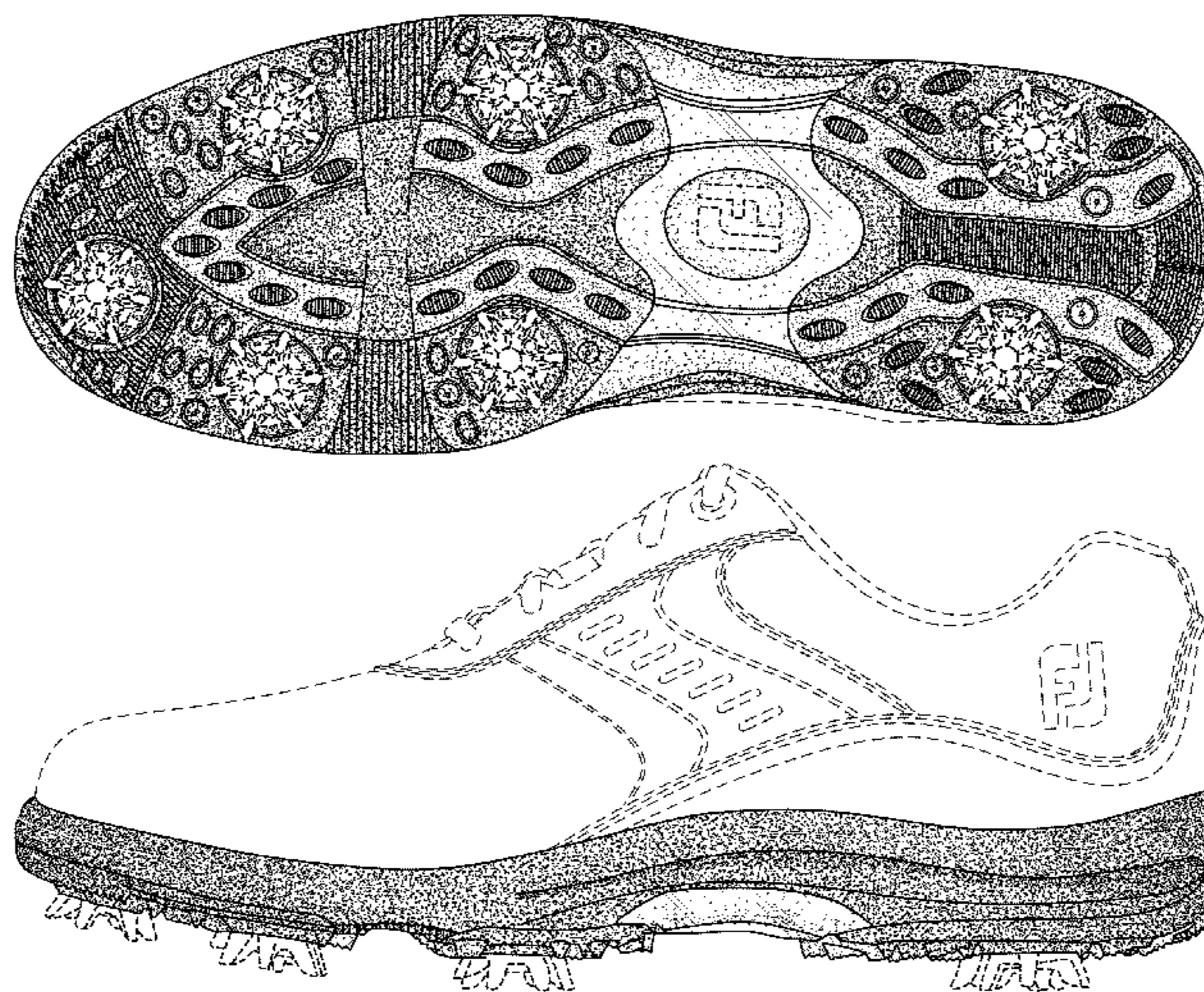
(57) **CLAIM**

The ornamental design for a golf shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of the golf shoe outsole of this invention;
FIG. 2 is a bottom plan view of the golf shoe outsole of this invention;
FIG. 3 is a lateral side elevation view of the golf shoe outsole of this invention;
FIG. 4 is a top plan view of the golf shoe outsole of this invention;
FIG. 5 is a medial side elevation view of the golf shoe outsole of this invention;
FIG. 6 is a front elevation view of the golf shoe outsole of this invention; and,
FIG. 7 is a rear elevation view of the golf shoe outsole of this invention.
In FIGS. 1-7, the broken lines showing logos and a shoe upper including a lace tightening system are for illustration purposes only and form no part of the claimed design.

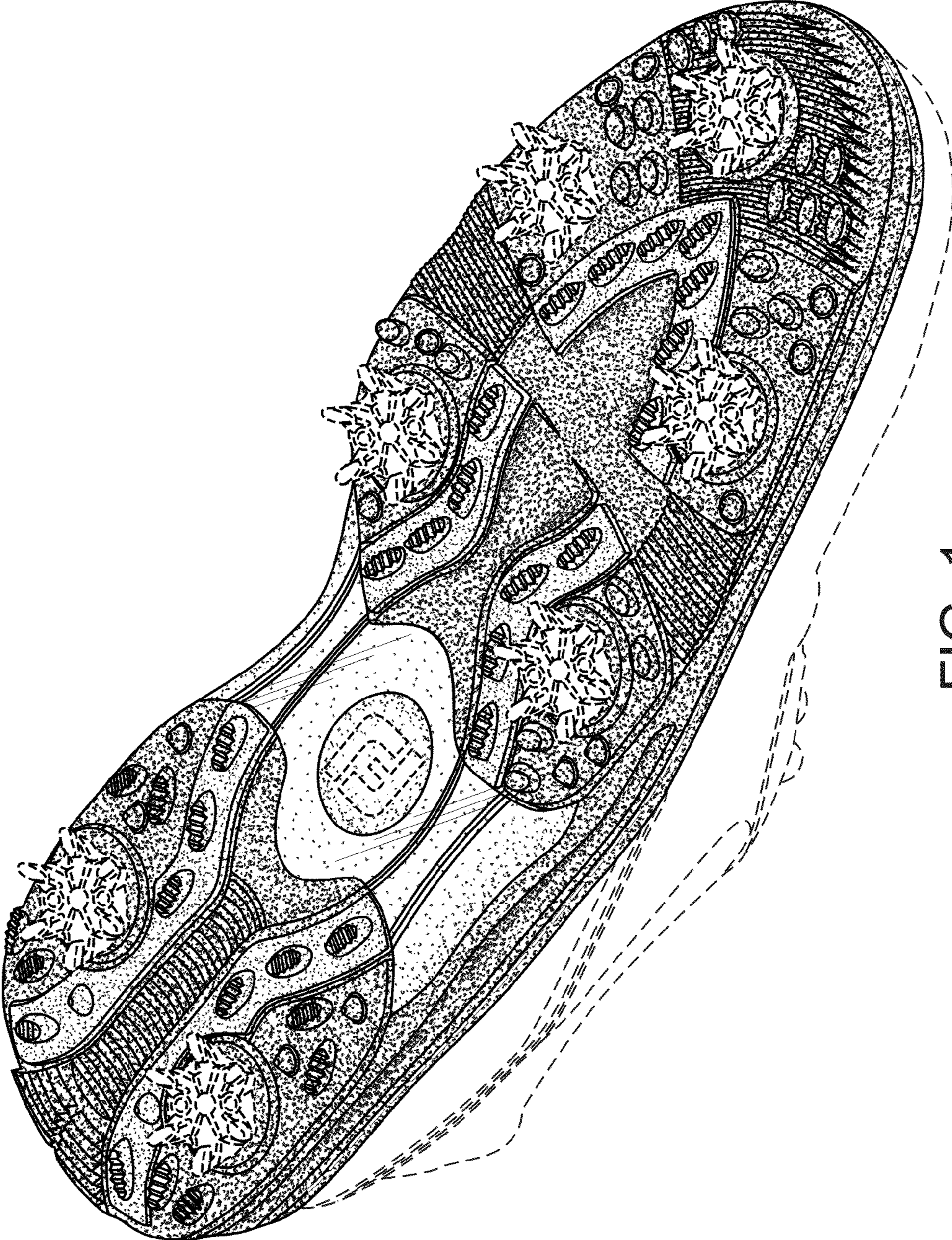

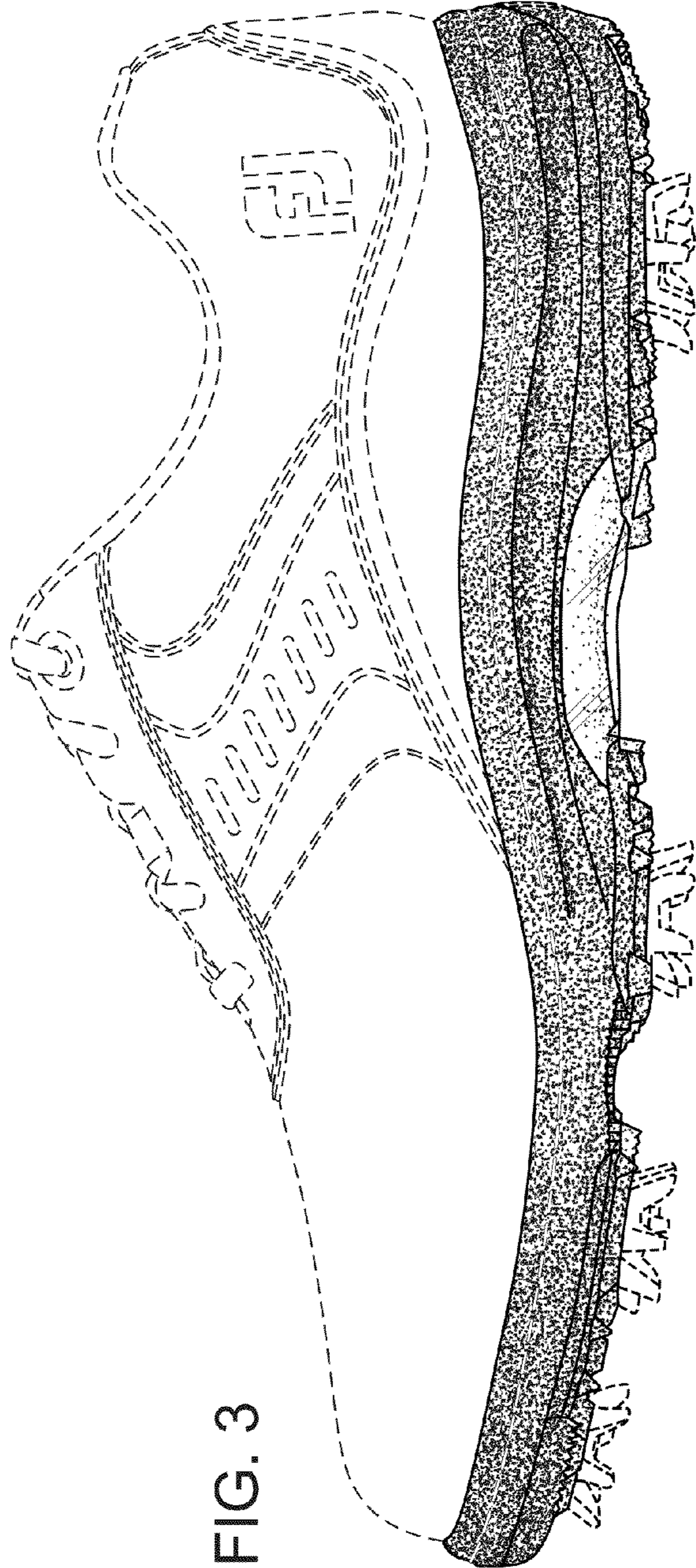
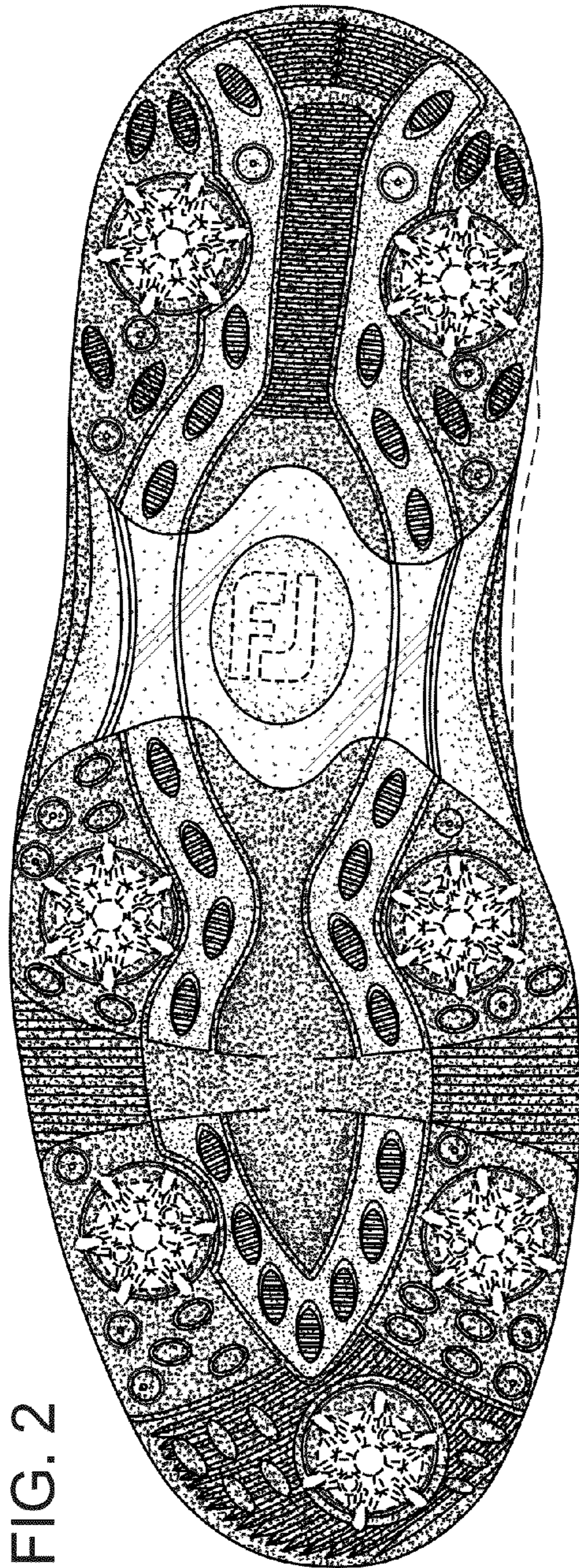

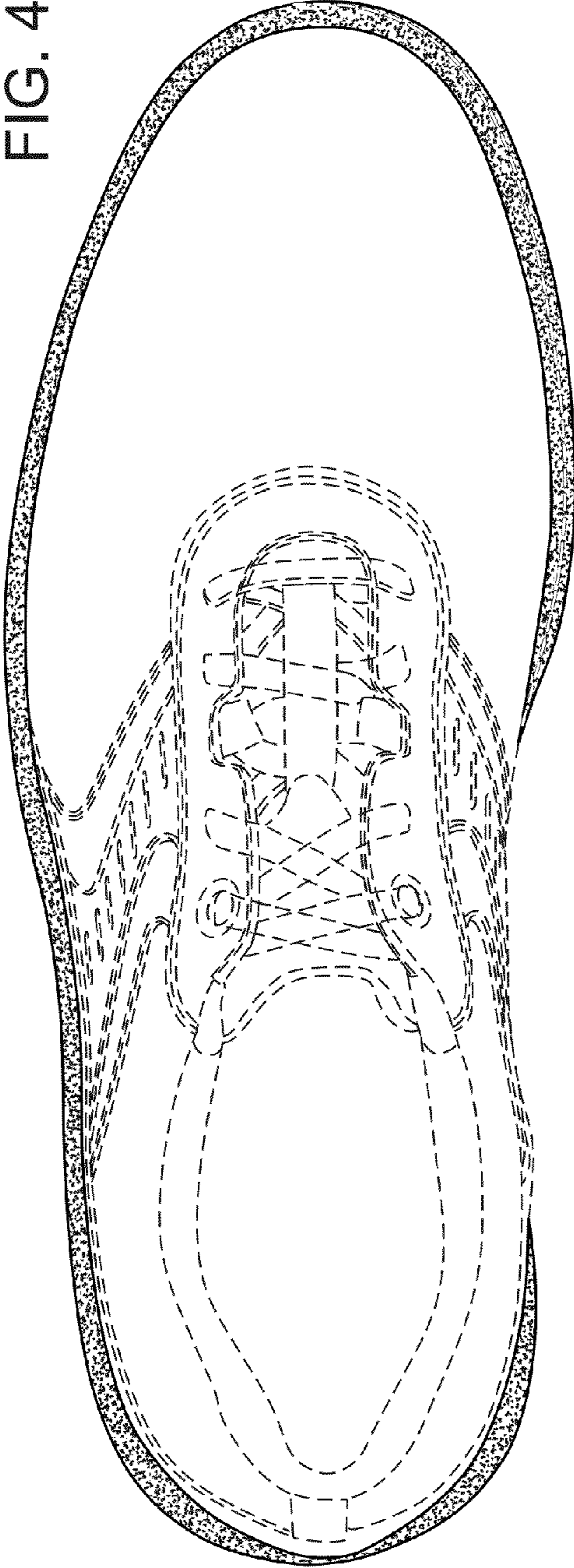
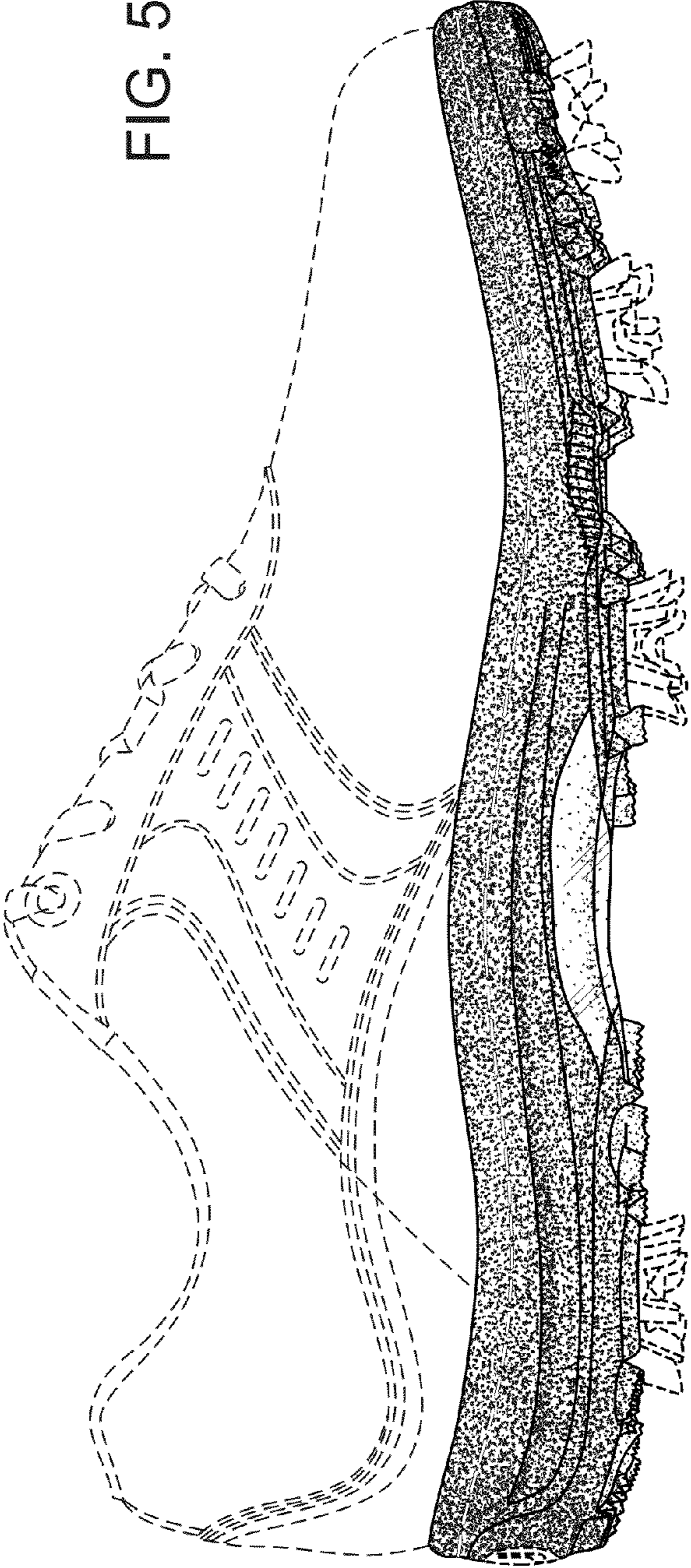

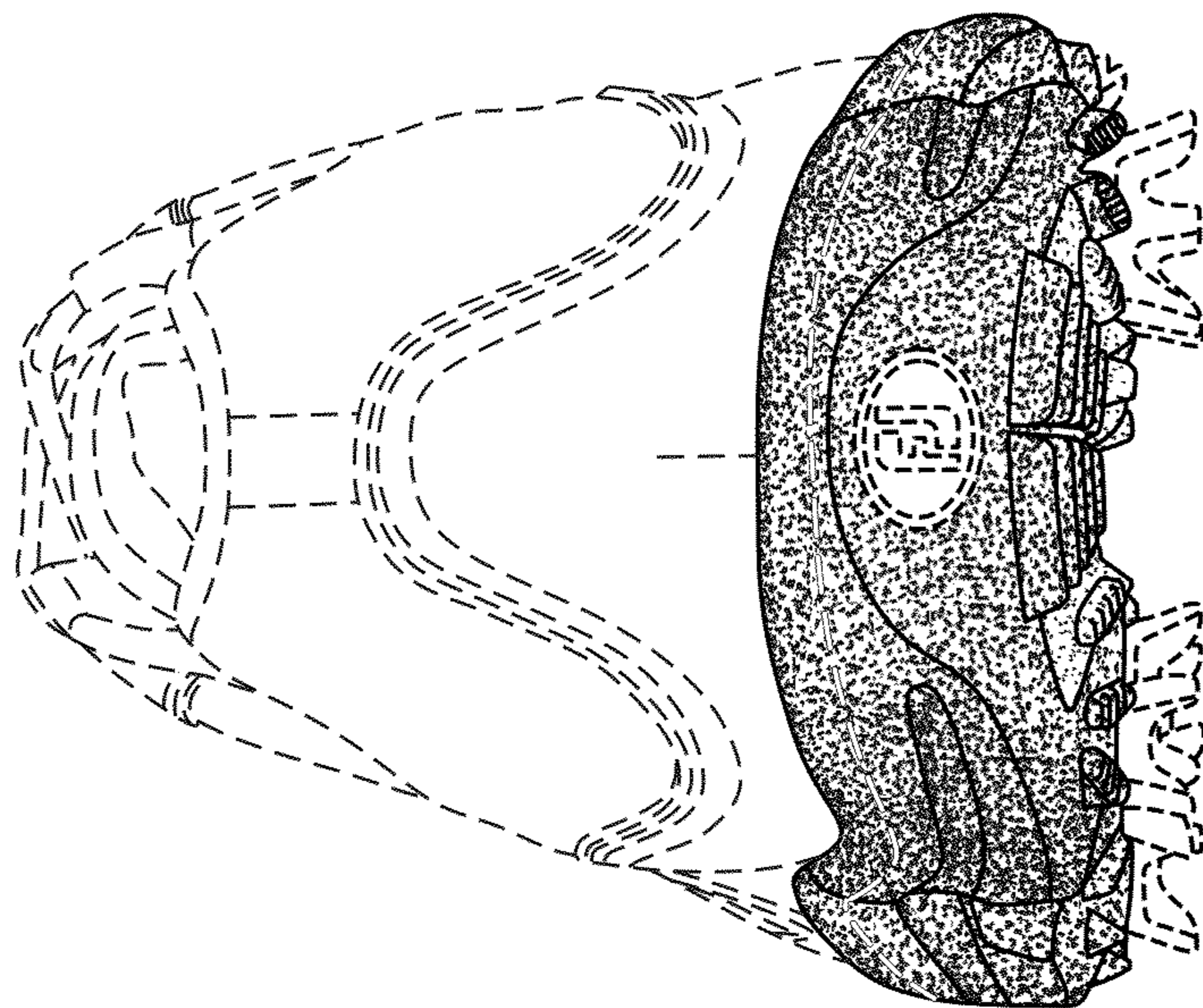

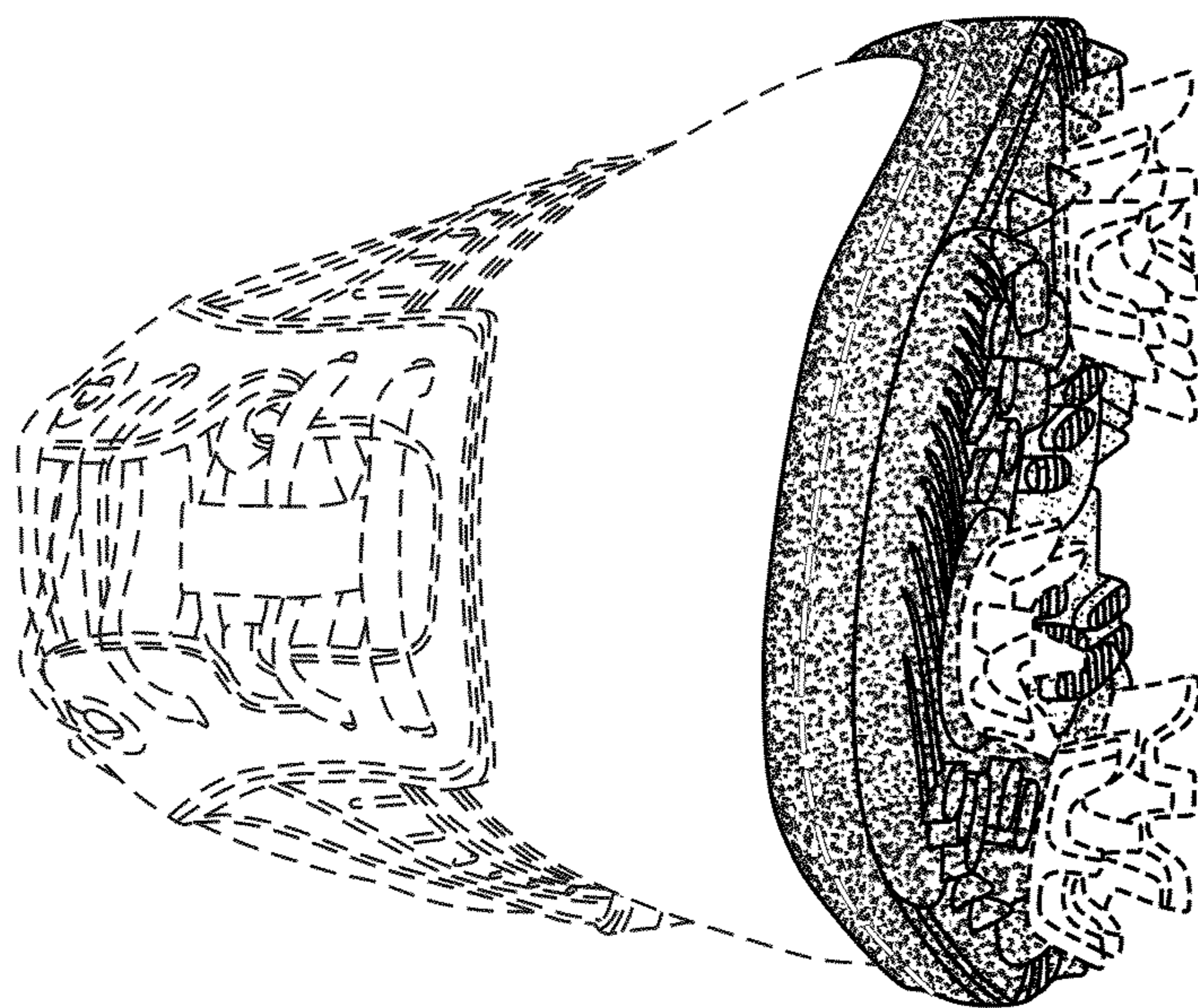
