**DESCRIPTION**

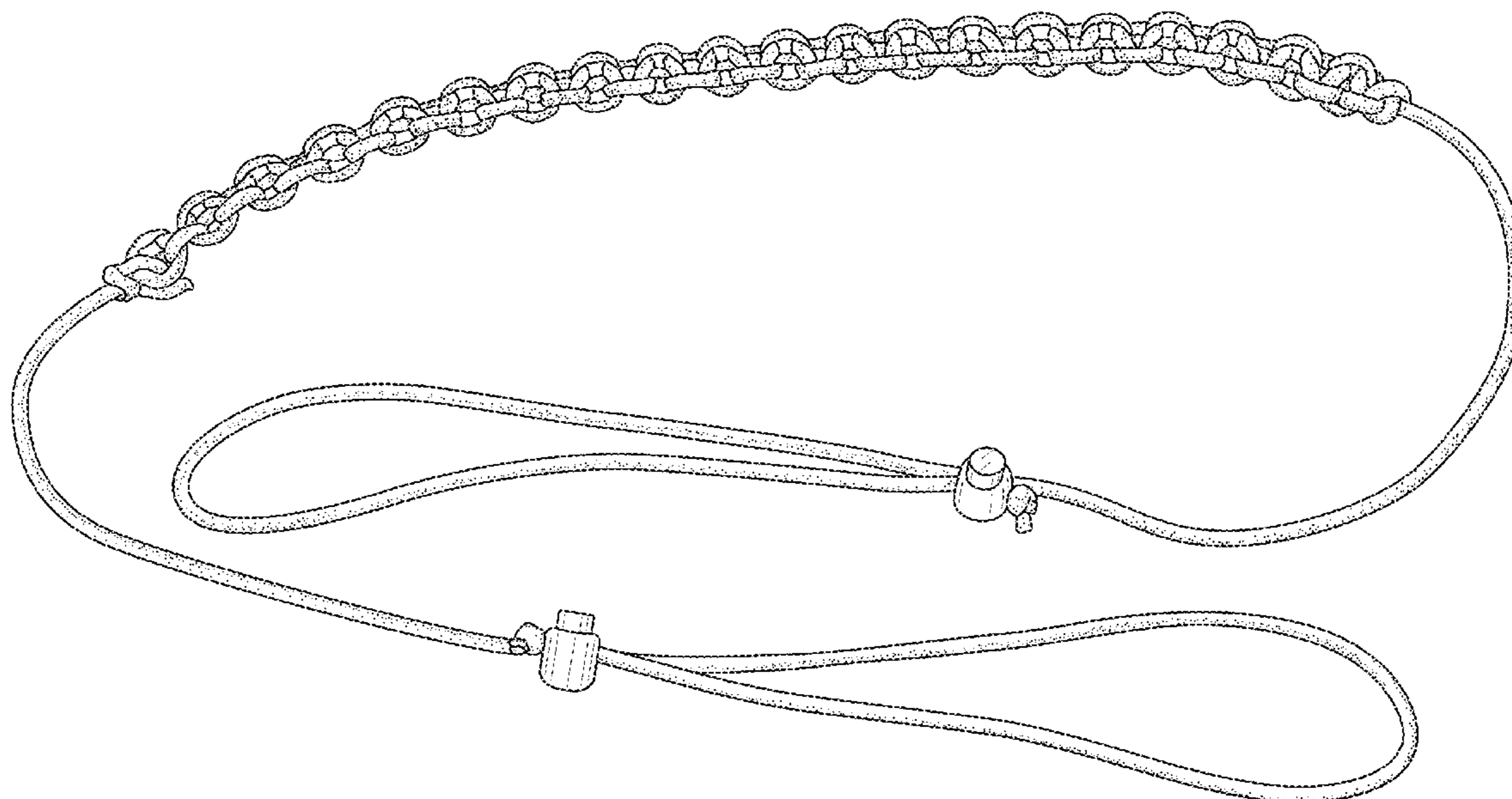
FIG. 1 is a perspective view of a yoga mat strap, showing my new design when the yoga mat strap is being used with a yoga mat;  
FIG. 2 is another perspective view of the yoga mat strap;  
FIG. 3 is an enlarged partial perspective view of a braided middle portion of the yoga mat strap; and,  
FIG. 4 is an enlarged partial perspective view of an end portion of the yoga mat strap, showing a cord lock of the yoga mat strap.

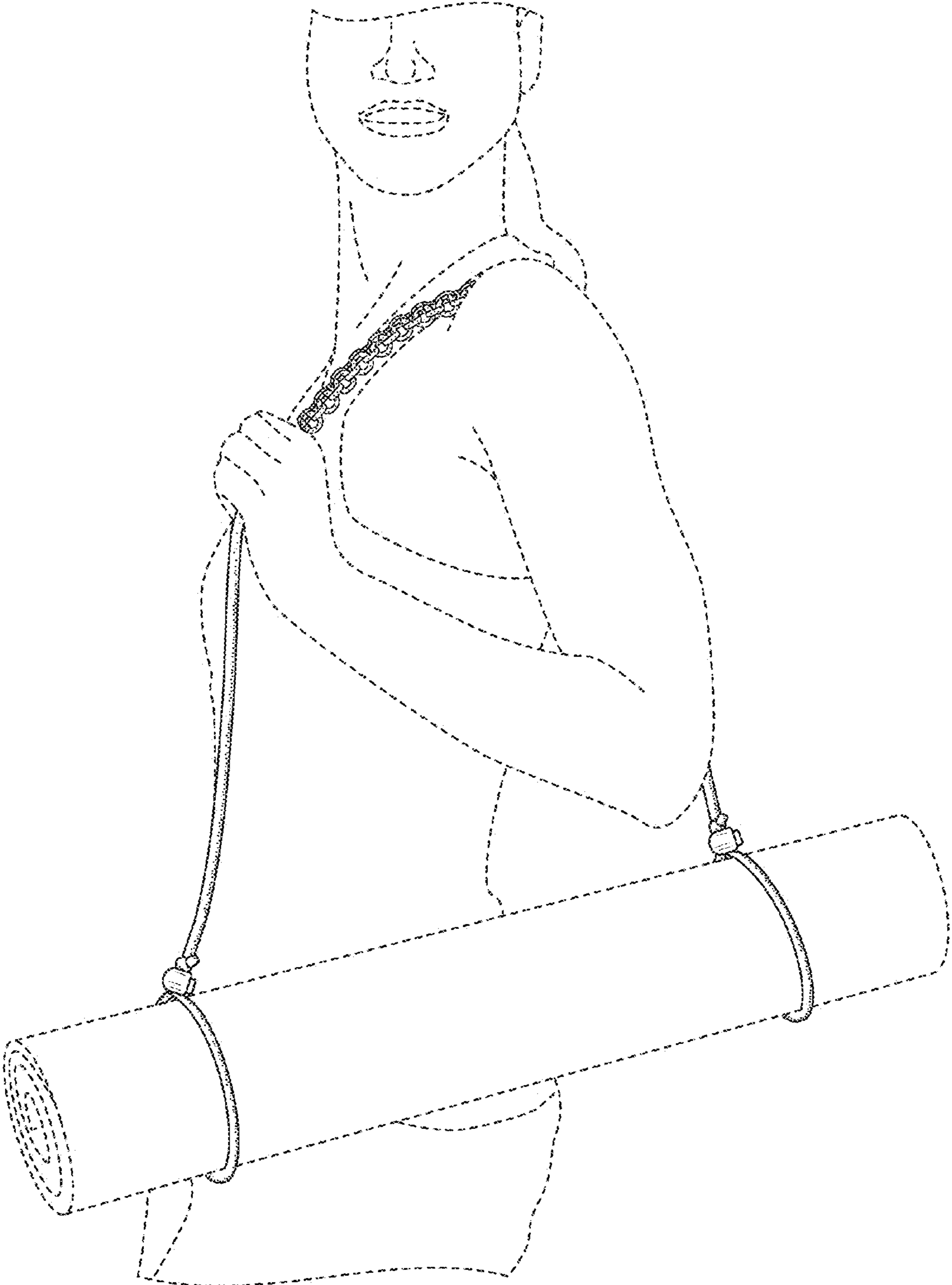

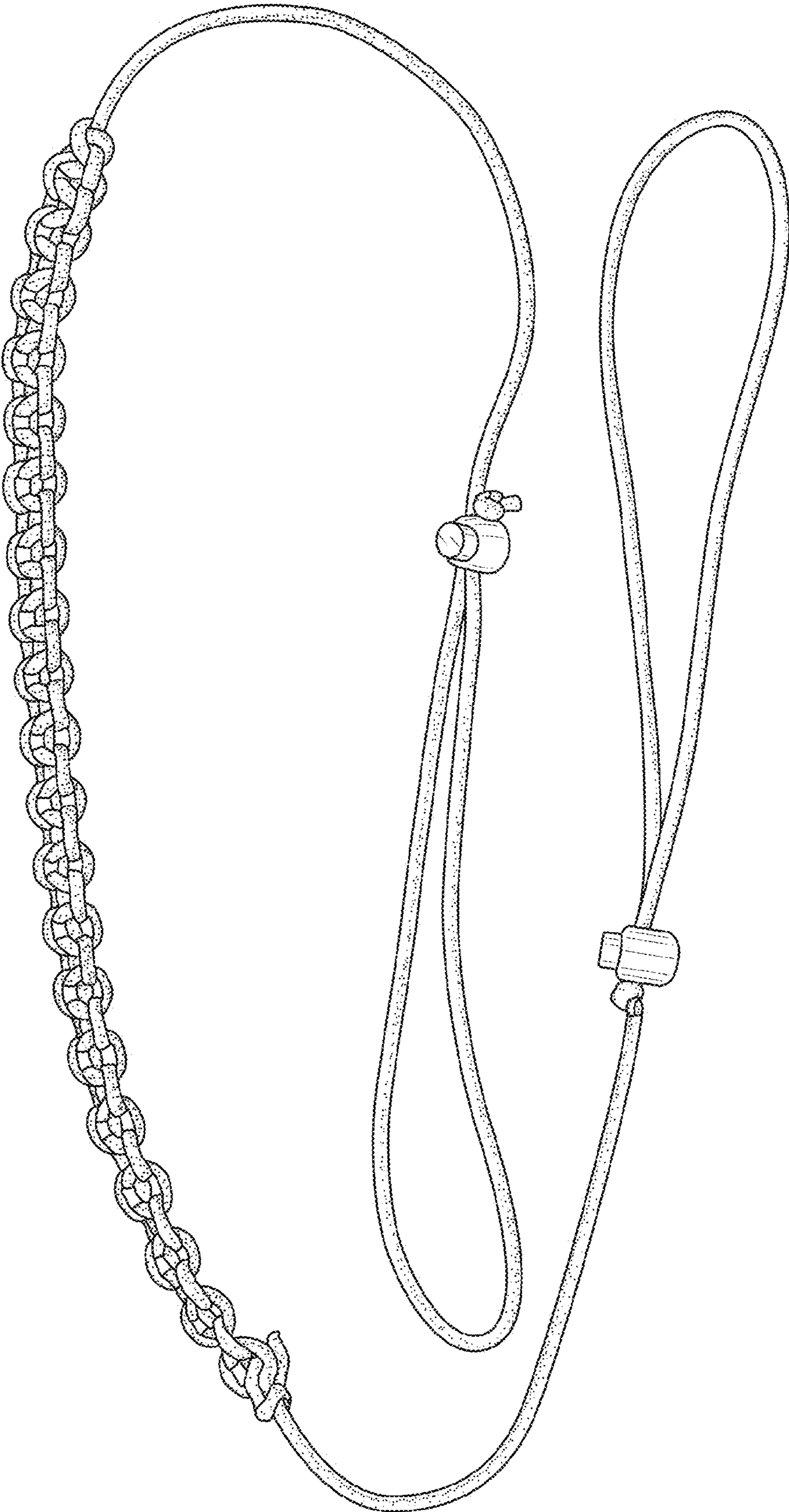

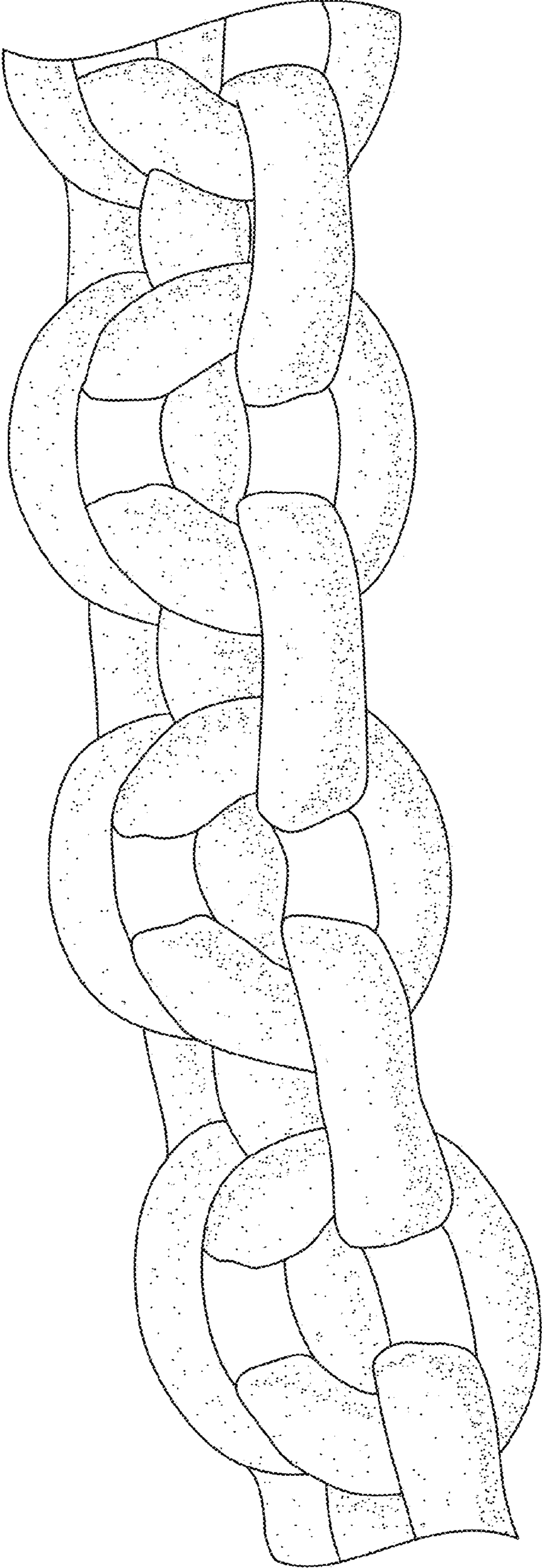

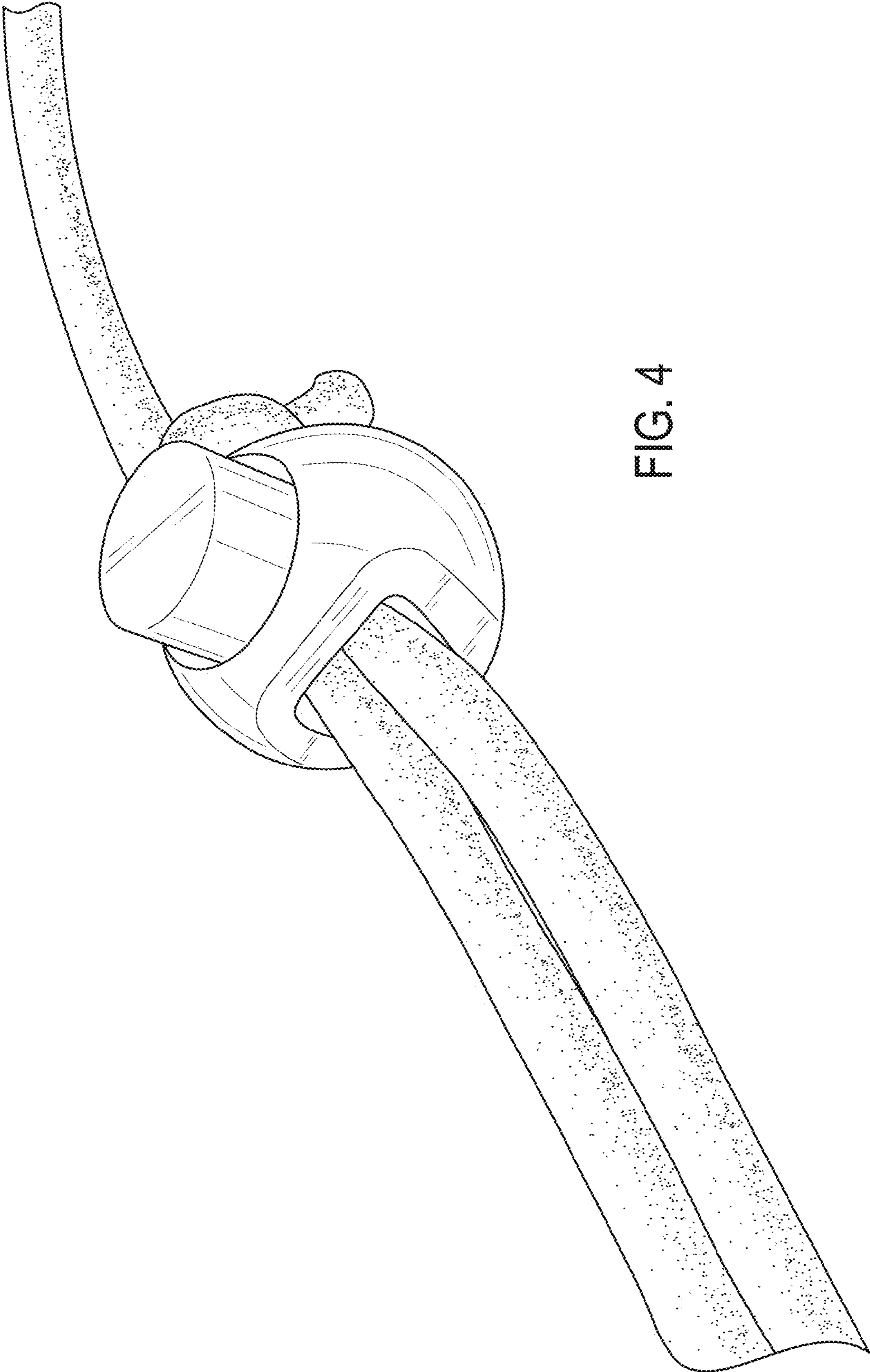
