(57) **CLAIM**

The ornamental design for an electric toothbrush, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an electric toothbrush showing my new design:

FIG. 5 is a left side elevational view thereof;

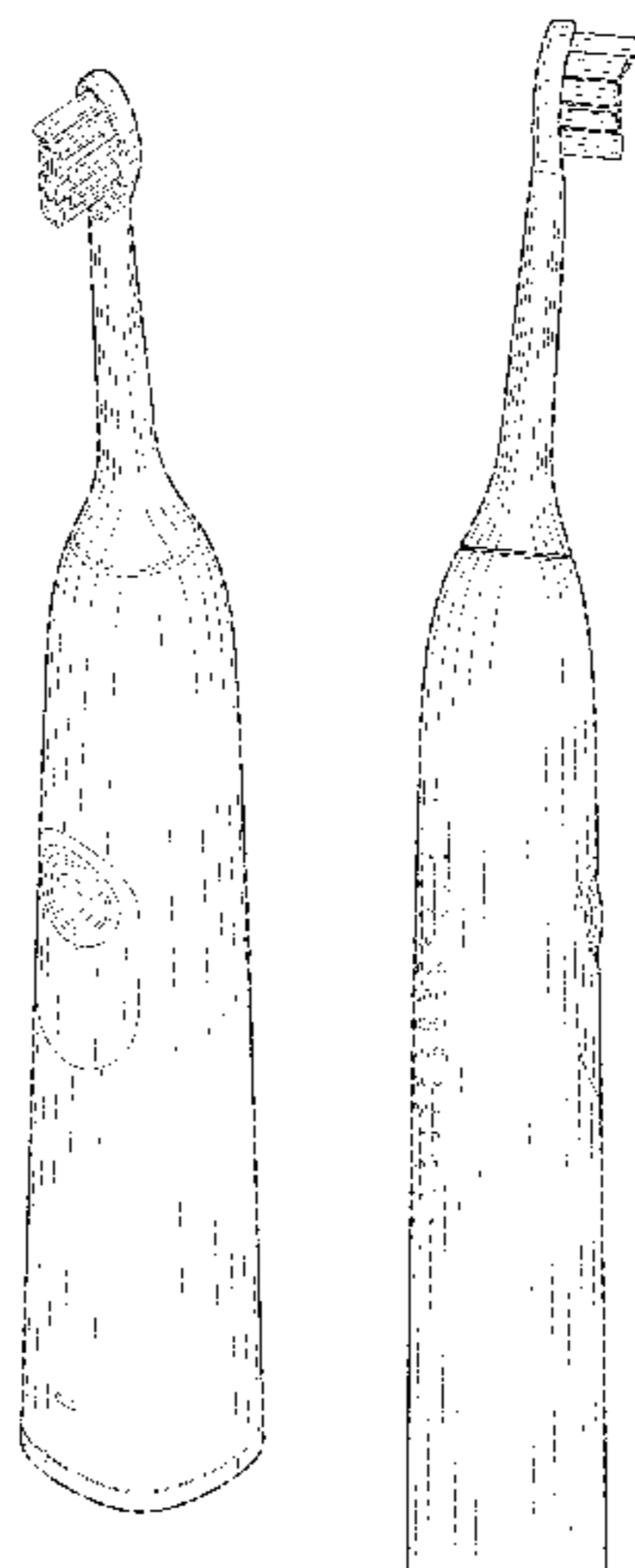
FIG. 6 is an enlarged top plan view thereof; and,

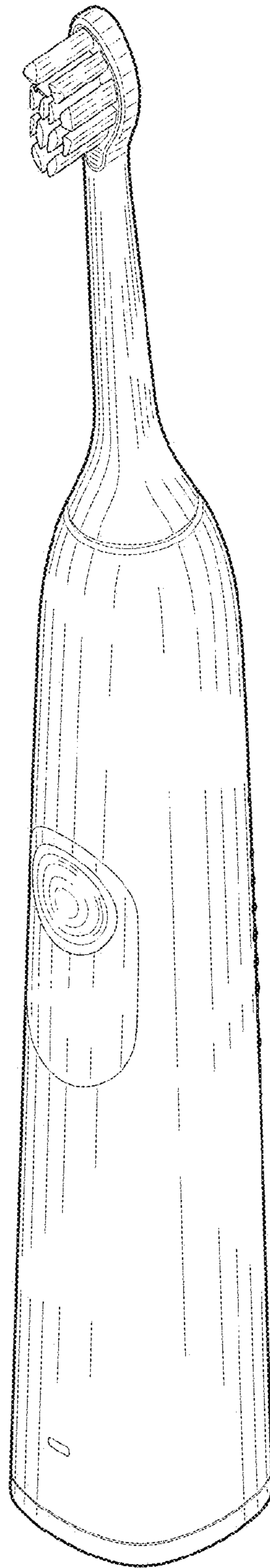

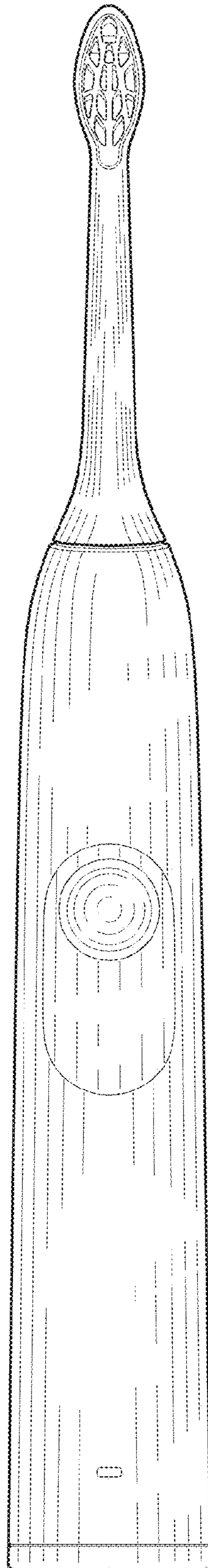

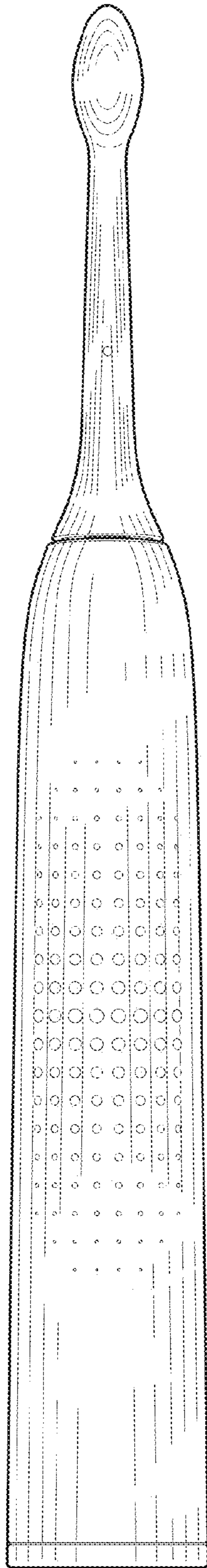

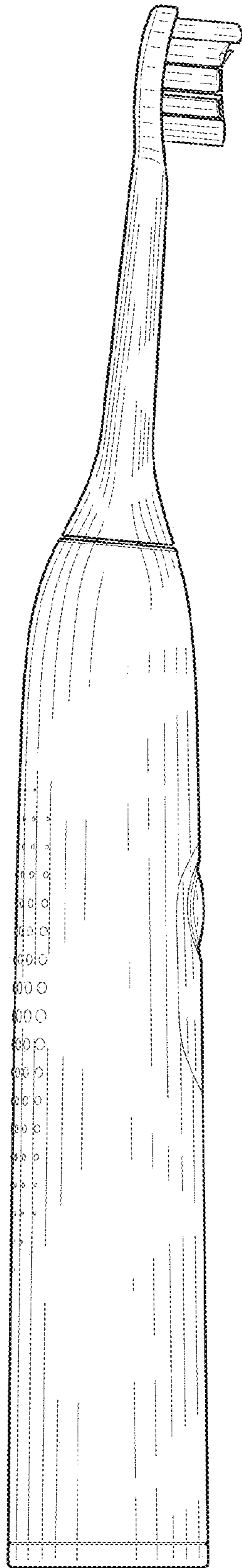

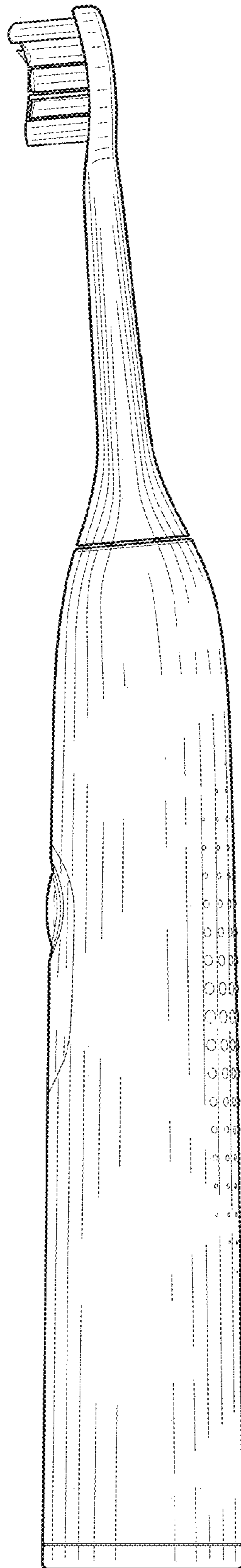

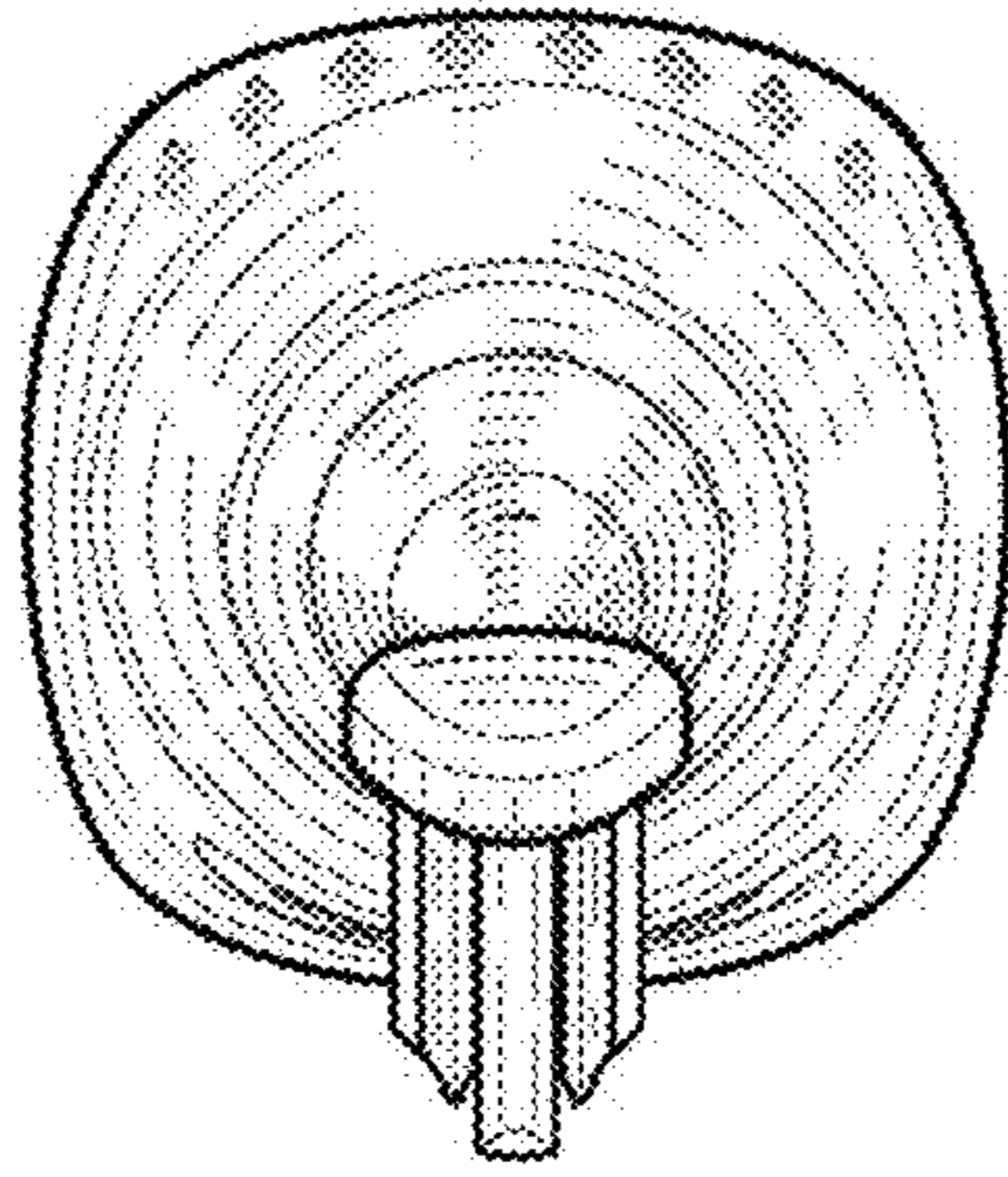

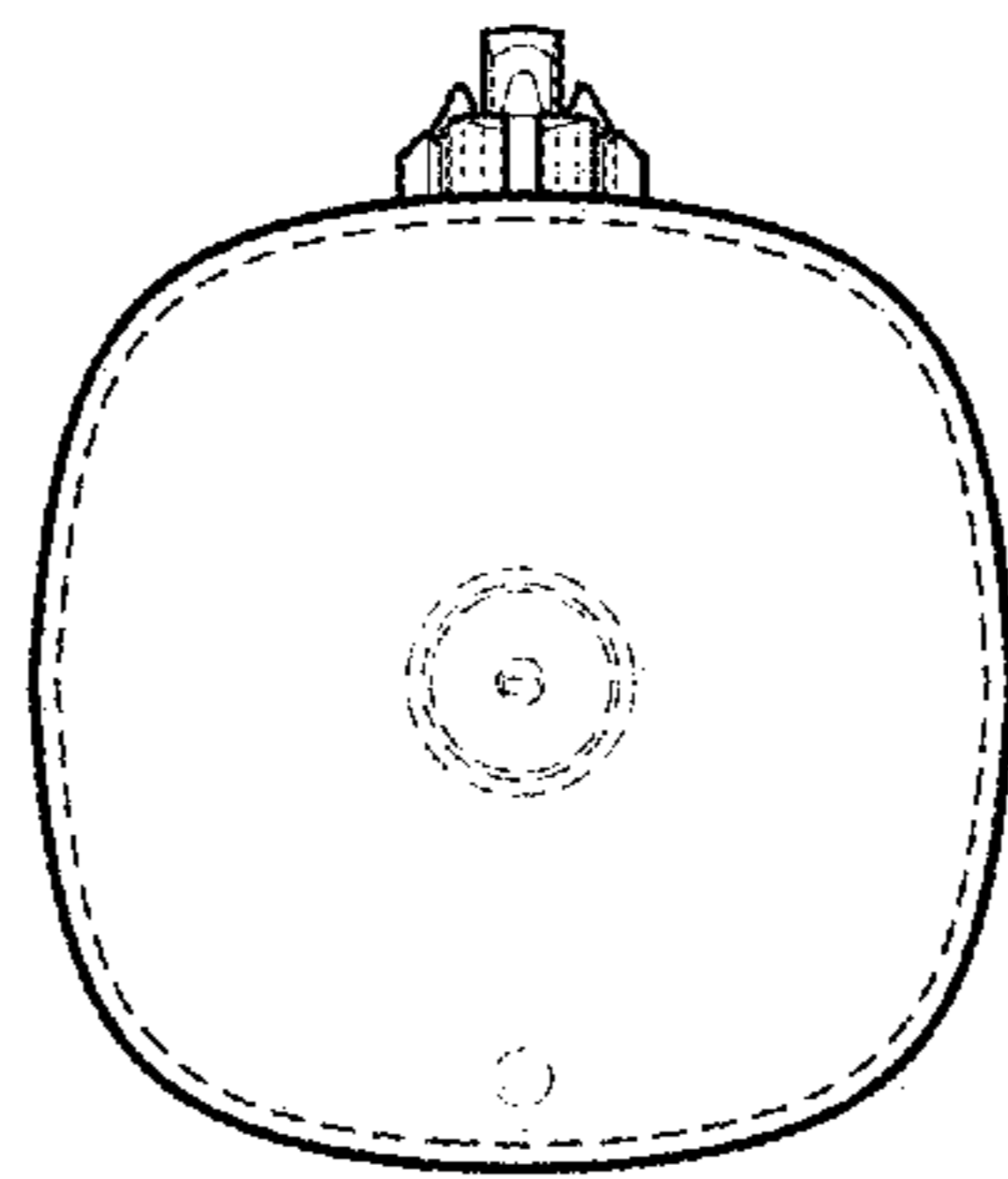
