(57) **CLAIM**

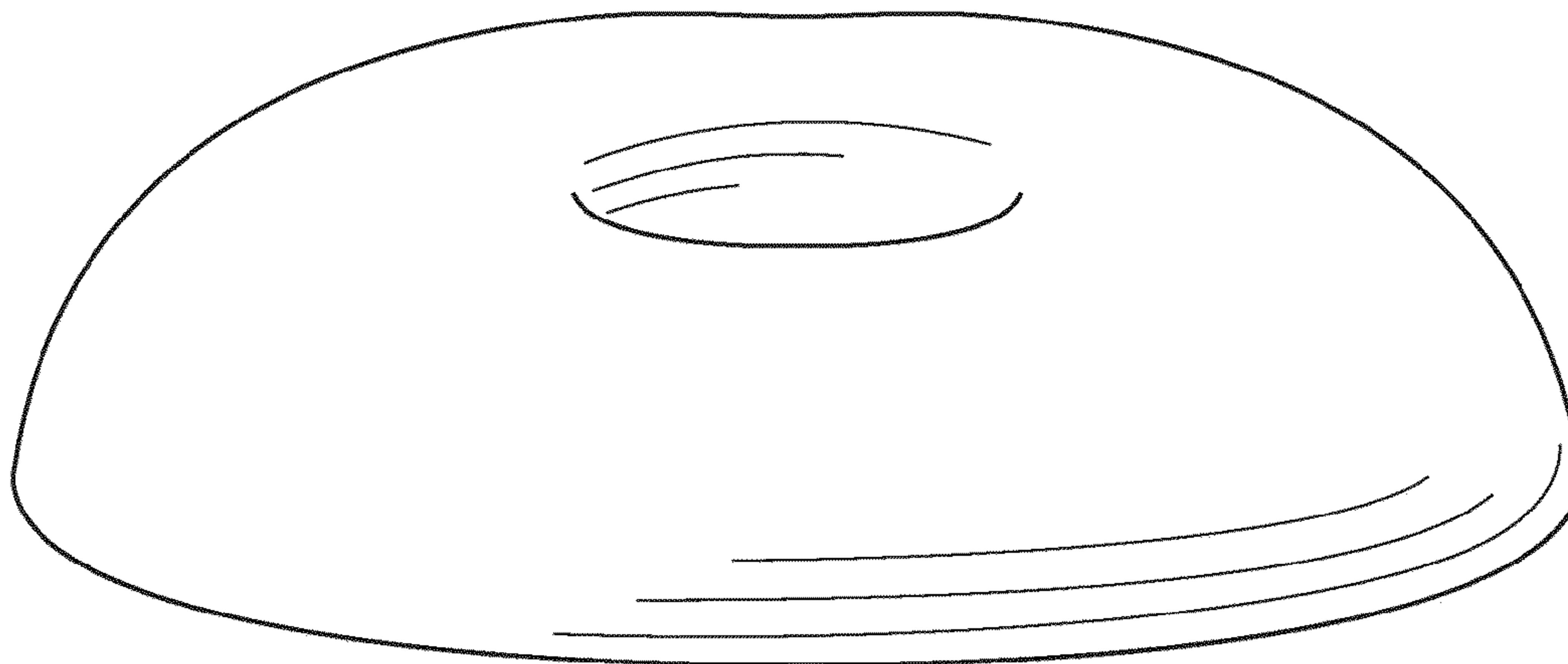
The ornamental design for an active seating cushion, as shown and described.

DESCRIPTION

FIG. 1 is a front/top perspective view of an active seating cushion, the rear/top perspective view being a mirror image; FIG. 2 is a side view of the active seating cushion of FIG. 1, the opposite side being a mirror image; and, FIG. 3 is a top view of an active seating cushion.

The bottom surface of the active seating cushion is not claimed.

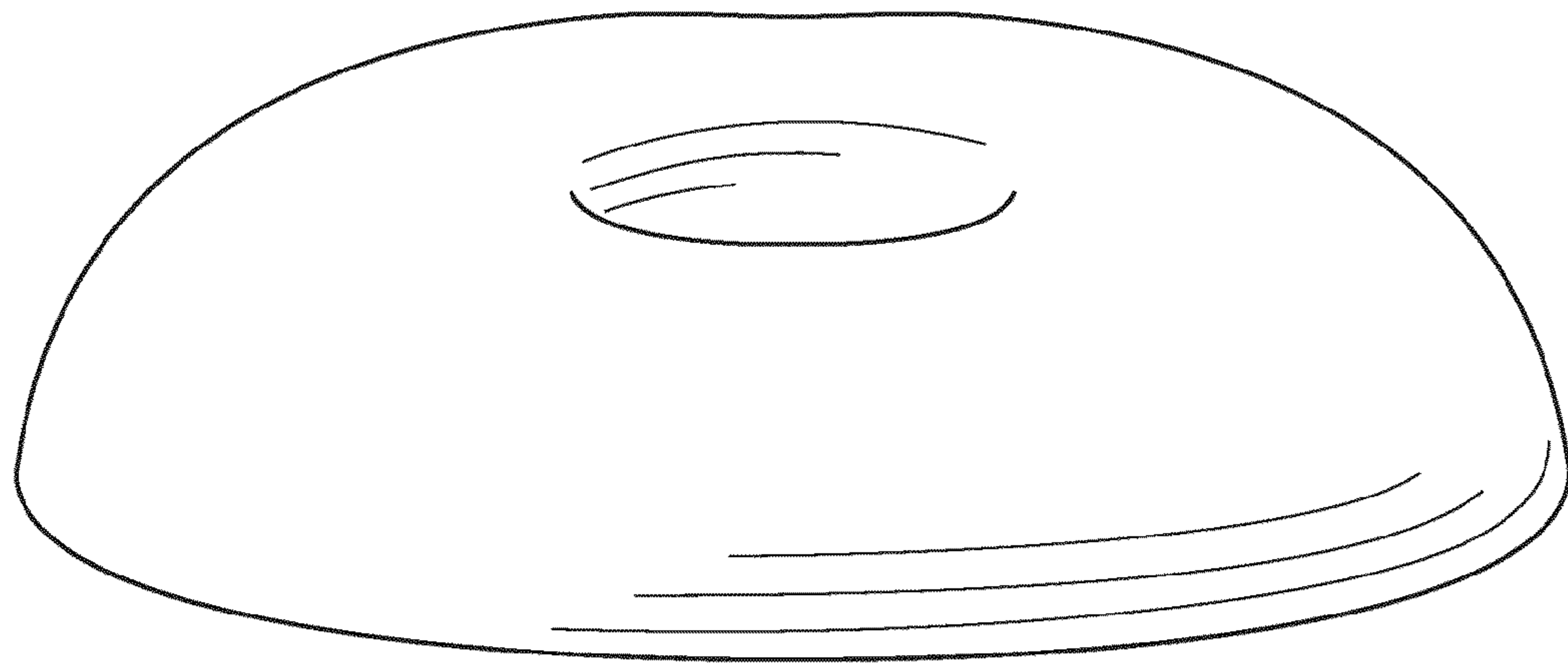

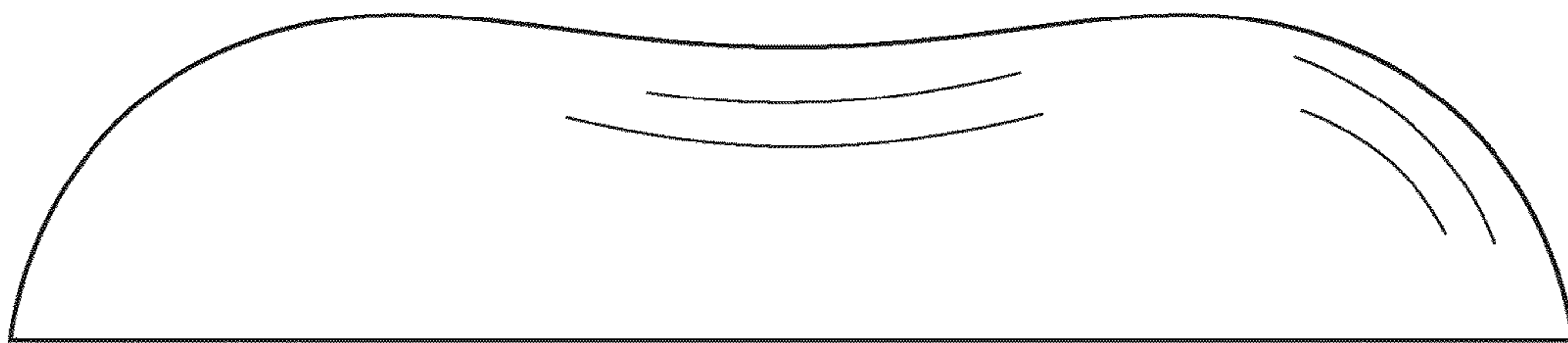

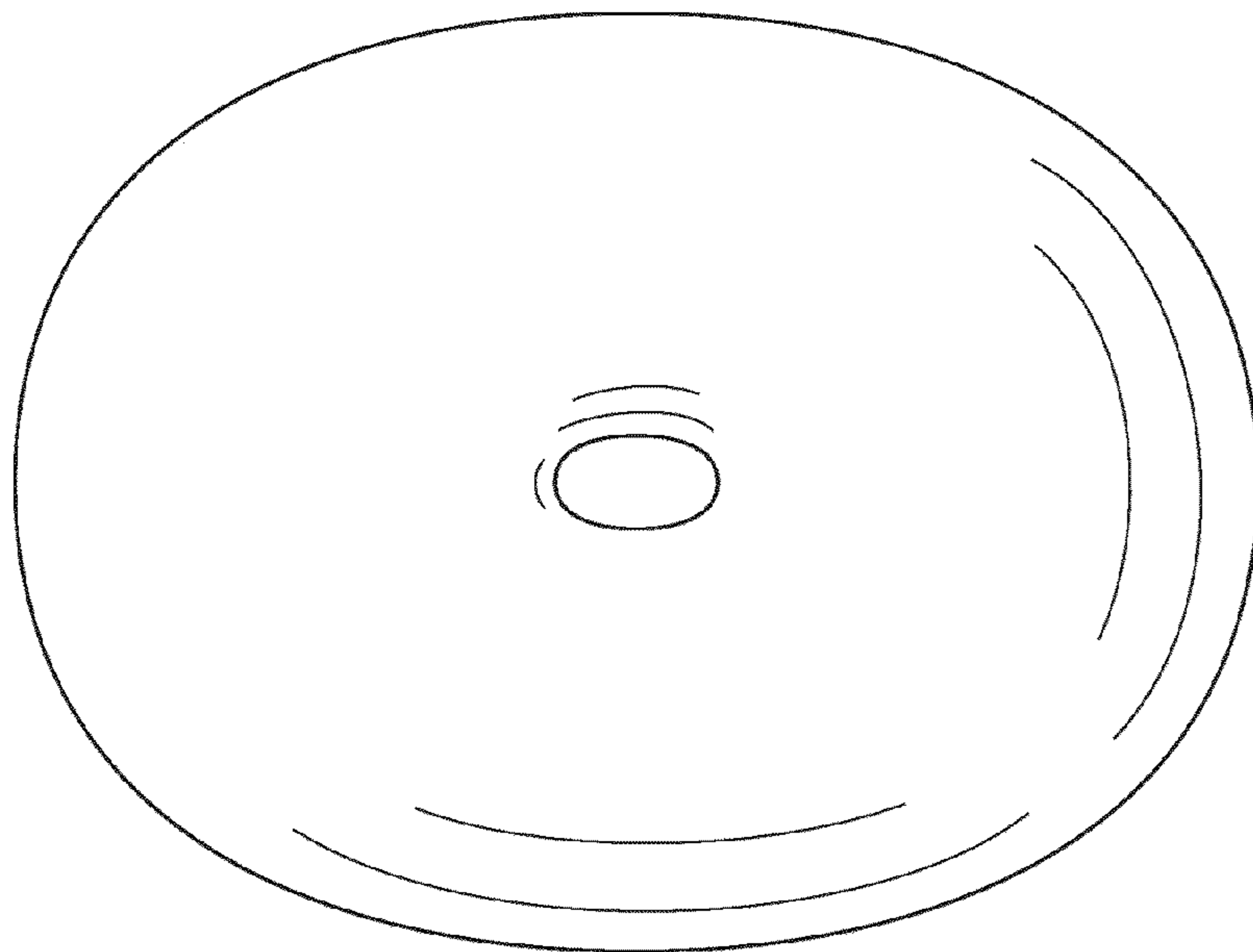
