FIG. 34 is a right side view thereof, of which a left side view is a mirror image thereof,

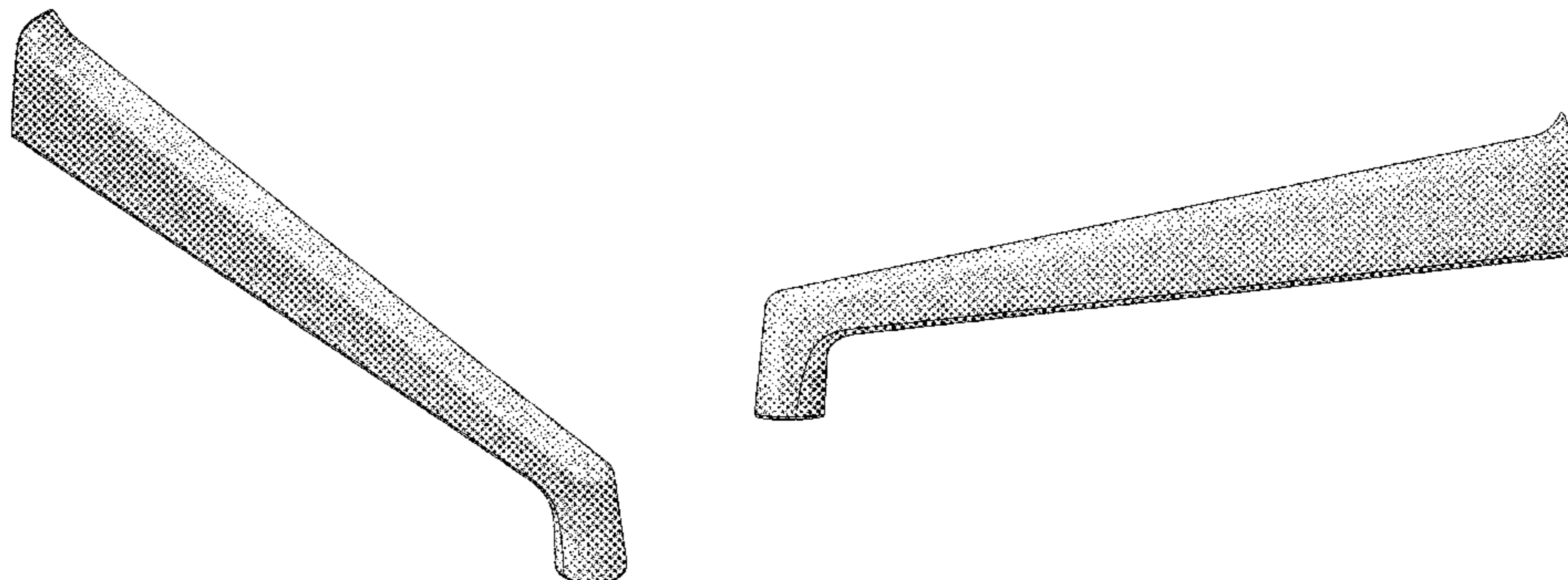


FIG. 35 is a top view thereof;

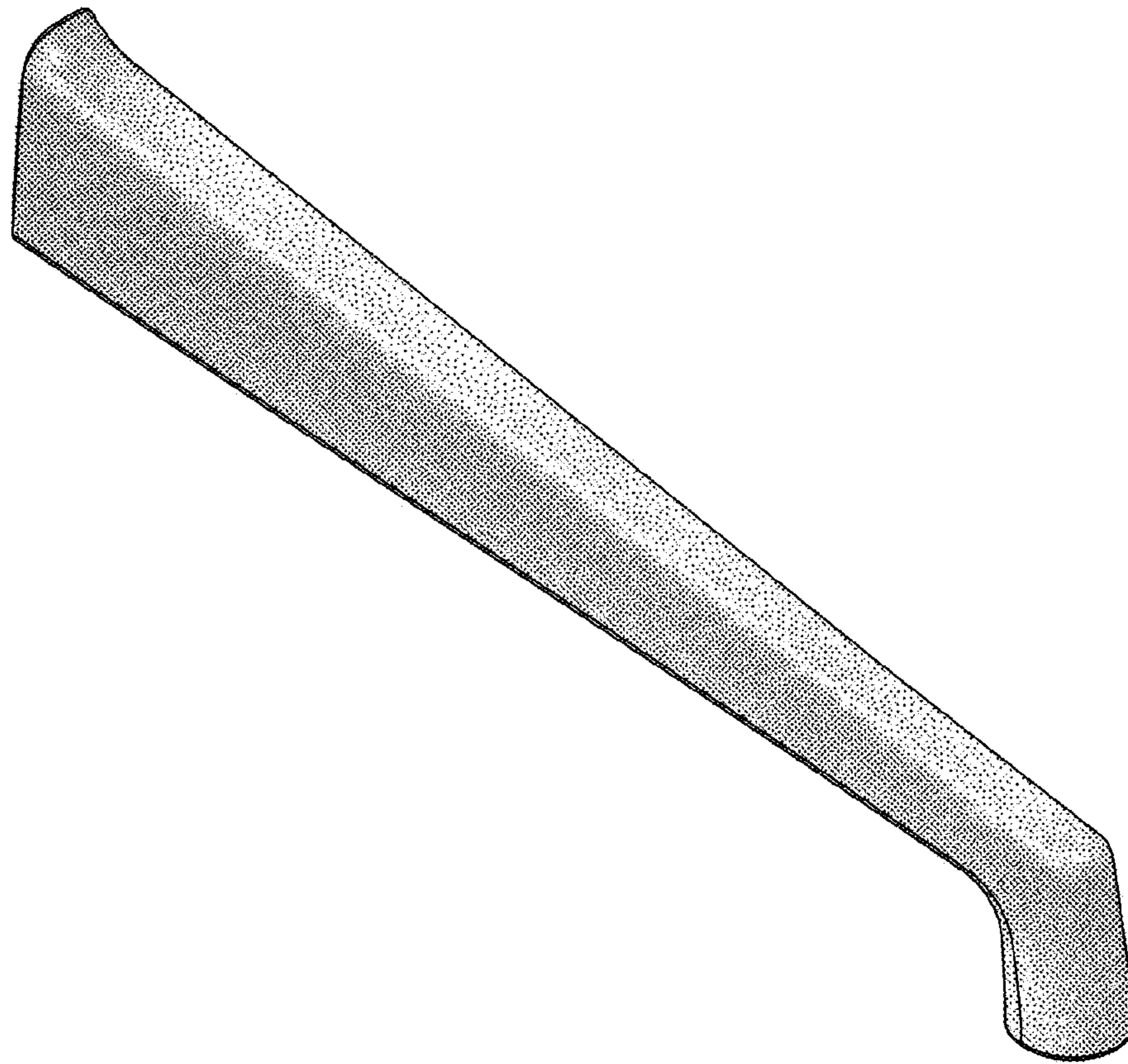

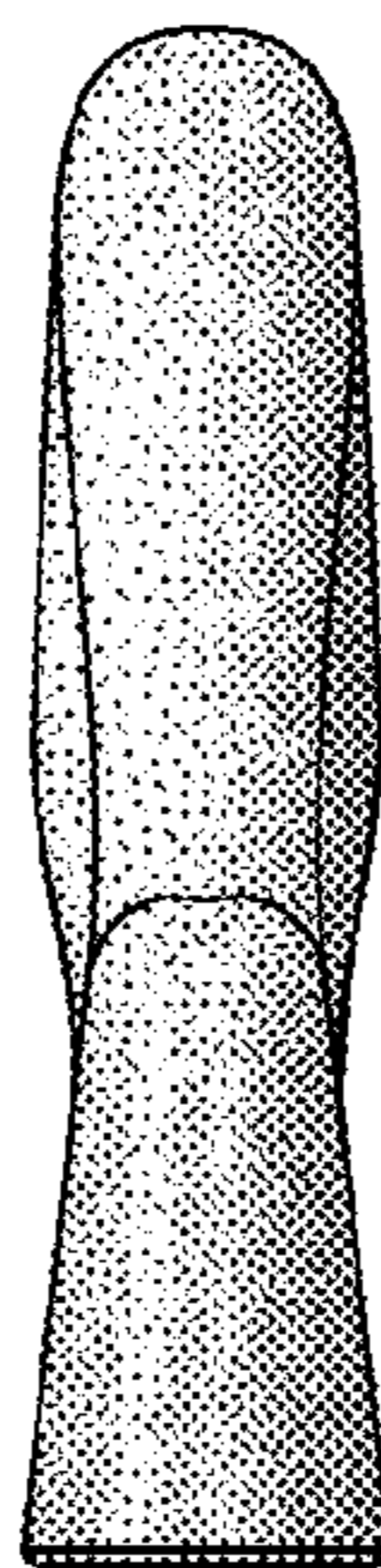

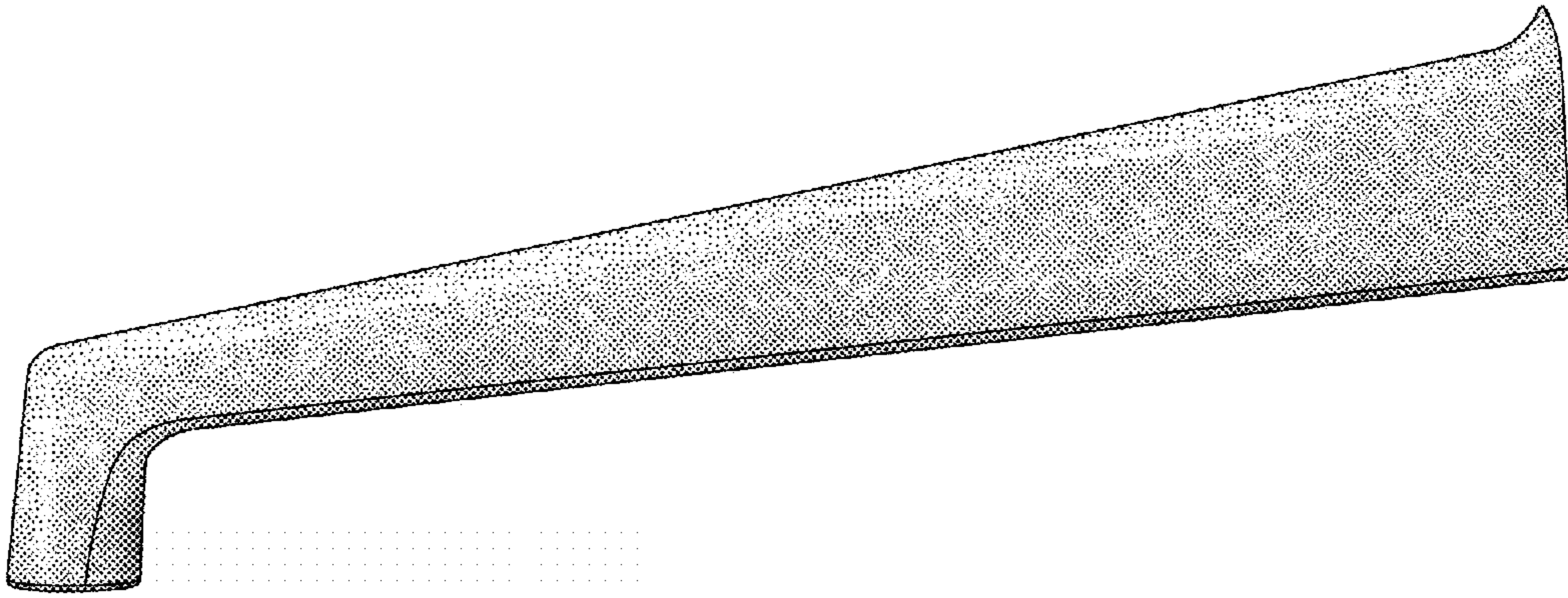

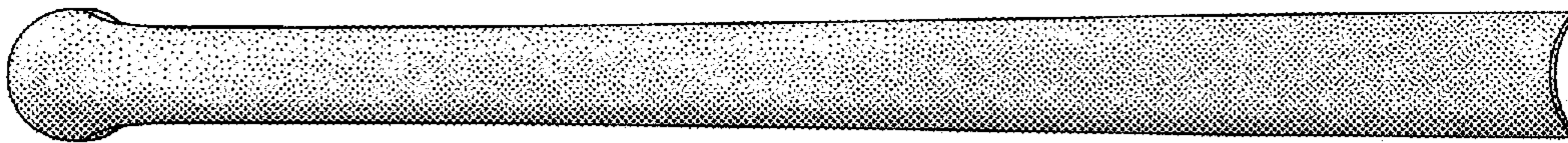

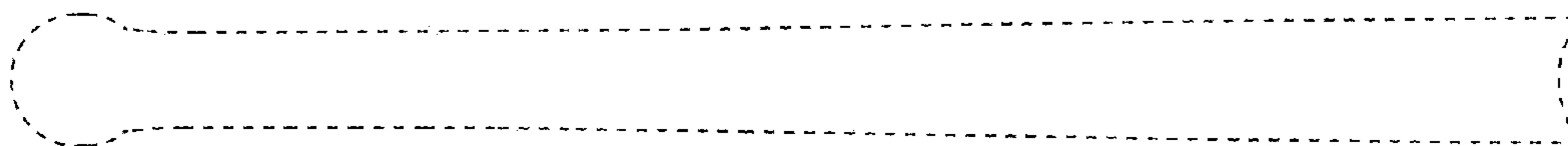

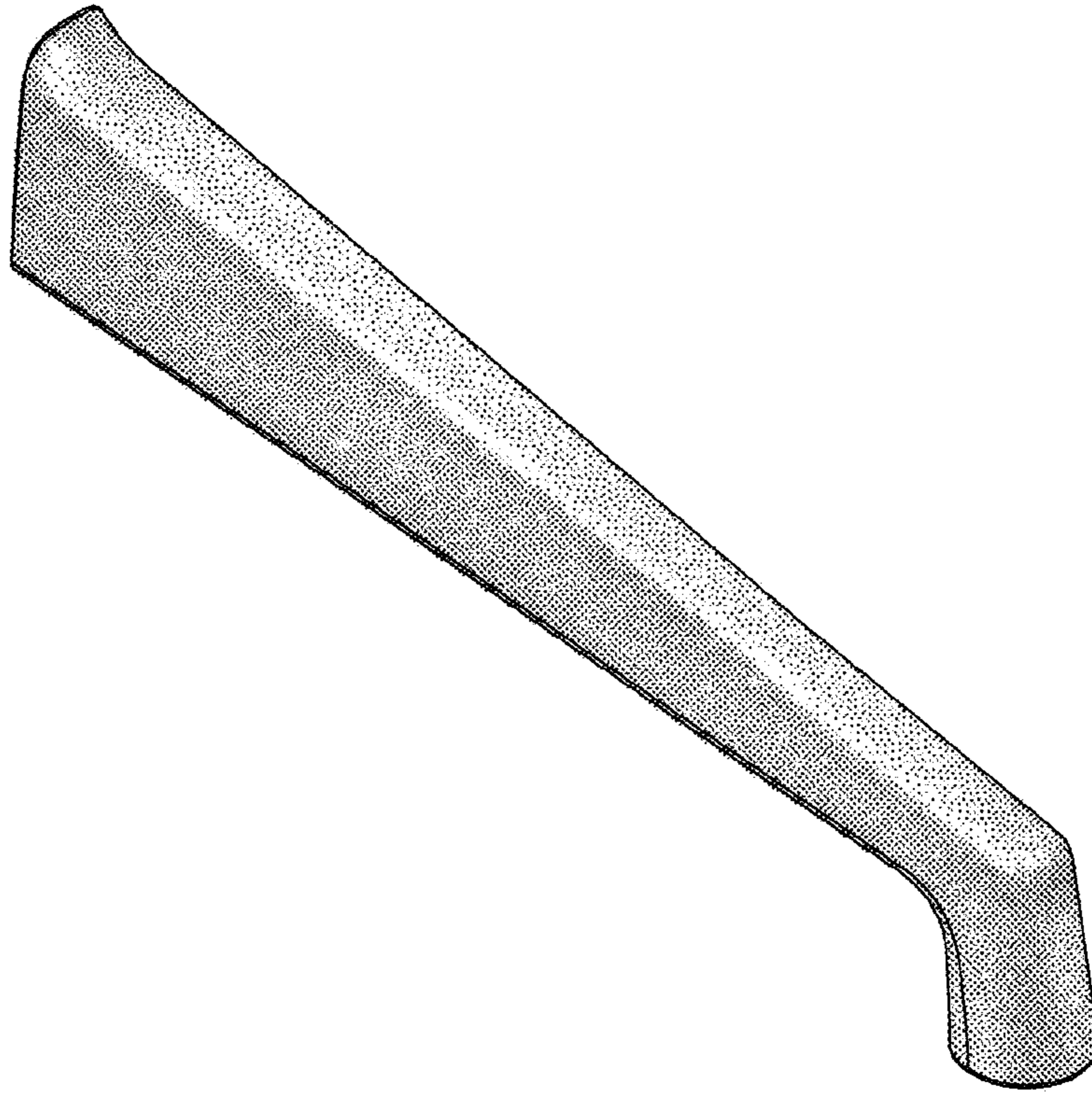

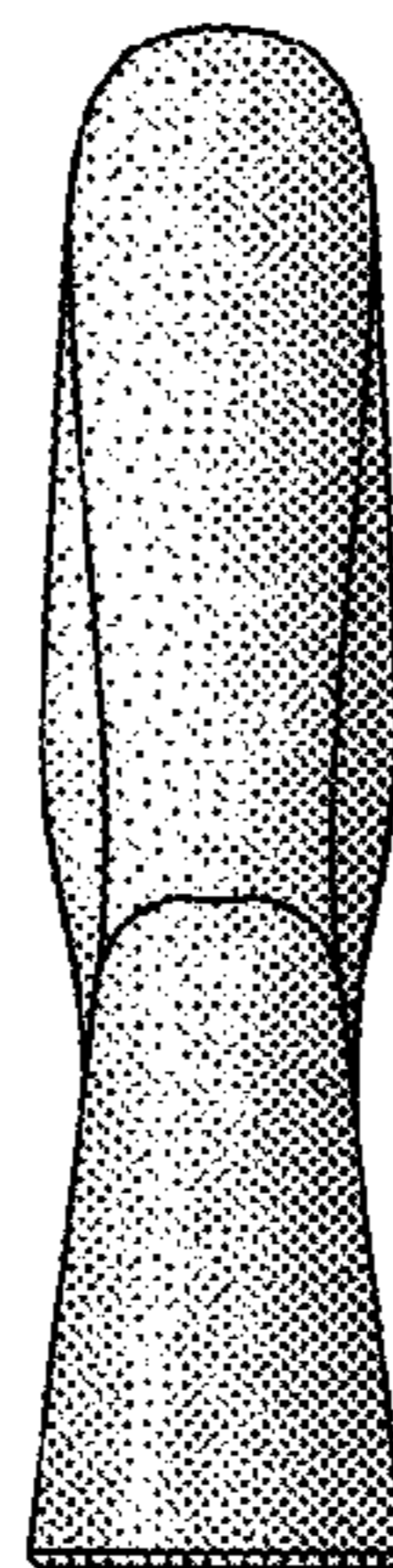

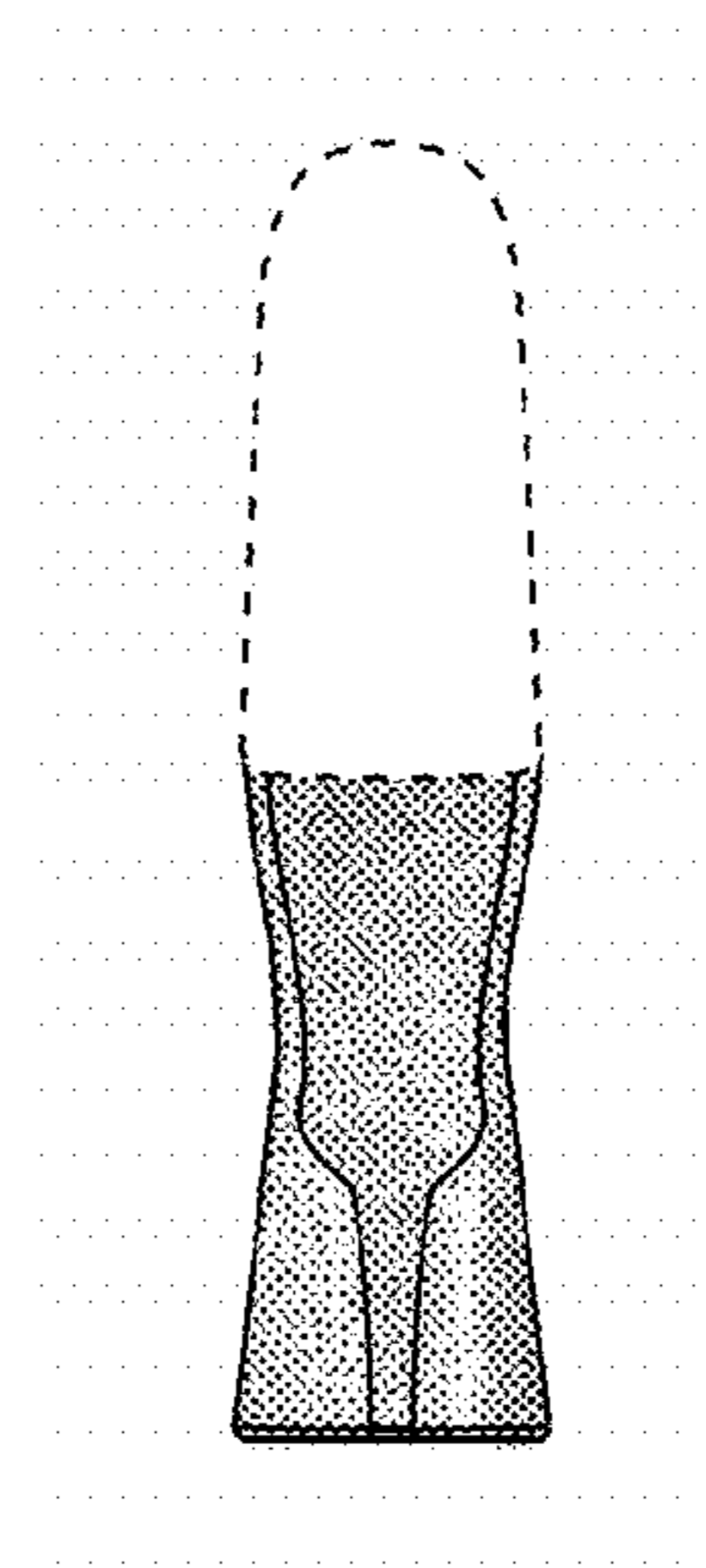

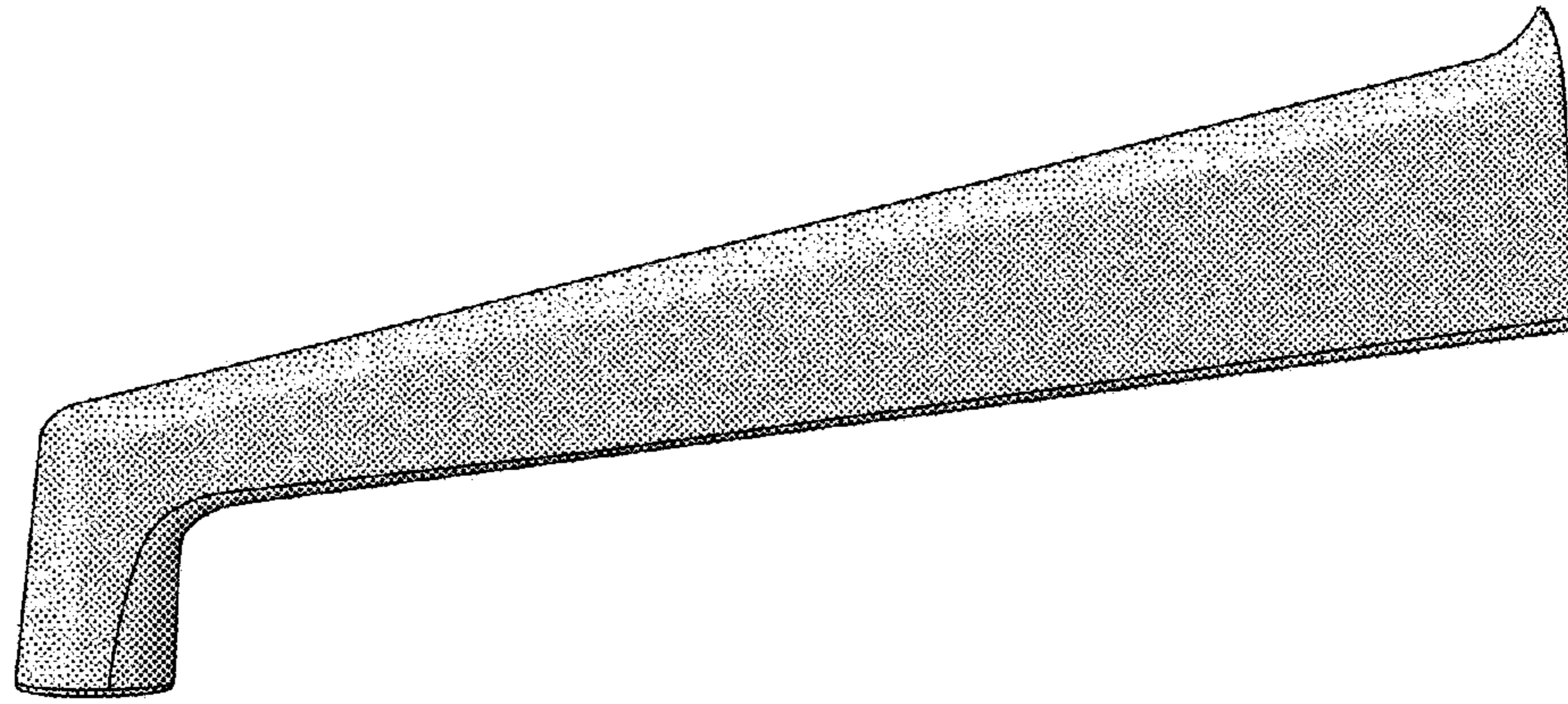

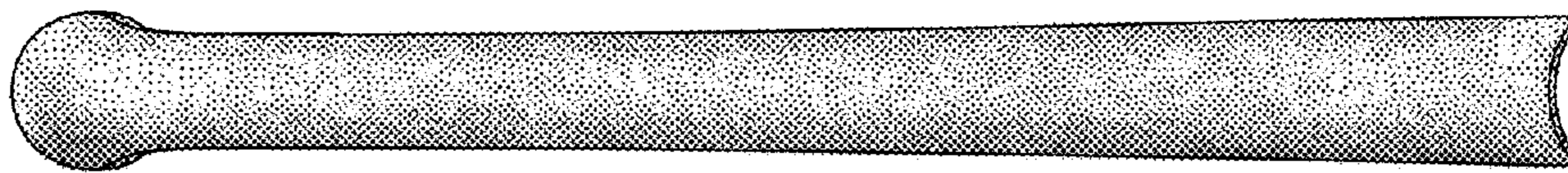

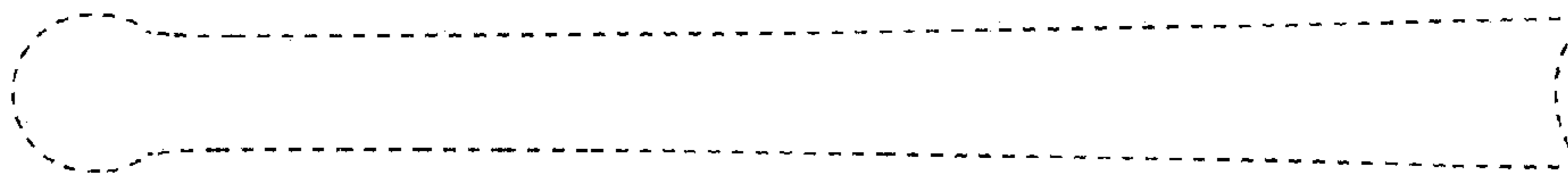

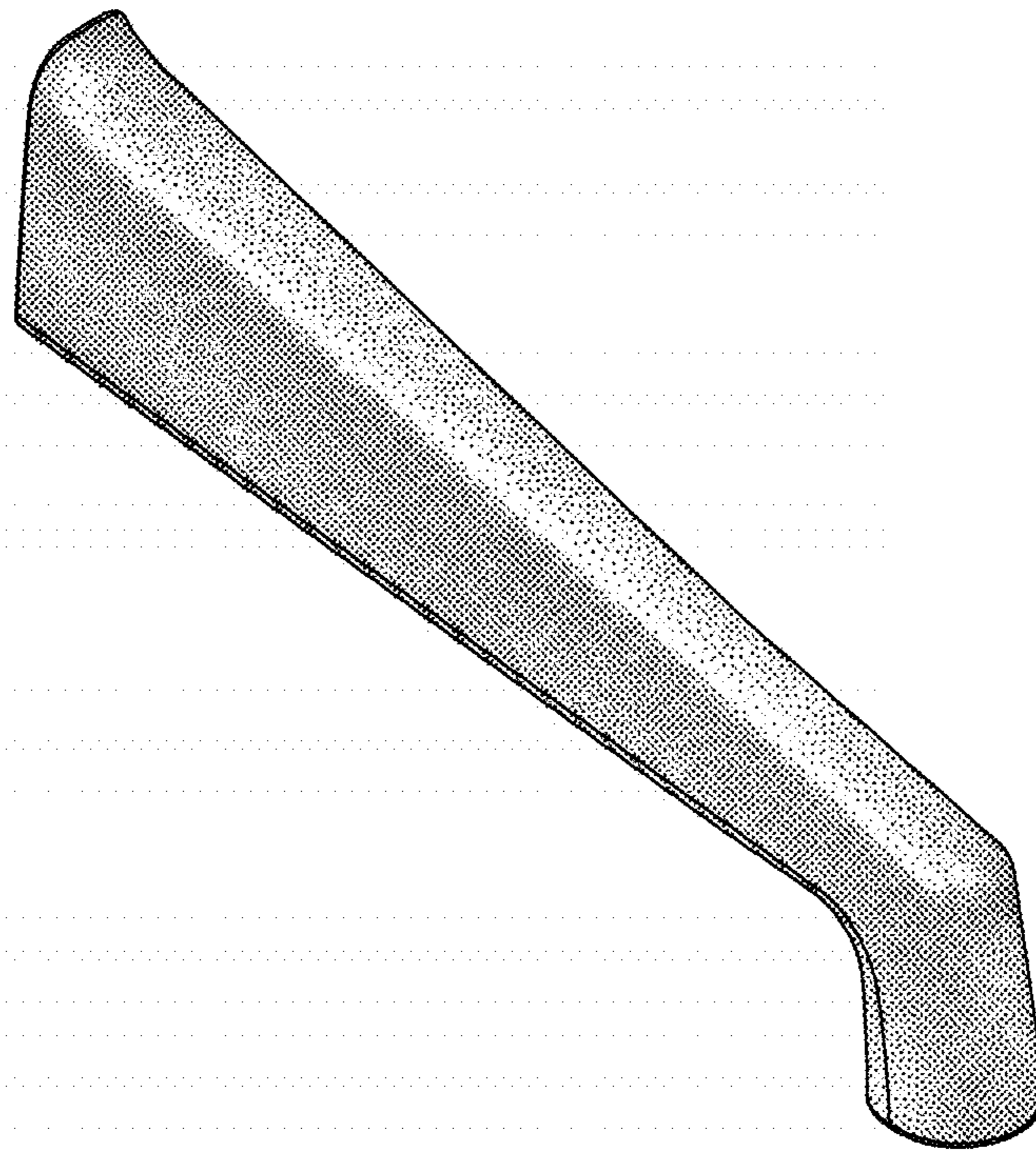

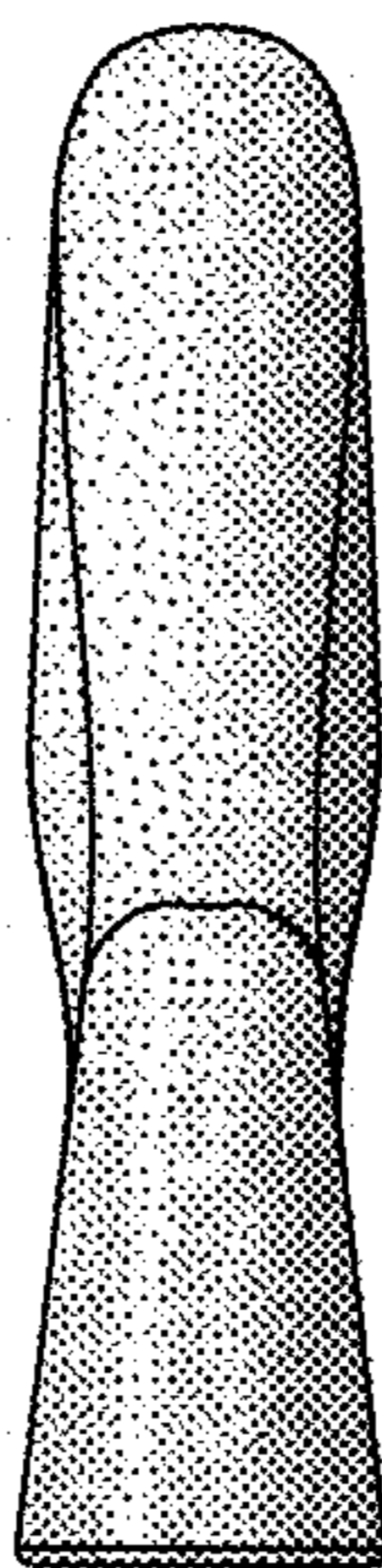

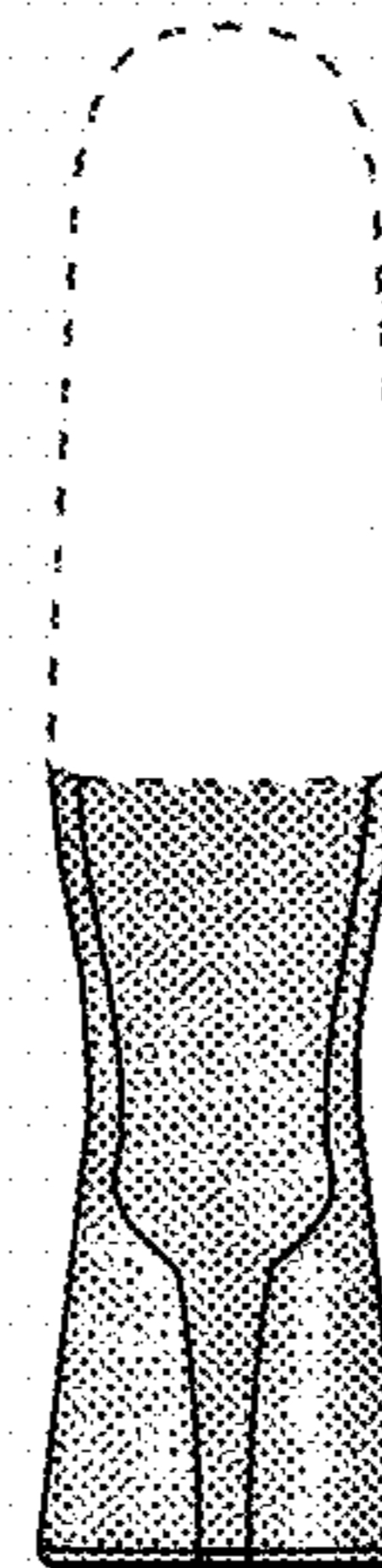

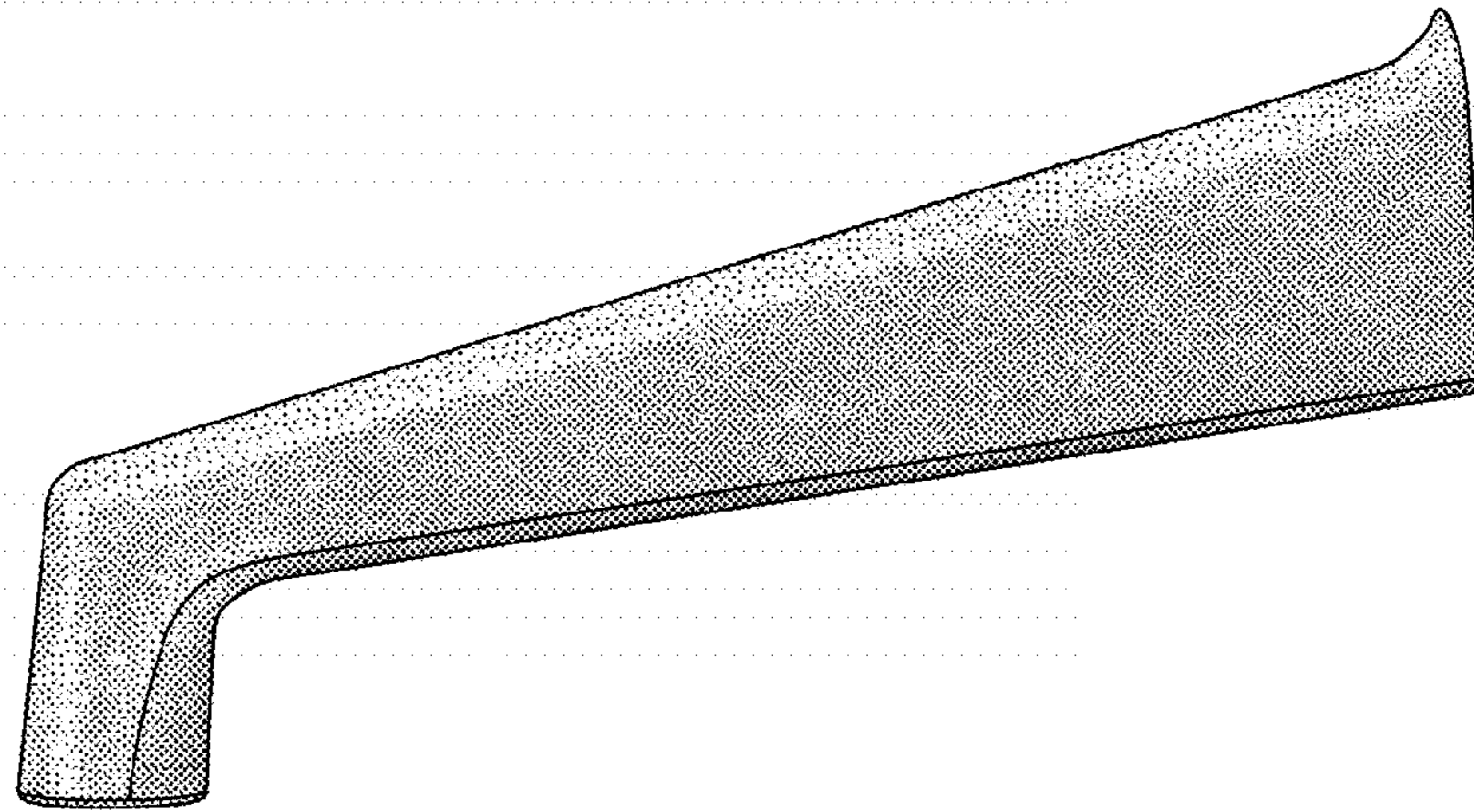

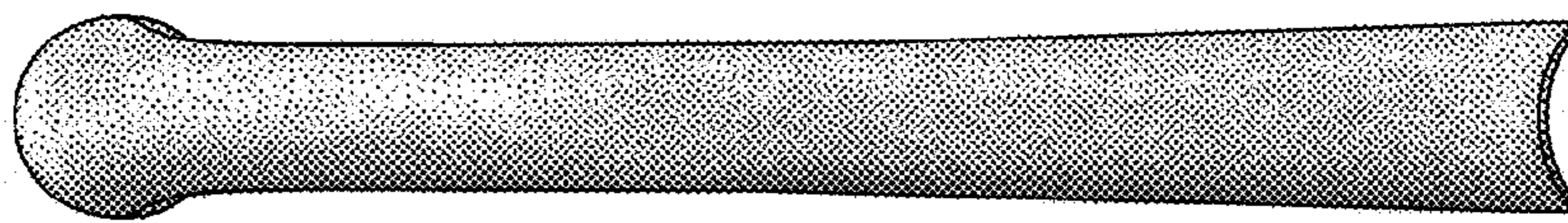

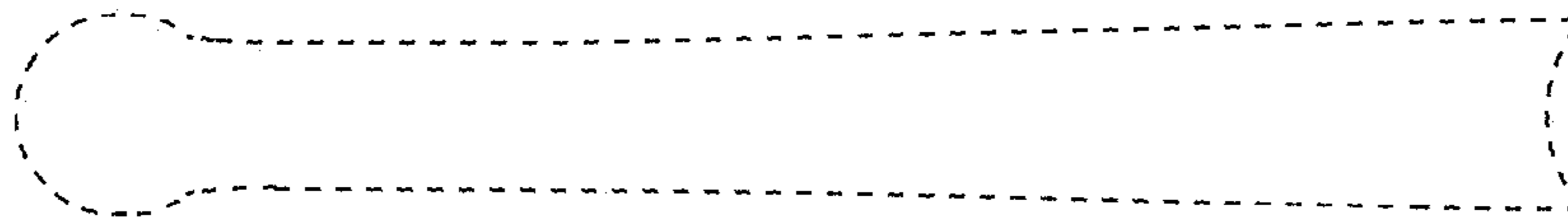

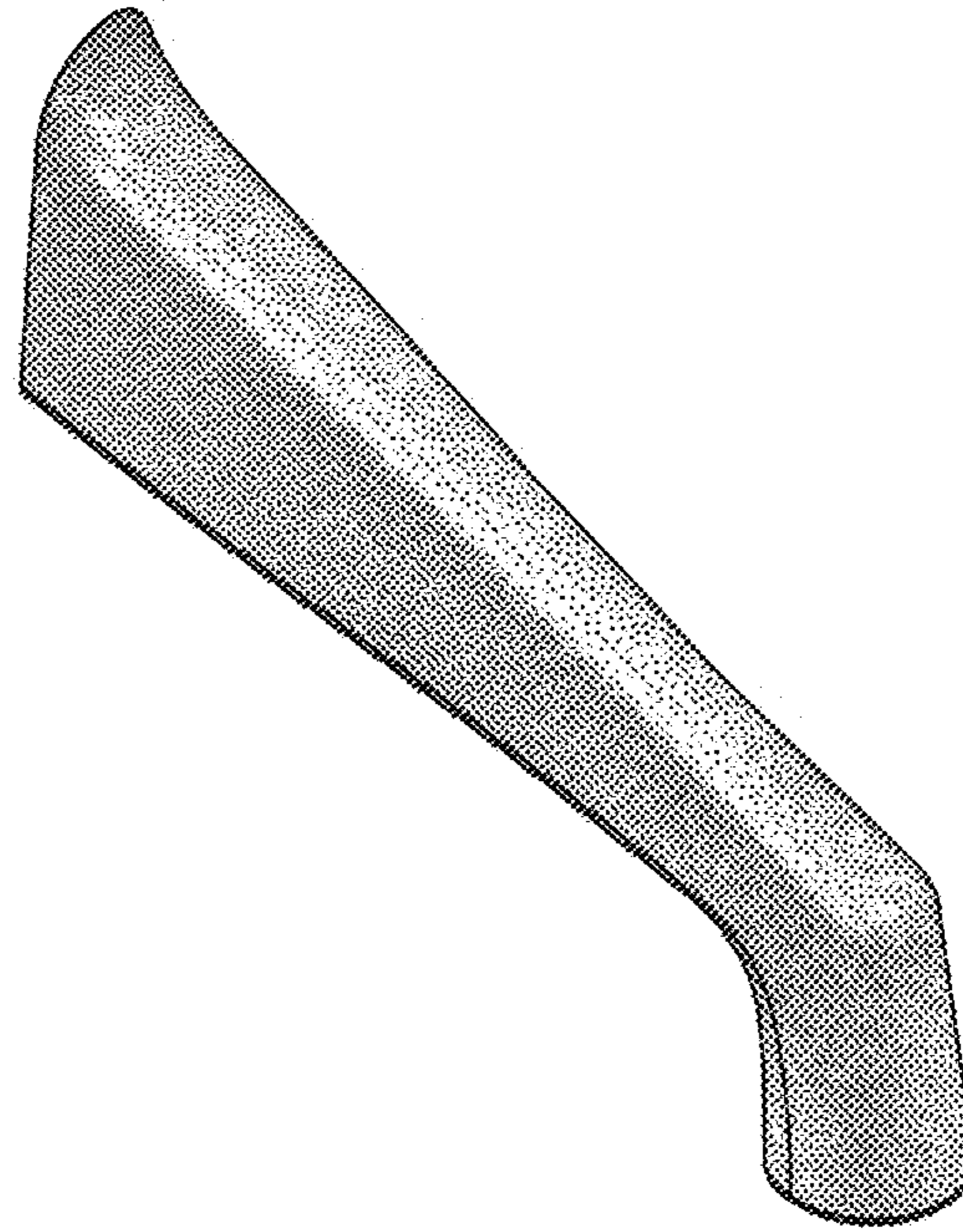

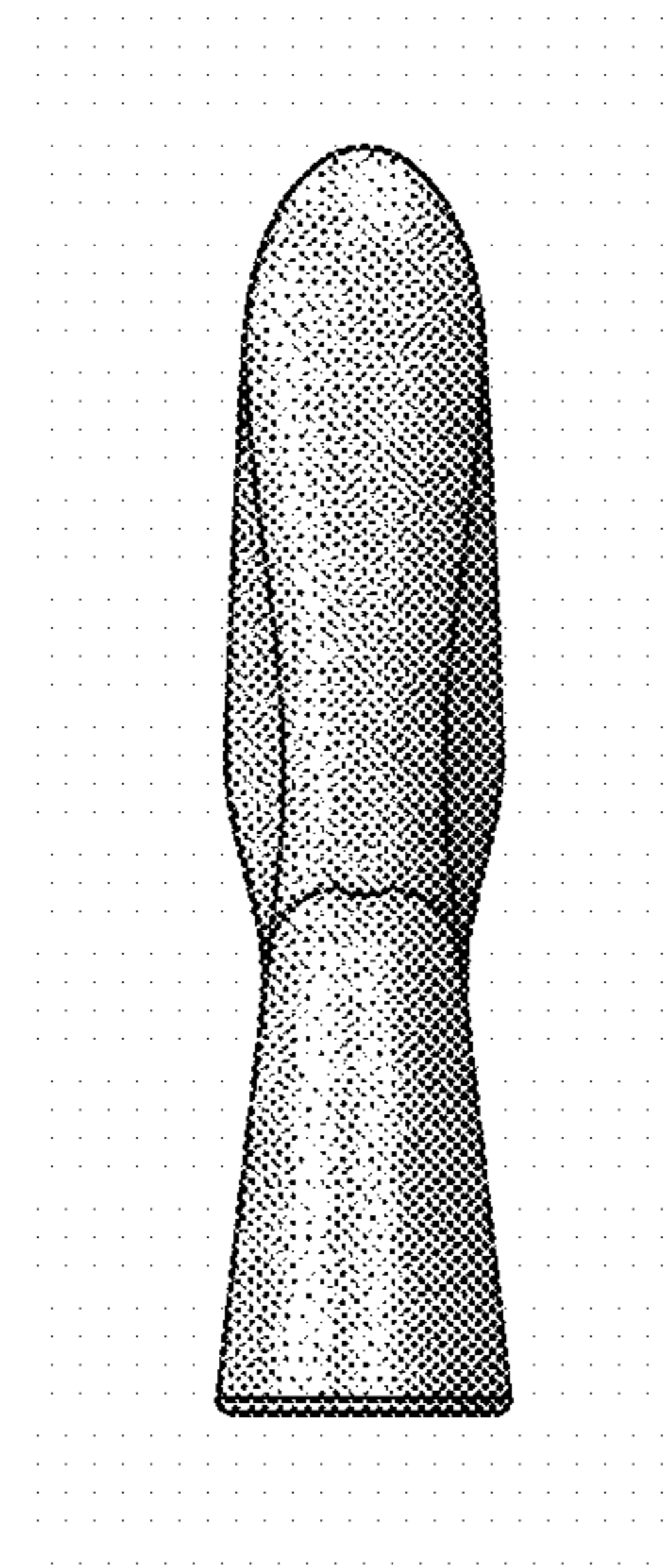

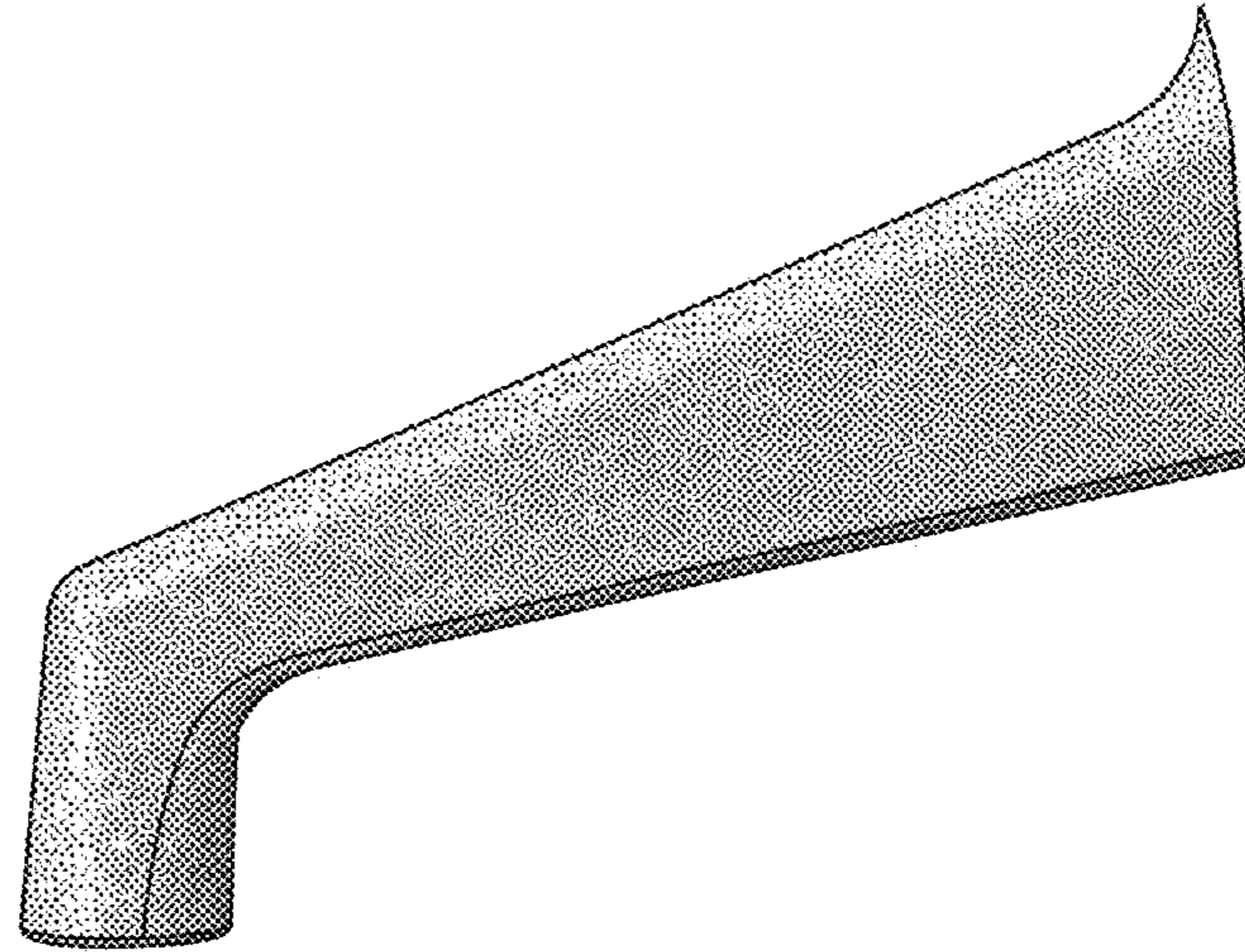

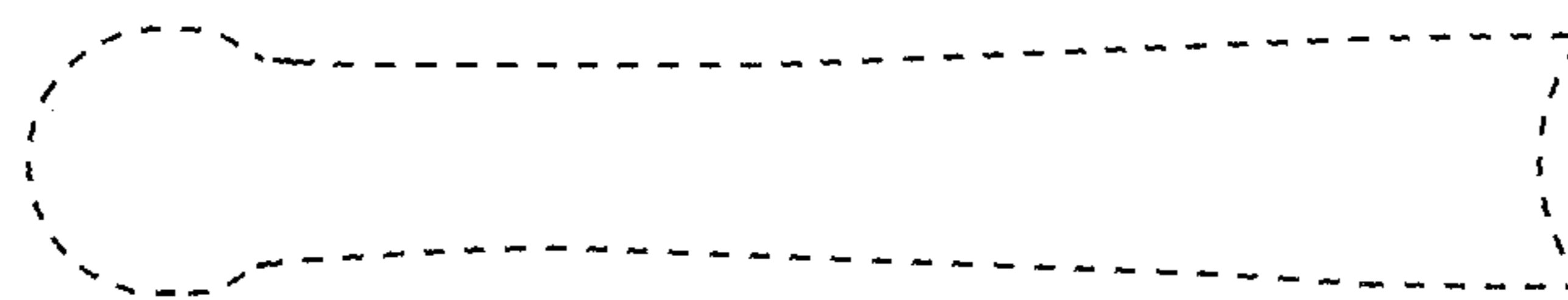

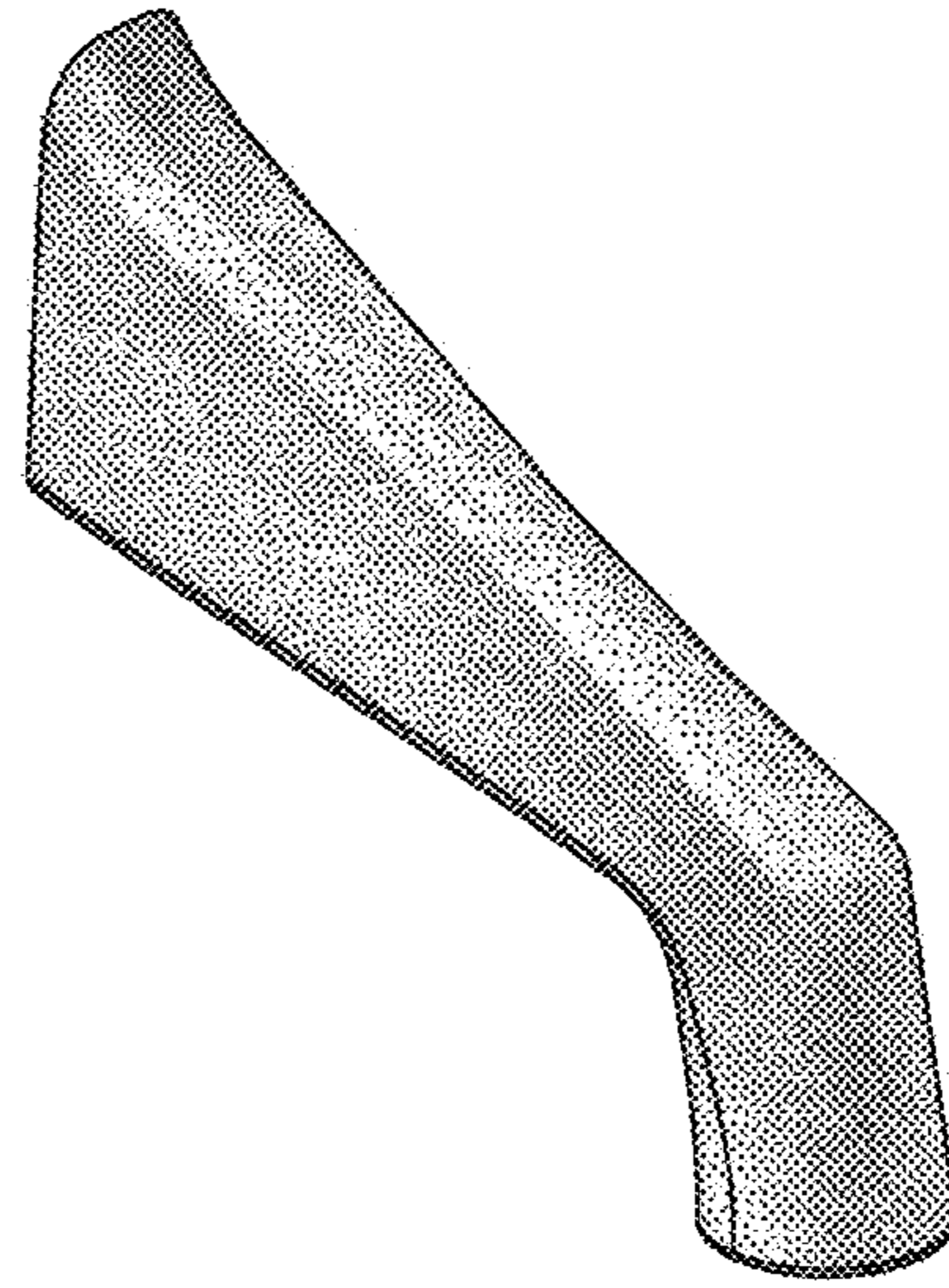

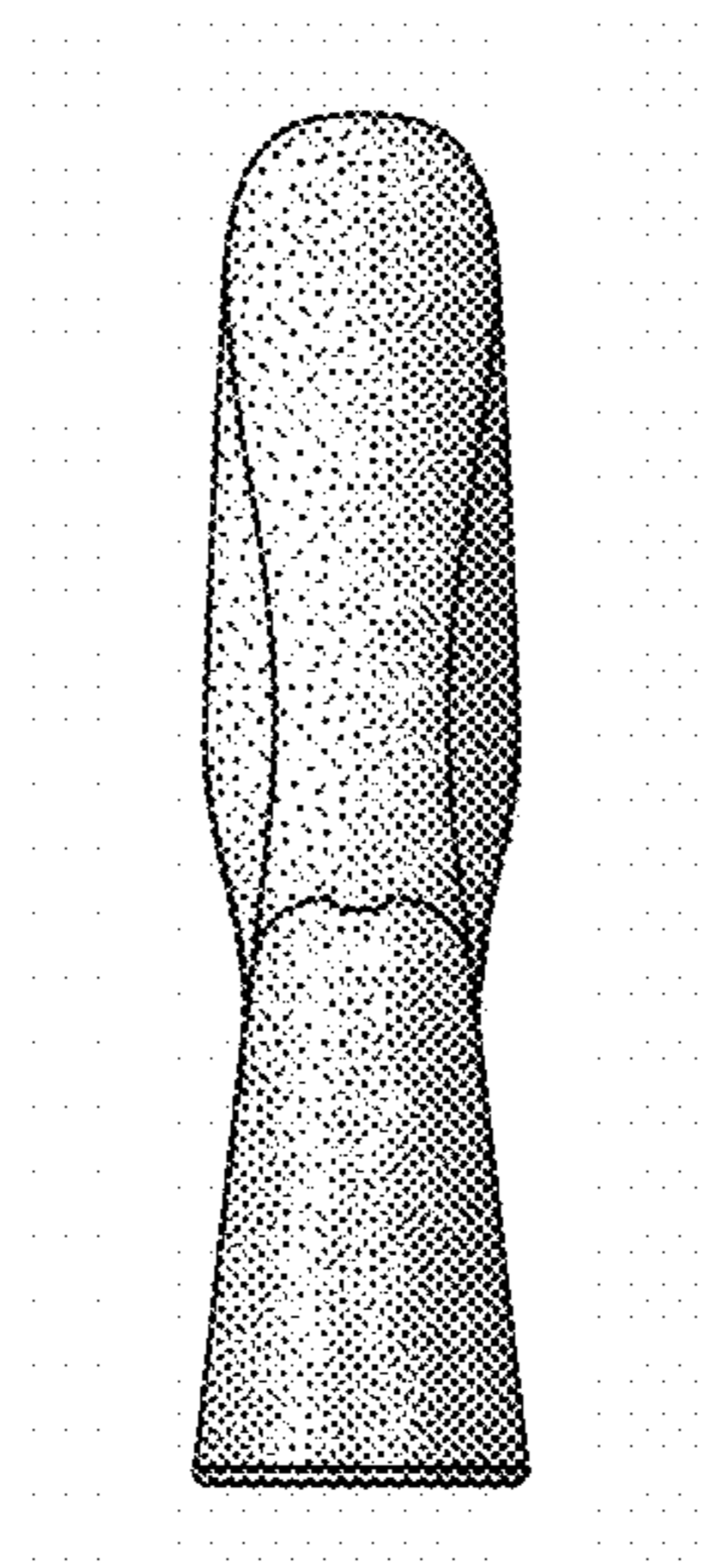

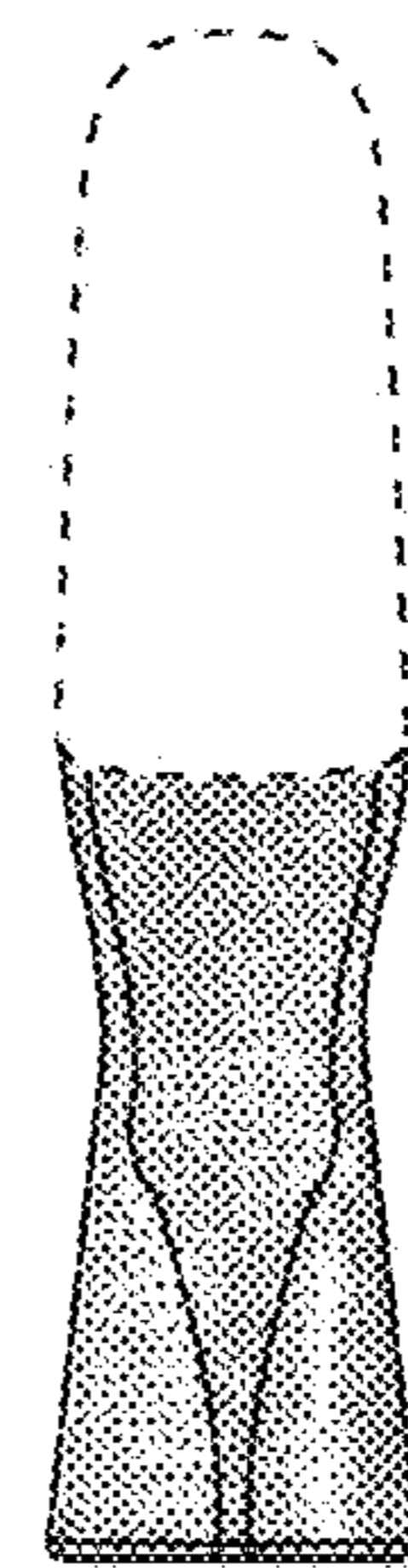

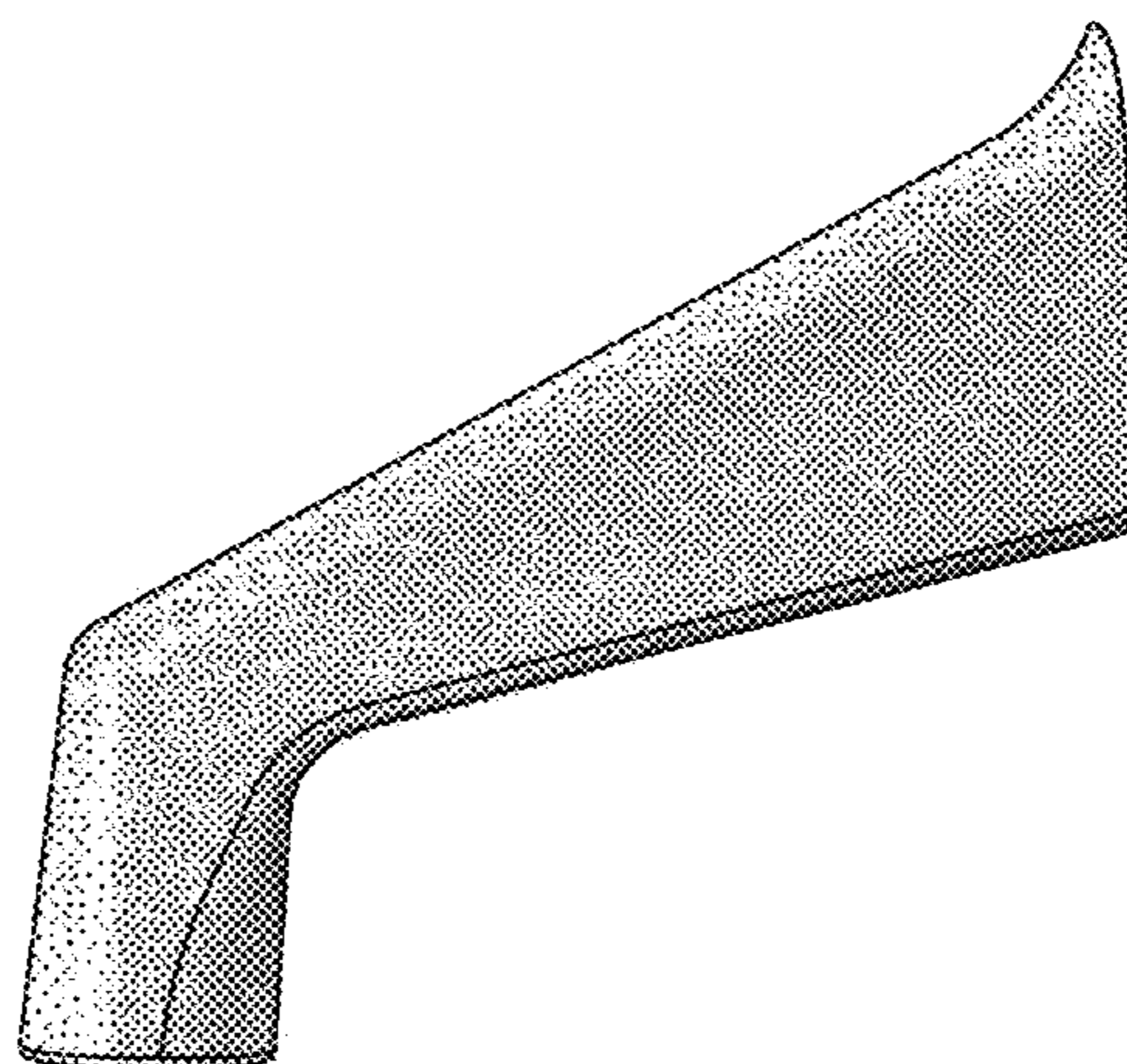

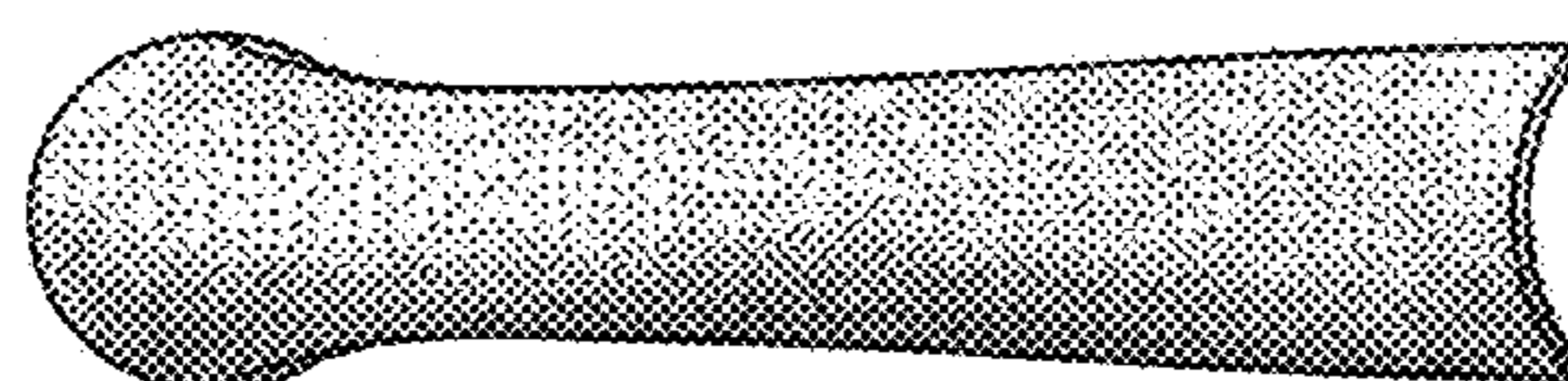

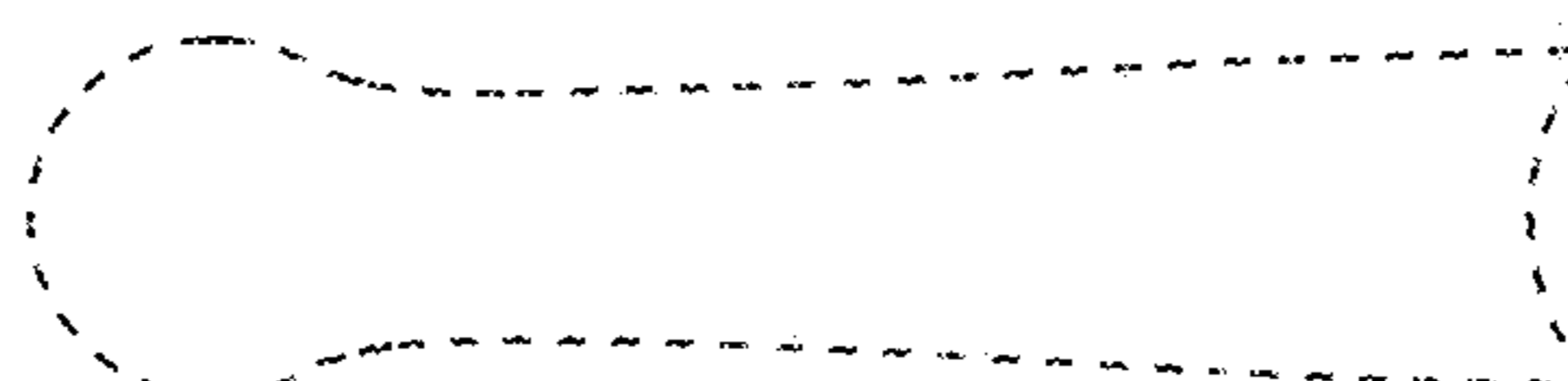

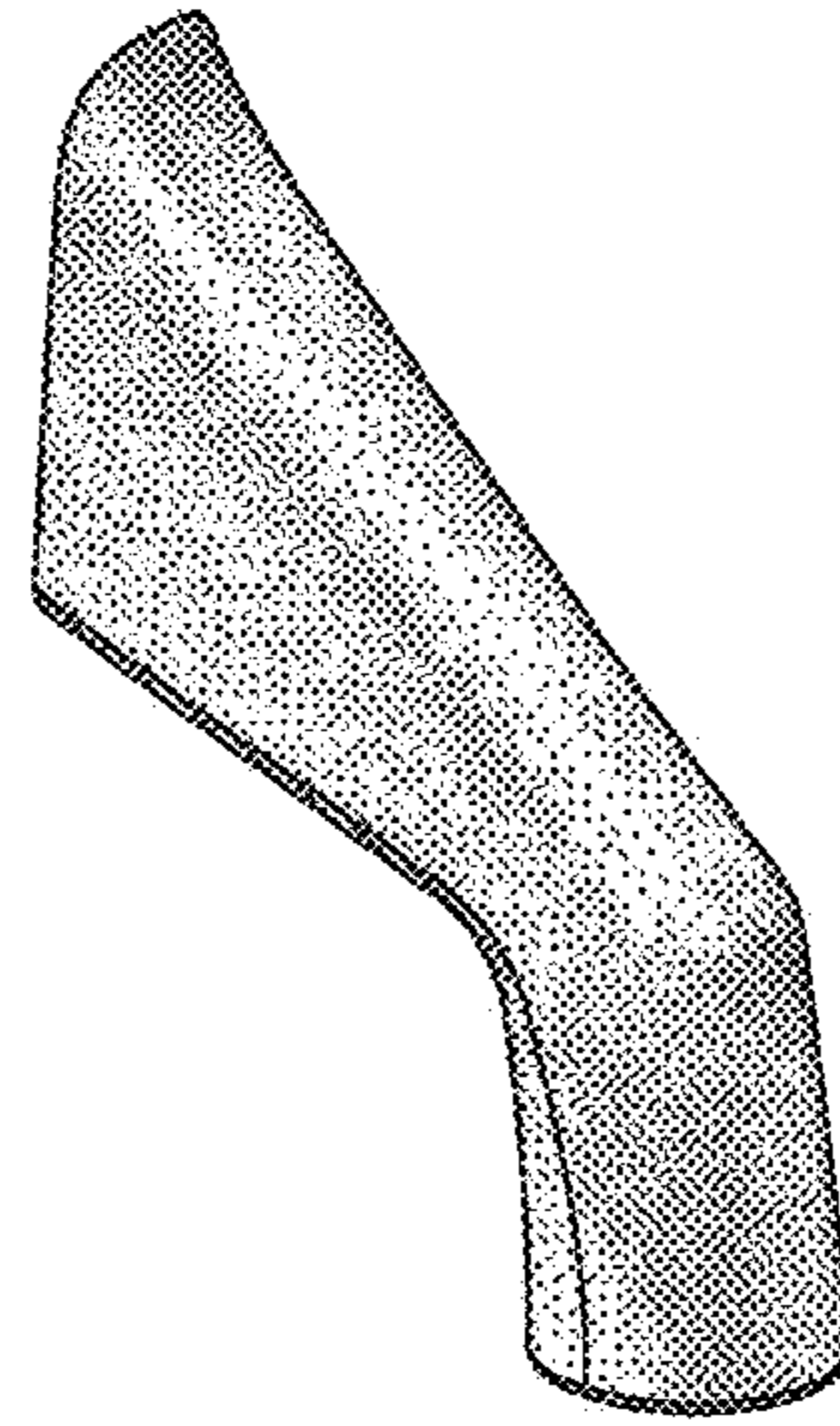

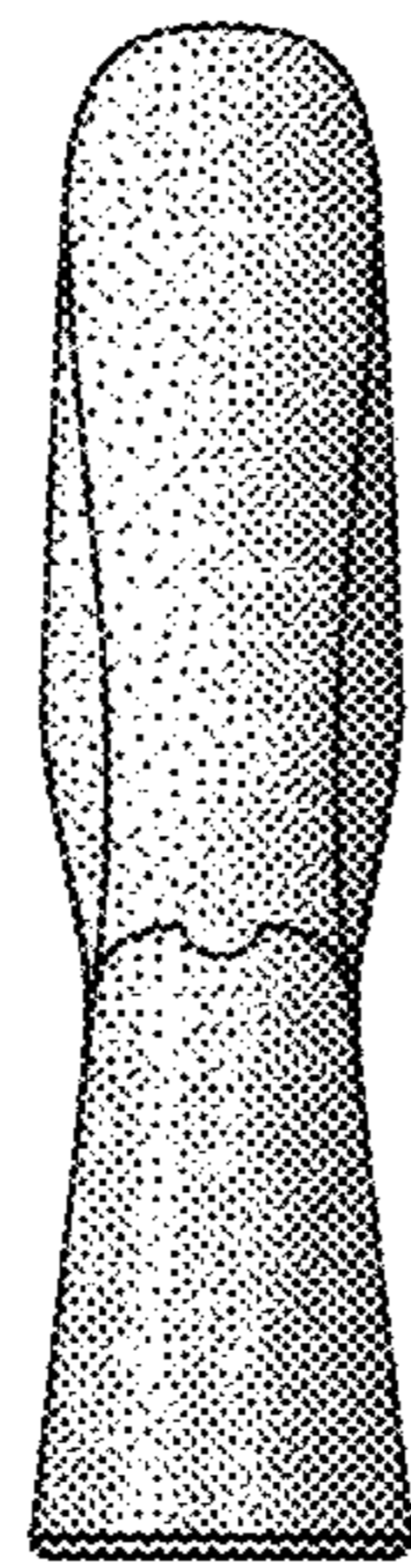

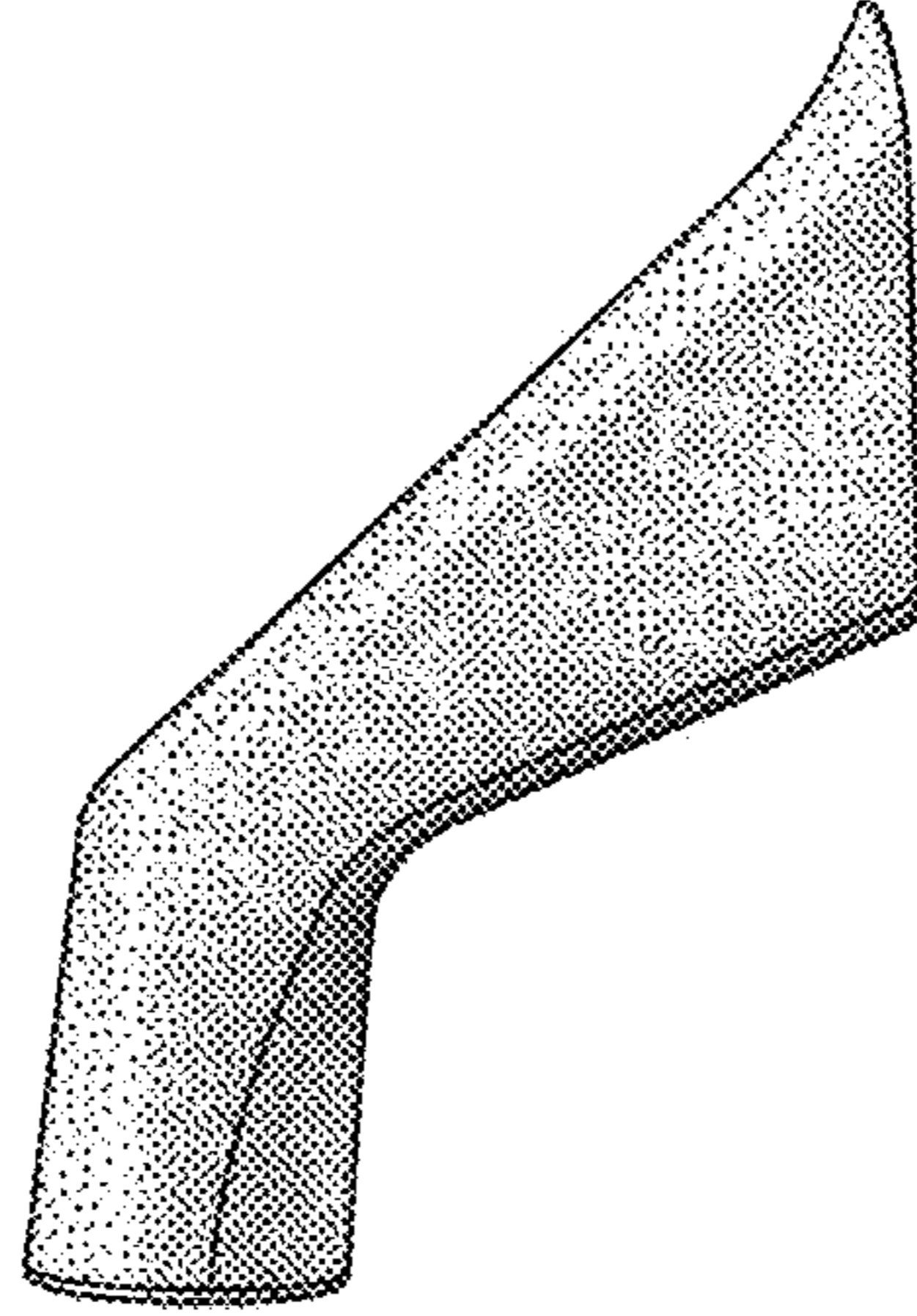

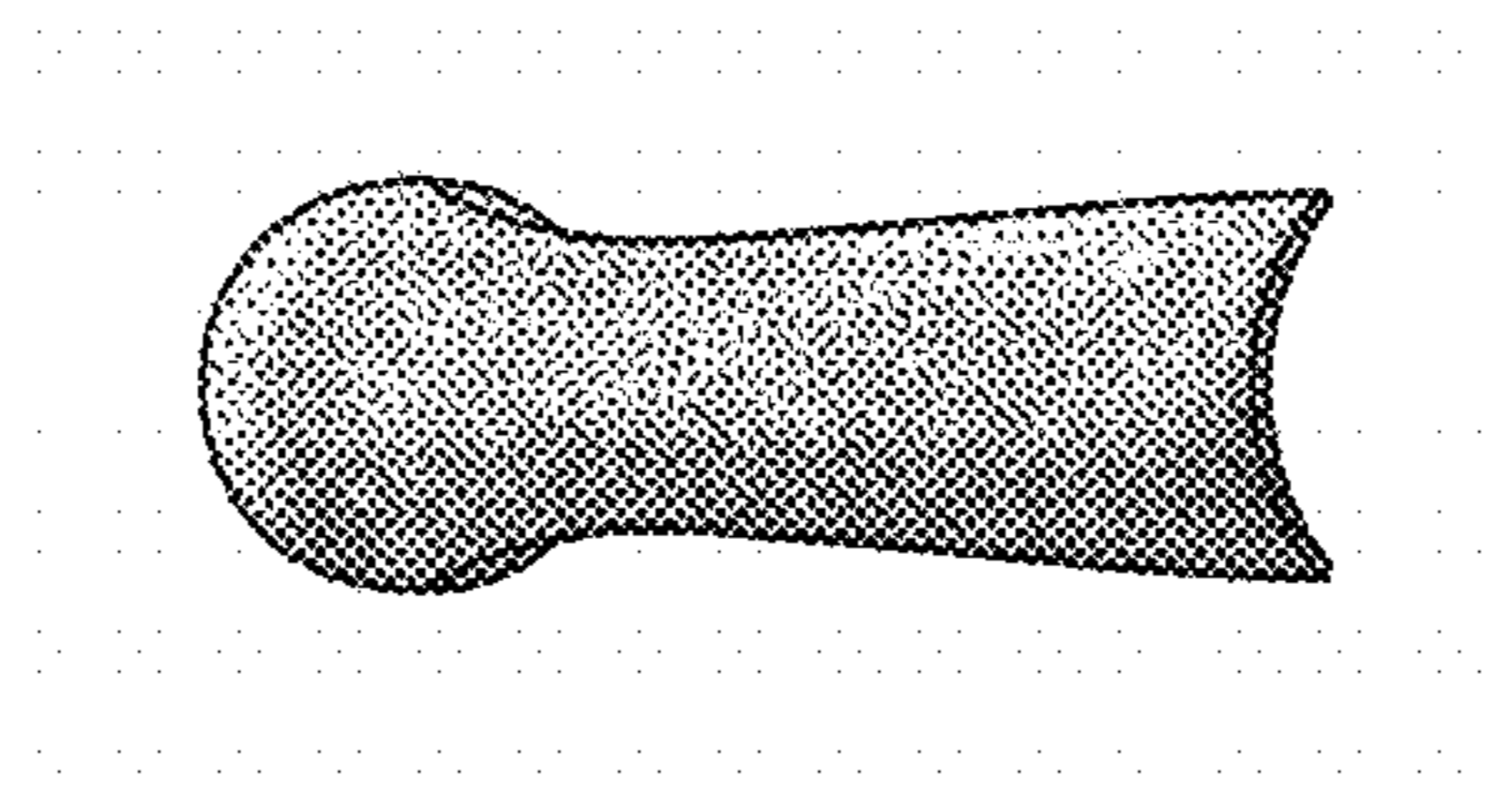

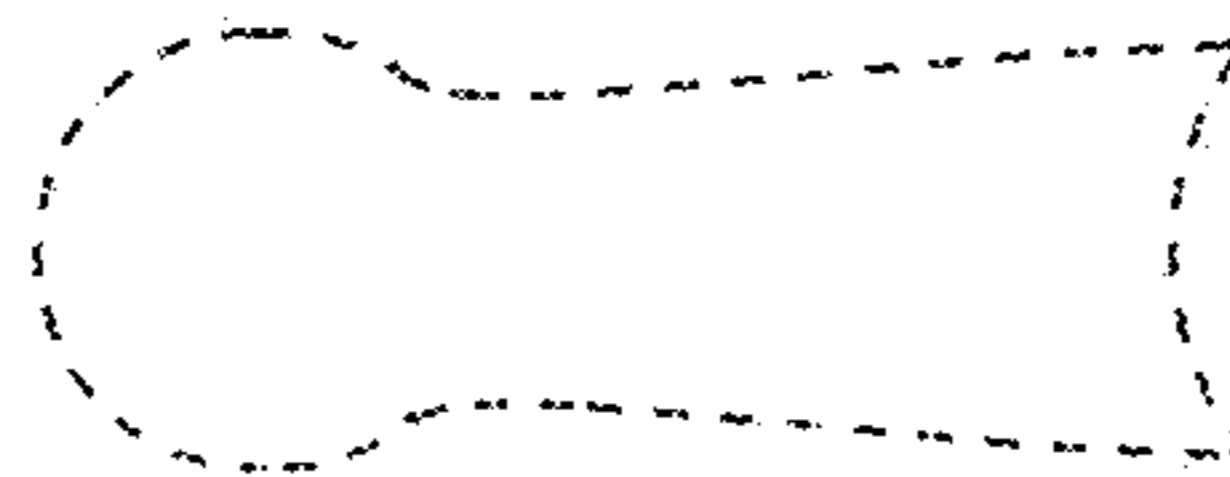

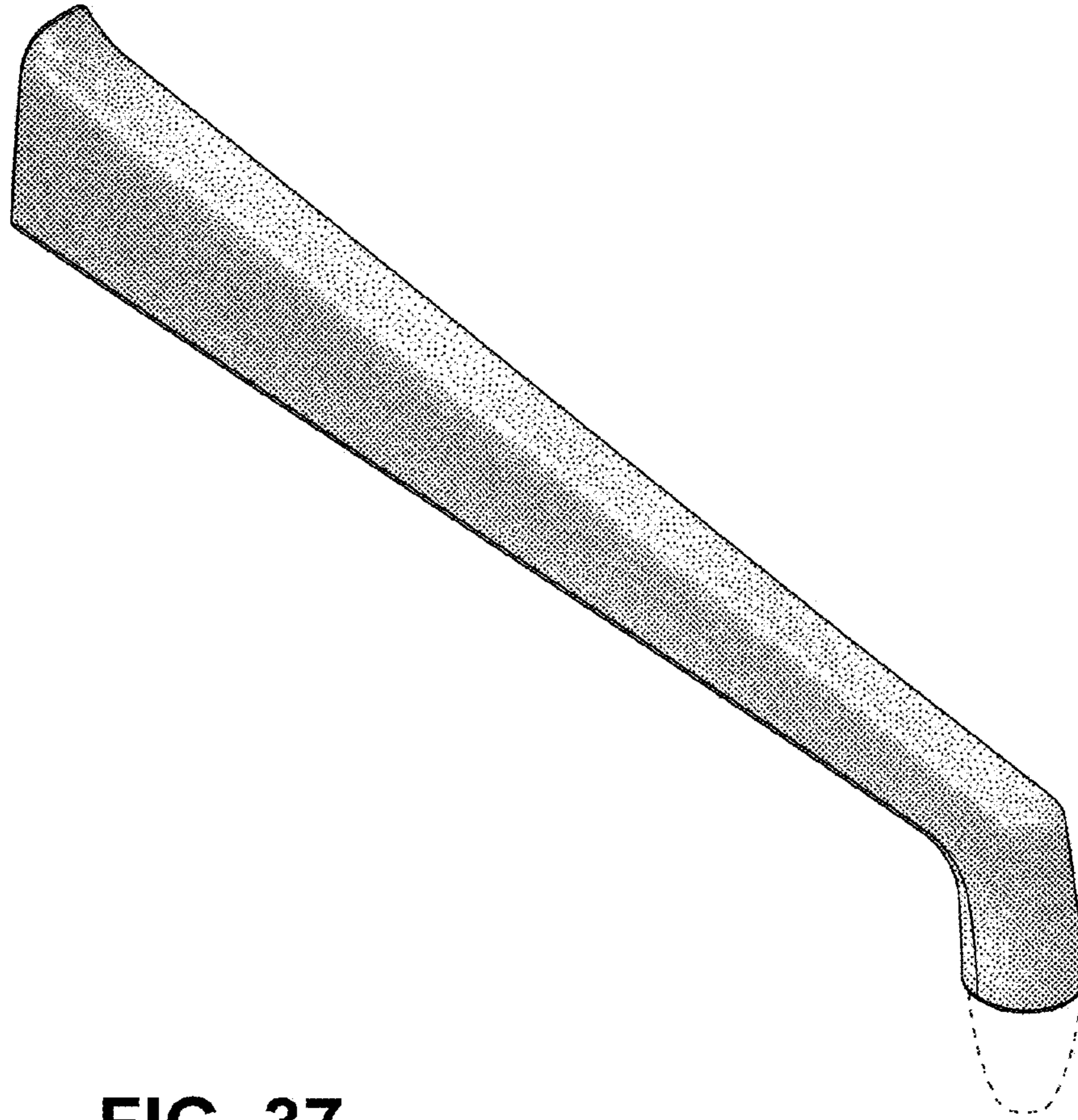

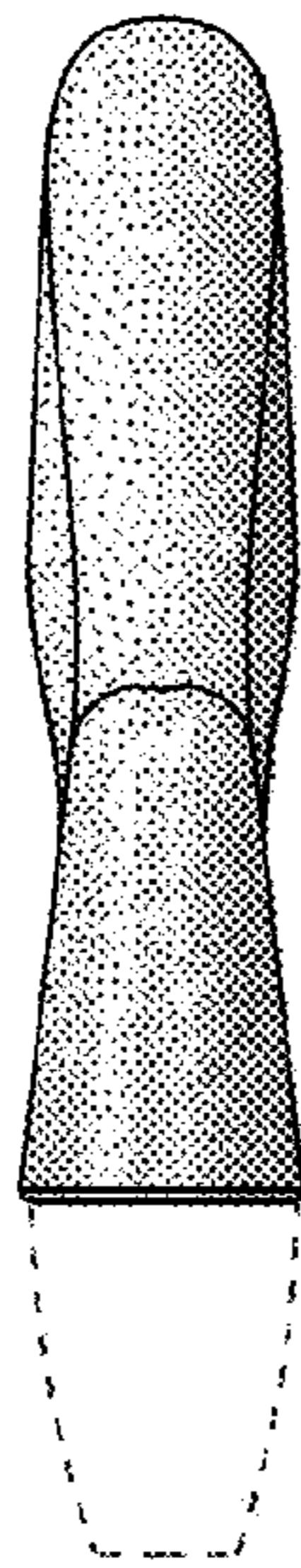

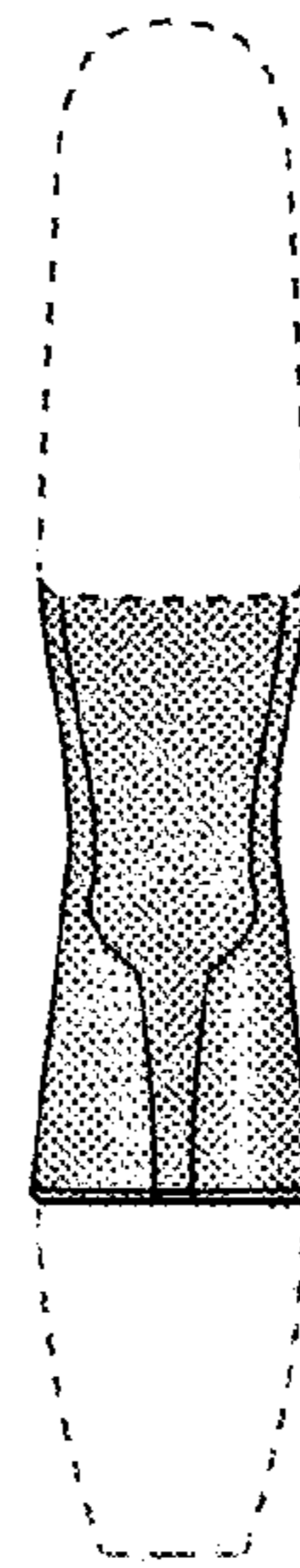

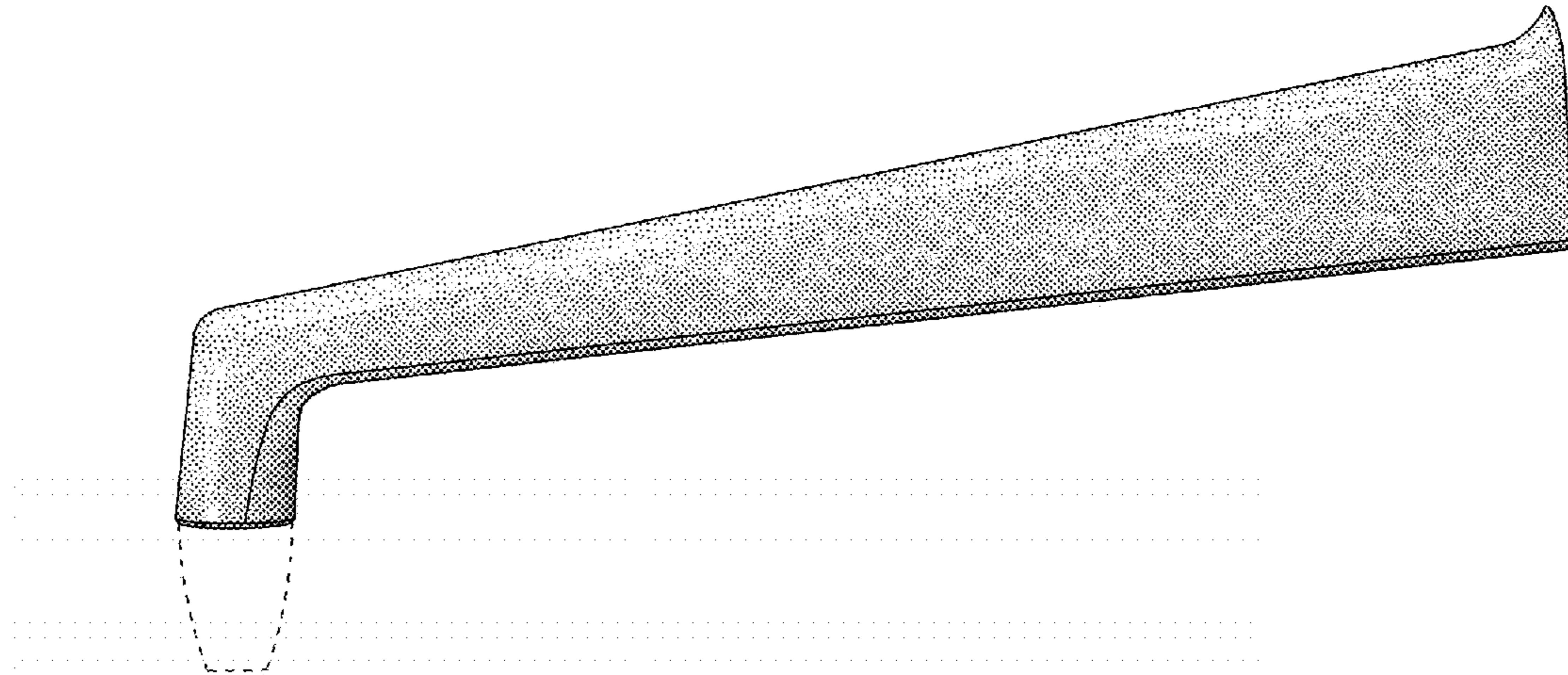

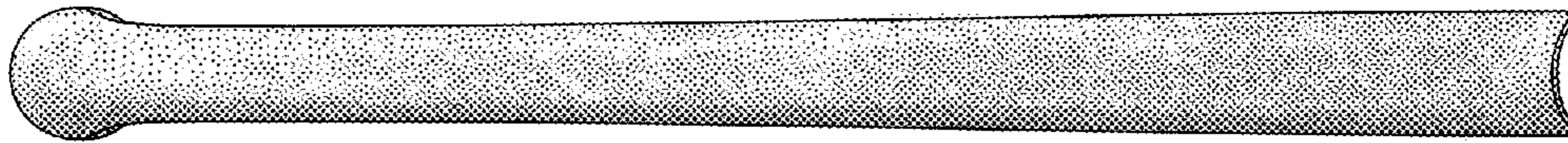

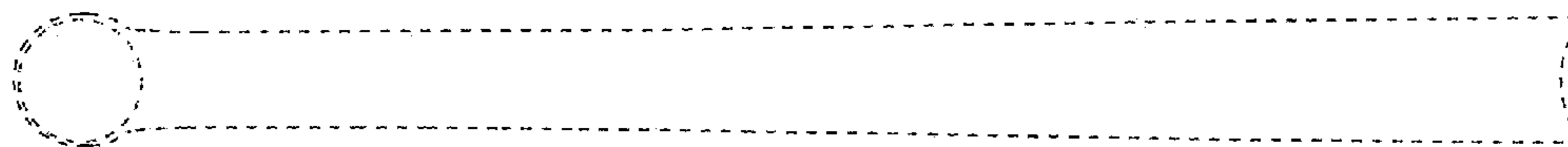

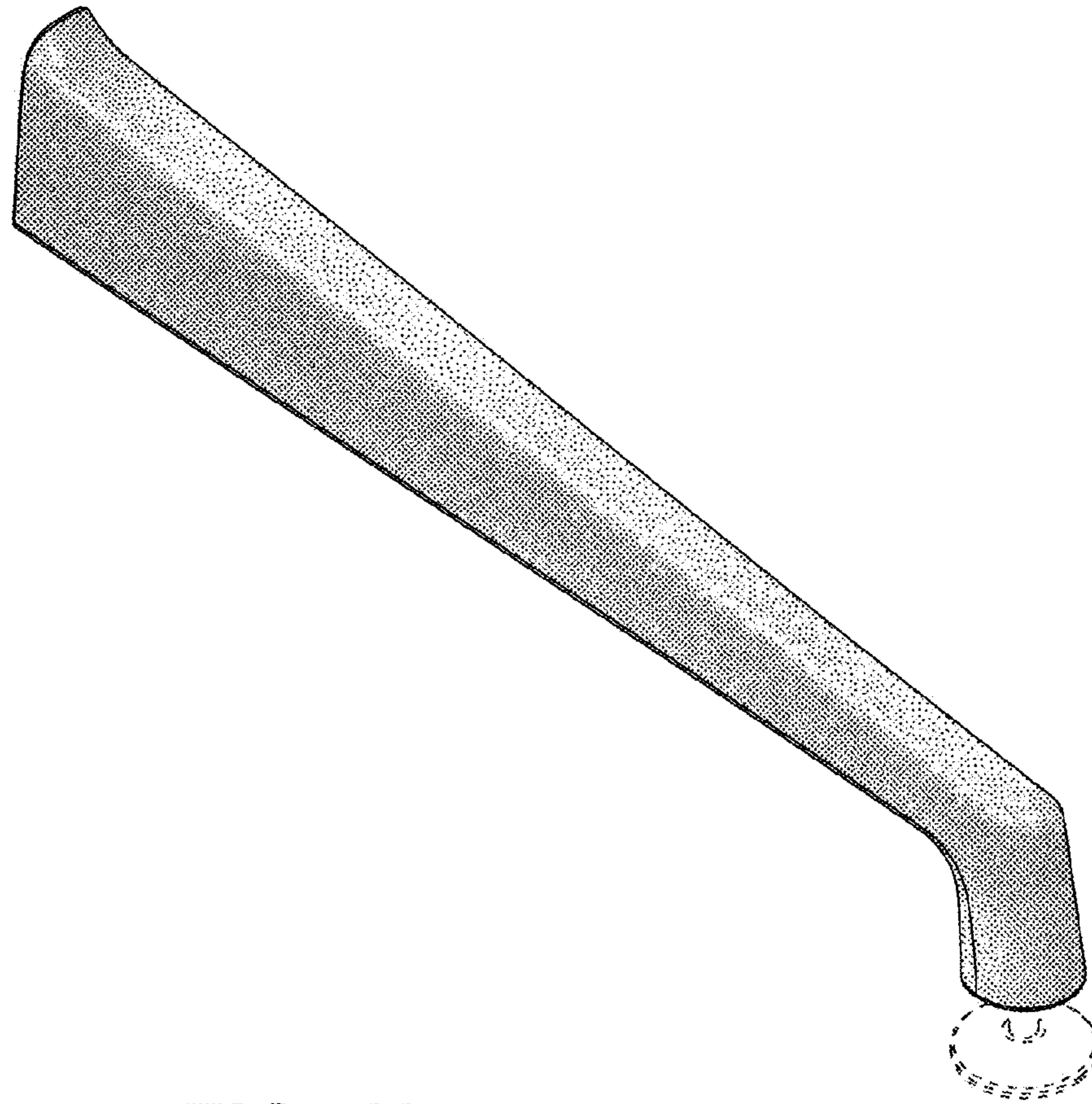

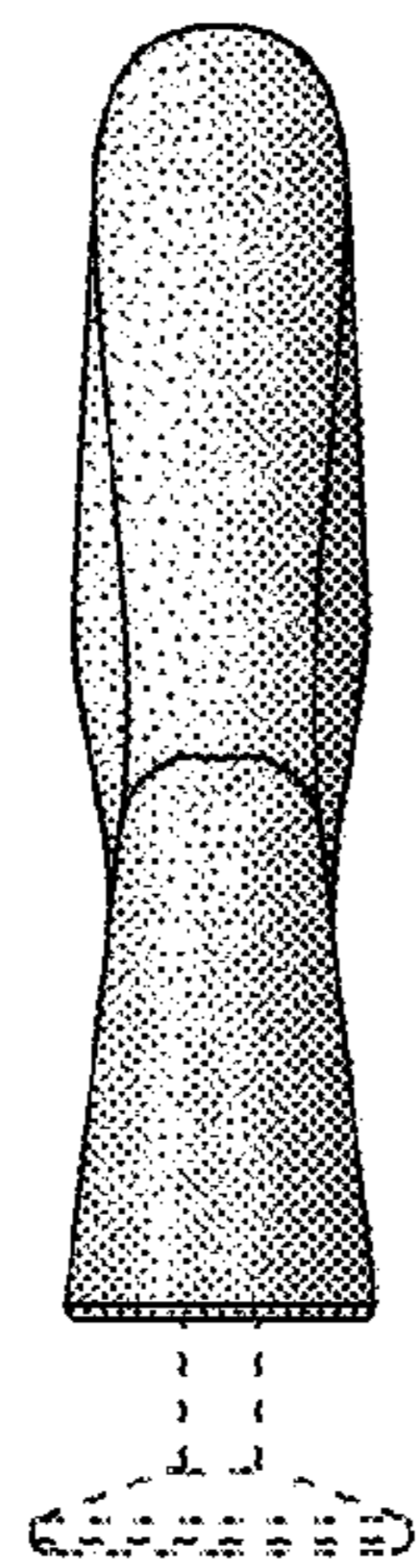

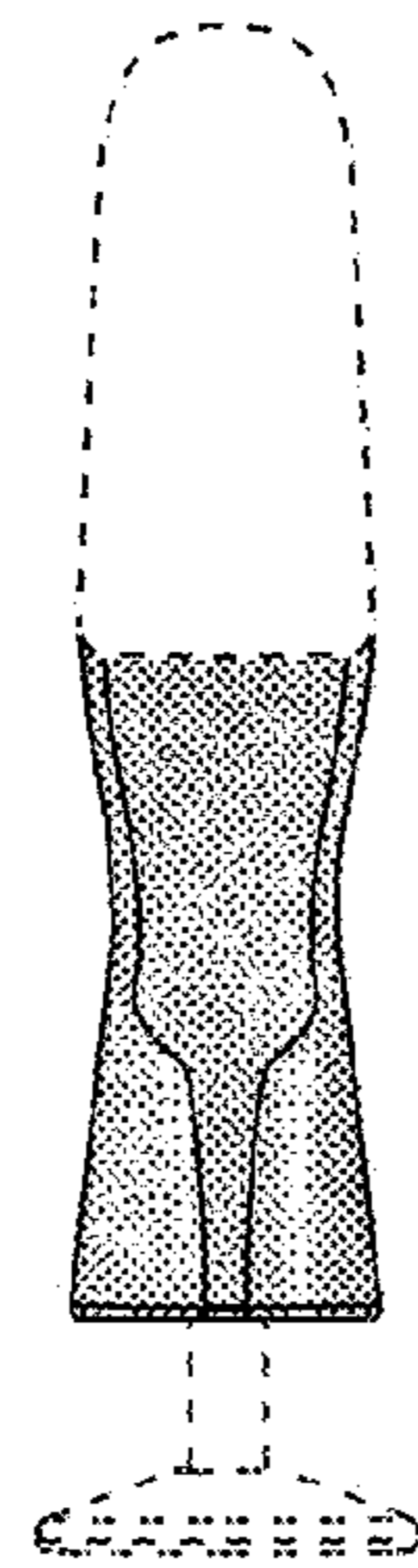

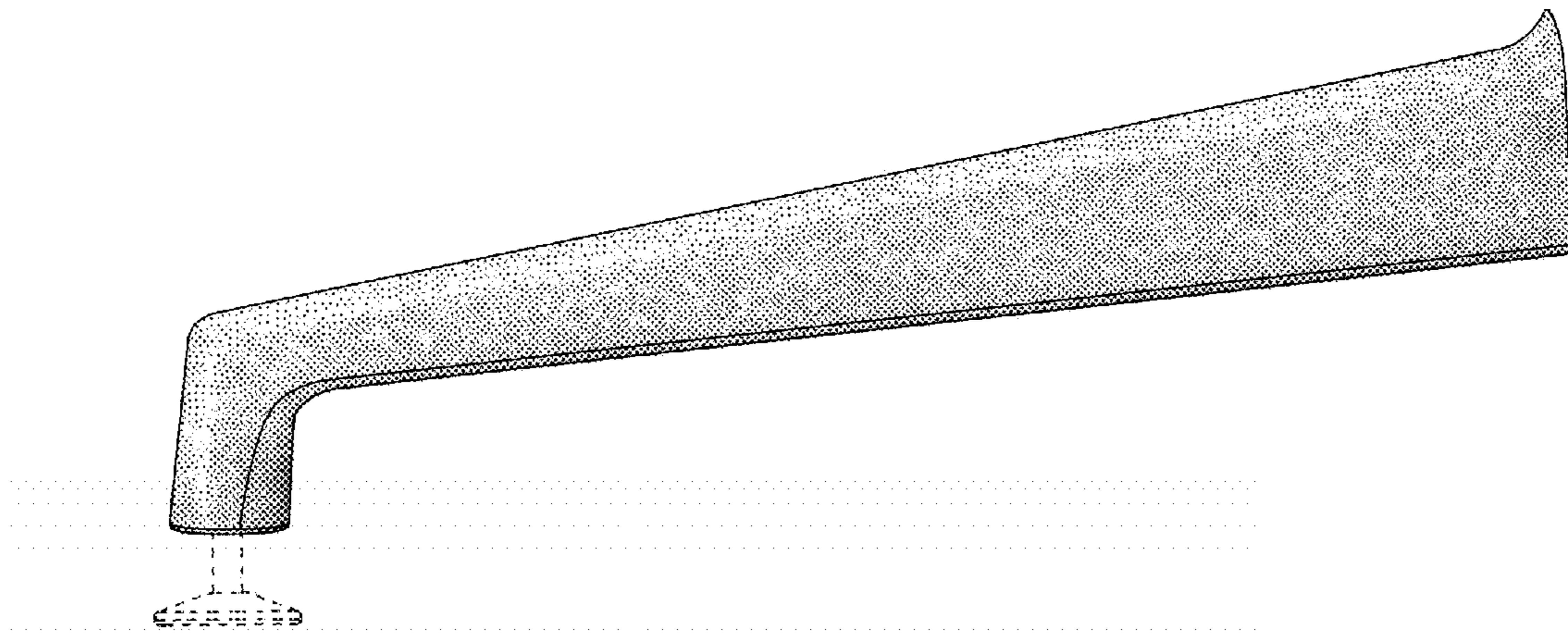

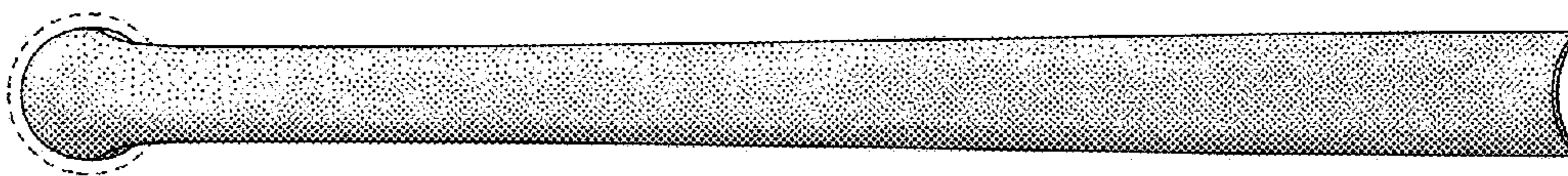

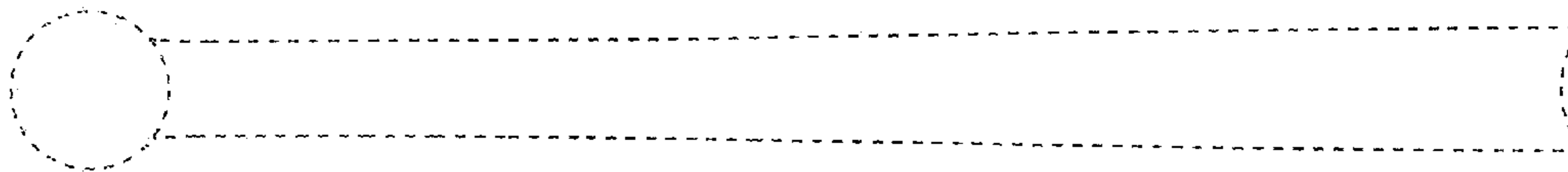

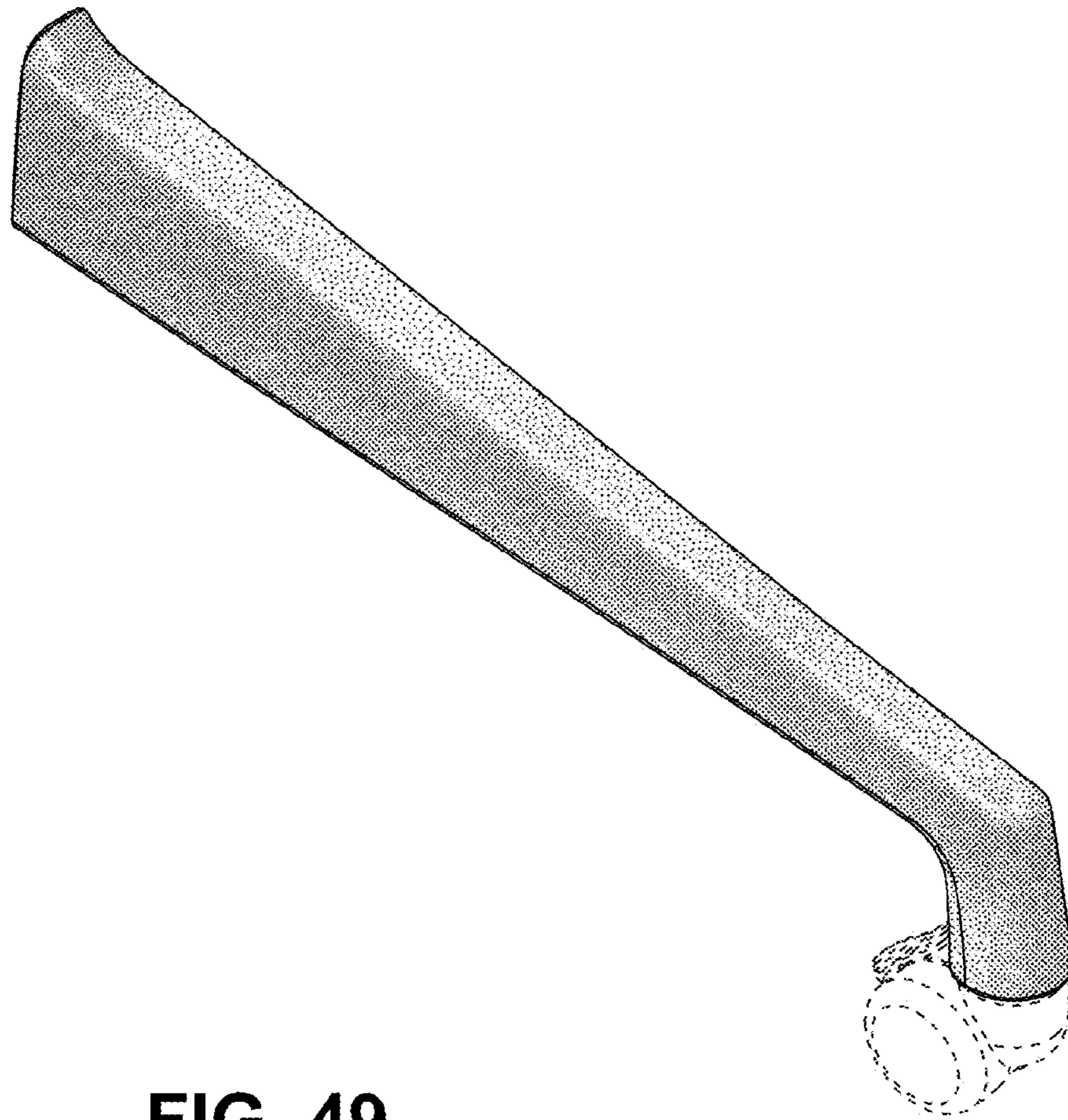

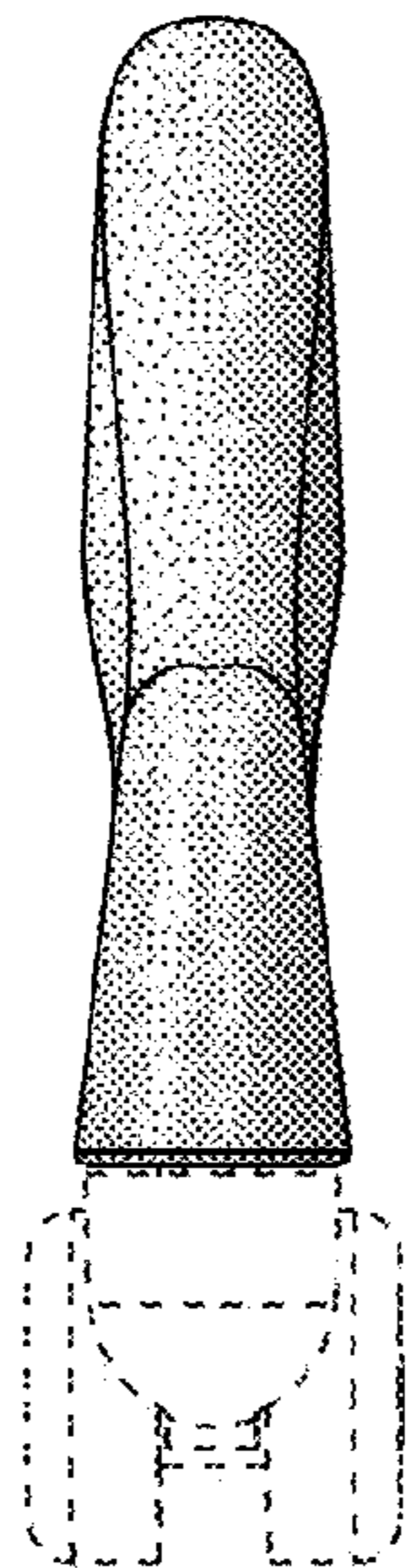

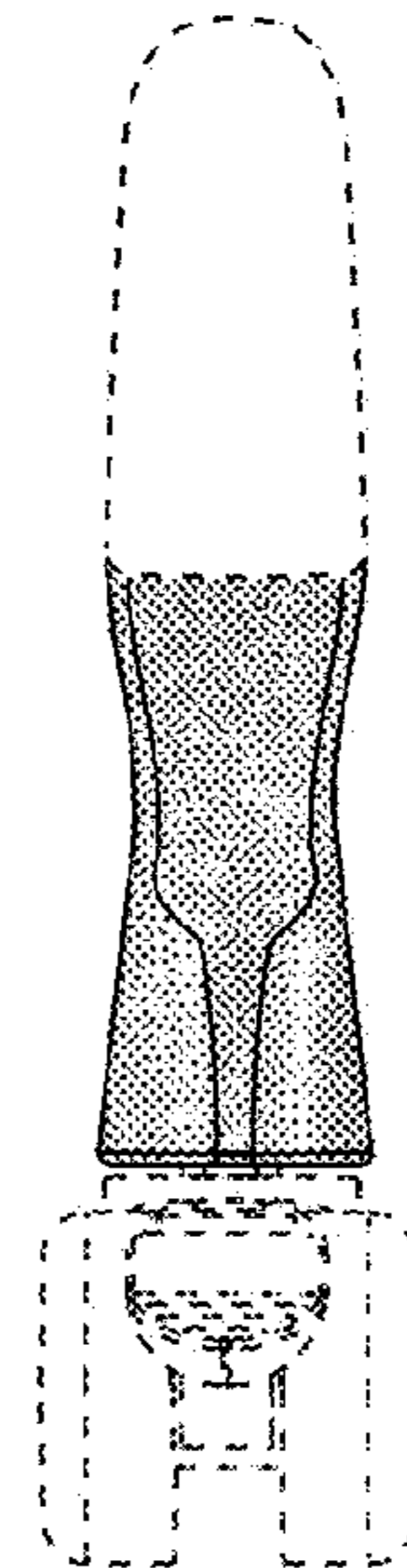

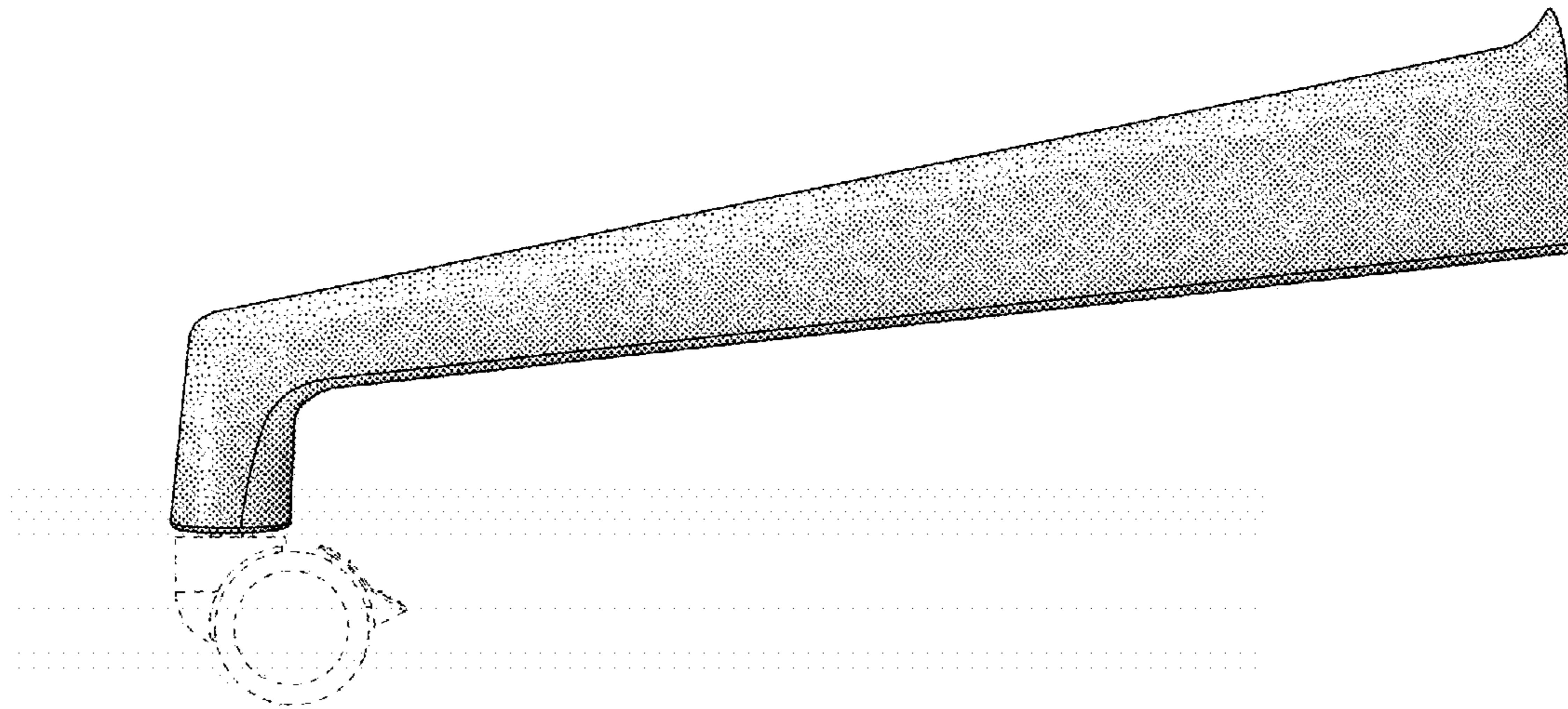

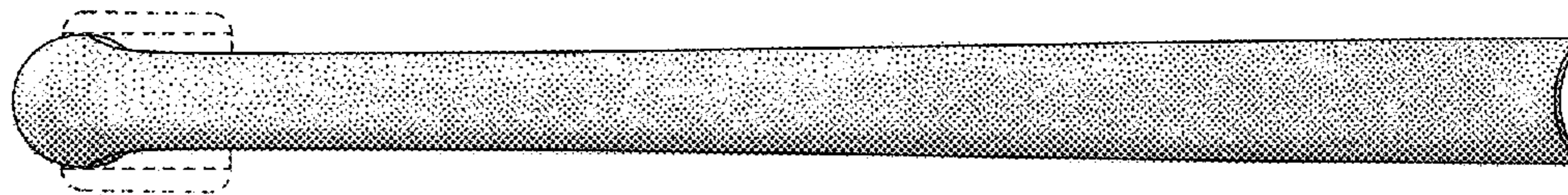

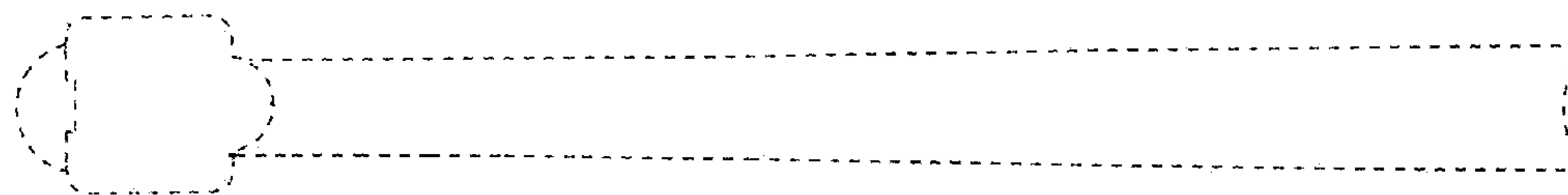
