We claim the ornamental design for a toaster, as shown and described.

DESCRIPTION

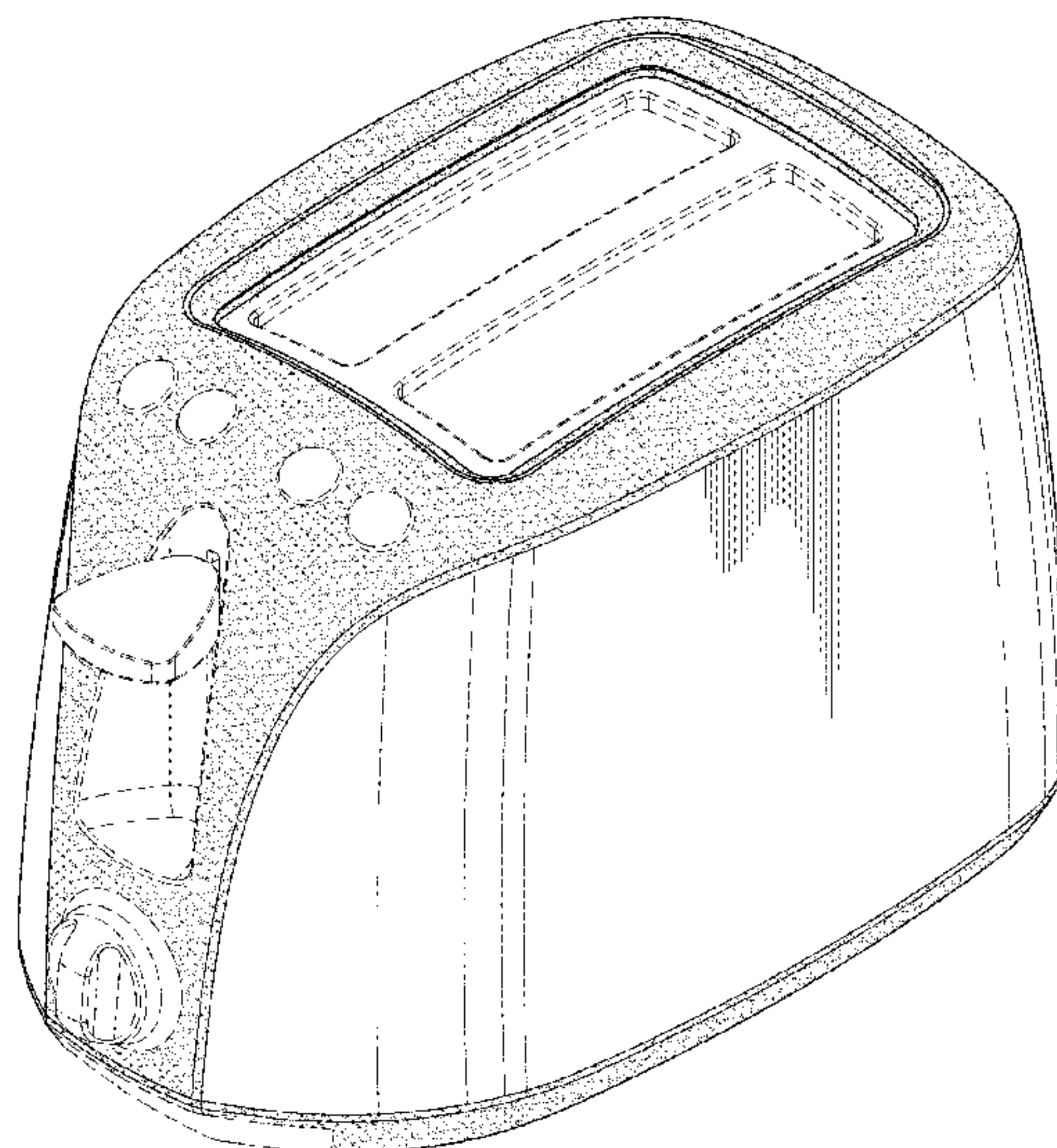

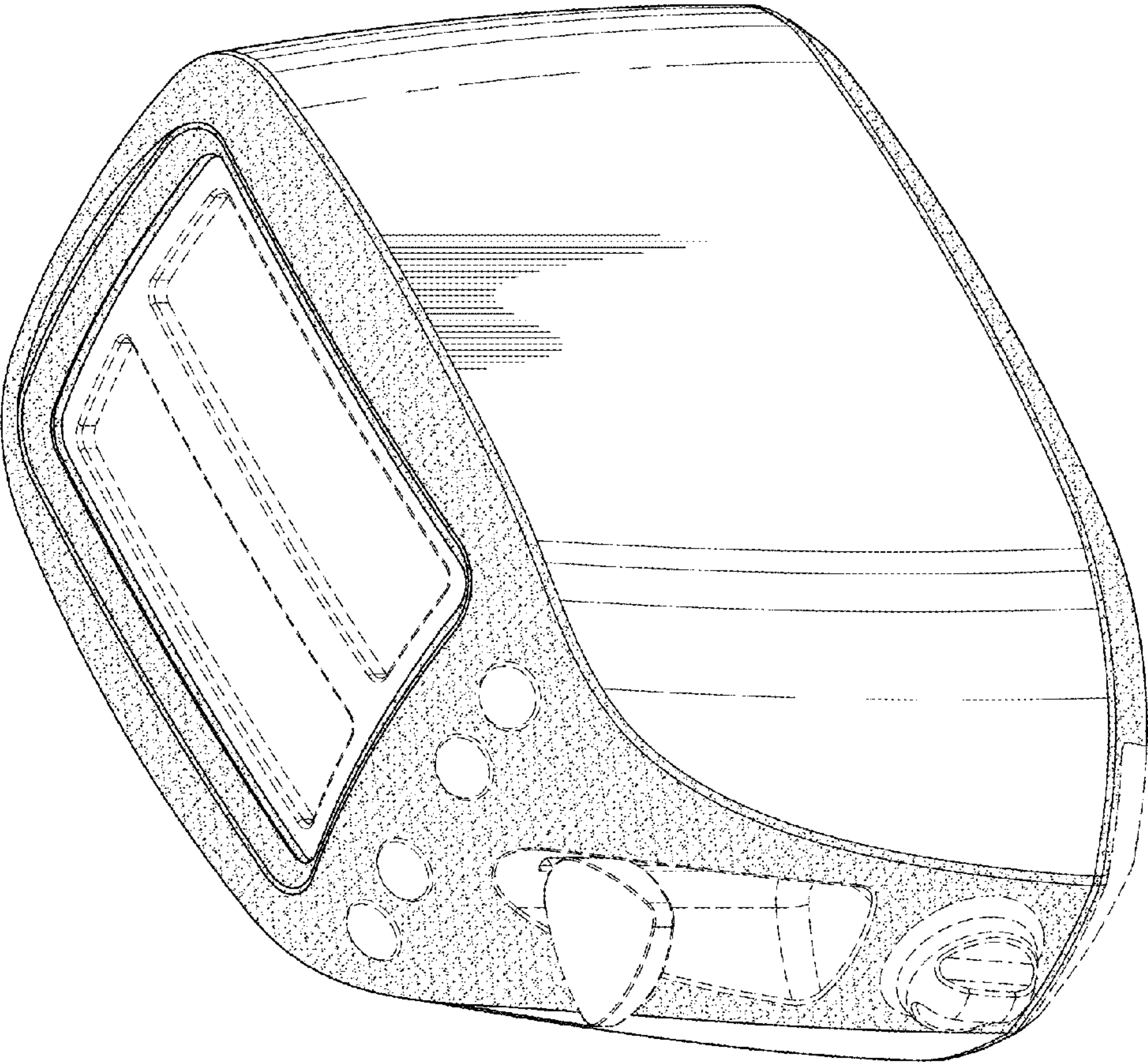
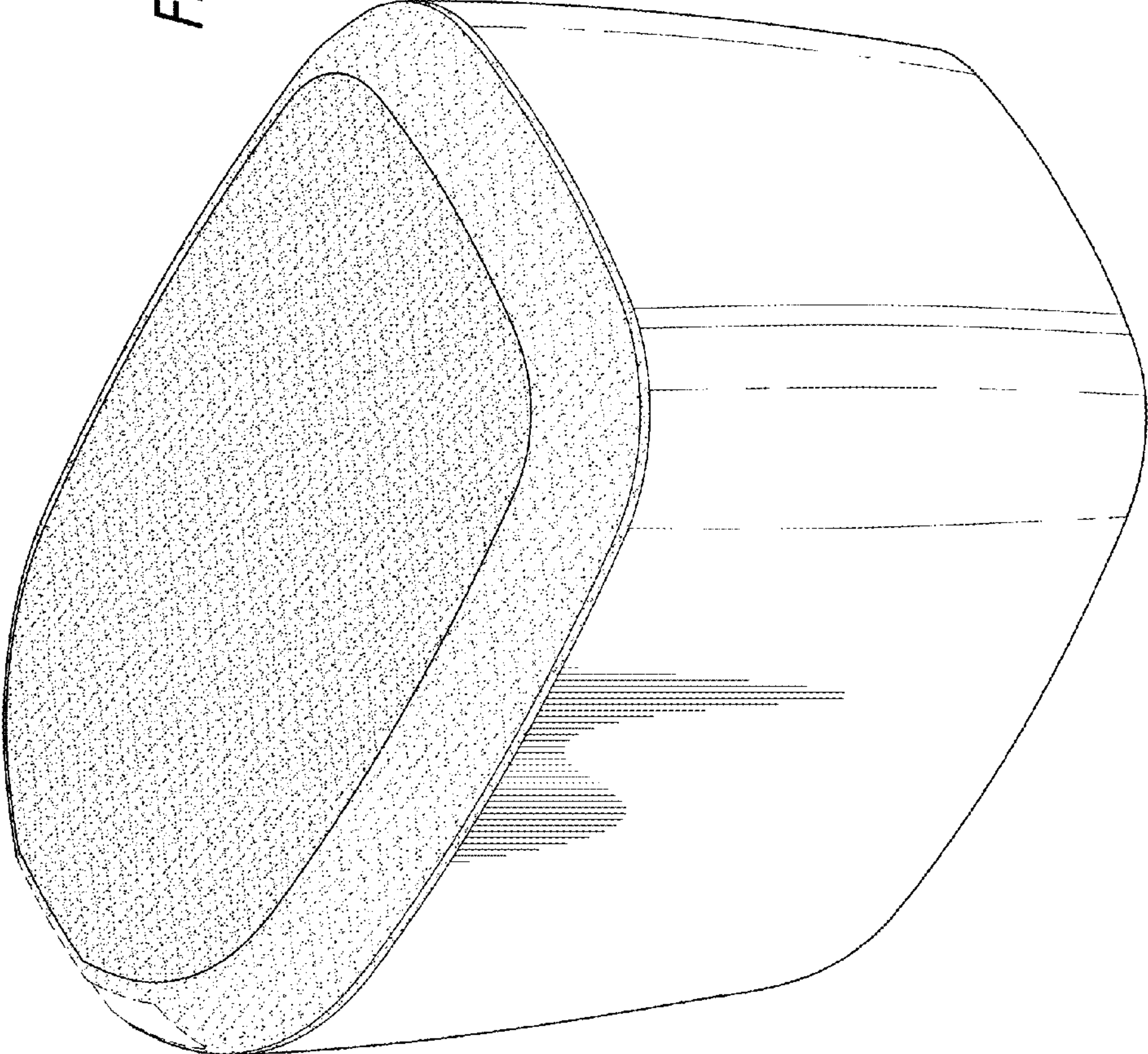

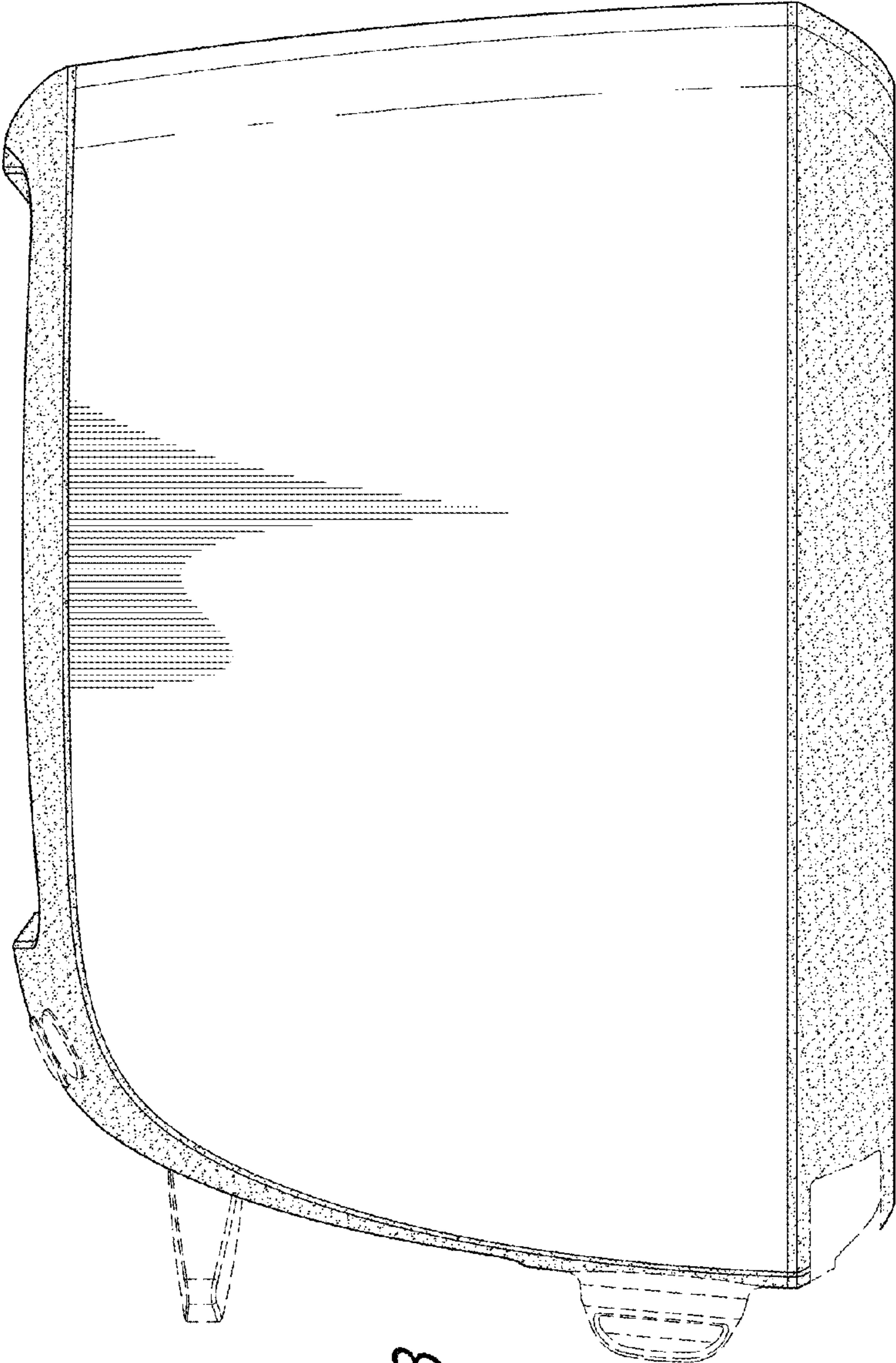

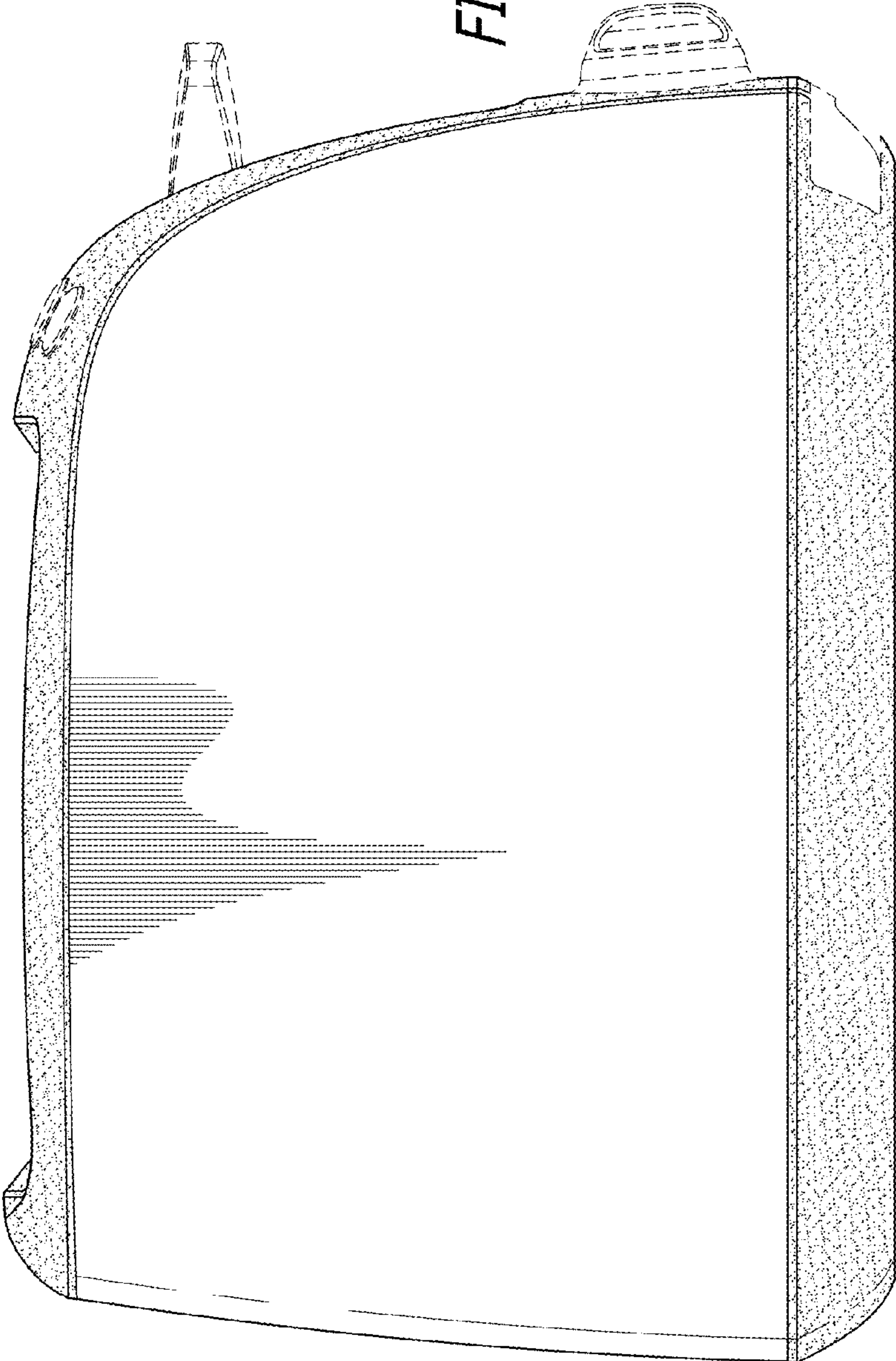

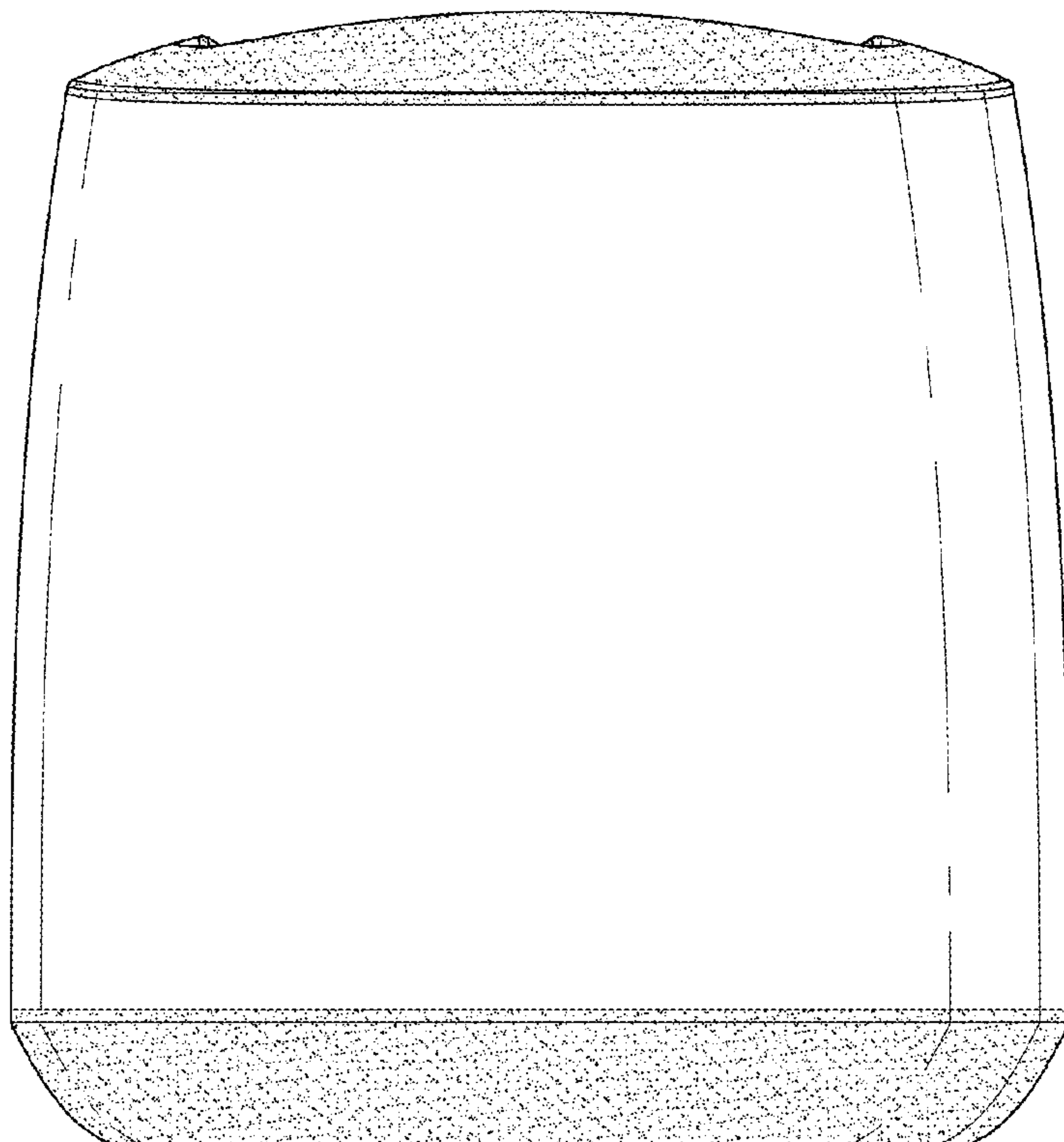
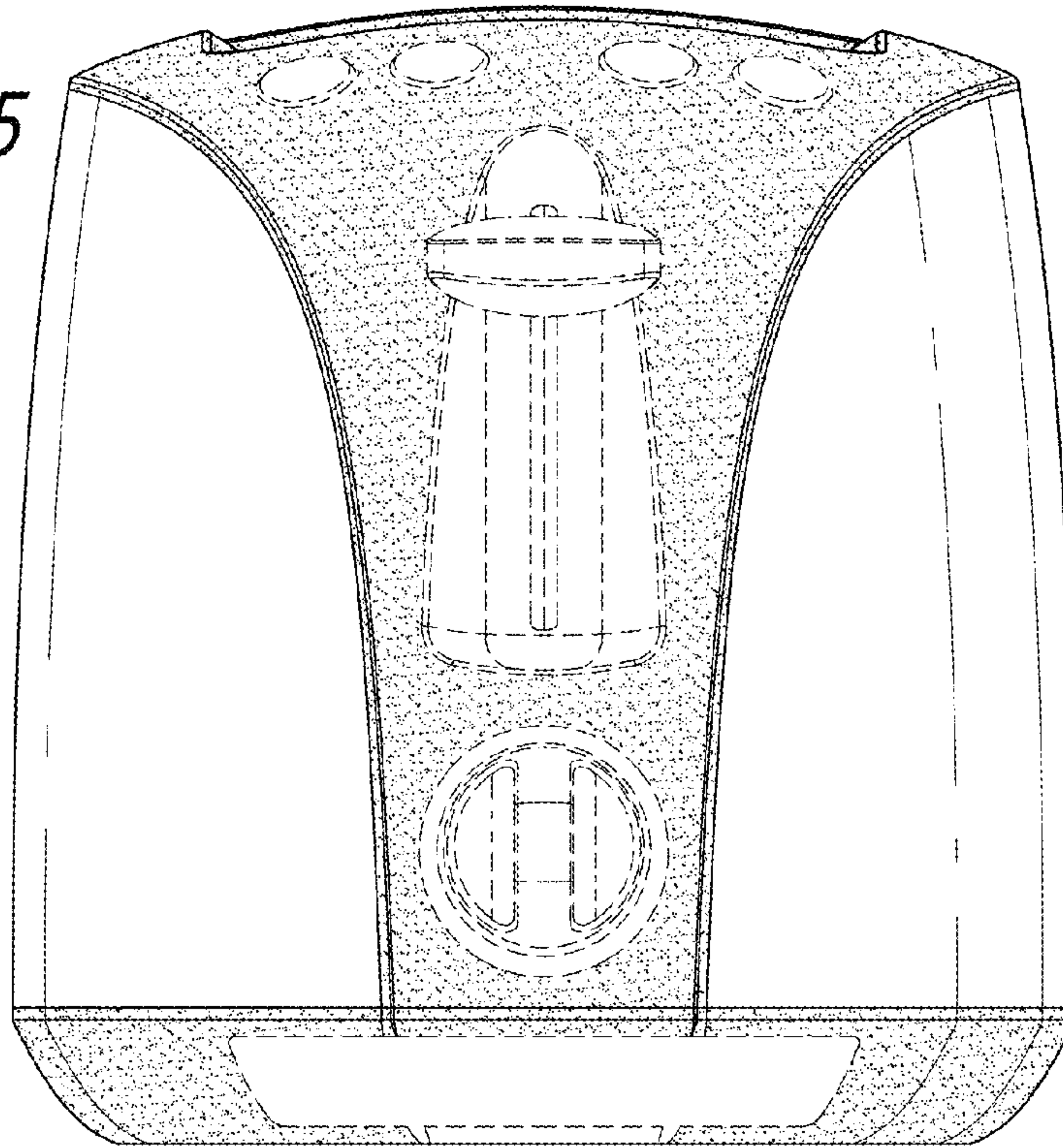

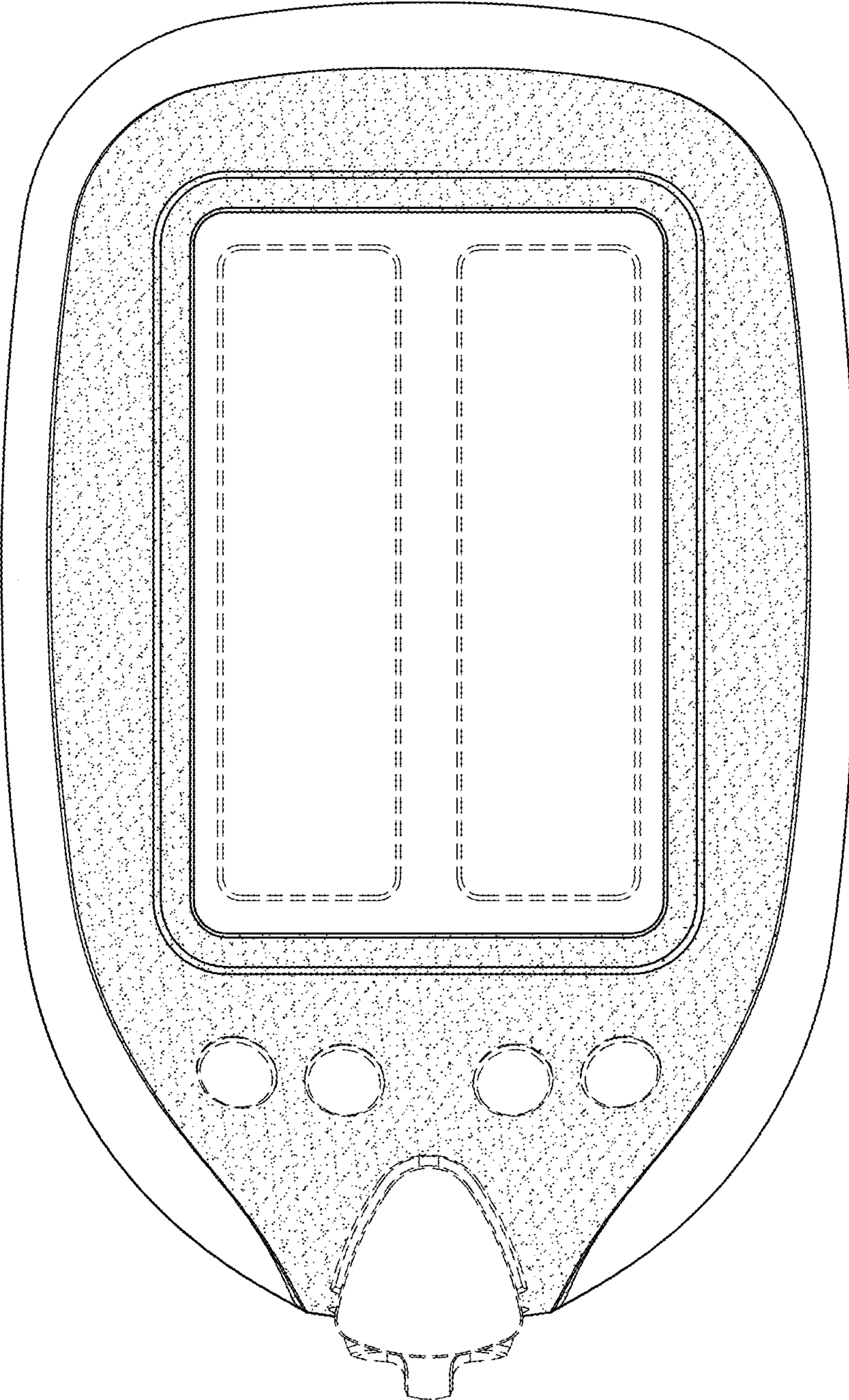

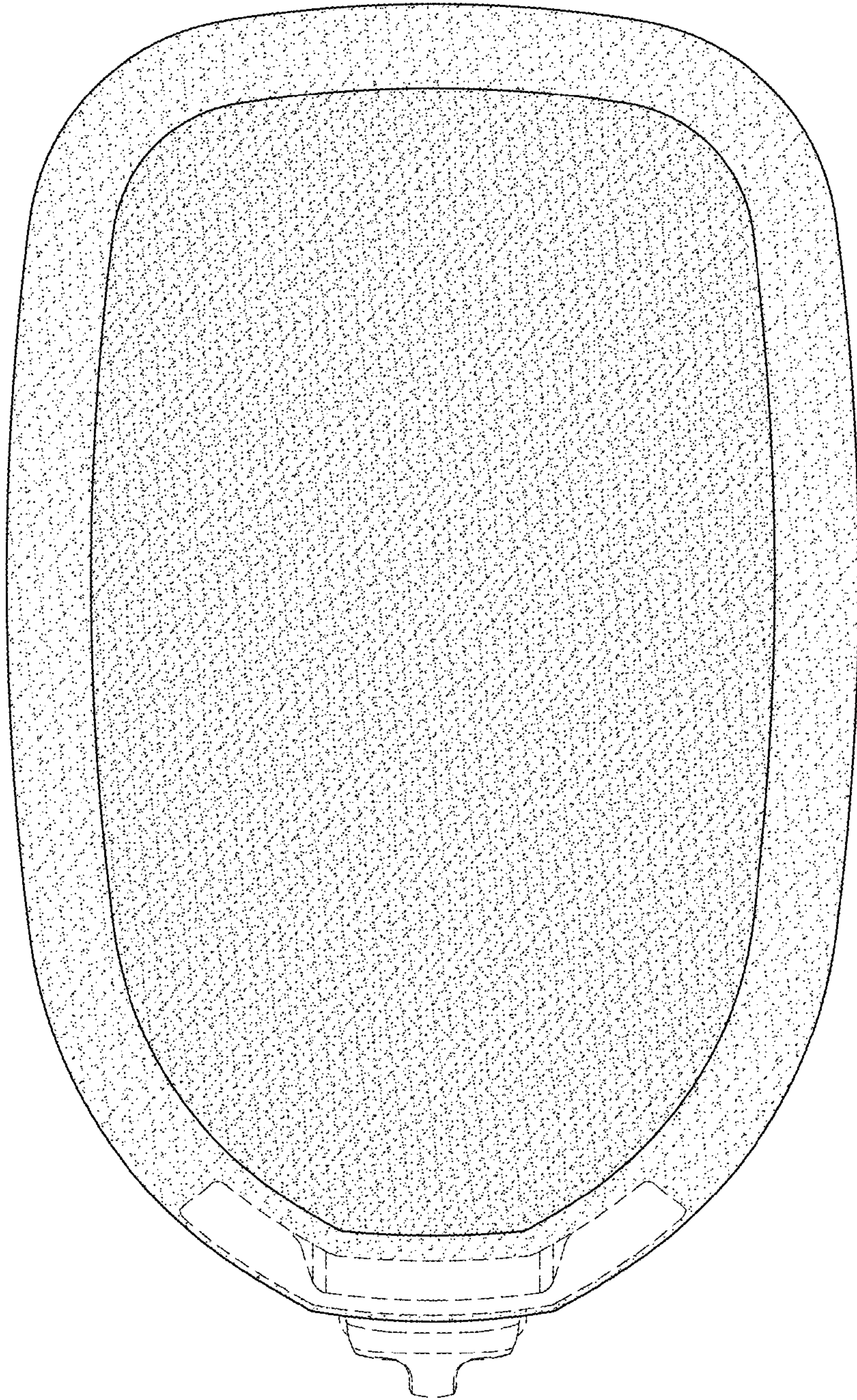
