(57) **CLAIM**

The ornamental design for a container seal with tabs, as shown and described.

**DESCRIPTION**

This application is related to co-pending U.S. patent application Ser. Nos. 29/520,688; 29/520,704; and 29/520,706, which are incorporated by reference herein.

FIG. 1 is a top, front and right side perspective view of a container seal with tabs showing my new design;

FIG. 2 is a bottom, rear and right side perspective view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a front elevation view, the rear elevation being identical thereto;

FIG. 6 is a right side elevation view, the left side being identical thereto; and,

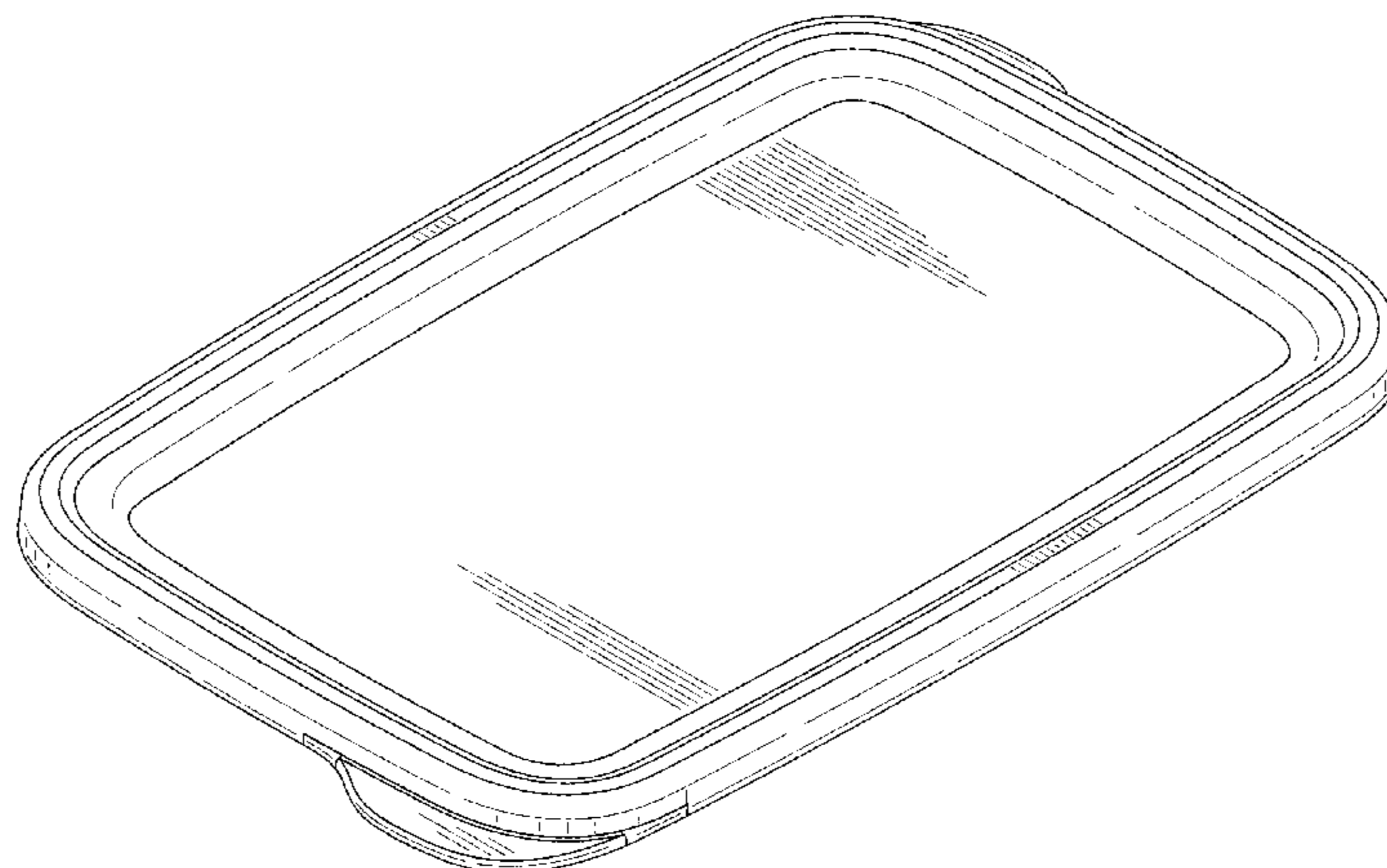
FIG. 7 is a cross-sectional view taken along line 7-7 of FIG. 3.

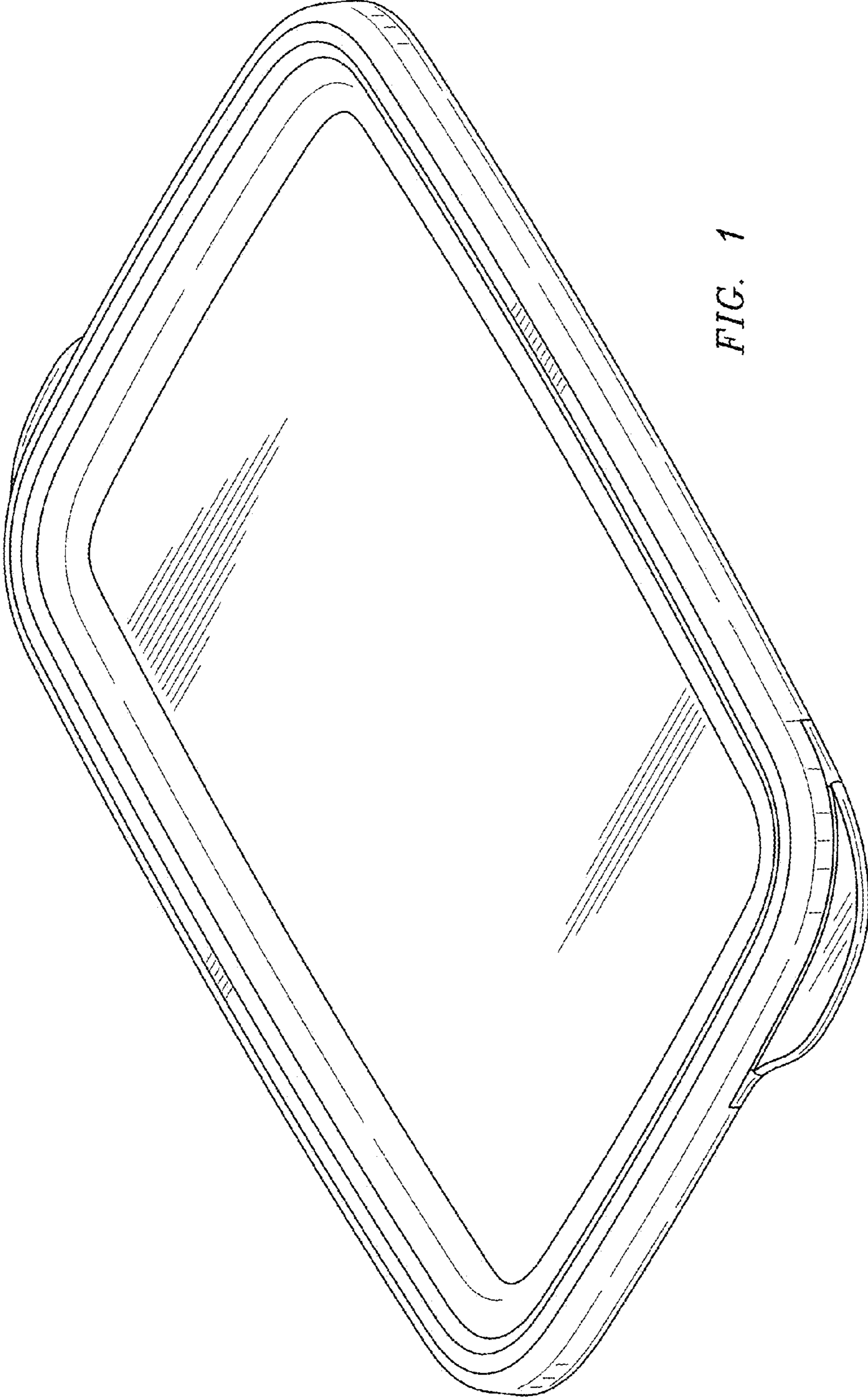

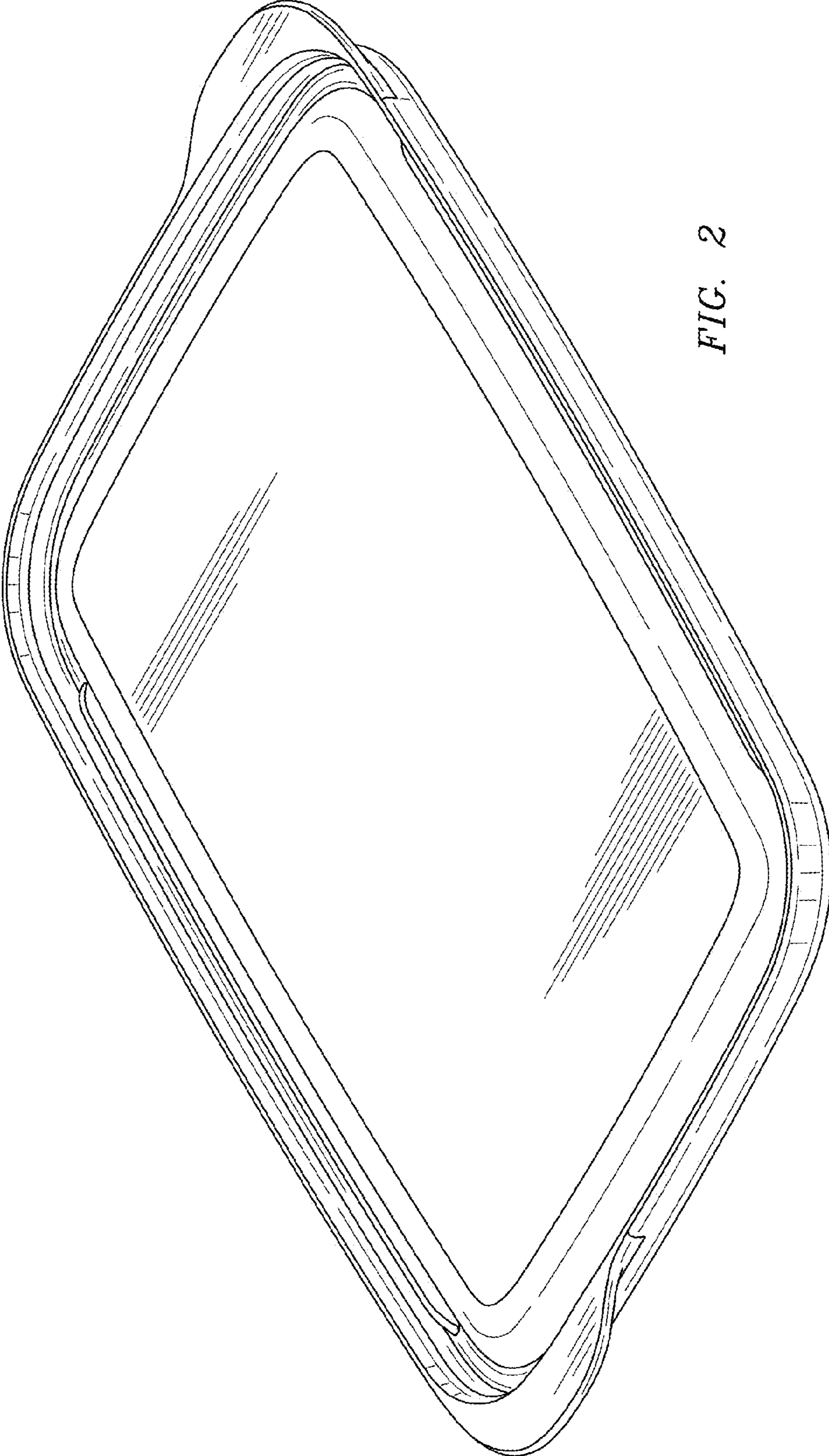

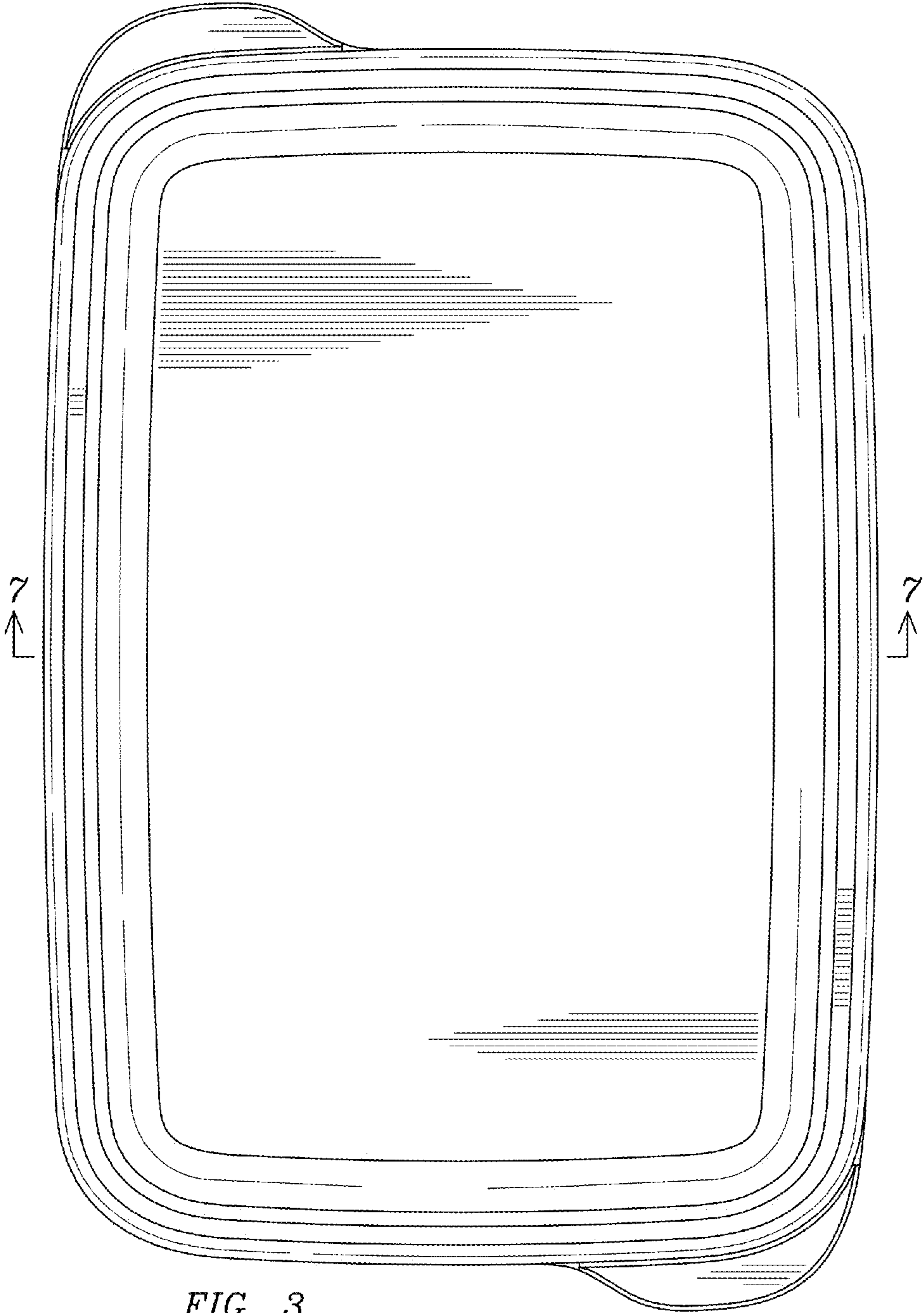

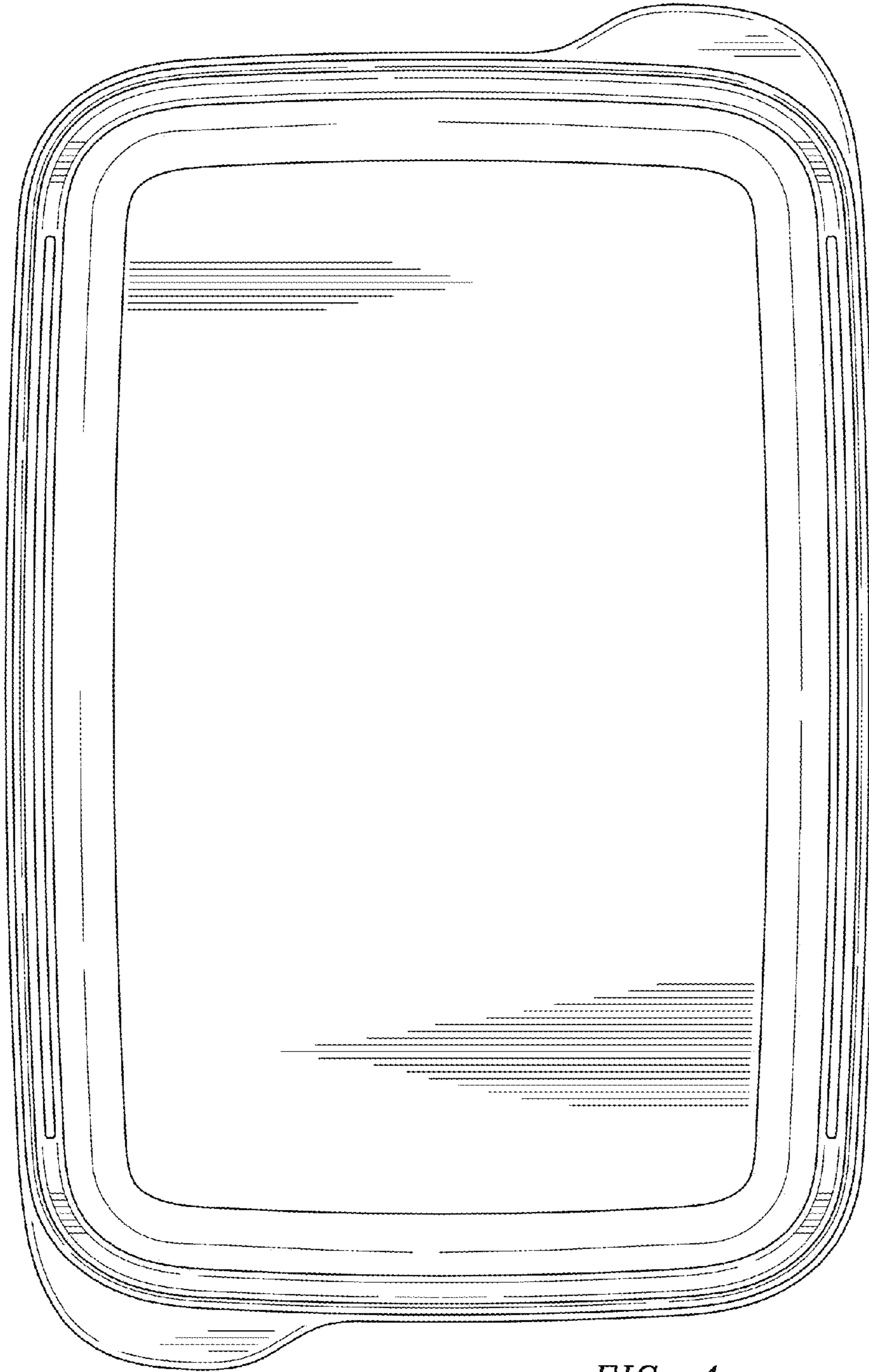

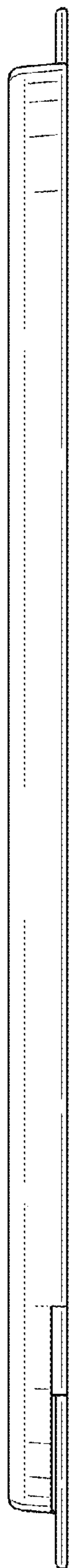

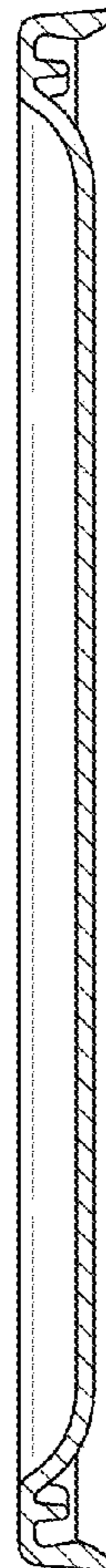
