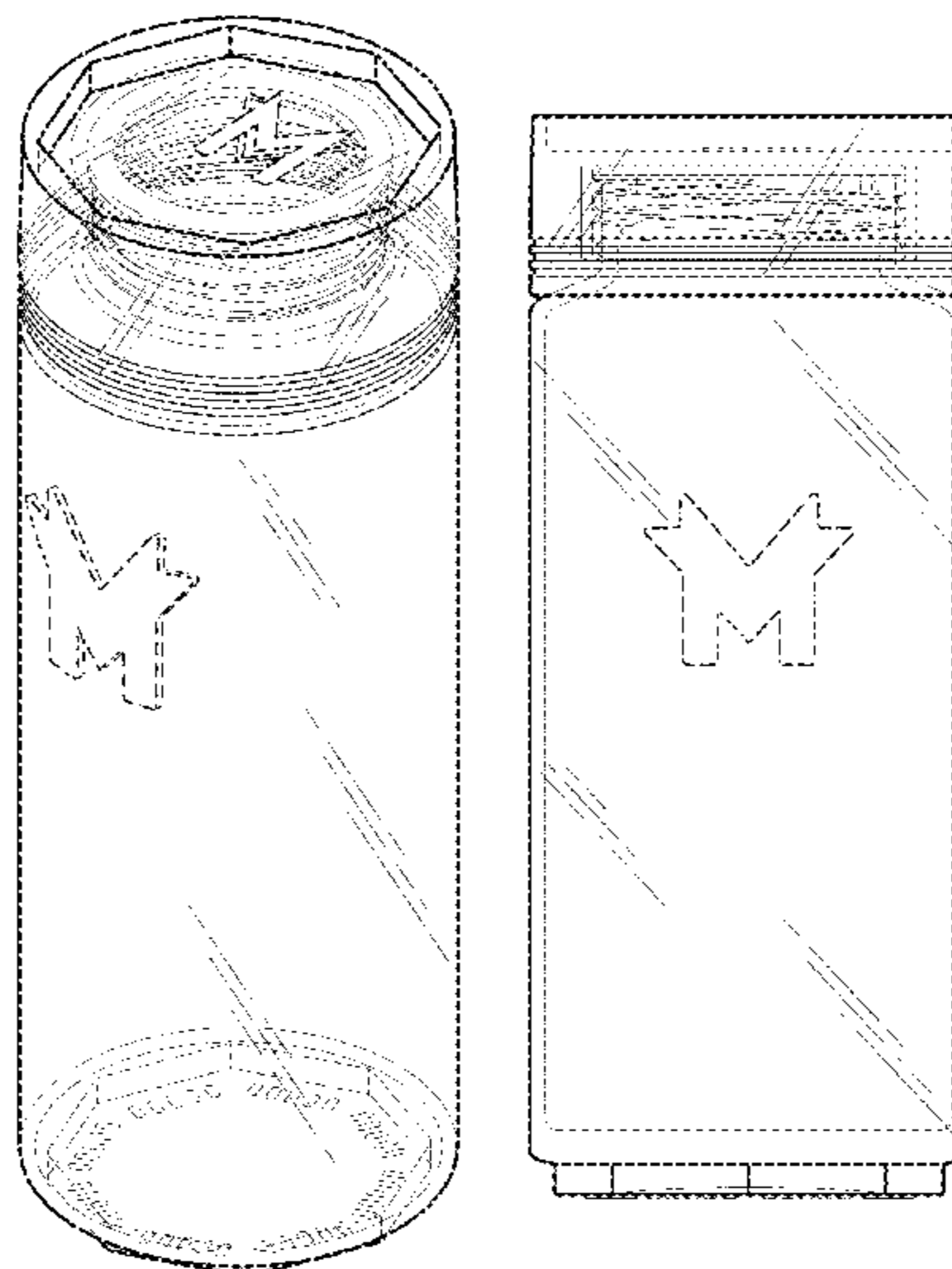
(57) **CLAIM**

The ornamental design for a stackable beverage container with cap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a stackable beverage container with cap in its closed position showing my new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a perspective view of the stackable beverage container with cap in its opened position; FIG. 9 is a bottom perspective view of FIG. 1; and, FIG. 10 is an environmental front view of the stackable beverage container with cap in stacked in use position. 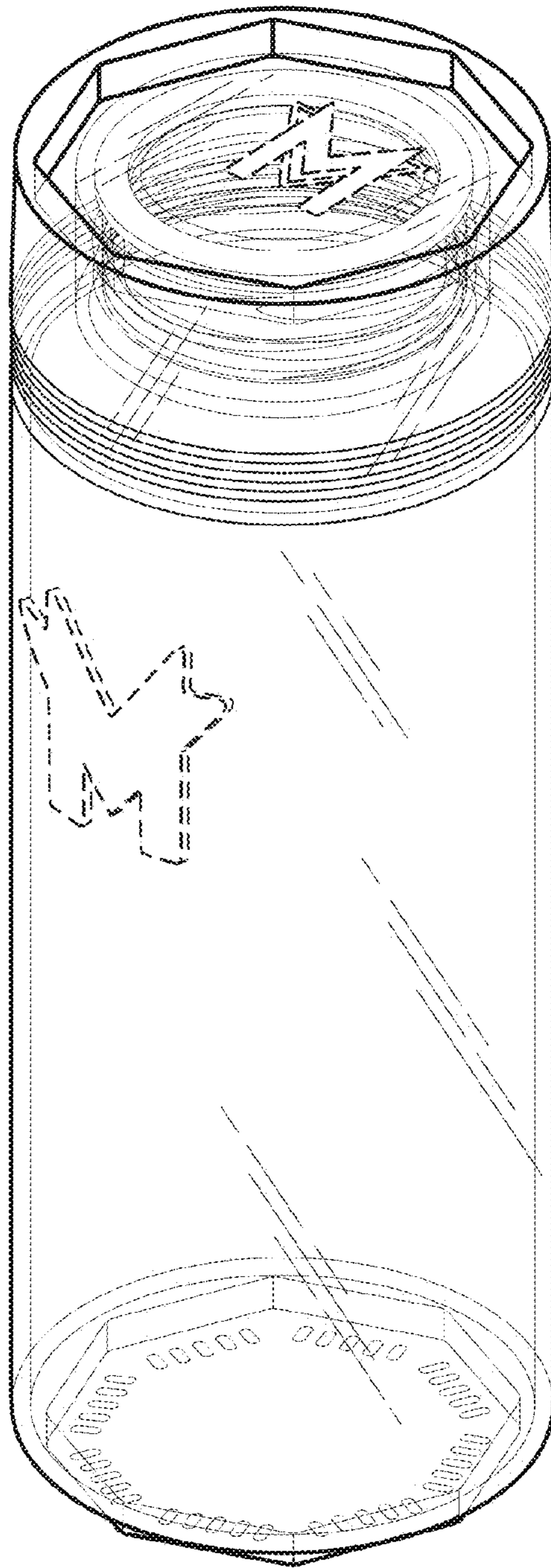

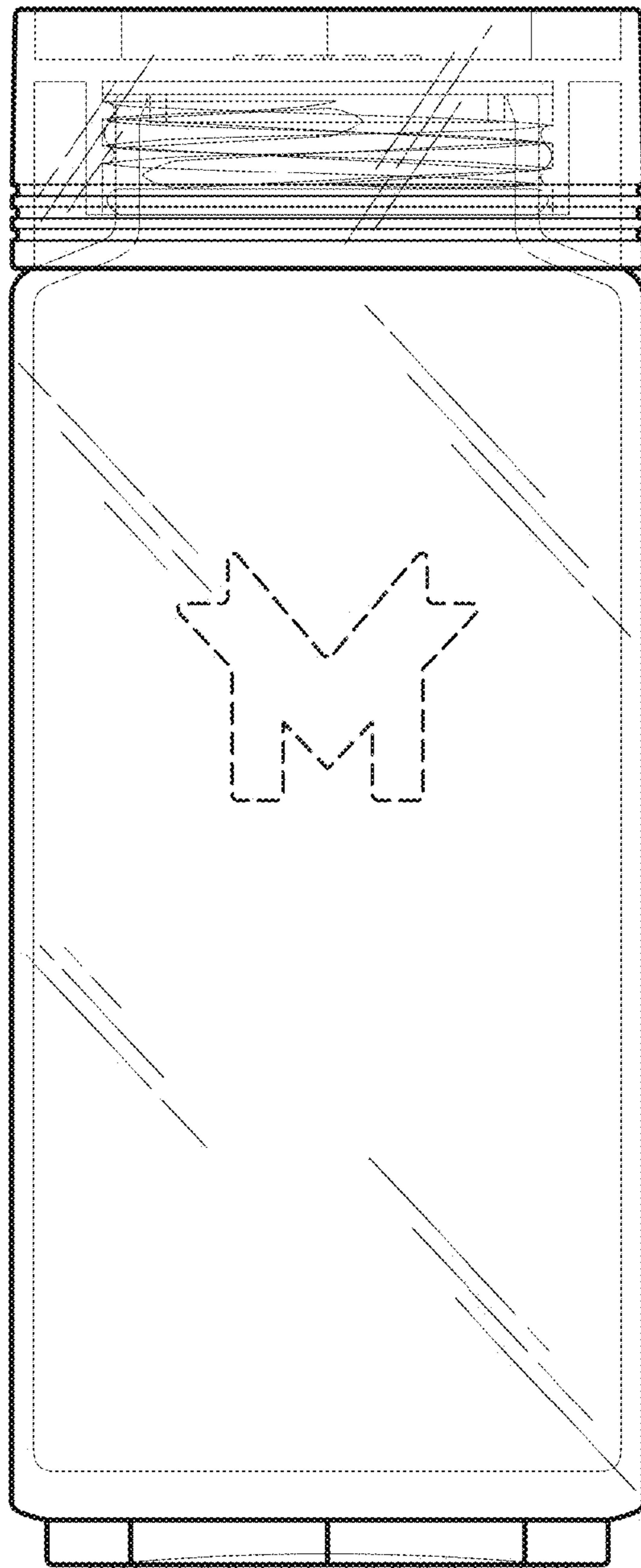

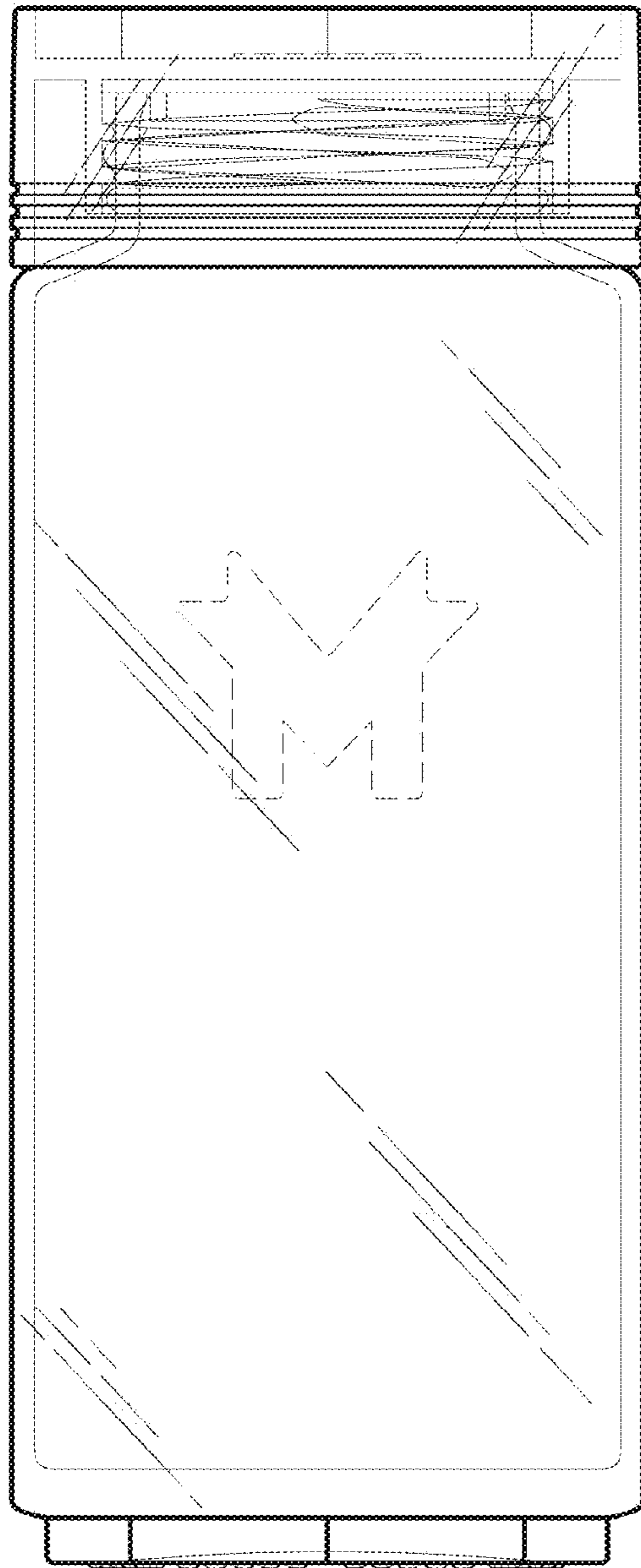

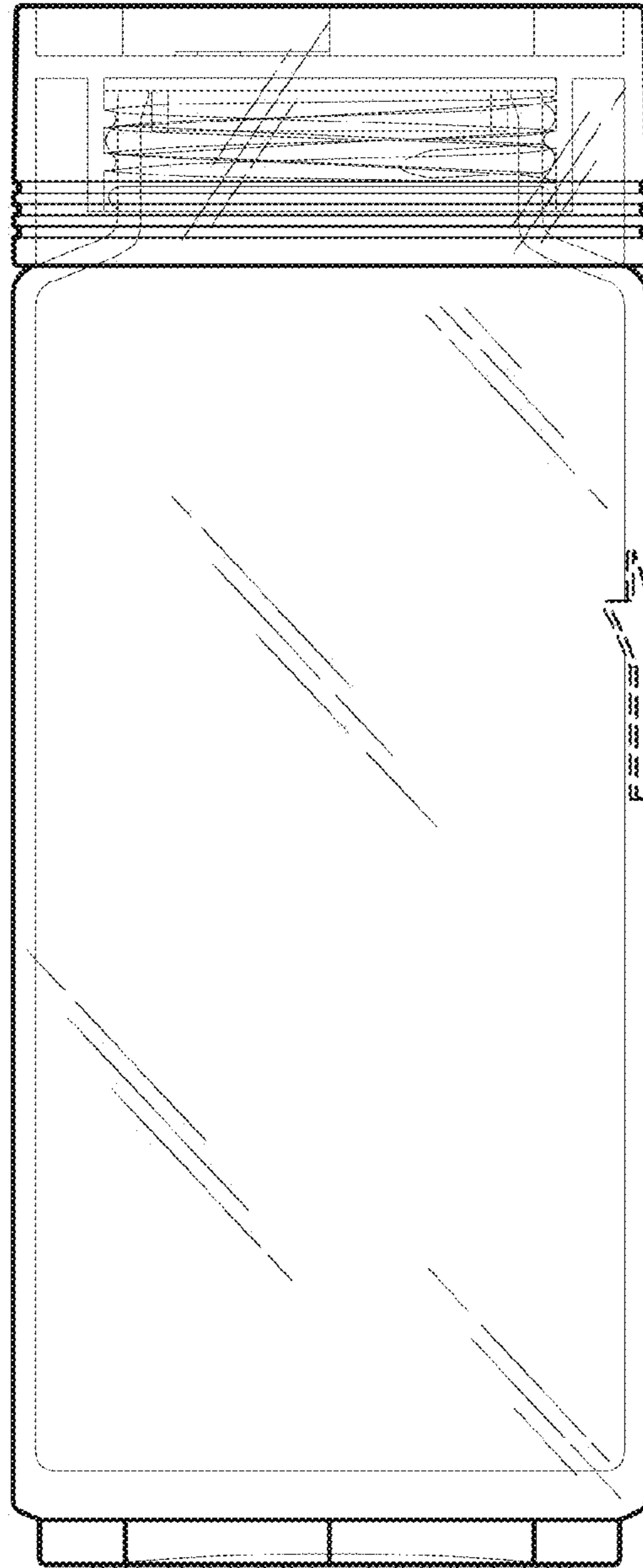

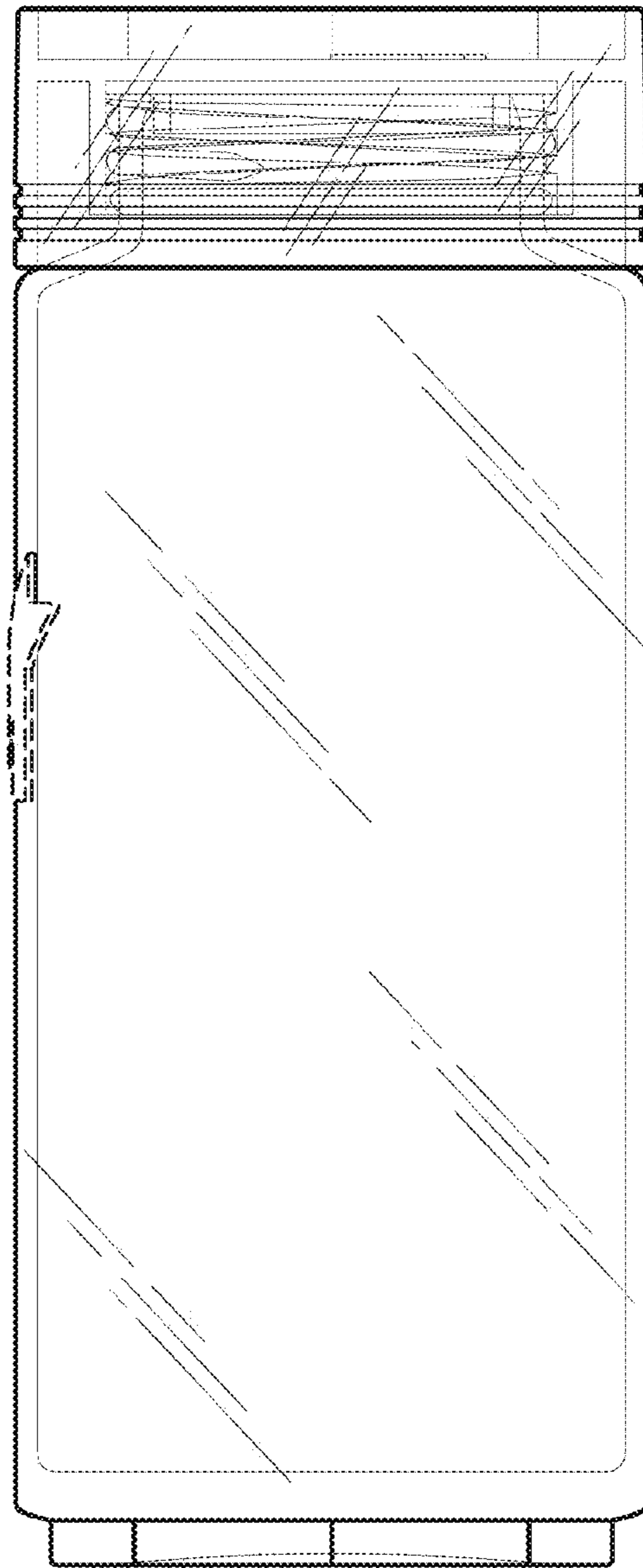

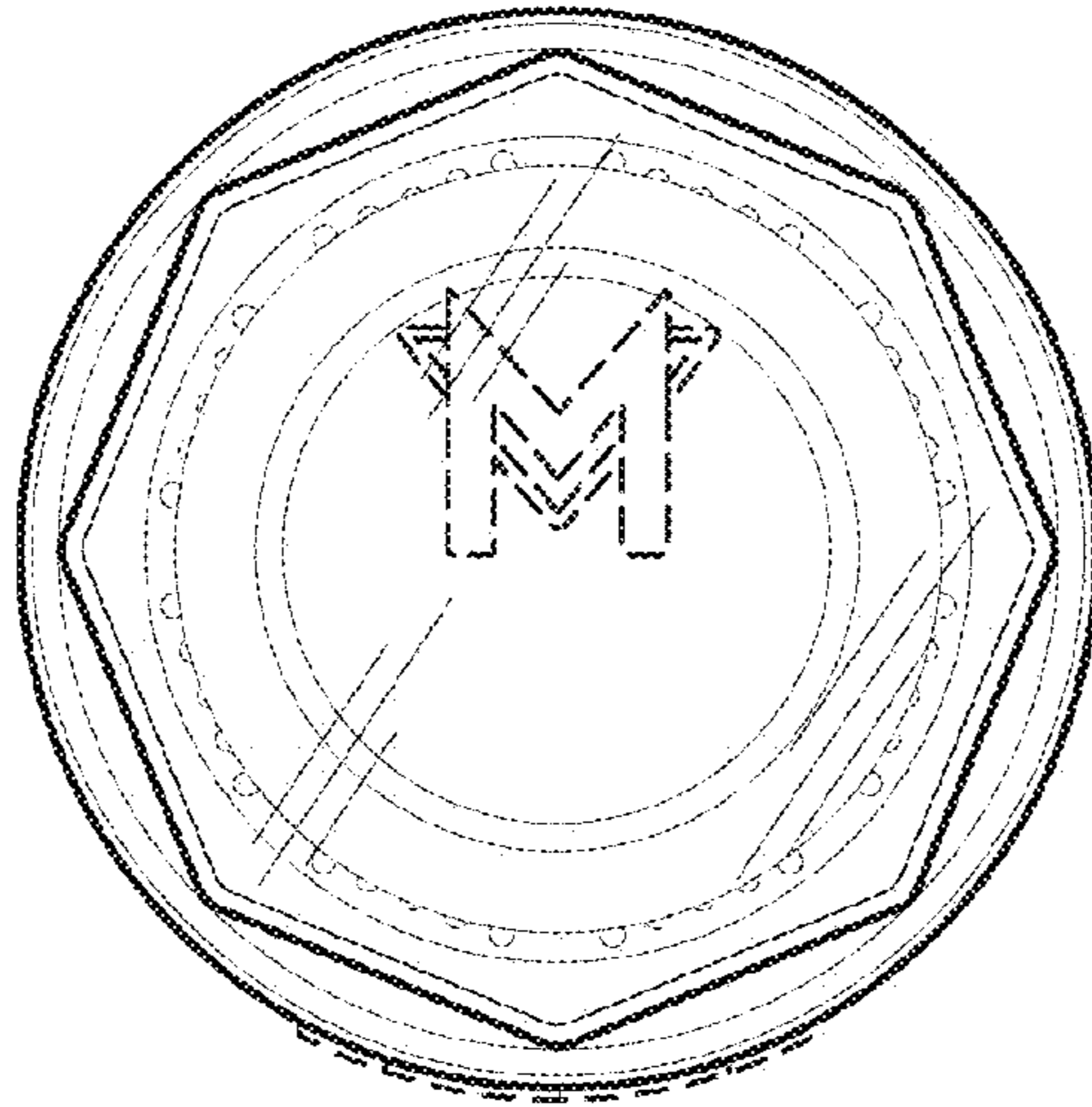

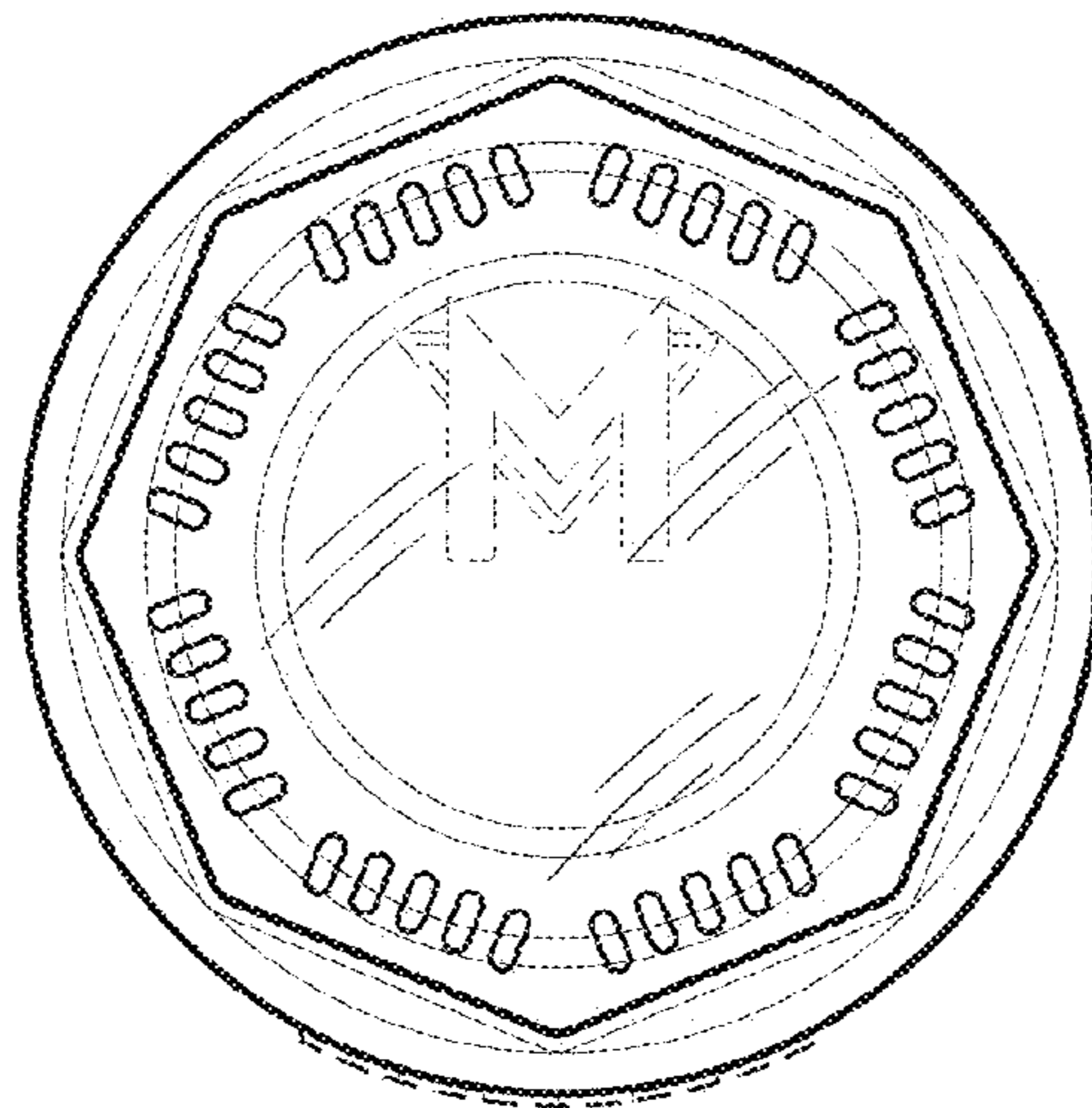

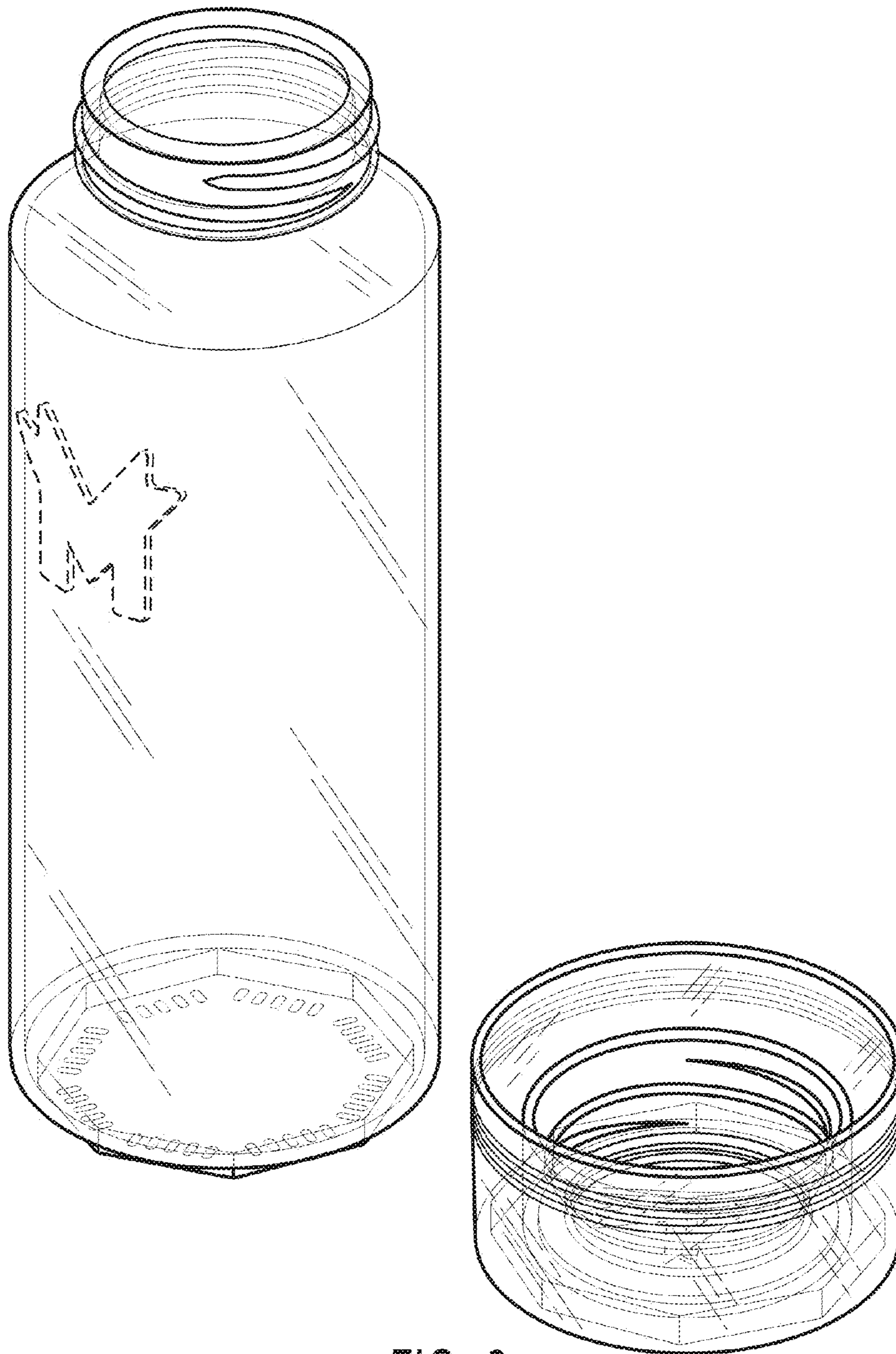

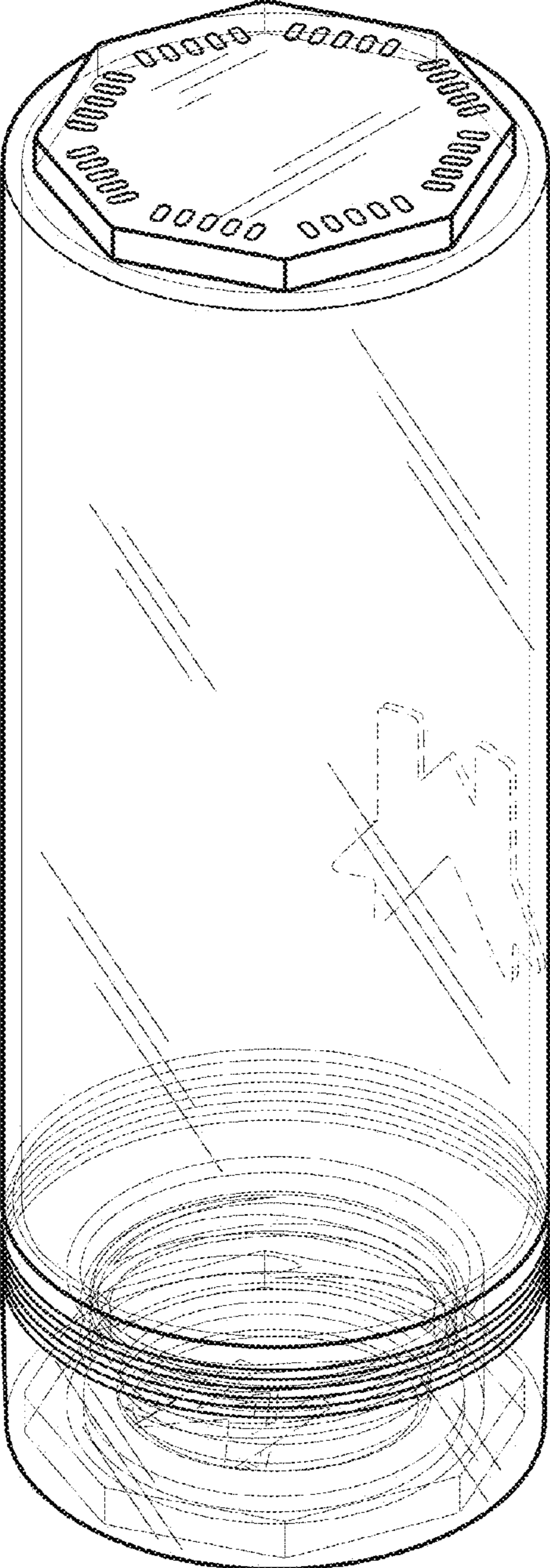

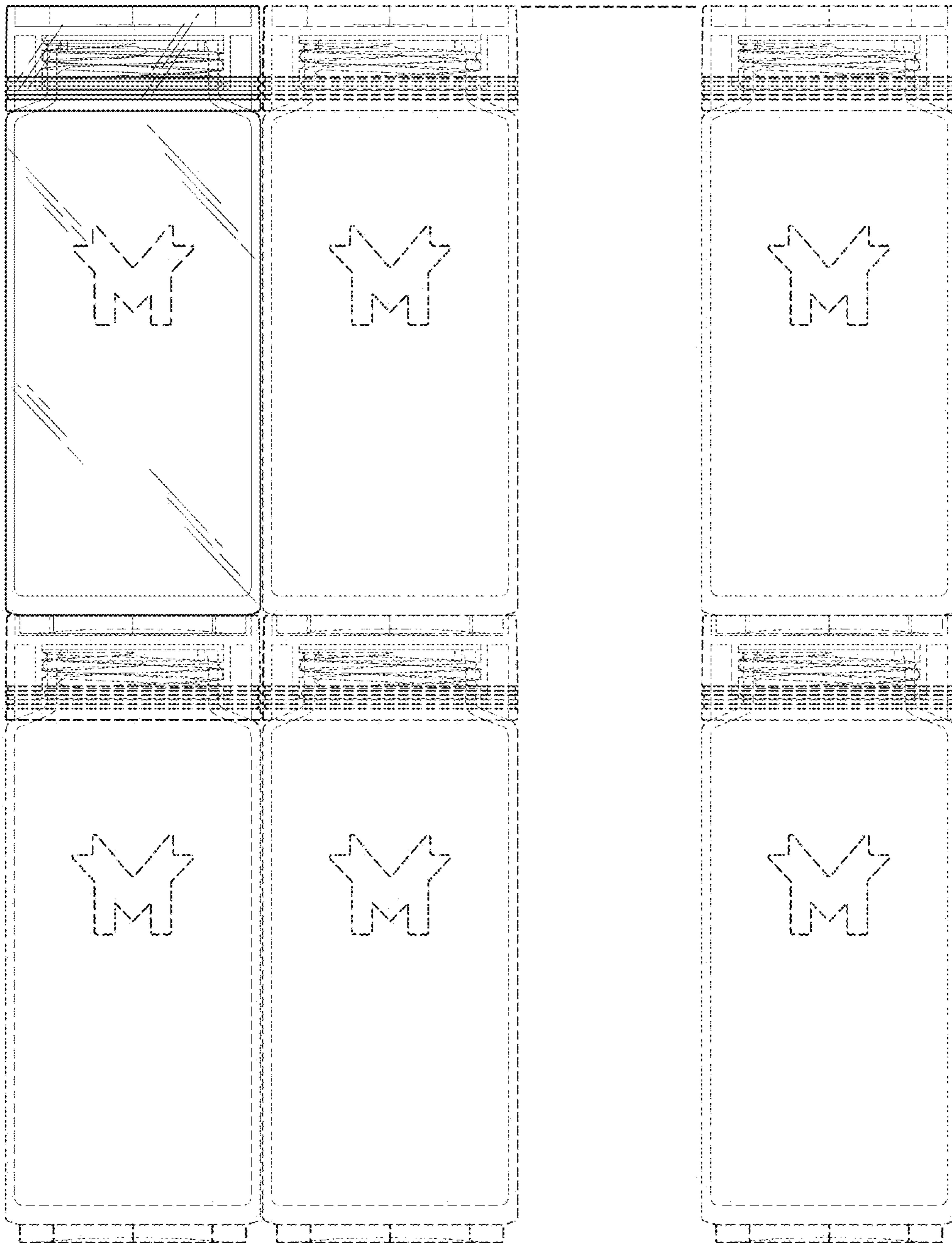
