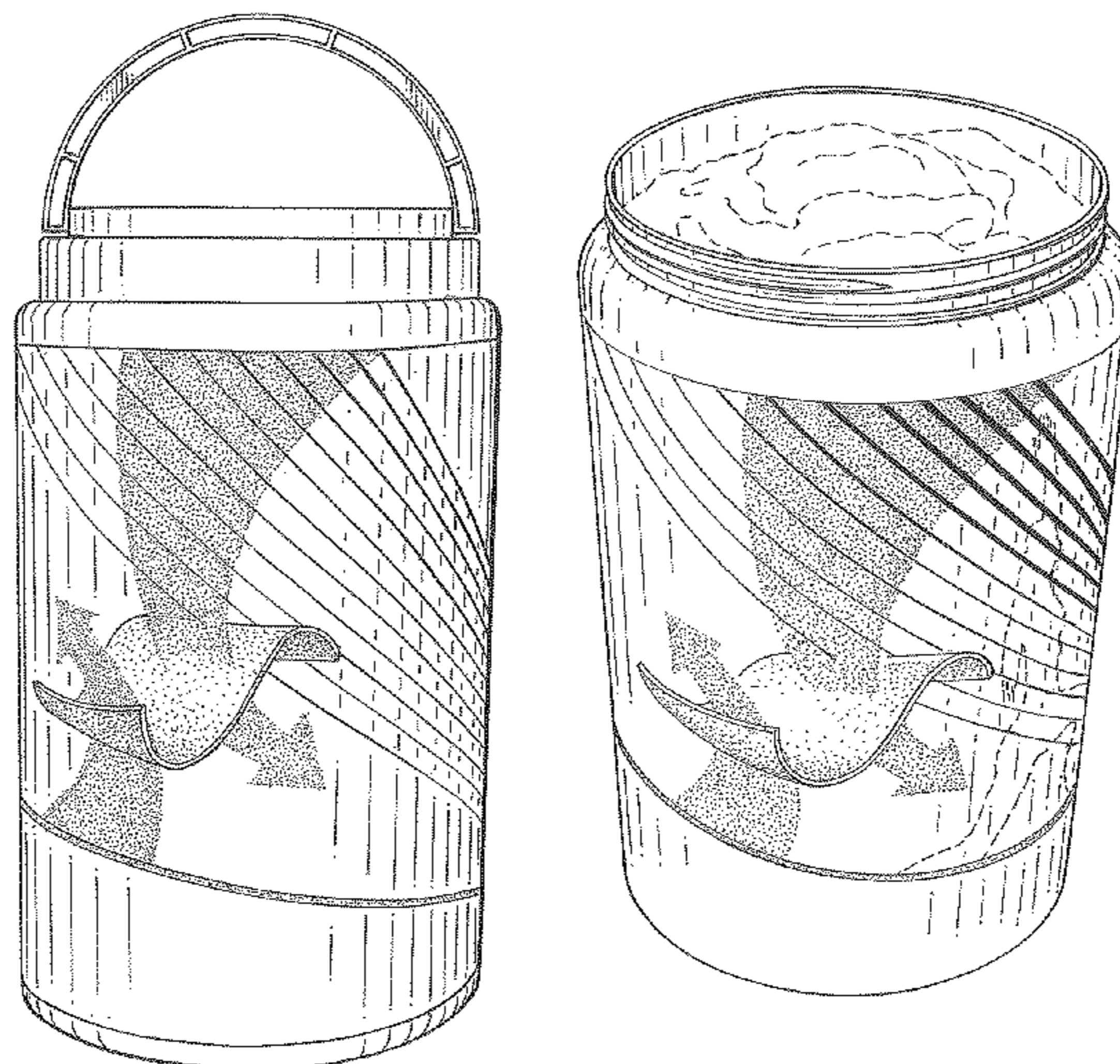
(57) **CLAIM**

The ornamental design for a jar package, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a jar package.  
FIG. 2 is a top view of the jar package of FIG. 1.  
FIG. 3 is a front view of the jar package, with the broken line showing removed;  
FIG. 4 is a front view of the jar package of FIG. 1.  
FIG. 5 is a right side view of the jar package of FIG. 3;  
FIG. 6 is a back side view of the jar package of FIG. 1.  
FIG. 7 is a bottom view of the jar package of FIG. 1.  
FIG. 8 is a front side view of the jar package of FIG. 3 with the handle raised. The back side view of the handle in the raised position is identical to the front.  
FIG. 9 is a perspective view of the jar package of FIG. 1, with the lid removed, the broken line showing of linen is for illustrative purposes only and forms no part of the claimed design;  
FIG. 10 is a perspective view of the bottom of the jar package in FIG. 1, shown separately for ease of illustration;  
FIG. 11 is a left side view of the jar package of FIG. 1;  
FIG. 12 is a perspective view of the lid of the jar package of FIG. 1, shown separately for ease of illustration; and,  
FIG. 13 is a perspective view of the jar package of FIG. 1, with the lid removed.  
The broken line showing in FIGS. 1, 4, 9 and 13 is for illustrative purposes only, and forms no part of the claimed design.

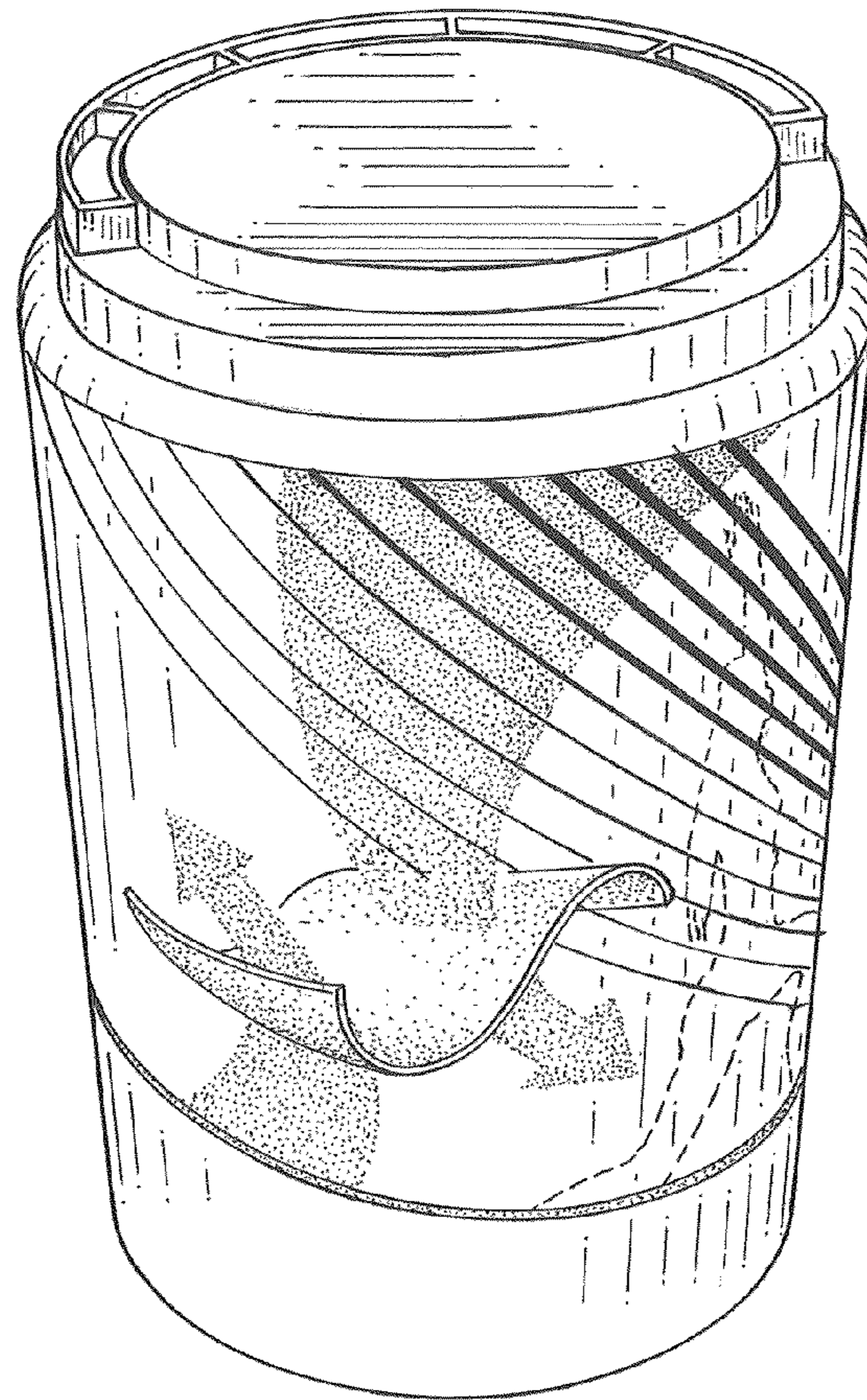

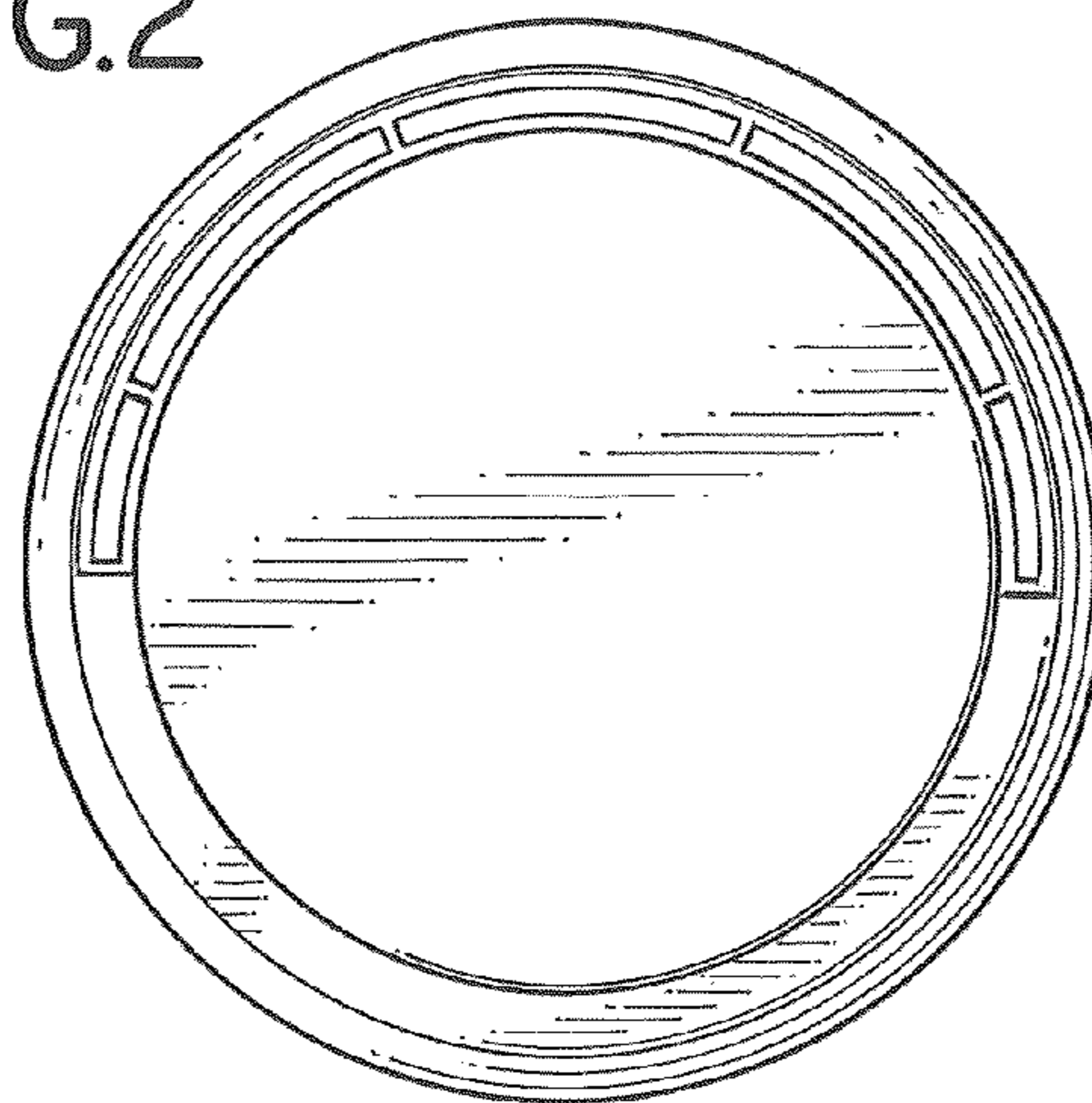

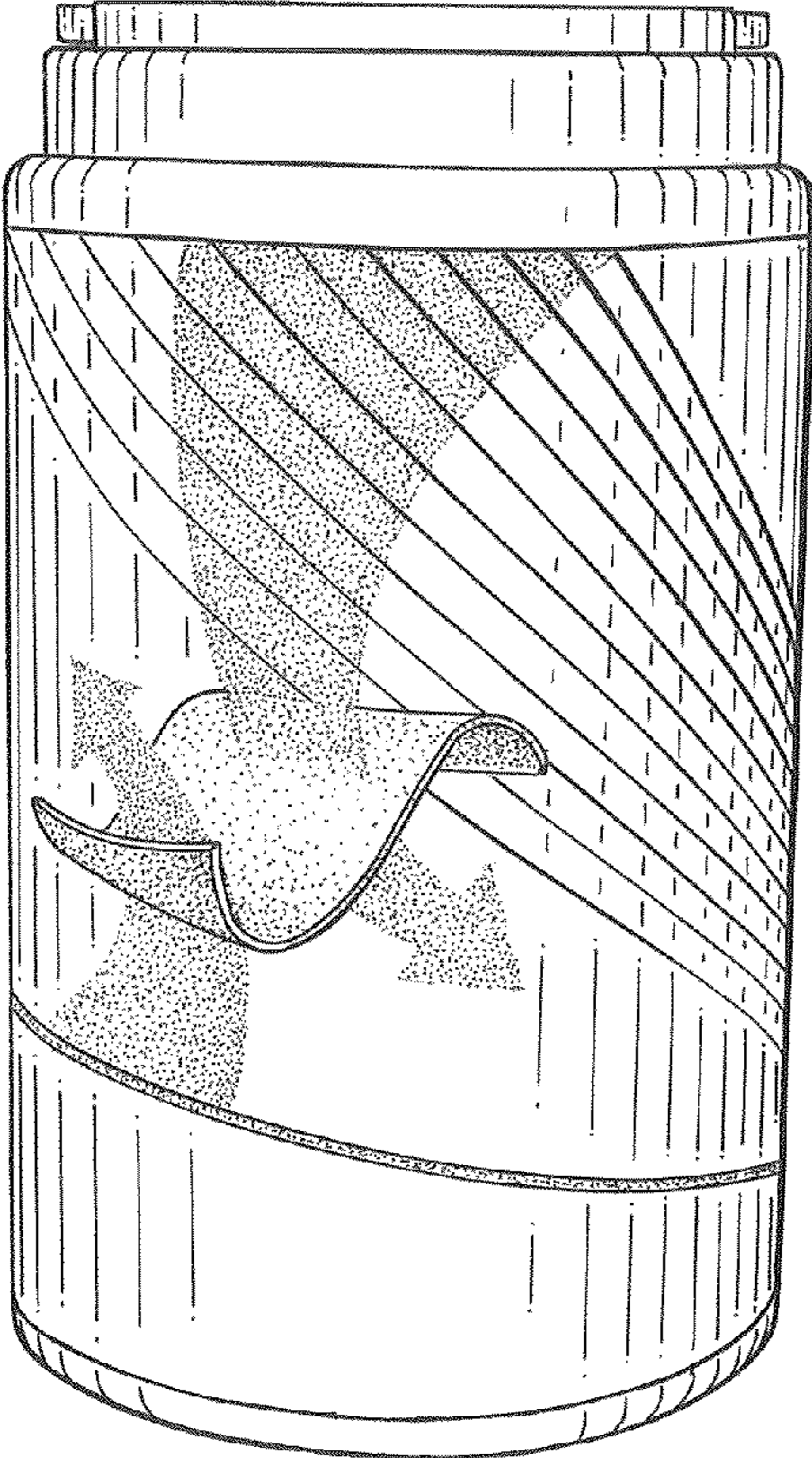

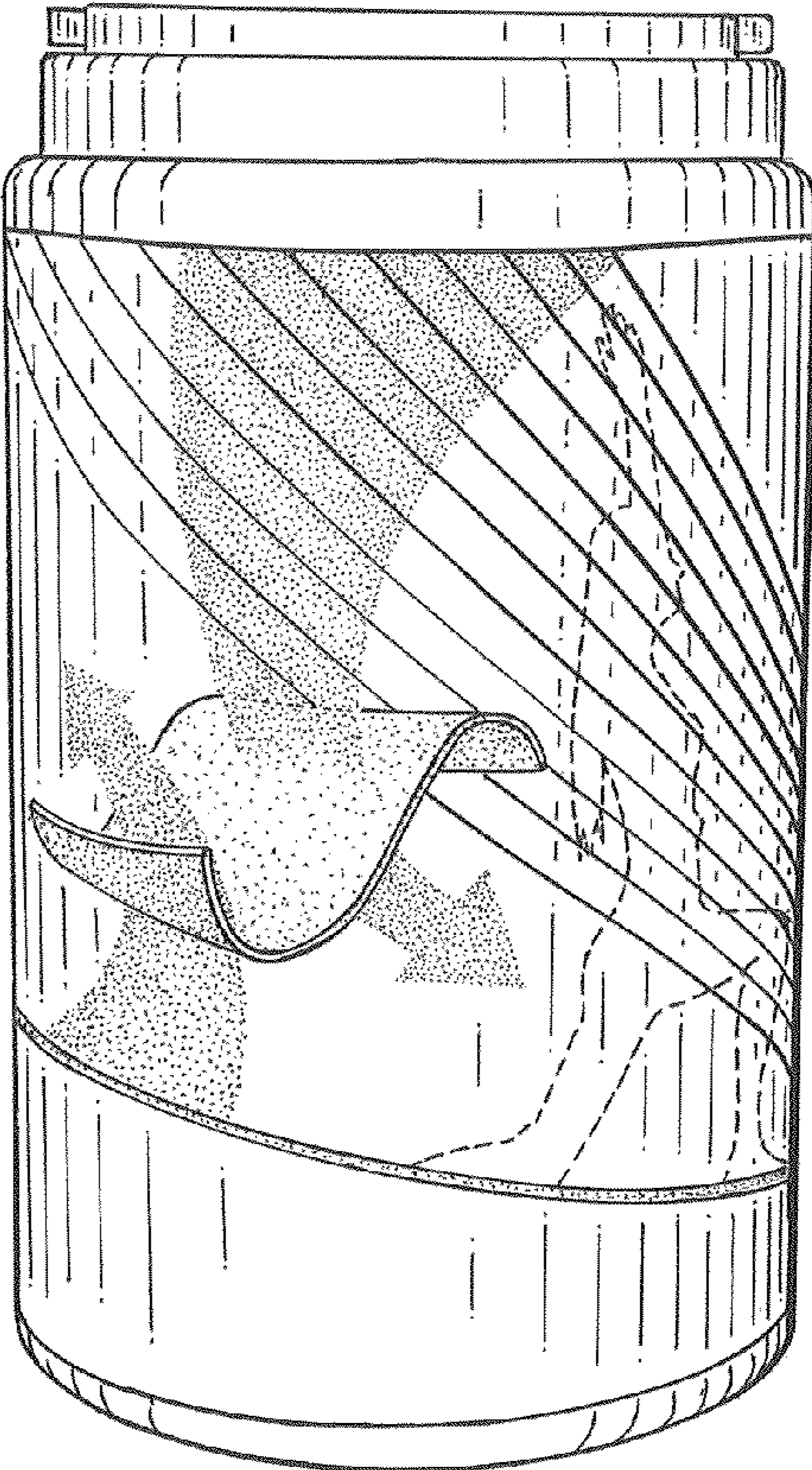

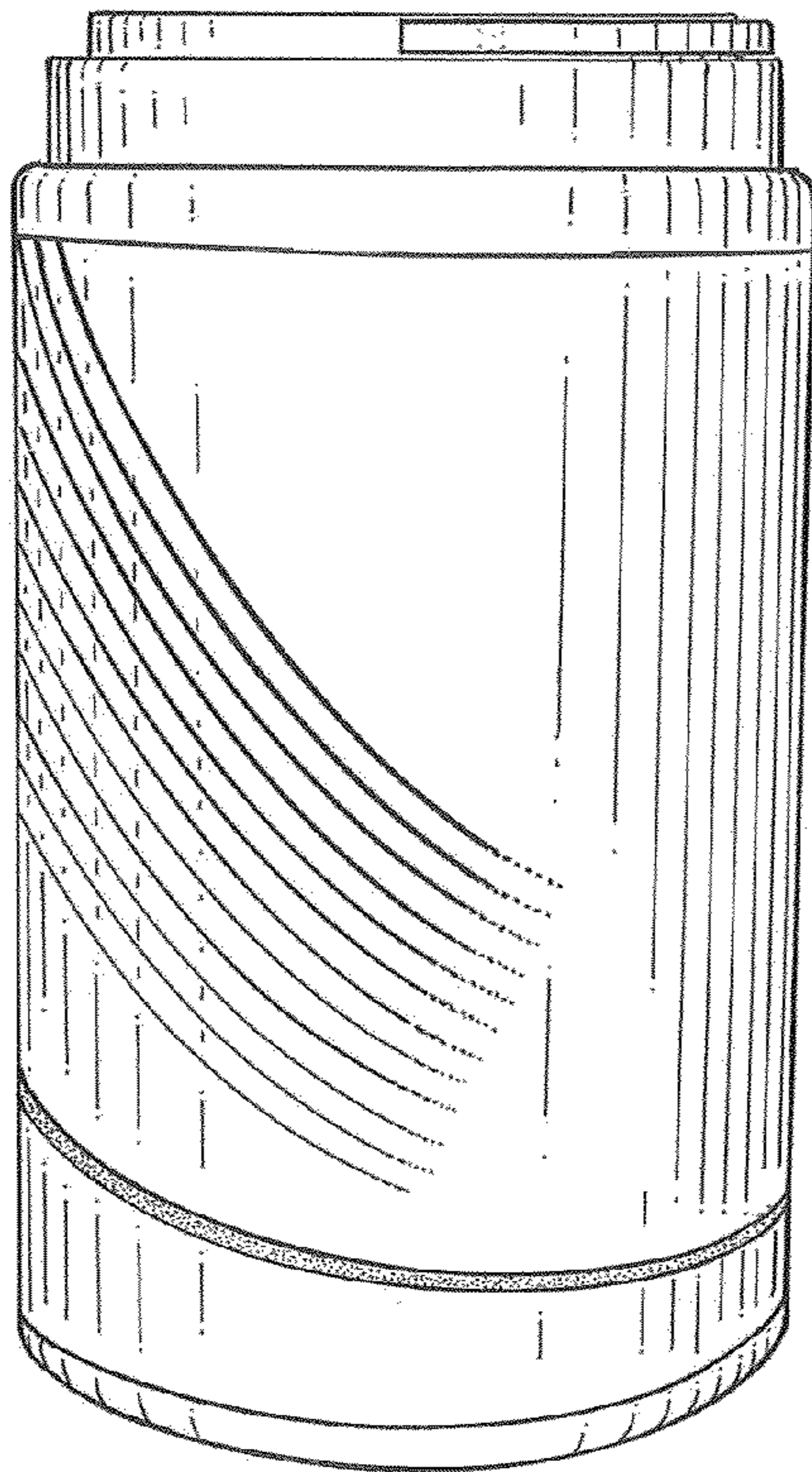

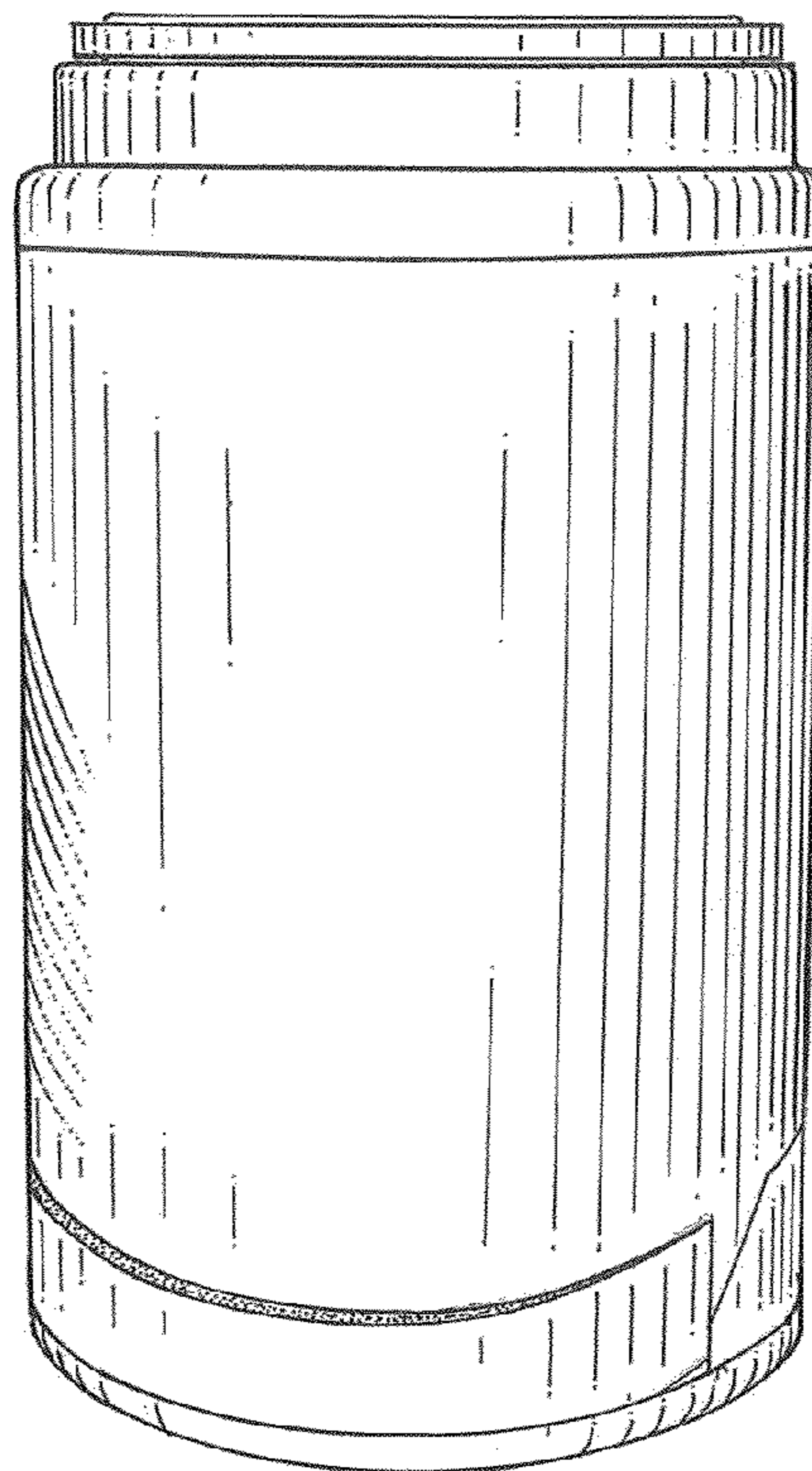

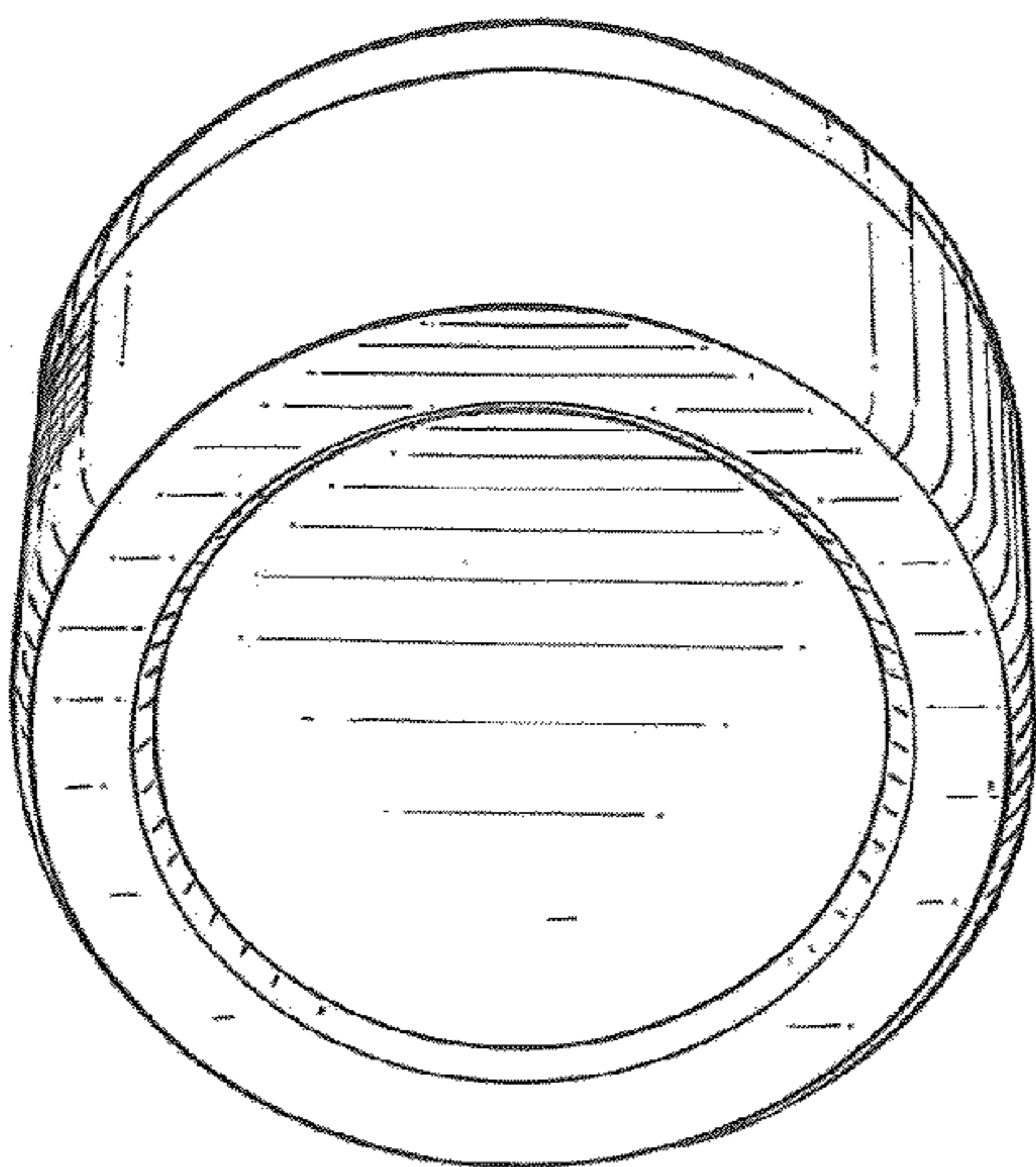
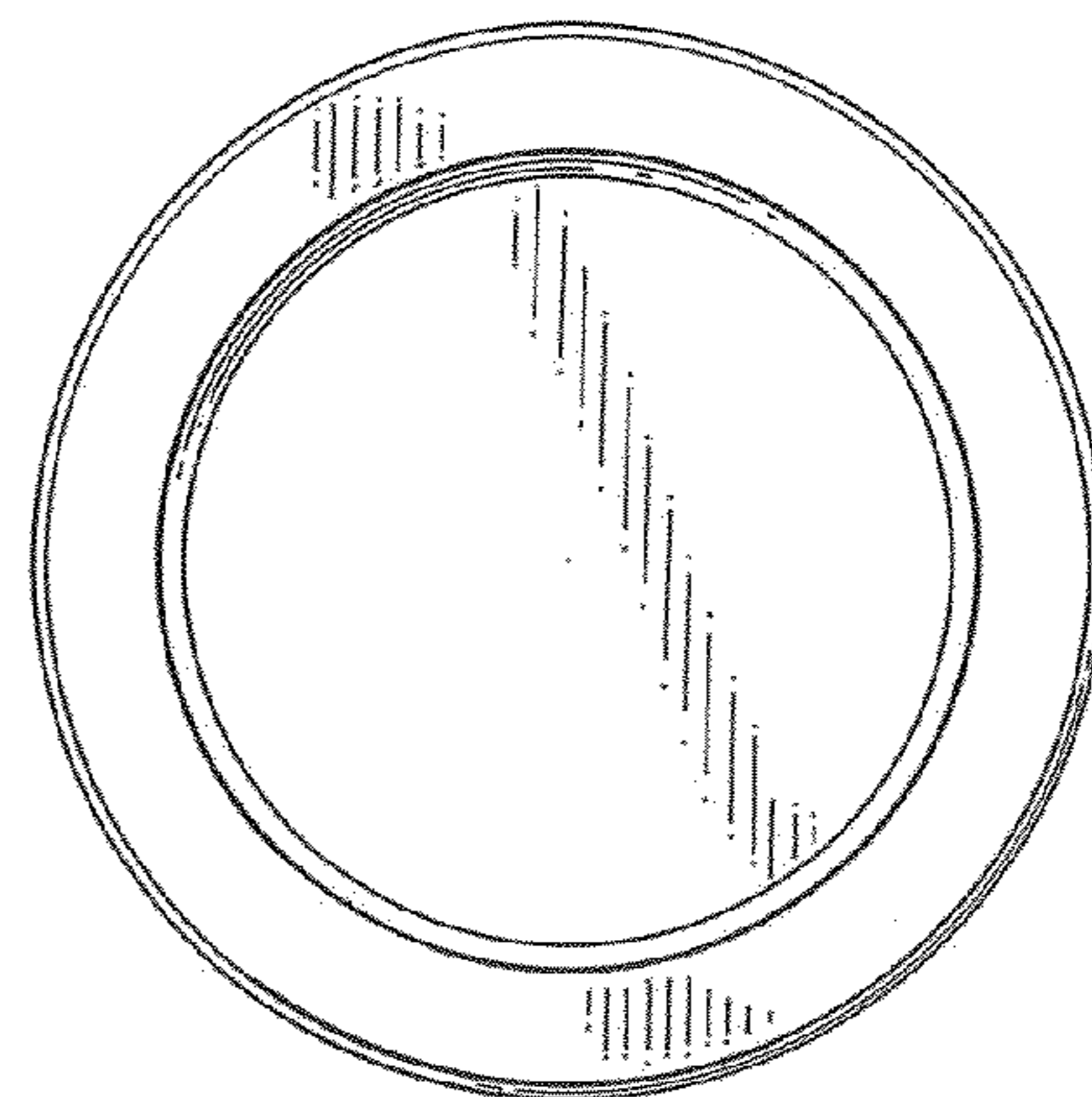

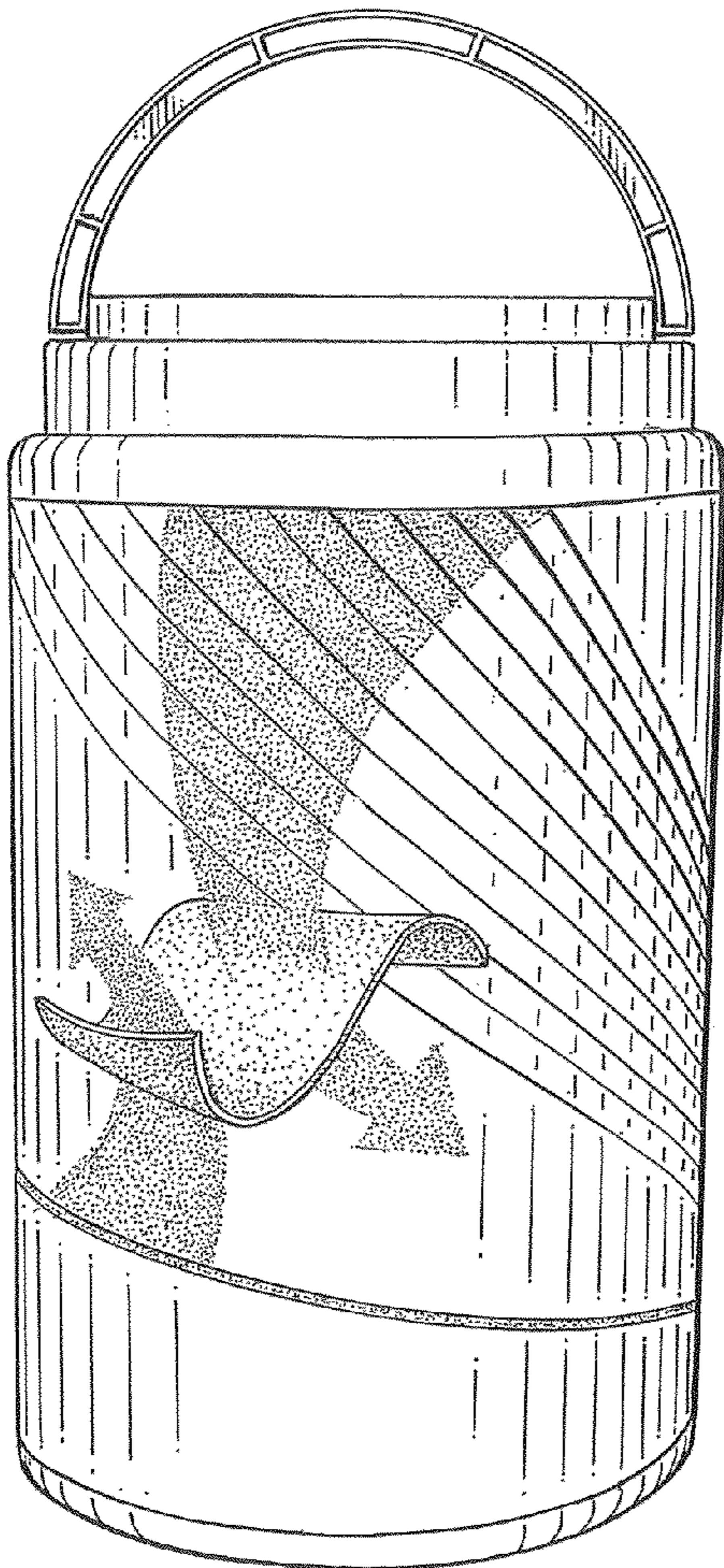

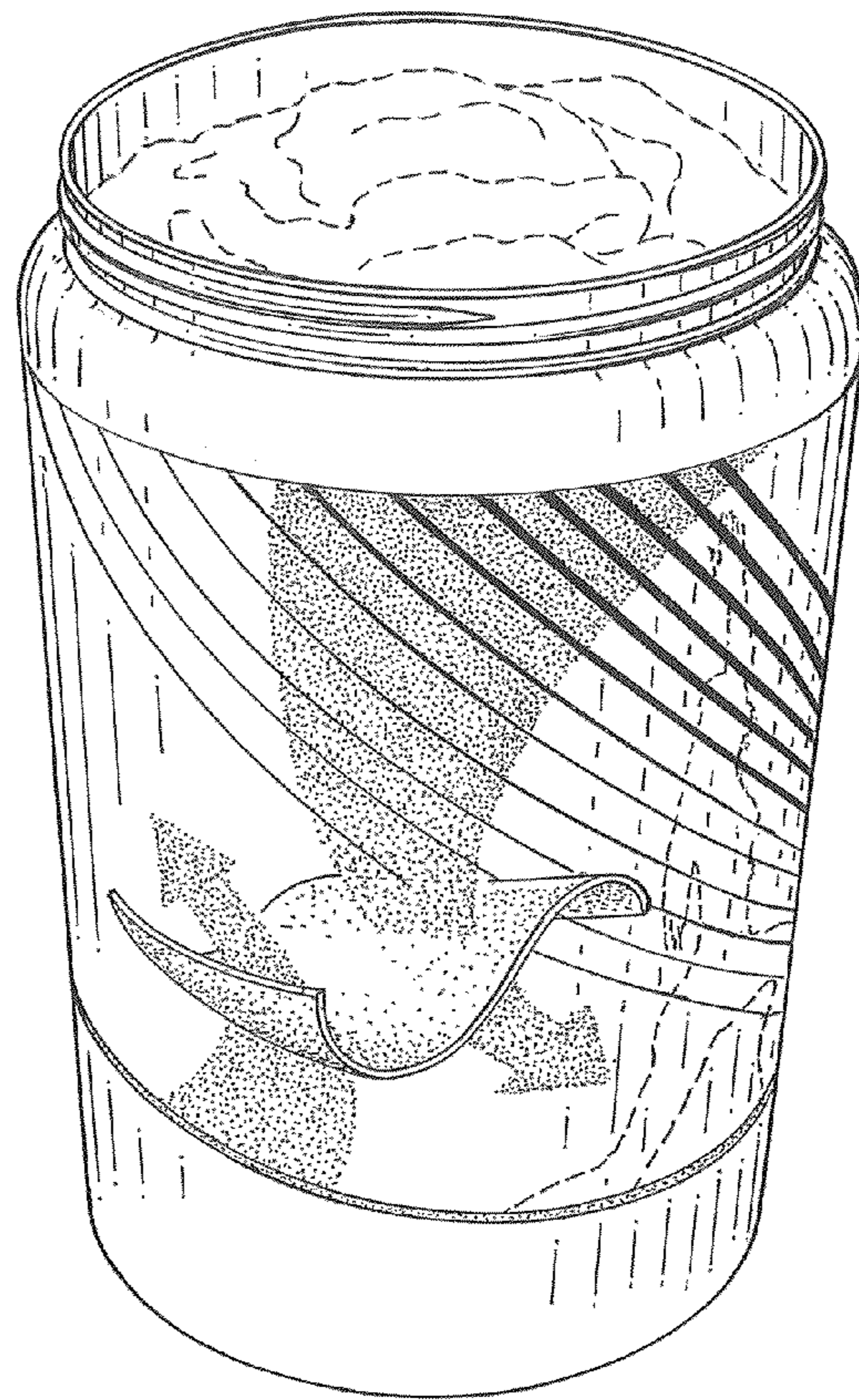

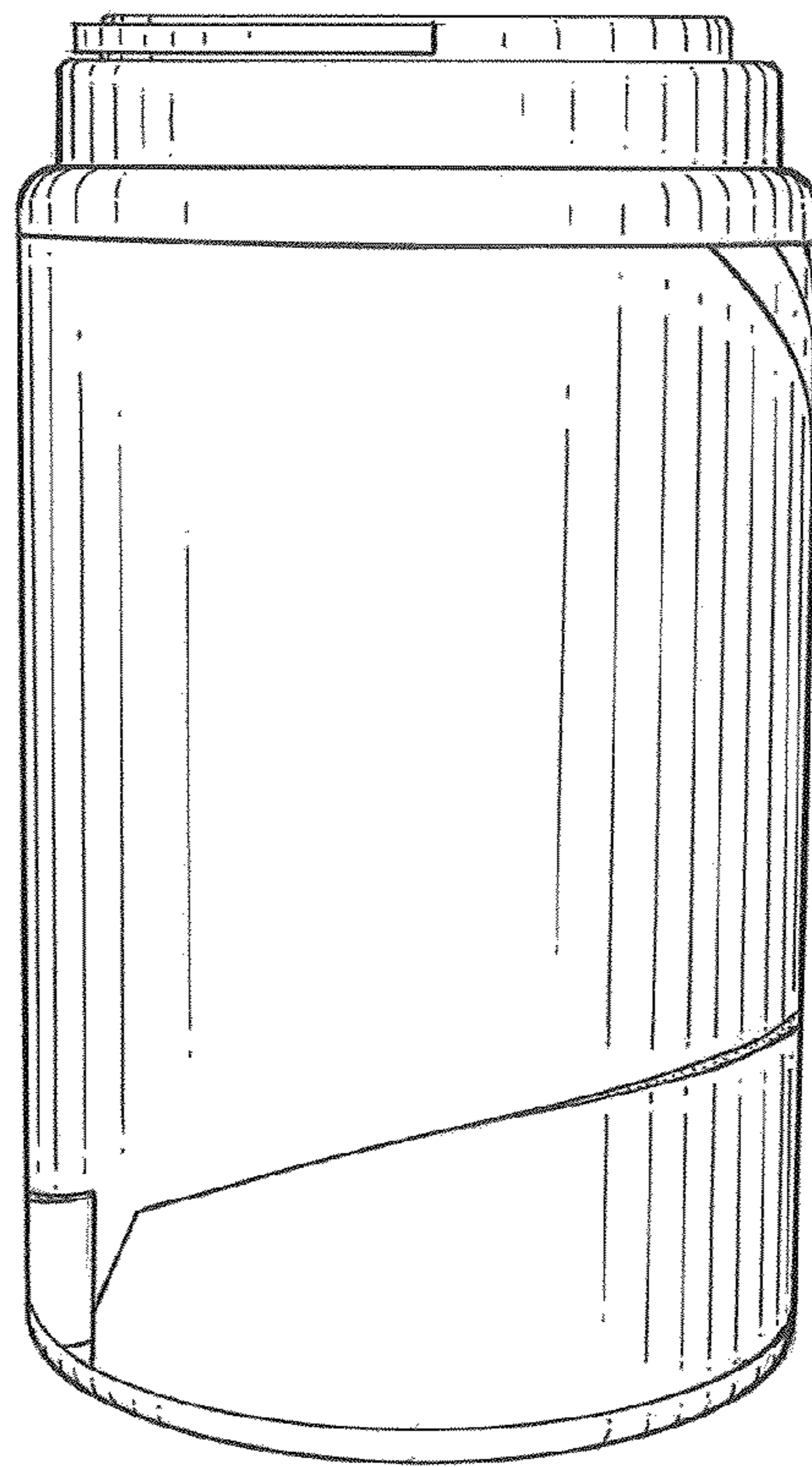

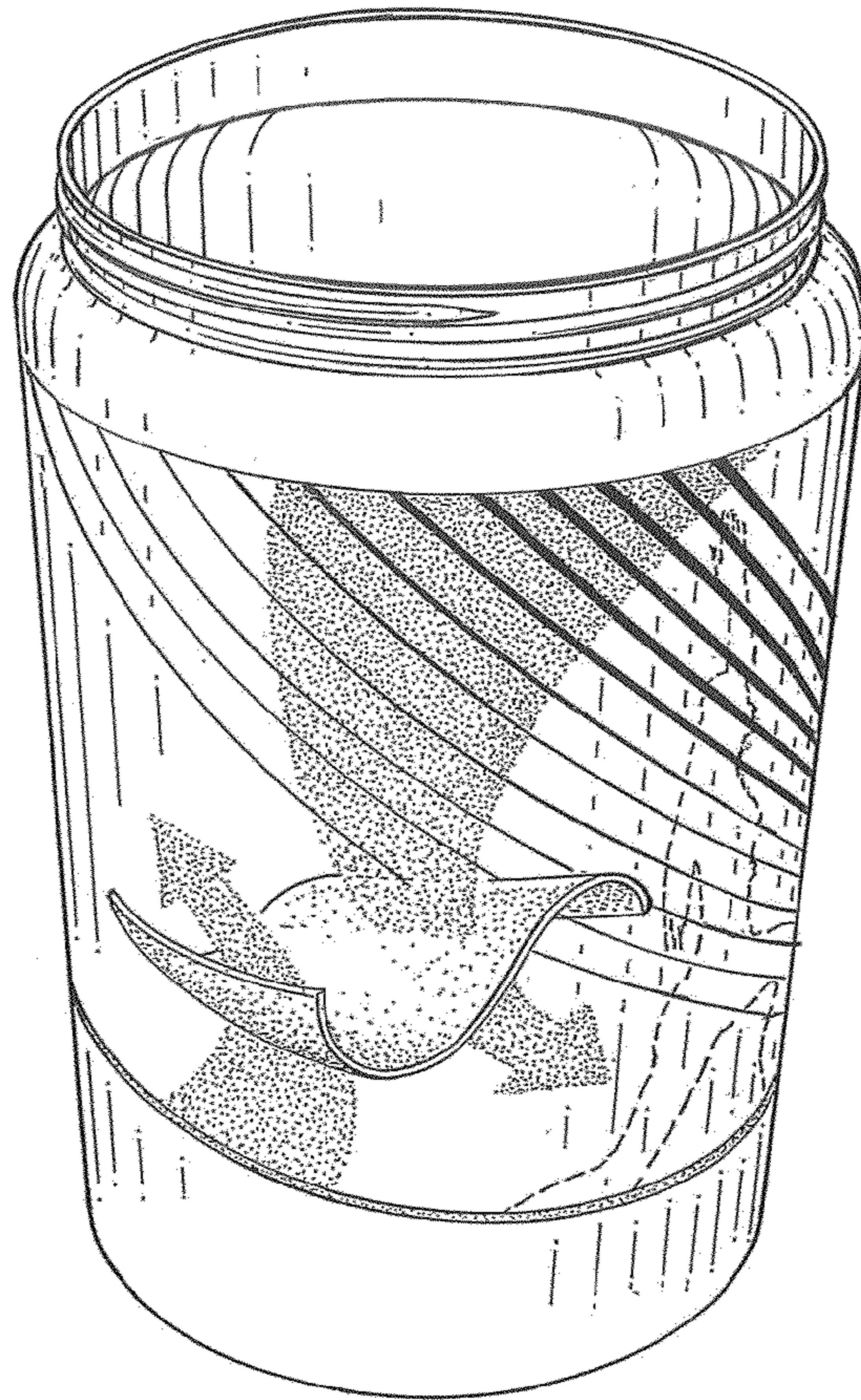
