FIG. 26 is a left side view with its front display sliding up fully and bending thereof;

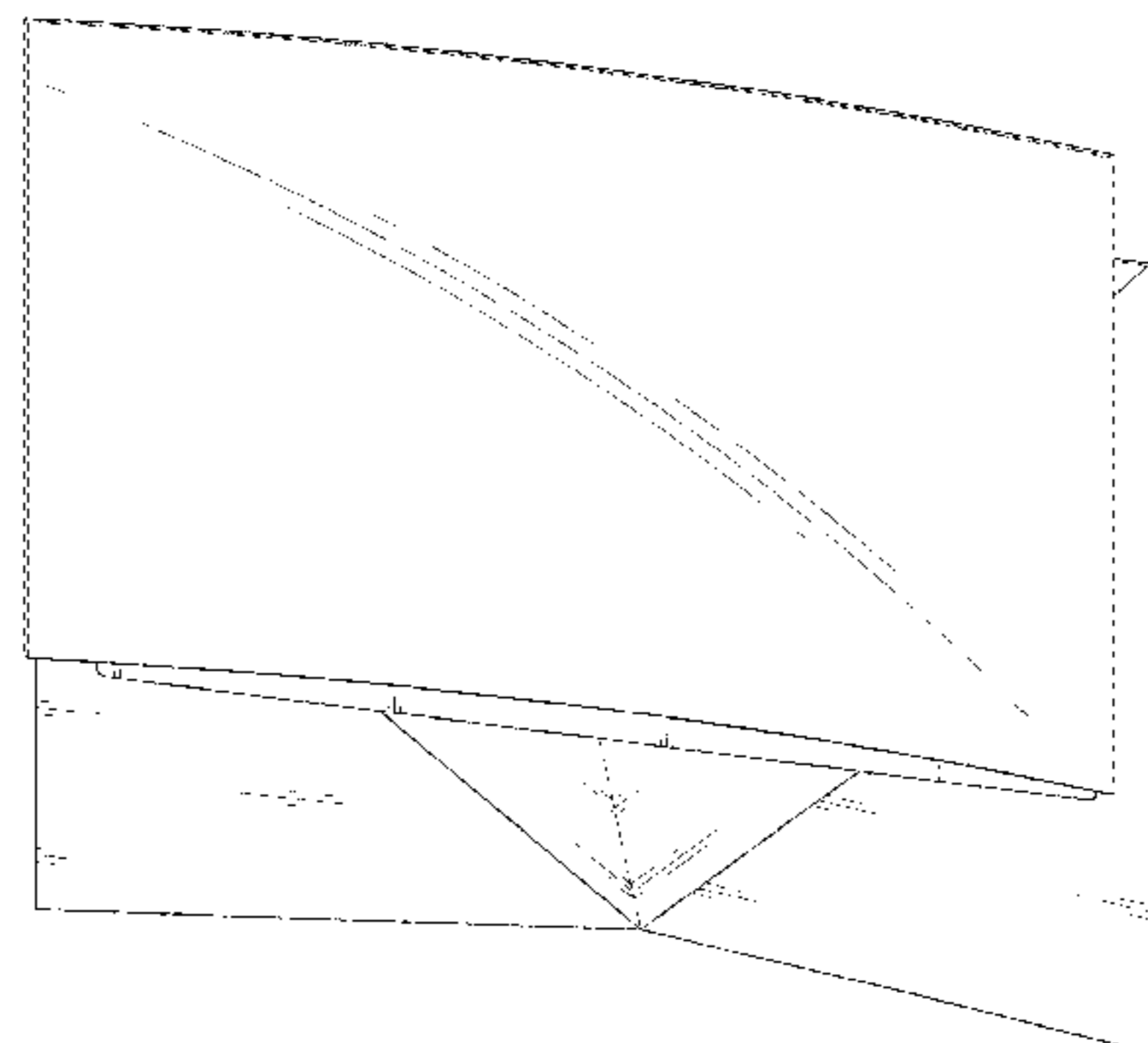
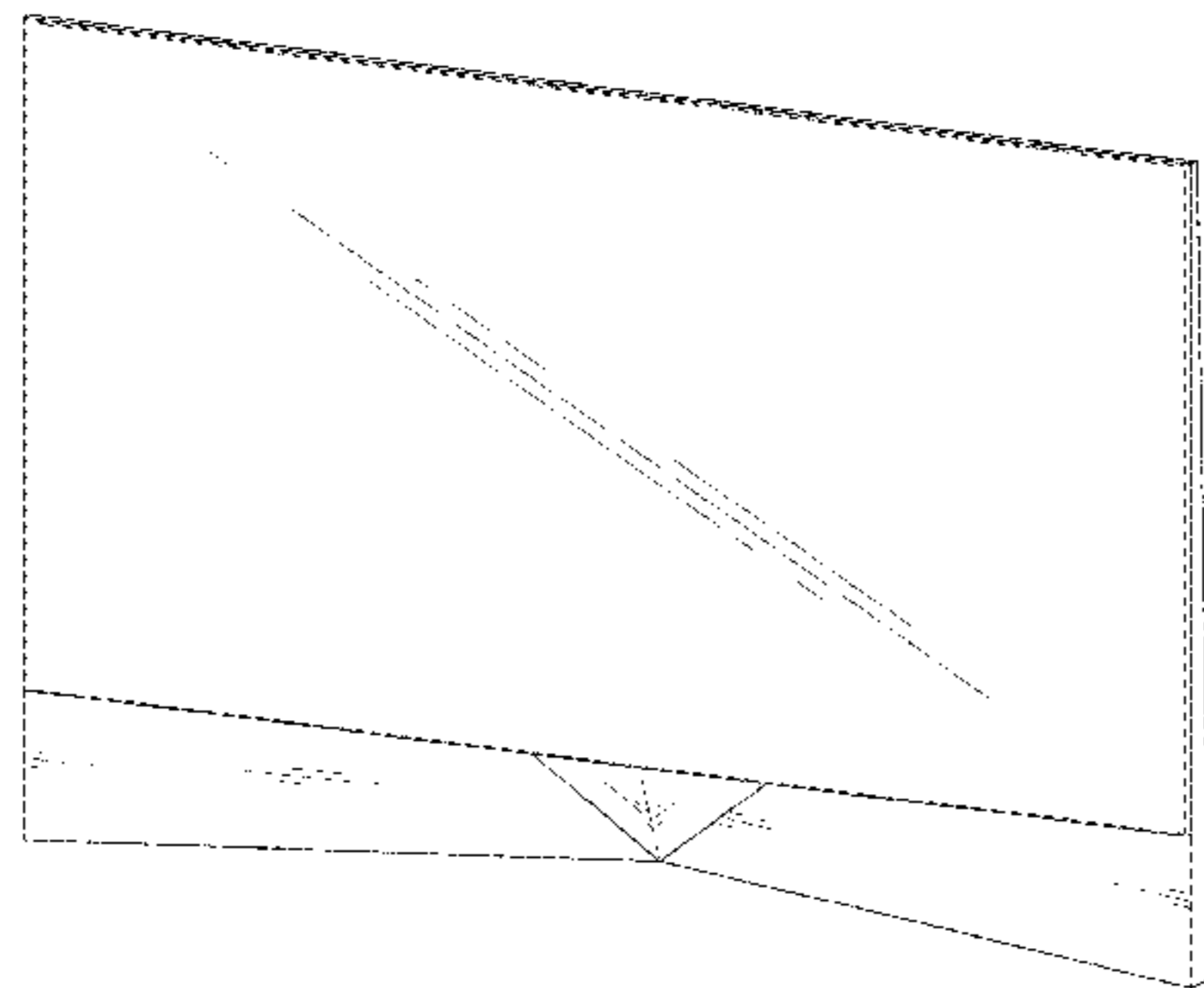
FIG. 27 is a right side view with its front display sliding up fully and bending thereof;

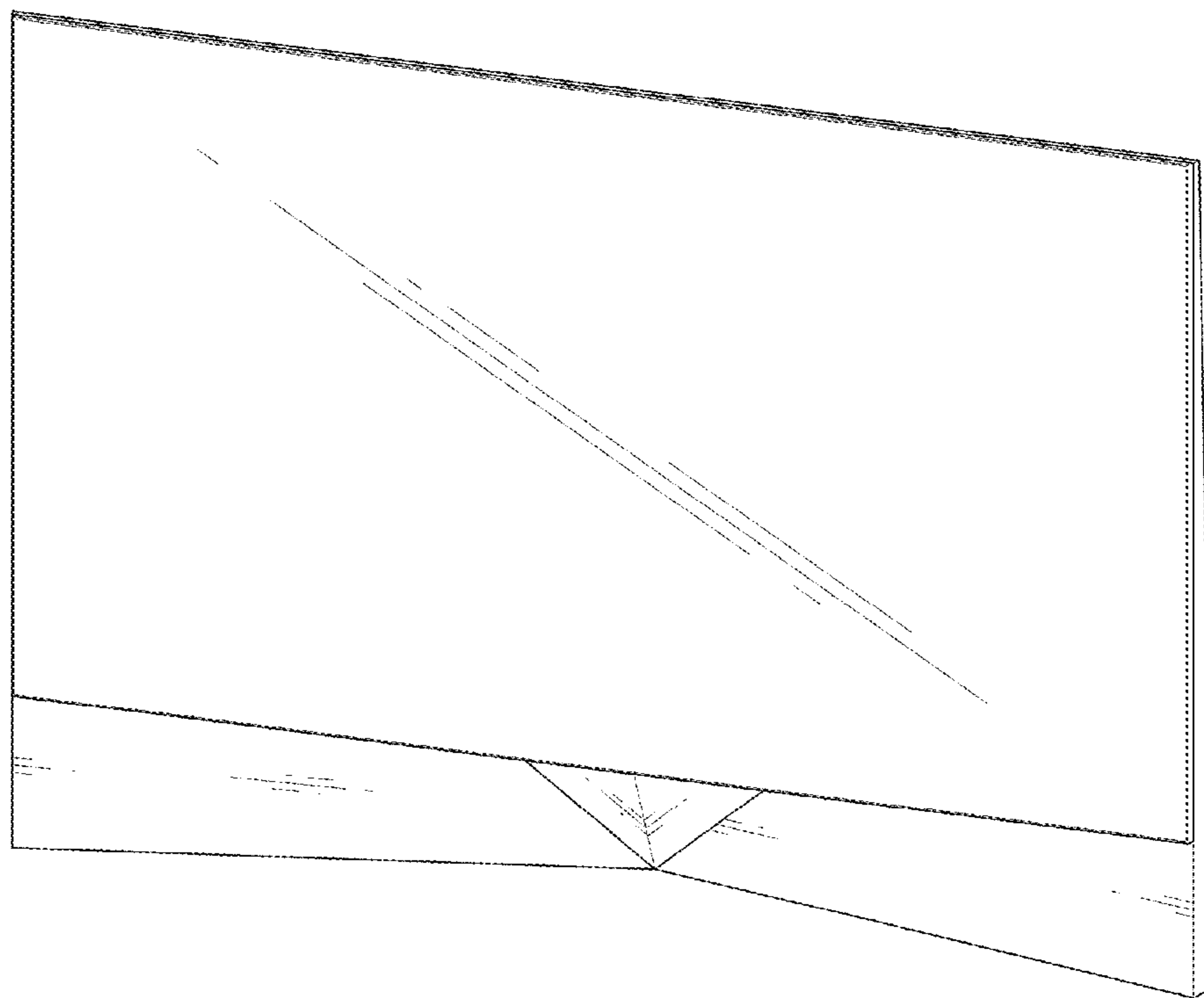

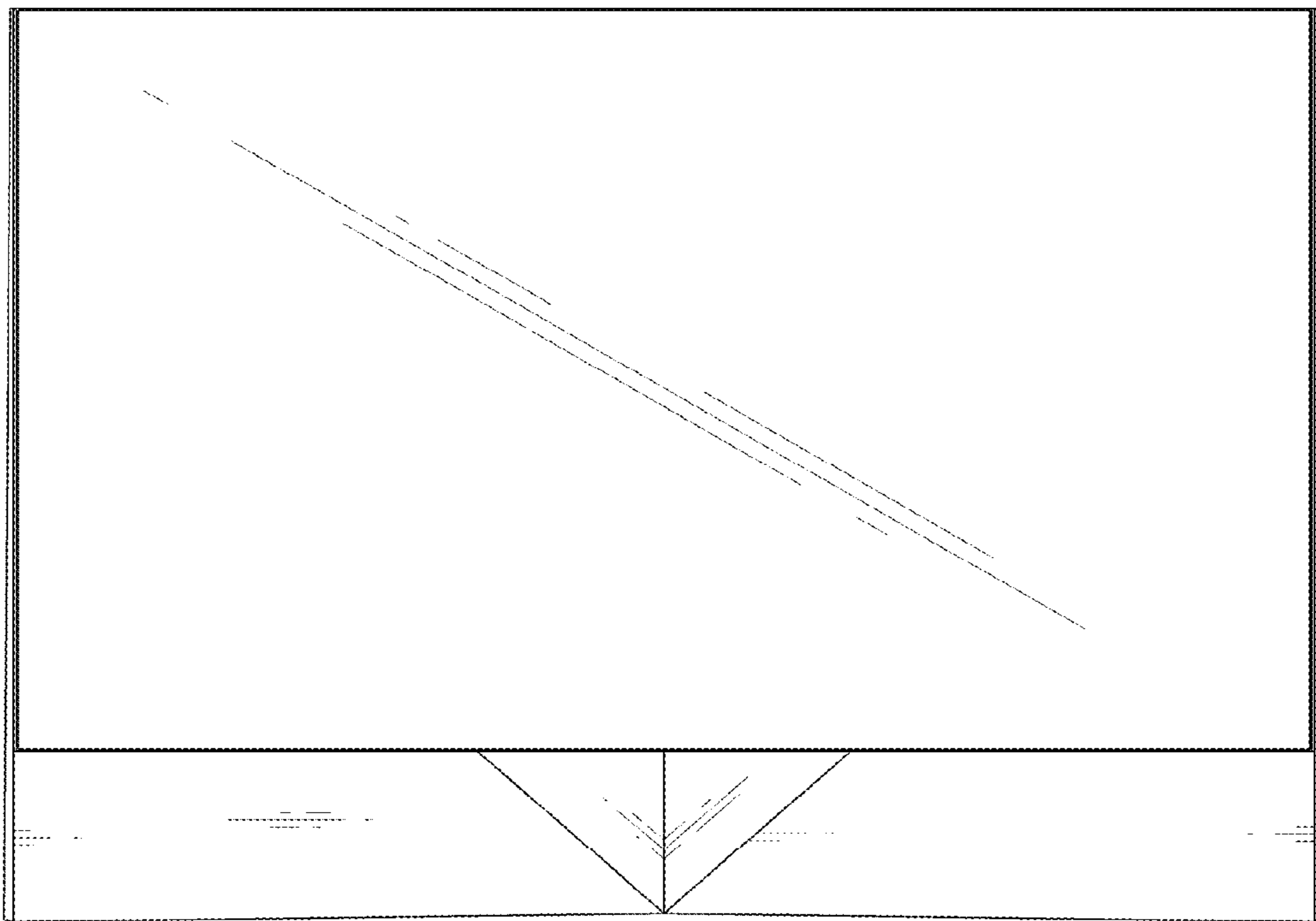

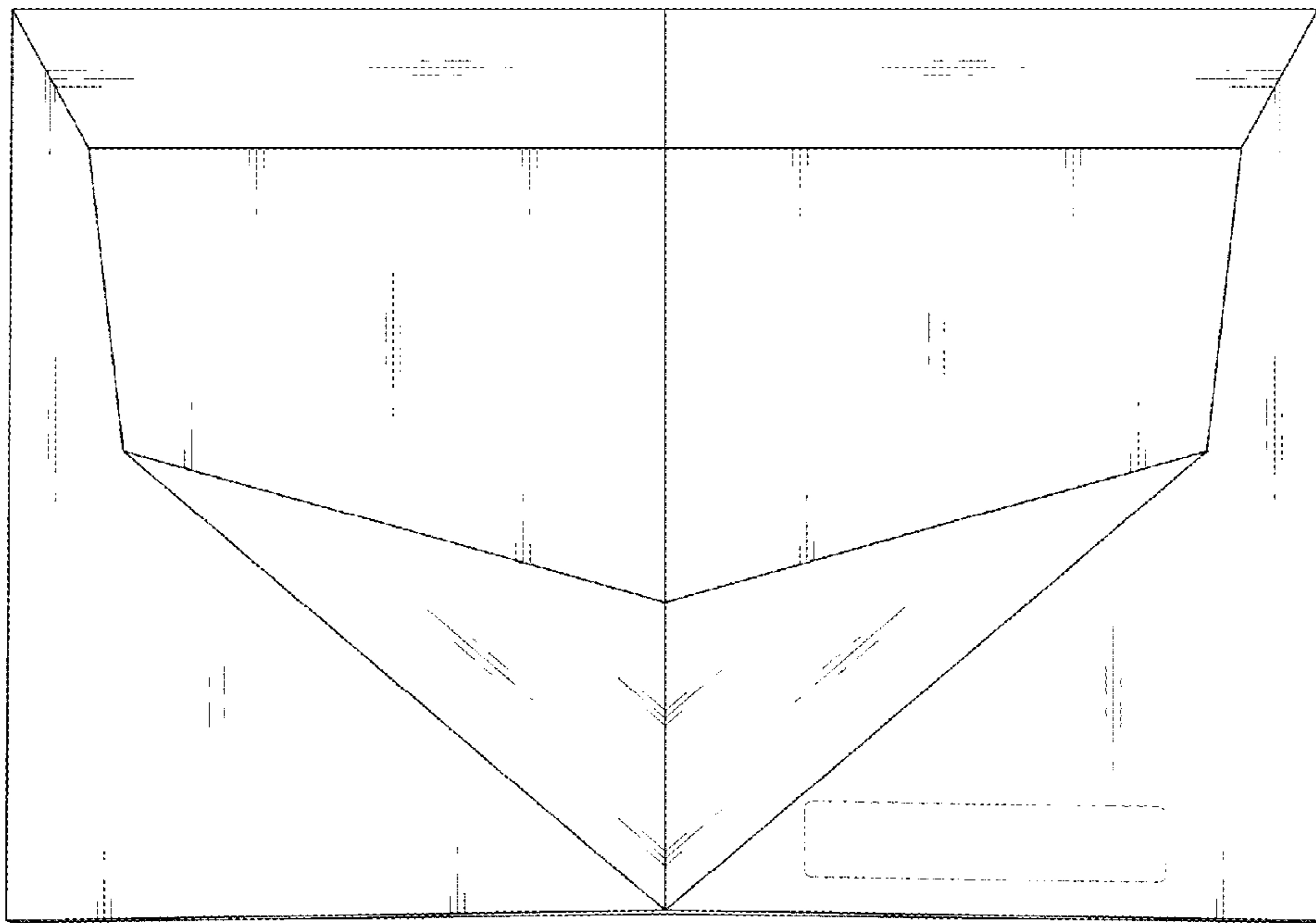

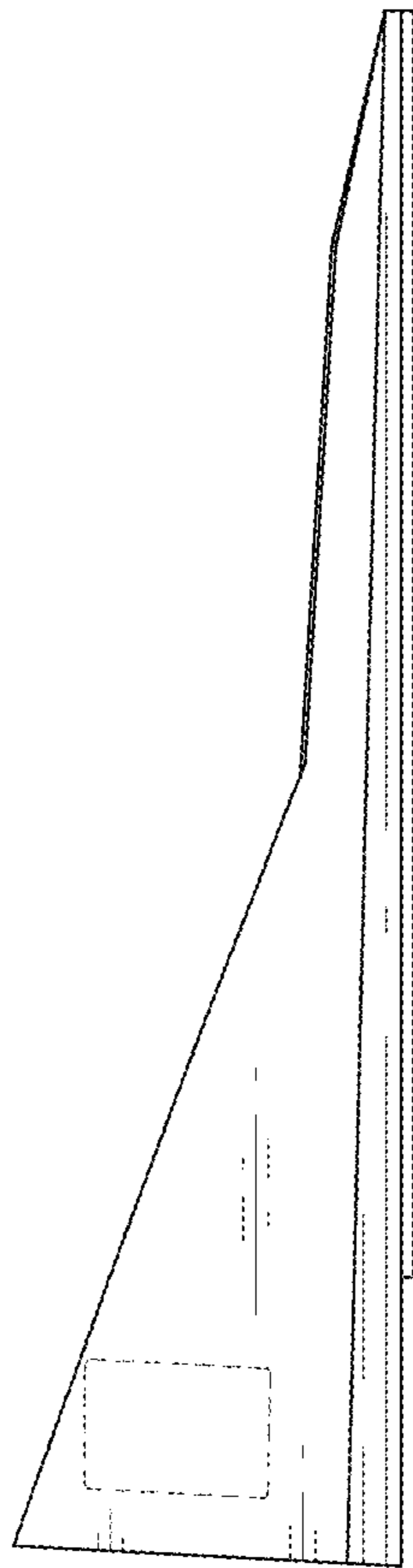

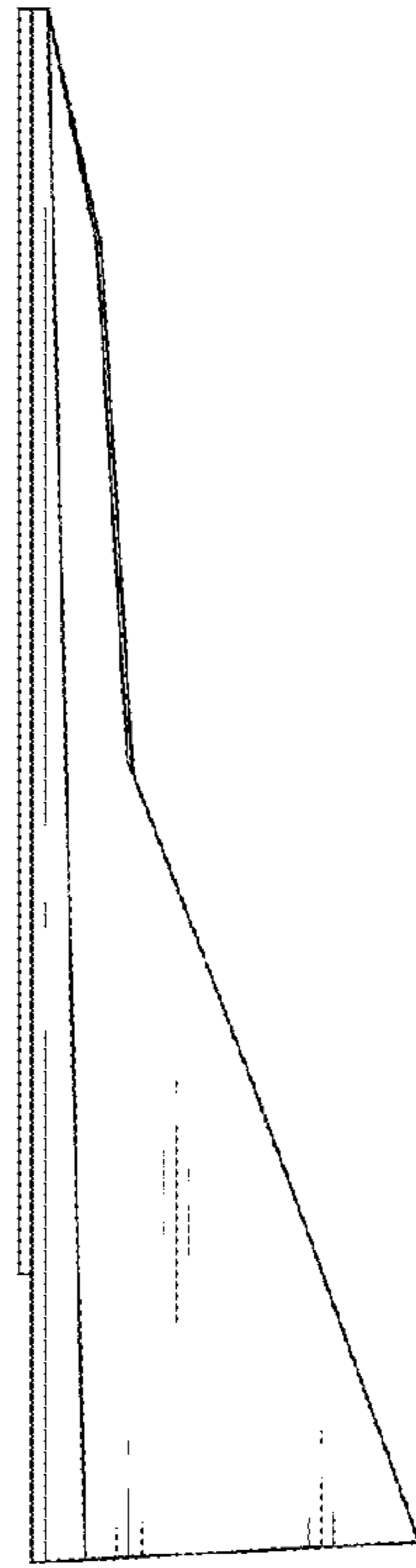

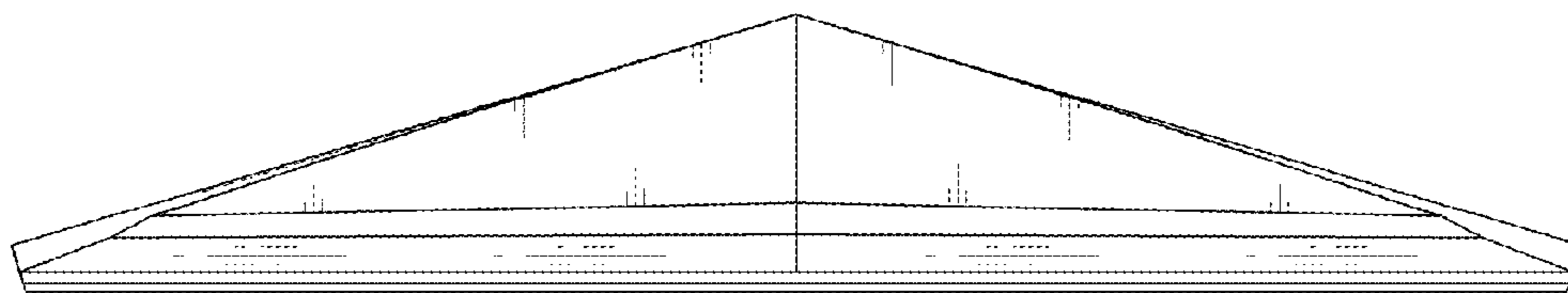

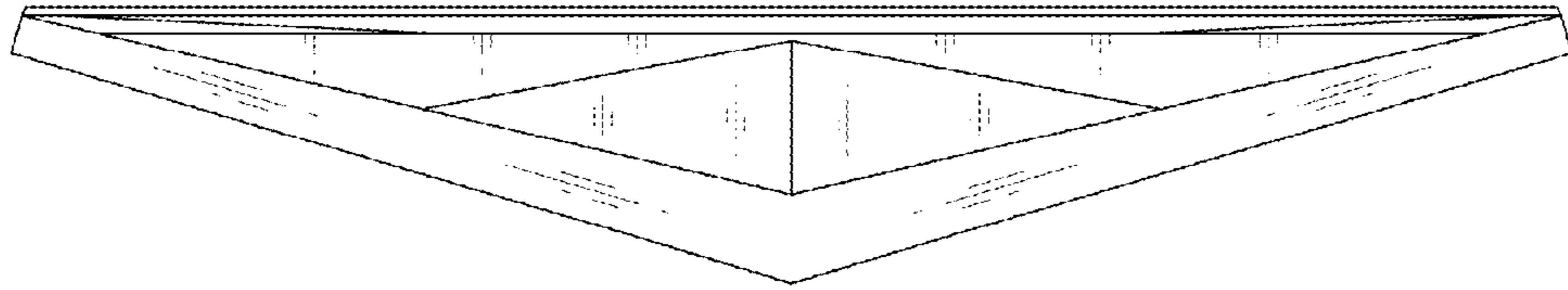

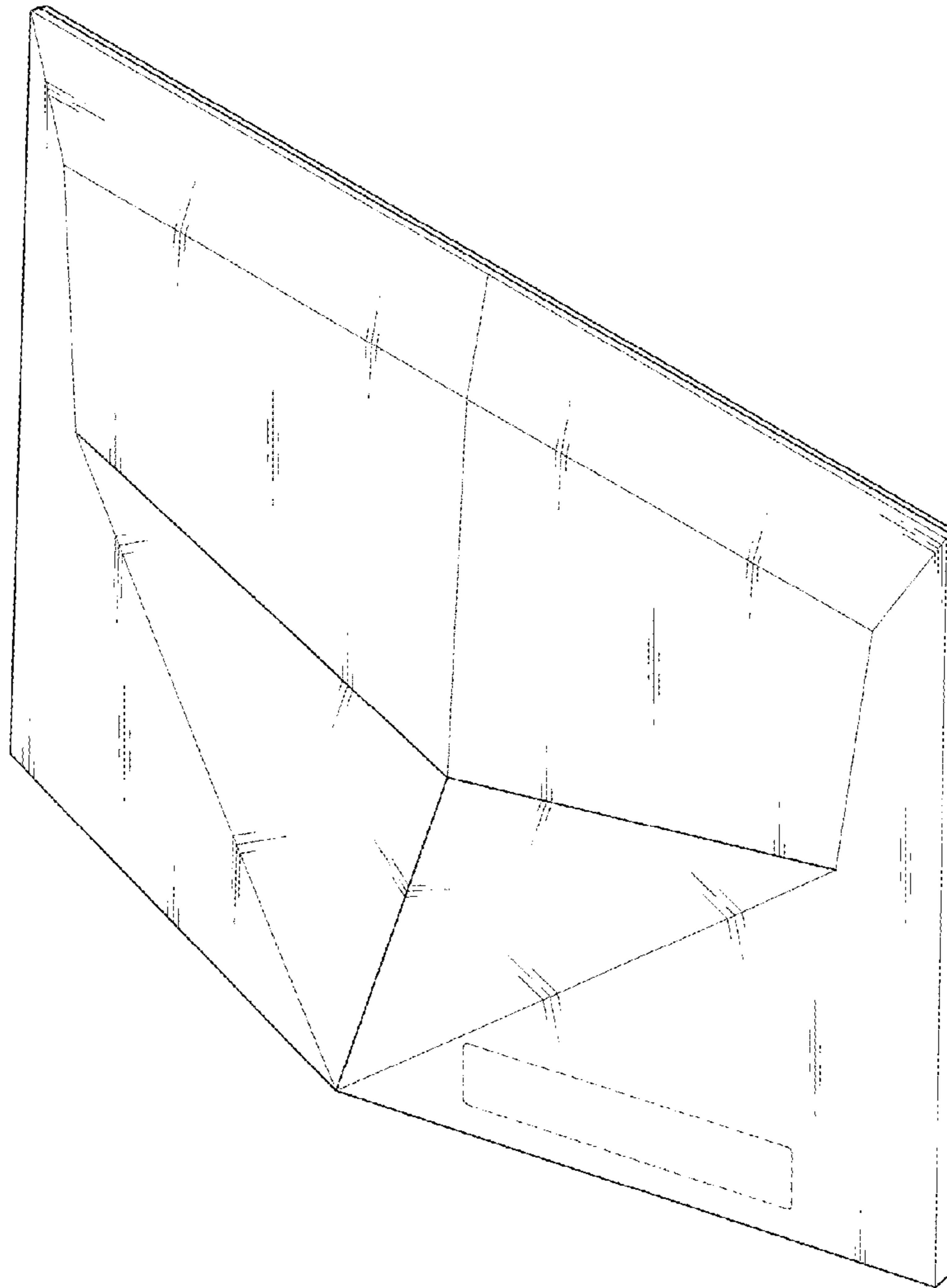

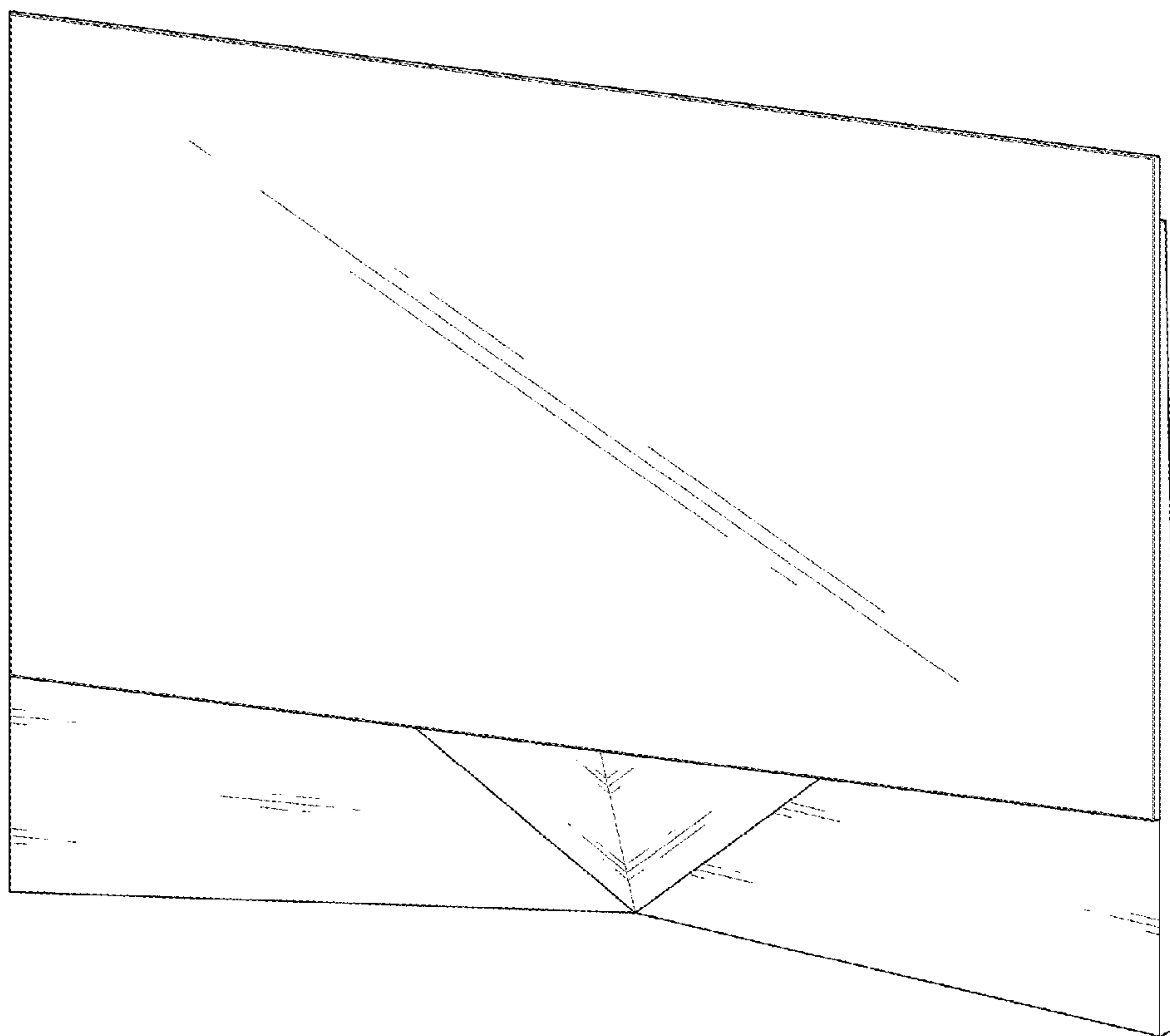

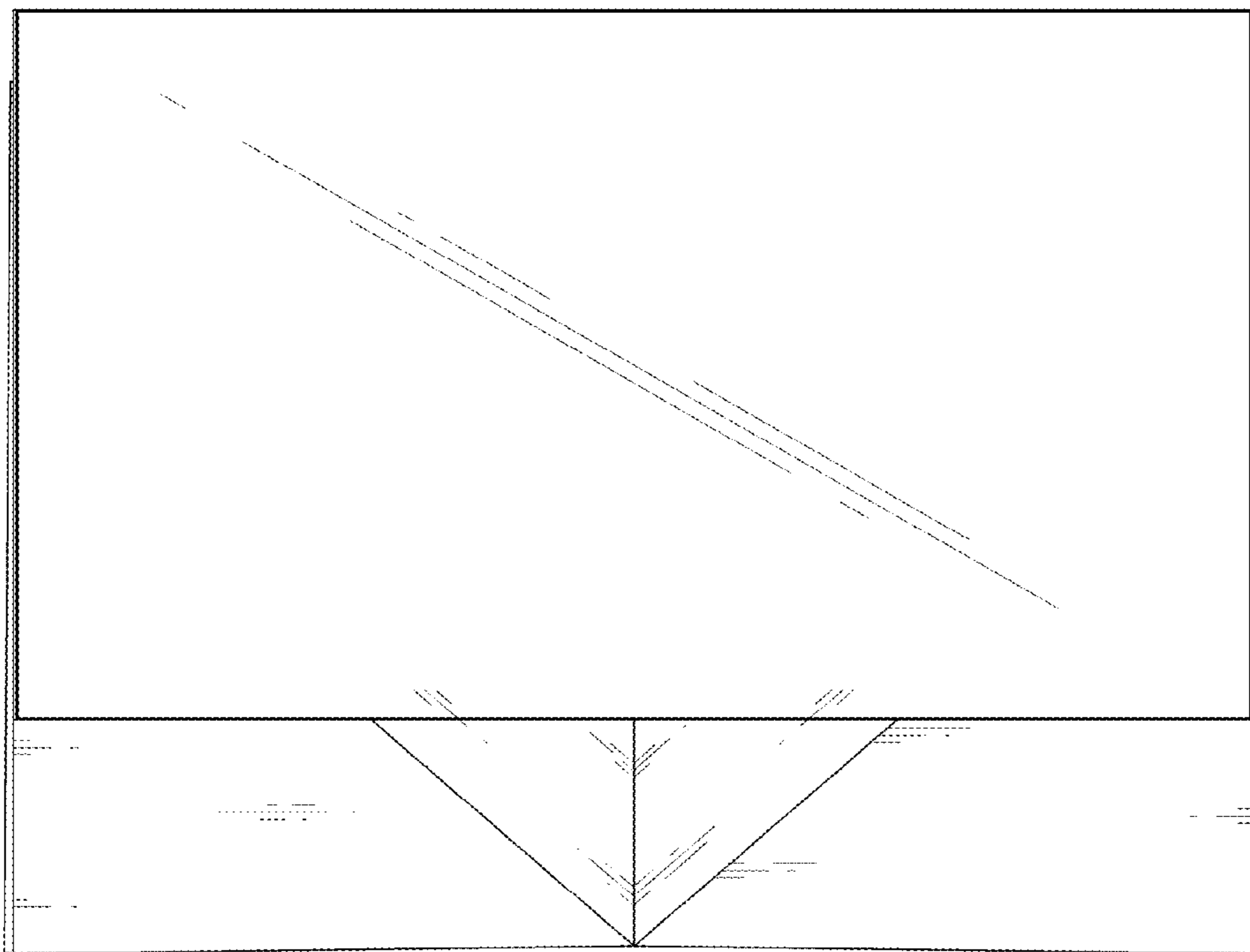

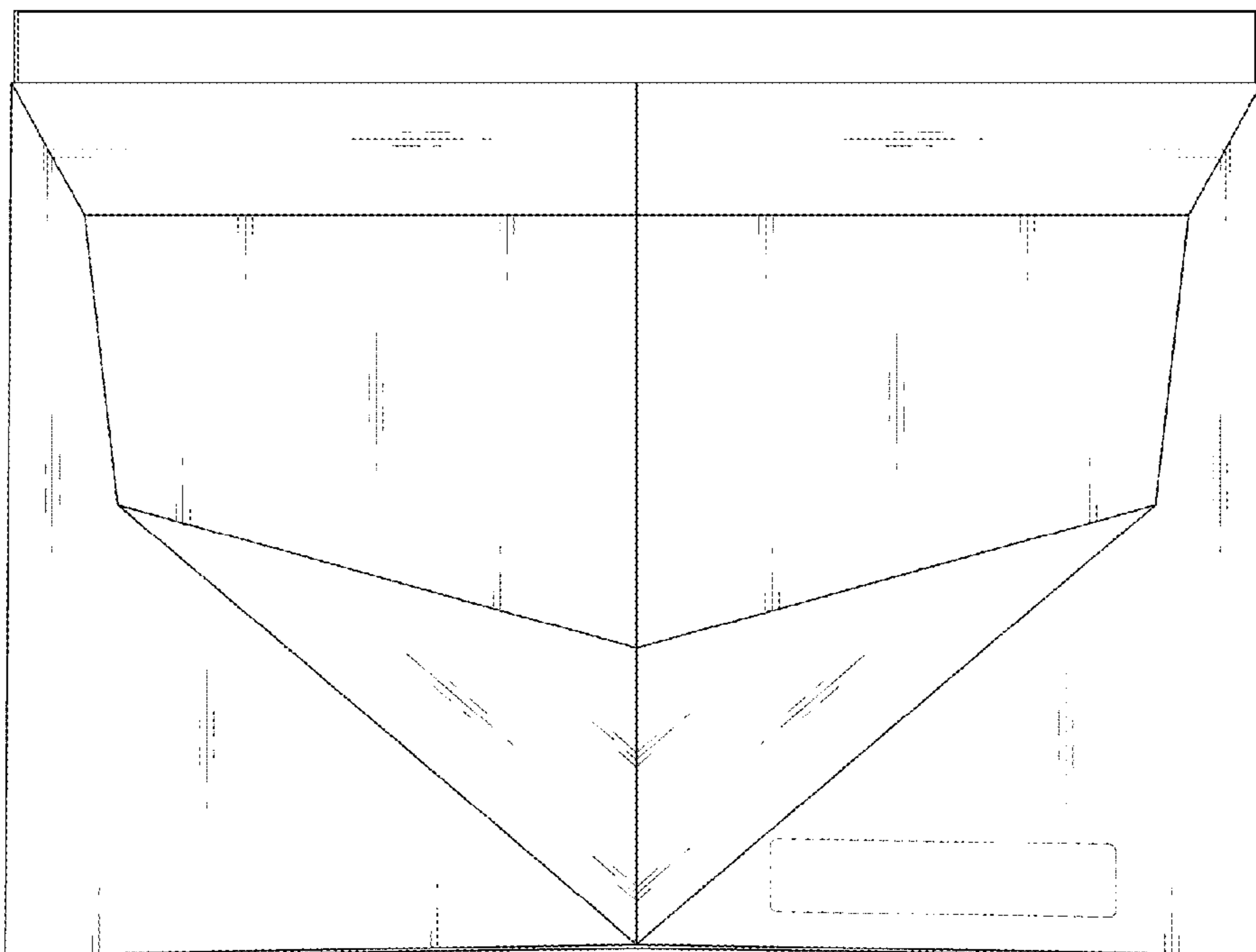

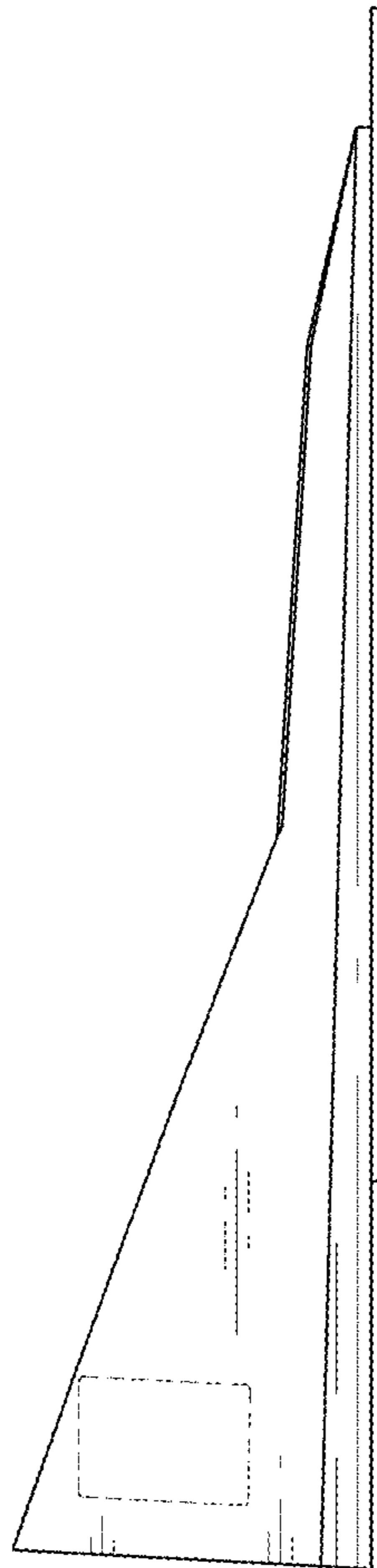

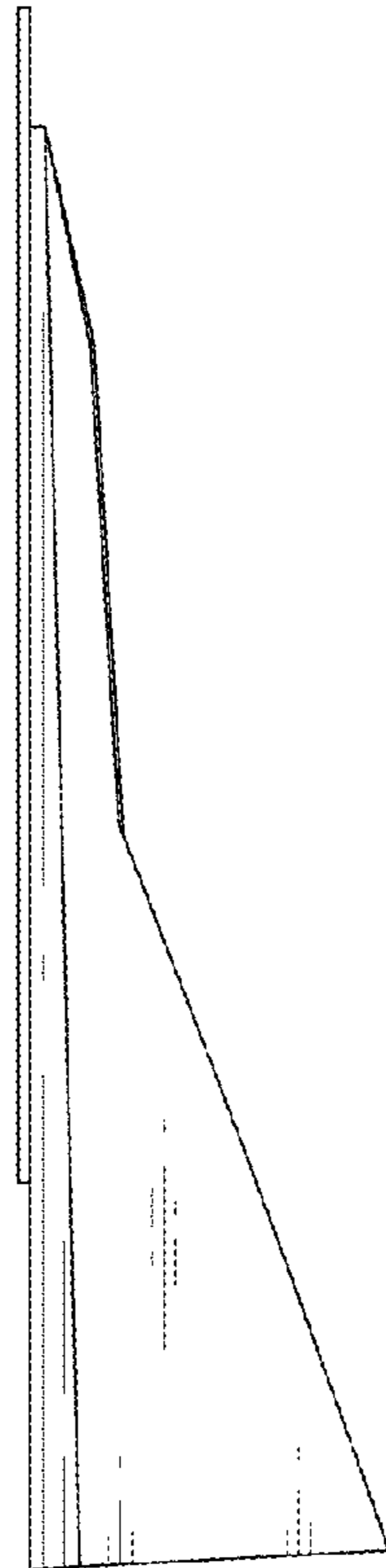

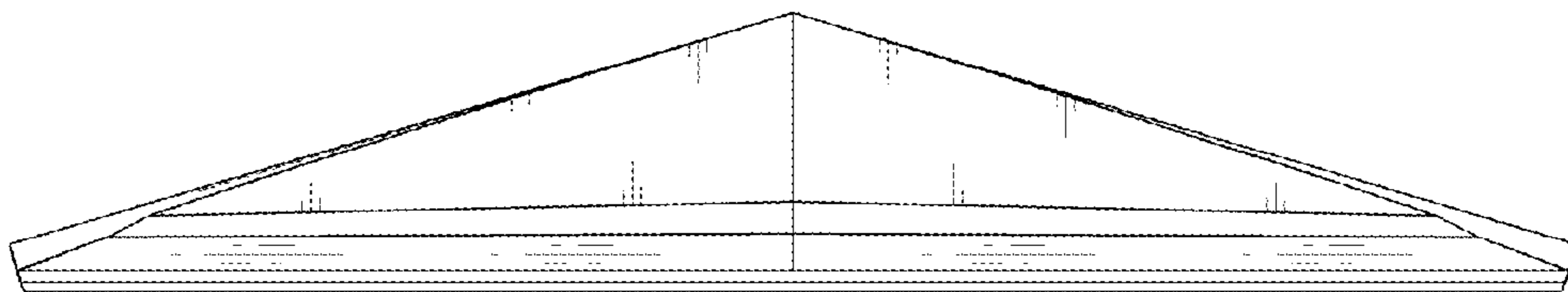

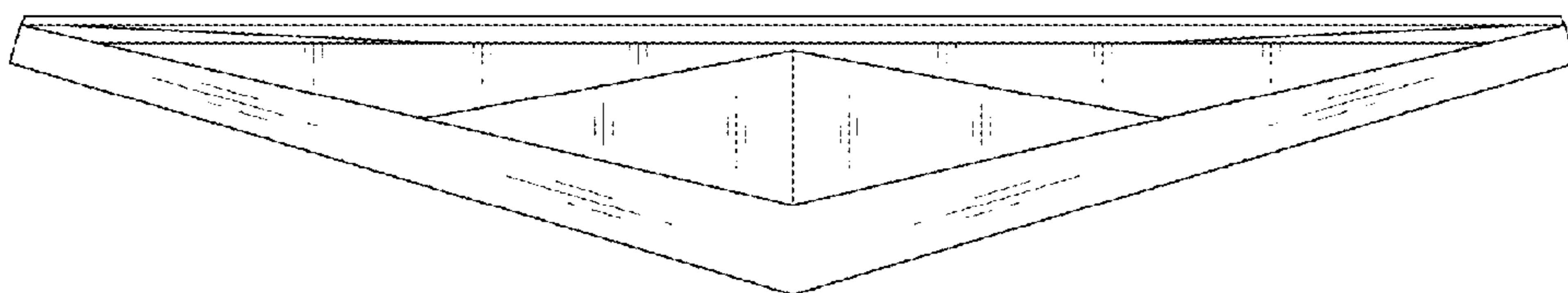

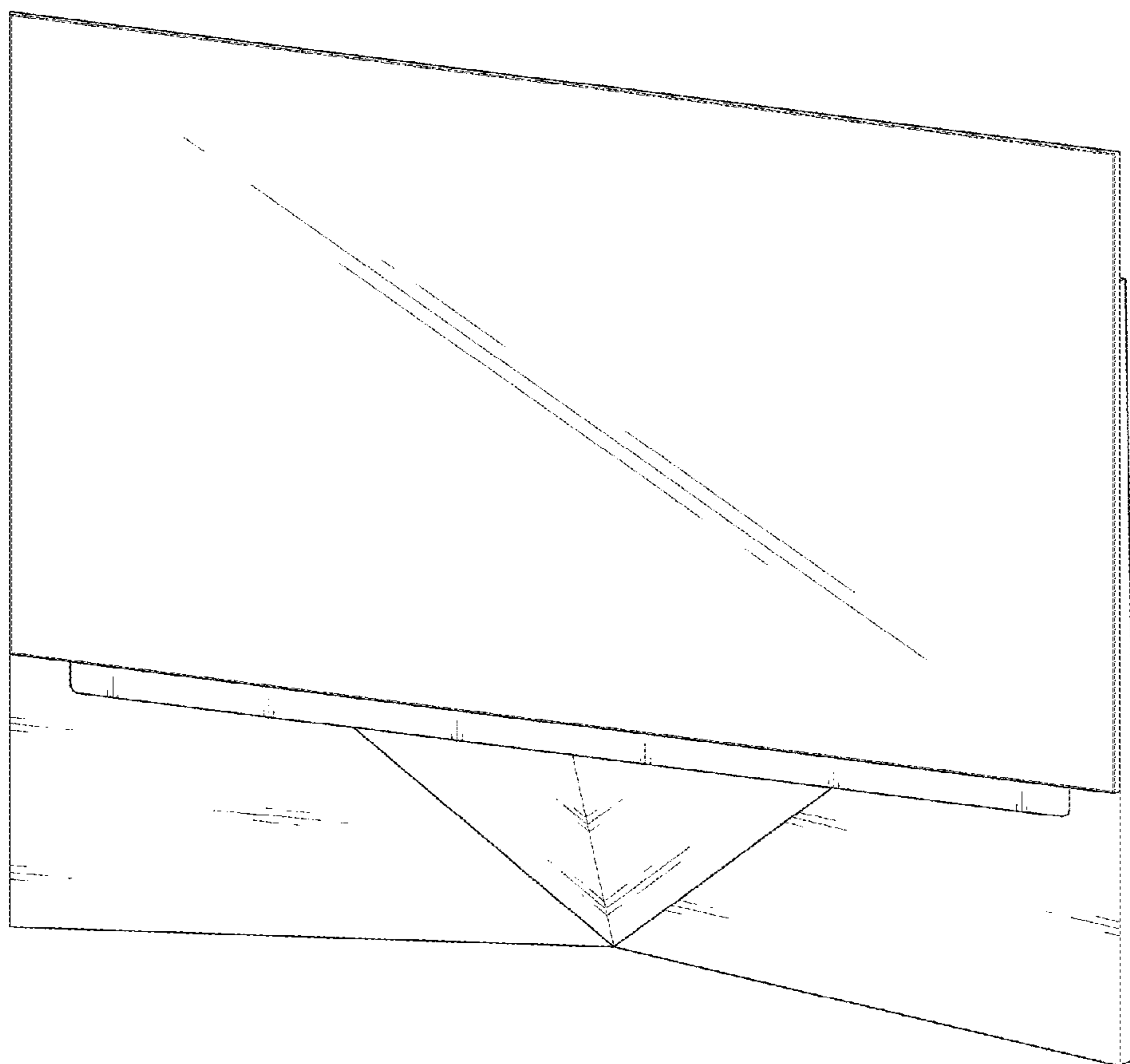

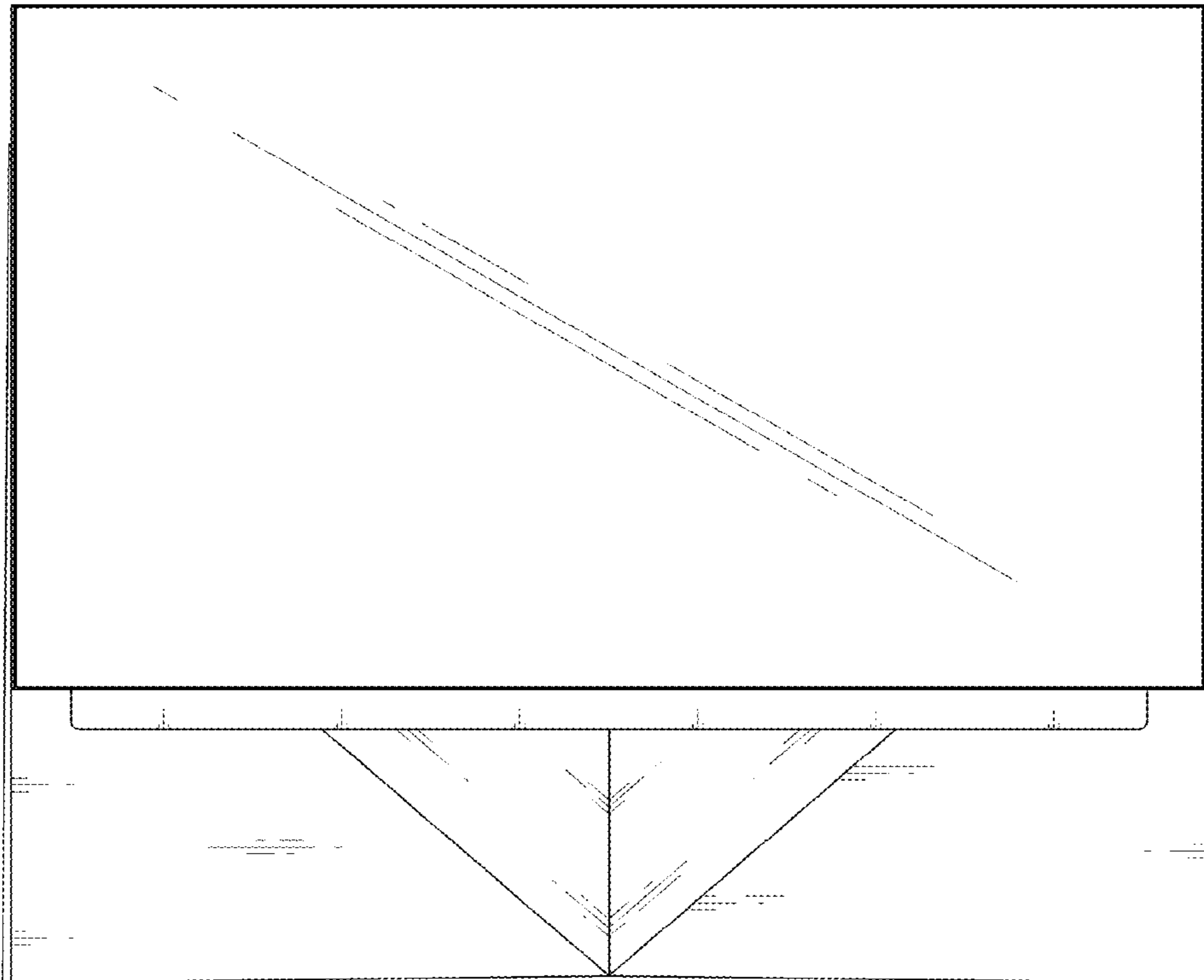

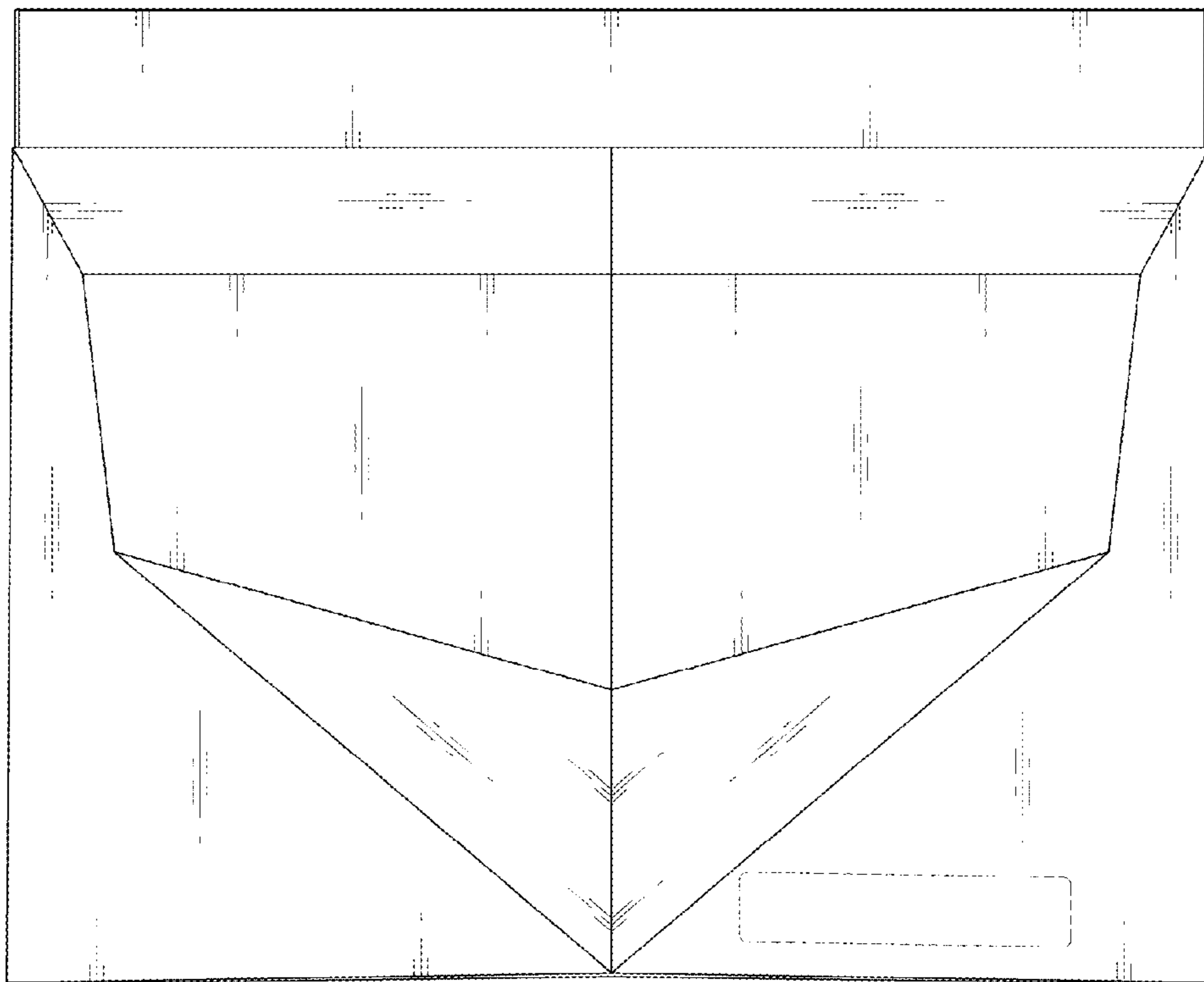

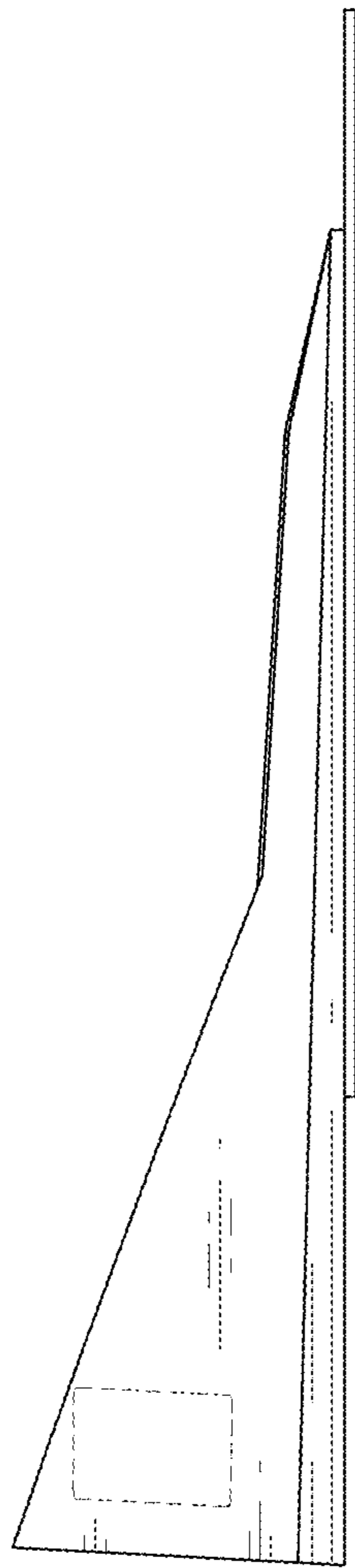

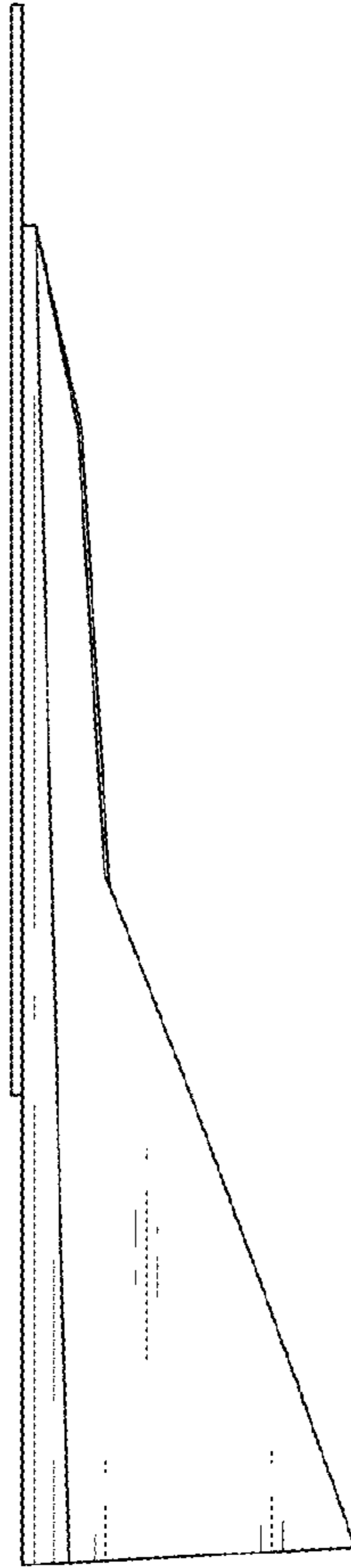

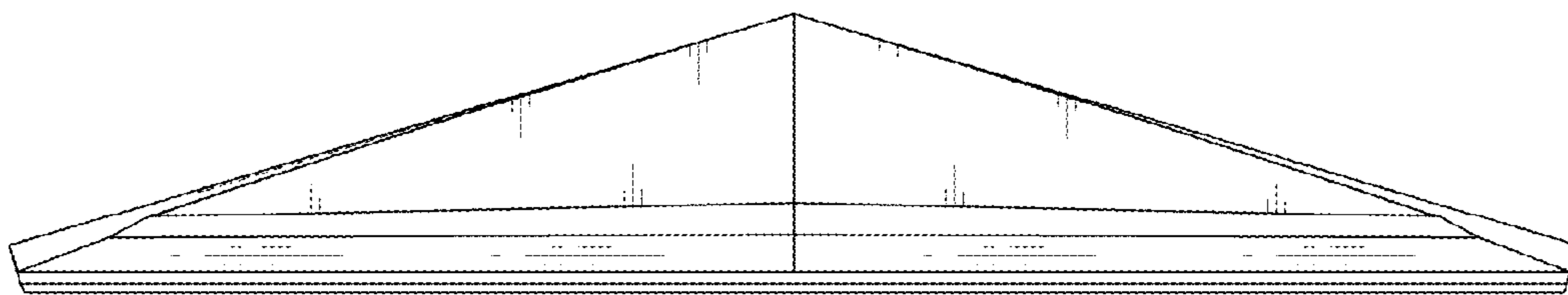

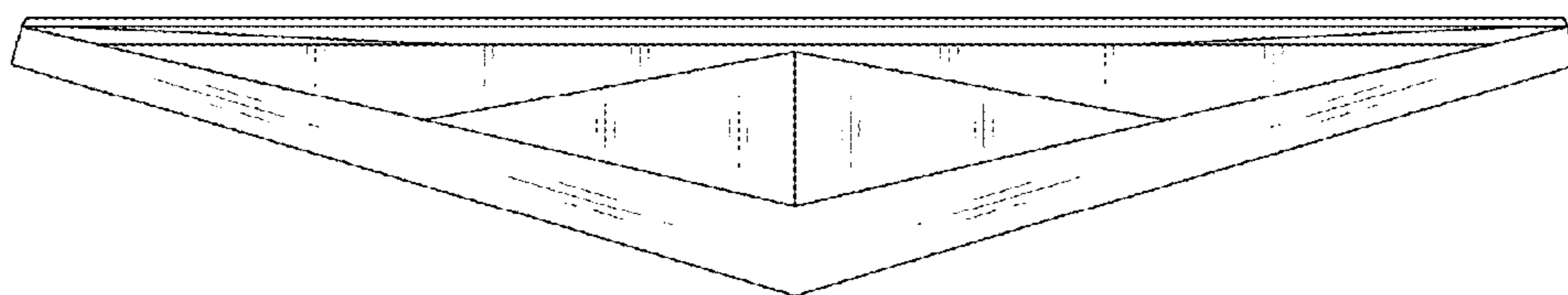

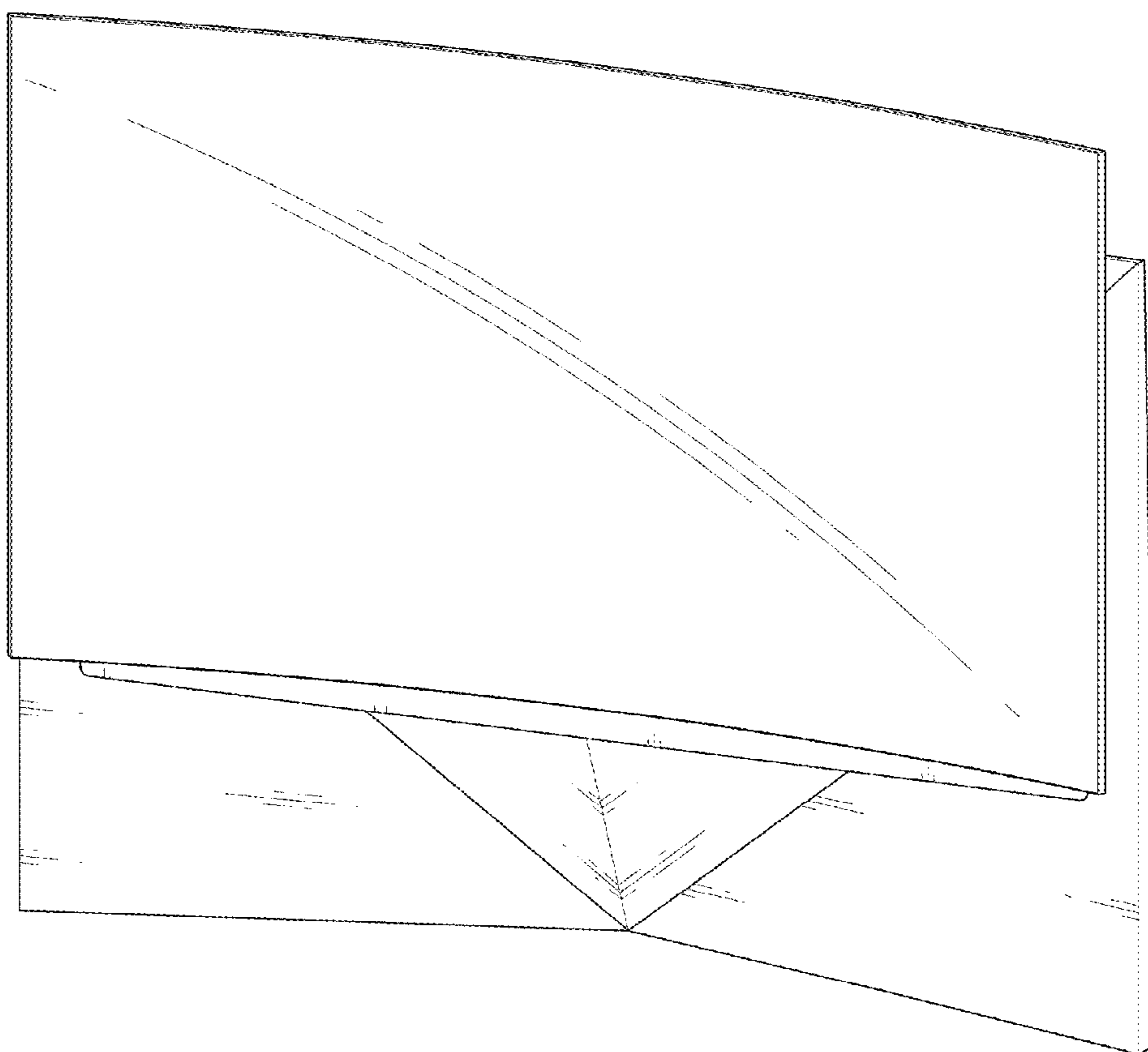

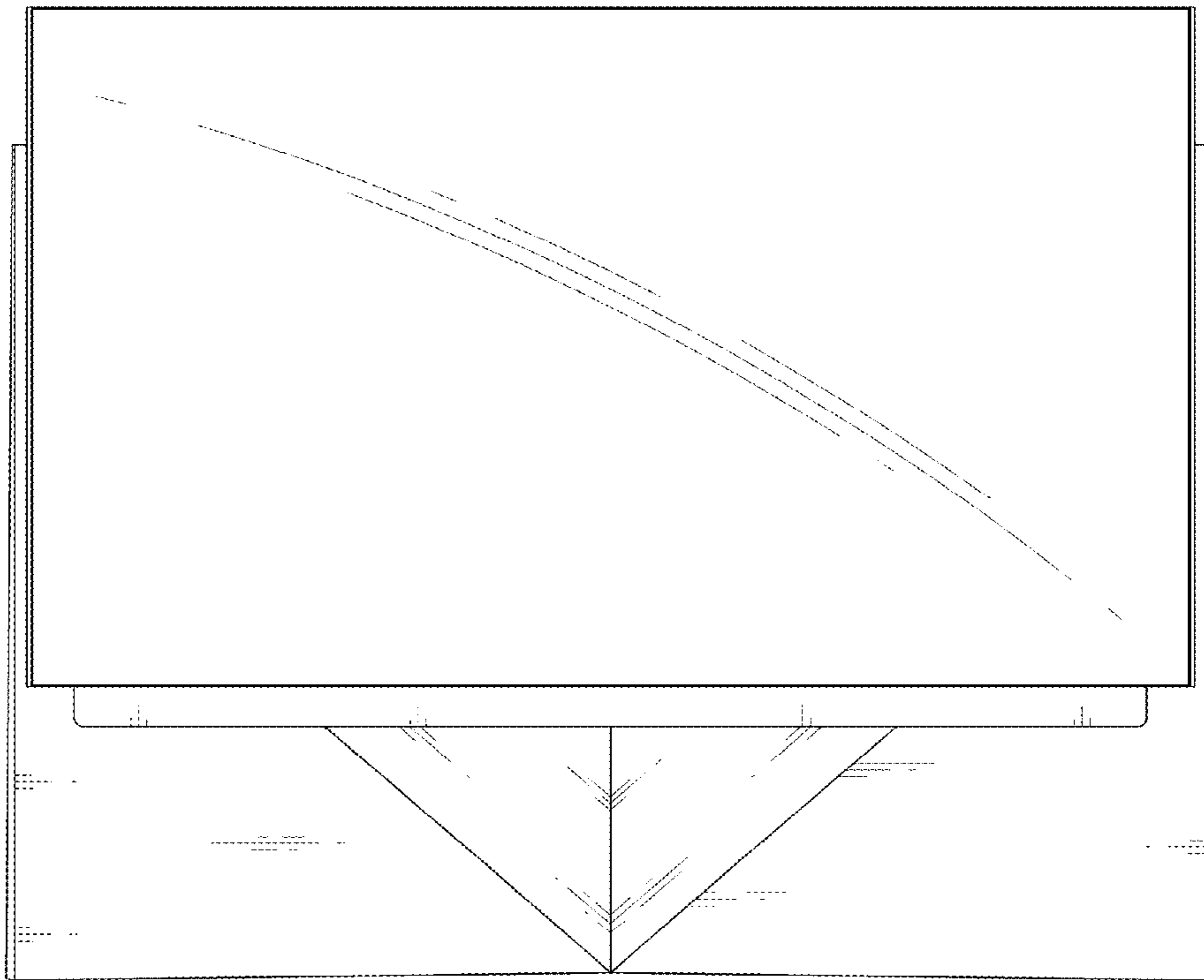

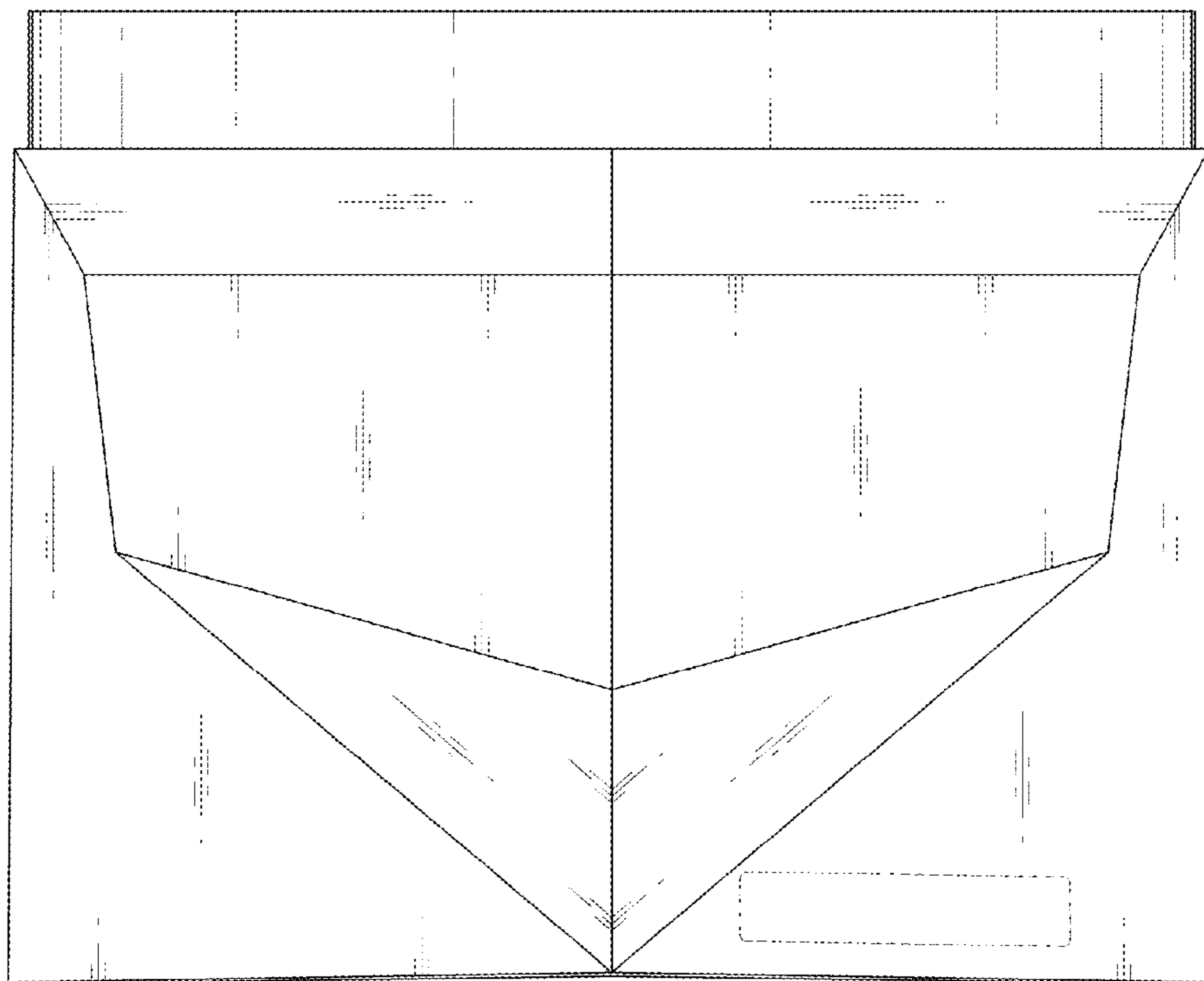

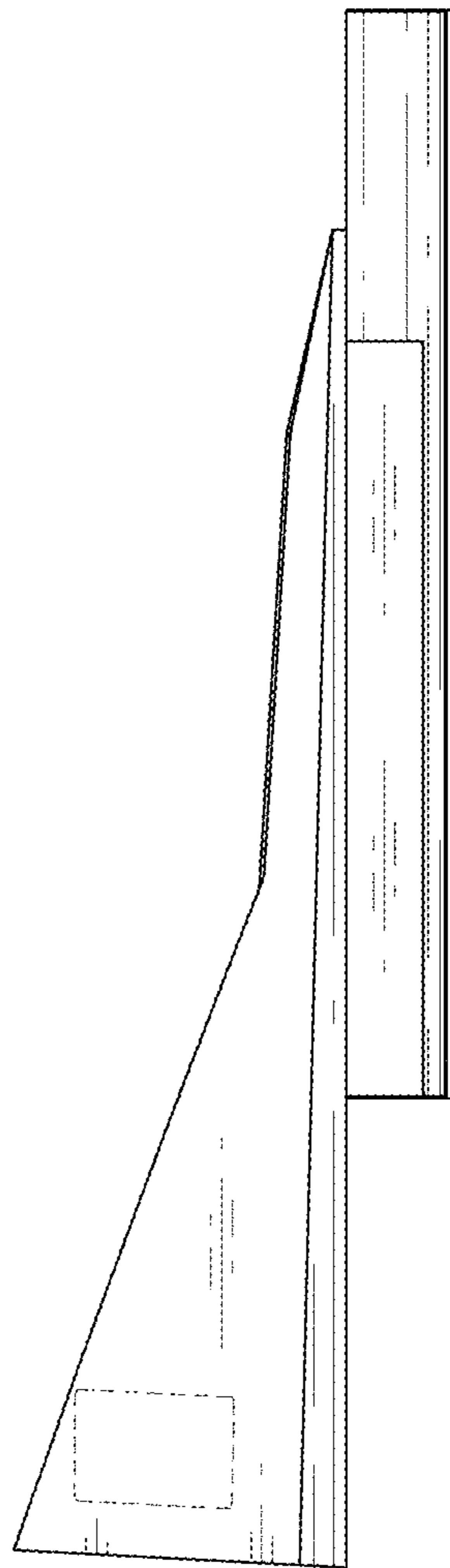

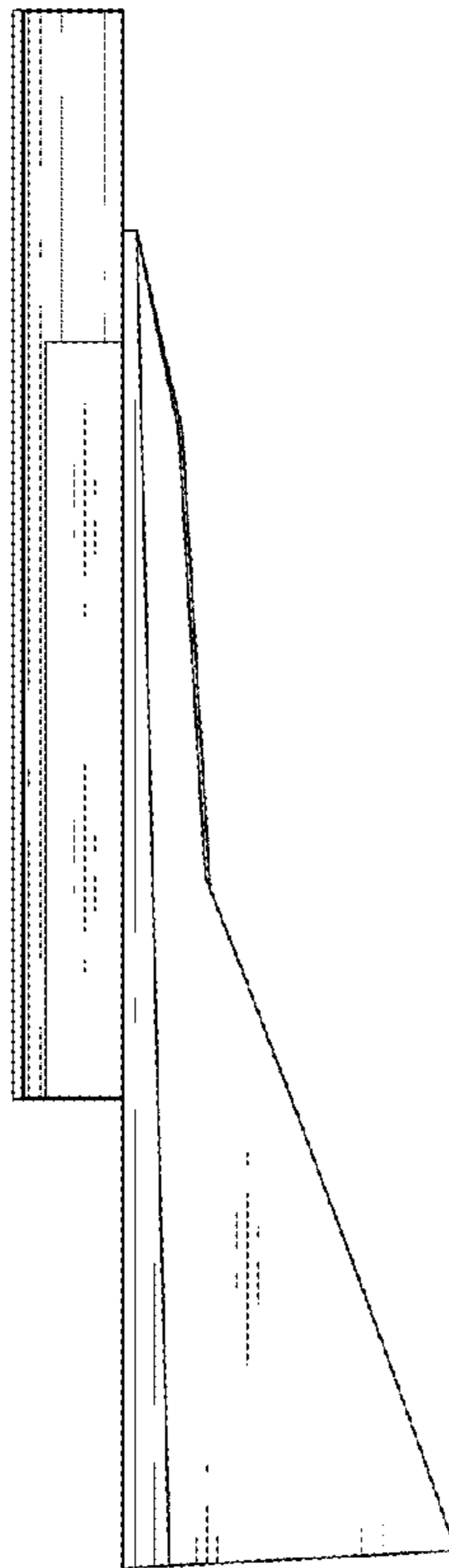

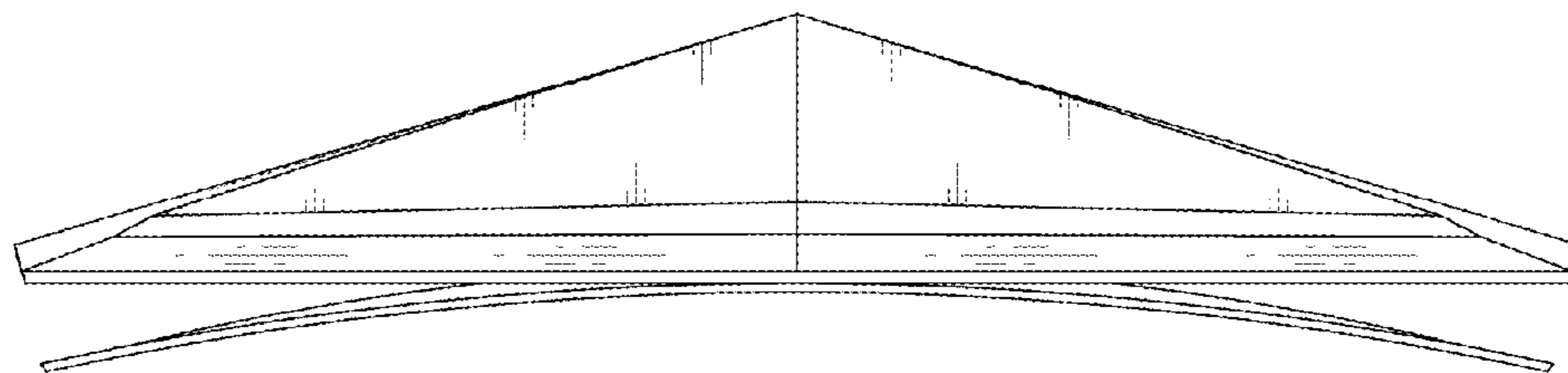
