(57) **CLAIM**

The ornamental design for a portion of a handheld device, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective side view of a first embodiment of a handheld device.

FIG. 2 is a front view of the embodiment of FIG. 1.

FIG. 3 is a rear view of the embodiment of FIG. 1.

FIG. 4 is a left side view of the embodiment of FIG. 1.

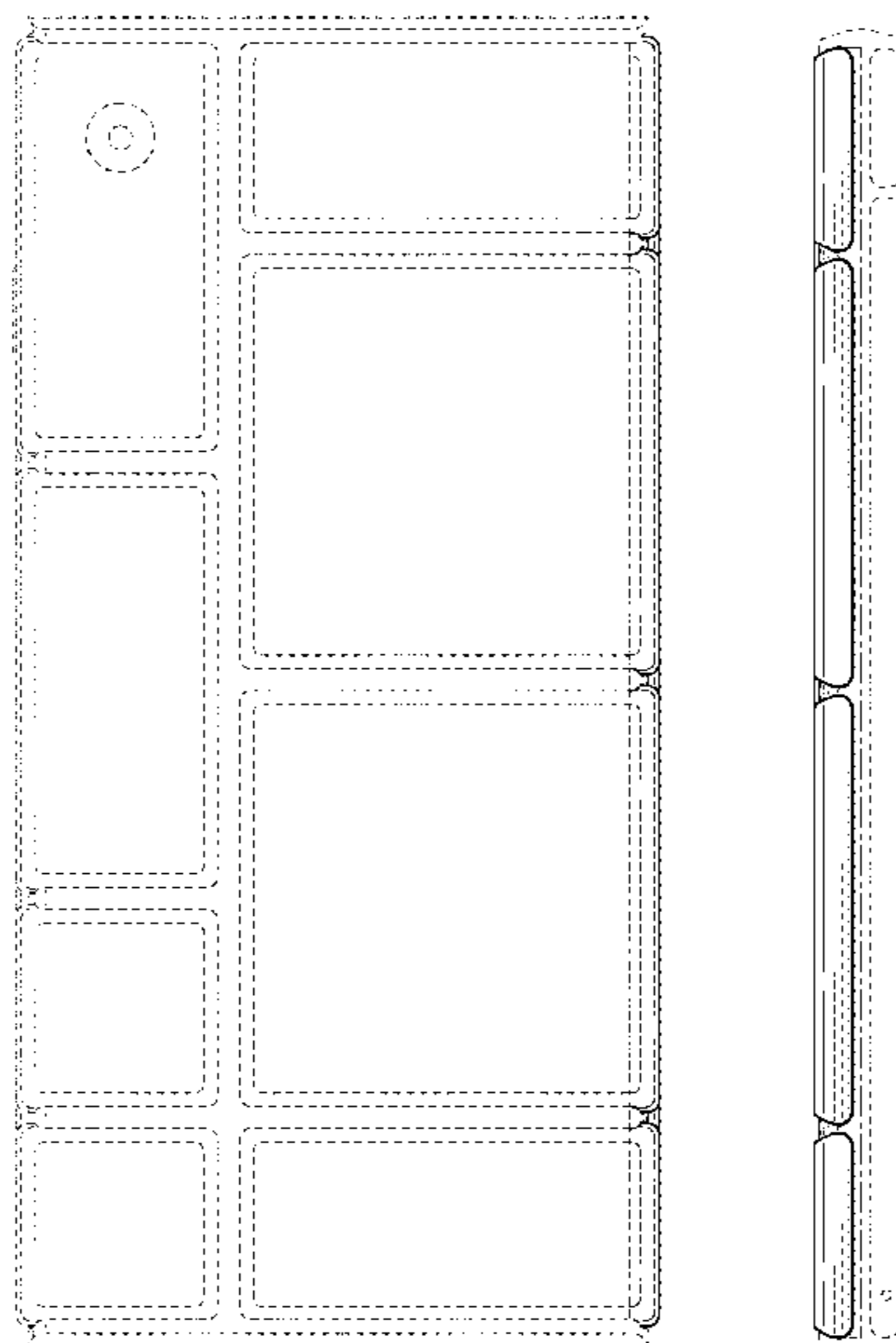
FIG. 5 is a right side view of the embodiment of FIG. 1.

FIG. 6 is a bottom view of the embodiment of FIG. 1; and, FIG. 7 is a top view of the embodiment of FIG. 1.

The claimed design, bordered by a dot-dash line in the perspective and rear views, is illustrated in these two examples as a portion of a side edge of a handheld electronic device, such as a mobile telephone or tablet. The design features modules bounded by and protruding from a frame having orthogonal ribs.

The broken lines in each figure illustrate graphical environmental features that form no part of the claimed design.

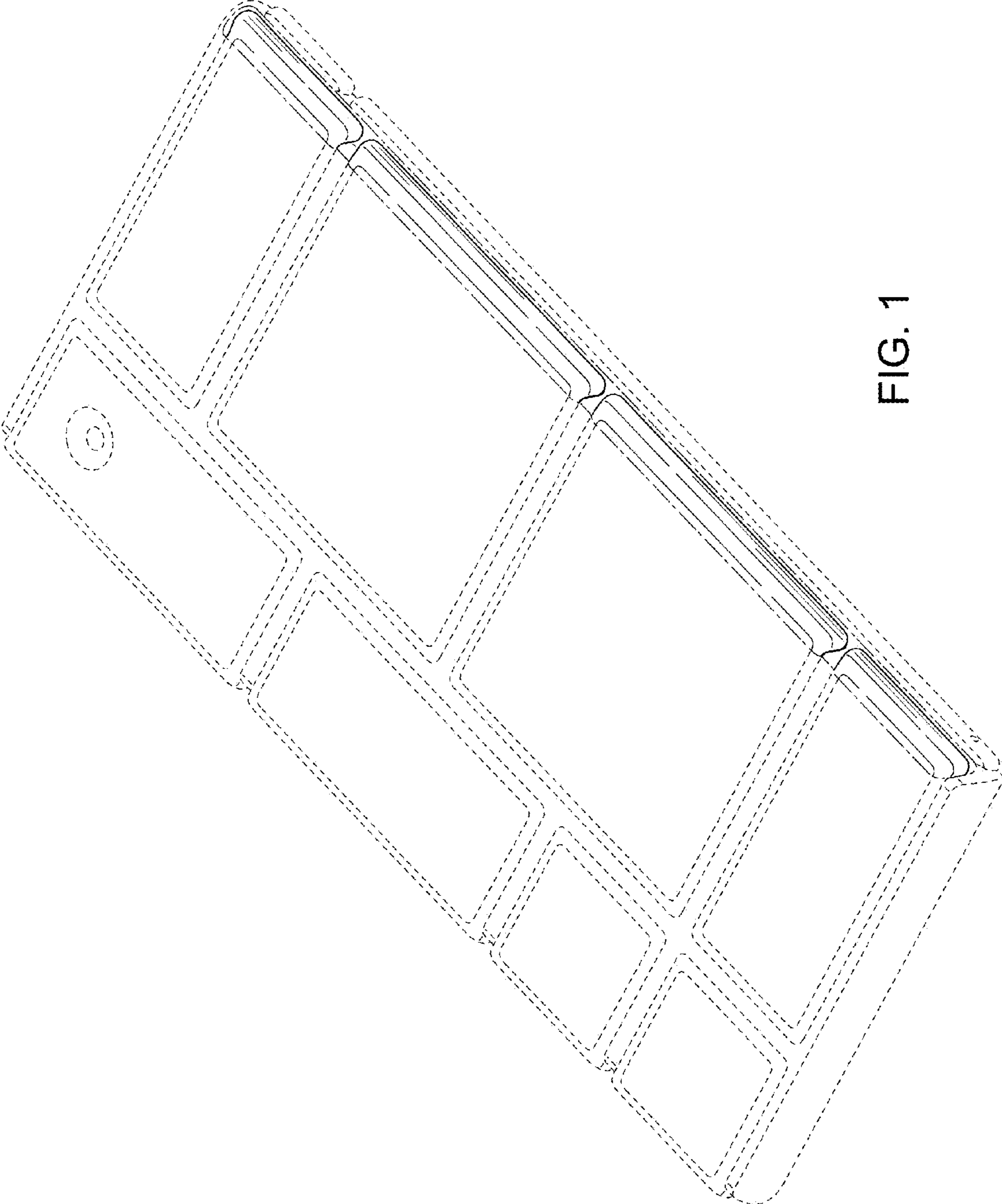

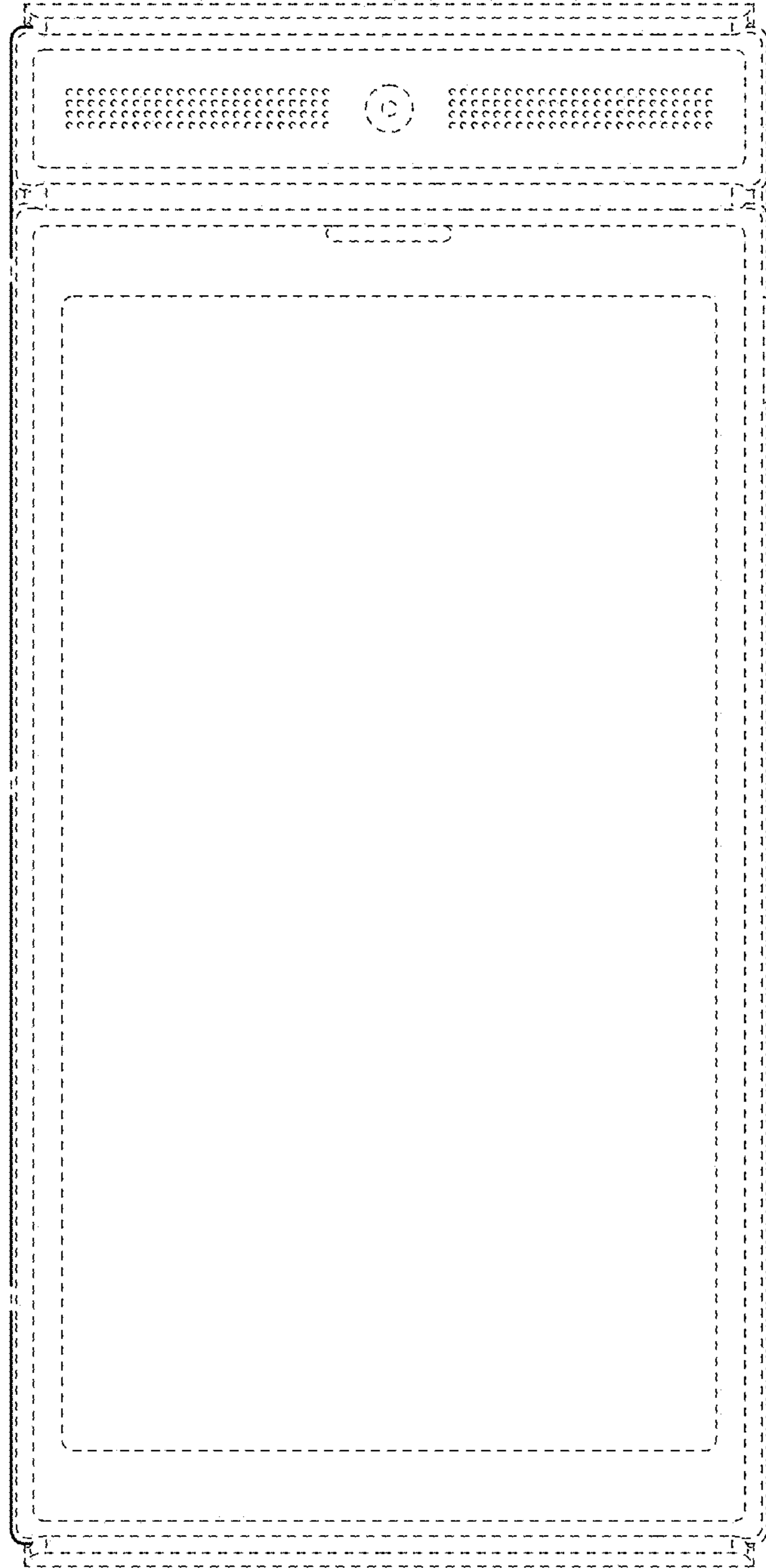

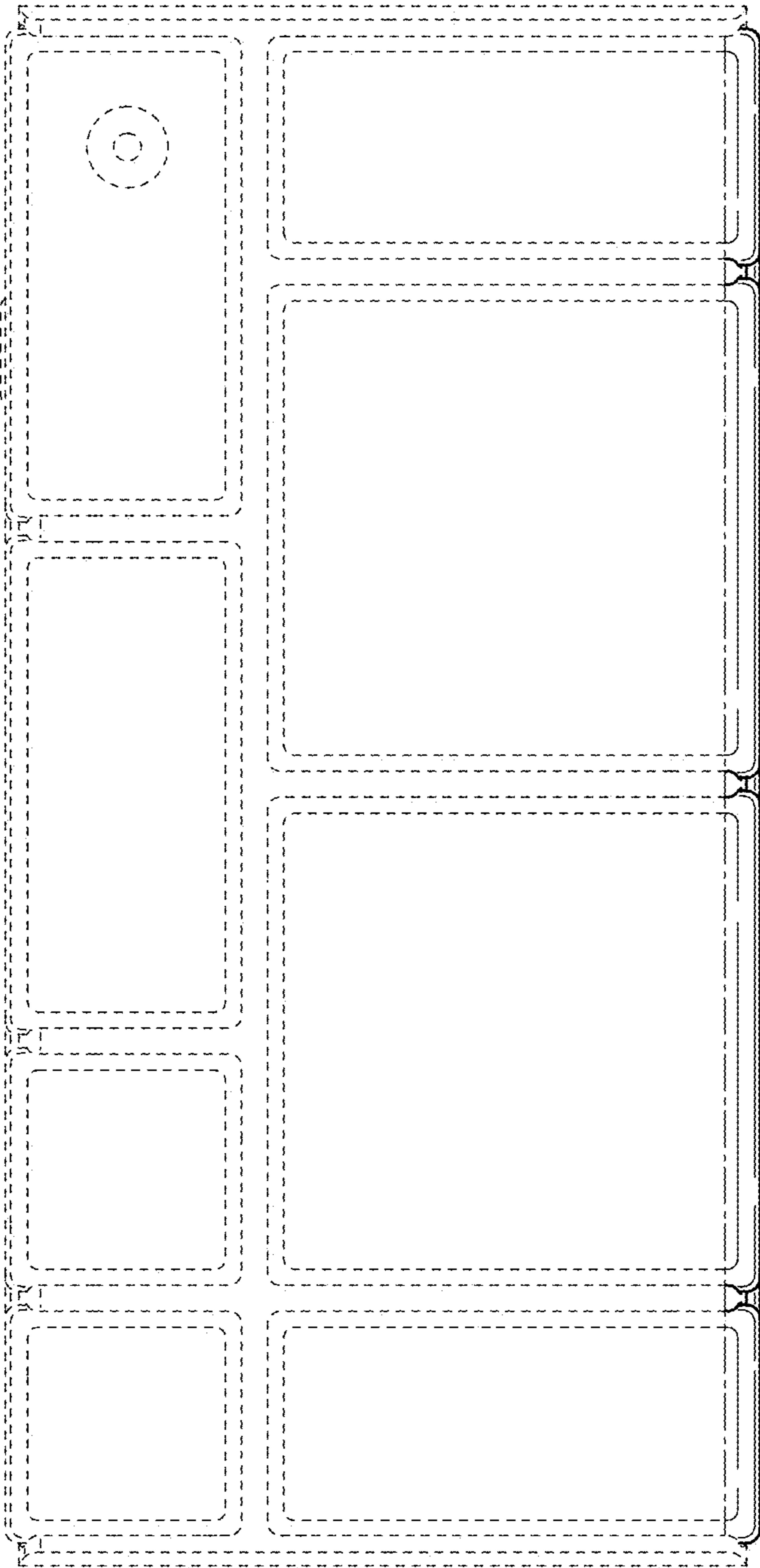

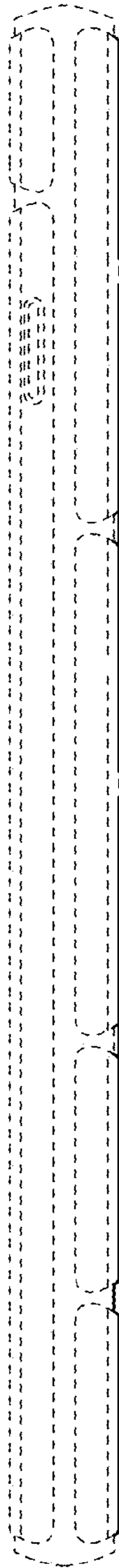

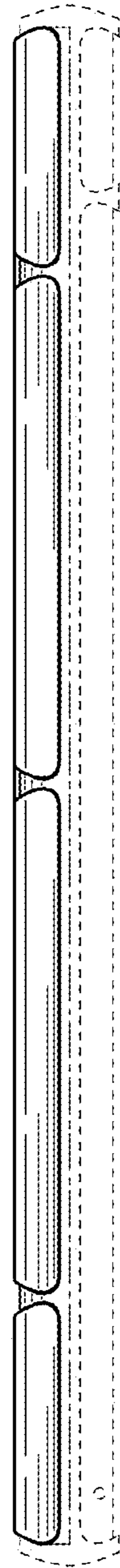

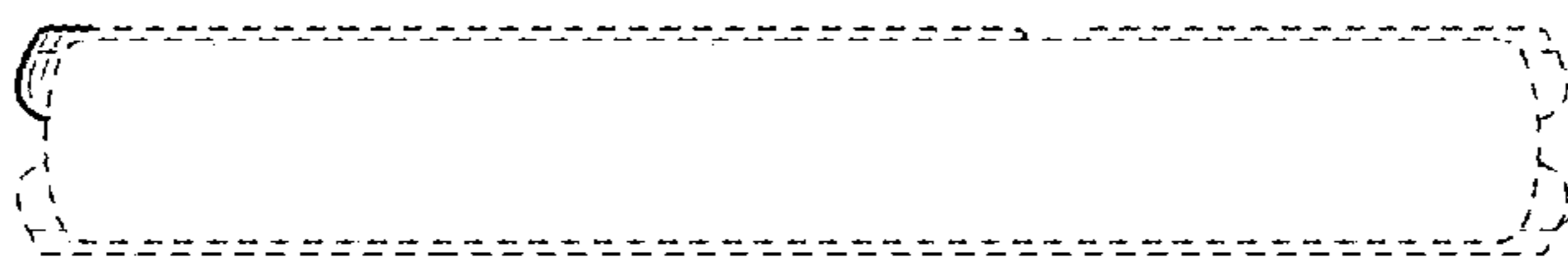

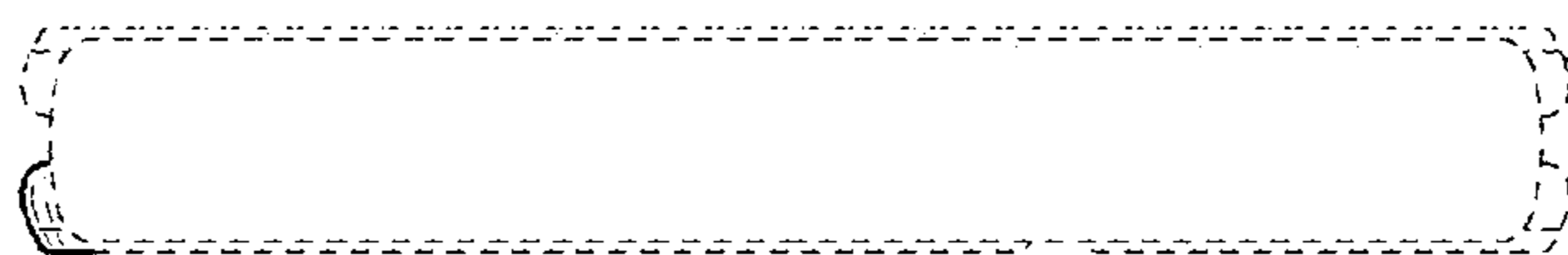
