(57) **CLAIM**

I claim the ornamental design for an display screen with icon
or packaging with surface ornamentation, as shown and
described.

DESCRIPTION

FIG. 1 is a front view of an display screen with icon or
packaging with surface ornamentation in accordance with a
first embodiment of my new design;

FIG. 2 is a front view thereof in accordance with a second
embodiment of my new design; and,

FIG. 3 is a front view thereof in accordance with a third
embodiment of my new design.

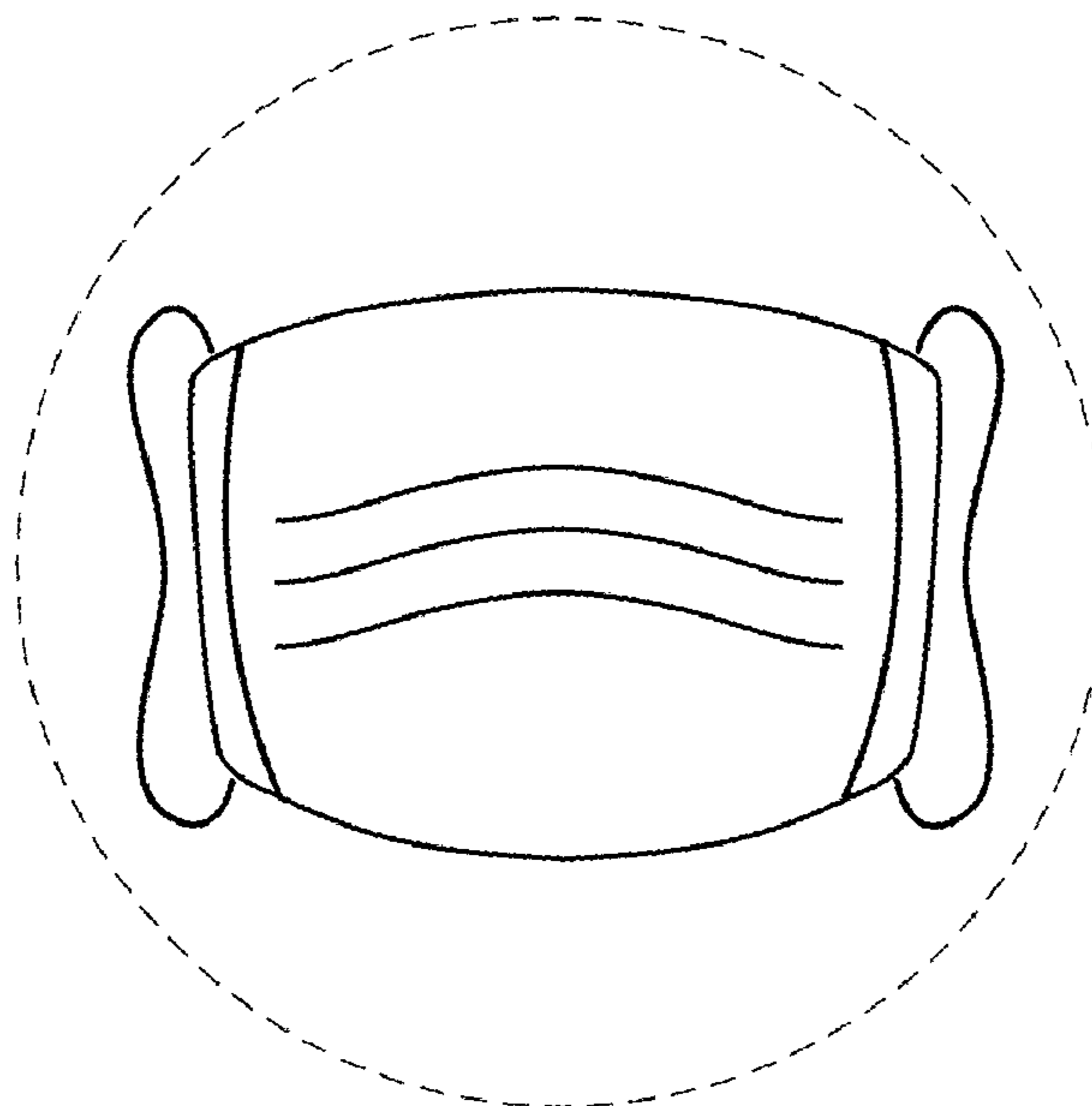

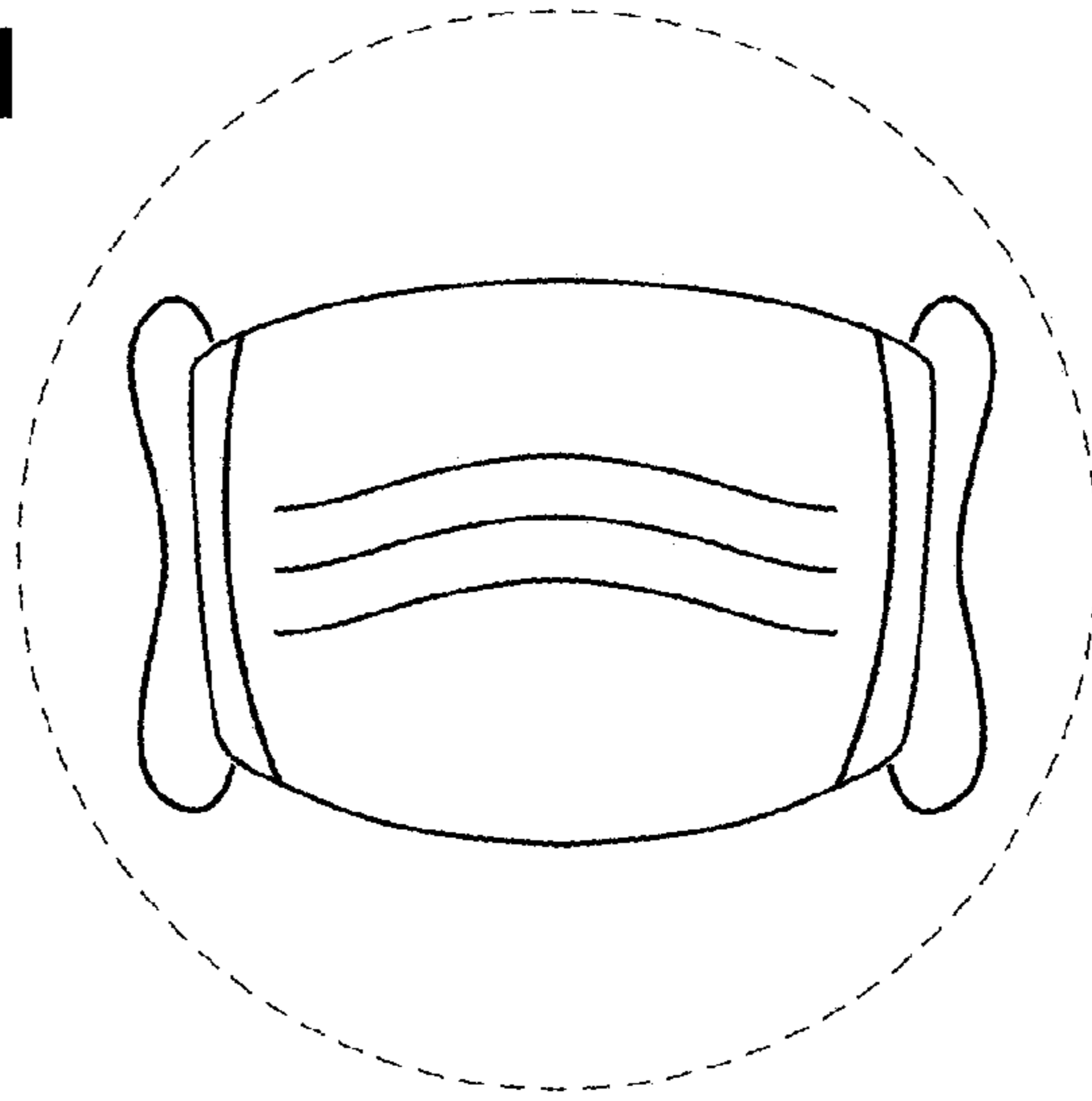

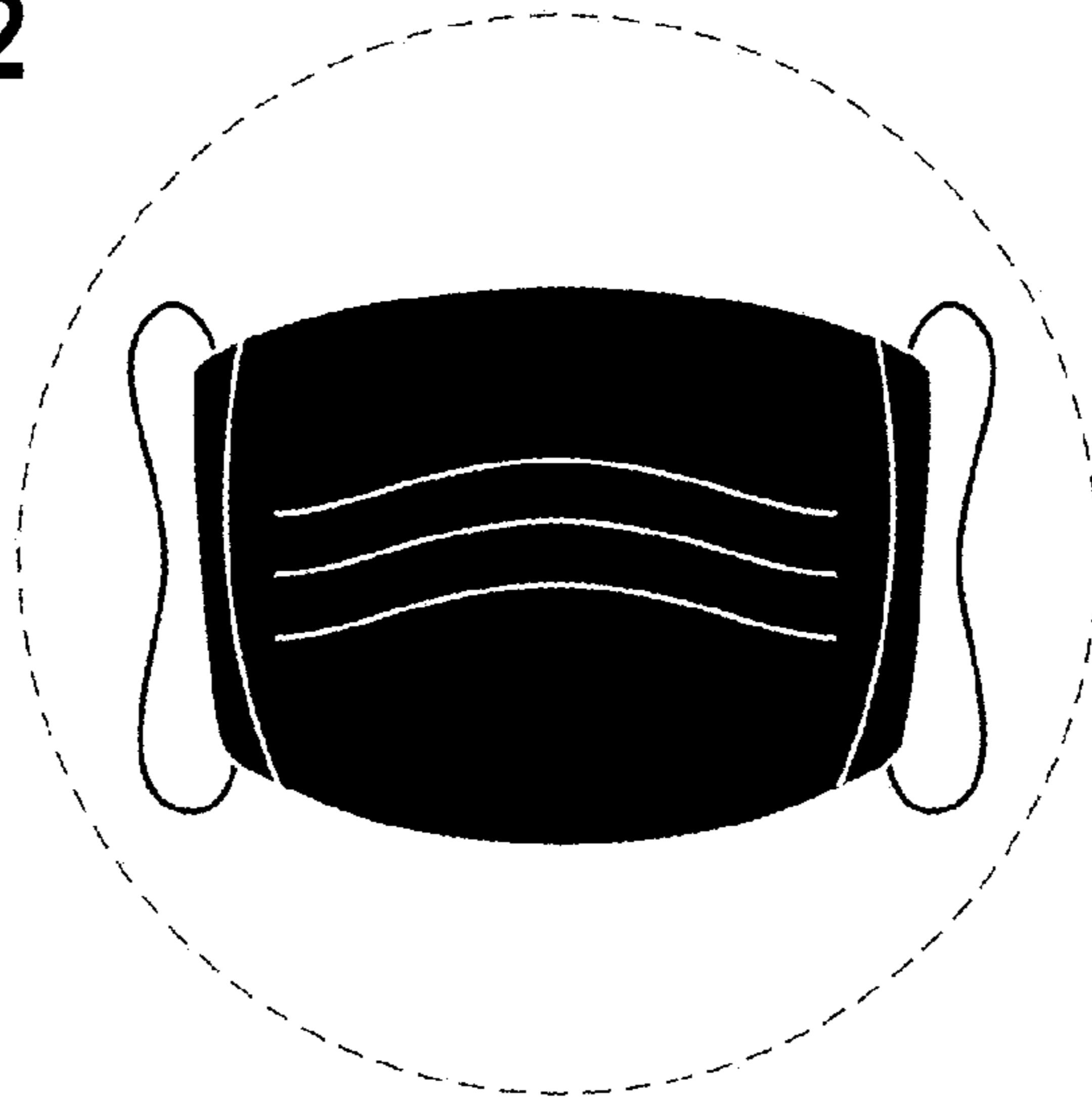
