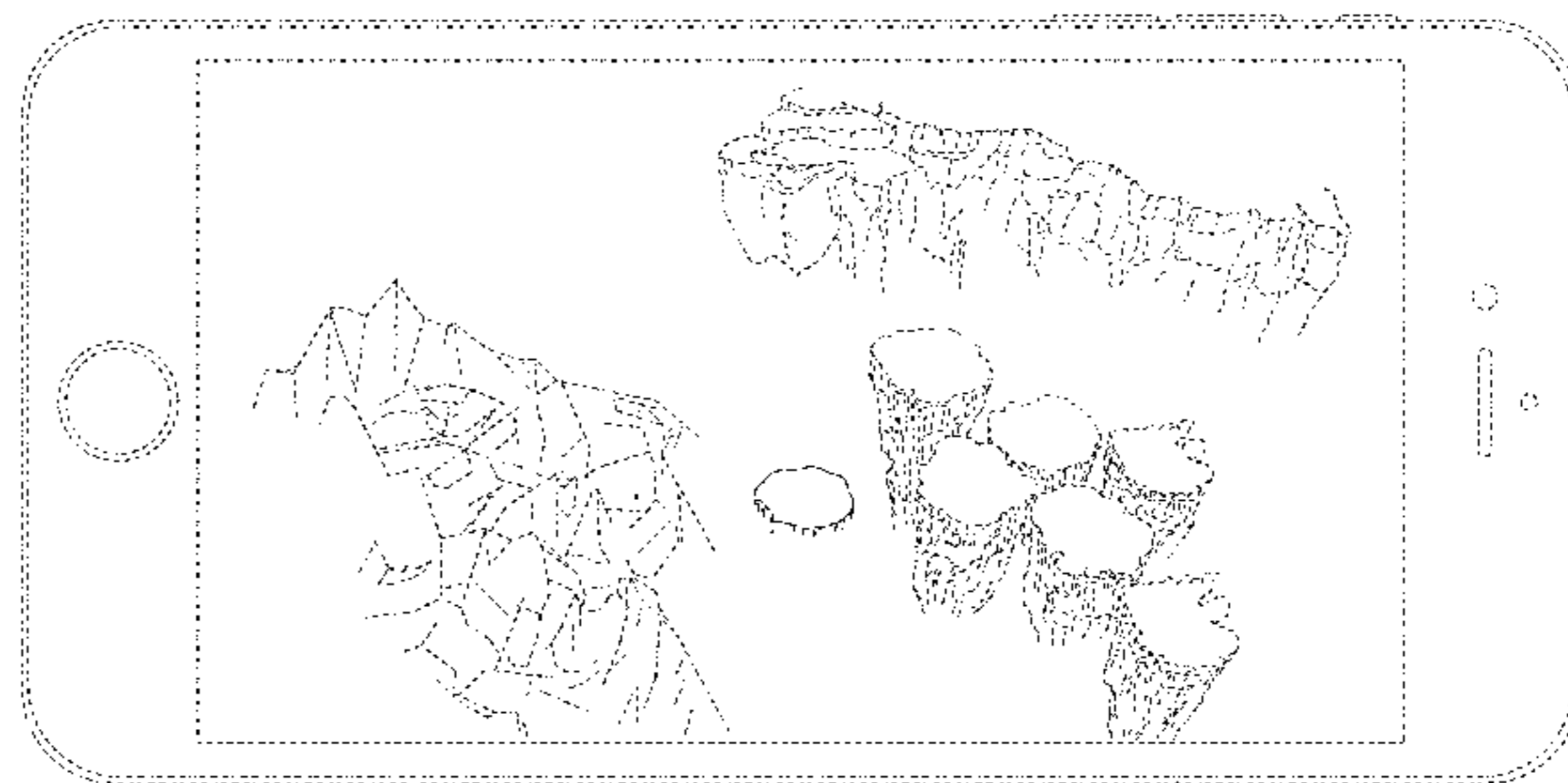
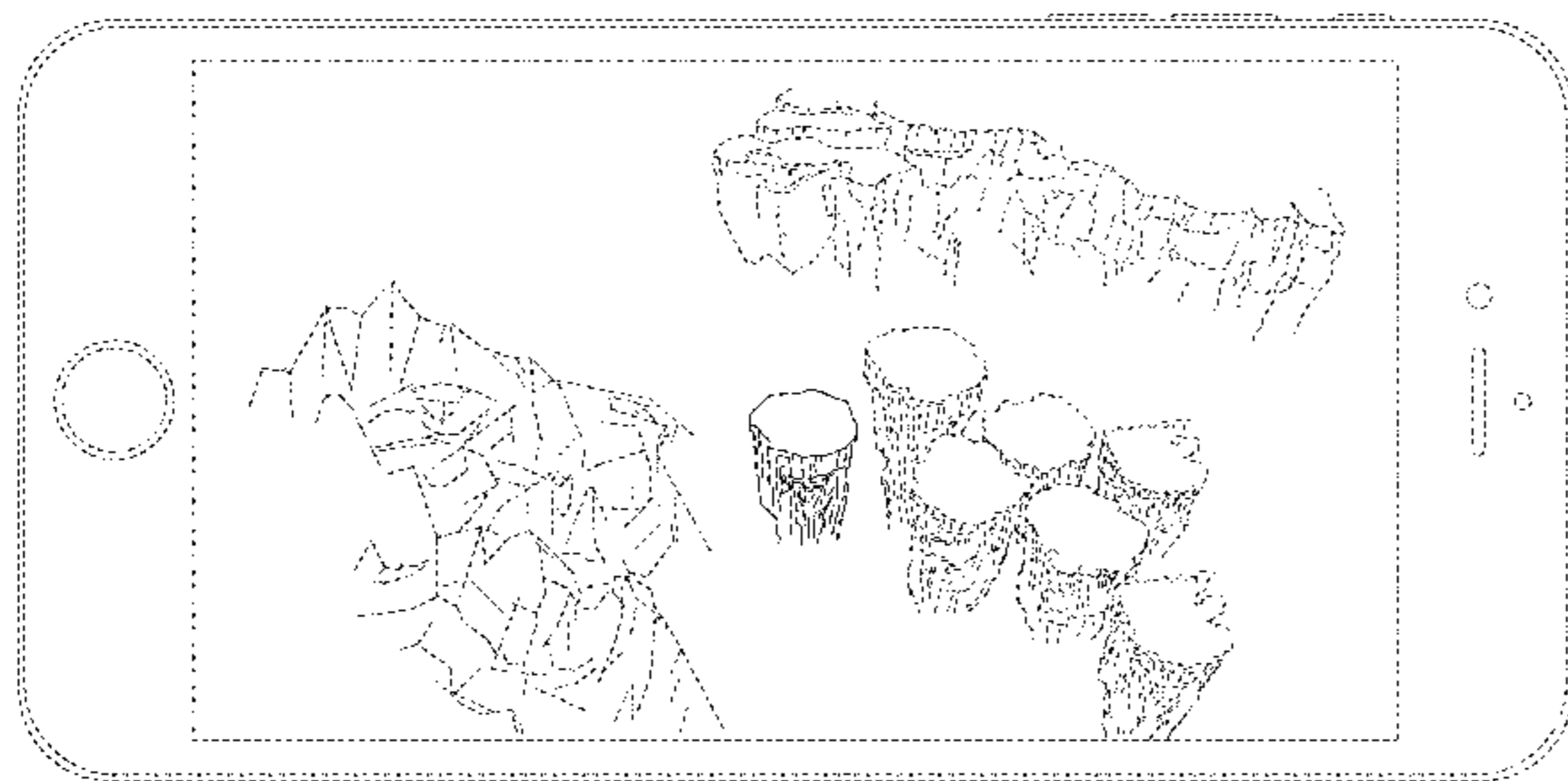
The ornamental design for a portion of a display having a graphical user interface with a transitional icon, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment showing the first image for the sequence of a portion of display having graphical user interface with transitional icon, showing my new design;
 FIG. 2 is a second image thereof;
 FIG. 3 is a third image thereof;
 FIG. 4 is a fourth image thereof;
 FIG. 5 is a fifth image thereof;
 FIG. 6 is front view of a second embodiment showing the first image for the sequence of a portion of display having graphical user interface with transitional icon;
 FIG. 7 is a second image thereof;
 FIG. 8 is a third image thereof;
 FIG. 9 is a fourth image thereof; and,
 FIG. 10 is a fifth image thereof.

The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1-5 and FIGS. 6-10. The process or period in which one image transitions to another forms no part of the claimed design. The broken line showing of the device is included for the purpose of illustrating environmental structure and the broken line showing of the display and portion of the graphical user interface is included for the purpose of illustrating portions of the article; the broken lines form no part of the claimed design.

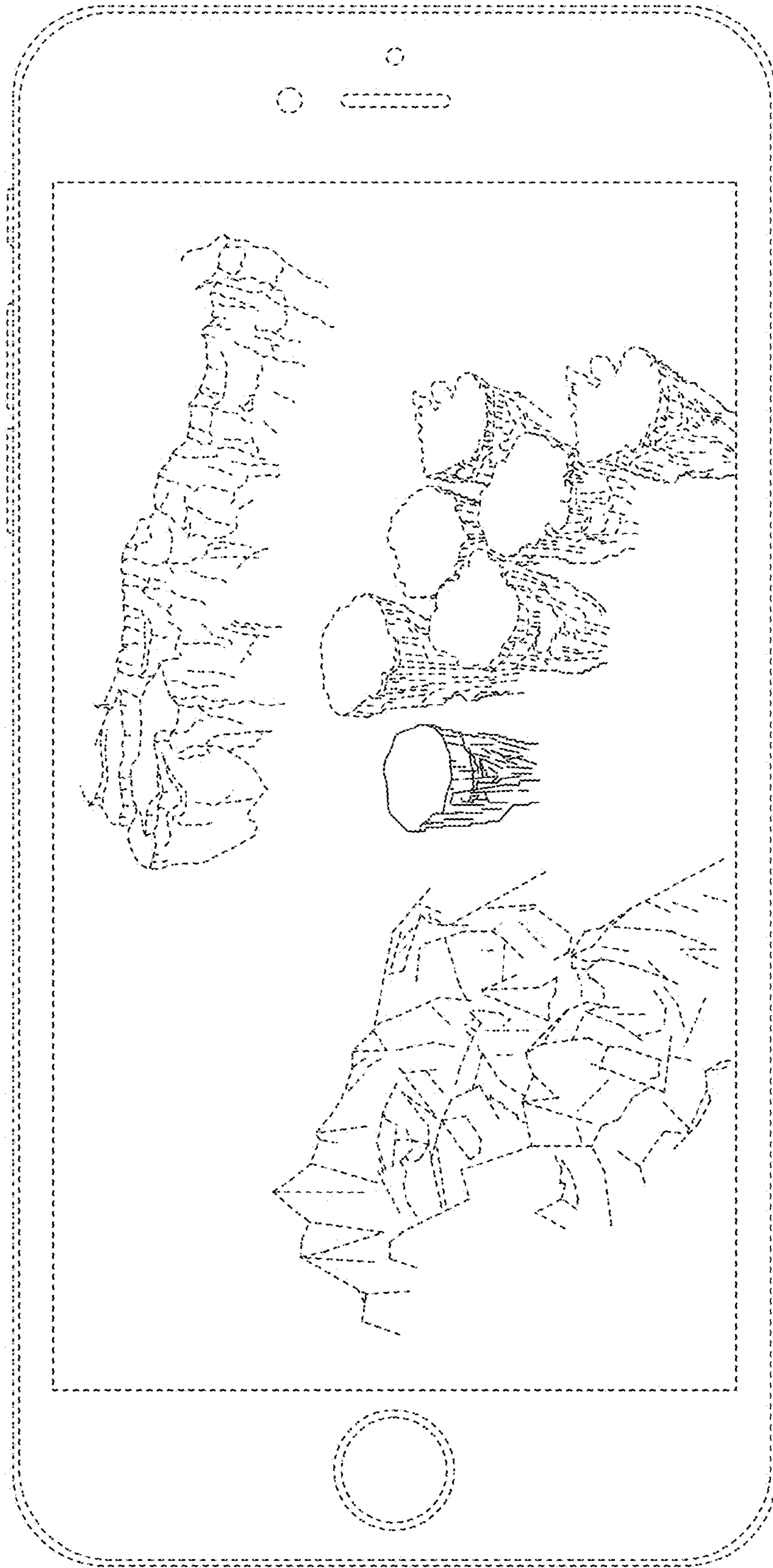

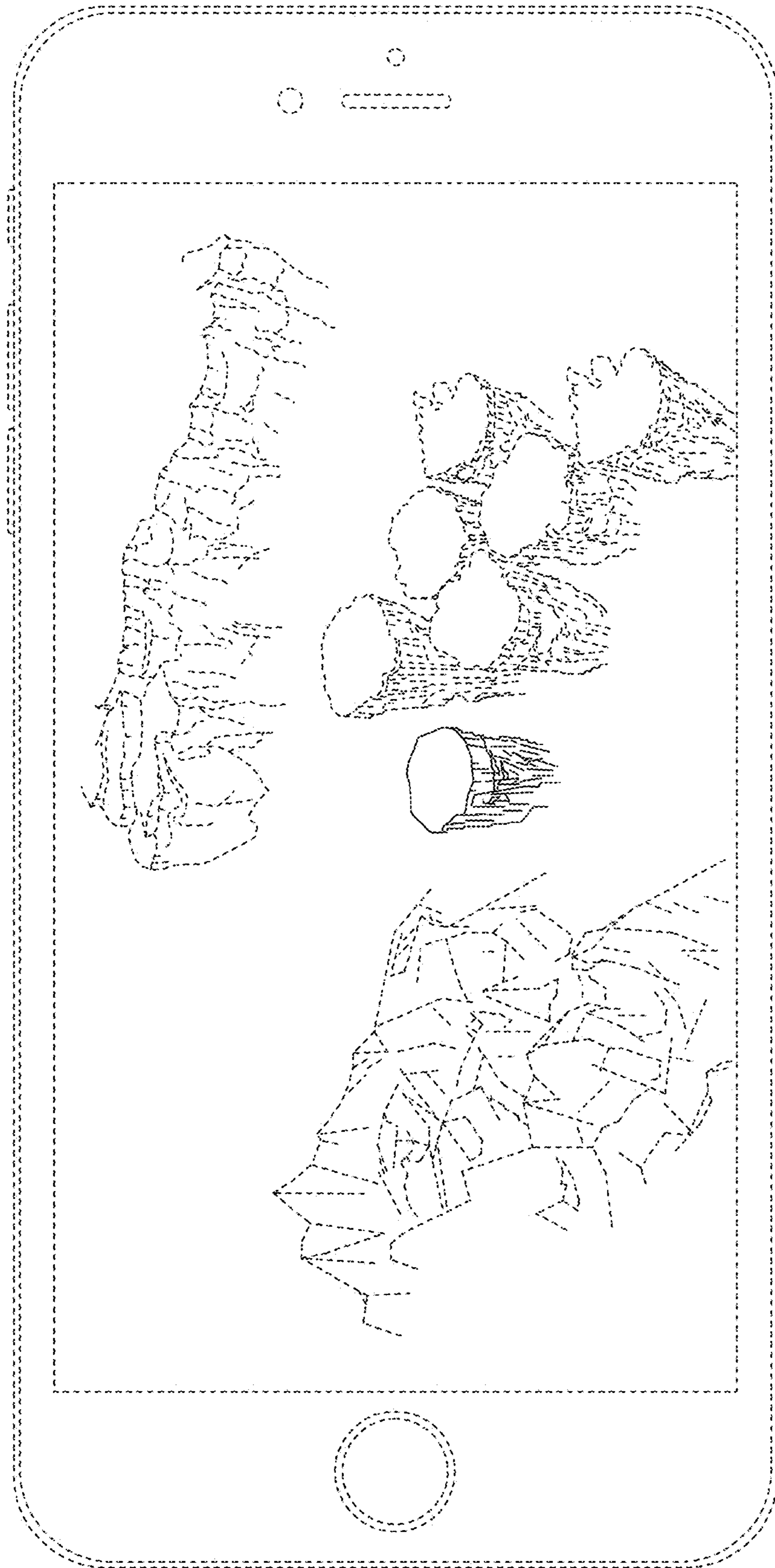

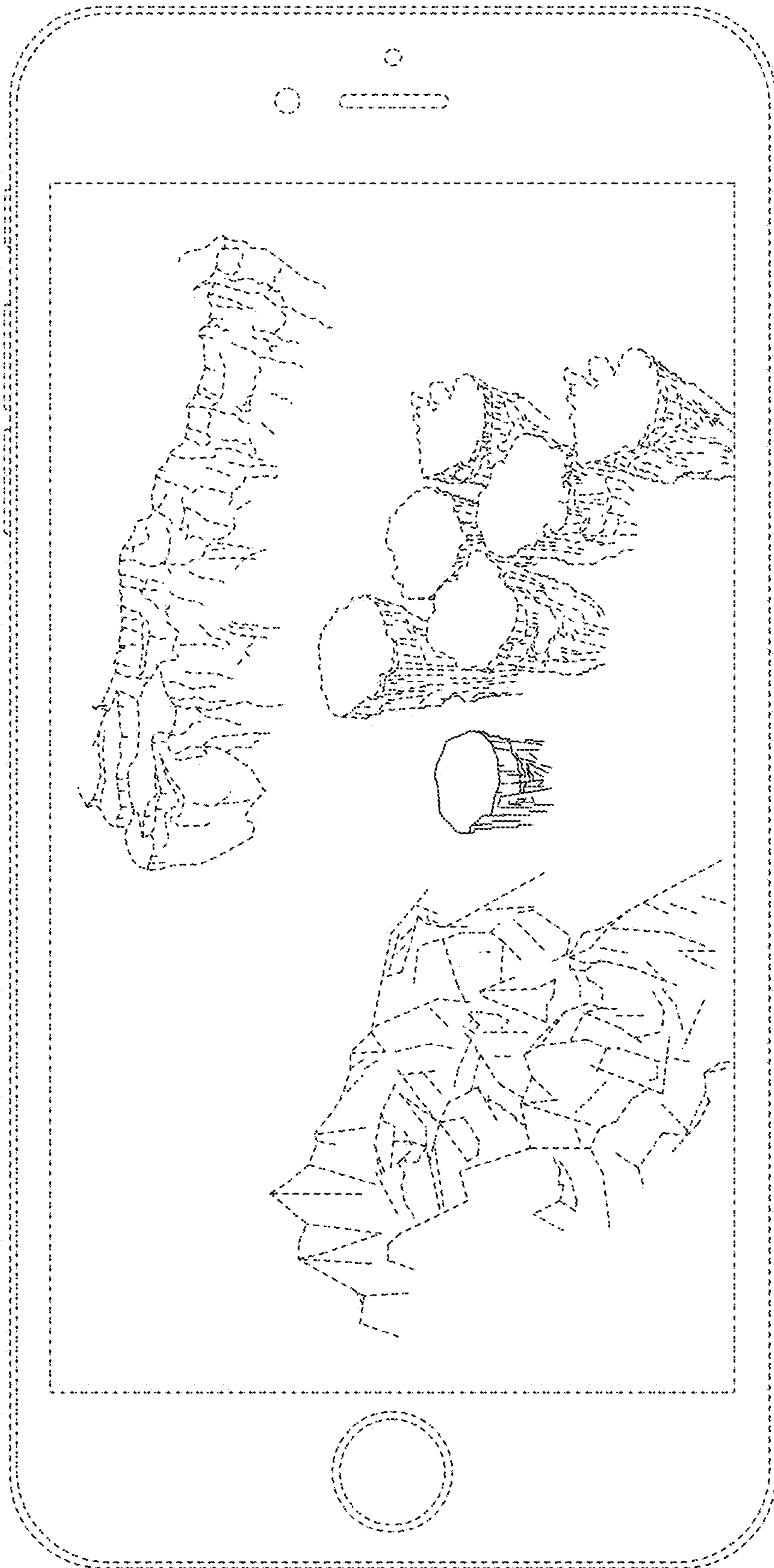

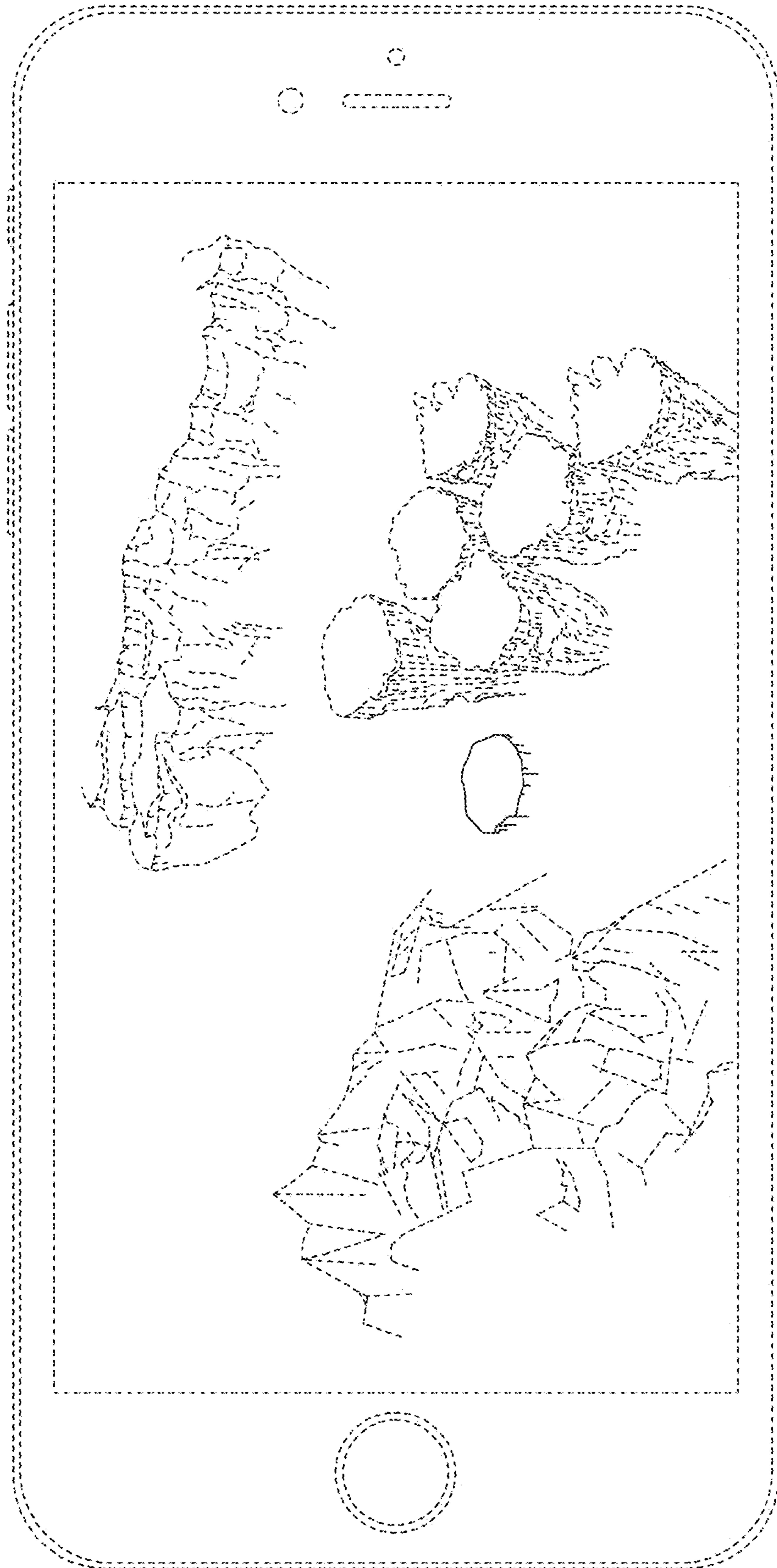

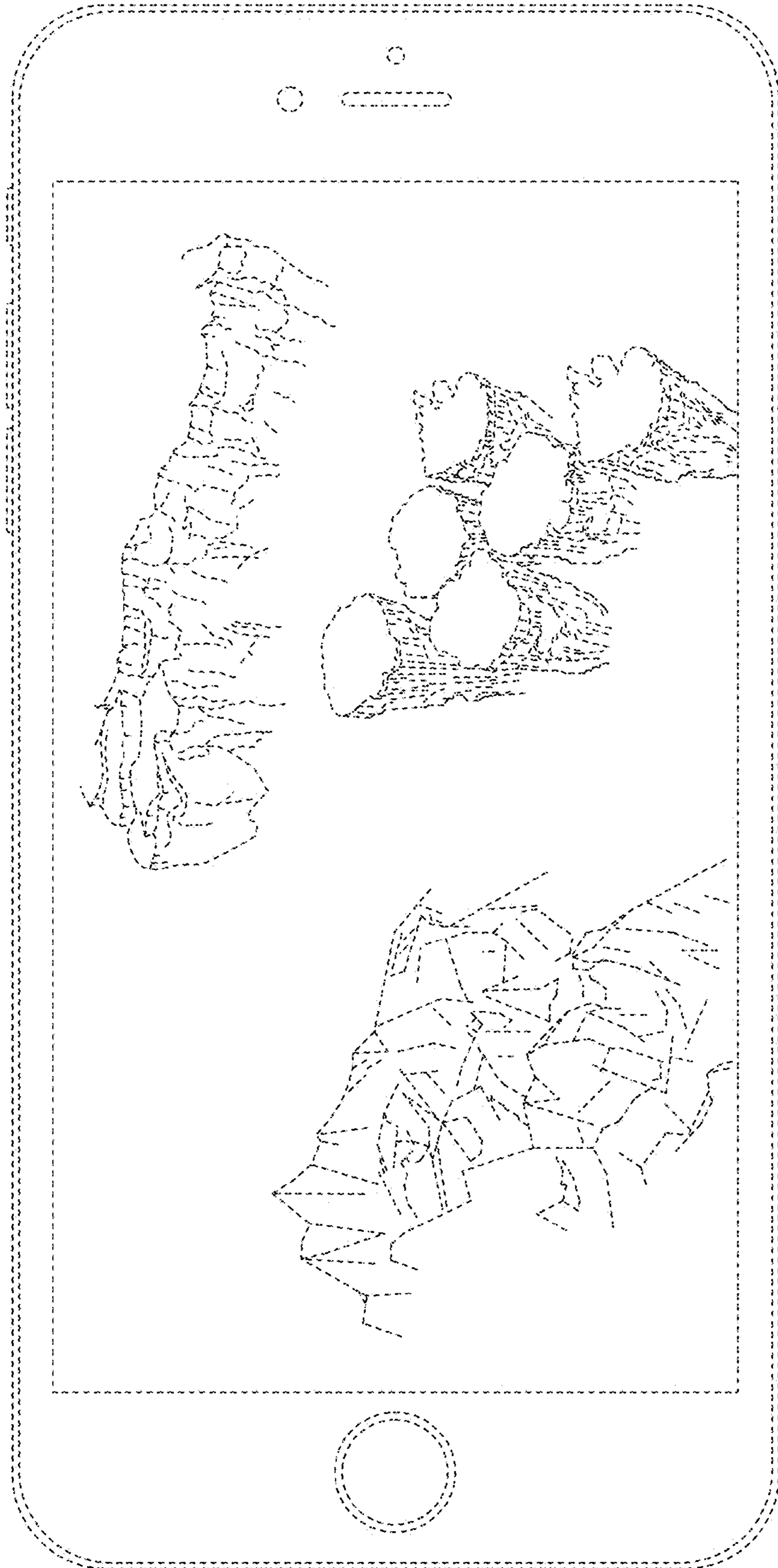

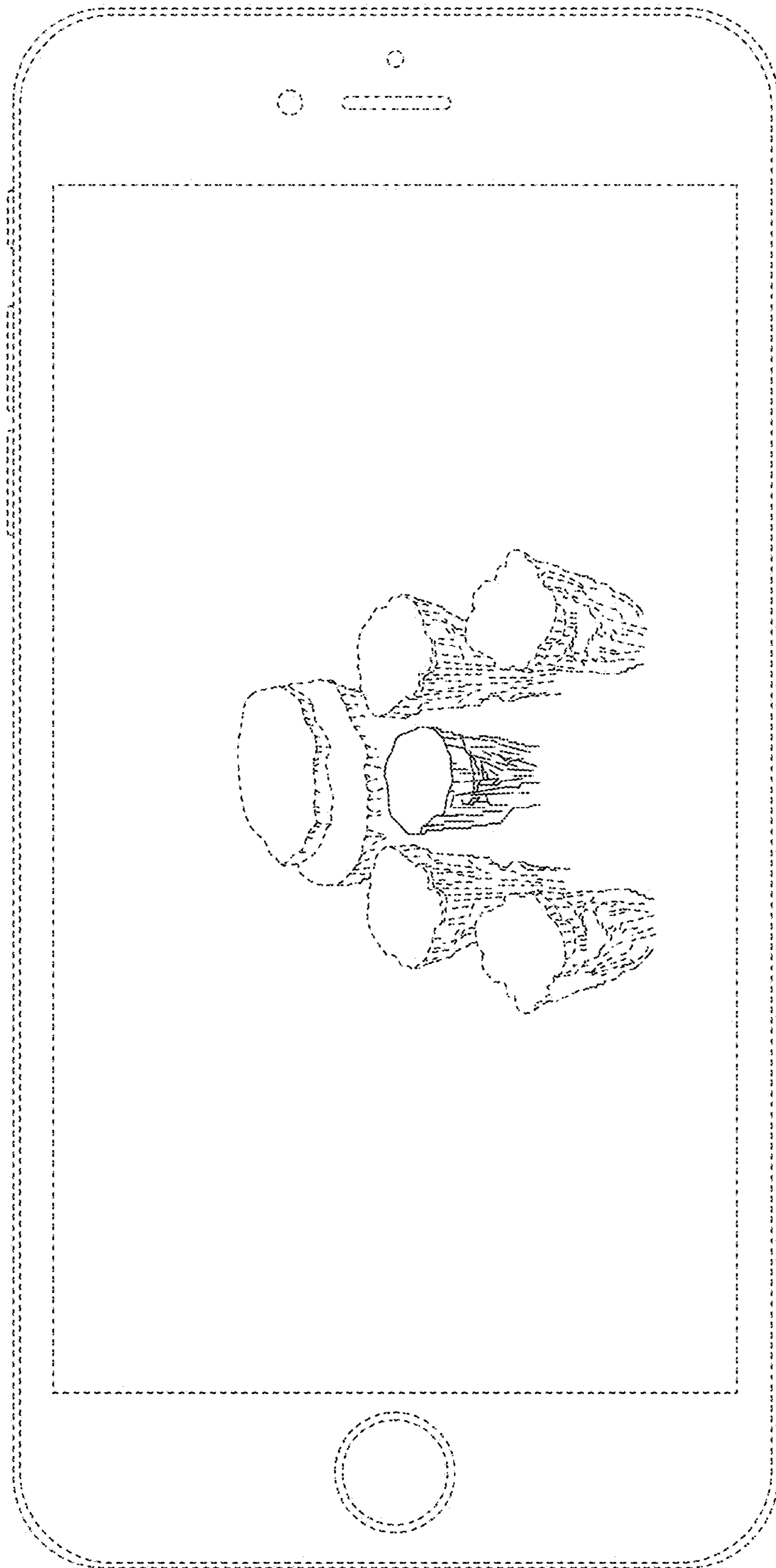

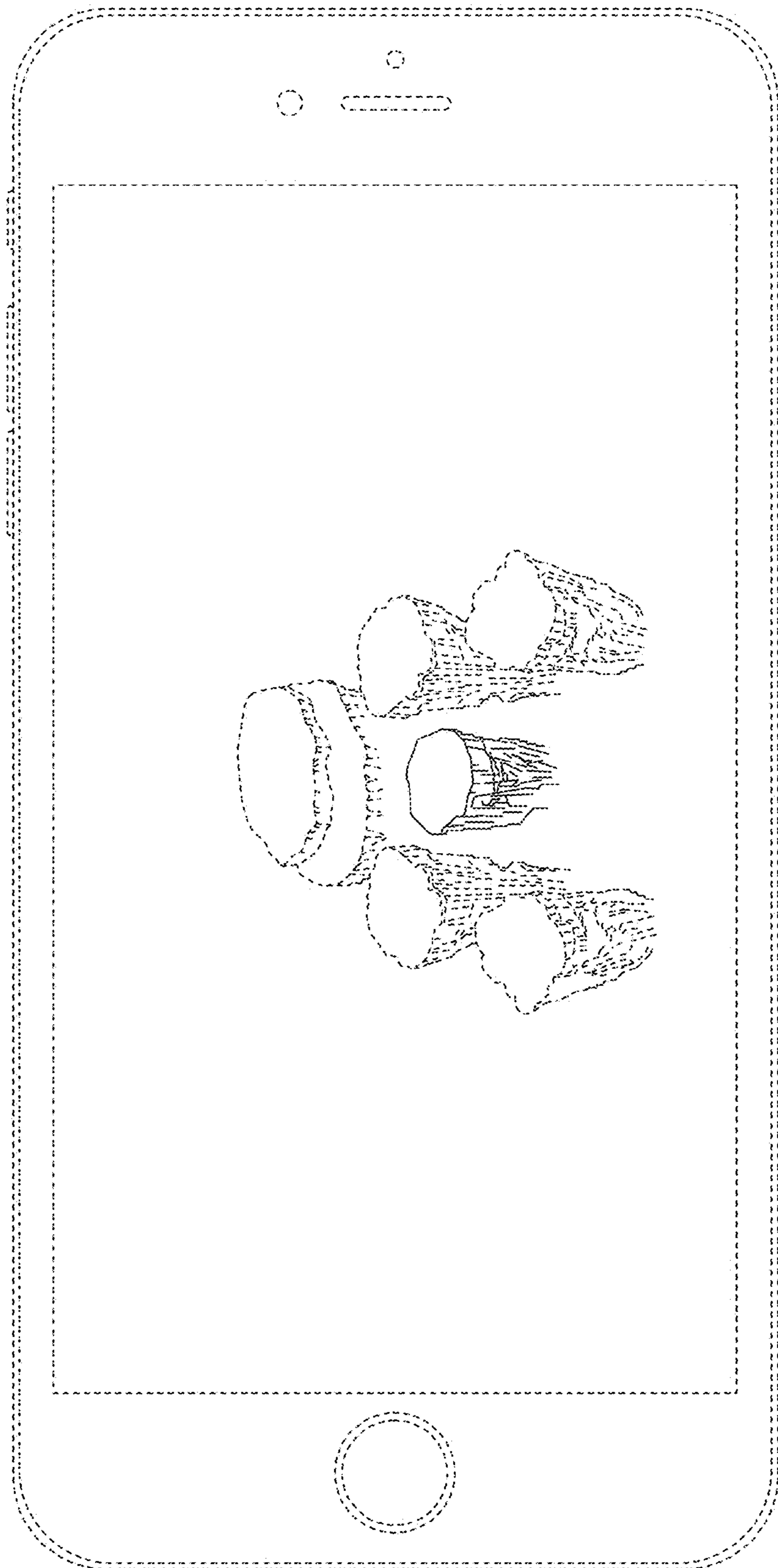

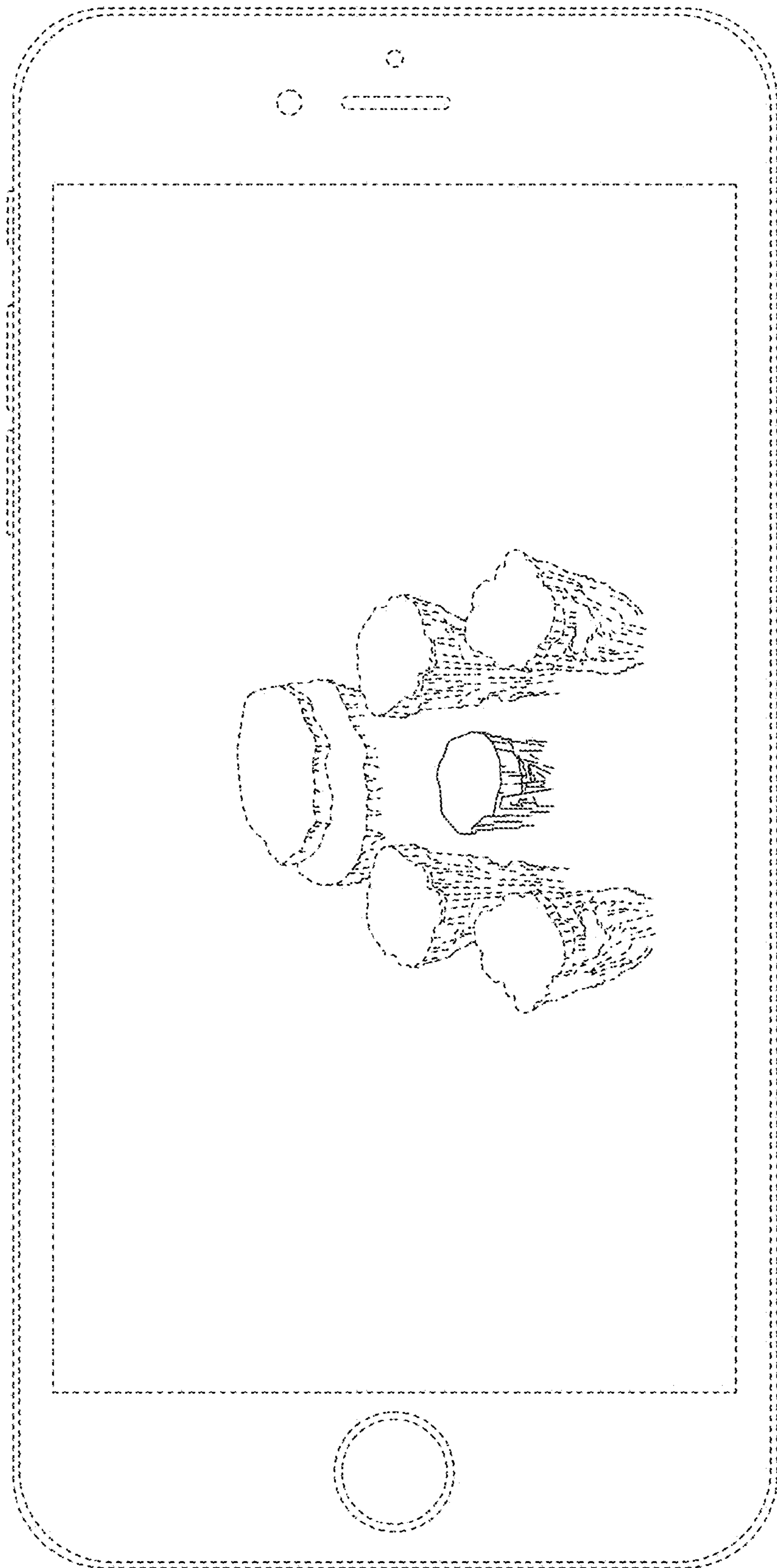

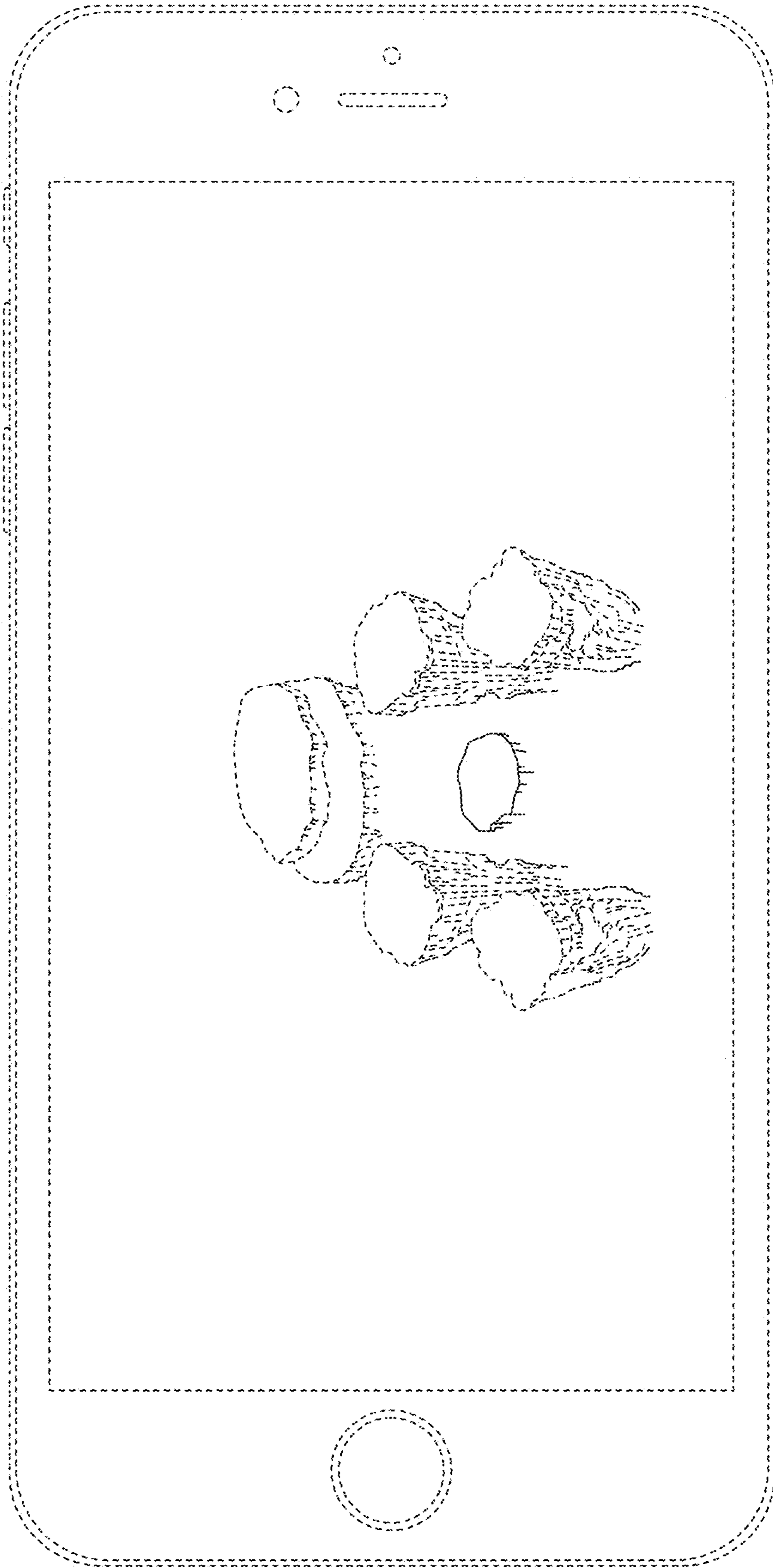

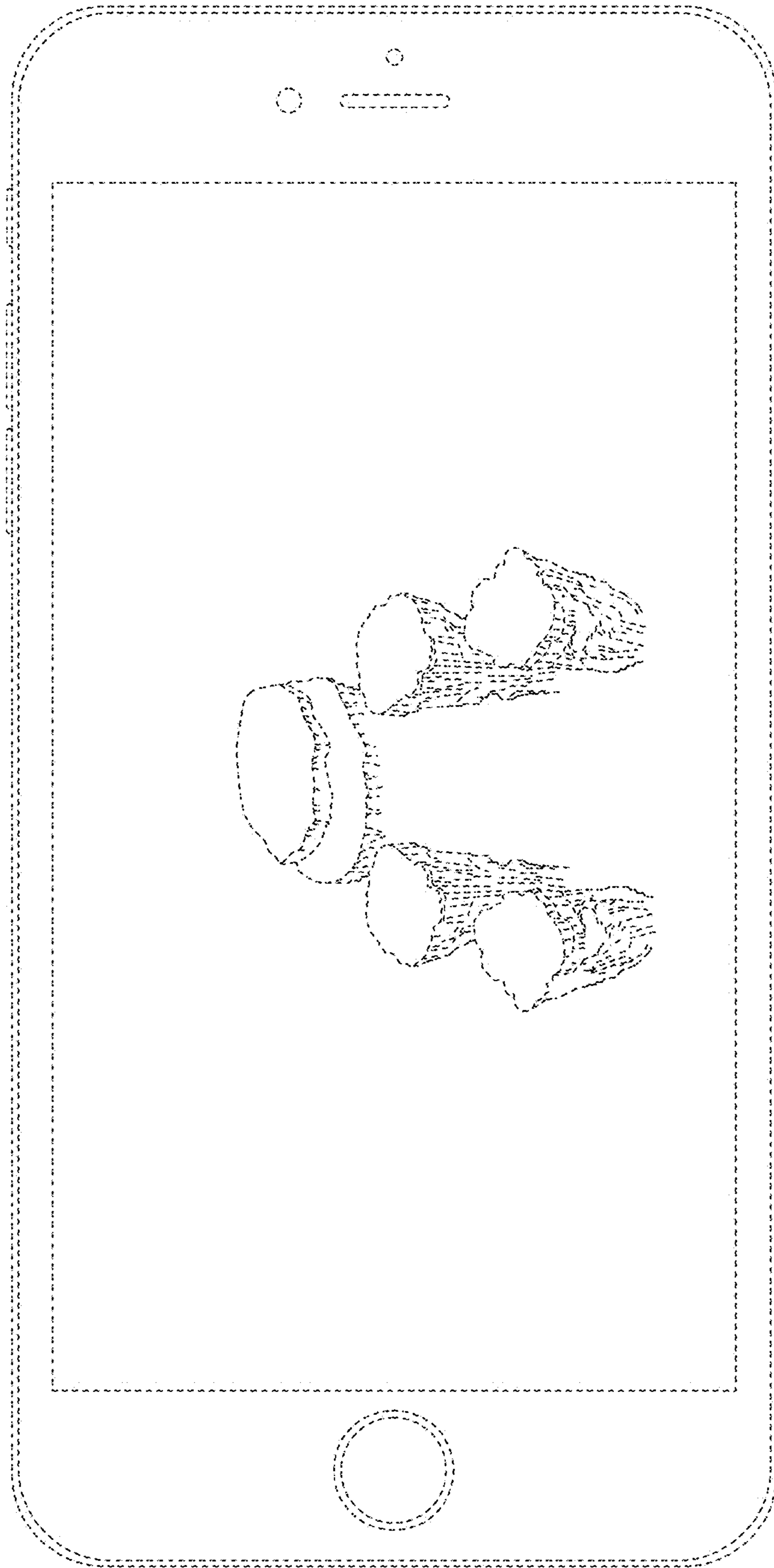
