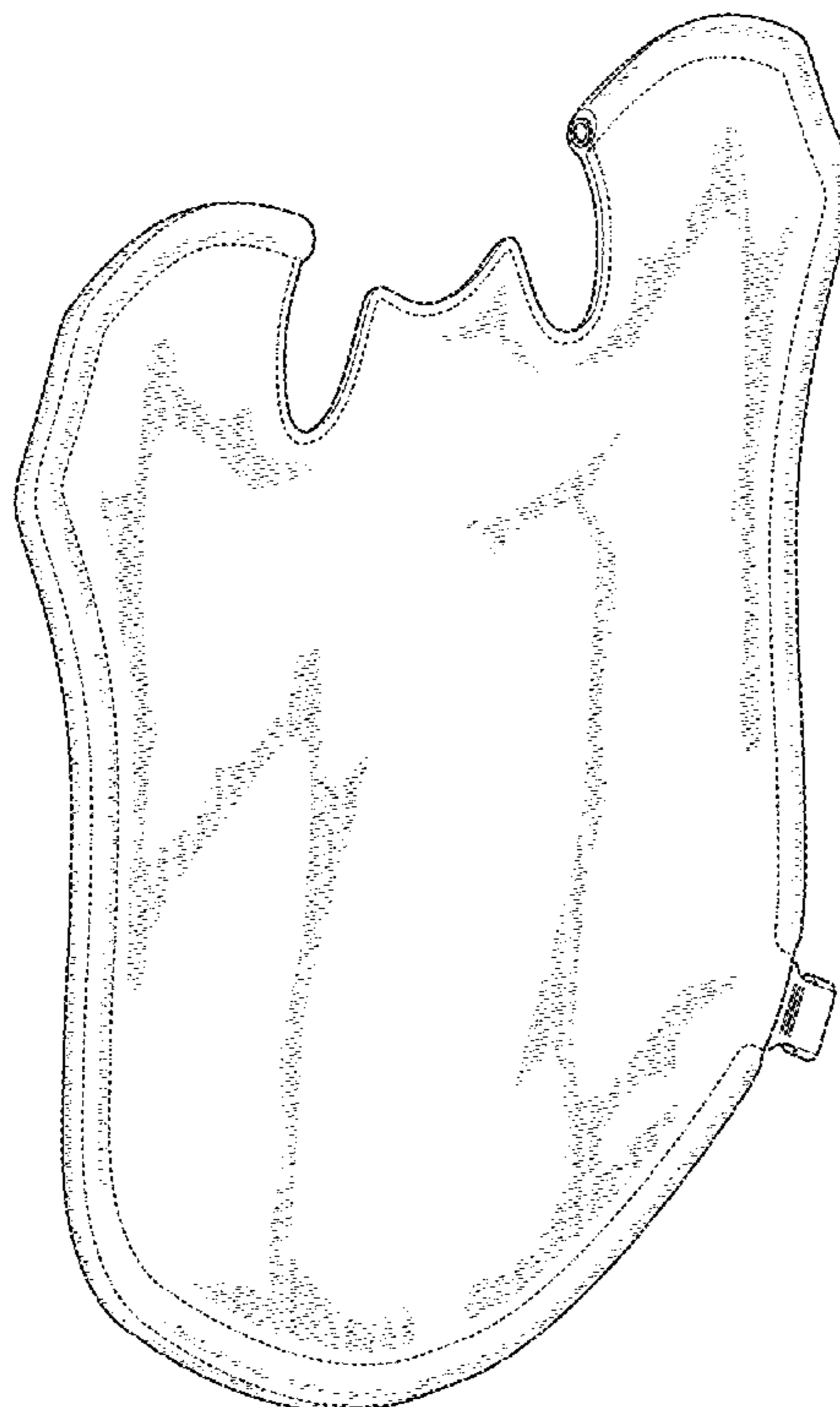
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, top left perspective view of a heat pad
showing my new design therefor;
FIG. 2 is a front elevational view thereof;

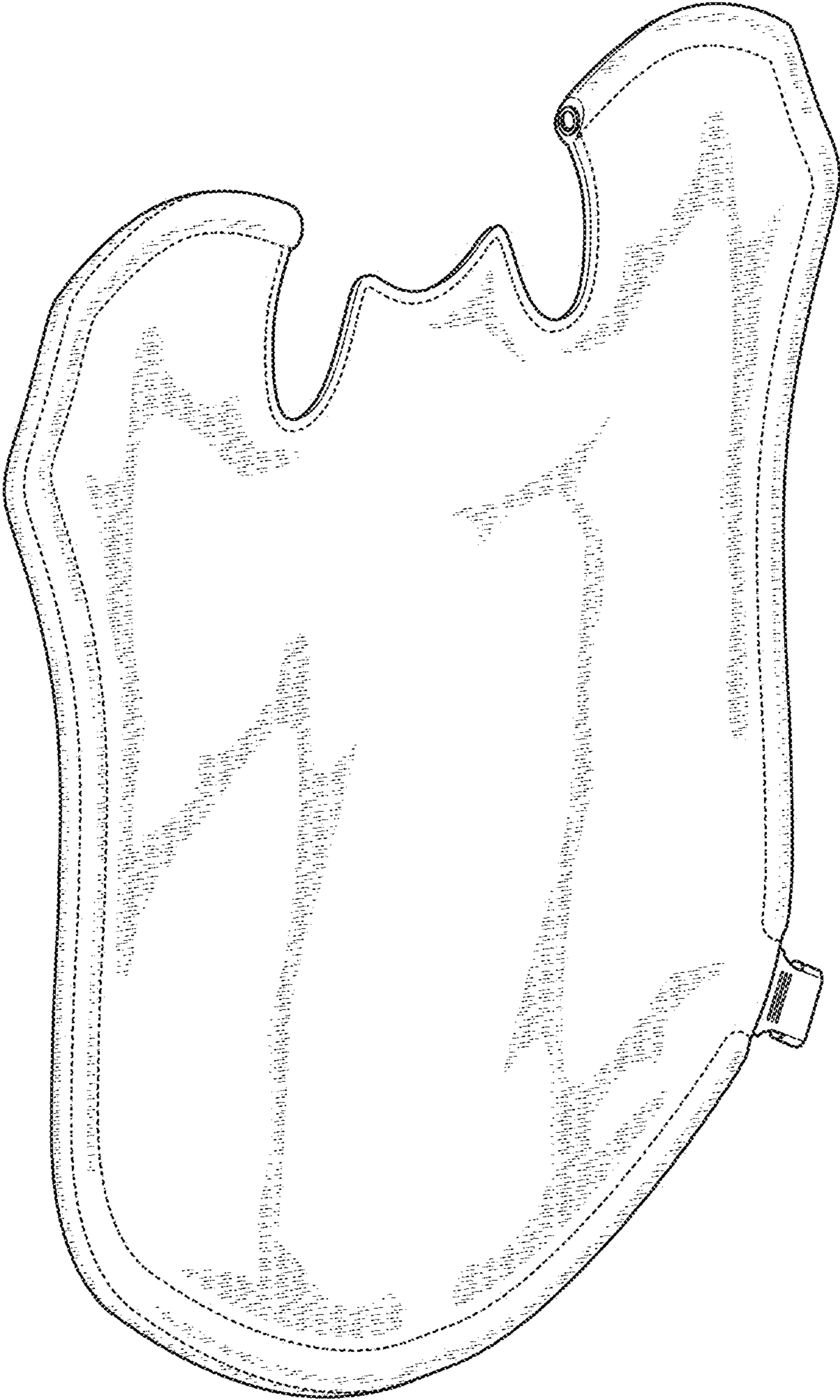

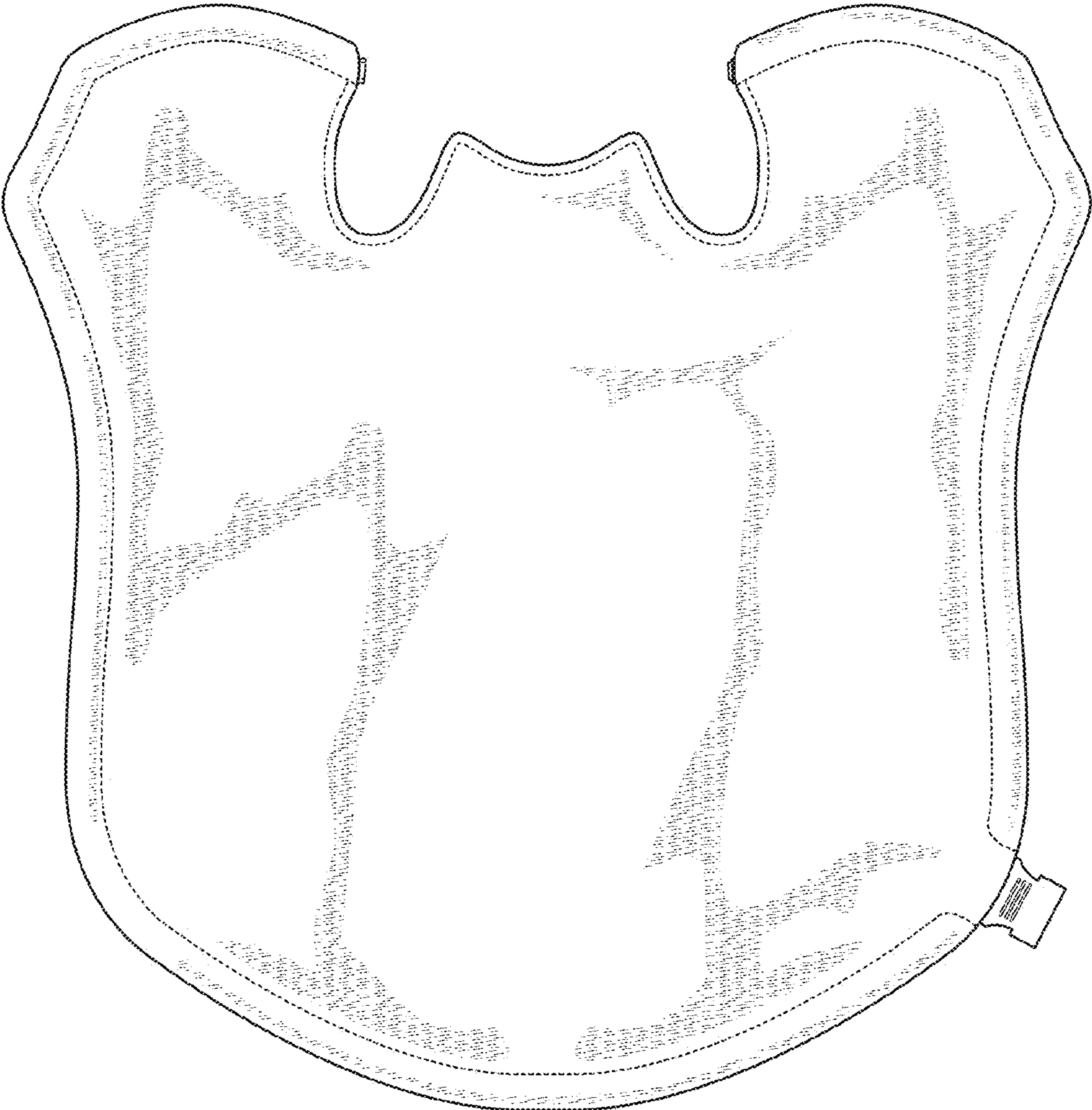

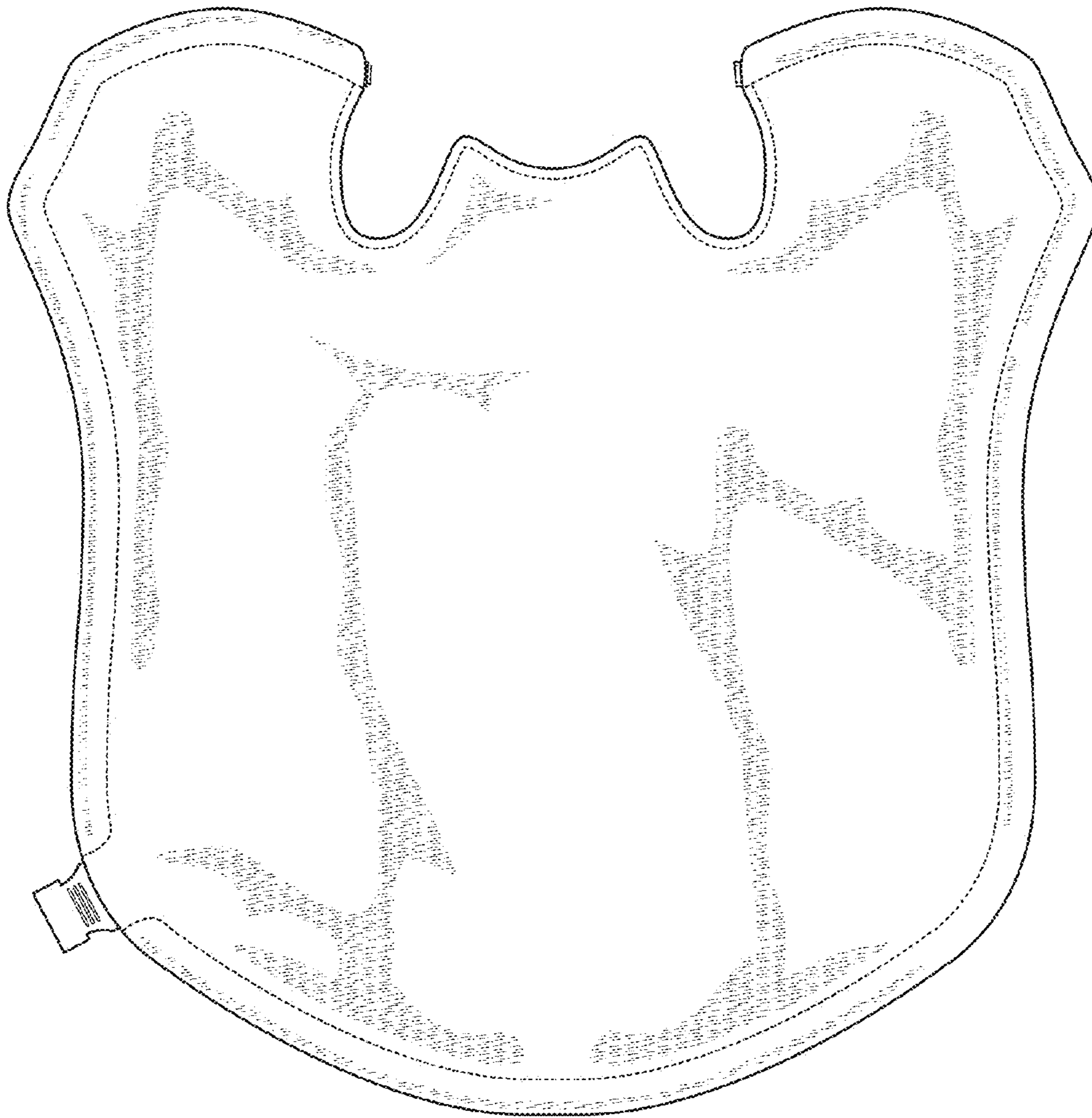

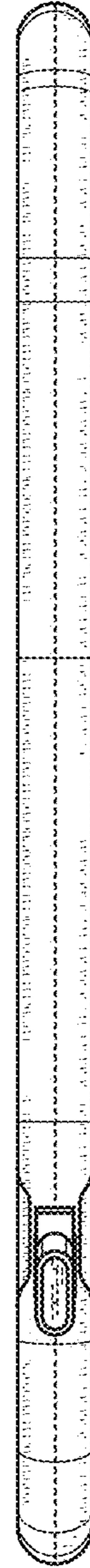

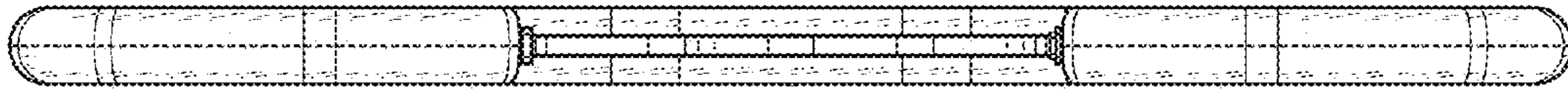
