The ornamental design for a portion of a light bulb, as shown and described.

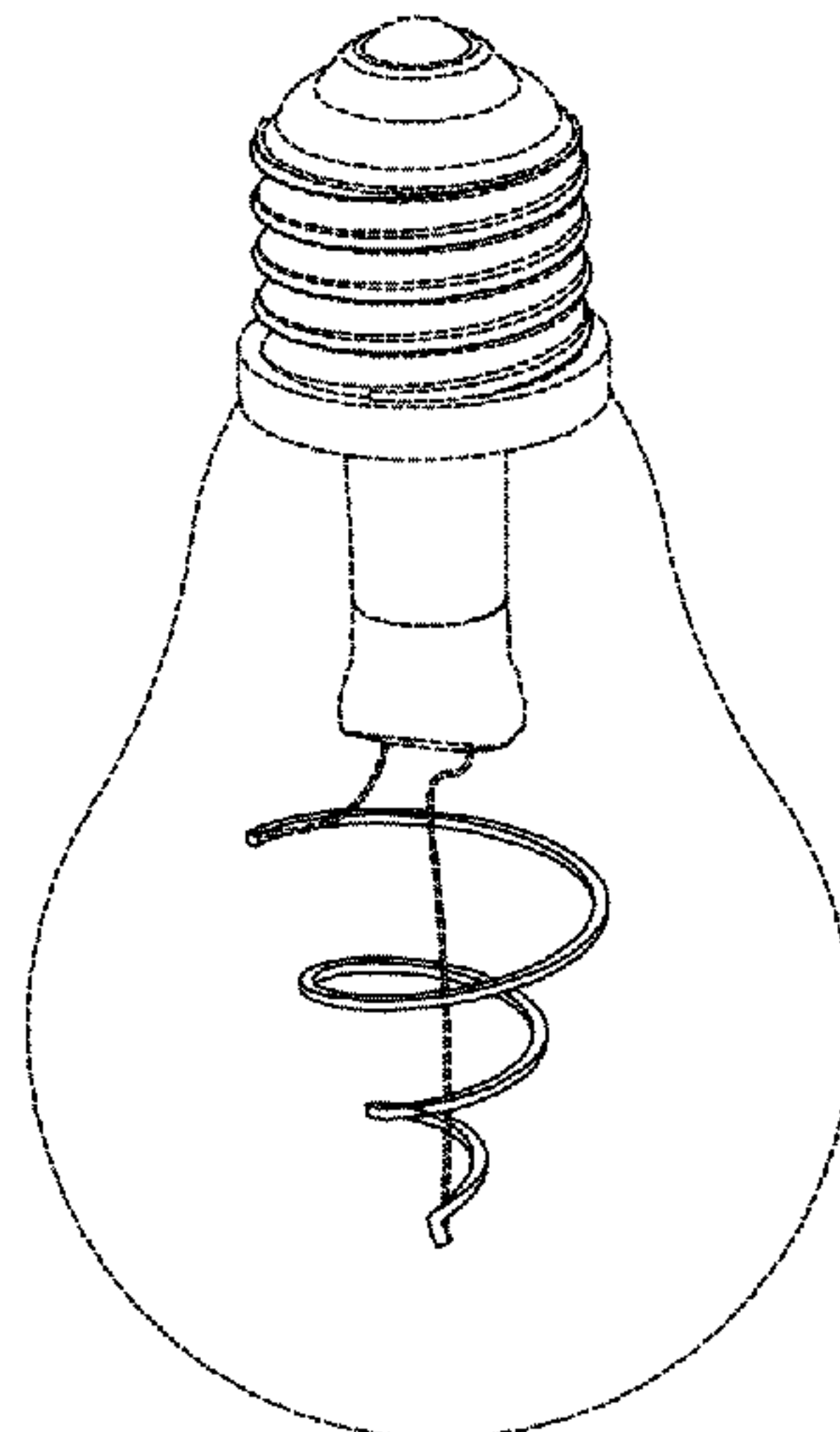
**DESCRIPTION**

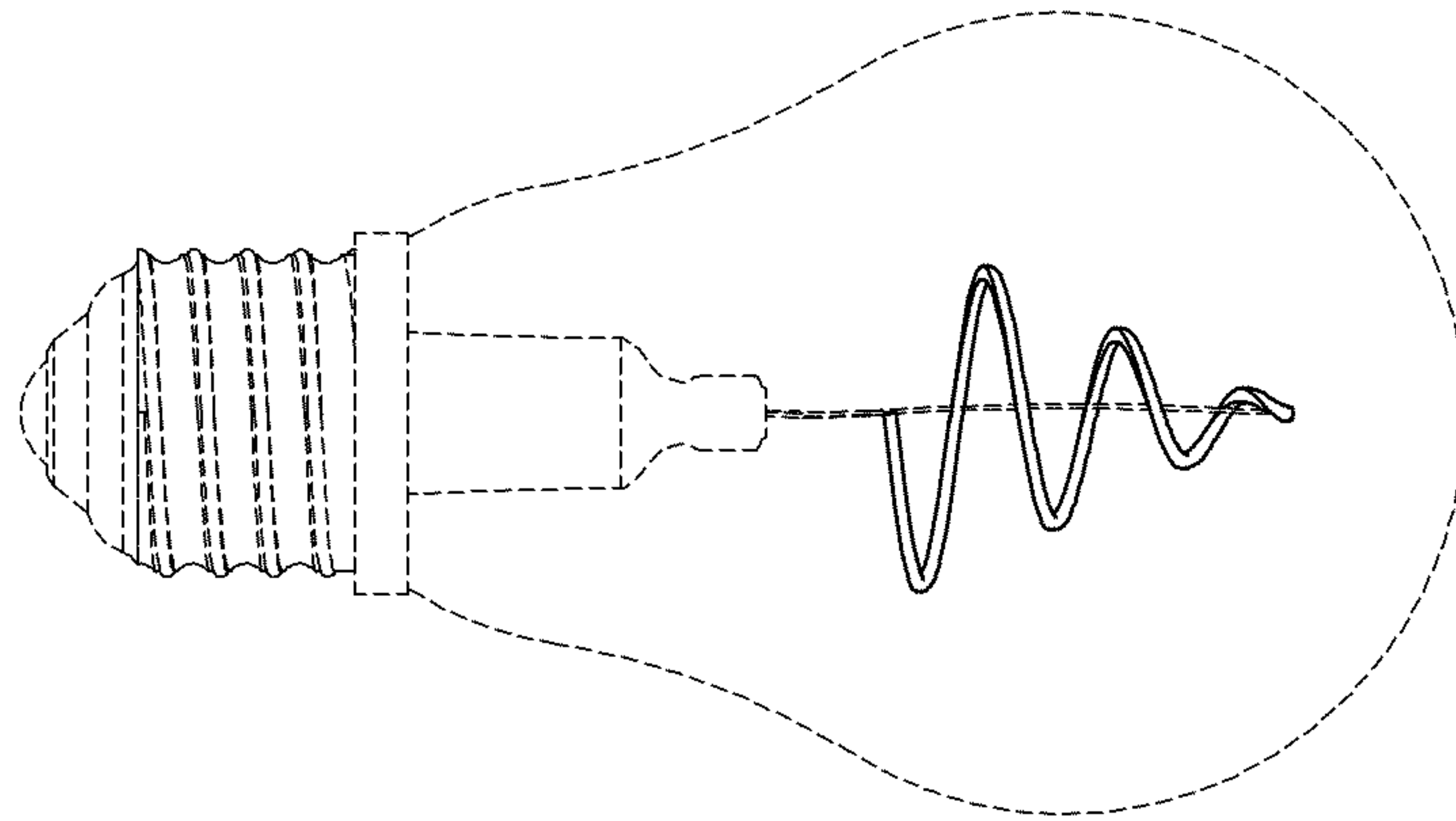

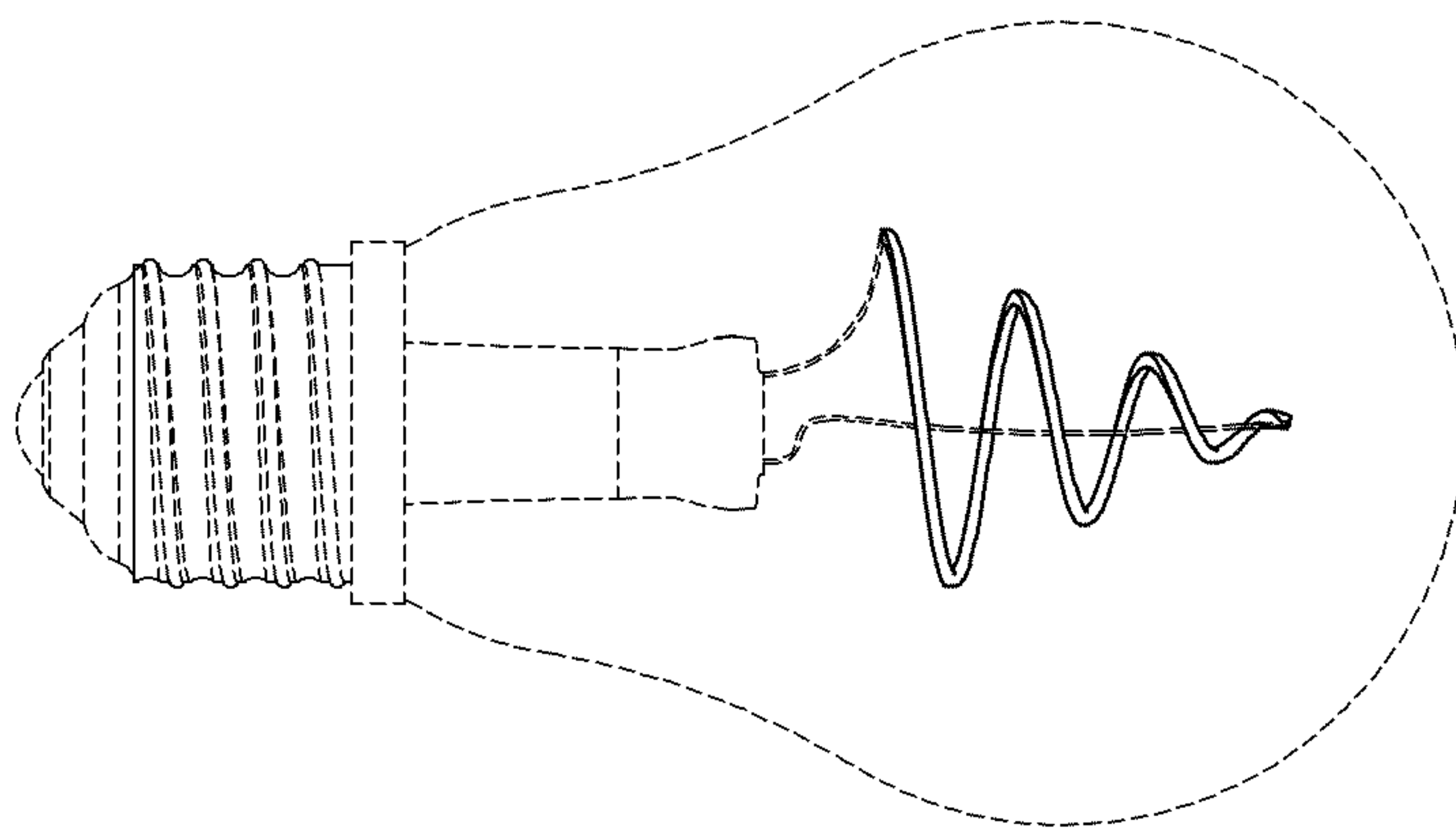

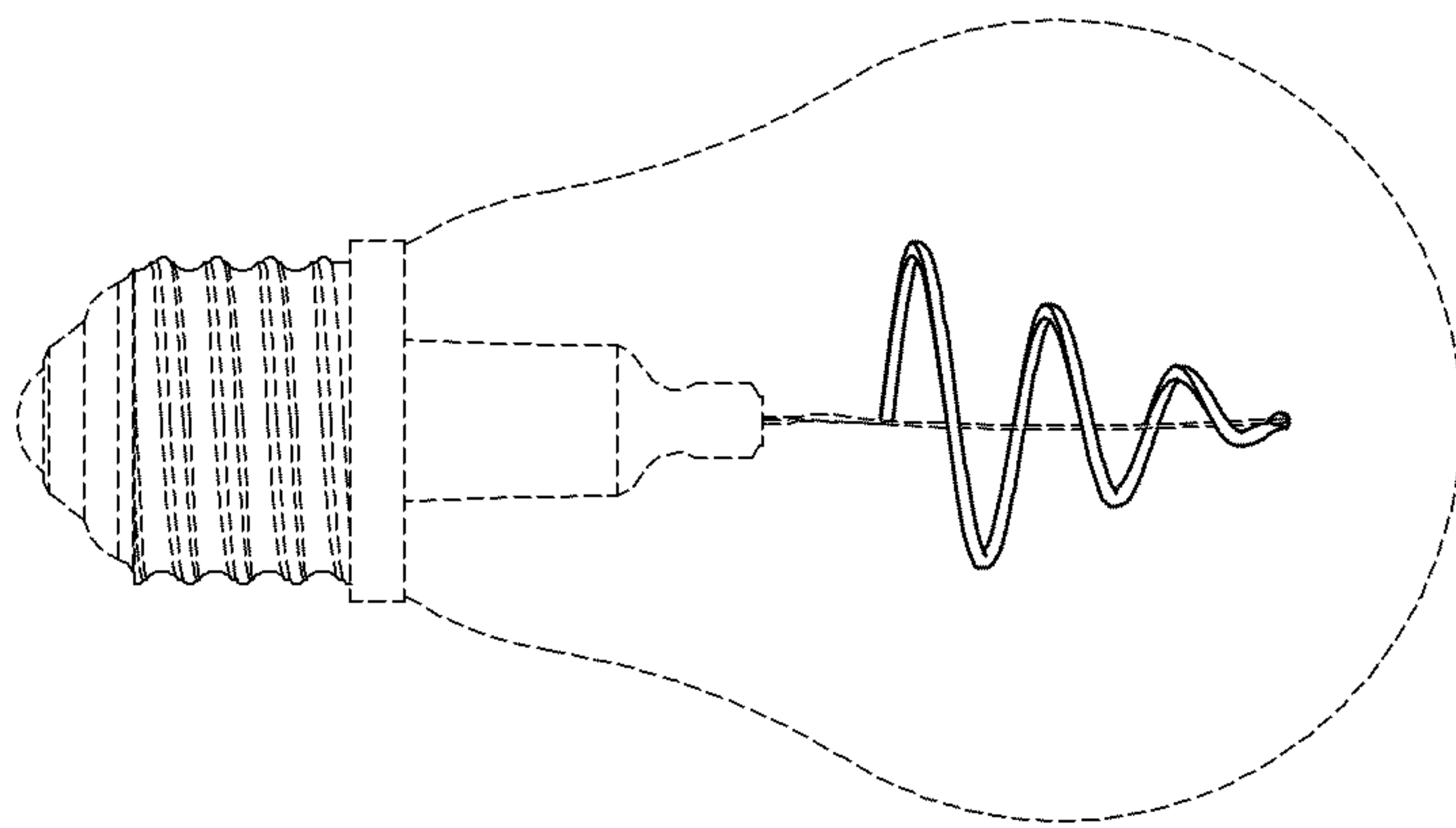

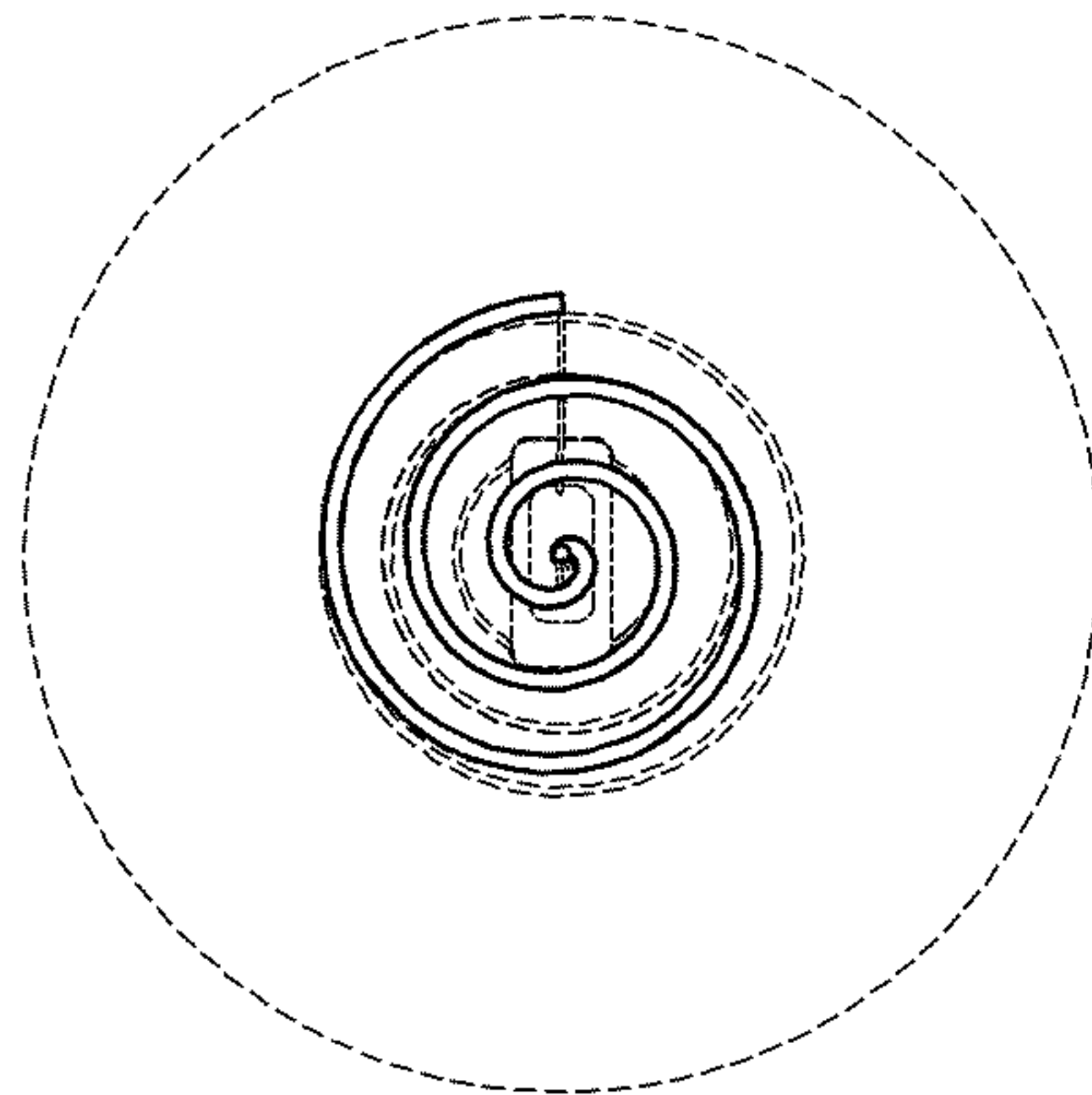

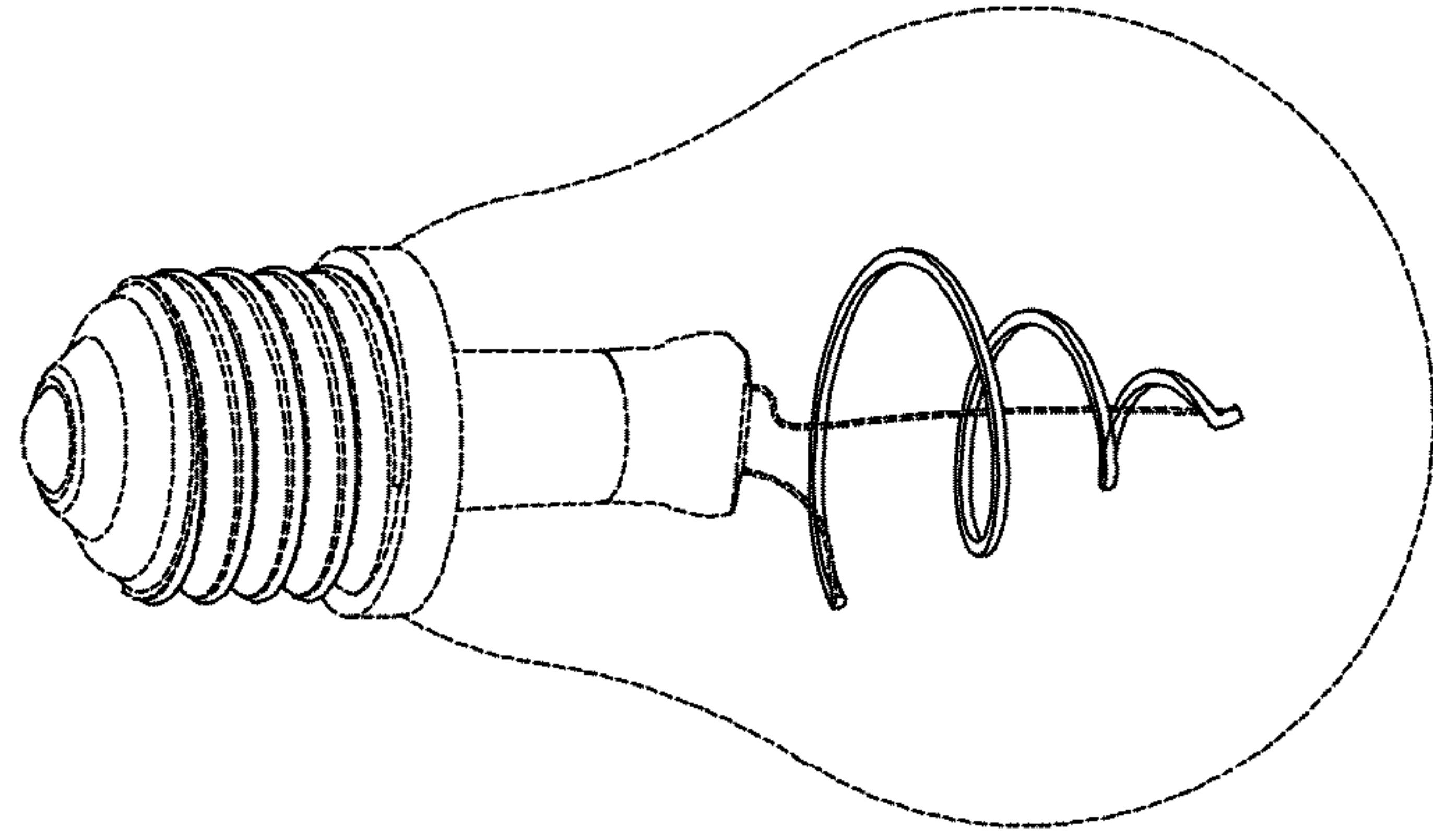

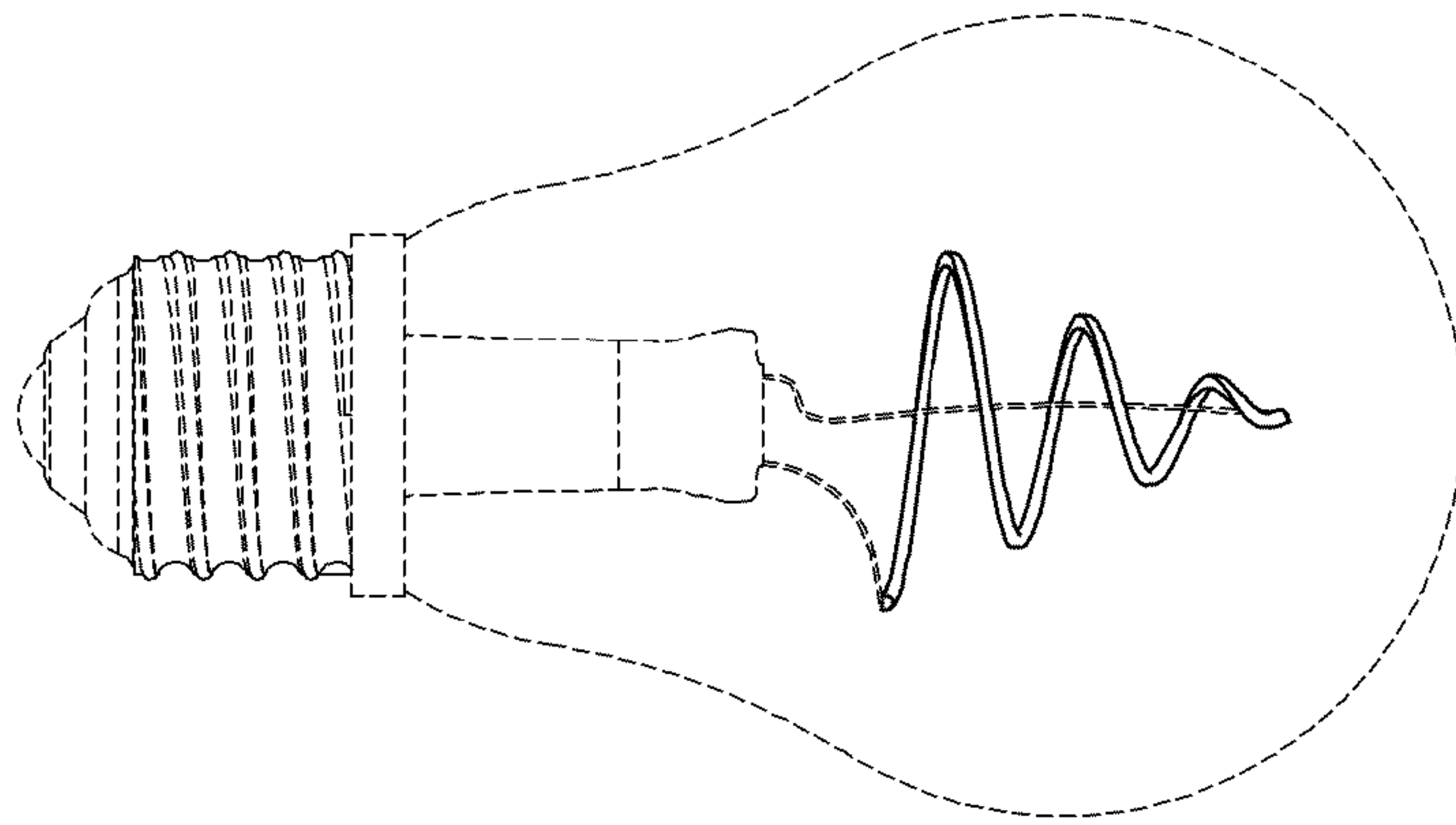

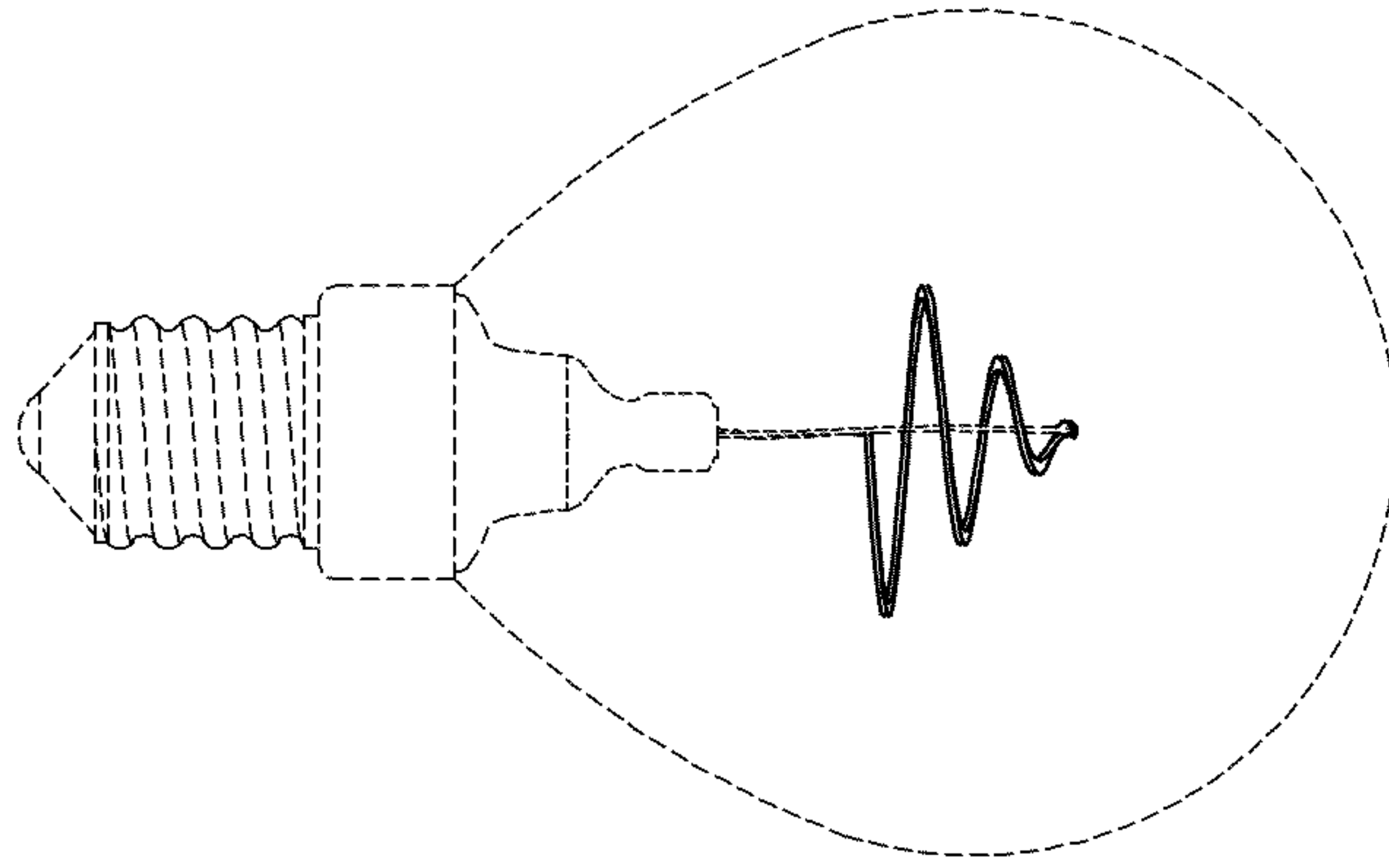

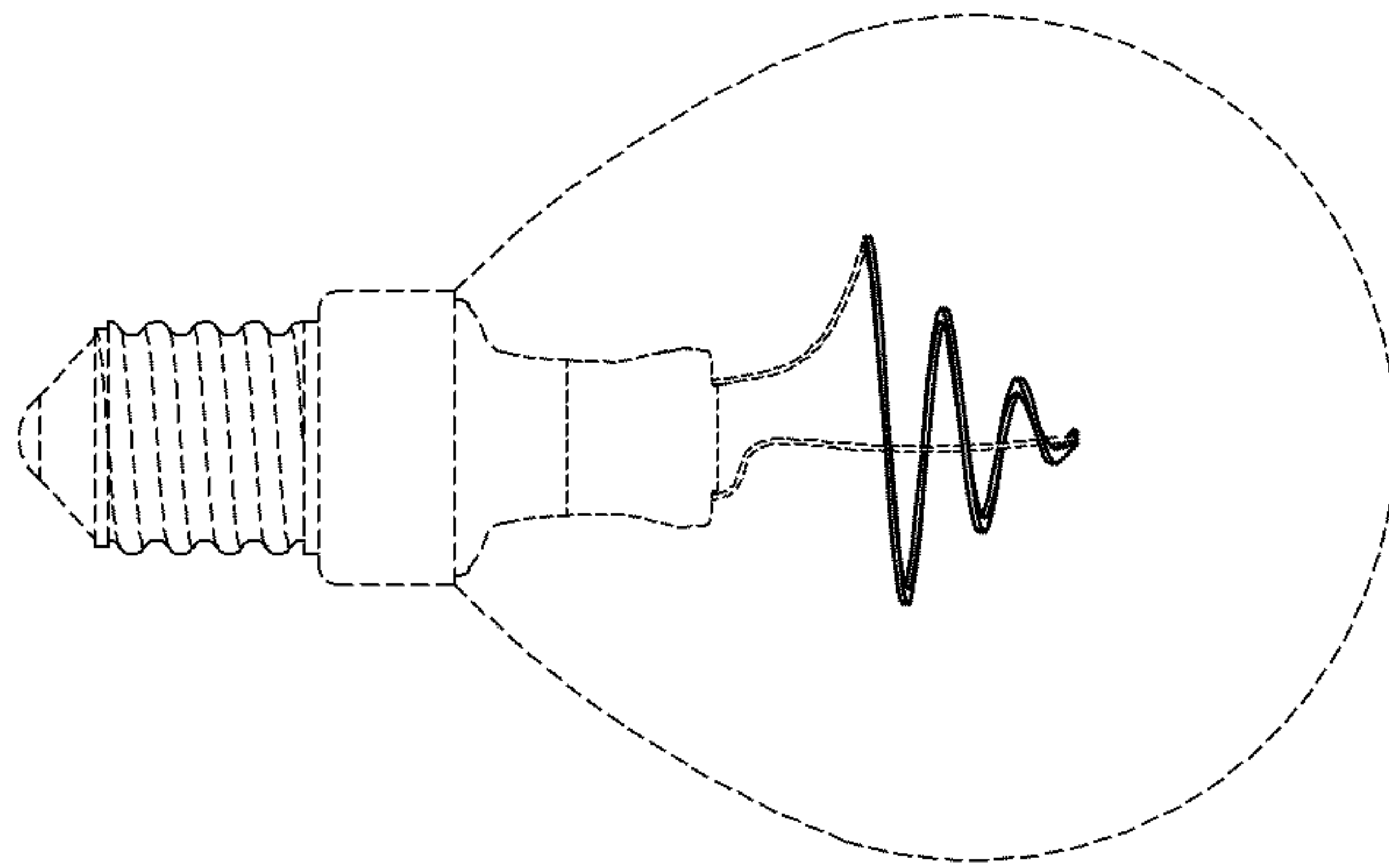

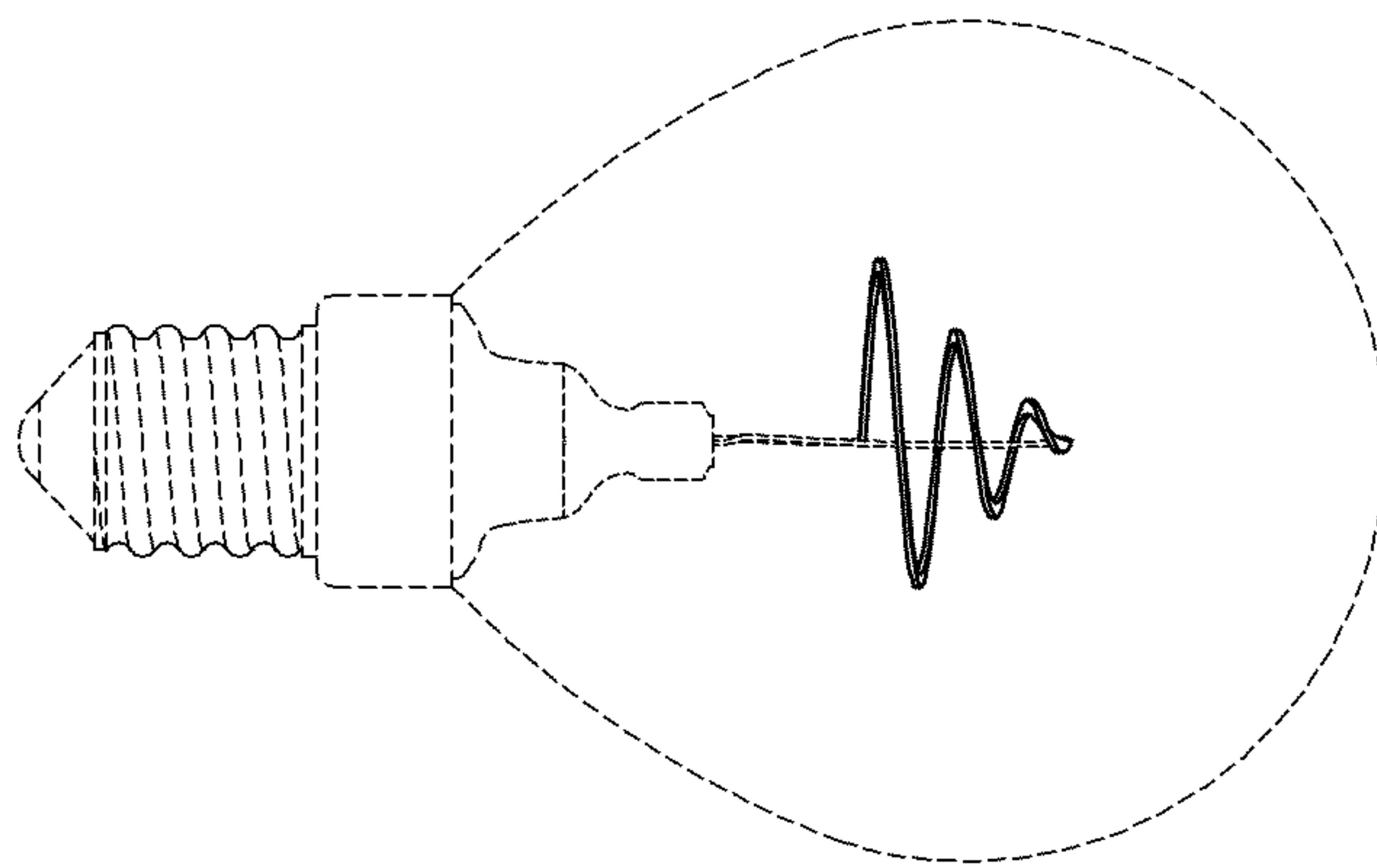

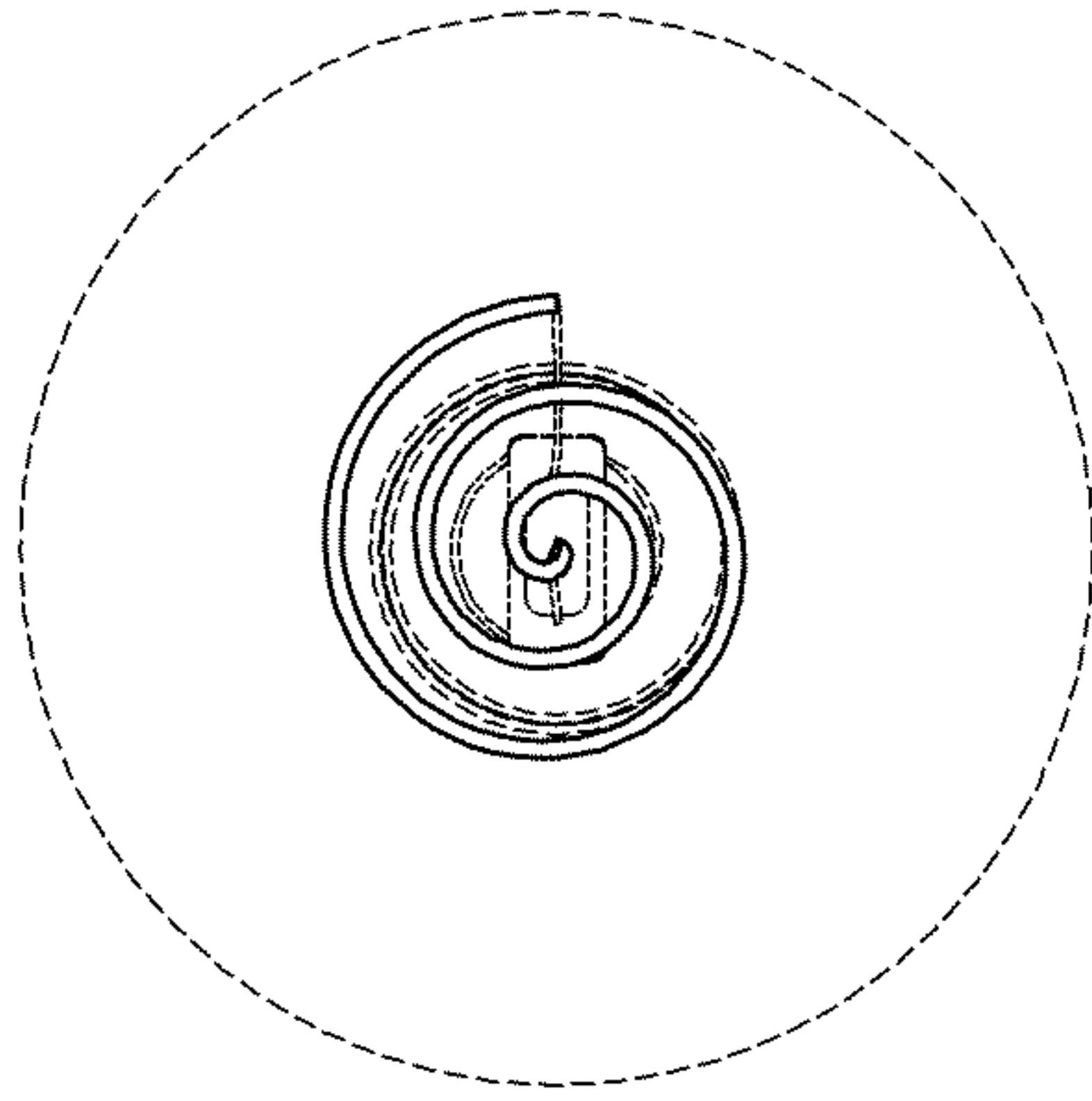

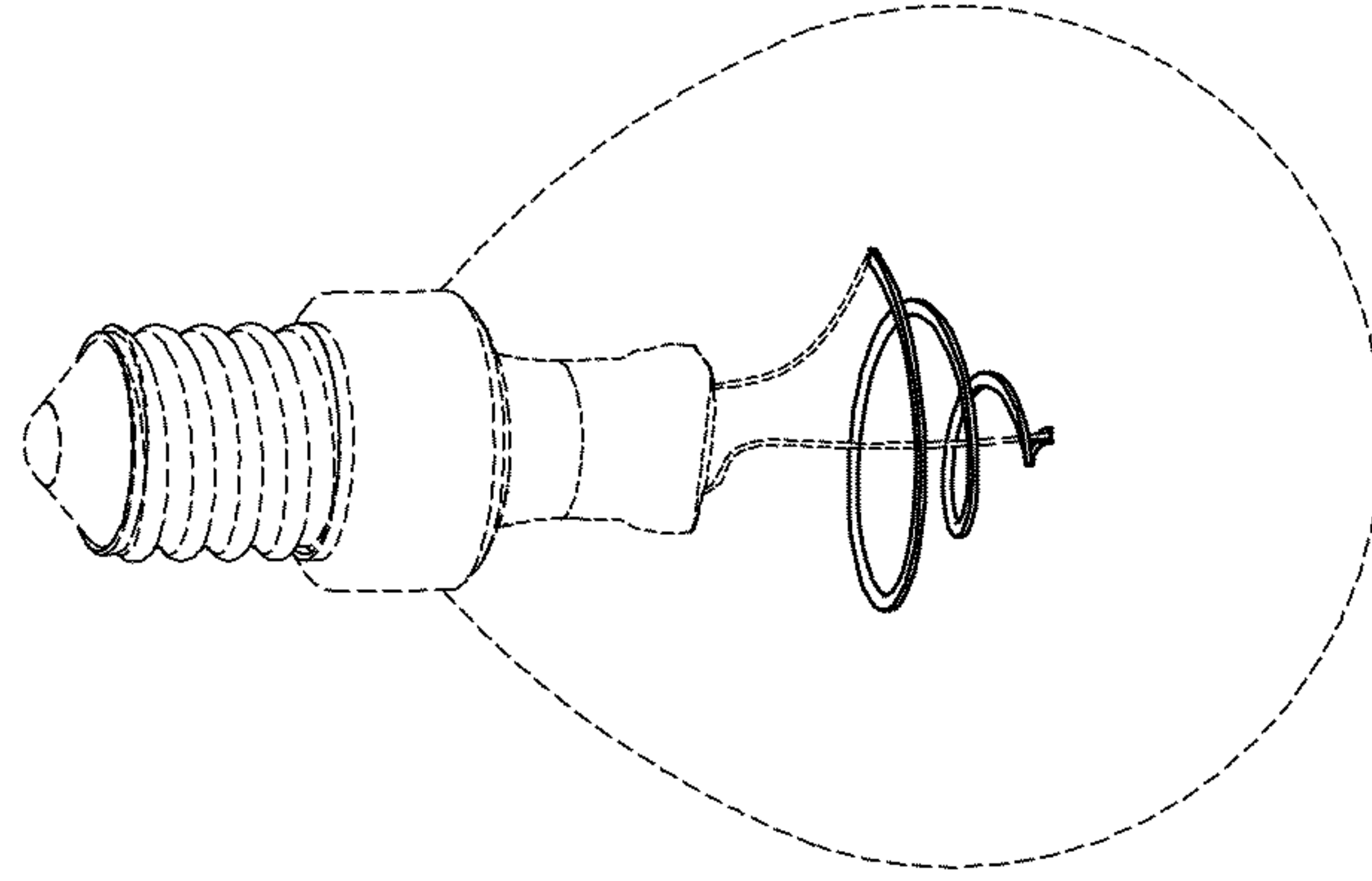

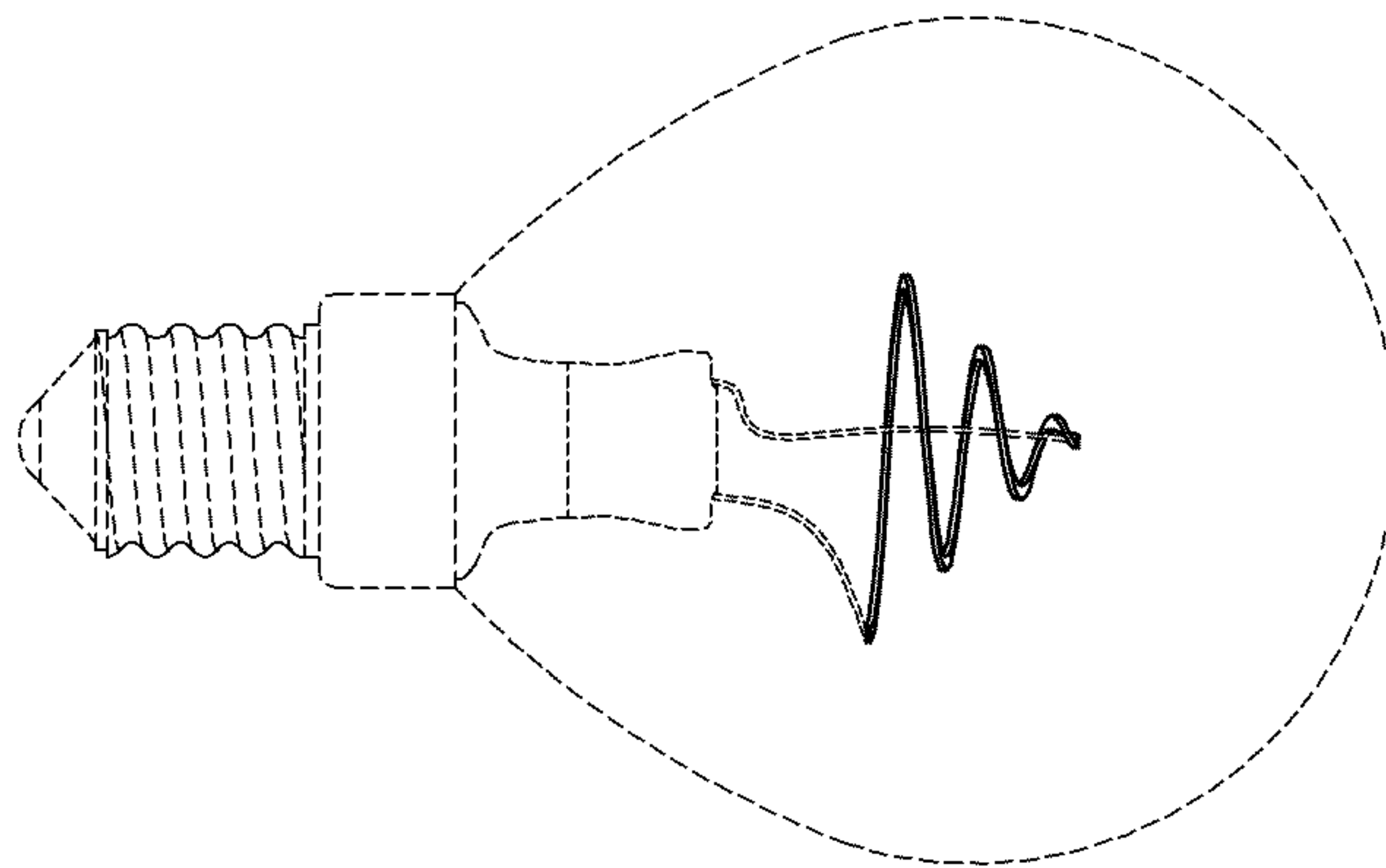

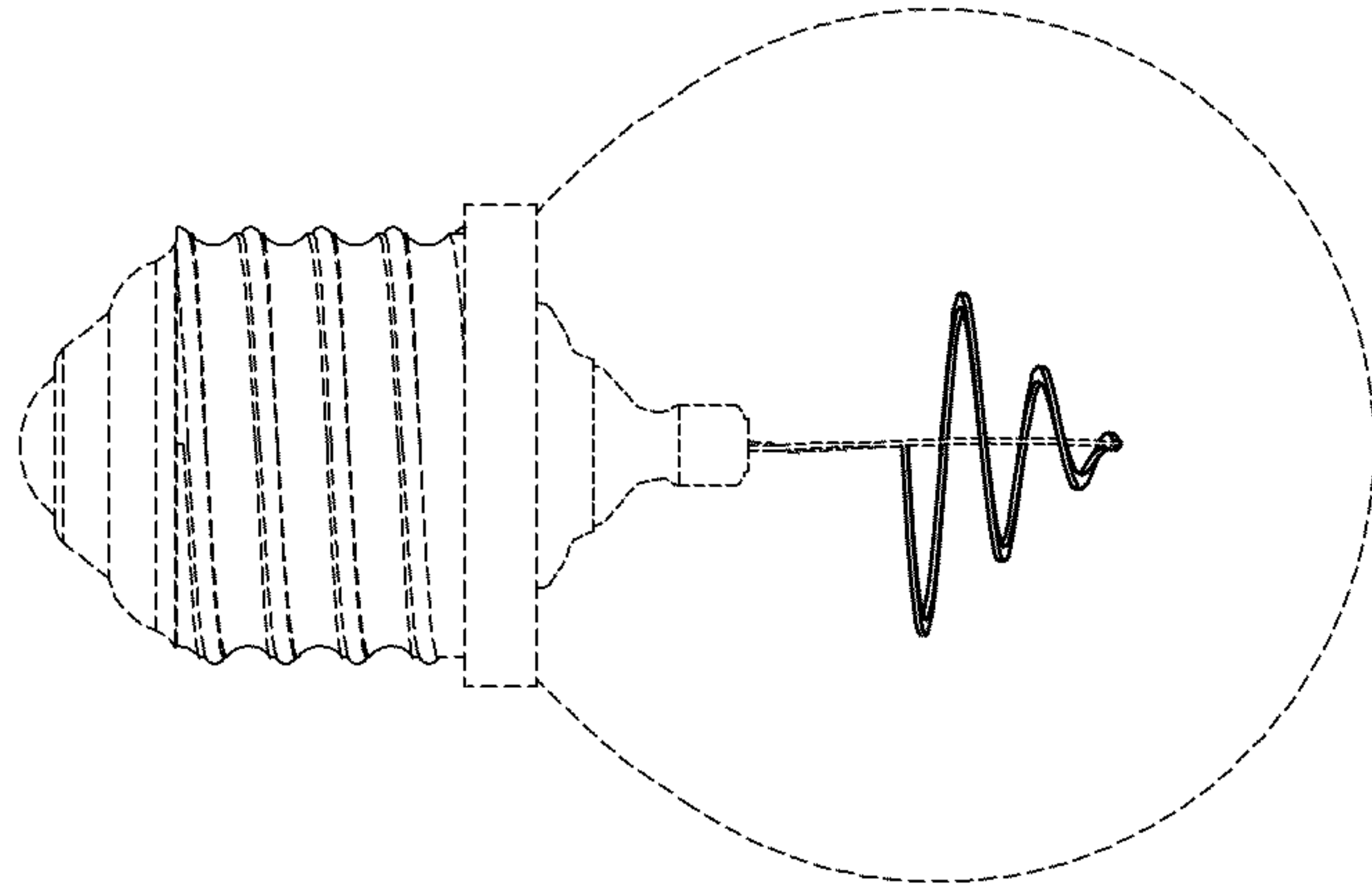

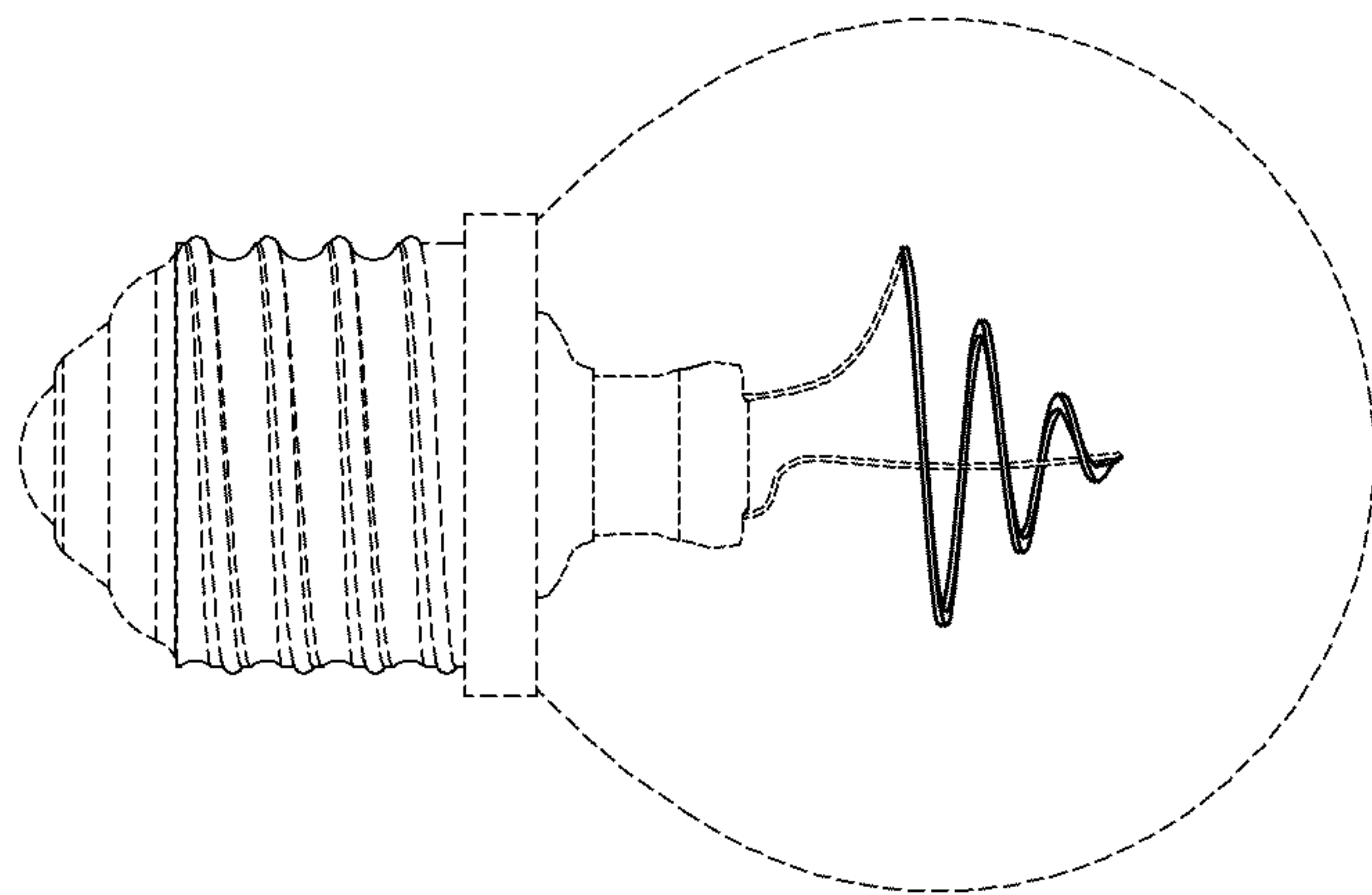

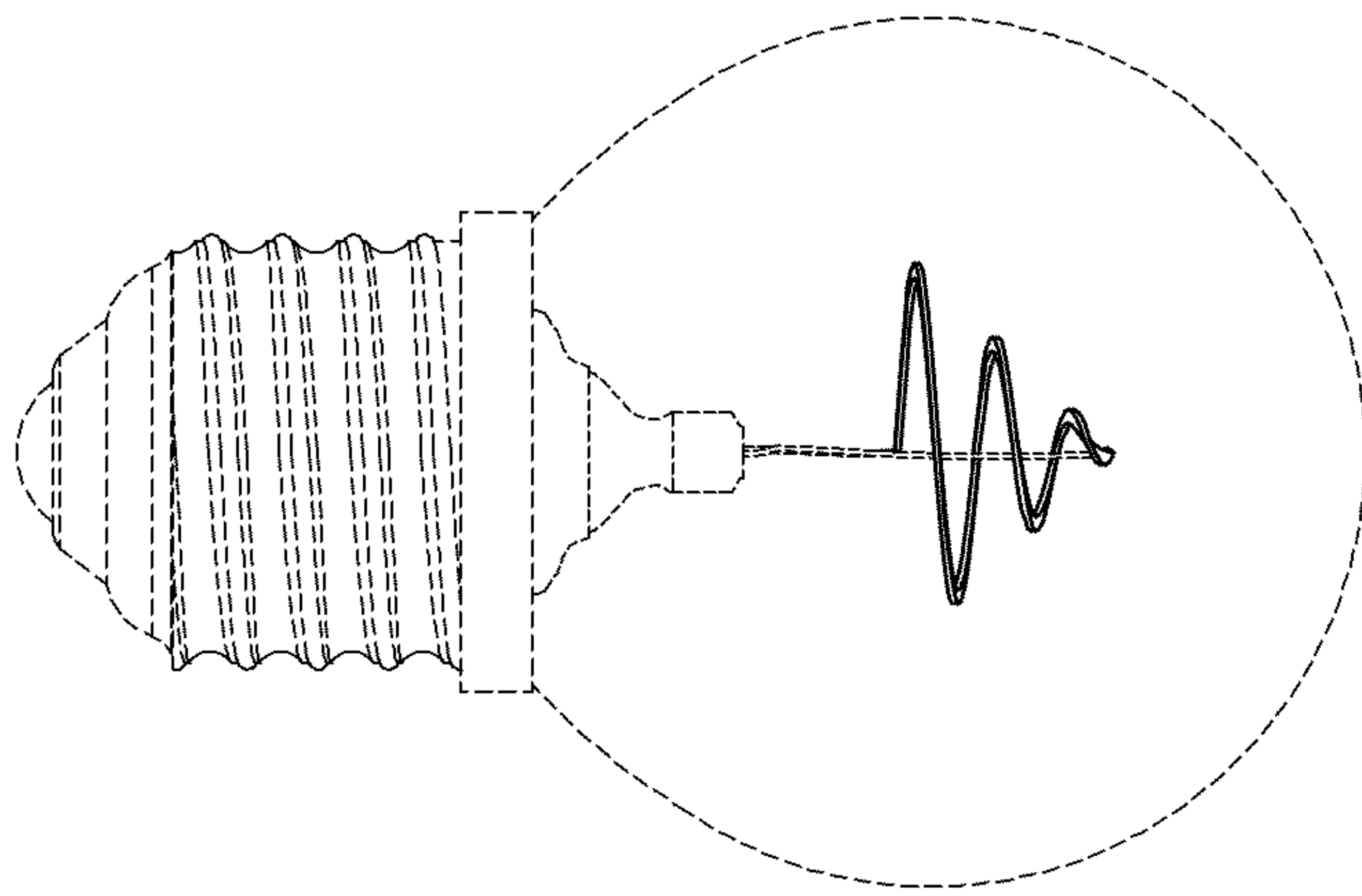

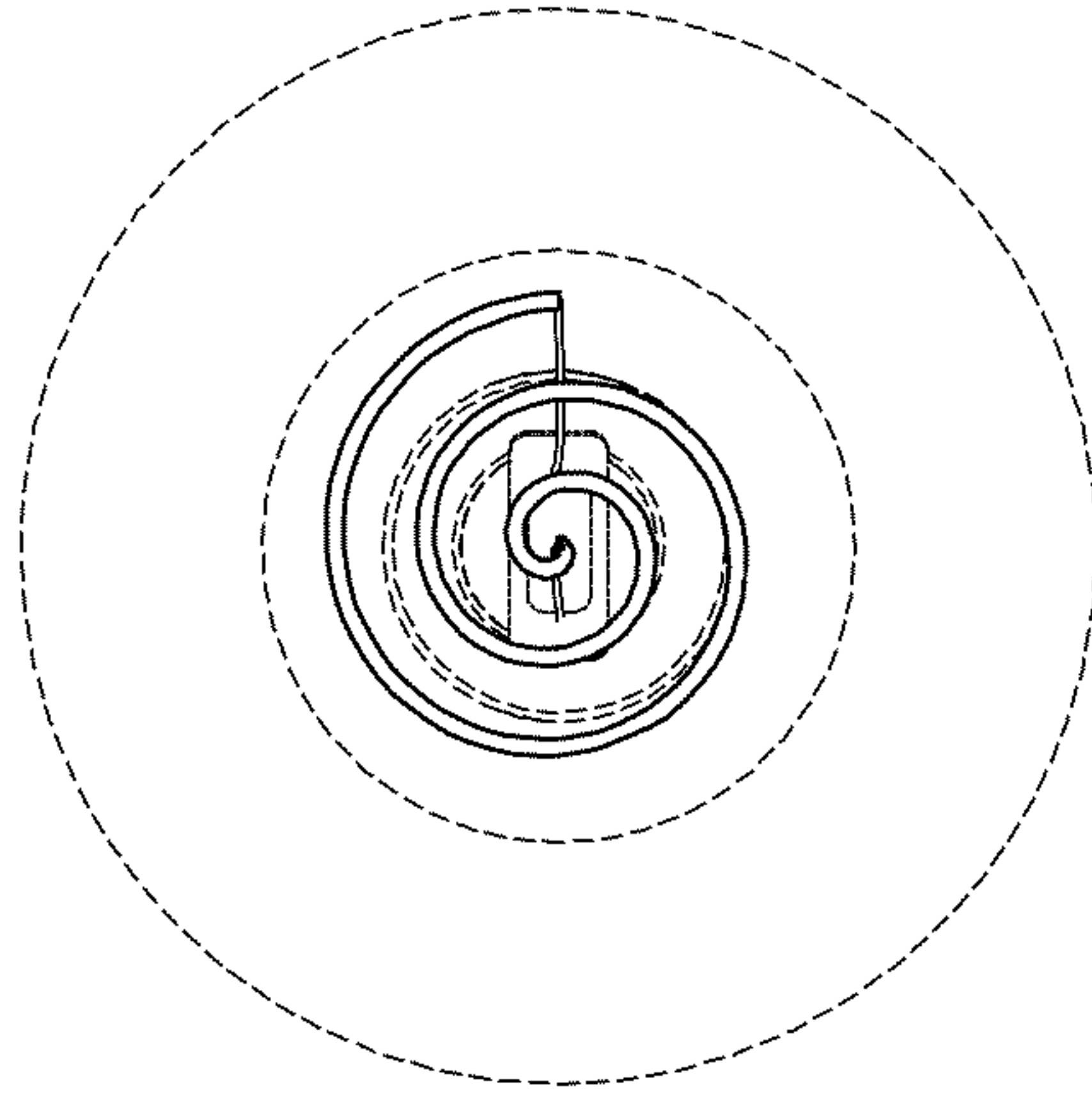

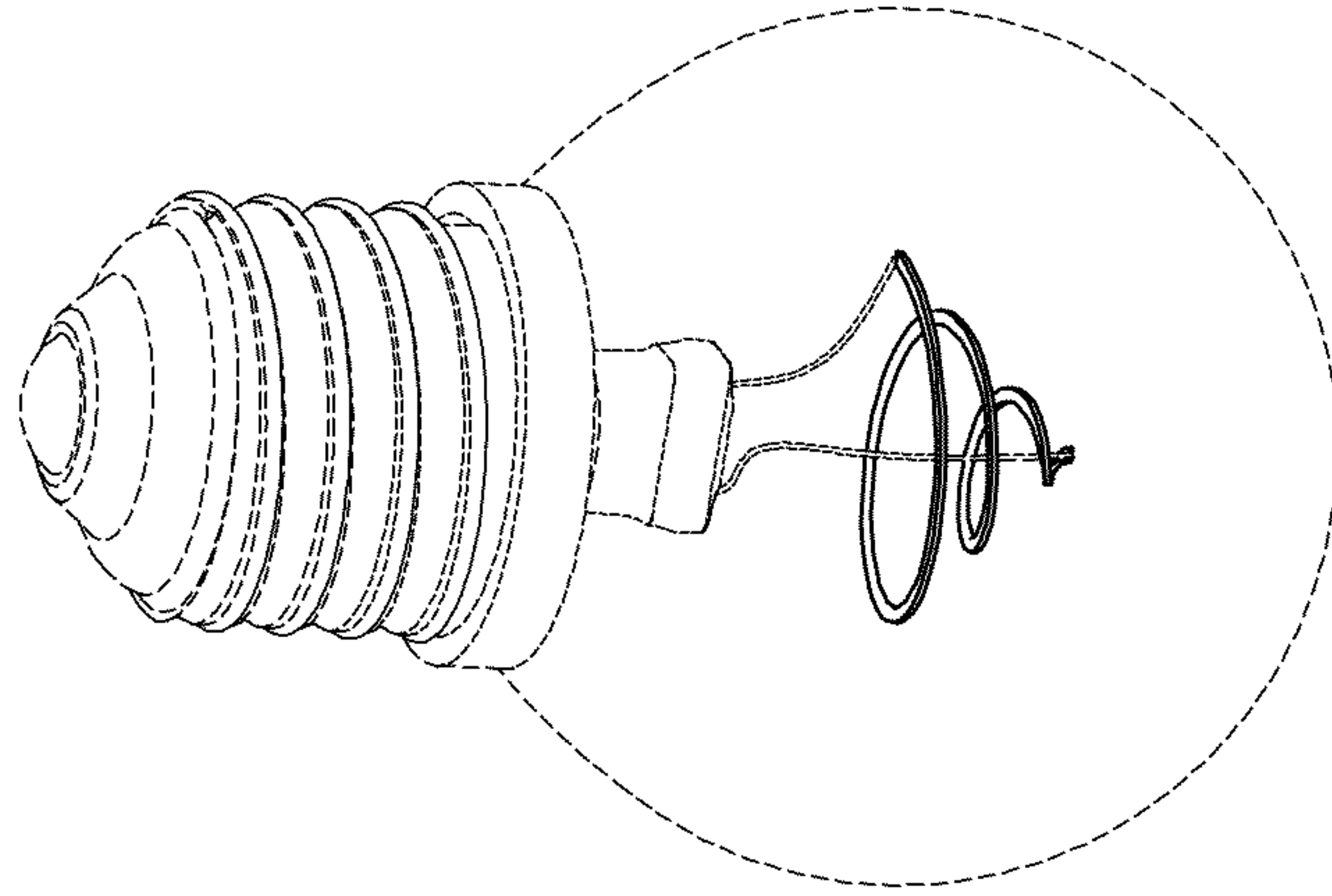

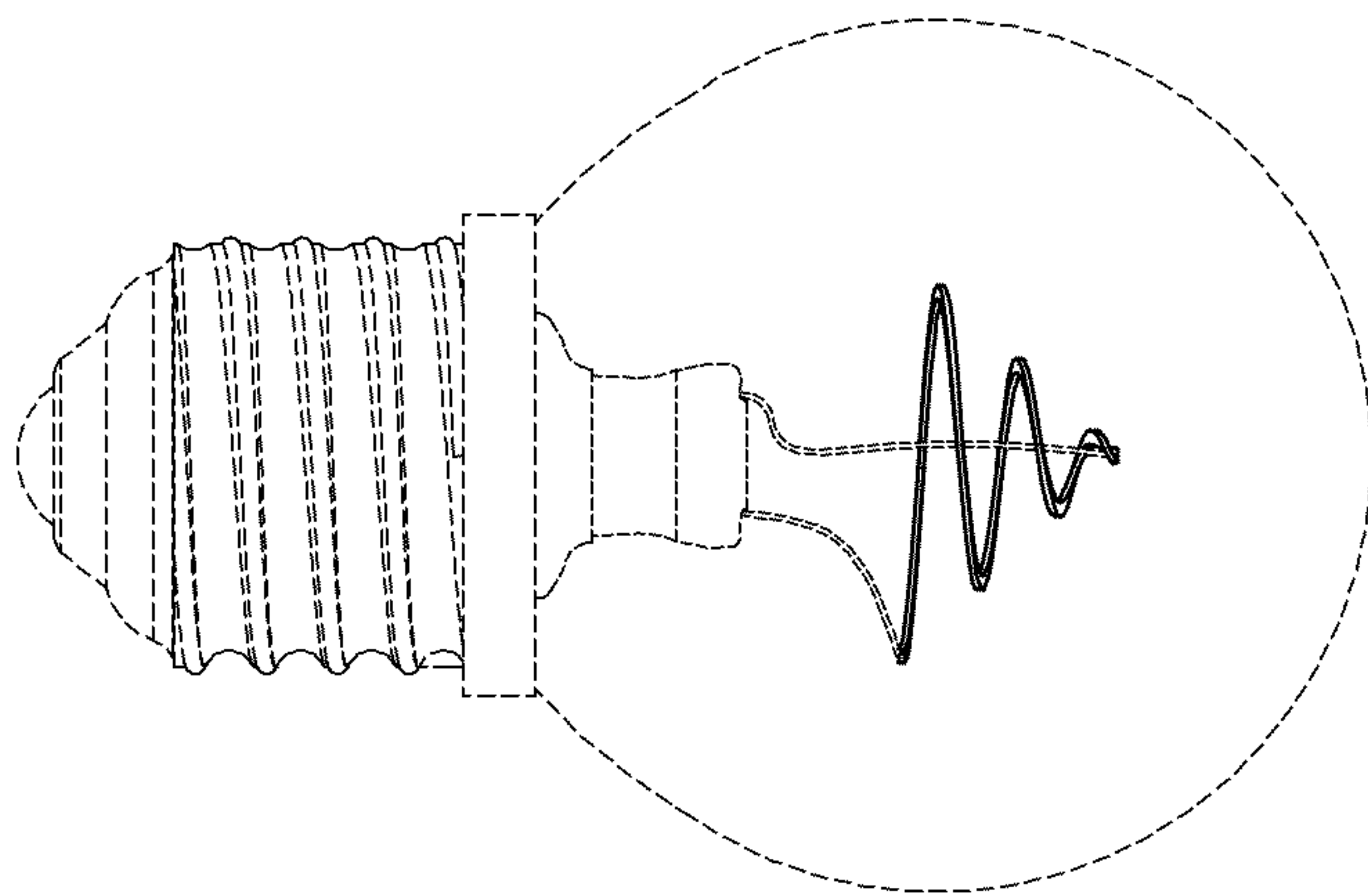
