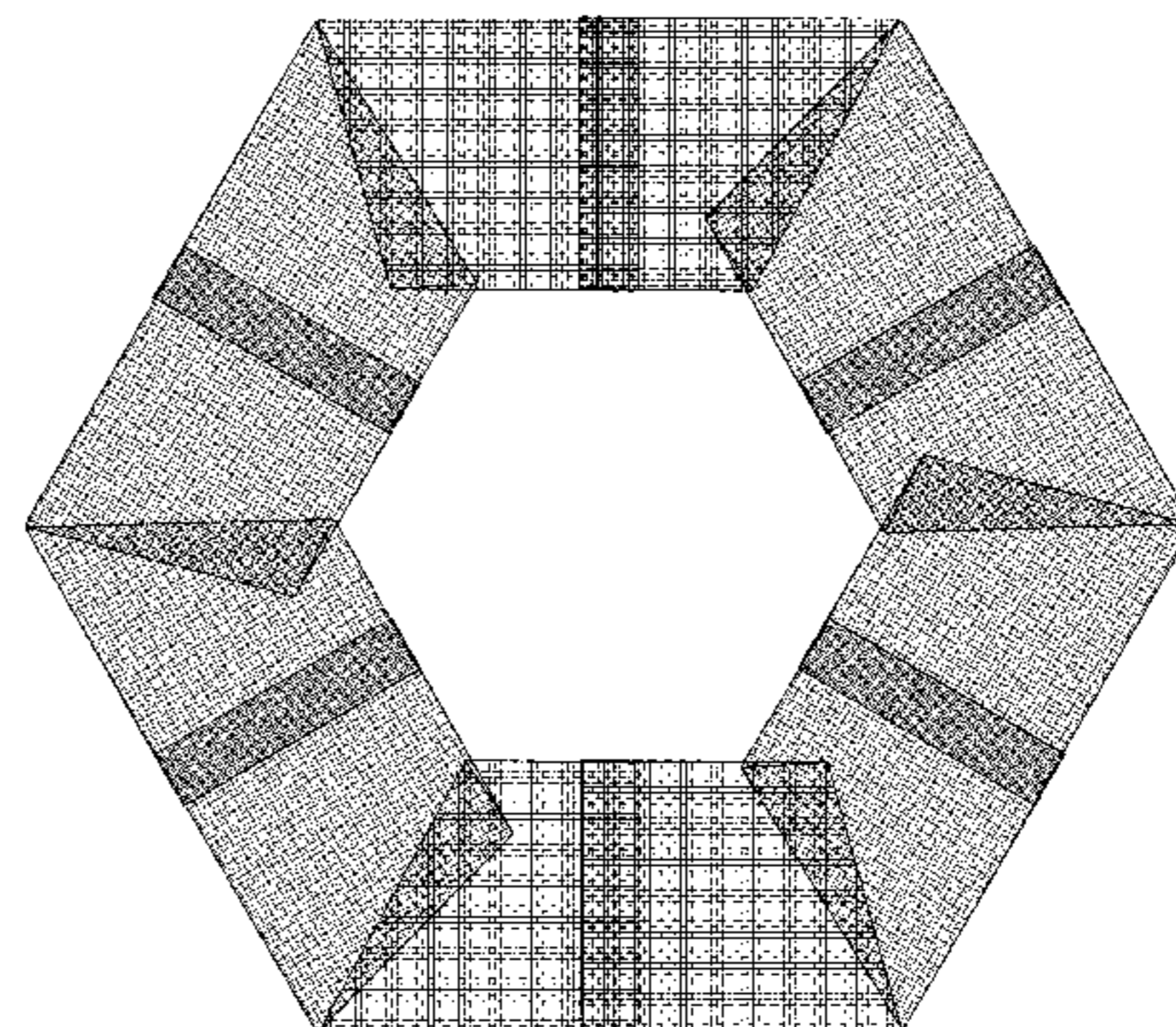
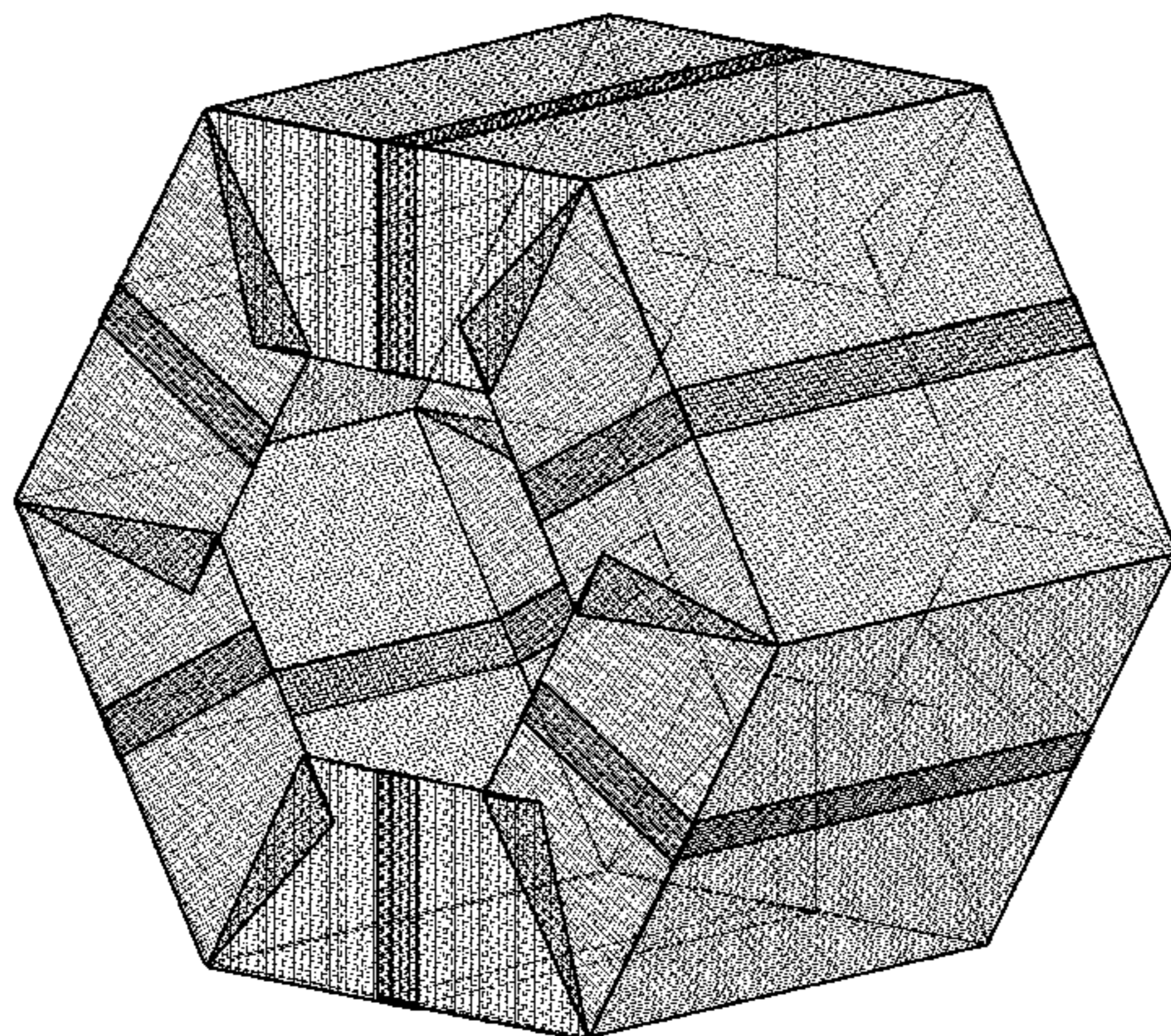
**CLAIM**

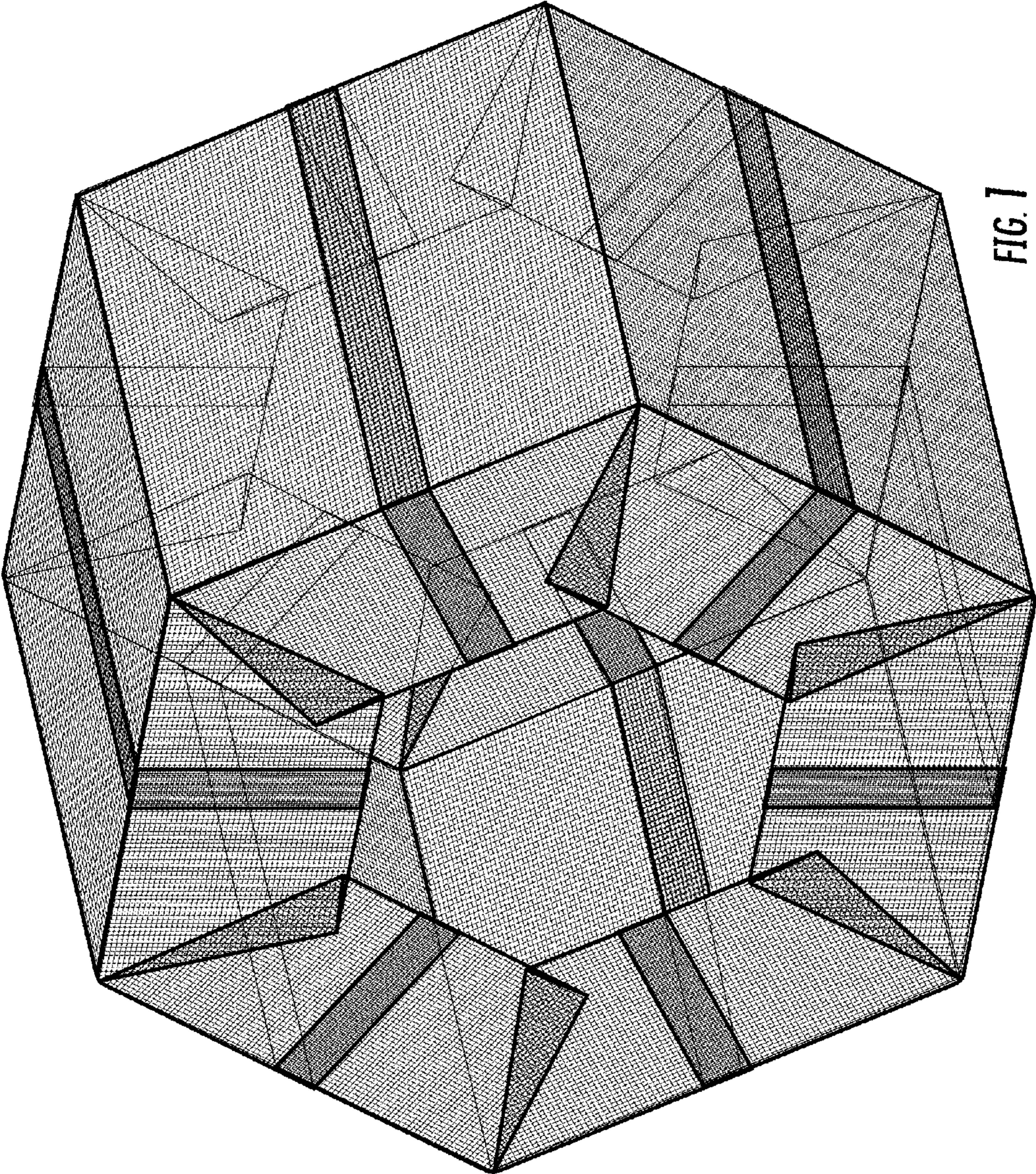

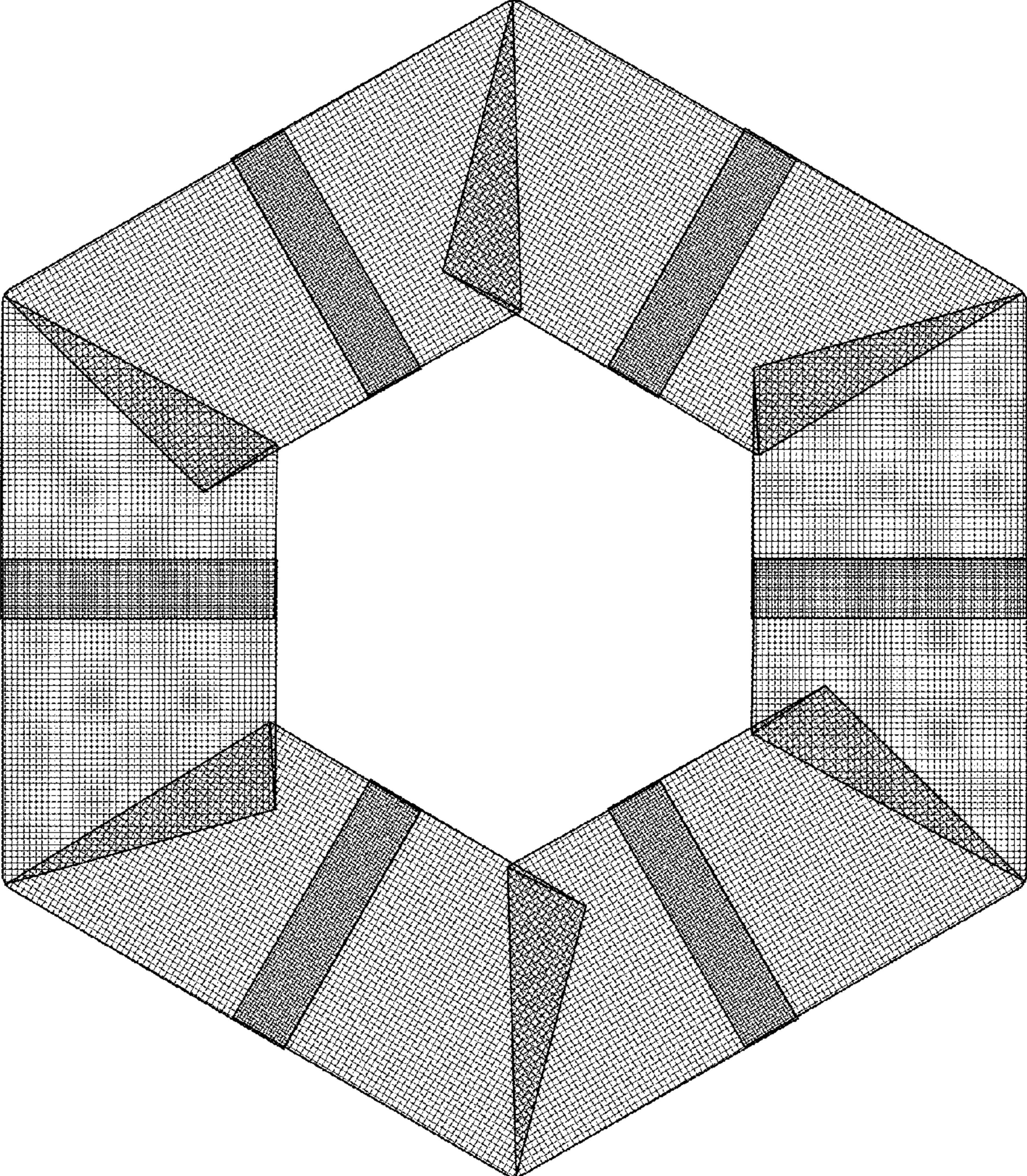

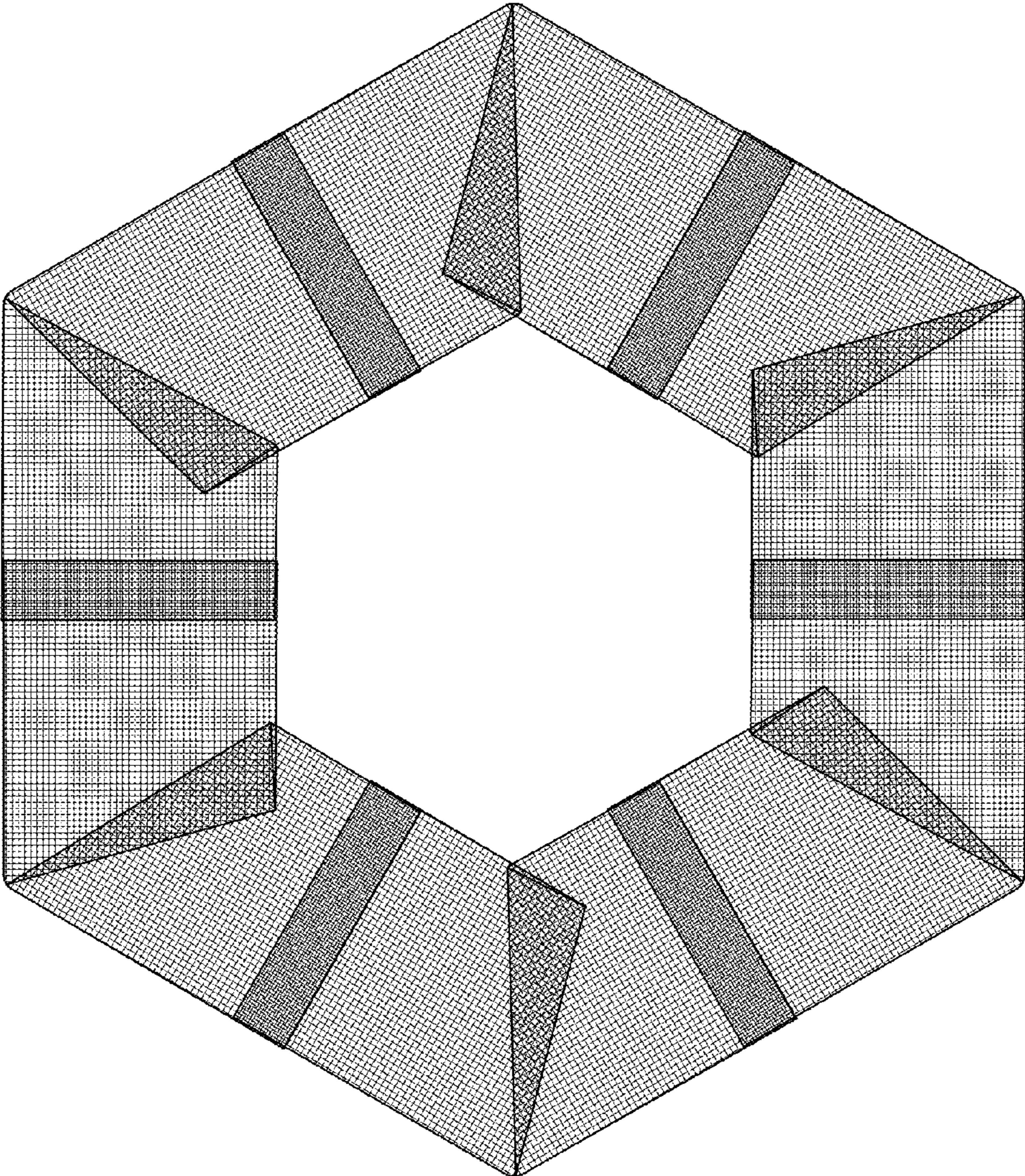

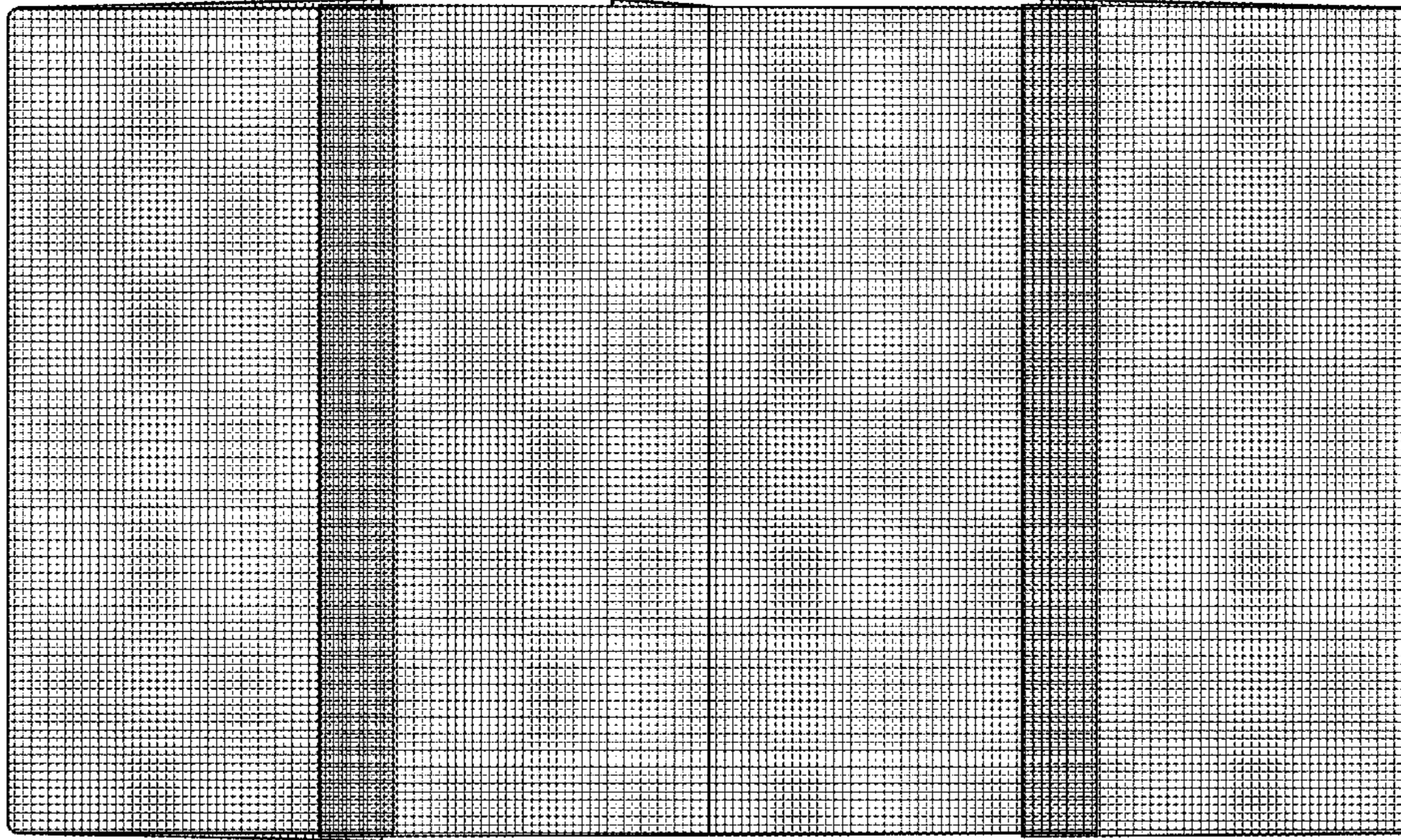

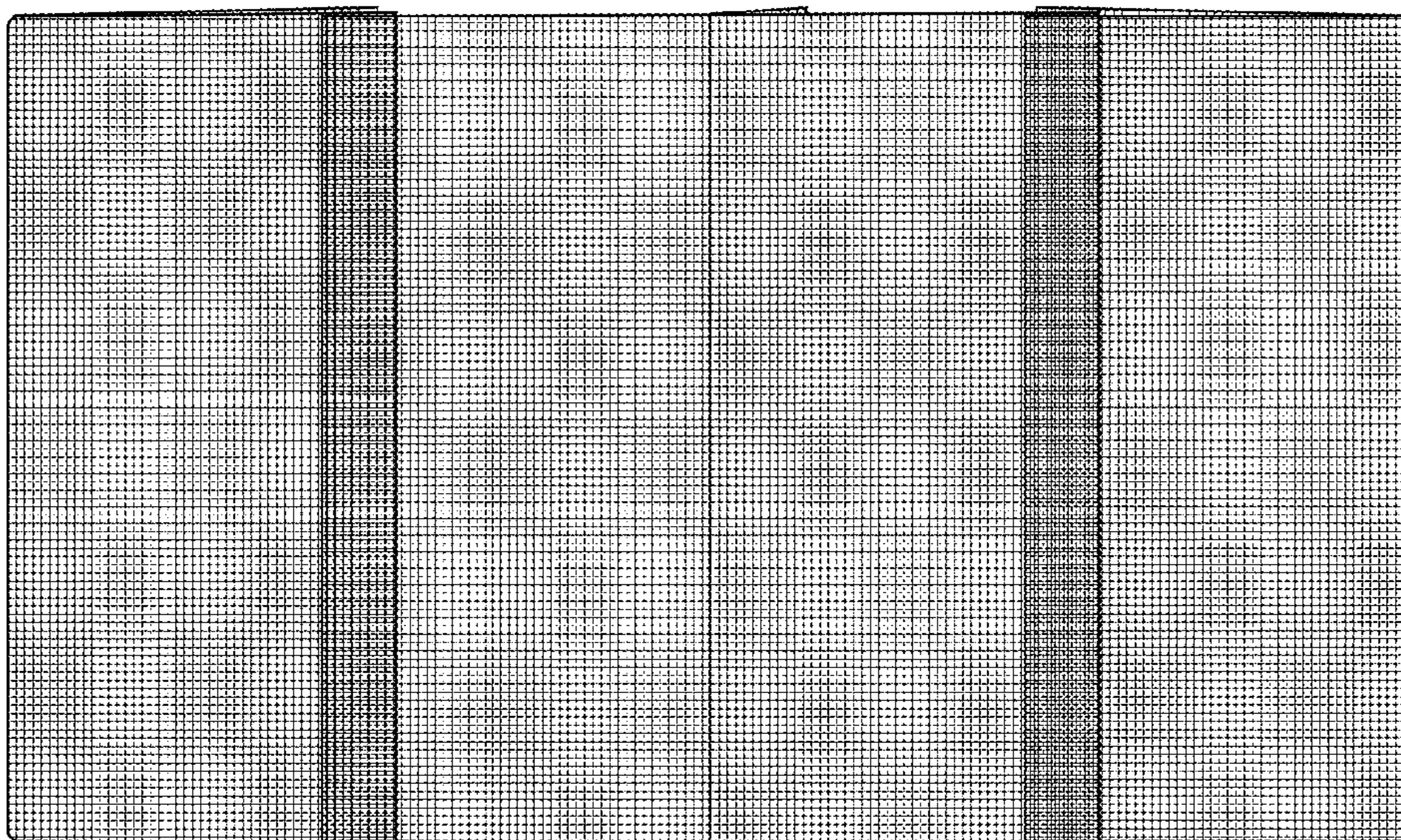

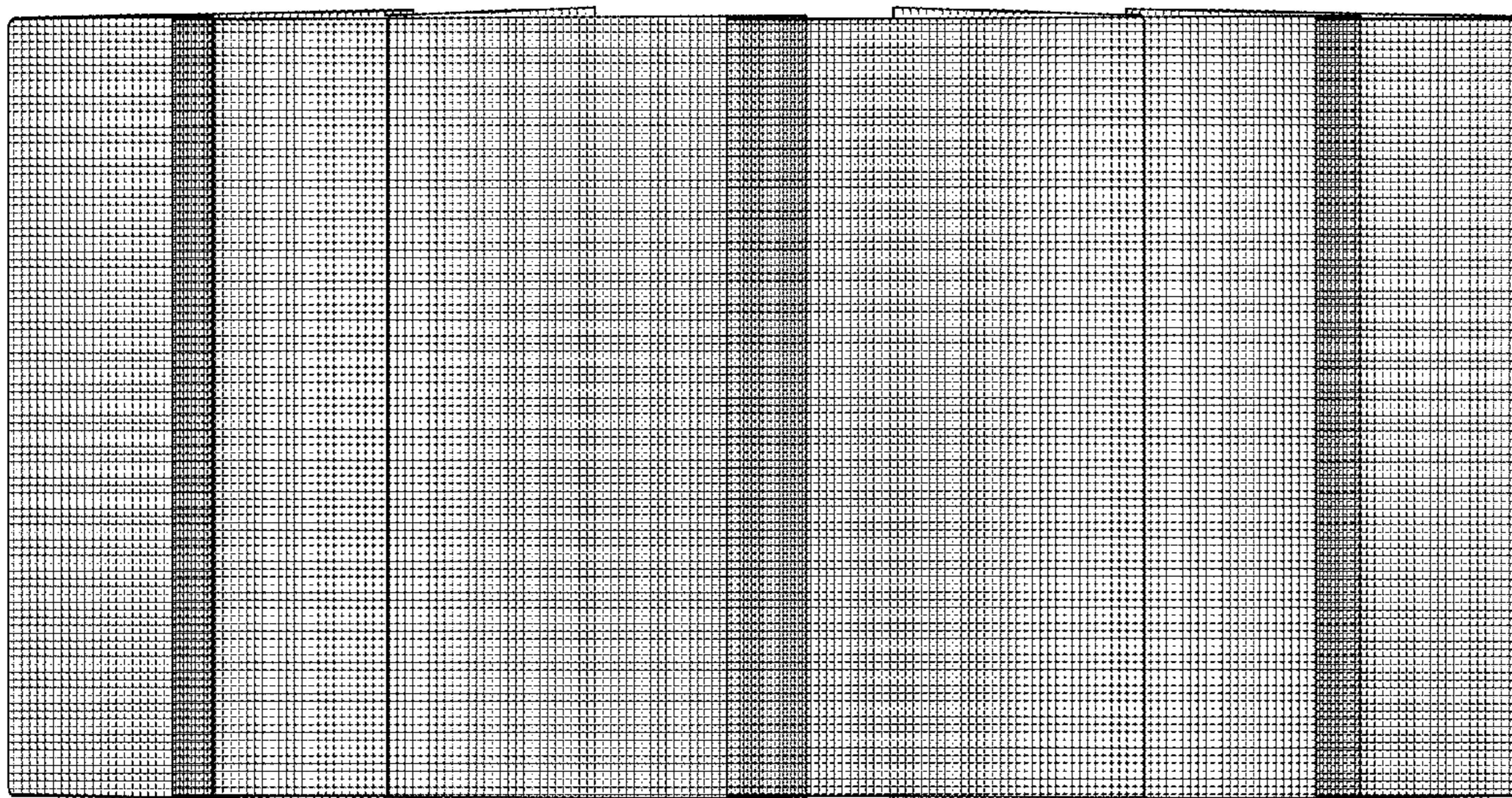

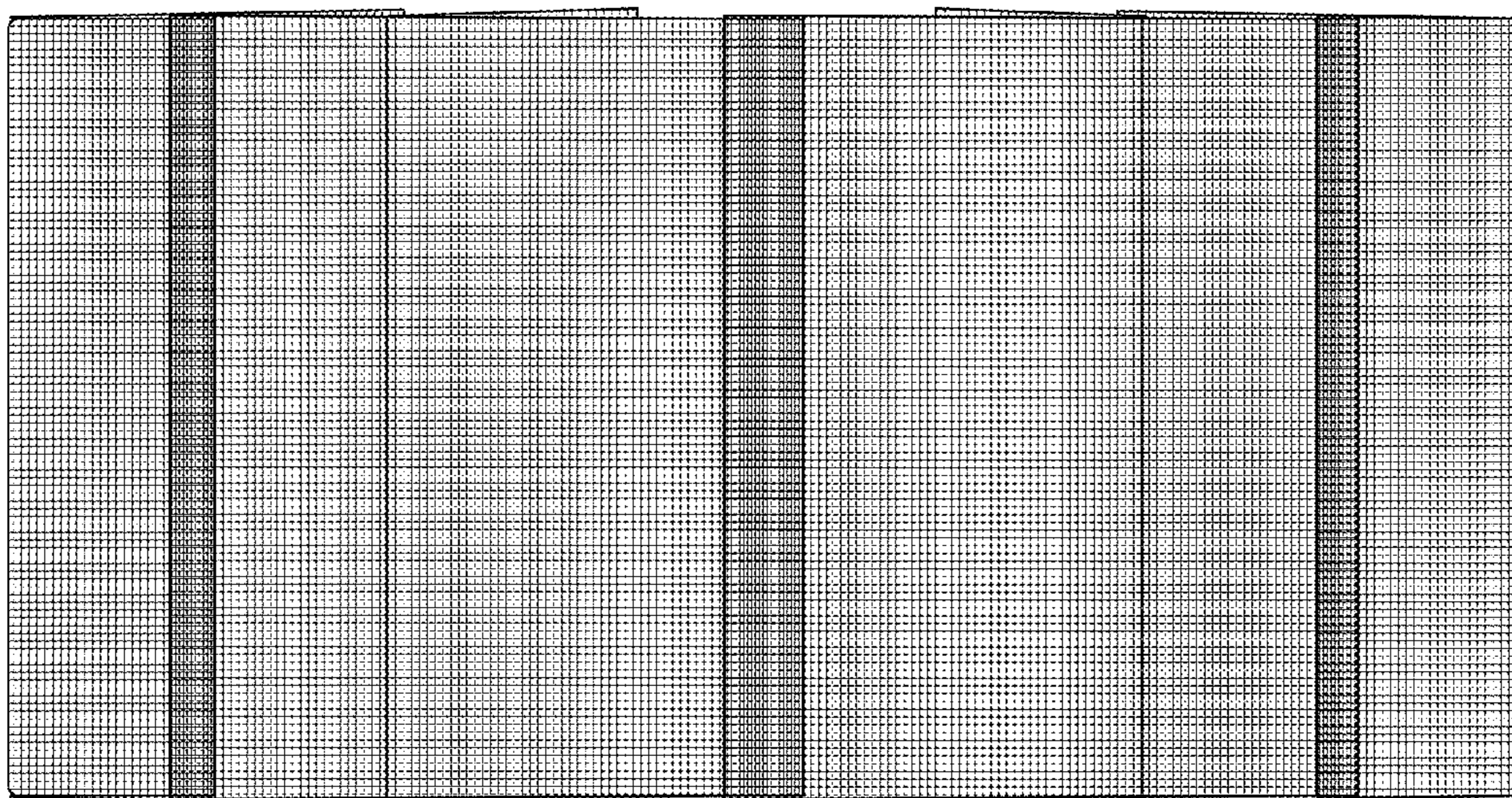
