**DESCRIPTION**

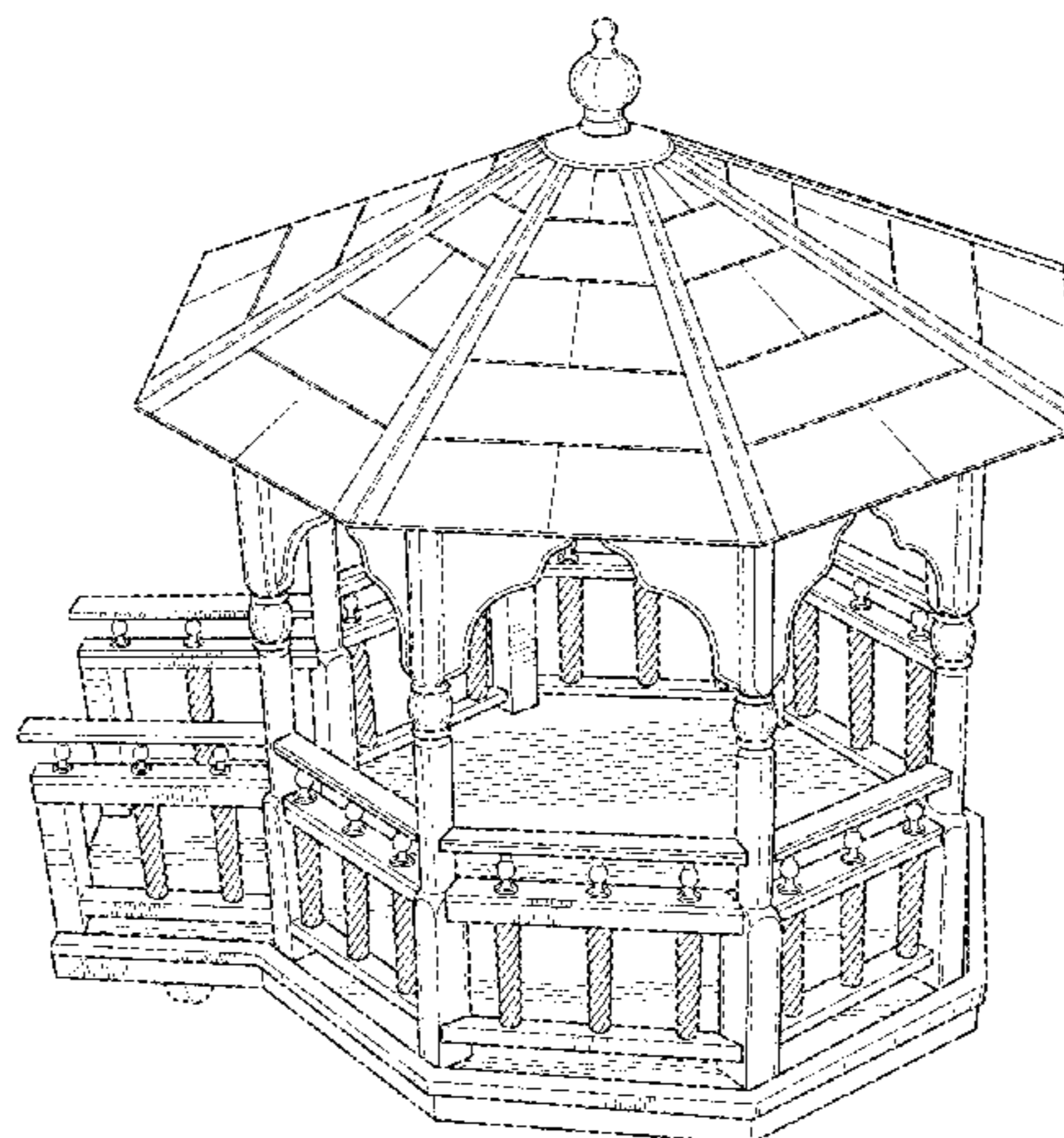
FIG. 1 is a perspective view of the gazebo for pets;

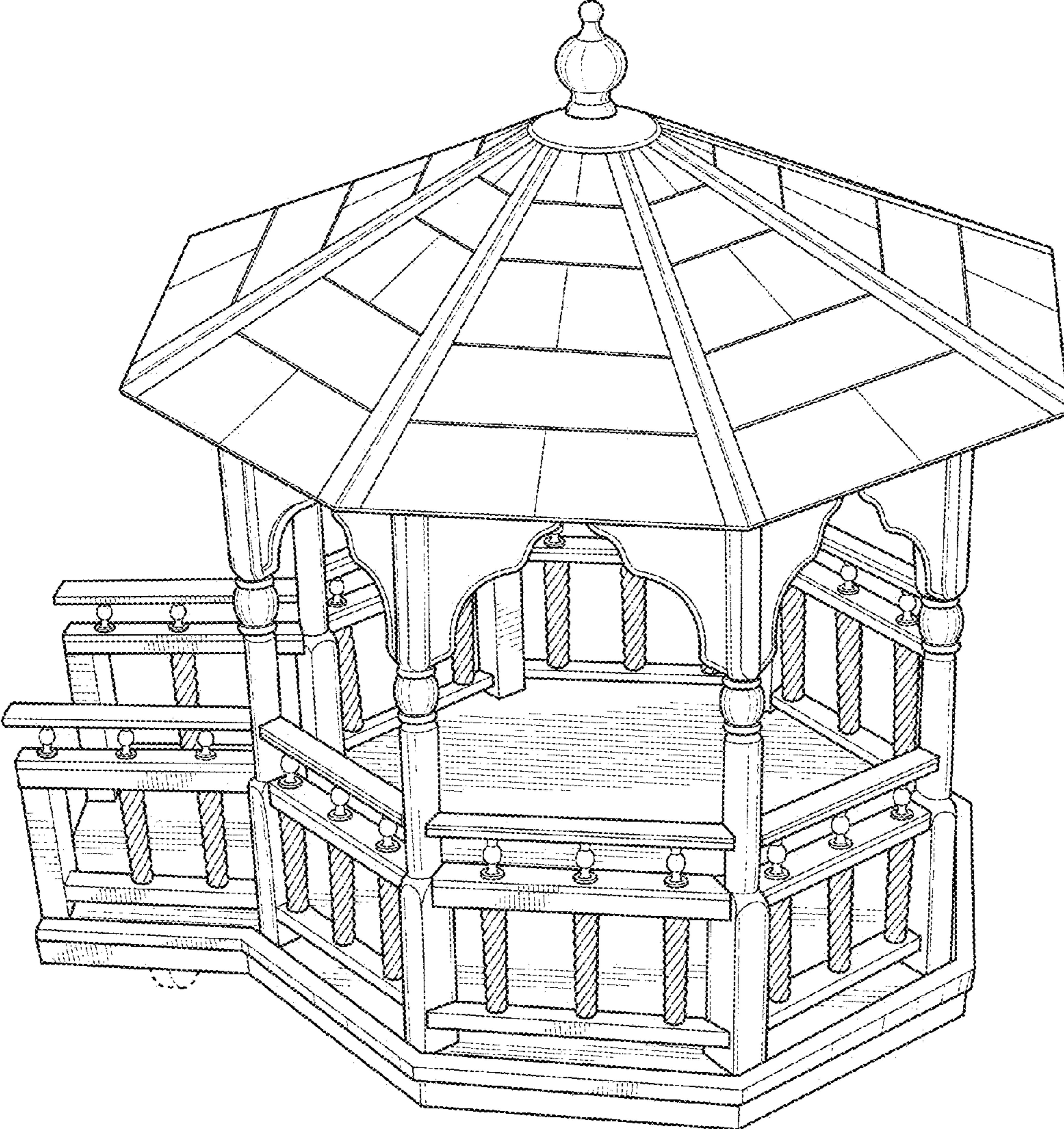

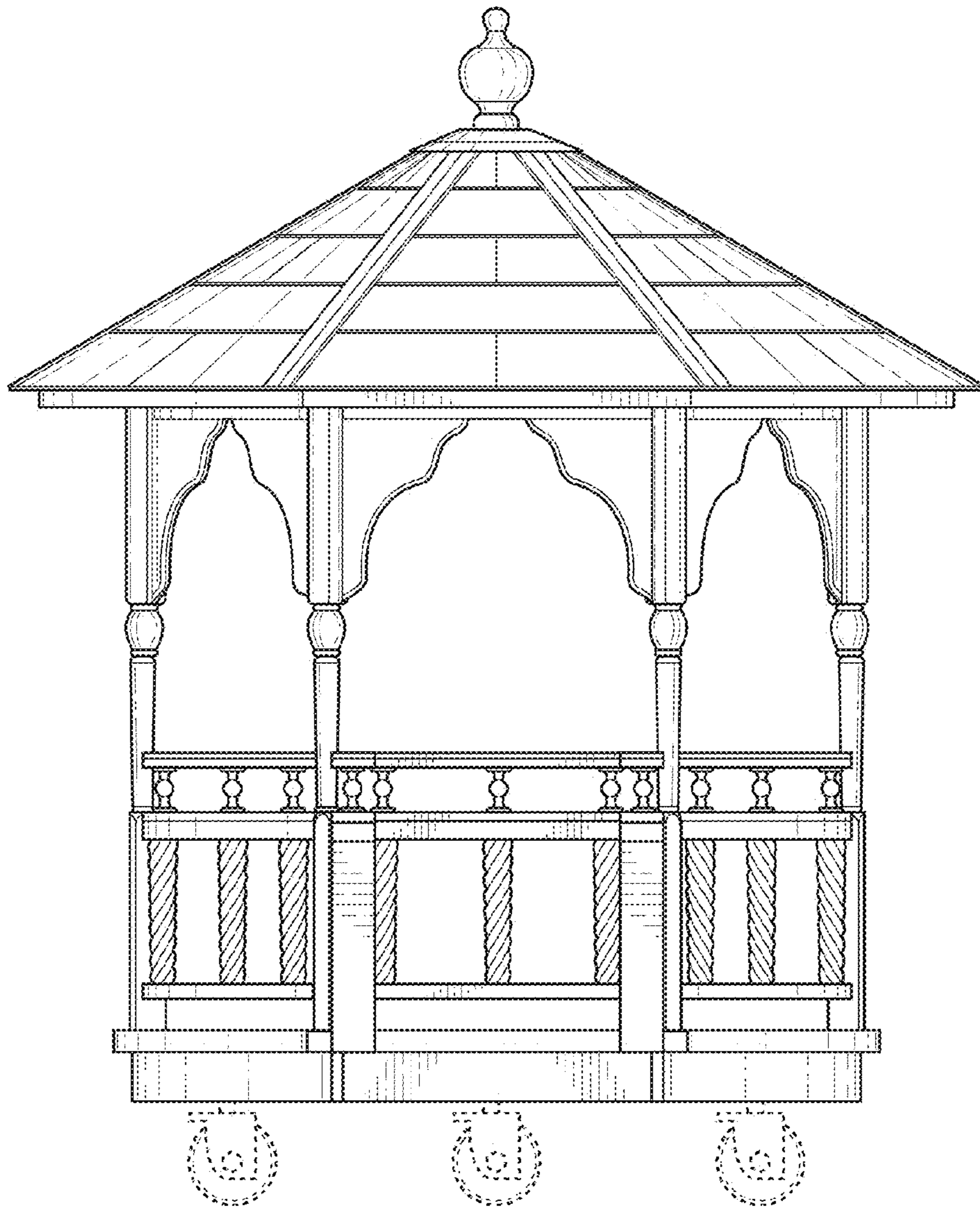

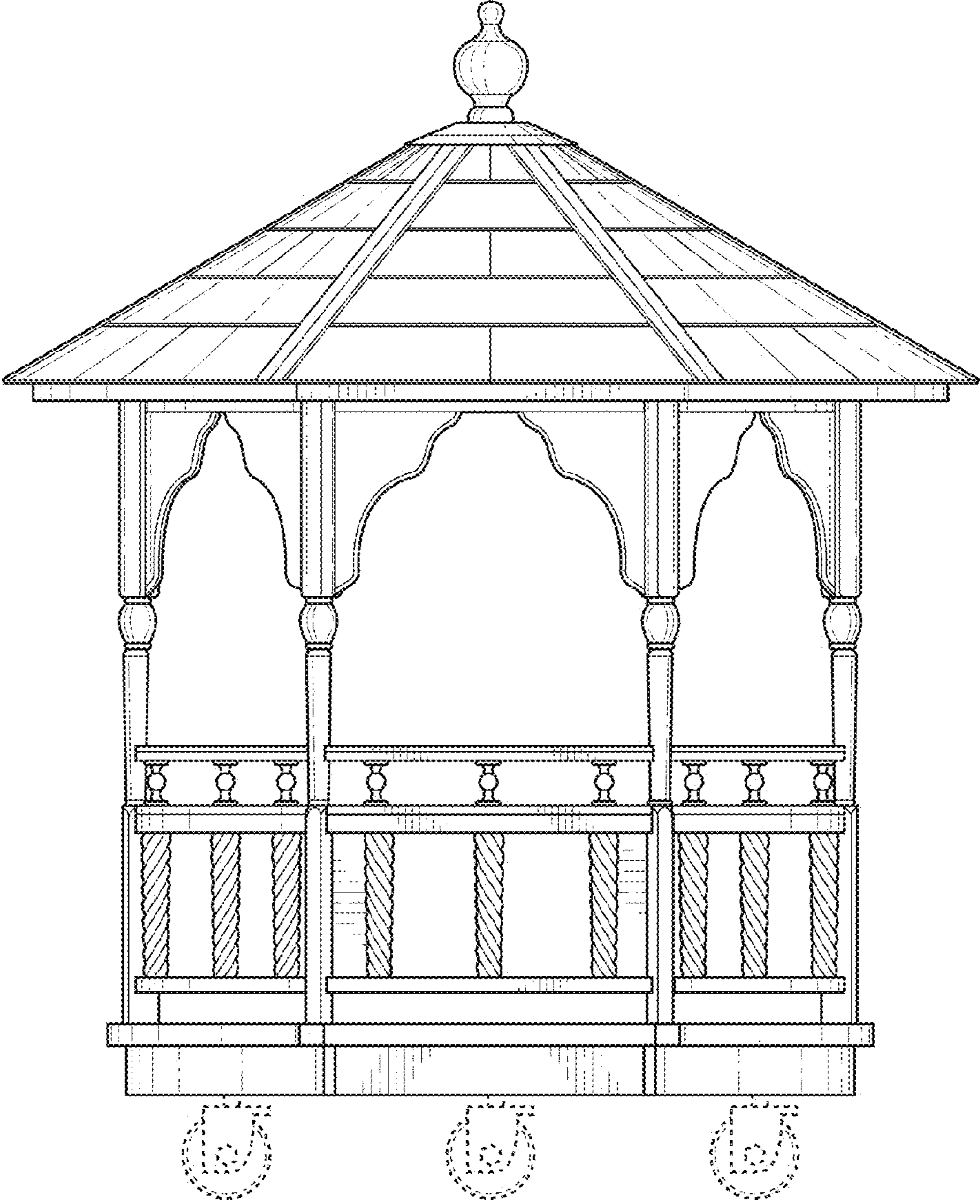

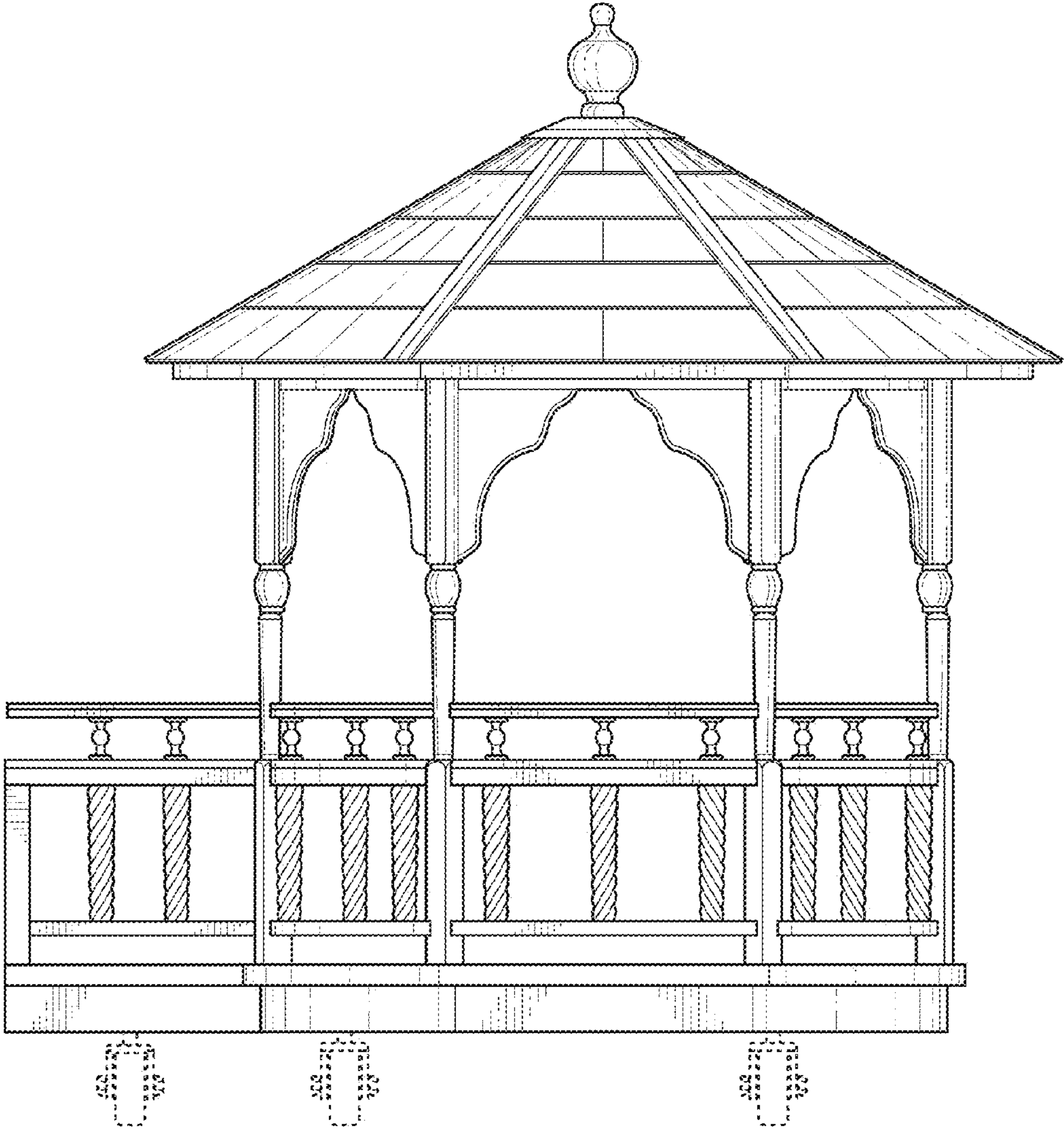

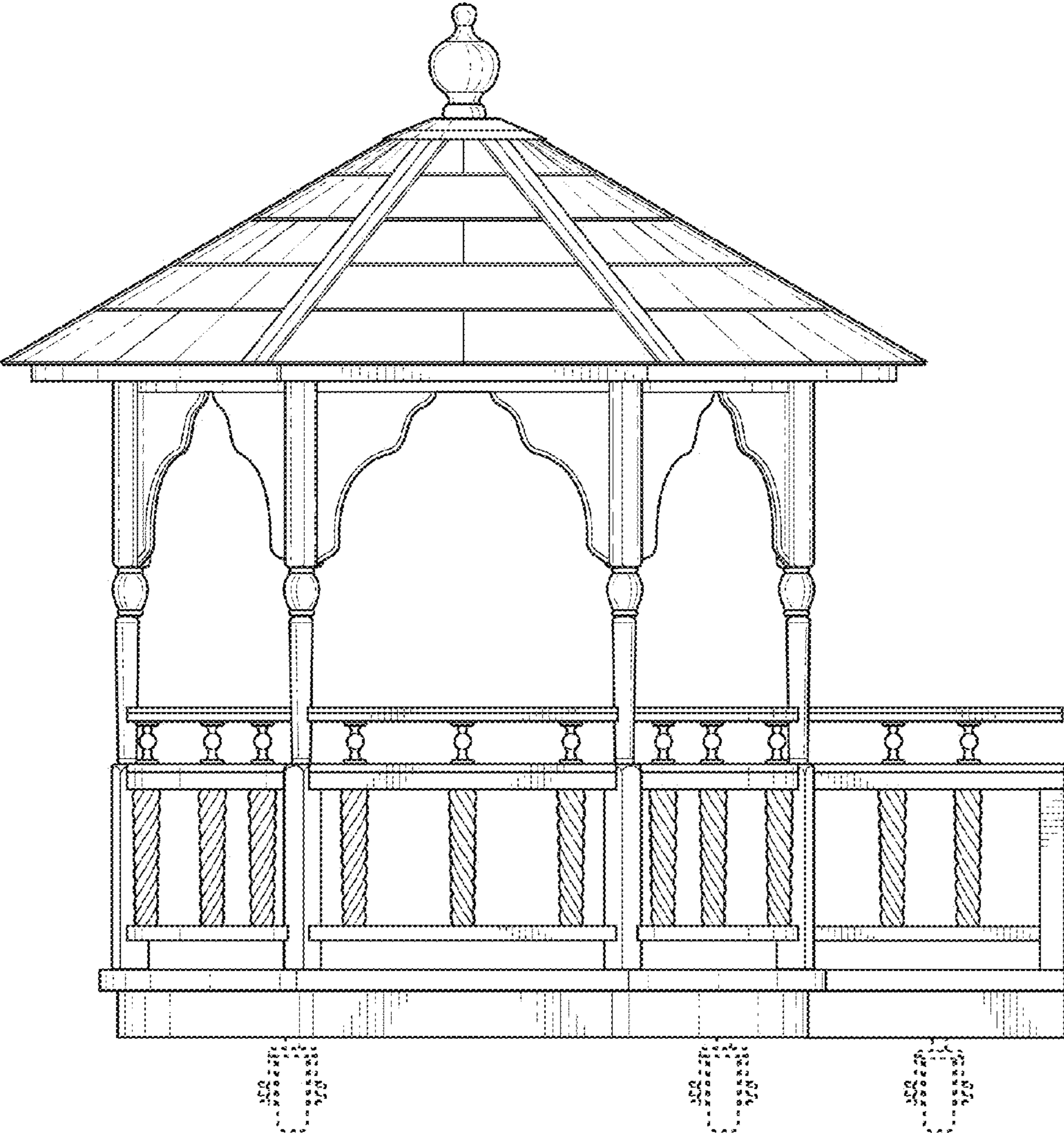

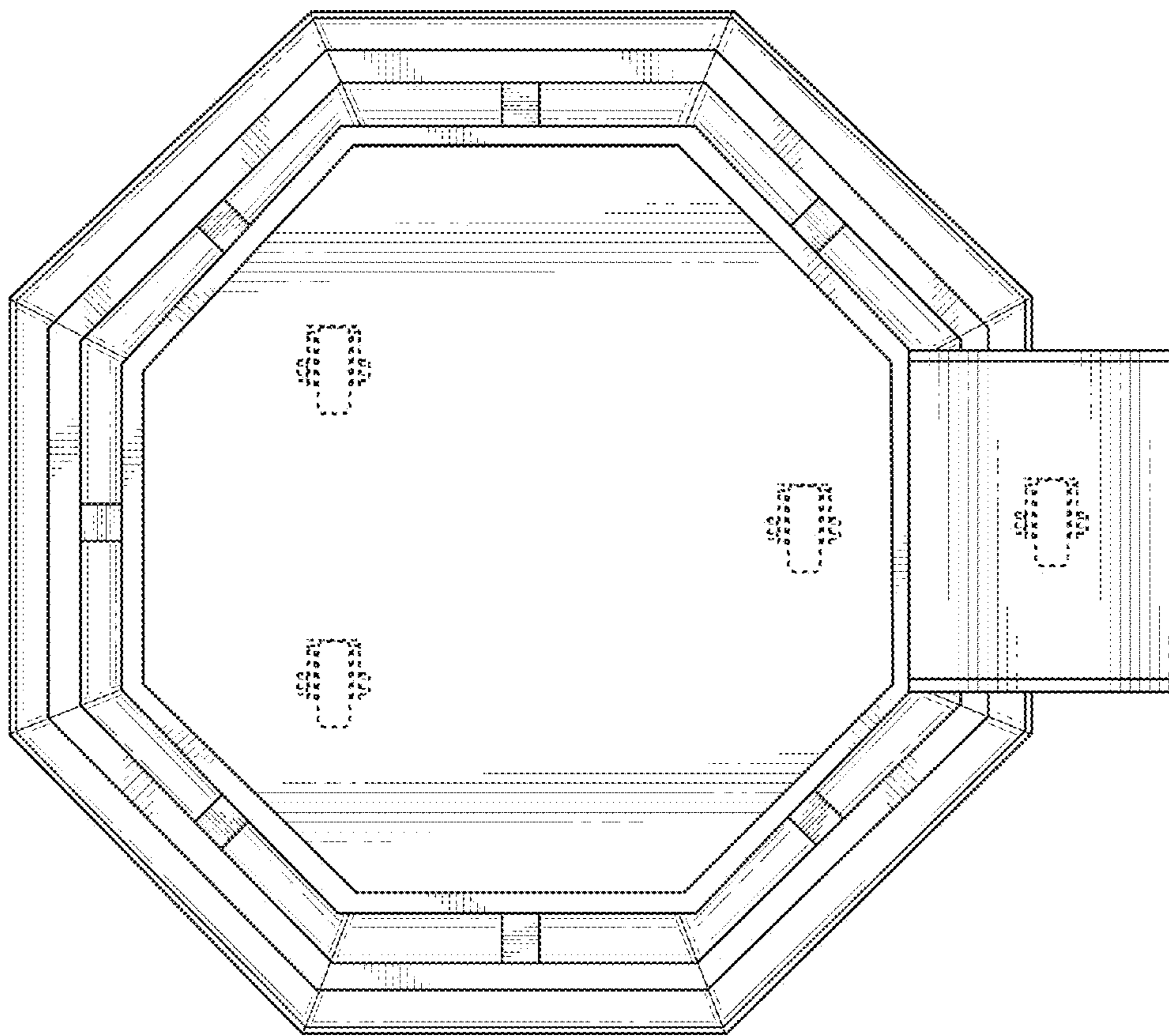

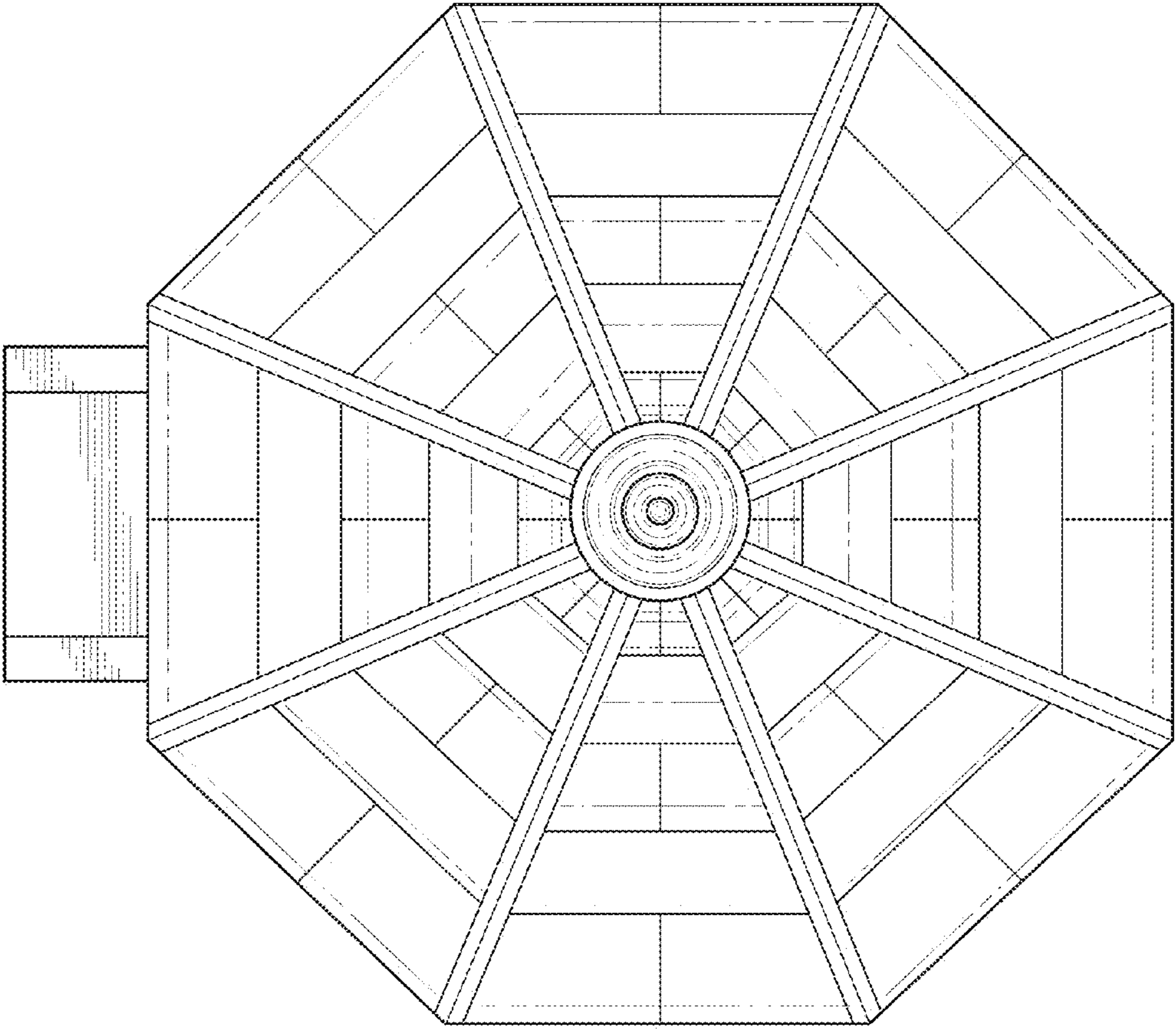

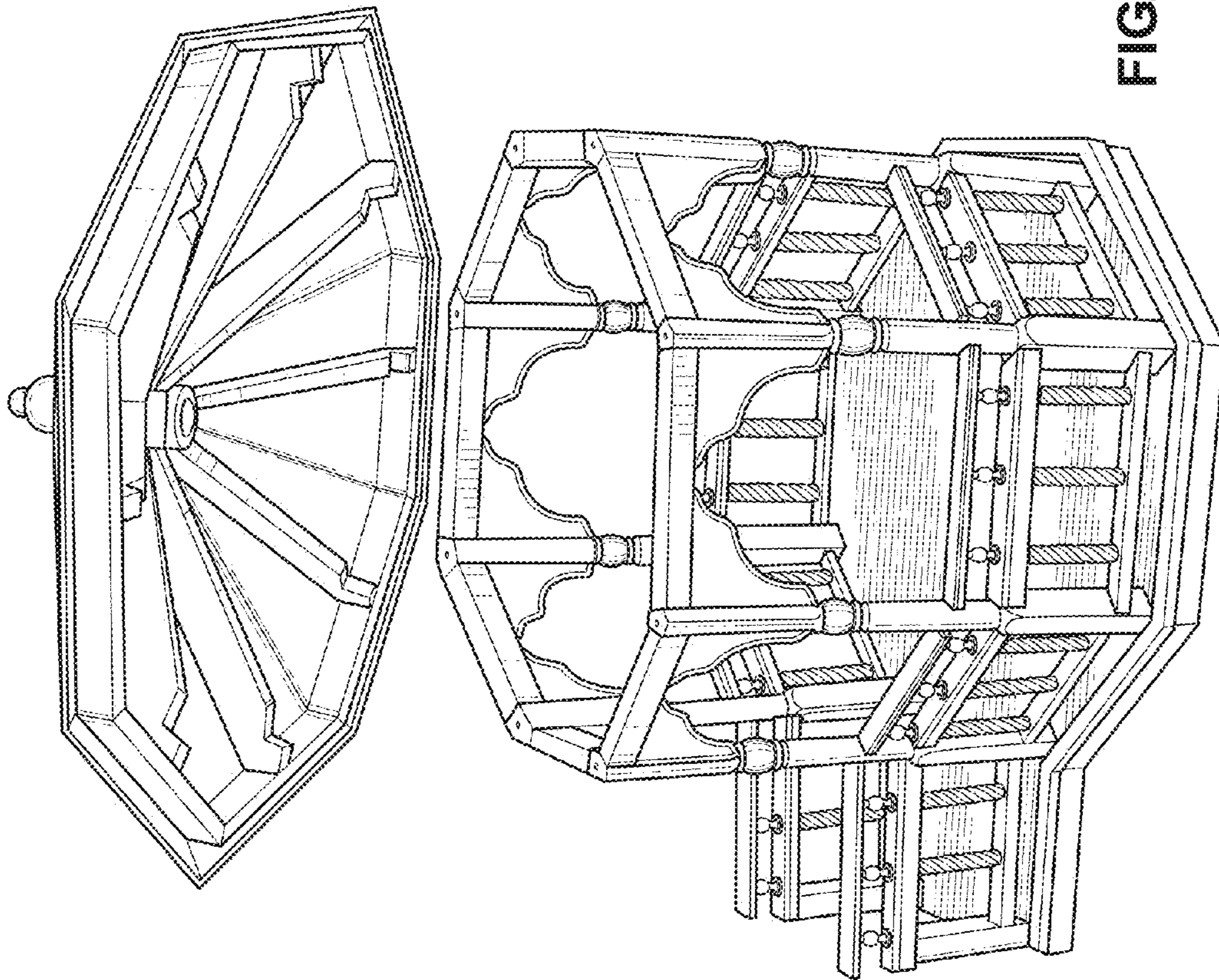

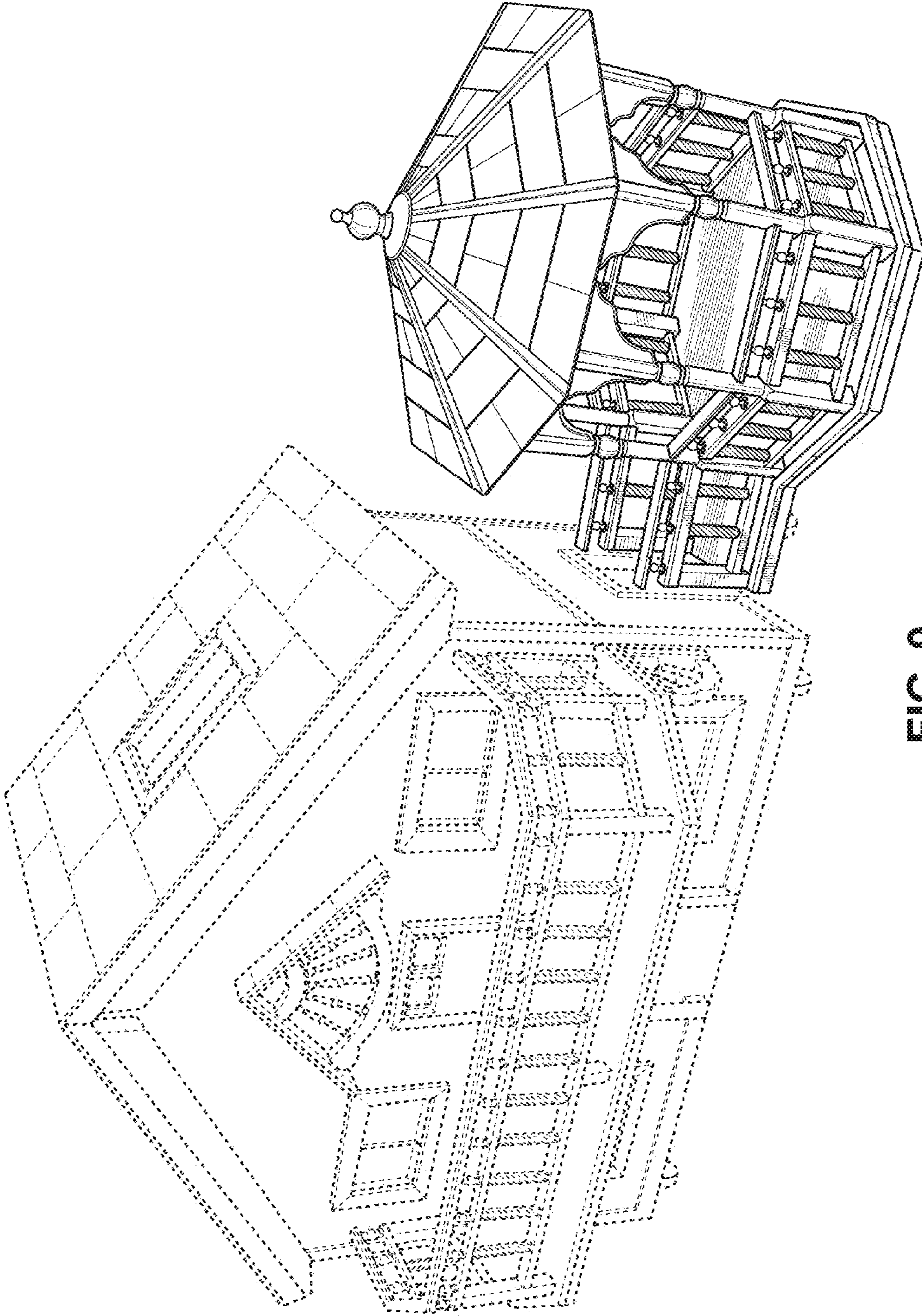

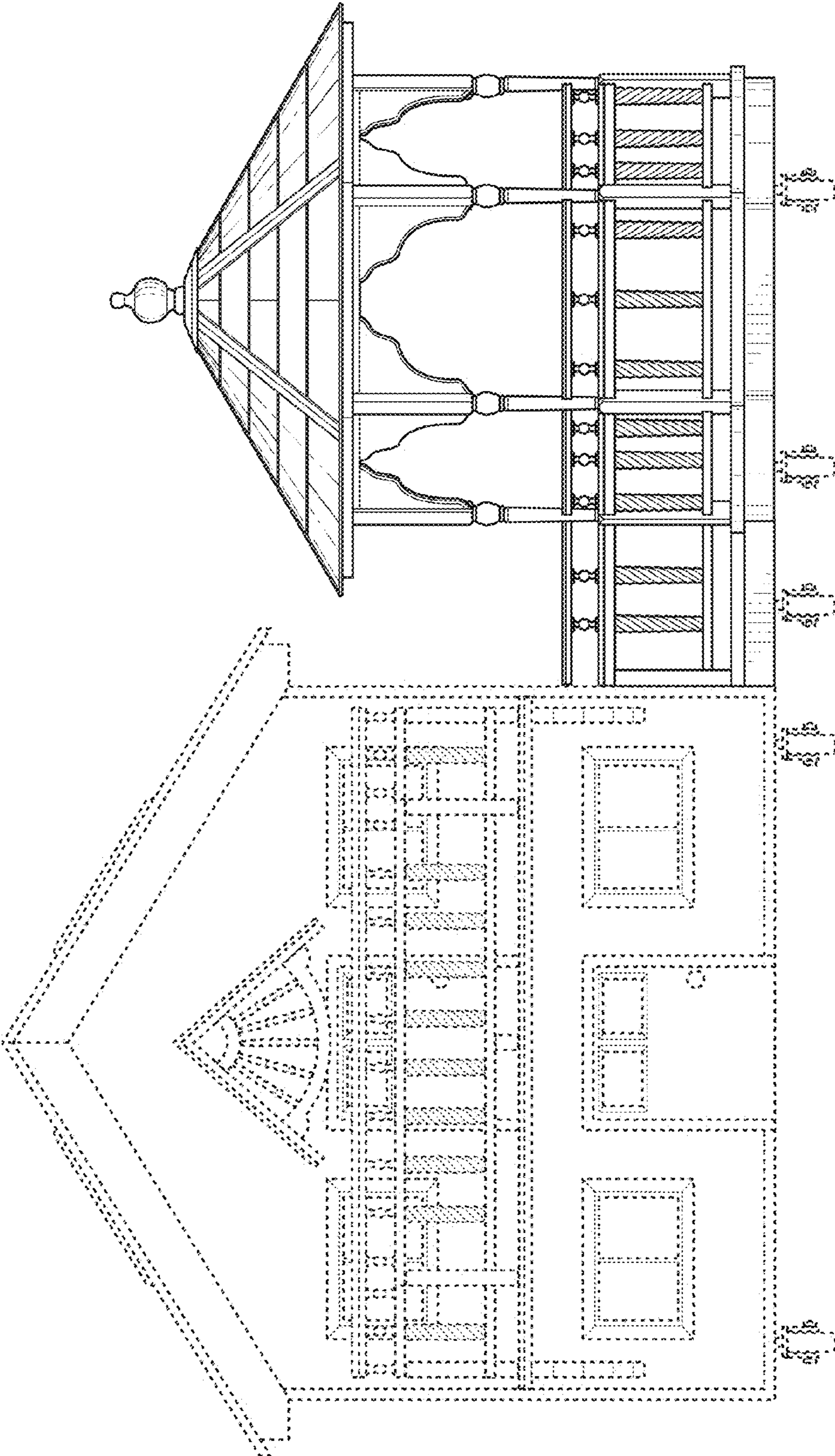
