FIG. 1 is a first side elevation view of the ornamental design of the hat with pockets for receiving eyeglasses stems with the opposing side being a mirrored image;

FIG. 2 is top plan view of the hat with pockets for receiving eyeglasses stems of FIG. 1;

FIG. 3 is a front elevation view of the hat with pockets for receiving eyeglasses stems of FIG. 1;

FIG. 4 is perspective view of the hat with pockets for receiving eyeglasses stems of FIG. 1;

FIG. 5 is a front elevation view of the hat with pockets for receiving eyeglasses stems of FIG. 1 shown without glasses installed;

FIG. 6 is a cross-sectional view taken at line 6-6 of FIG. 5 and showing an interior view of the hat with pockets for receiving eyeglasses stems of FIG. 1, partially hidden by the band of the hat;

FIG. 7 is a front elevation view of the hat with pockets for receiving eyeglasses stems of FIG. 1 shown without glasses installed and showing a cross-section cut for FIG. 8; and,

FIG. 8 is a cross-sectional view taken at line 8-8 of FIG. 7 and showing an interior view of the hat with pockets for receiving eyeglasses stems of FIG. 1 from behind the band of the hat.

The broken lines illustrate environmental structure that forms no part of the claimed design.

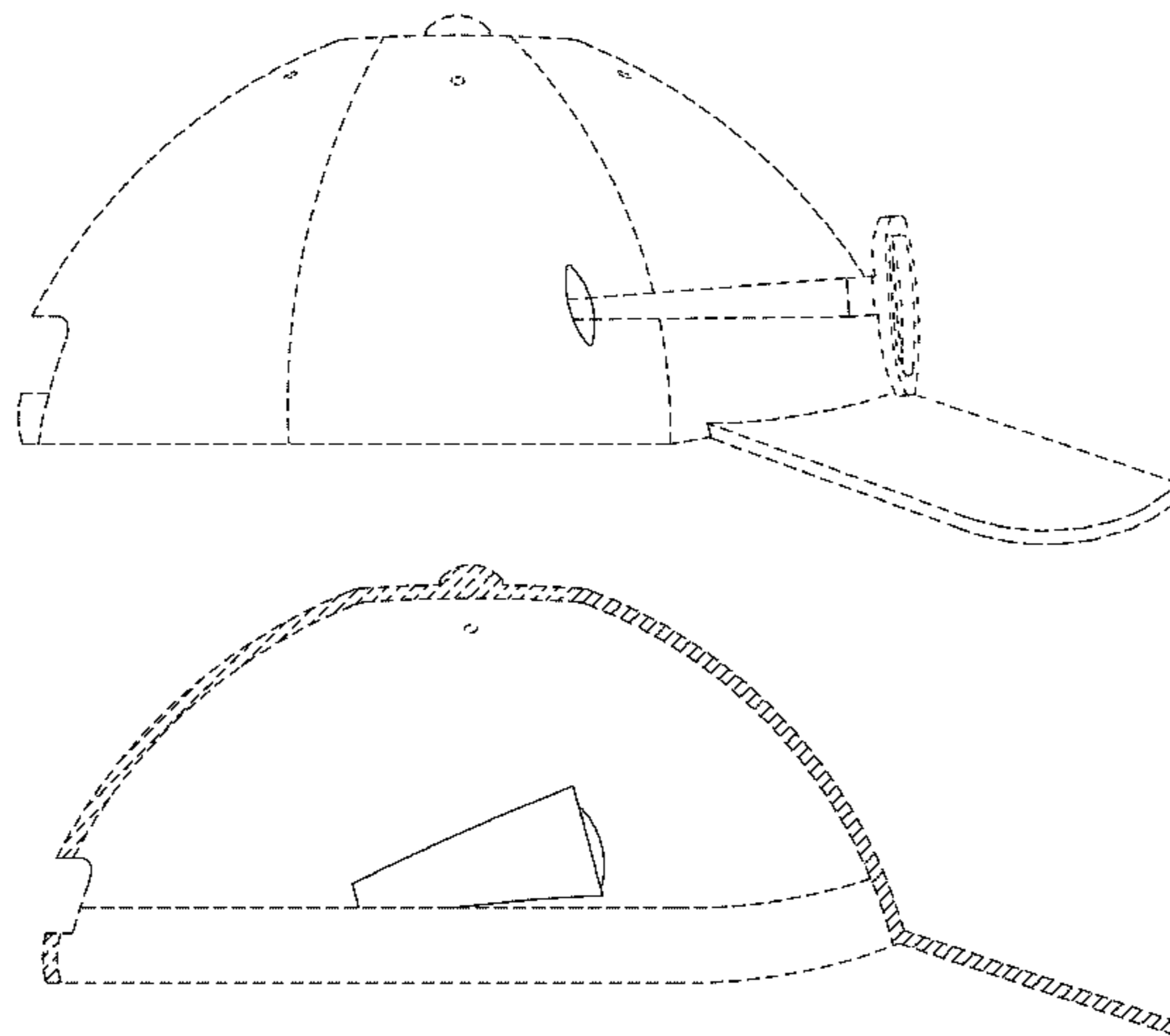
The hat with pockets for receiving eyeglasses stems is shown as a slit on the outside of a hat and providing entry to the pocket on the interior of the hat.

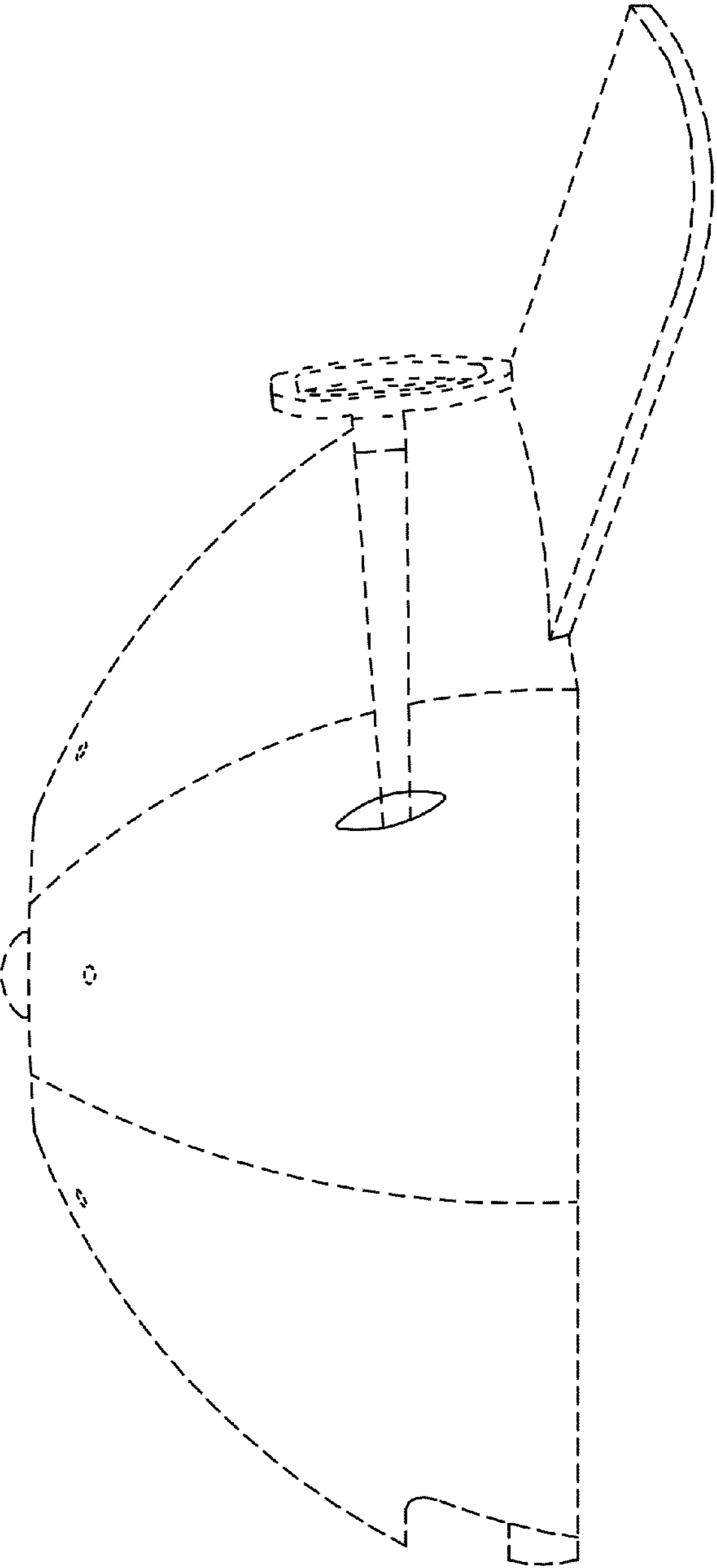

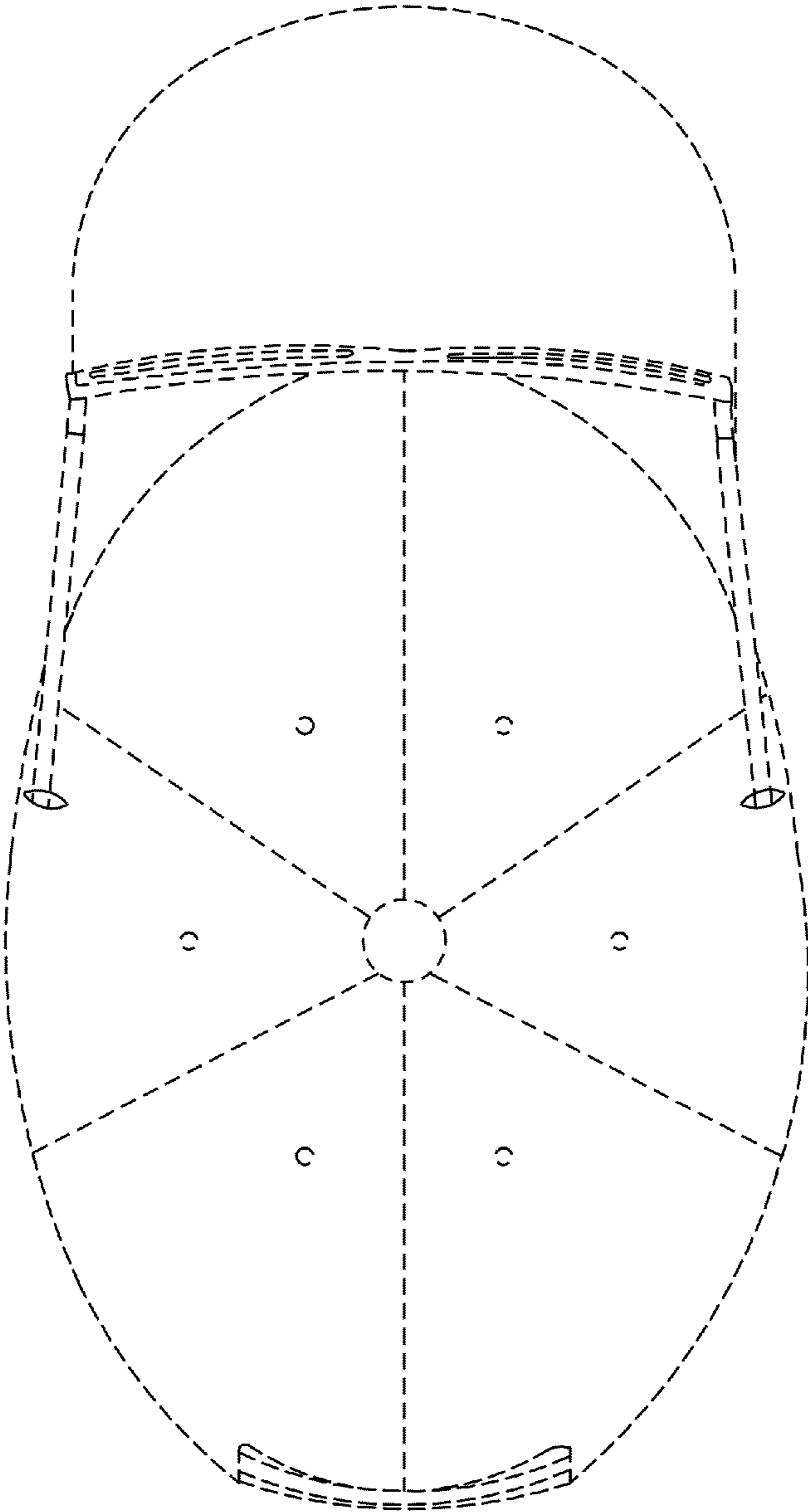

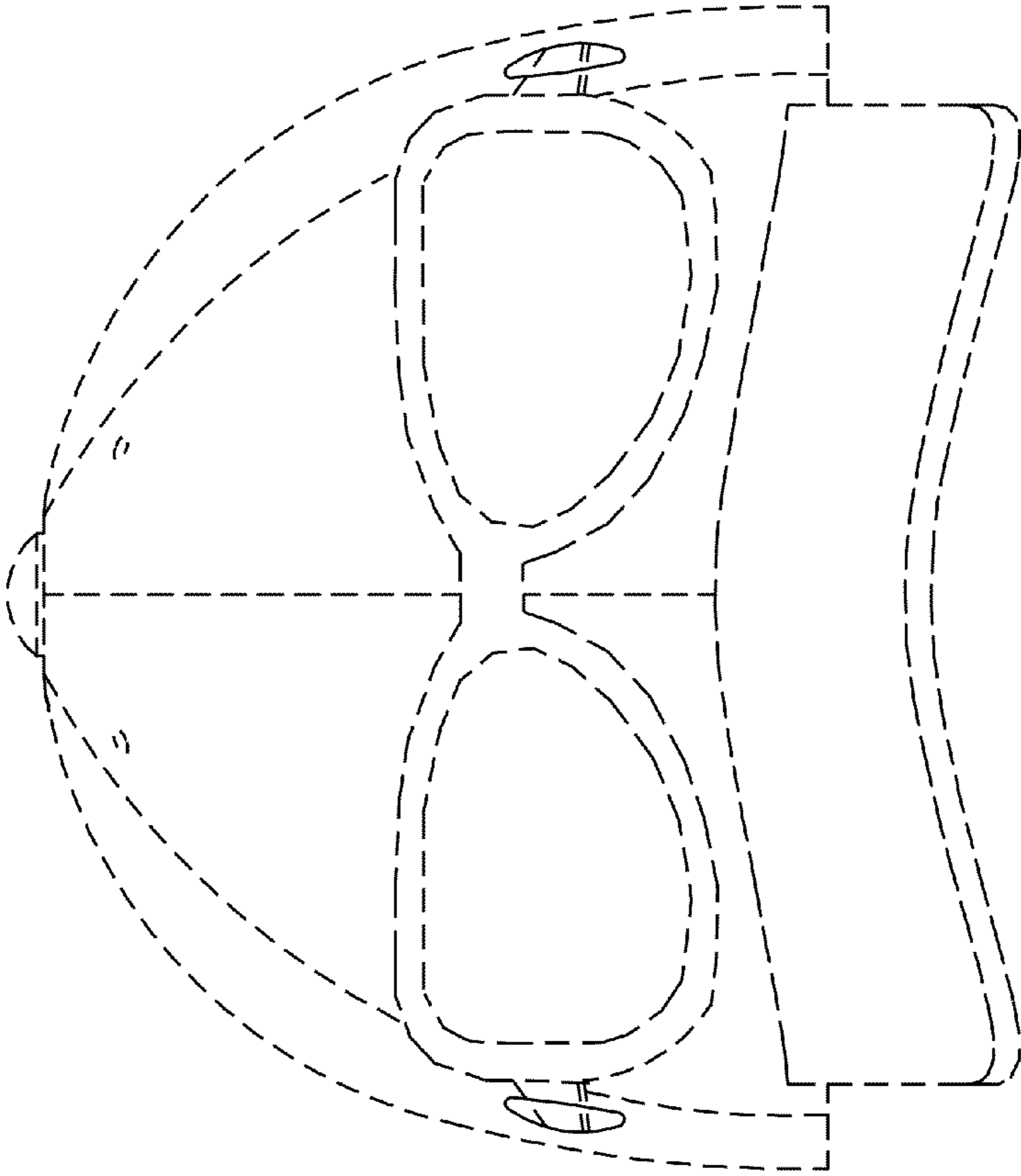

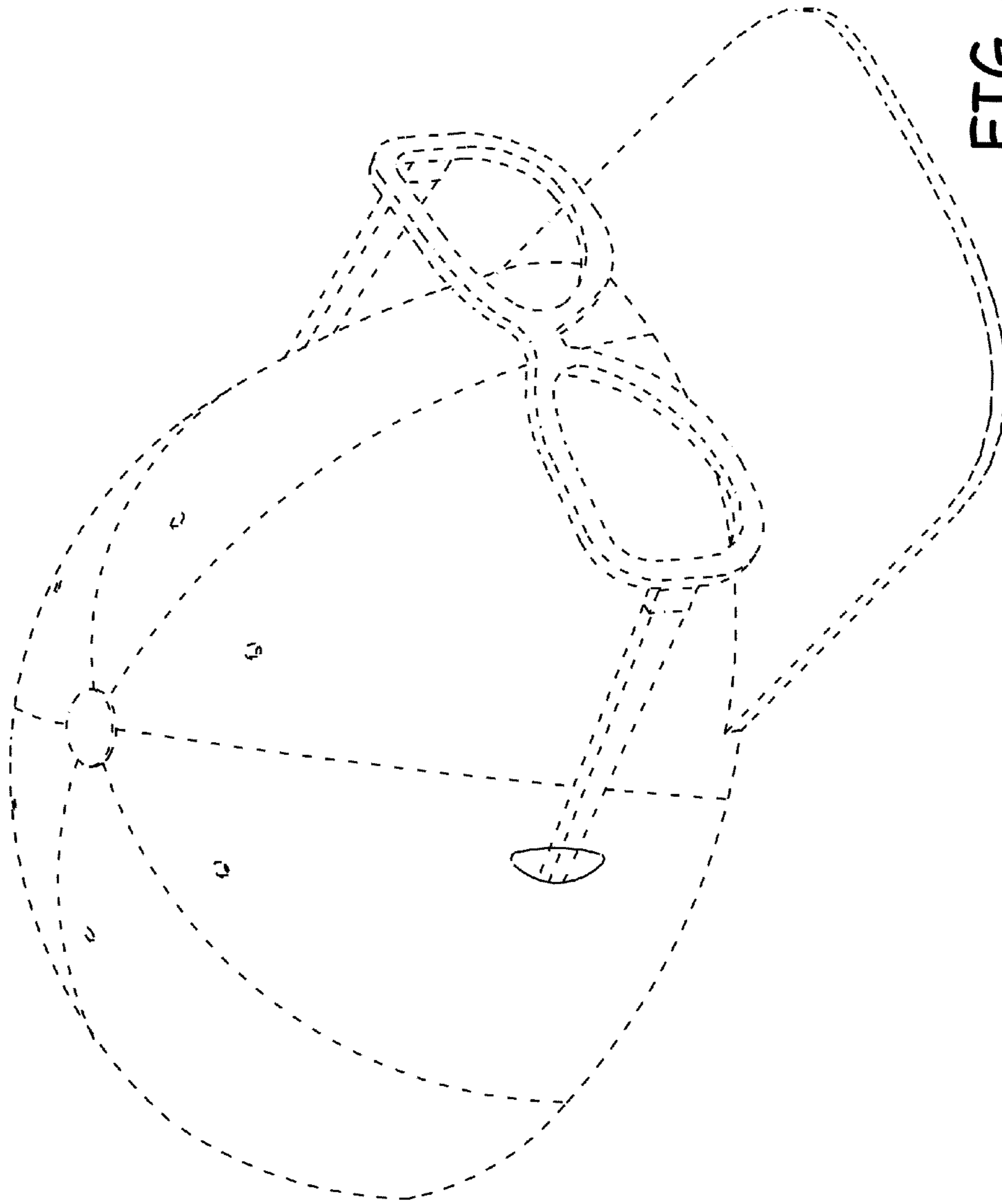

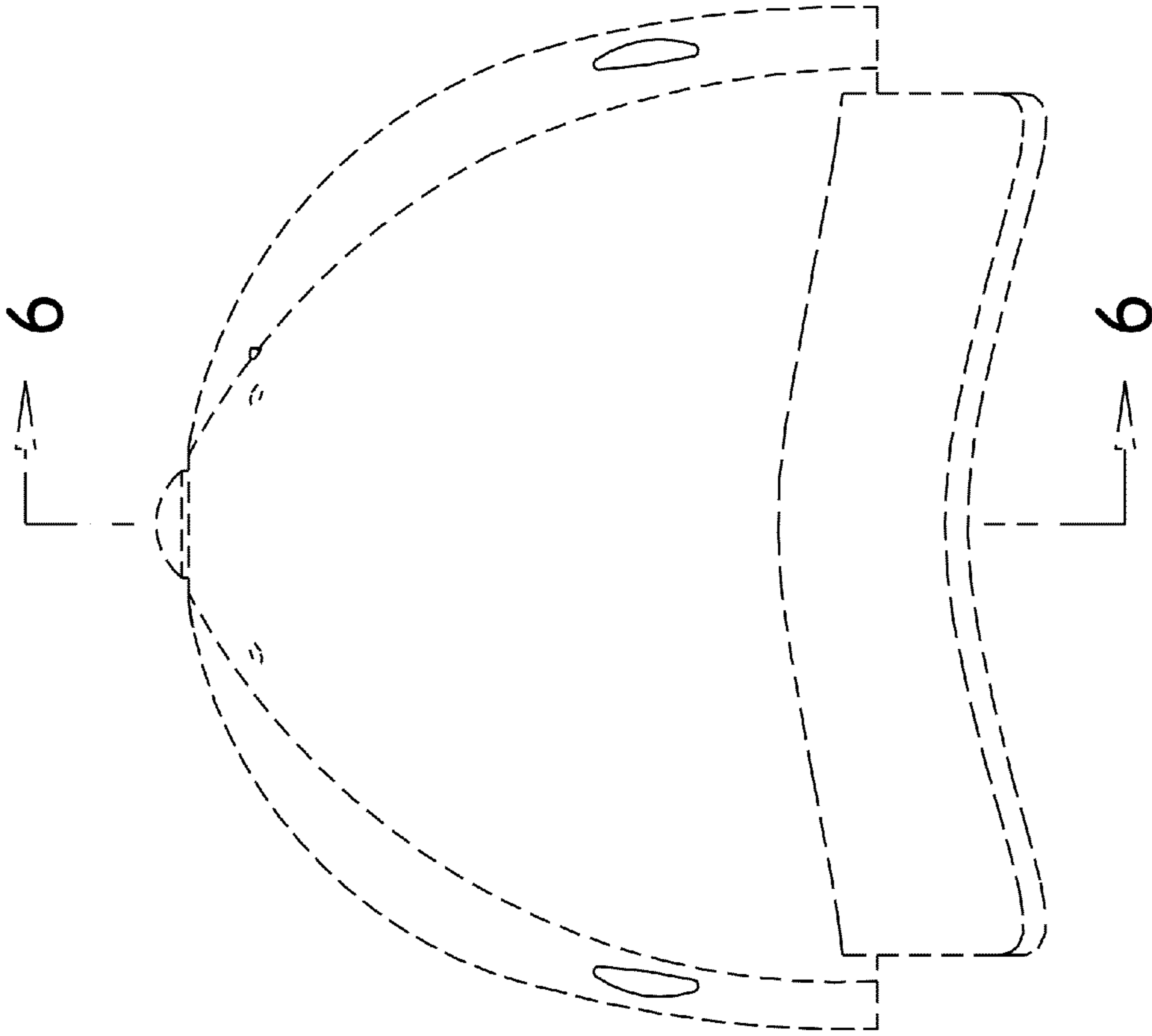

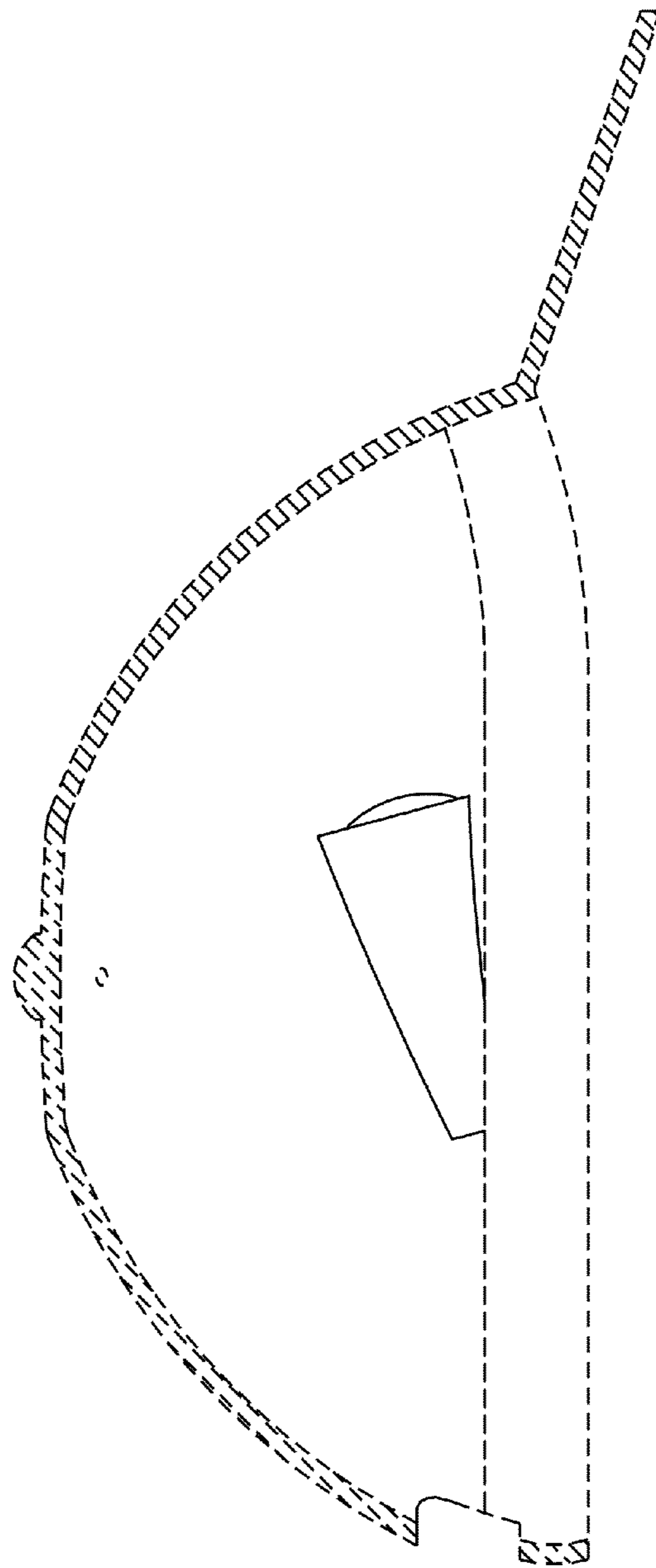

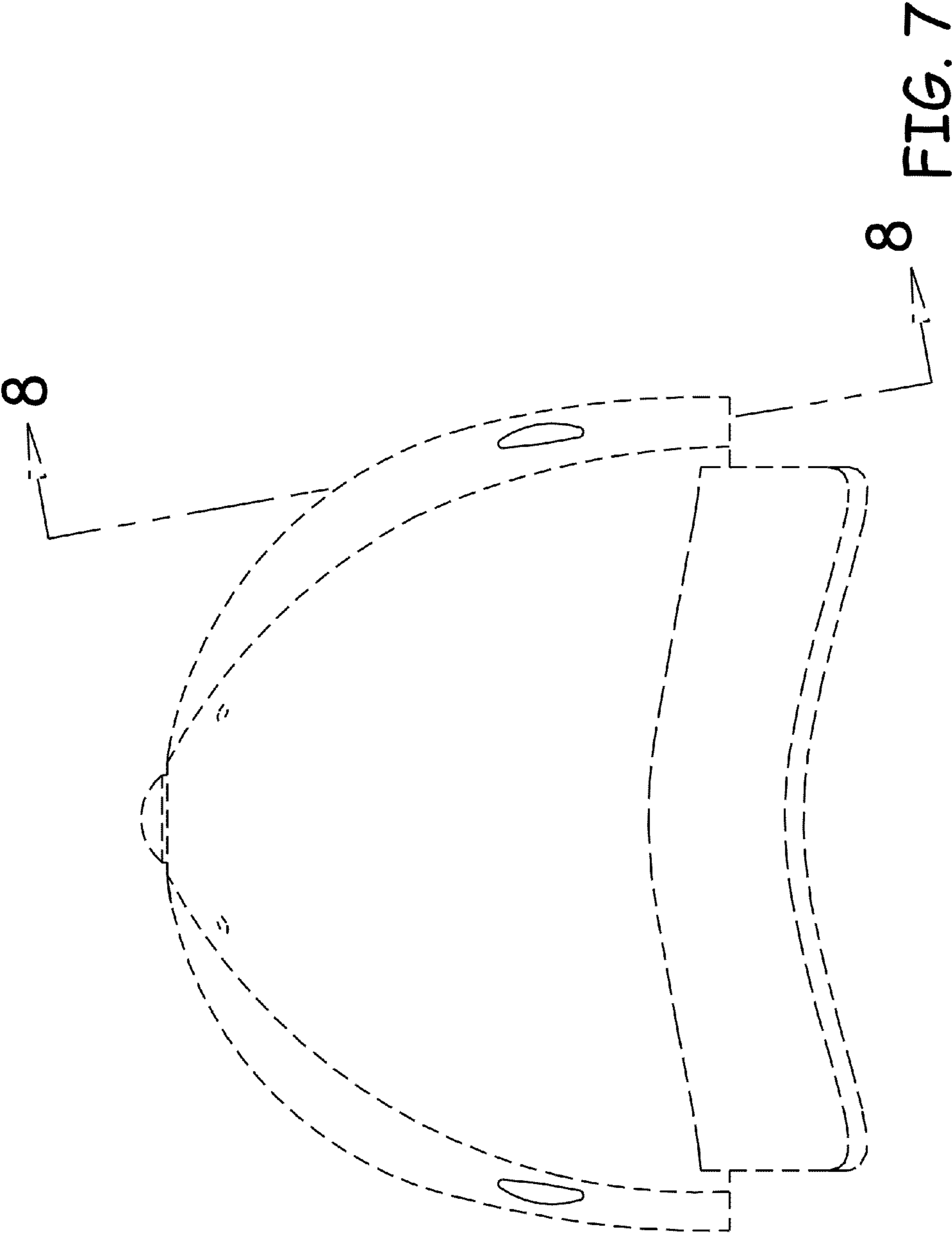
