FIG. 14 is a bottom view thereof.

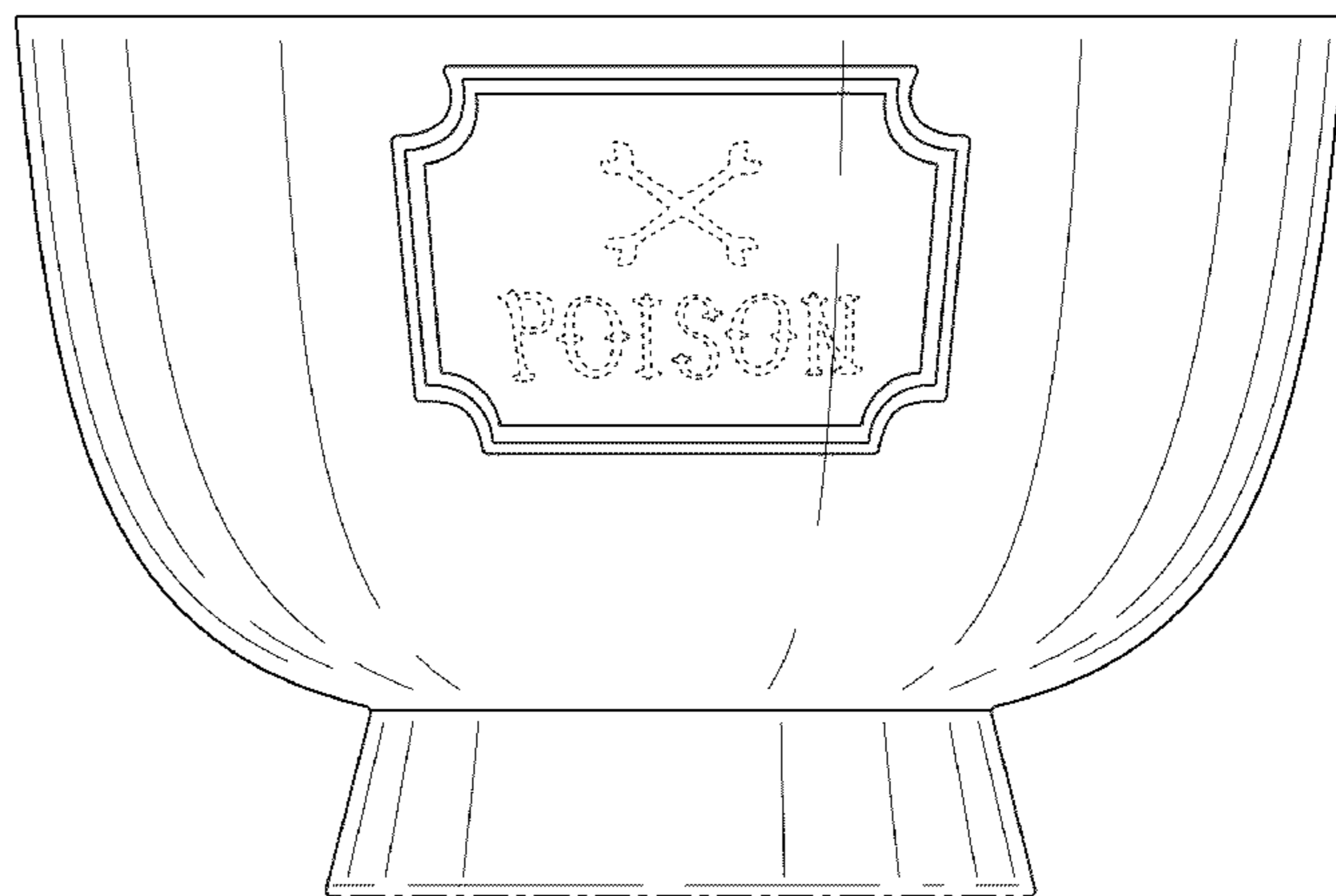
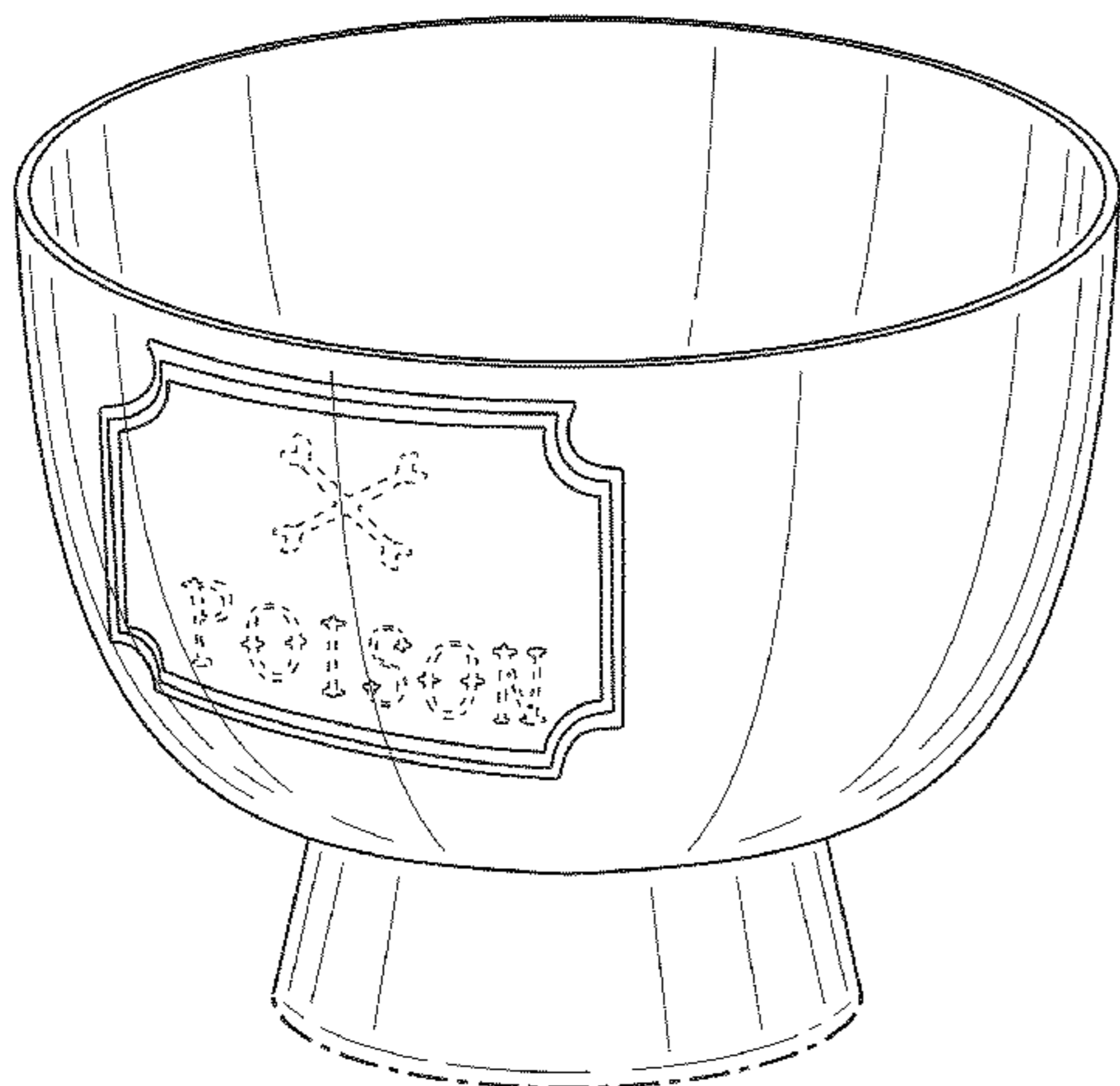
The features shown in broken lines are portions of the pedes-

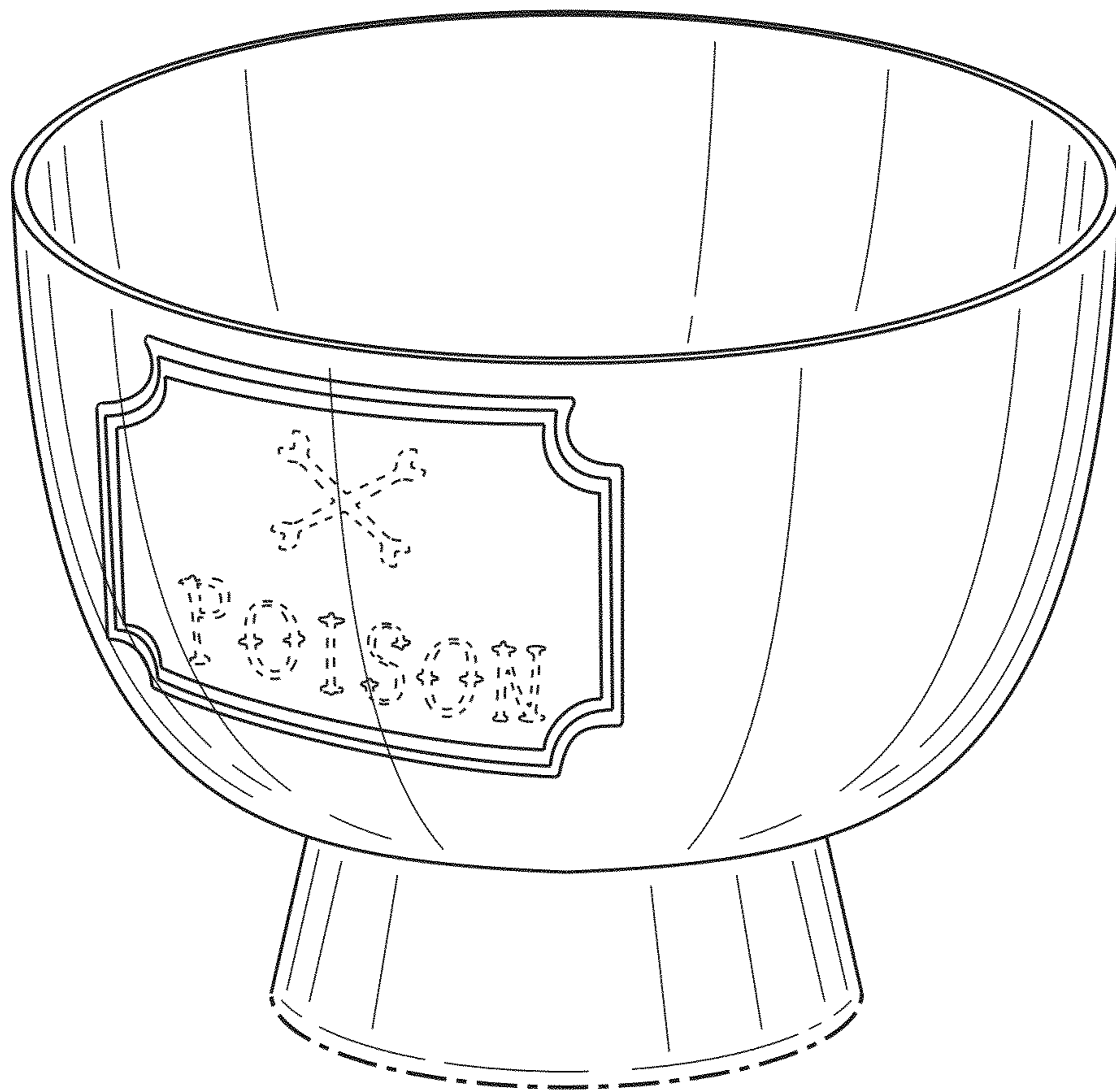

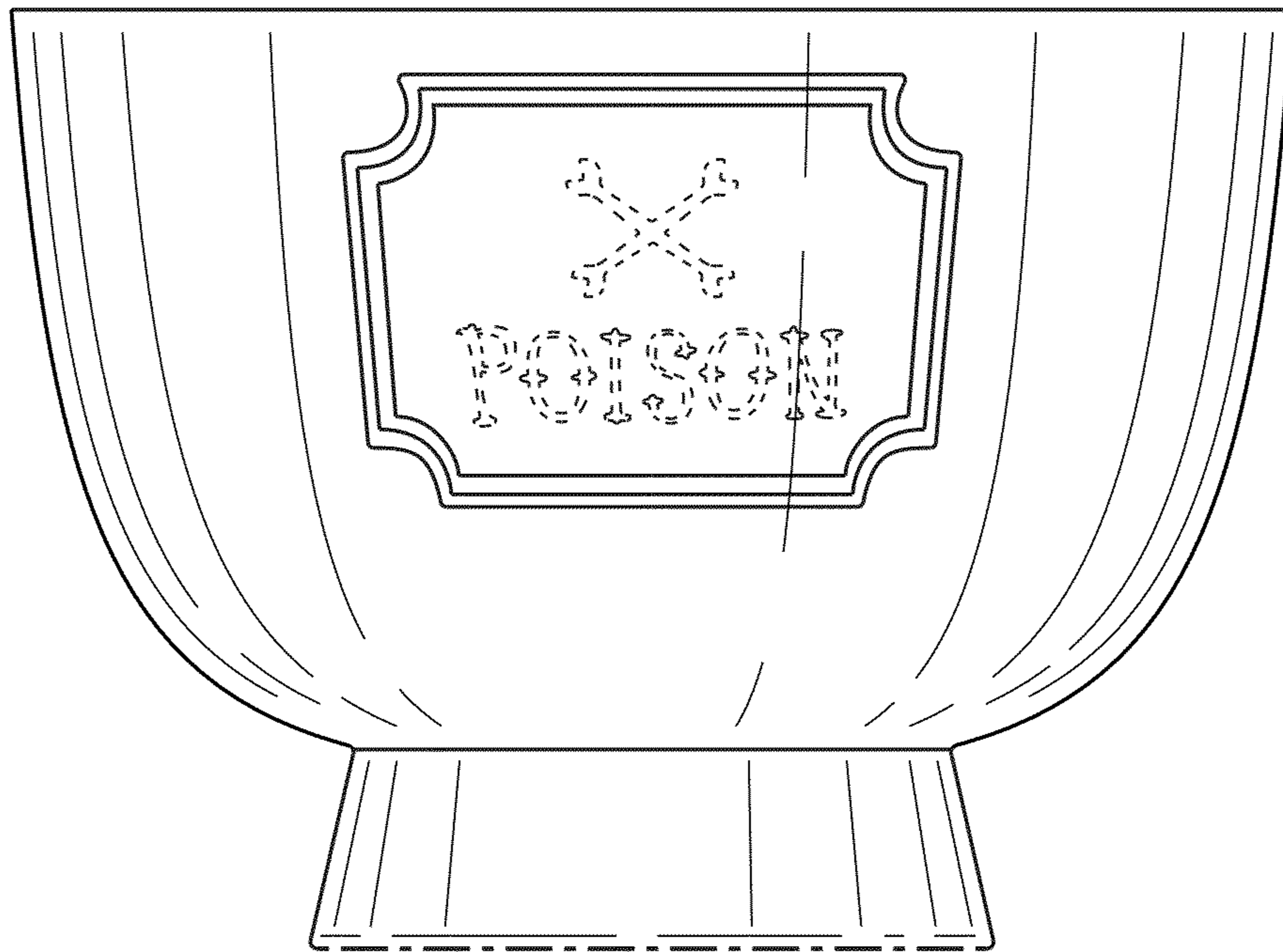

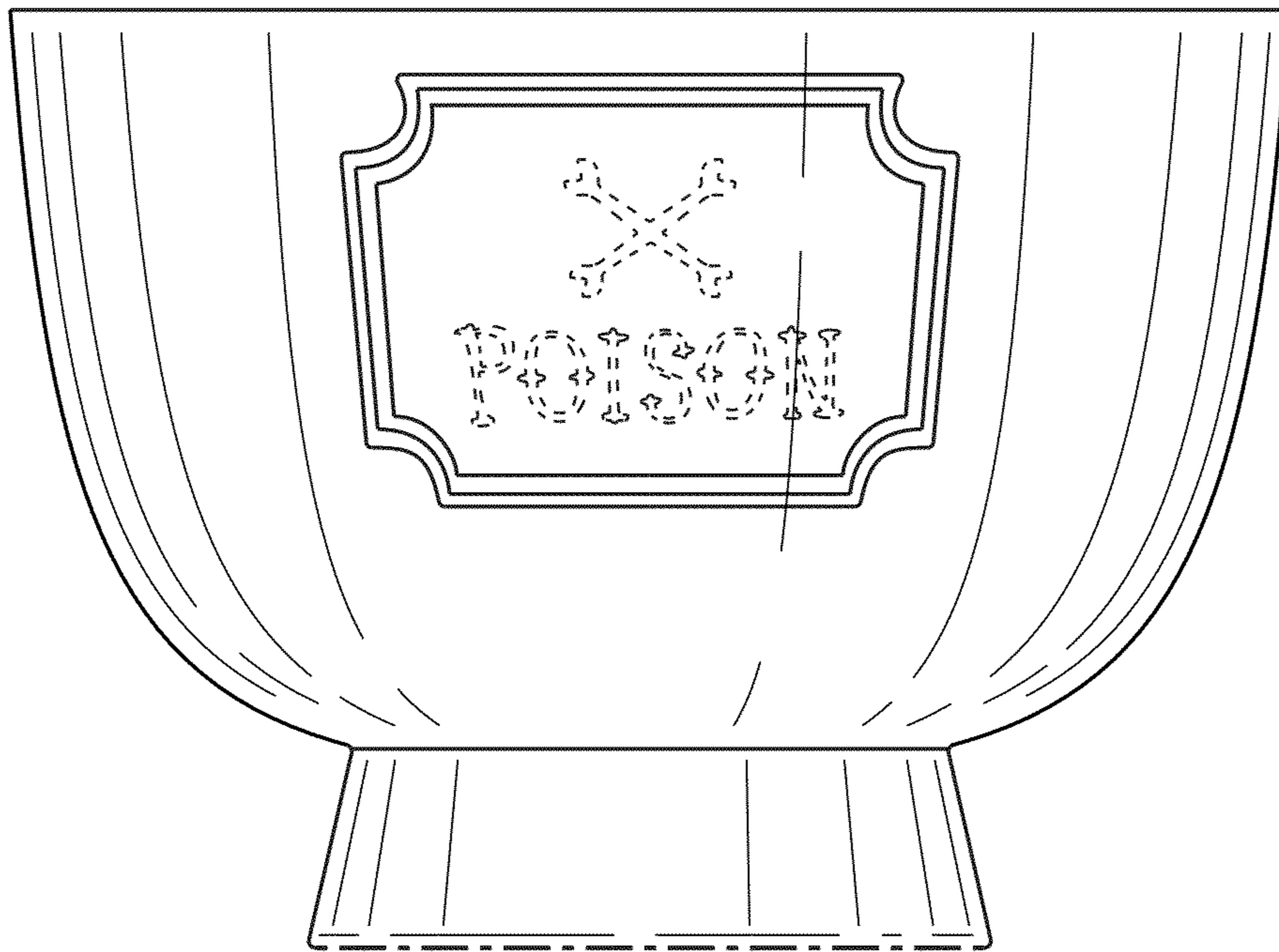

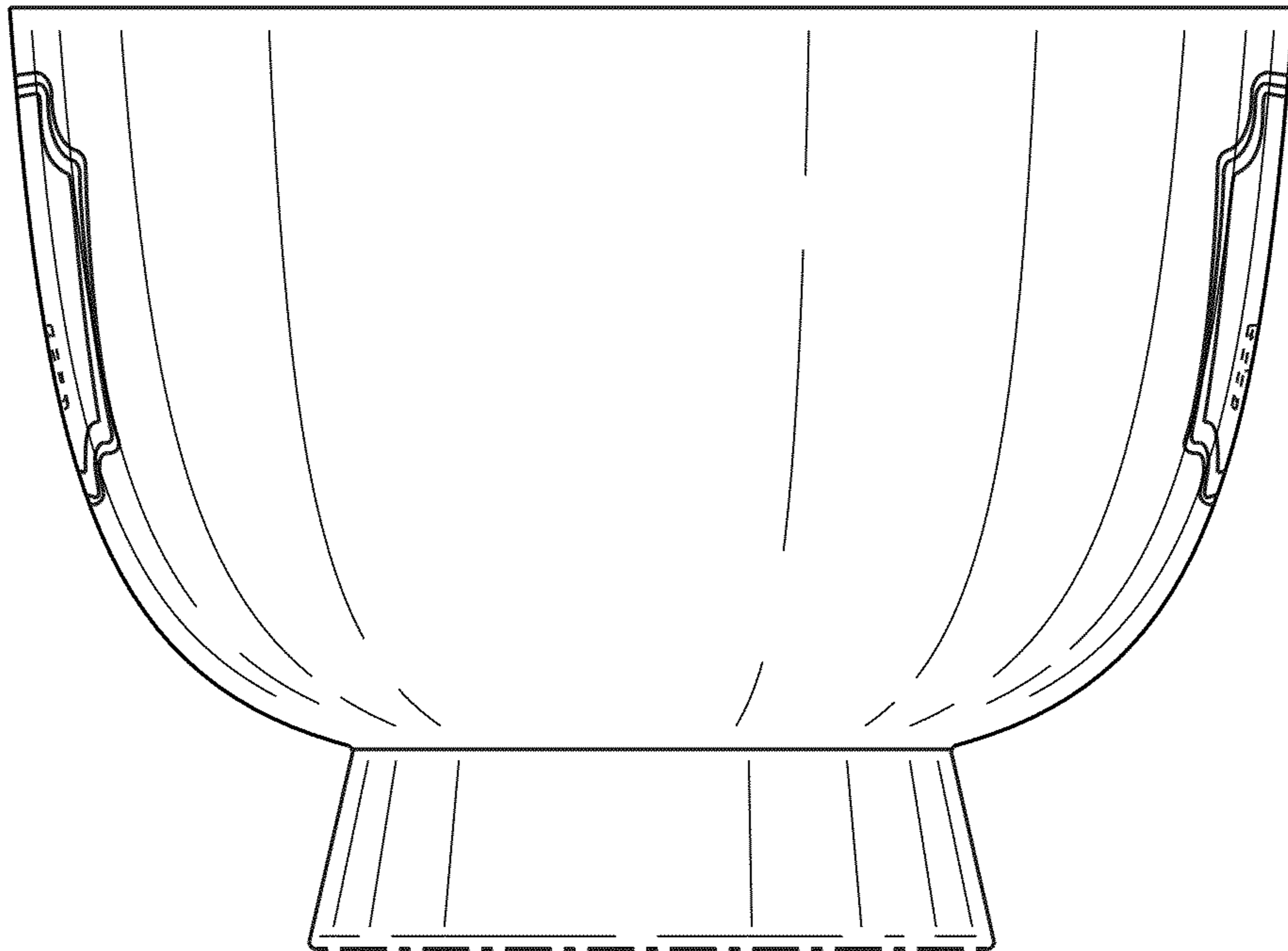

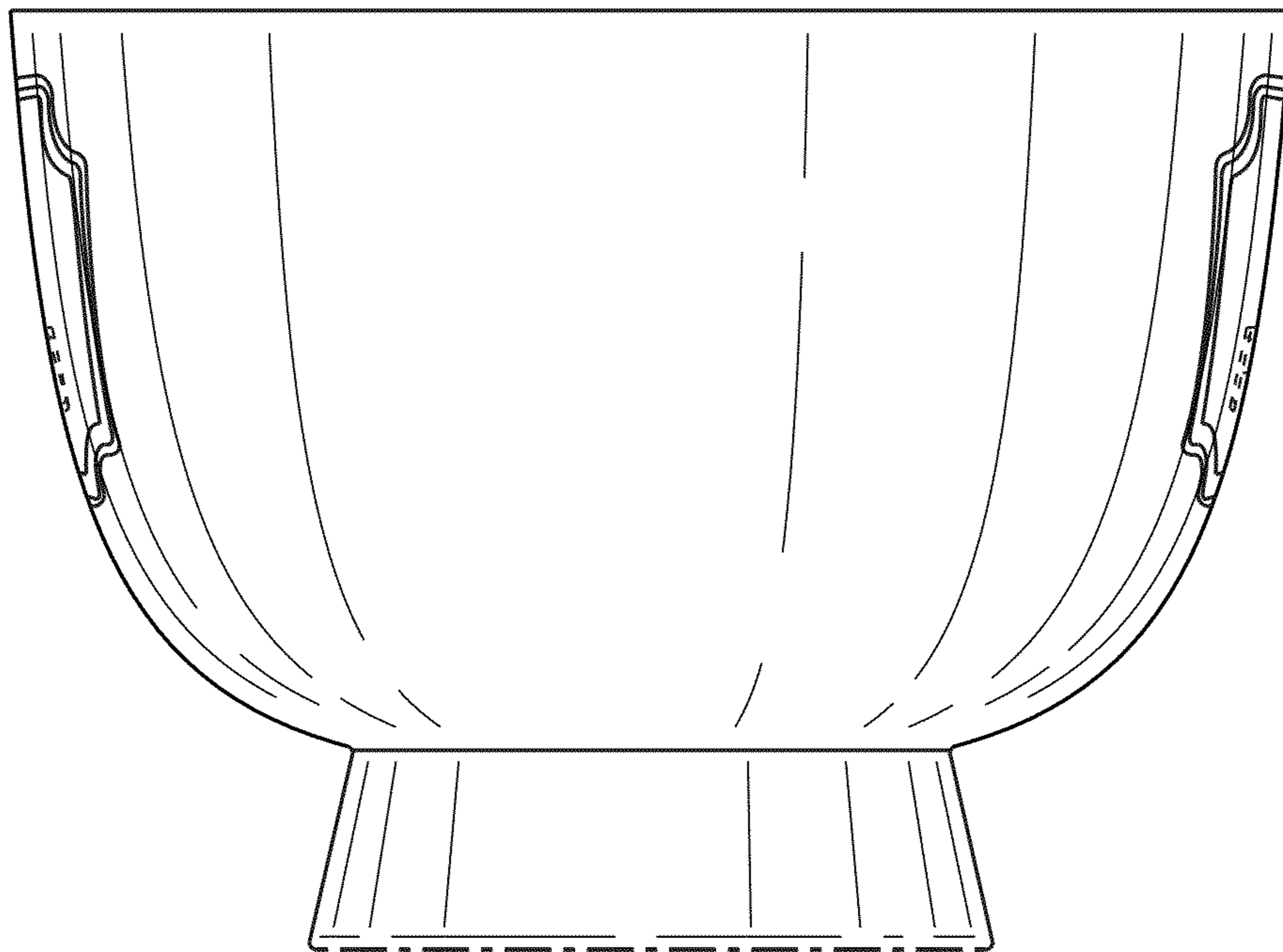

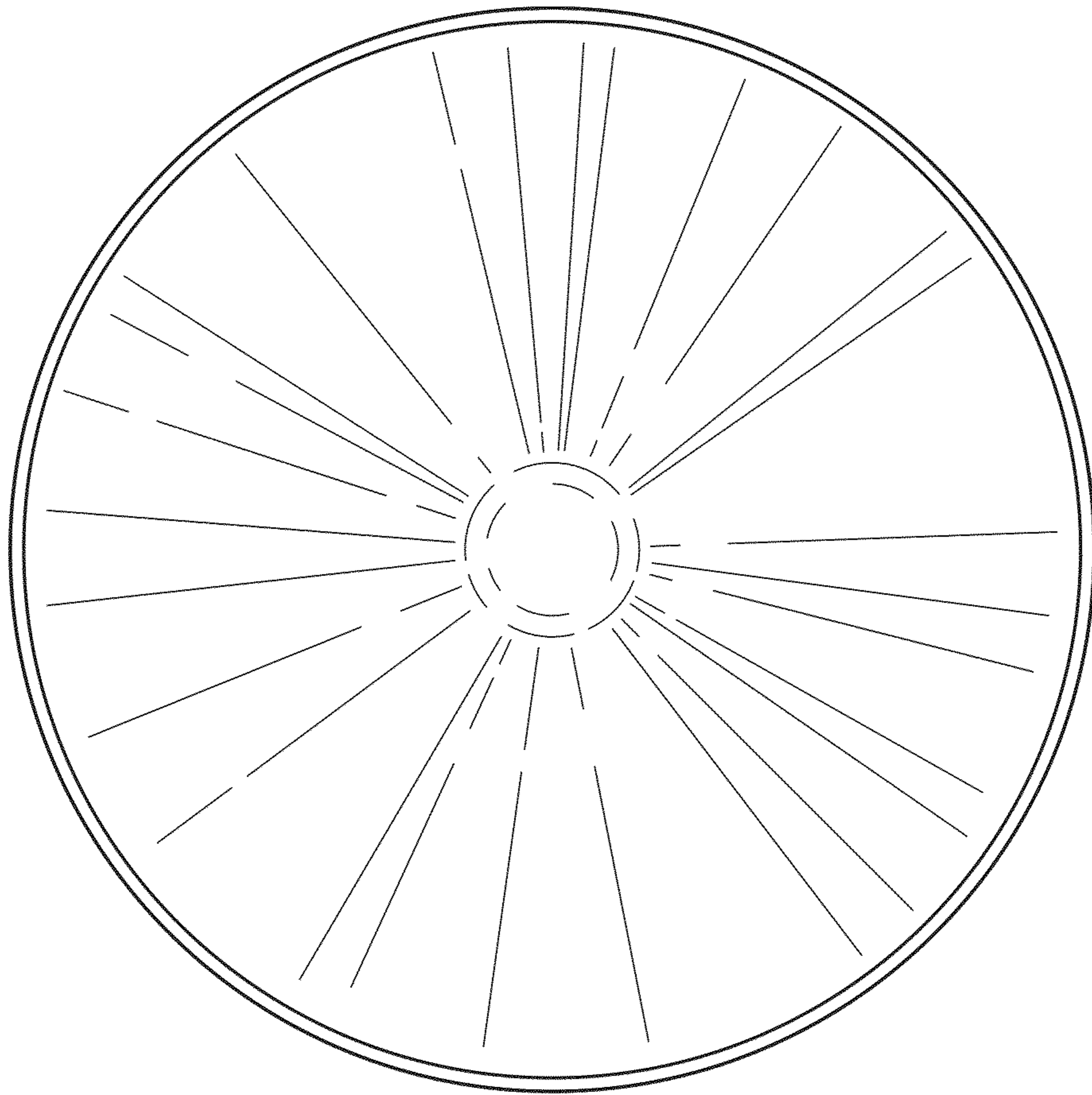

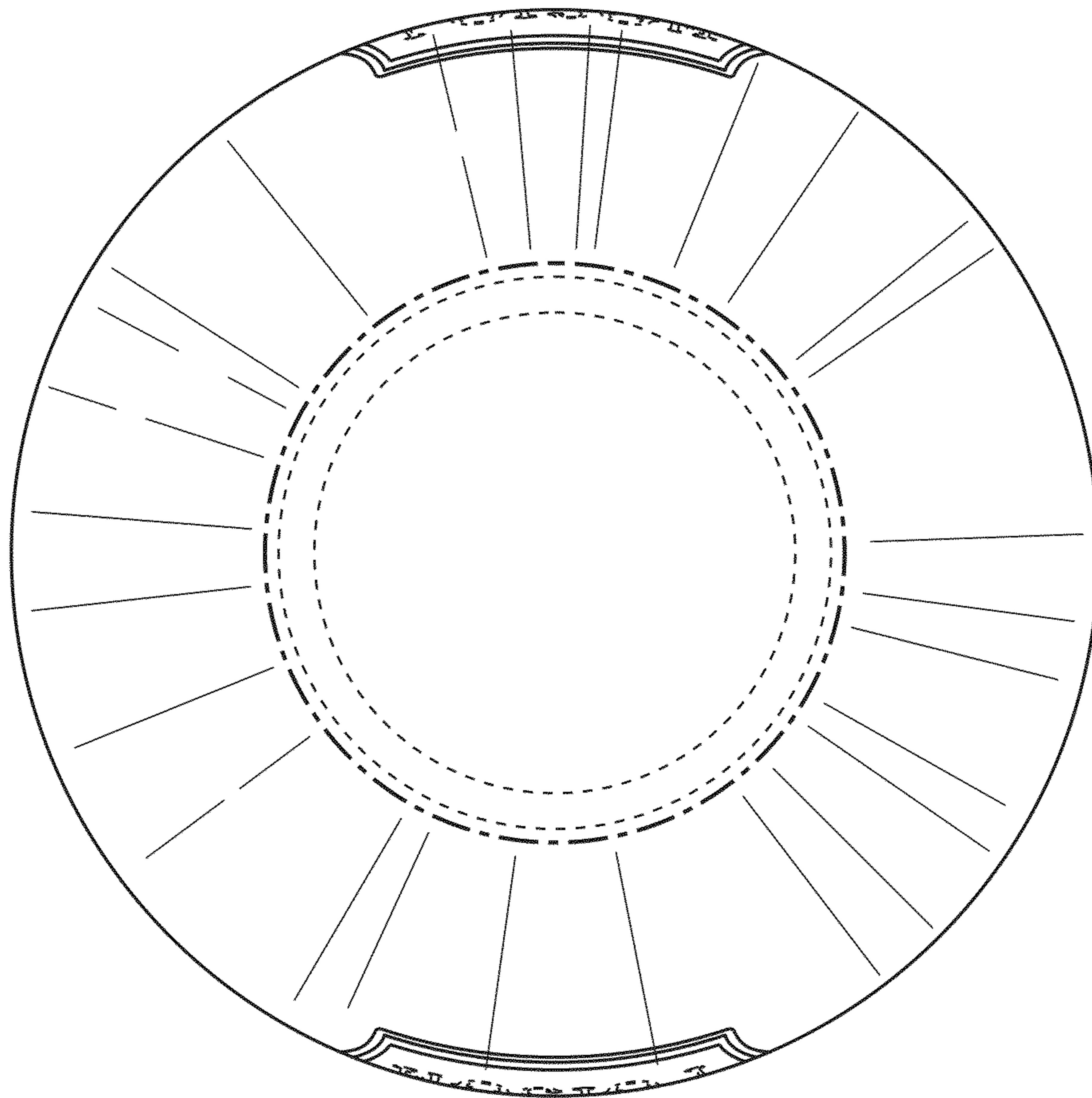

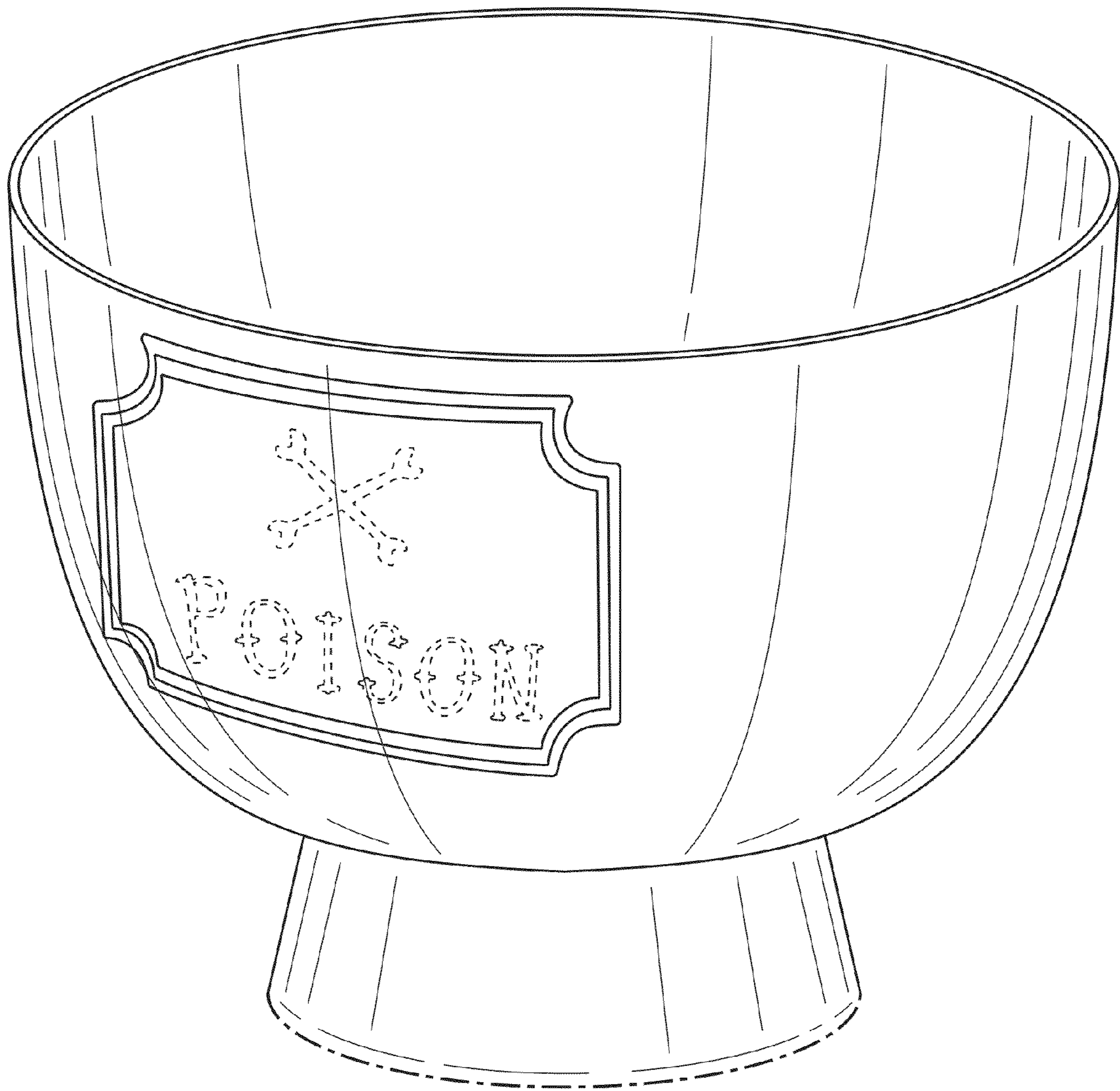

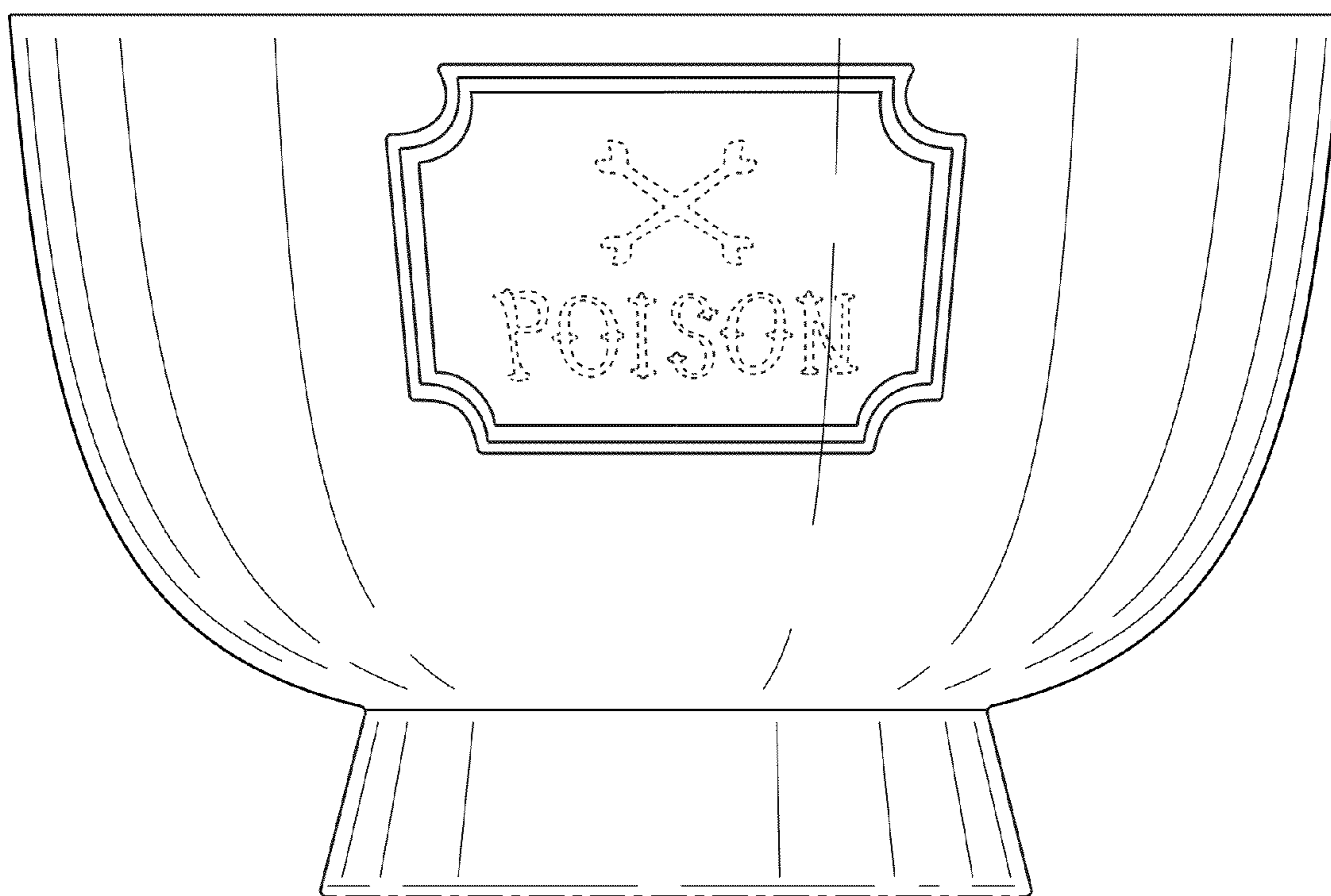

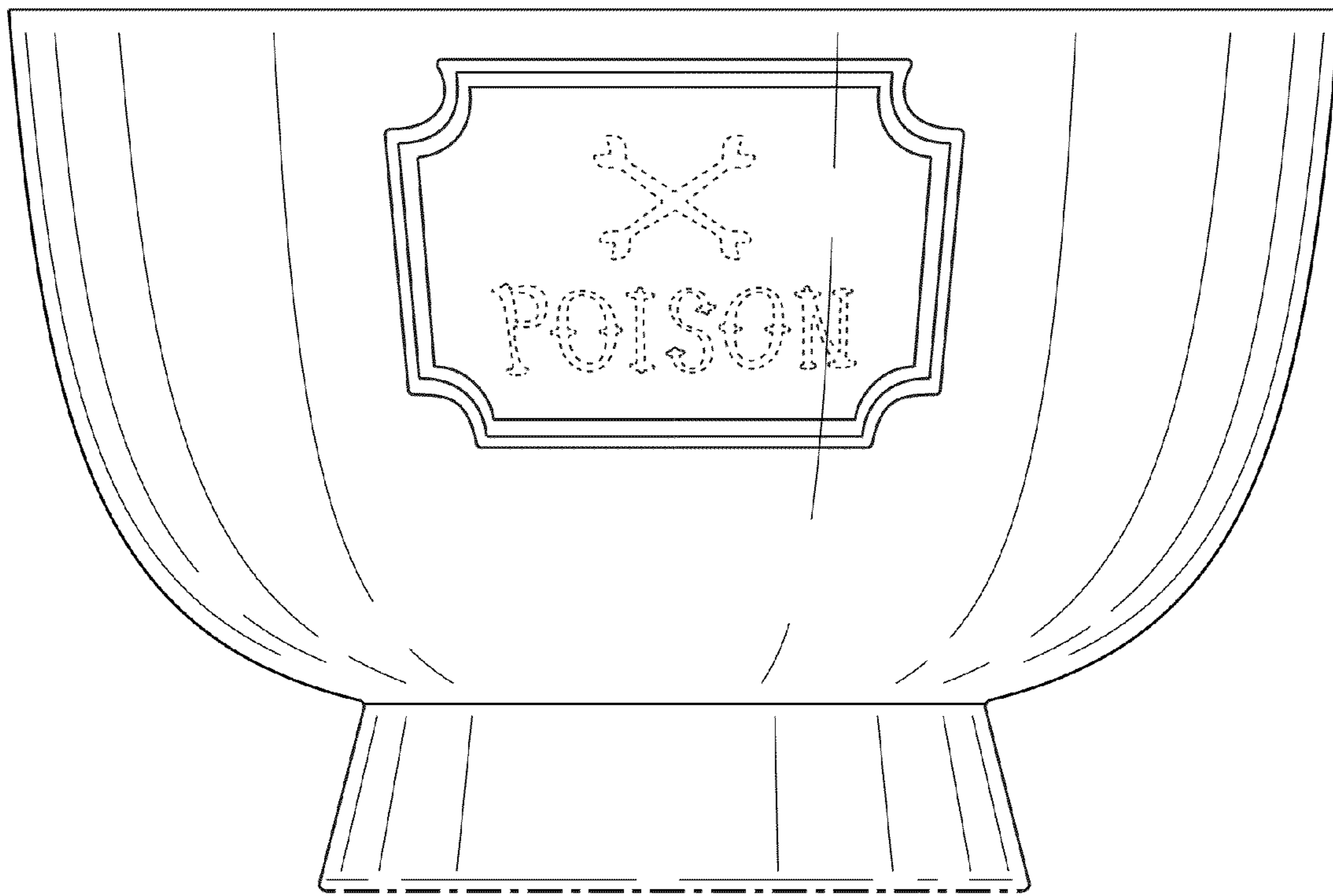

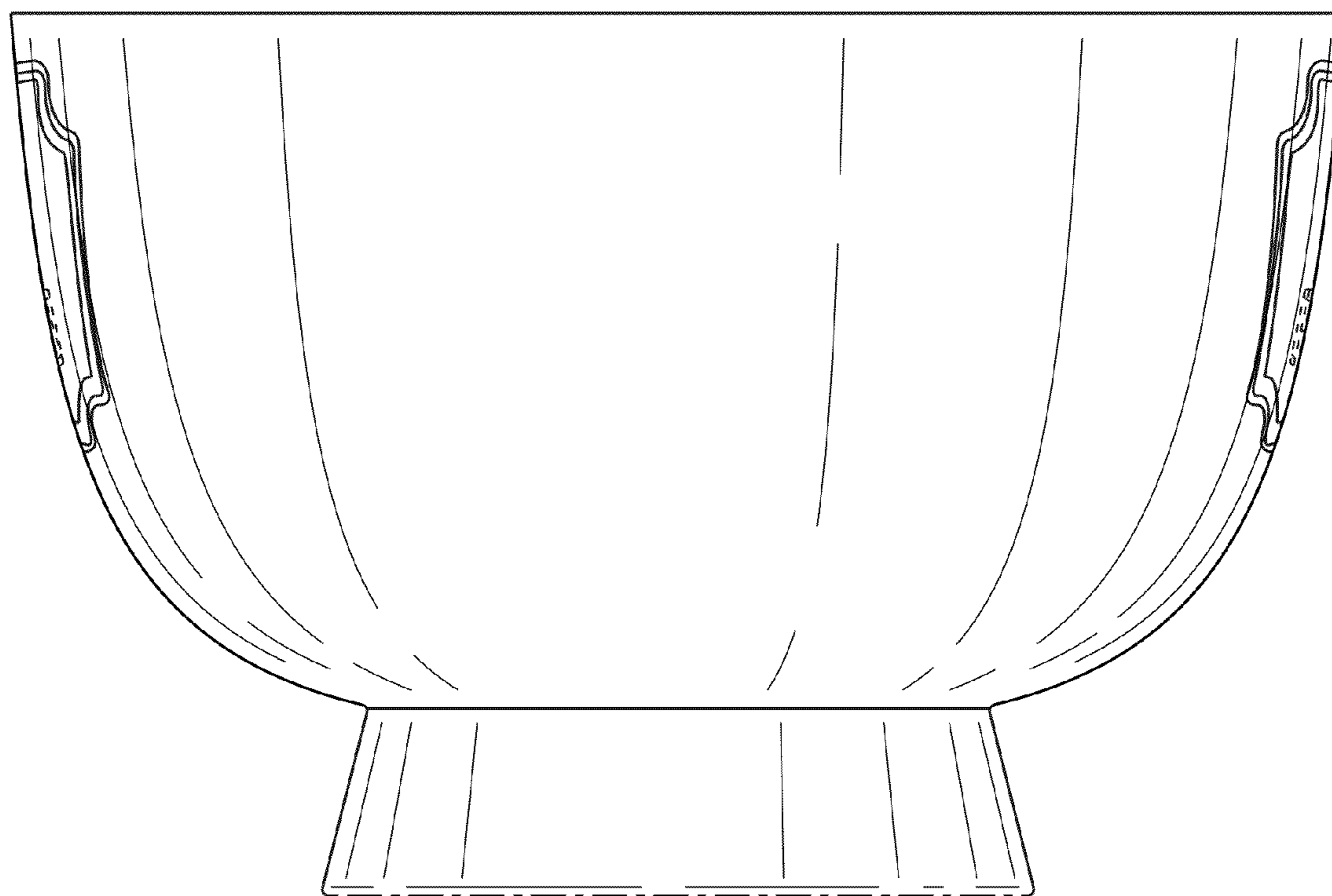

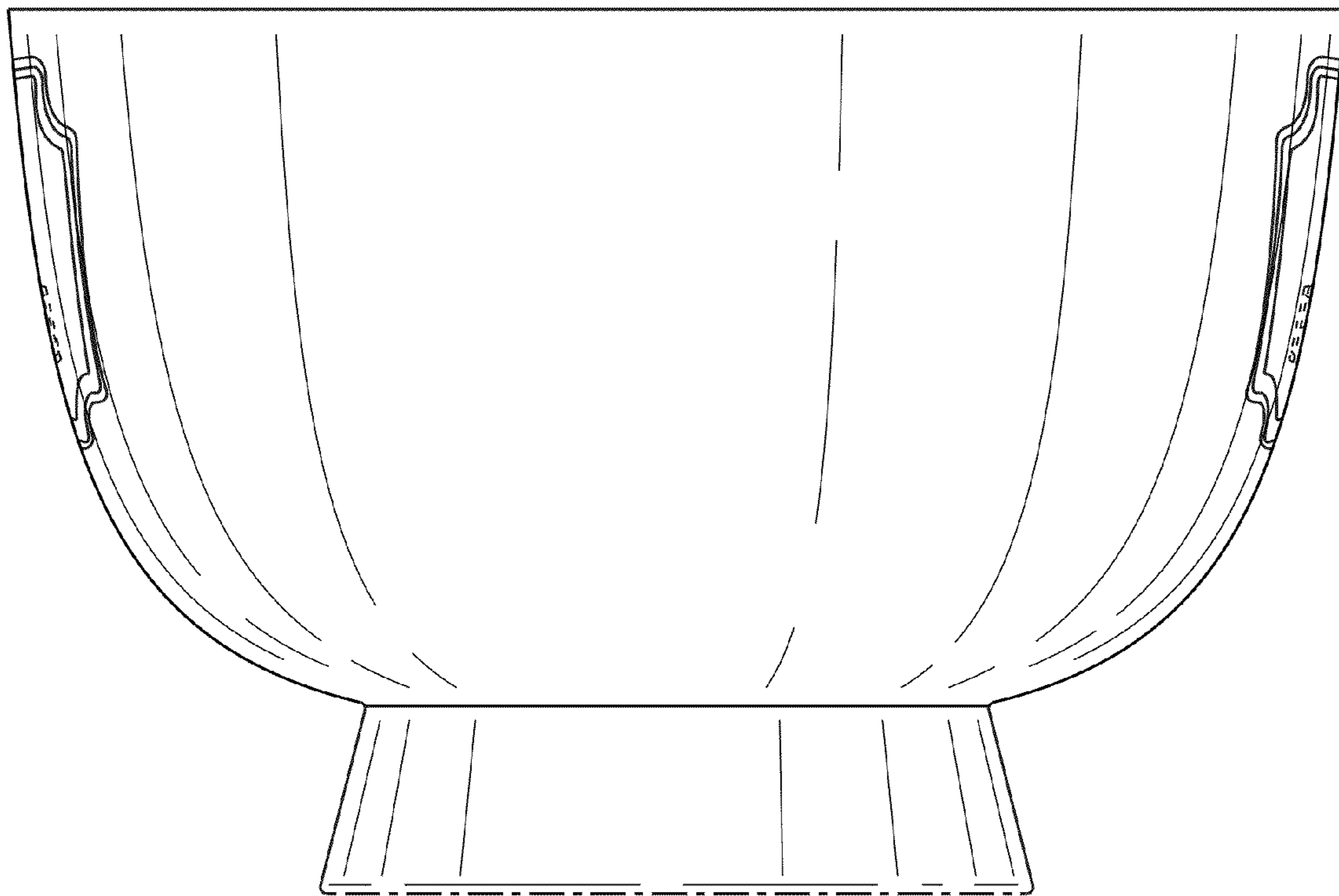

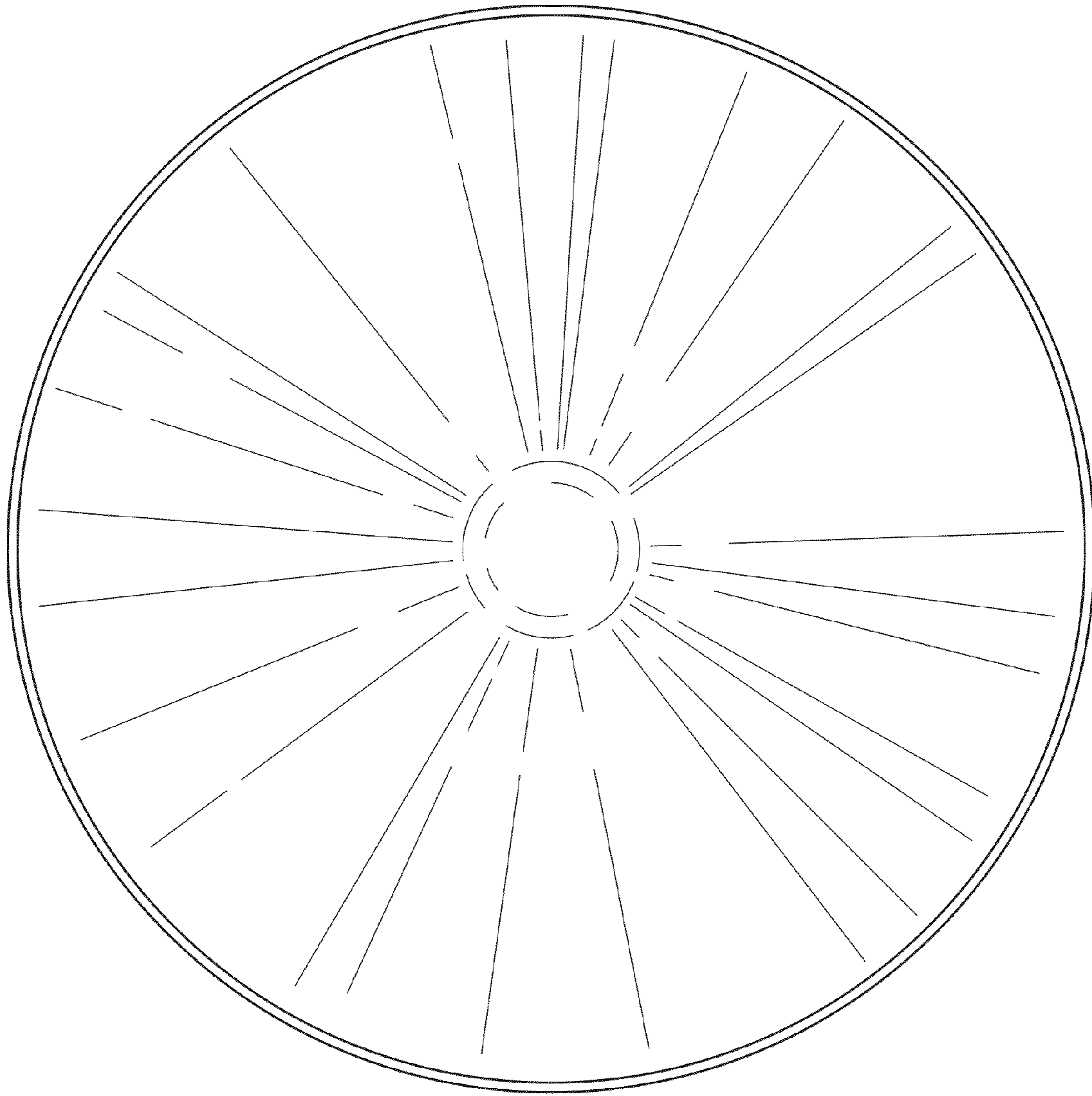

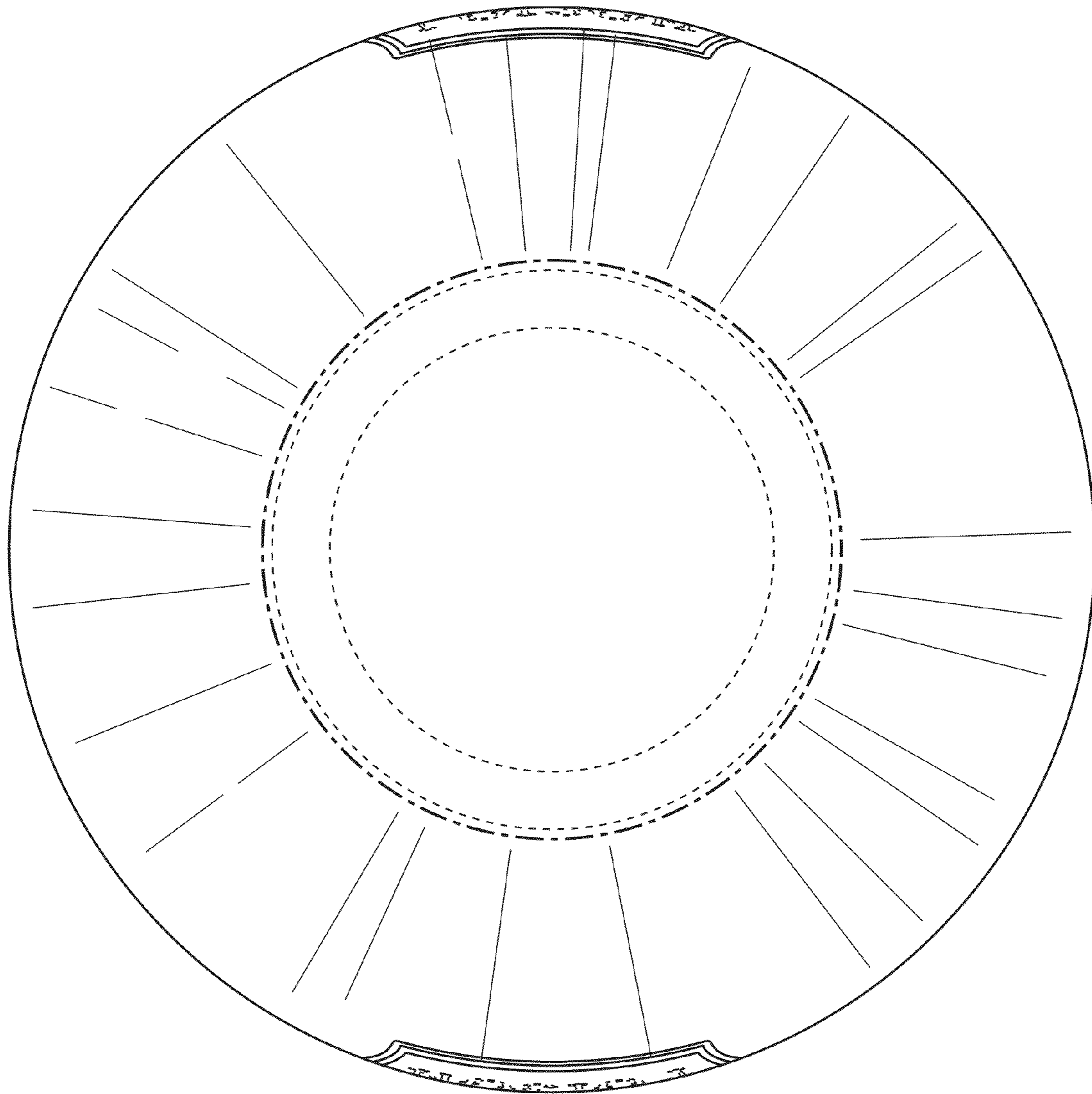
