(57) **CLAIM**

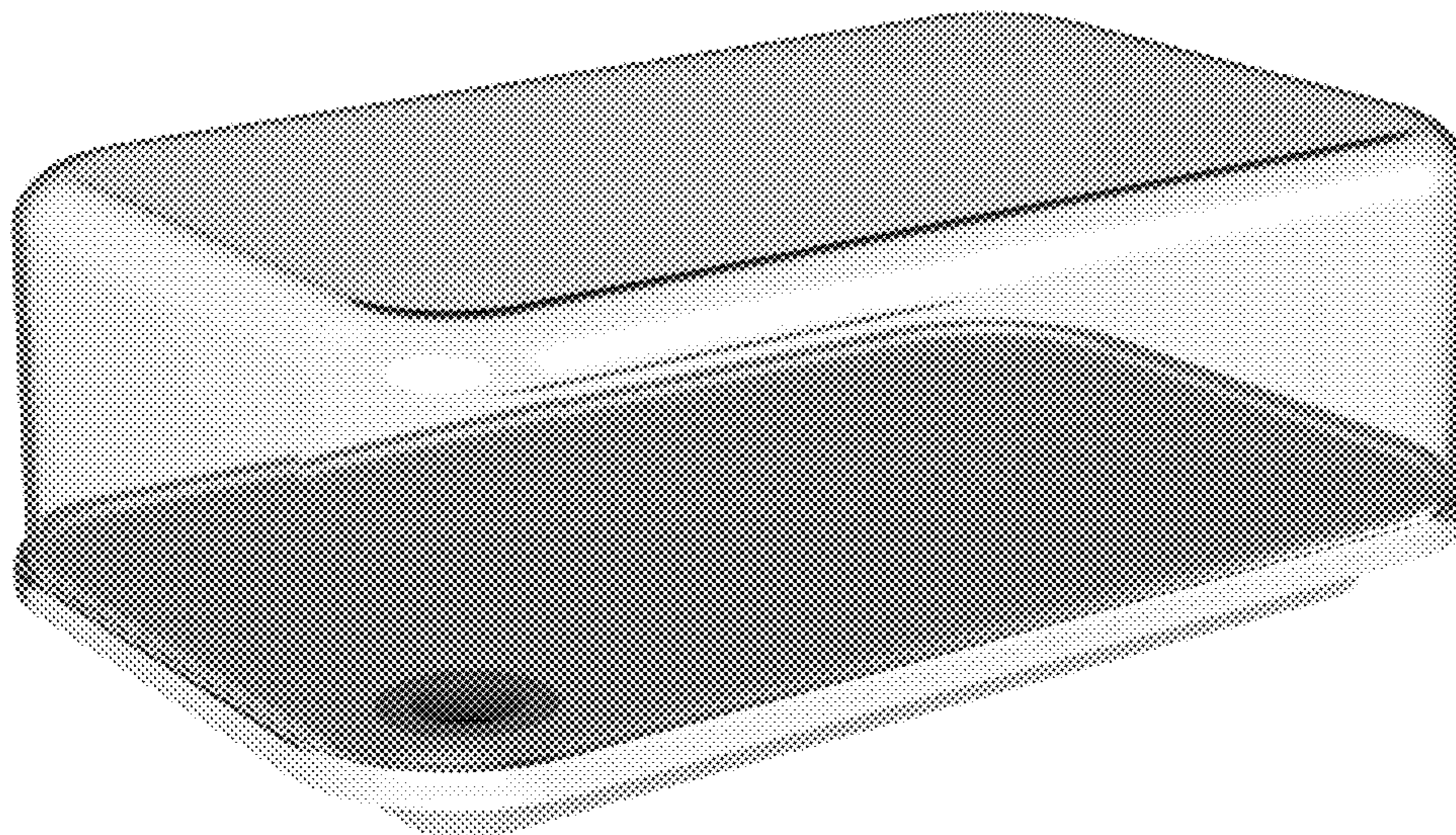
The ornamental design for a cutting tray with cover (modula dome), as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a cutting tray with cover (modula dome);
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is an exploded perspective view thereof;
FIG. 4 is a front view (with the back side view being a mirror image thereof);
FIG. 5 is a left side view (with the right side view being a mirror image thereof);
FIG. 6 is a top view thereof, shown without cover; and,
FIG. 7 is bottom view thereof.

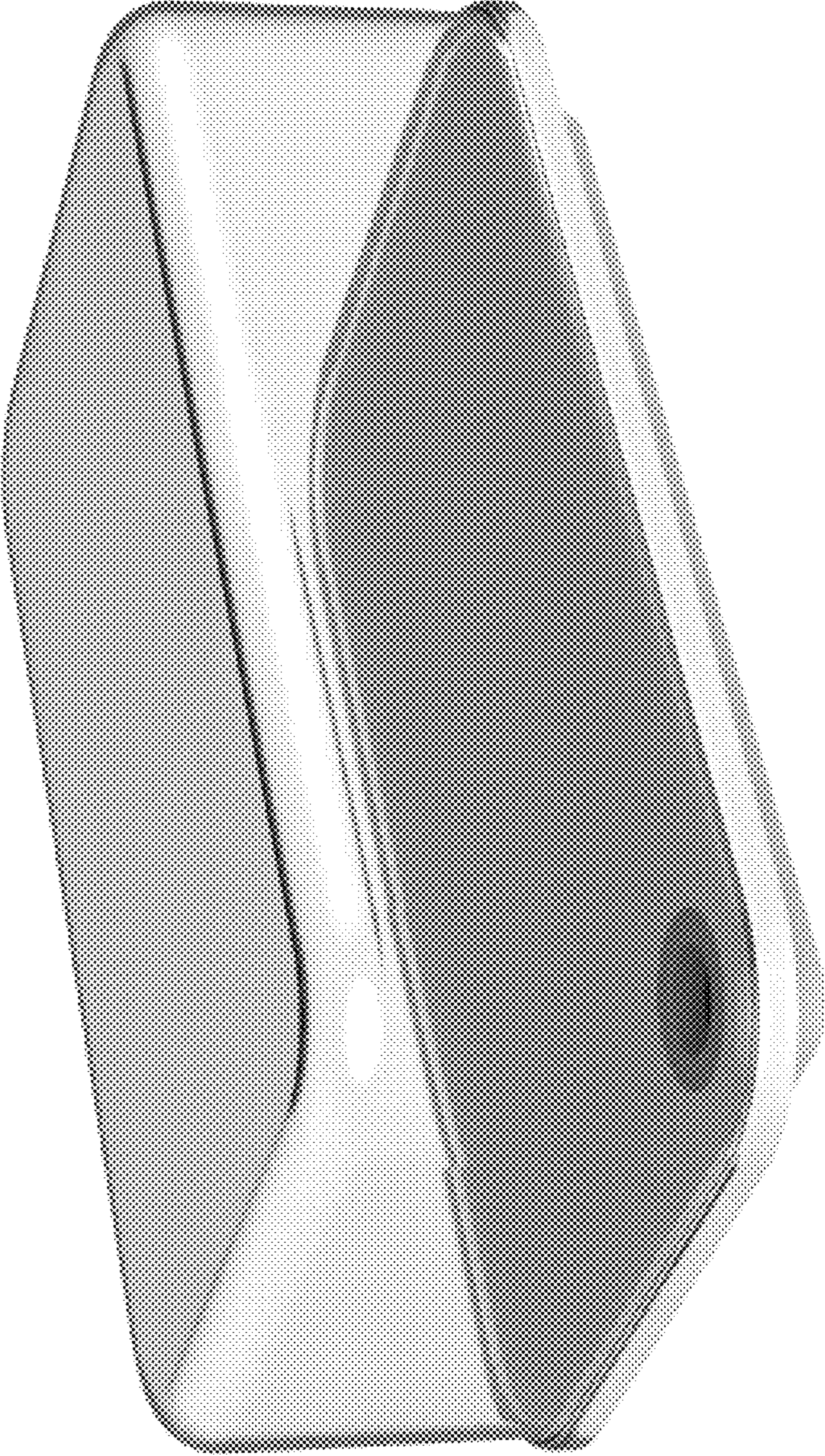

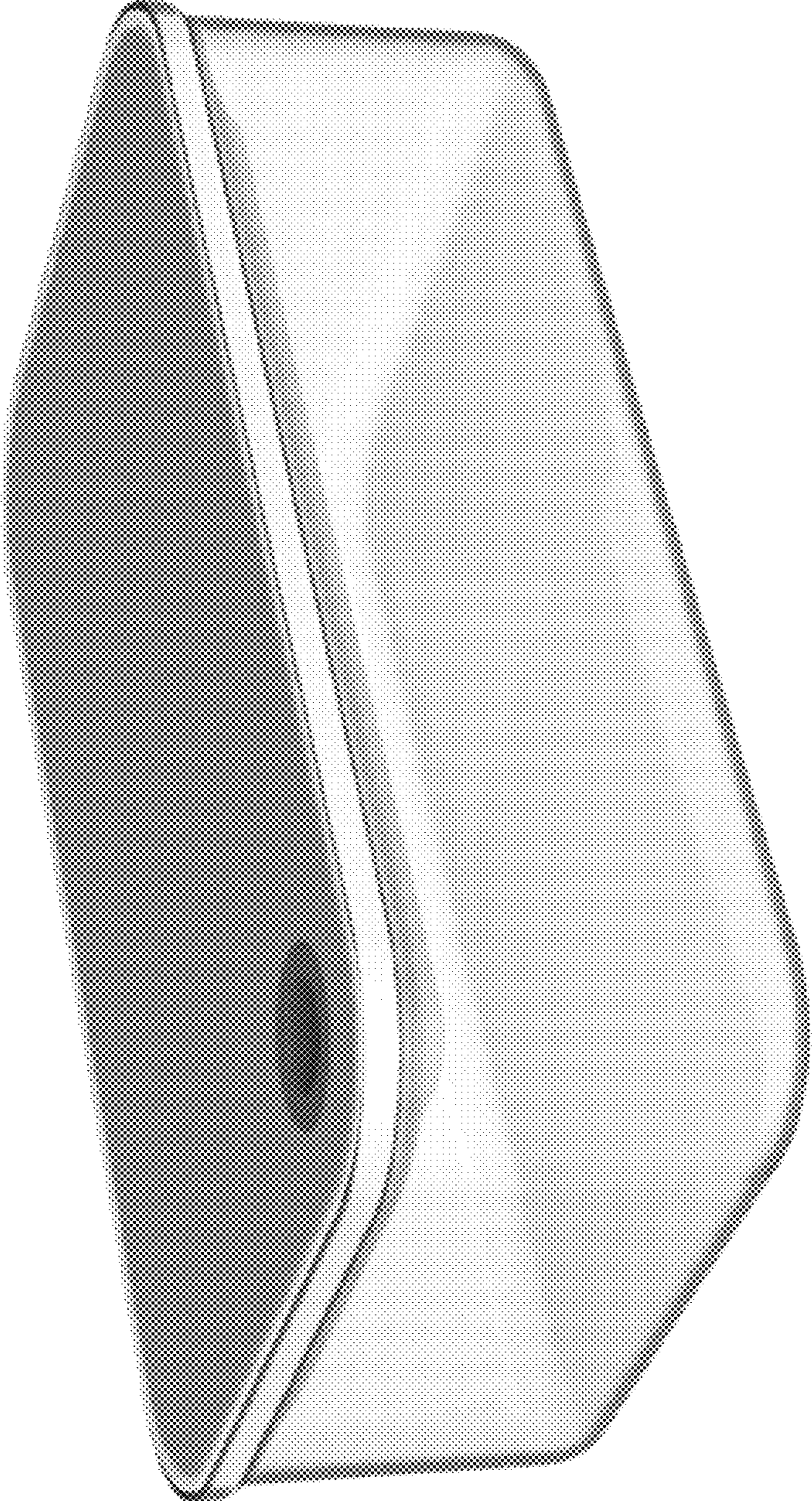

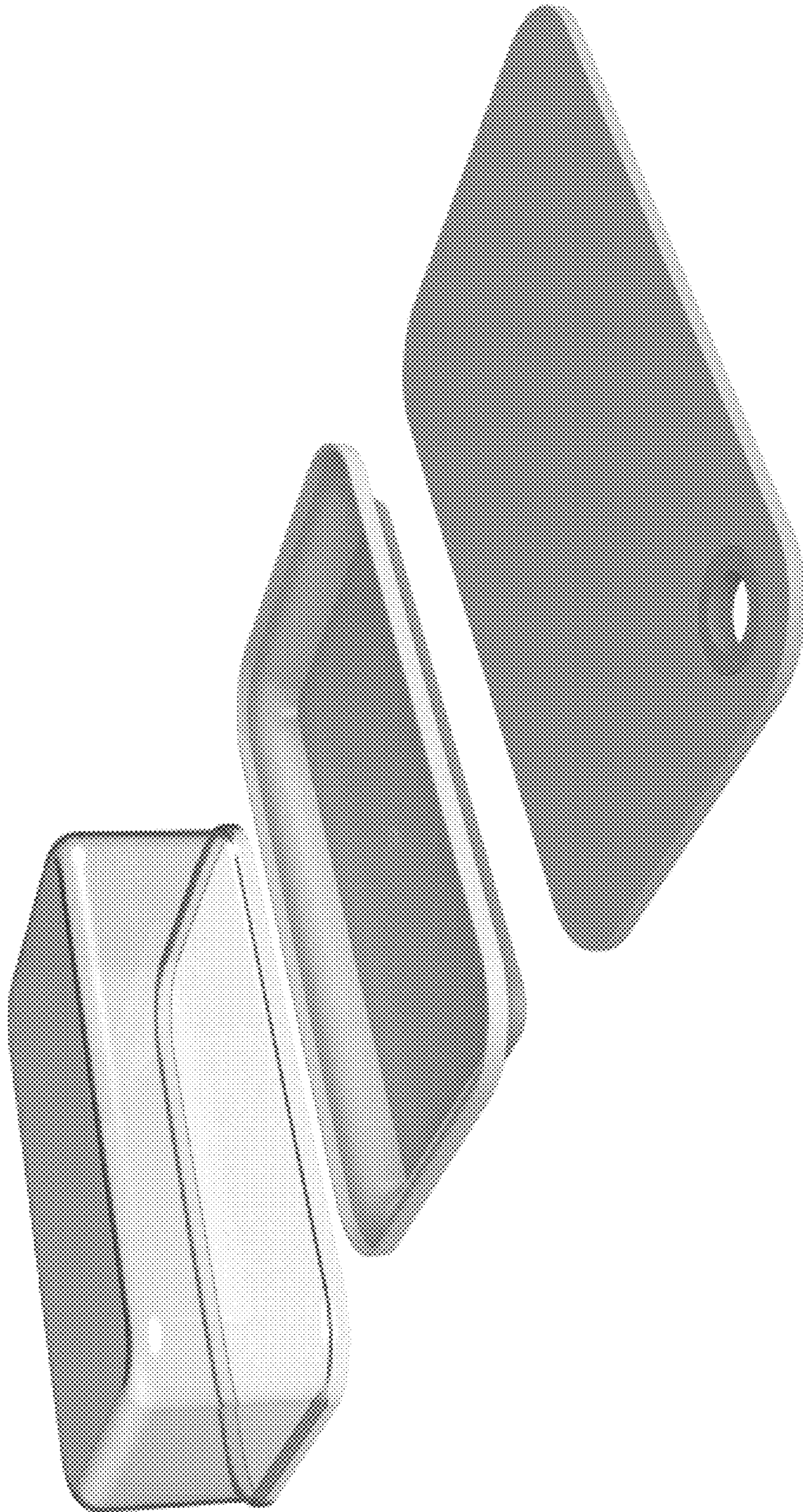

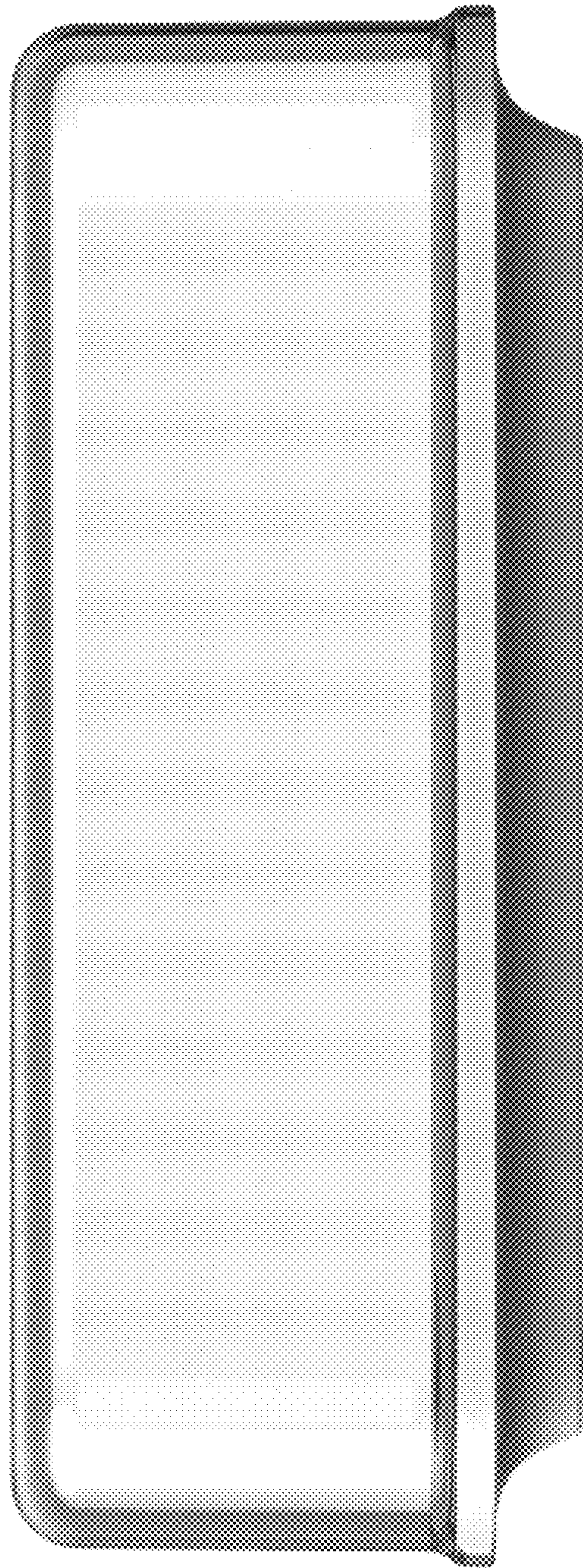

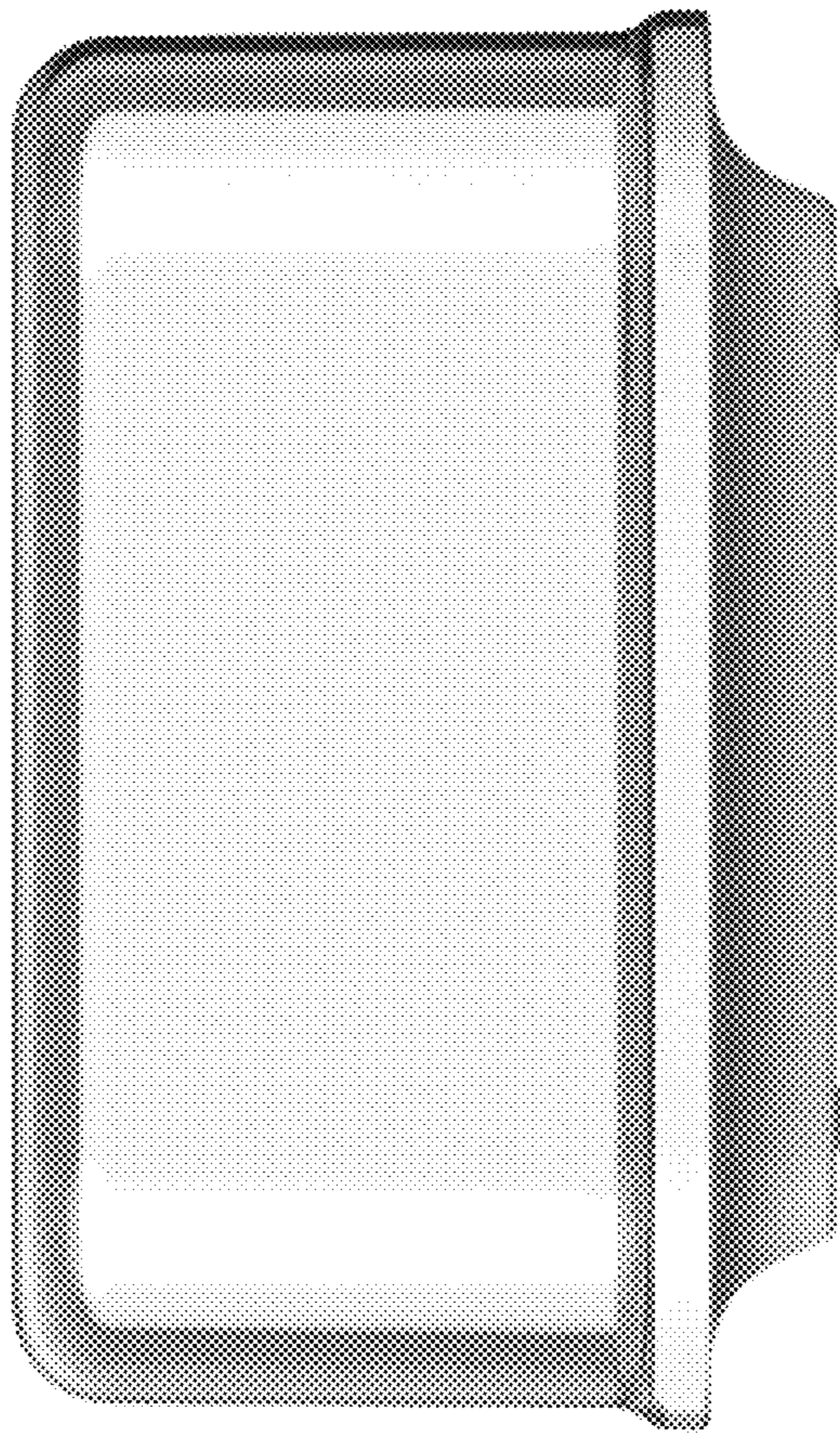

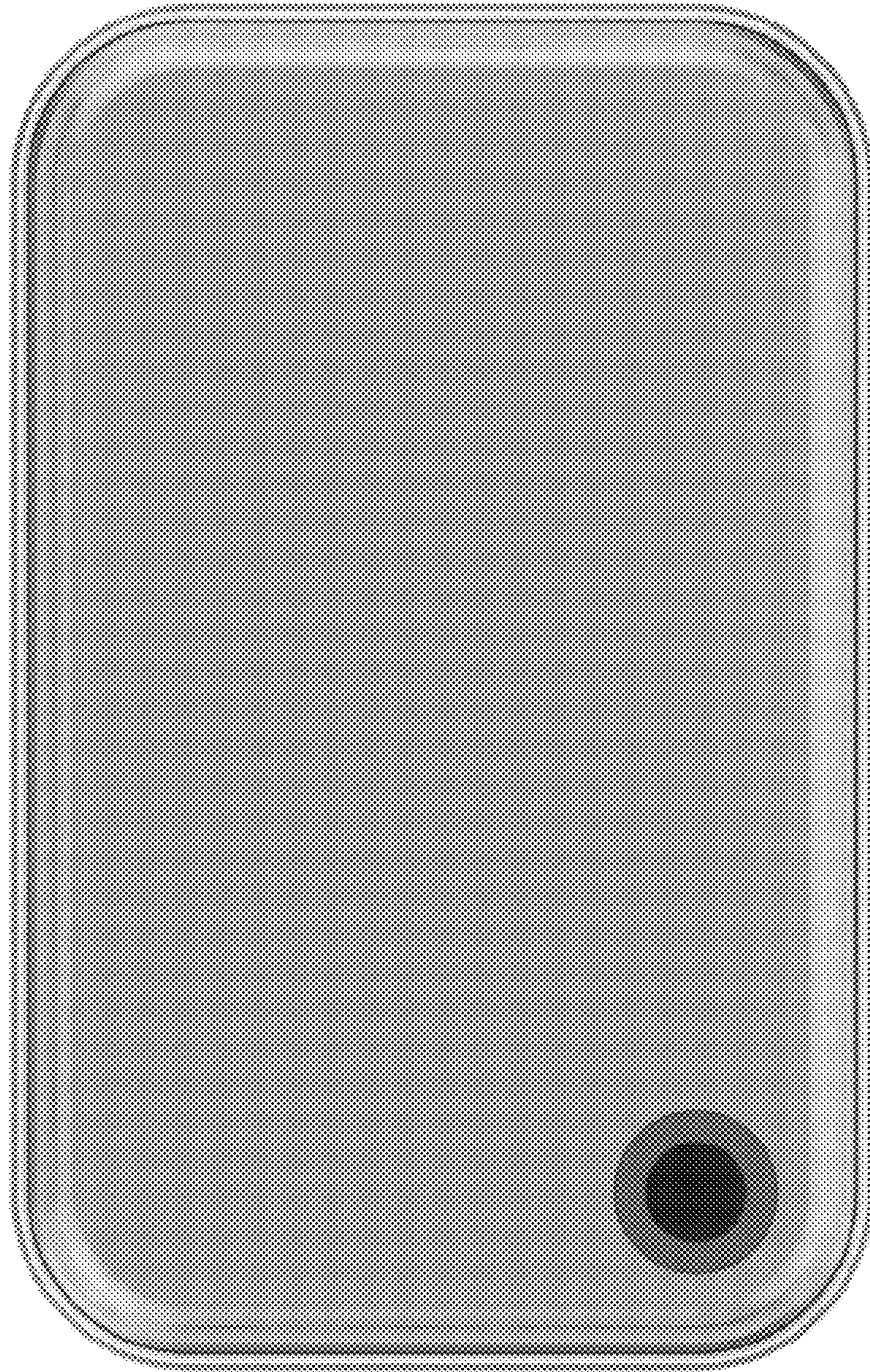

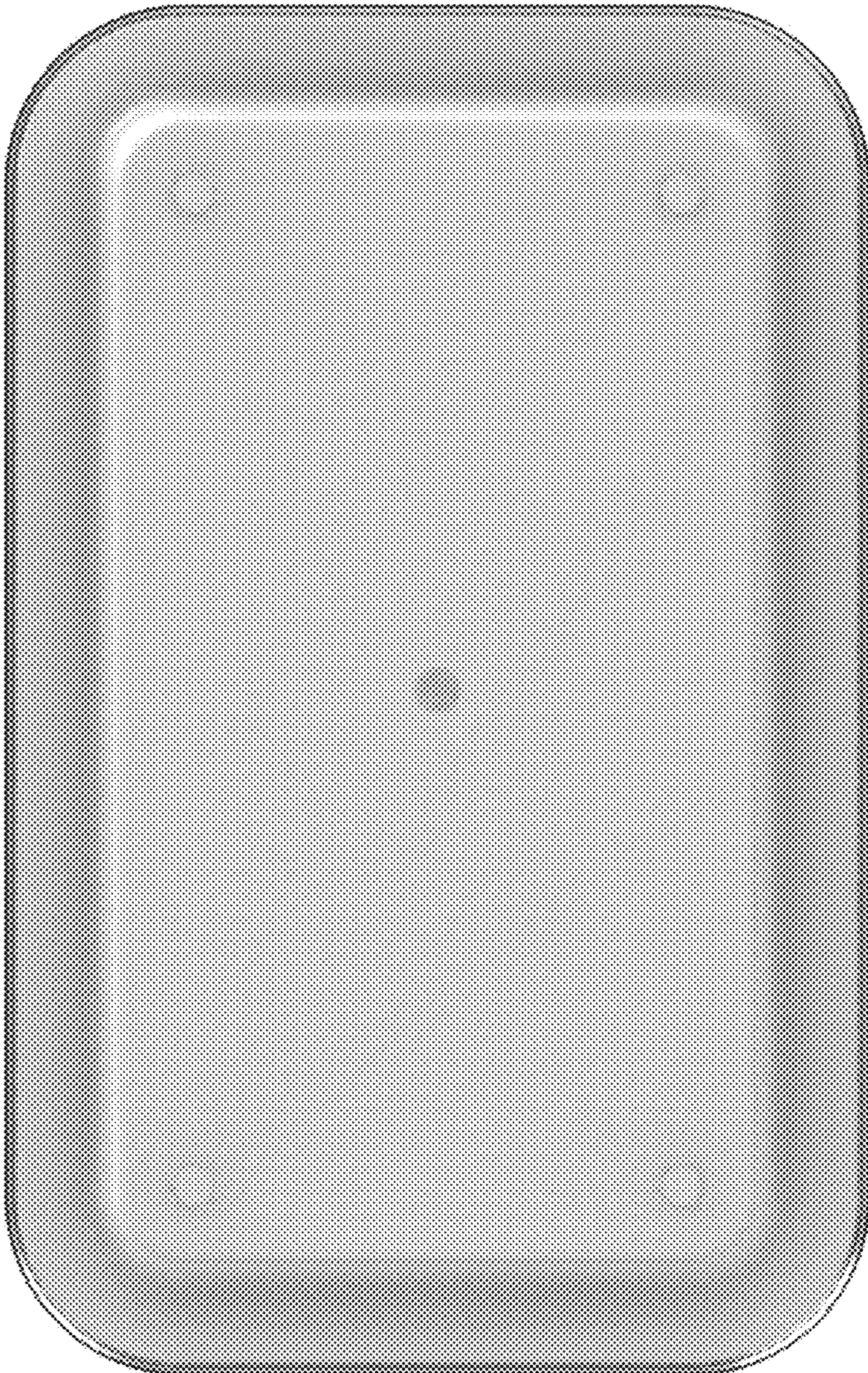
