FIG. 5 is a front view of the gun tool; the broken lines in the drawings depict parts of the gun tool that form no part of the claimed design; and,

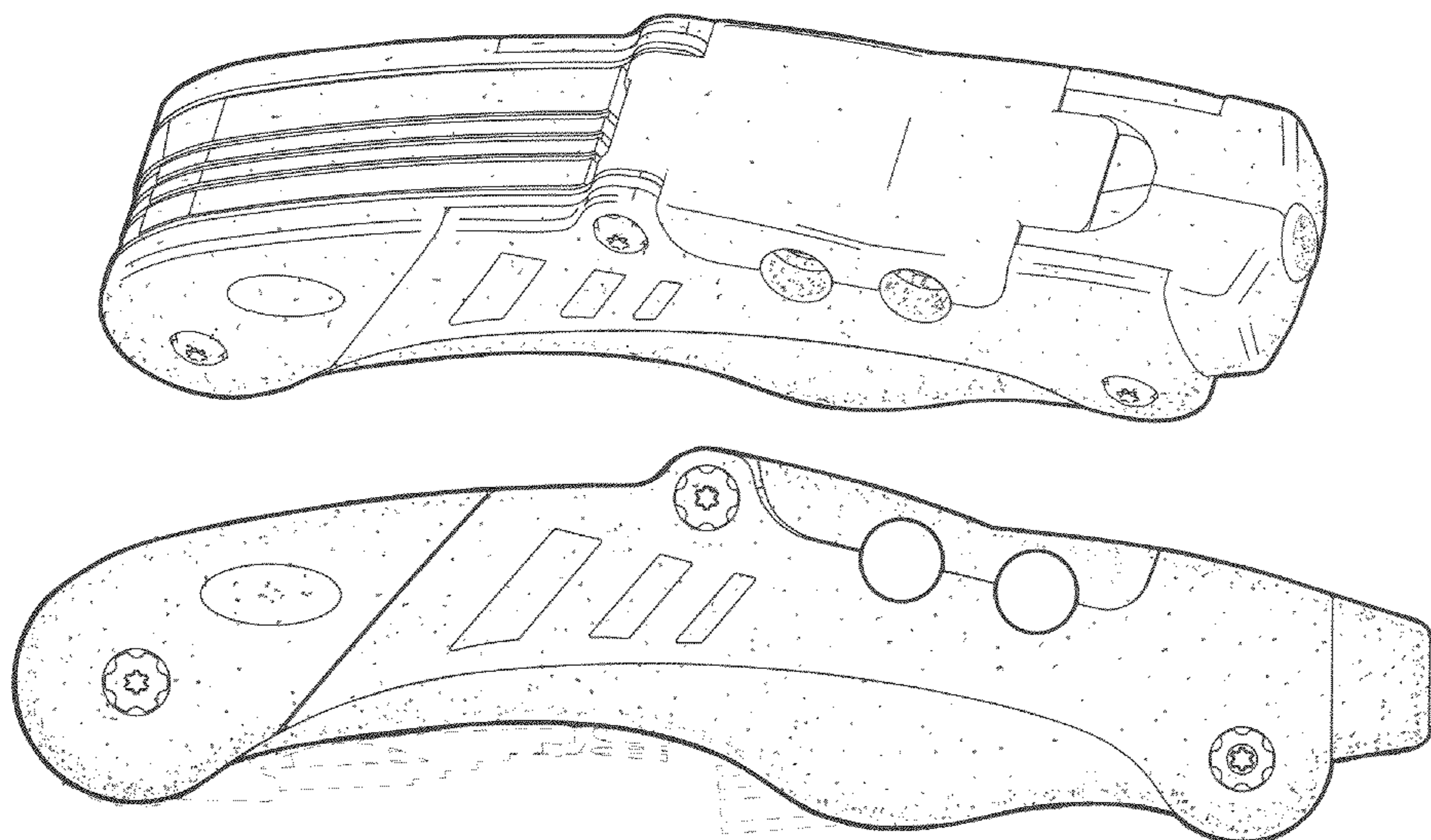
FIG. 6 is a rear view of the gun tool; the broken lines in the drawings depict parts of the gun tool that form no part of the claimed design.

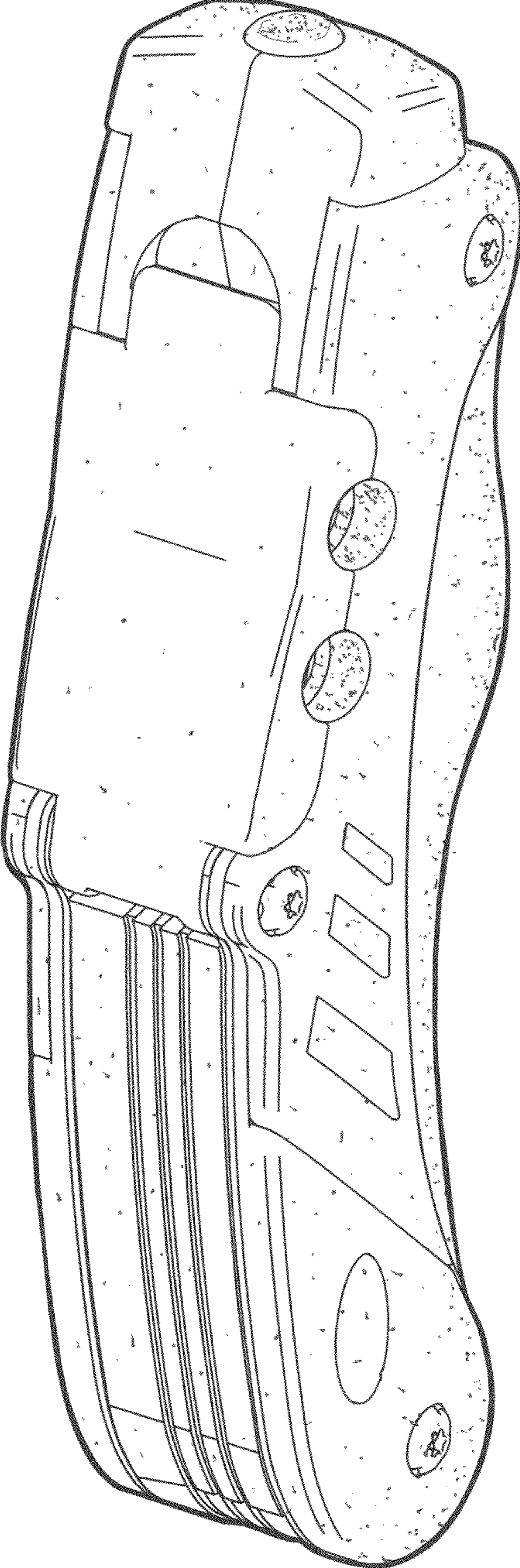

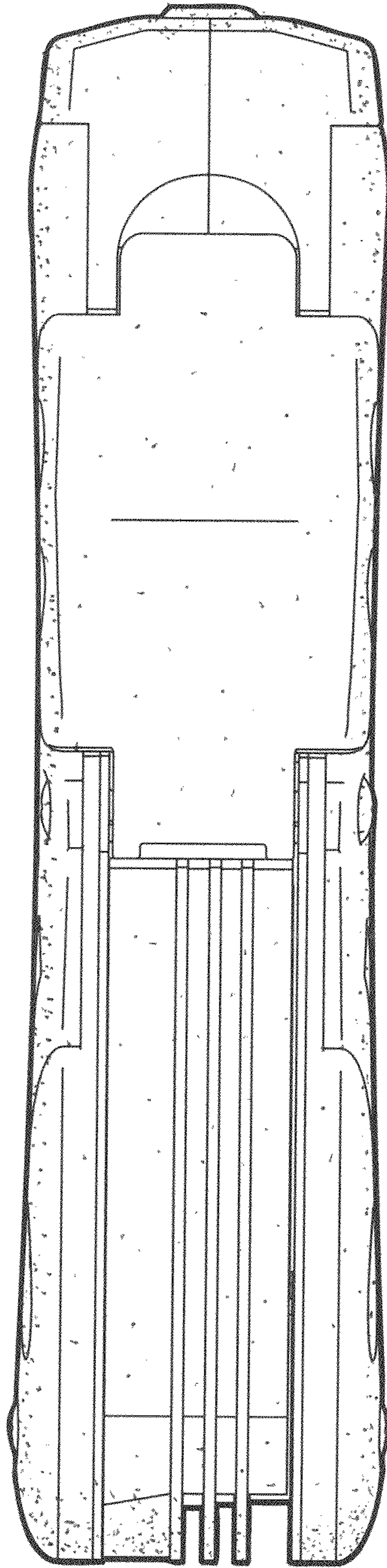

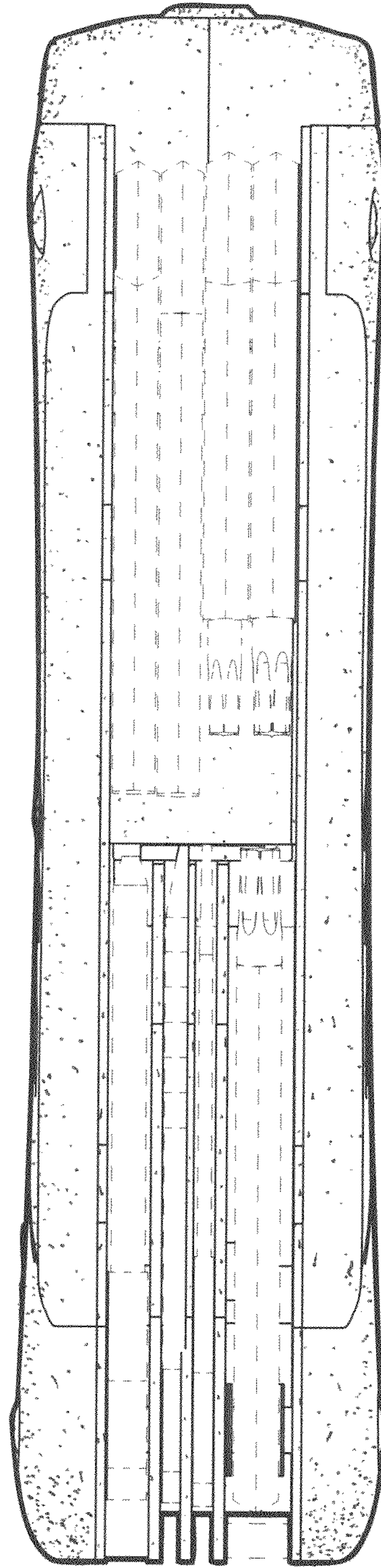

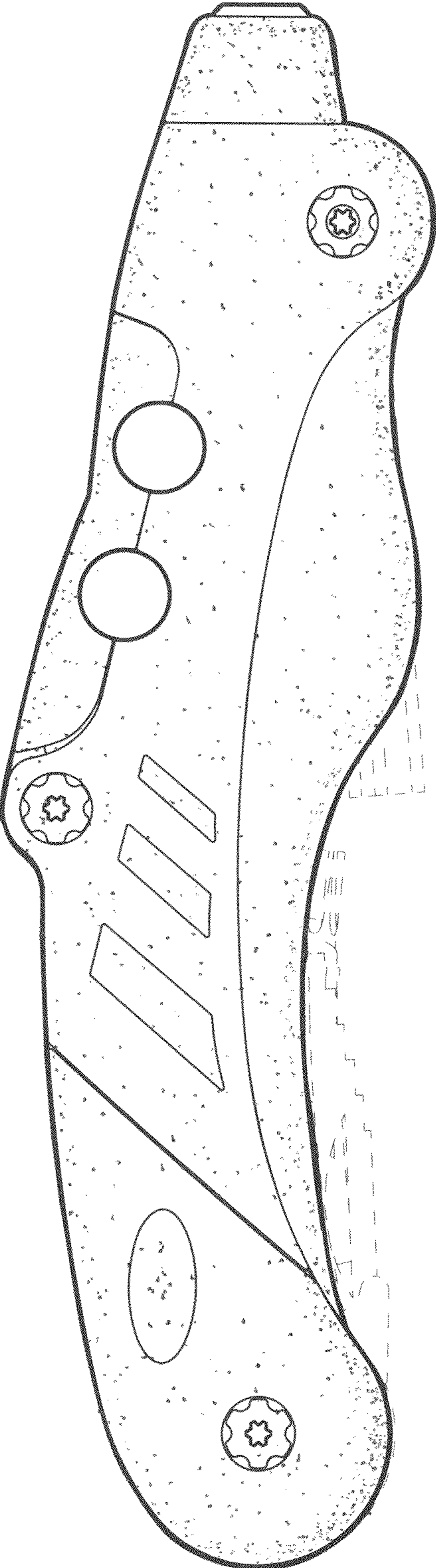

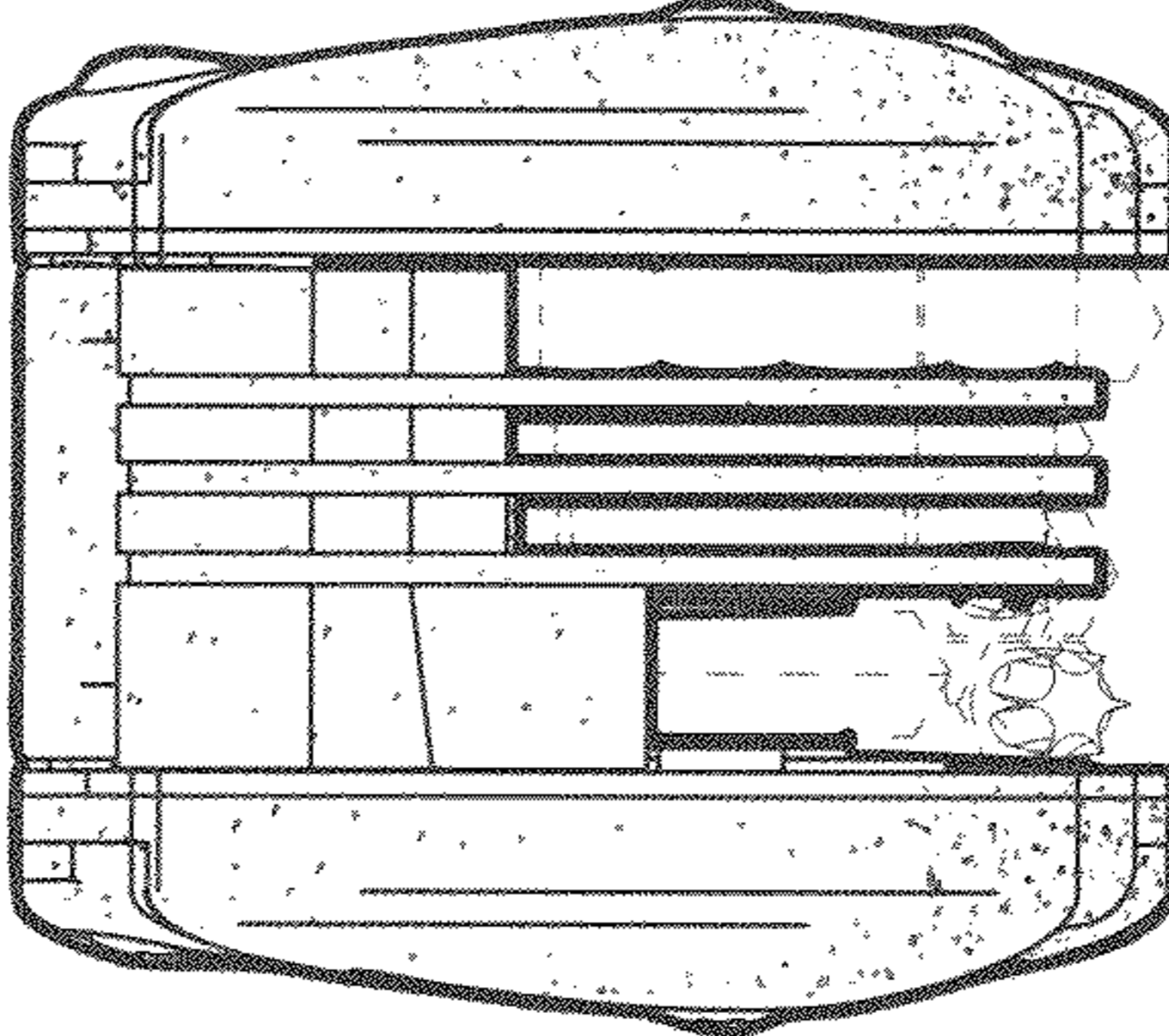
