(57) **CLAIM**

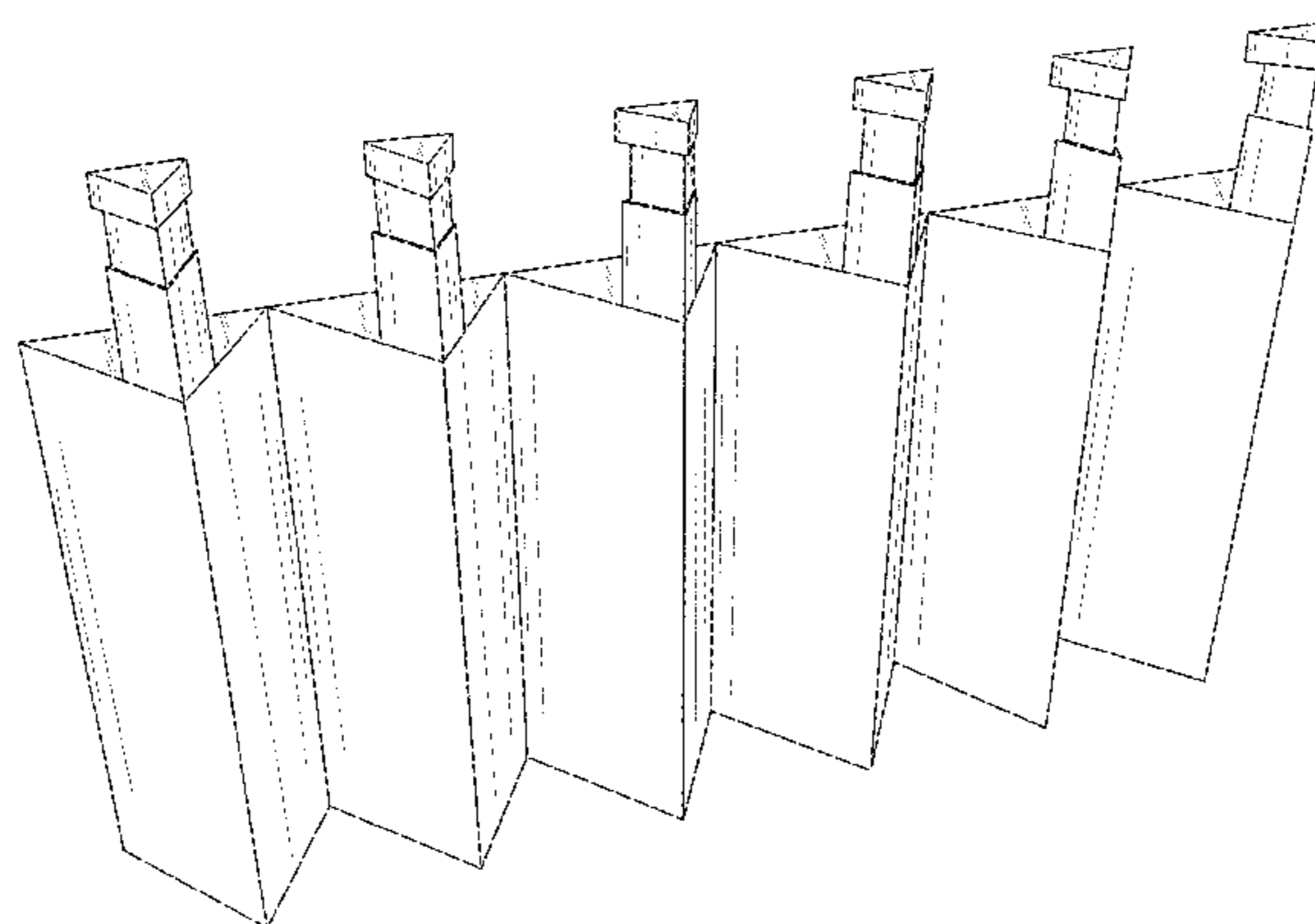
The ornamental design for a container having triangular compartments, as shown and described.

**DESCRIPTION**

This application is related to the following co-pending applications filed concurrently herewith by the same Applicant: “Multi-Compartment Roll-Up Container” application Ser. No. 14/621,542, “Multi-Compartment Roll-Up Container-Rounded”, application Ser. No. 29/517,512, and “Multi-Compartment Roll-Up Container-Rounded Different Sizes”, application Ser. No. 29/517,514. The complete disclosures of these co-pending applications are incorporated herein by reference.

FIG. 1 is a top perspective view of a container having triangular compartments, showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left elevation view thereof; FIG. 5 is a right elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

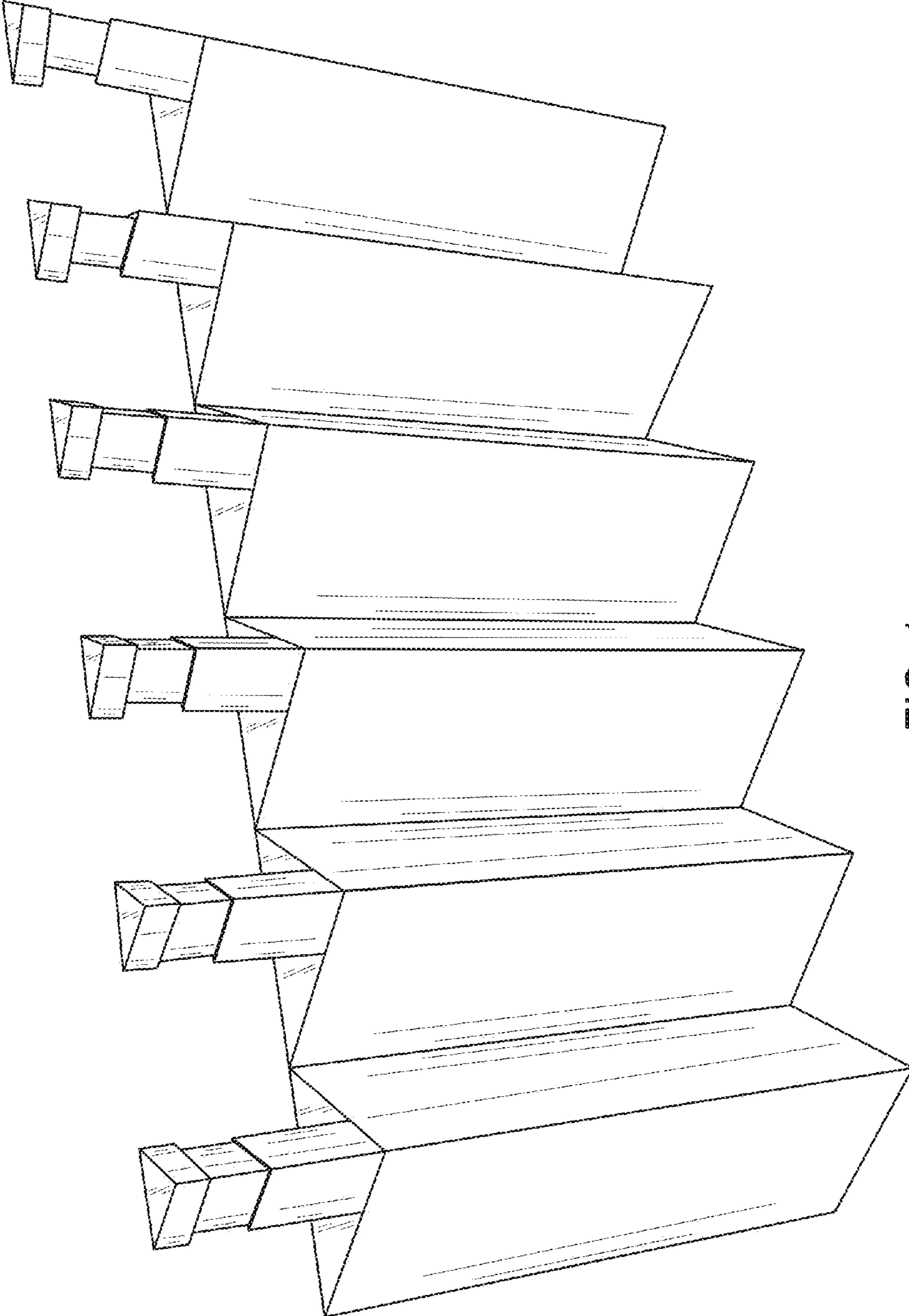
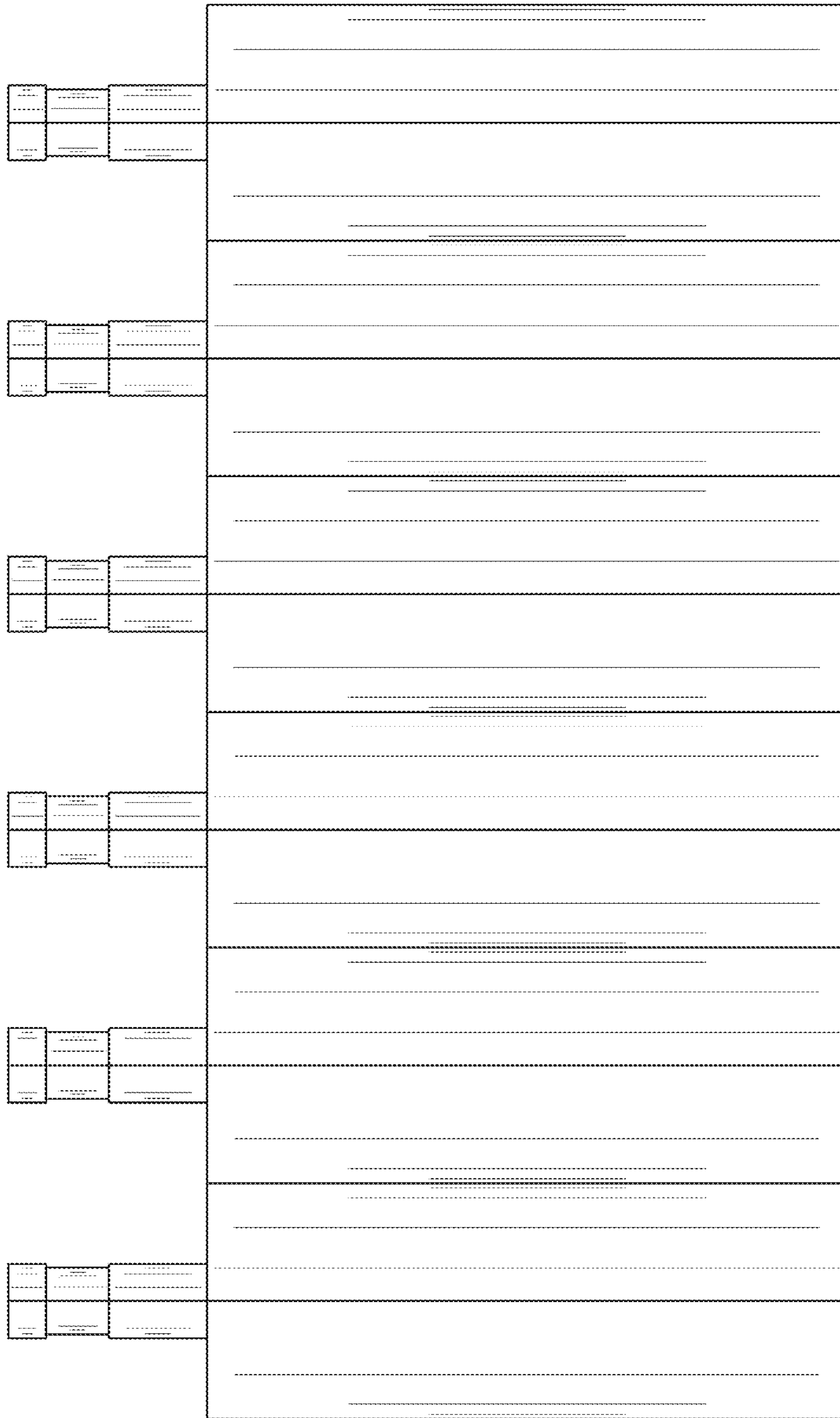

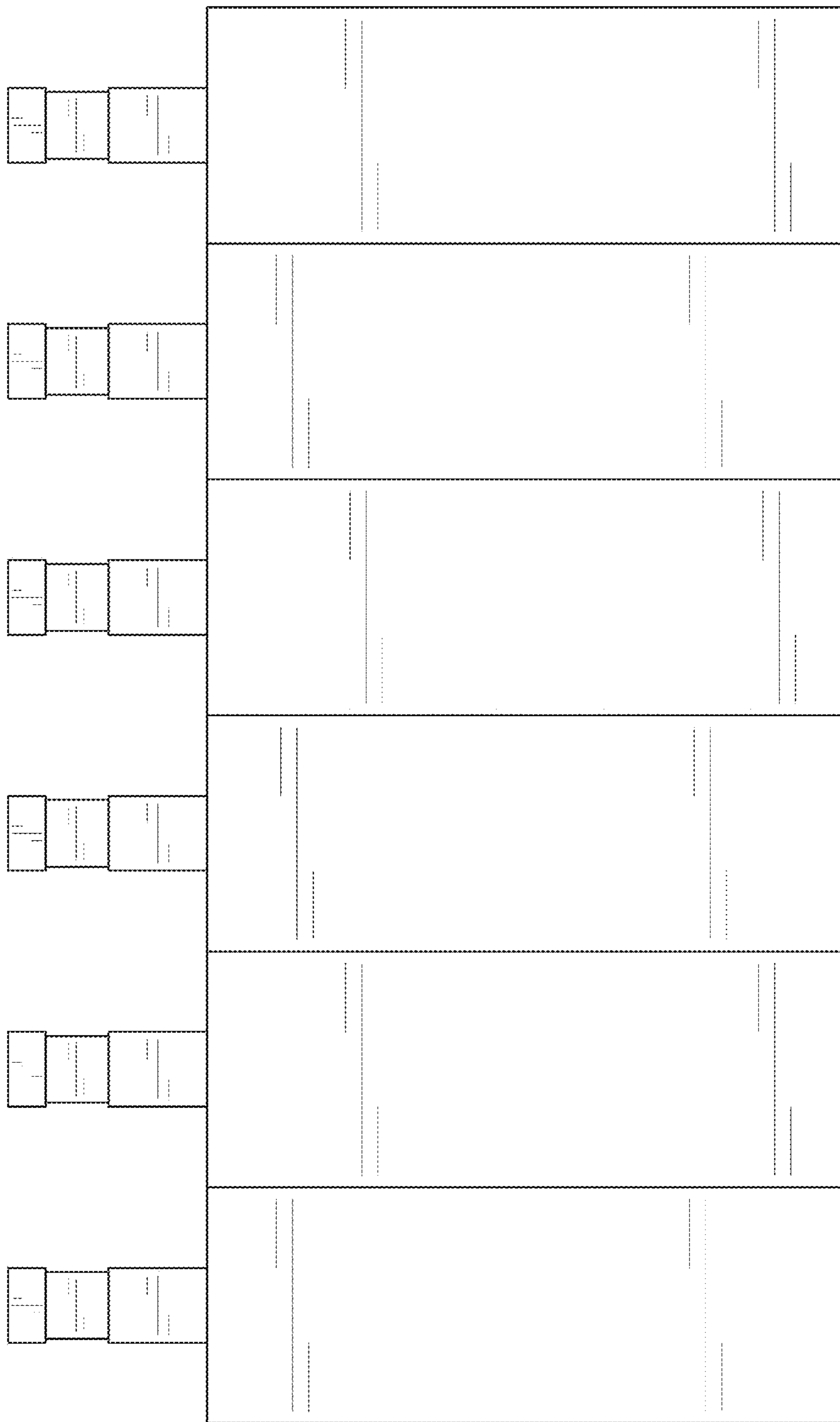

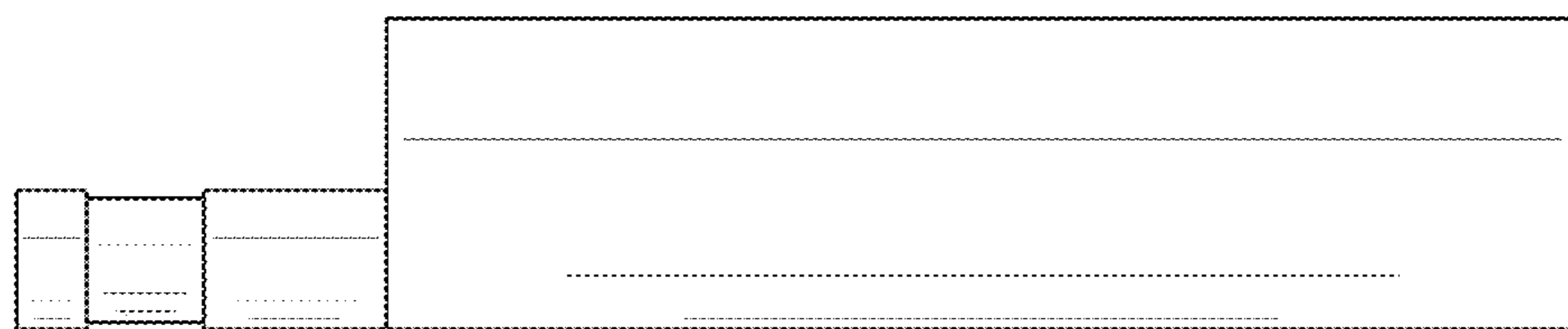

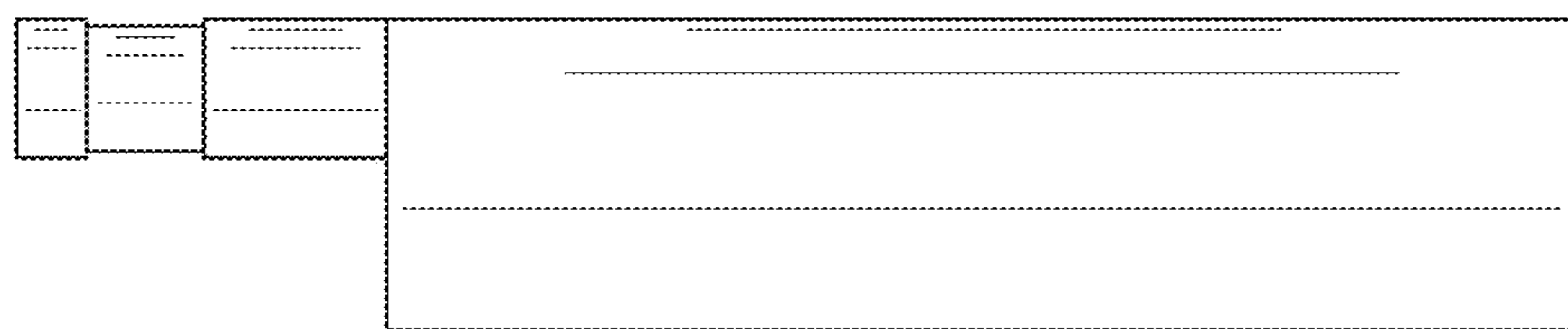

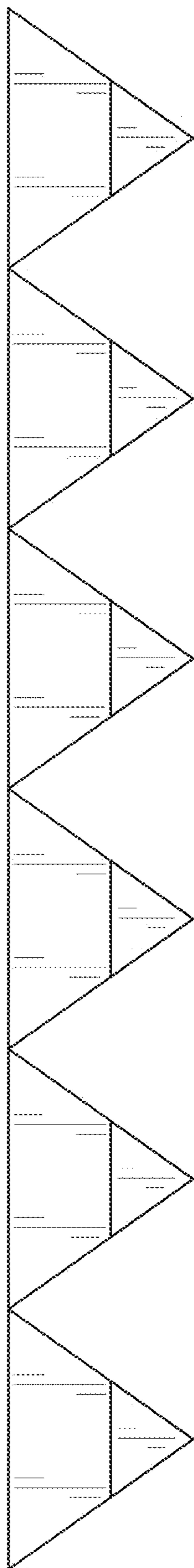

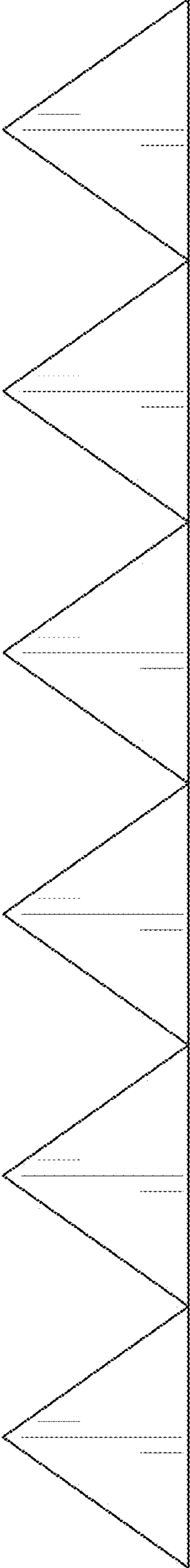
