The ornamental design for a locket, as shown and described.

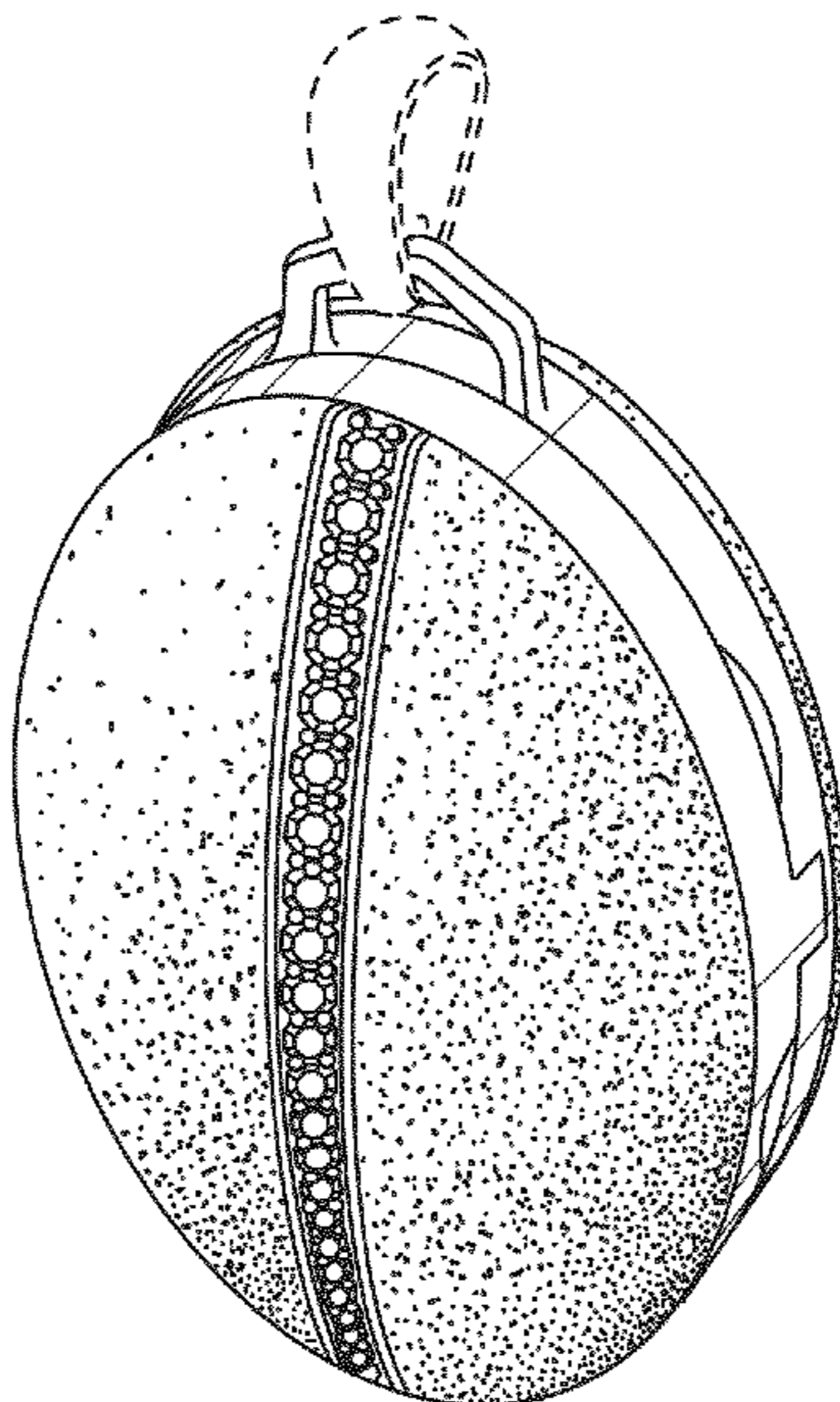
DESCRIPTION

FIG. 1 is a perspective view of a locket; FIG. 2 is a front view of the locket of FIG. 1; FIG. 3 is a rear view of the locket of FIG. 1; FIG. 4 is a right side view of the locket of FIG. 1; FIG. 5 is a left side view of the locket of FIG. 1; FIG. 6 is a top view of the locket of FIG. 1; FIG. 7 is a bottom view of the locket of FIG. 1; and, FIG. 8 is a perspective view of the locket of FIG. 1 shown in an open position.

The stippling shown in the drawings represents a contrasting appearance with the remaining portions of the locket.

The broken lines shown in the drawings represent portions of the locket which form no part of the claimed design.

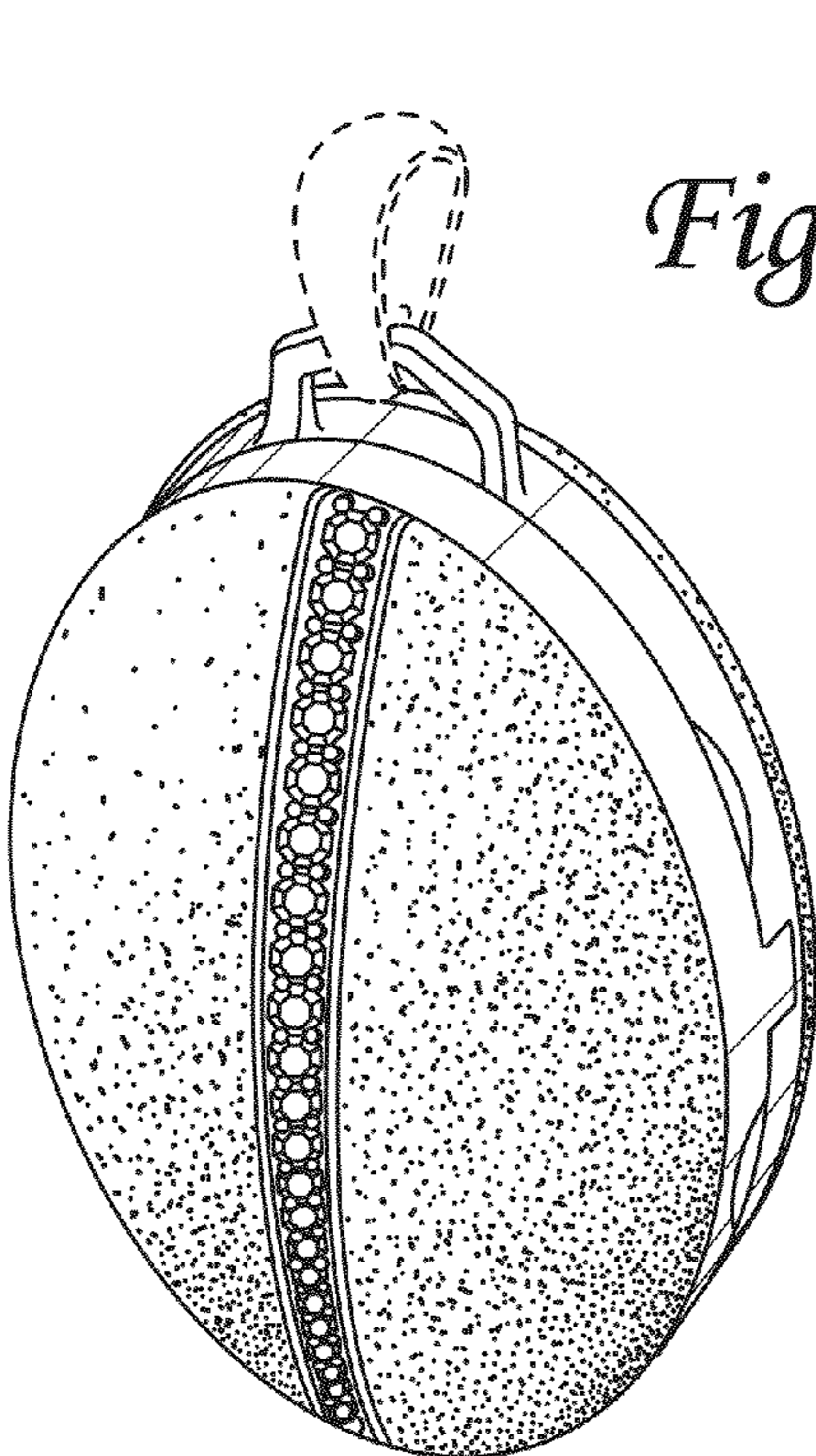

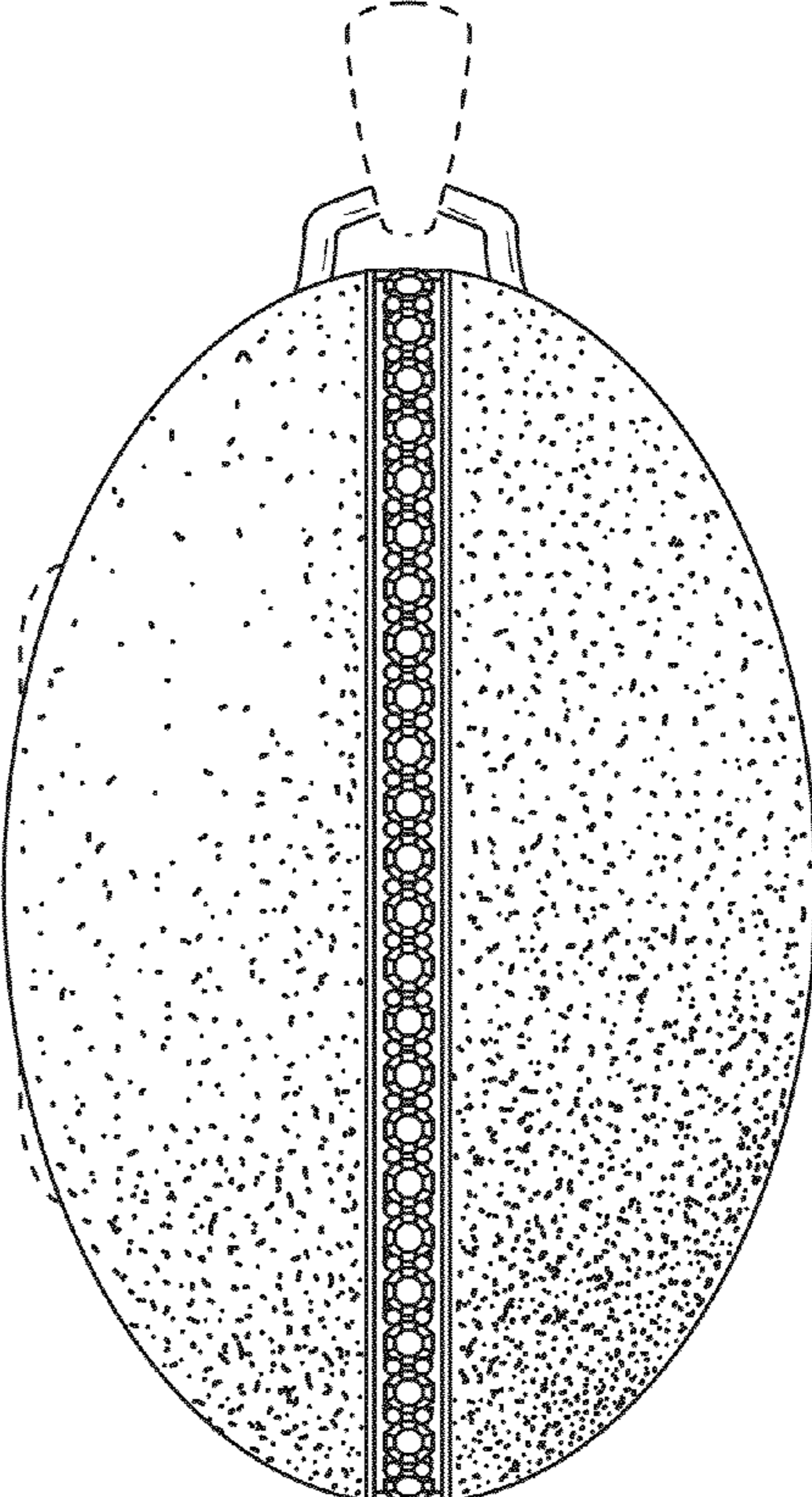

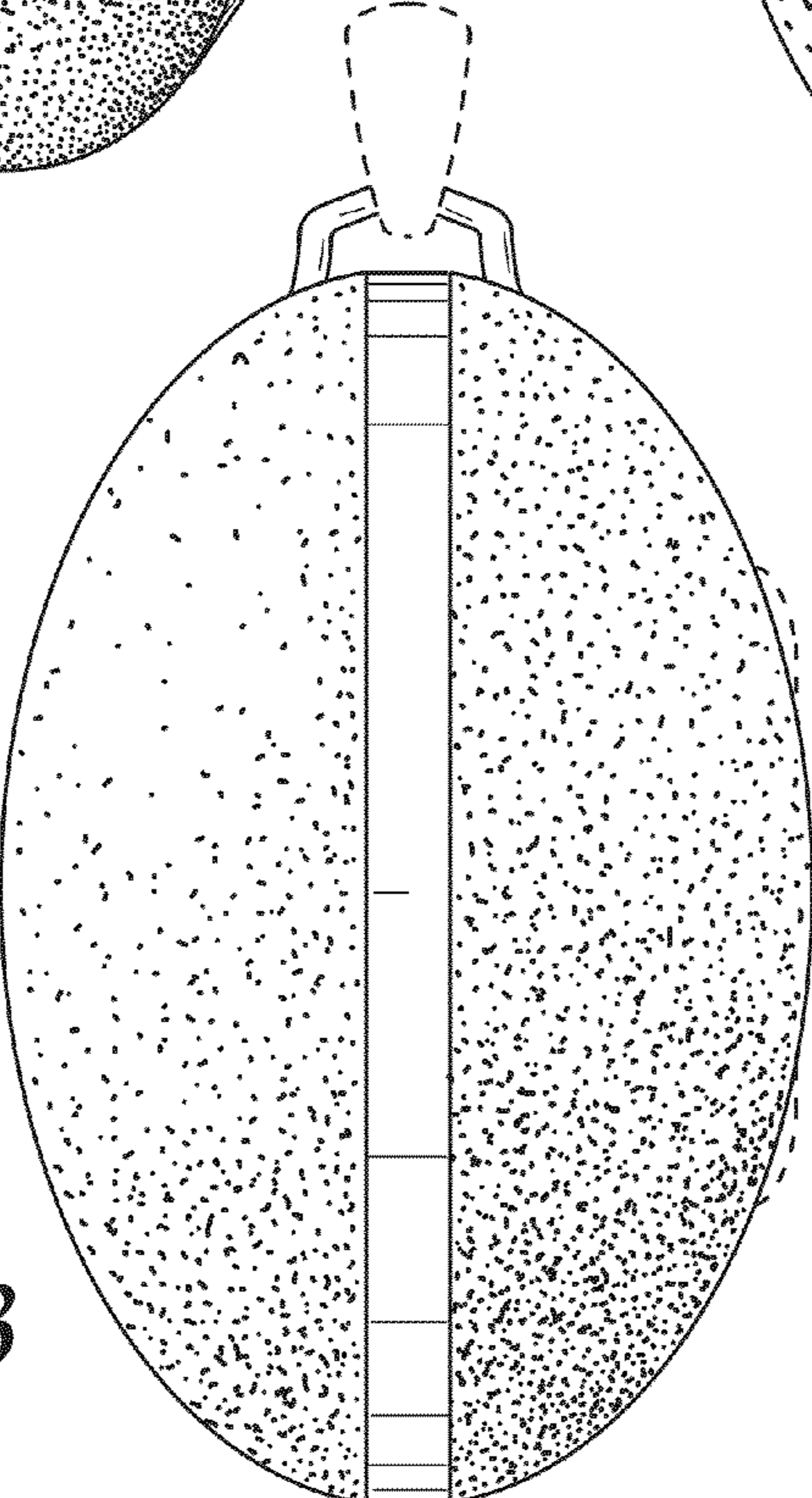

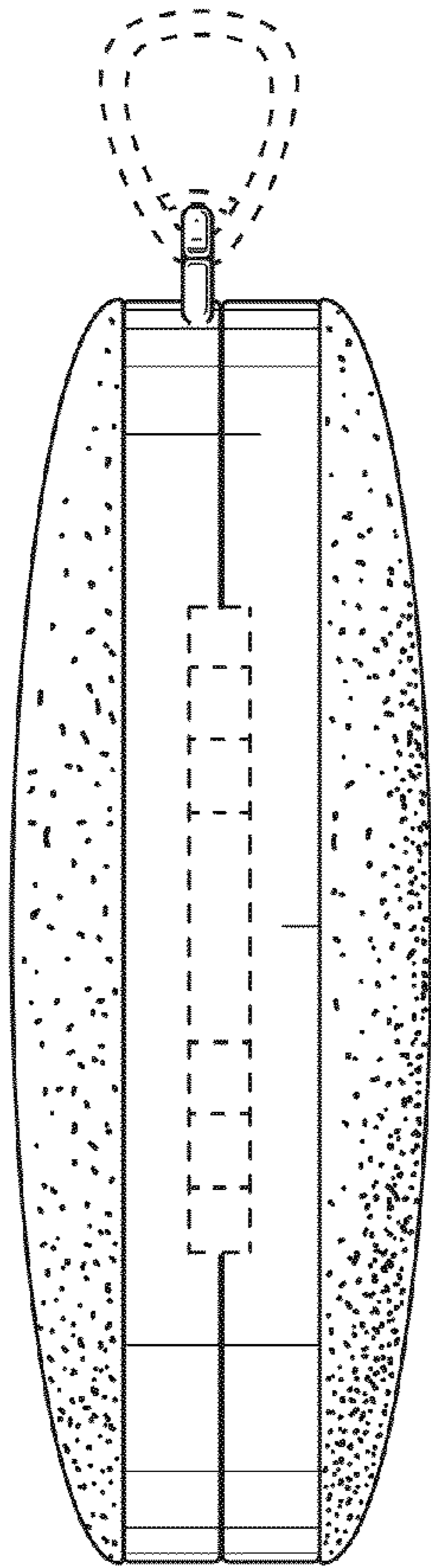

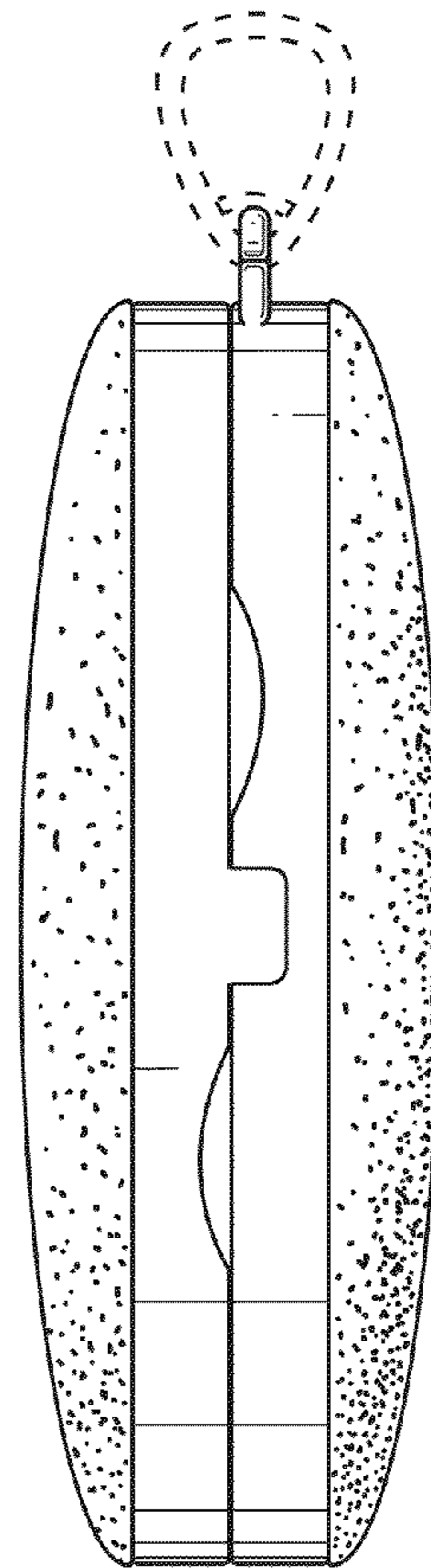

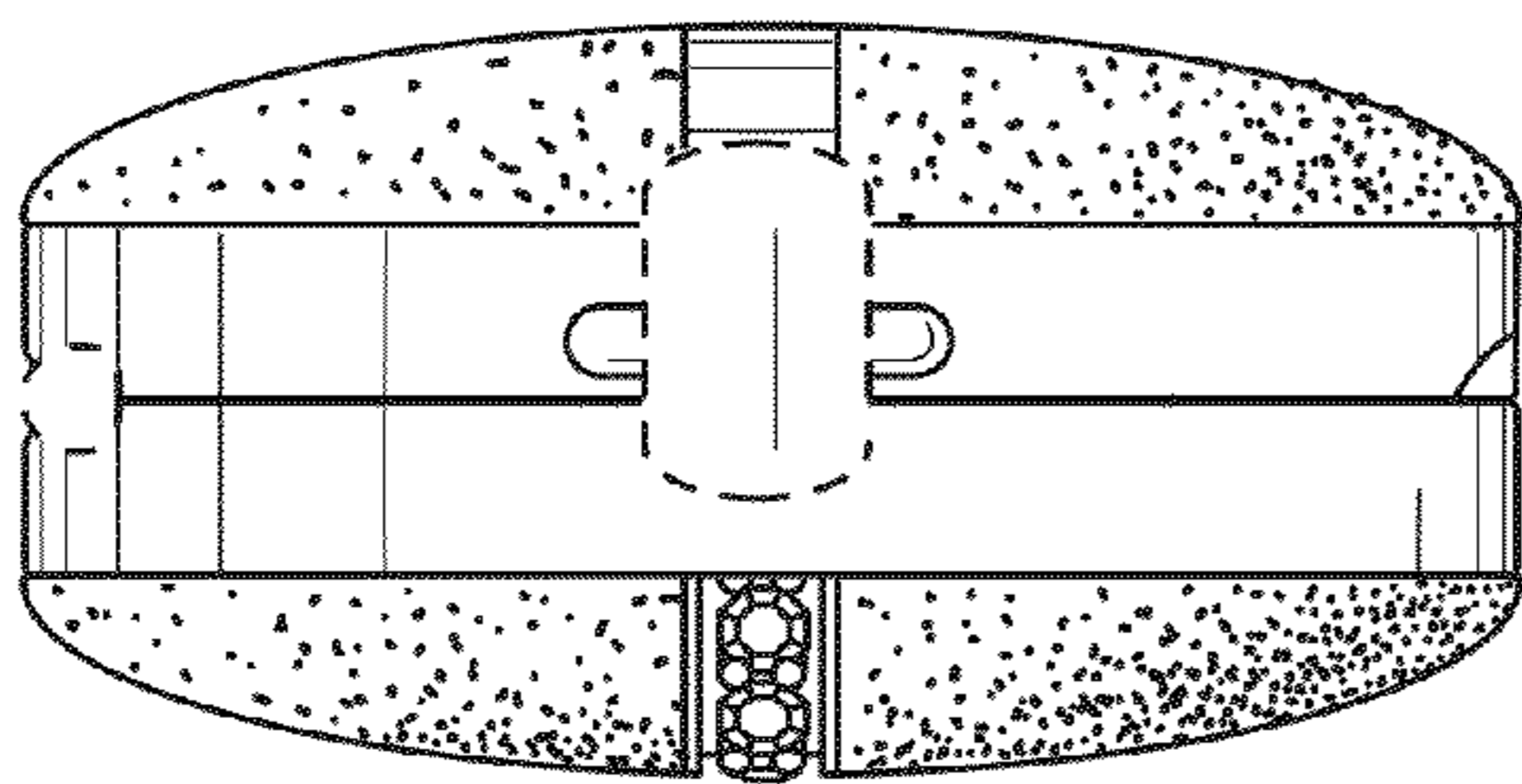

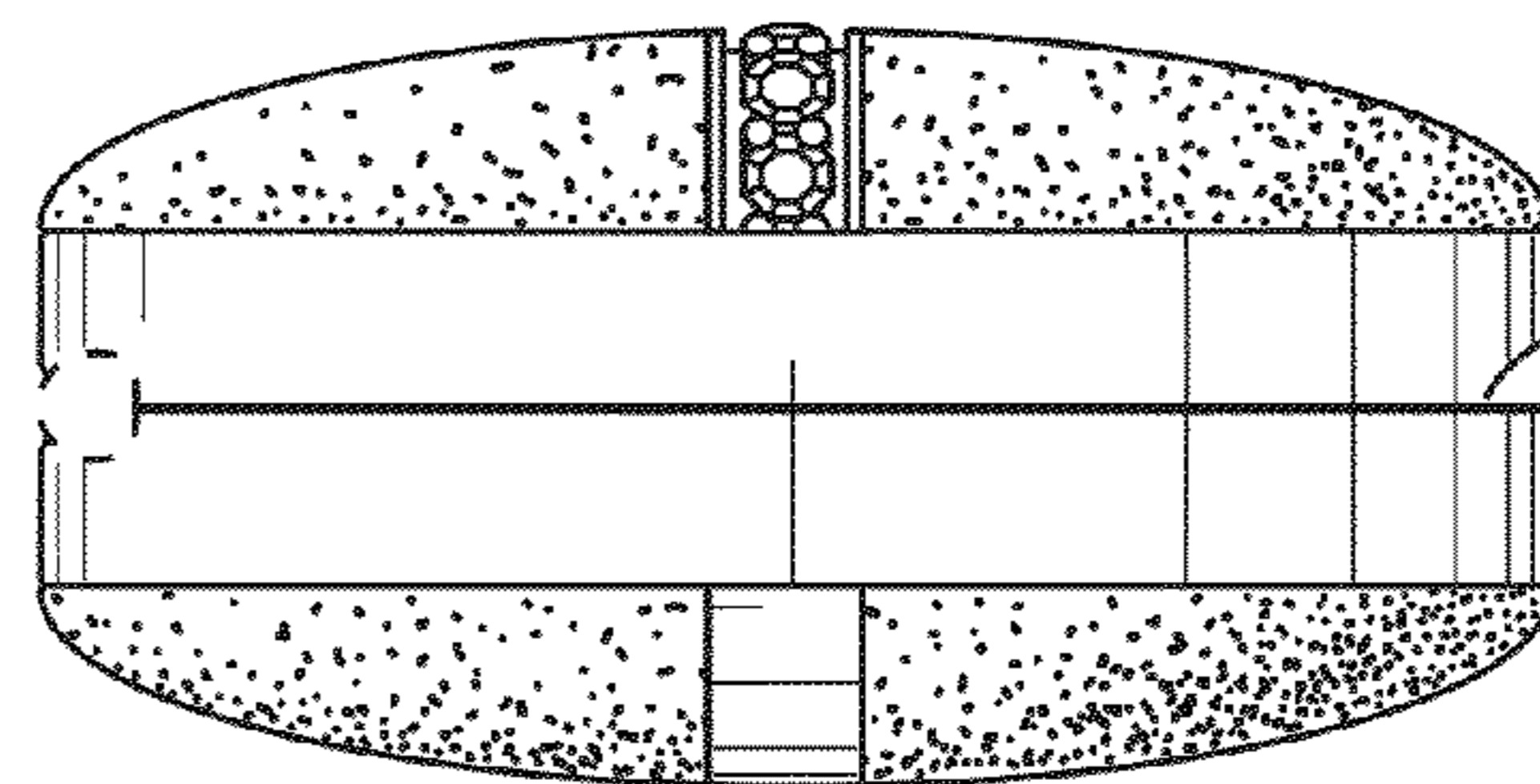

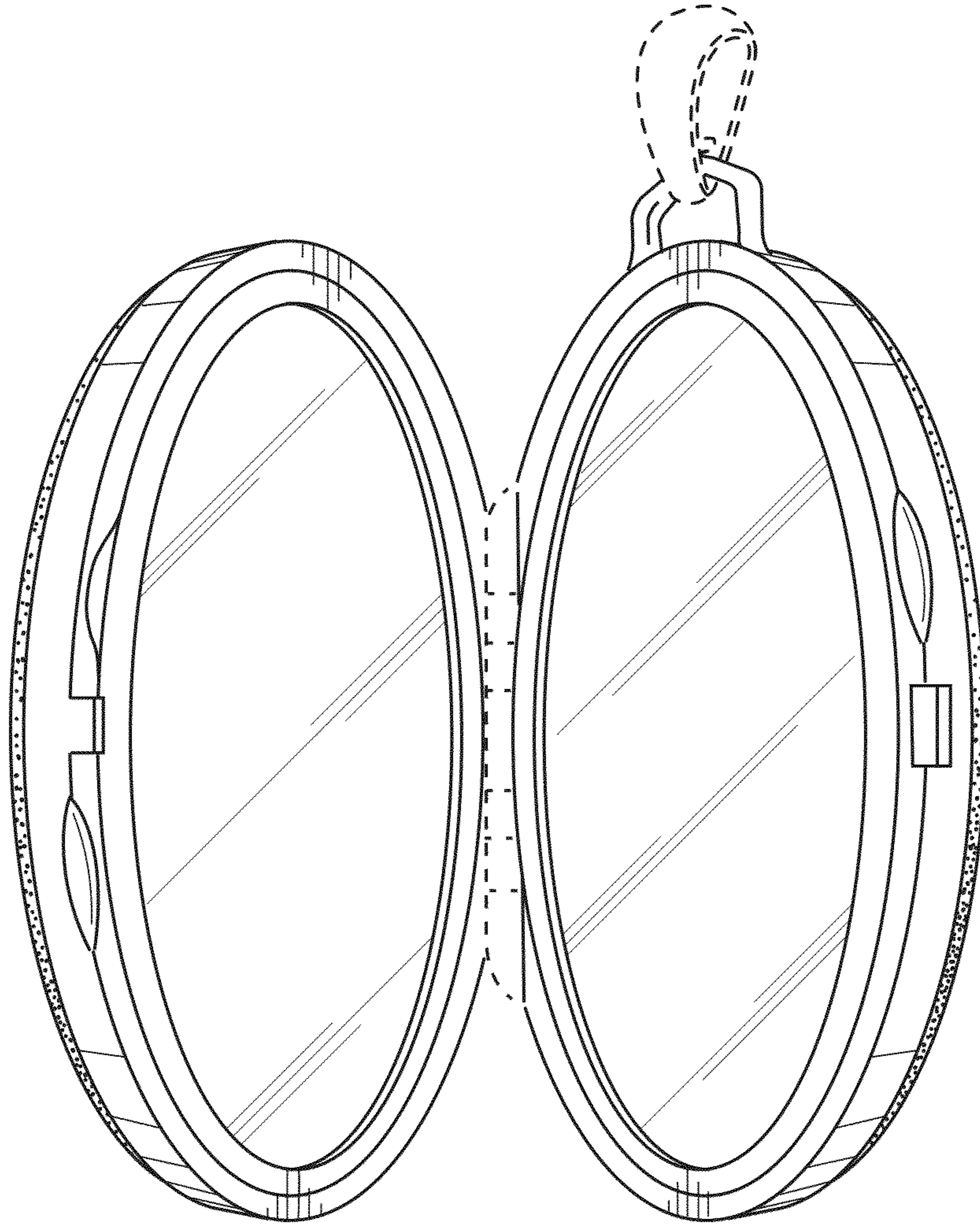
