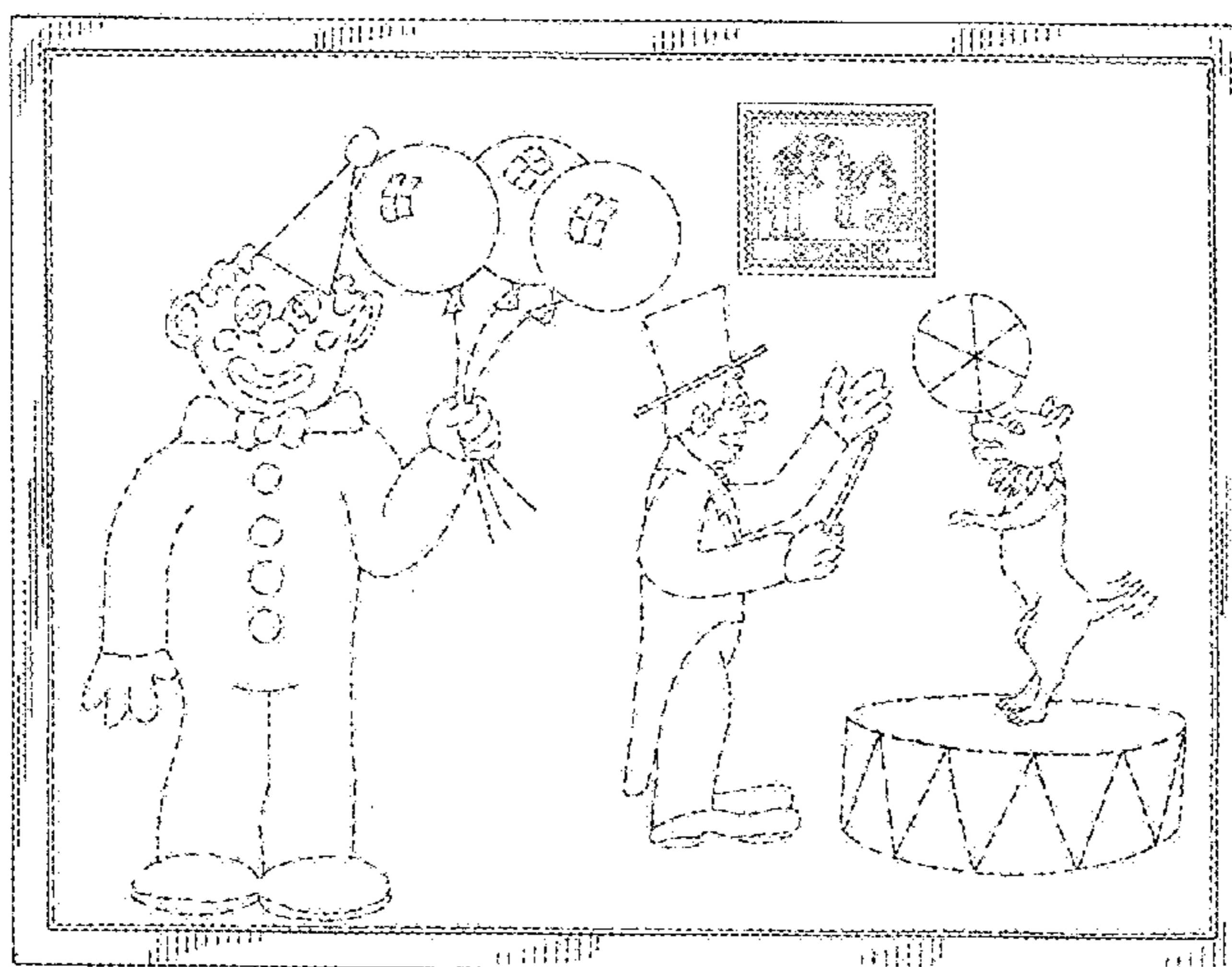
The ornamental design for a wall decoration, as shown and described.
