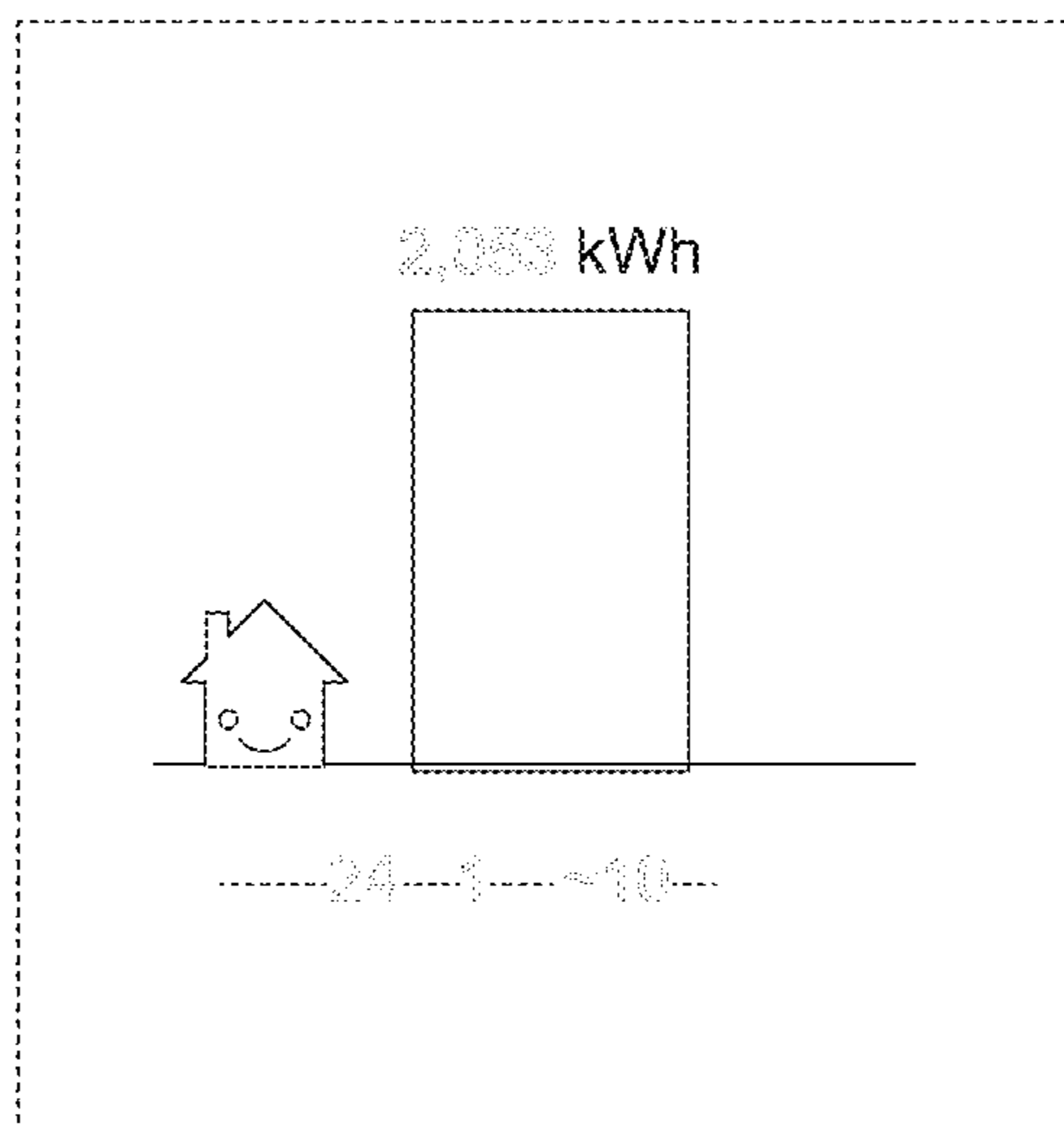
(57) **CLAIM**

We claim the ornamental design for a display screen of a communications terminal with graphical user interface, as shown and described.

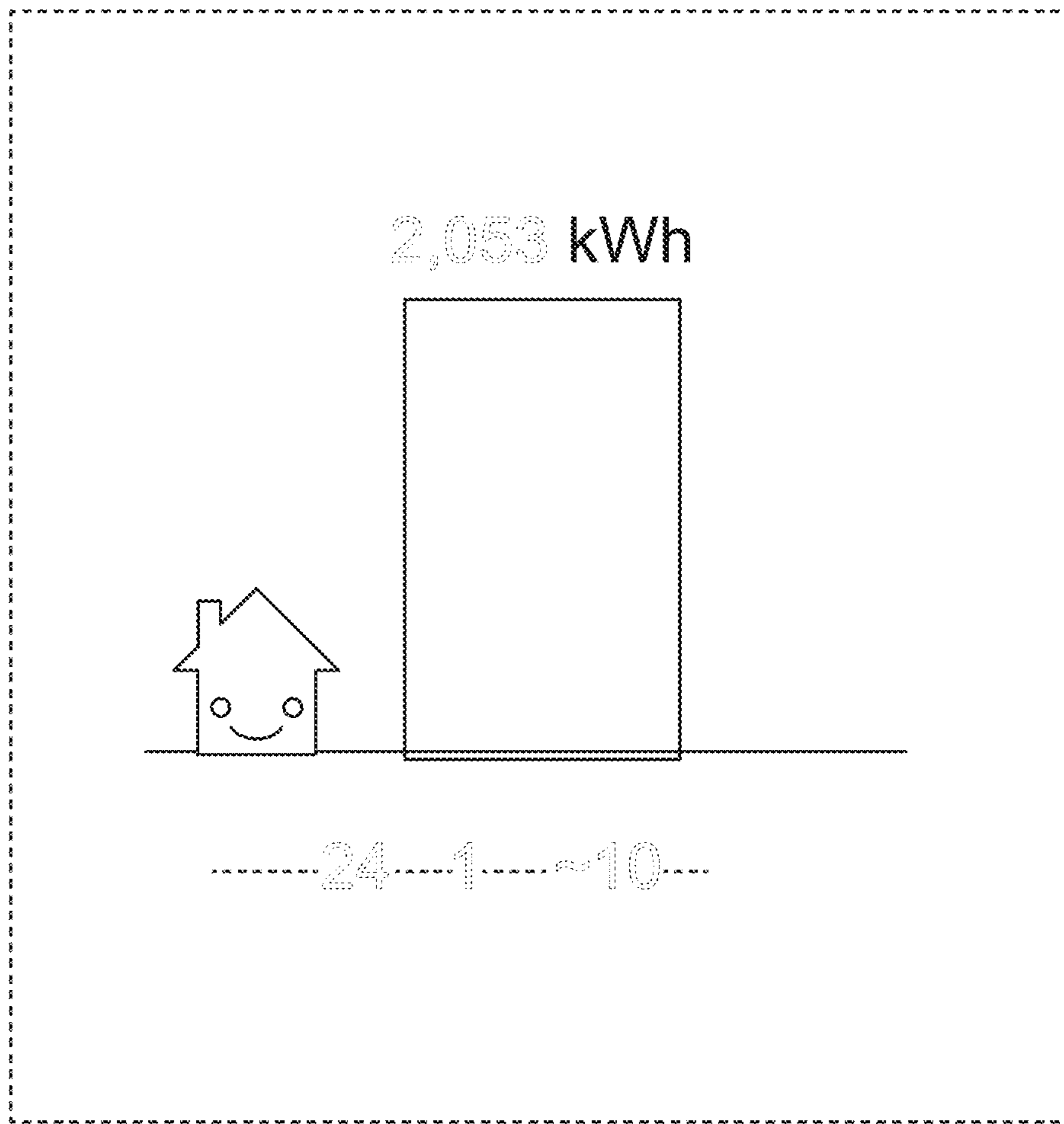

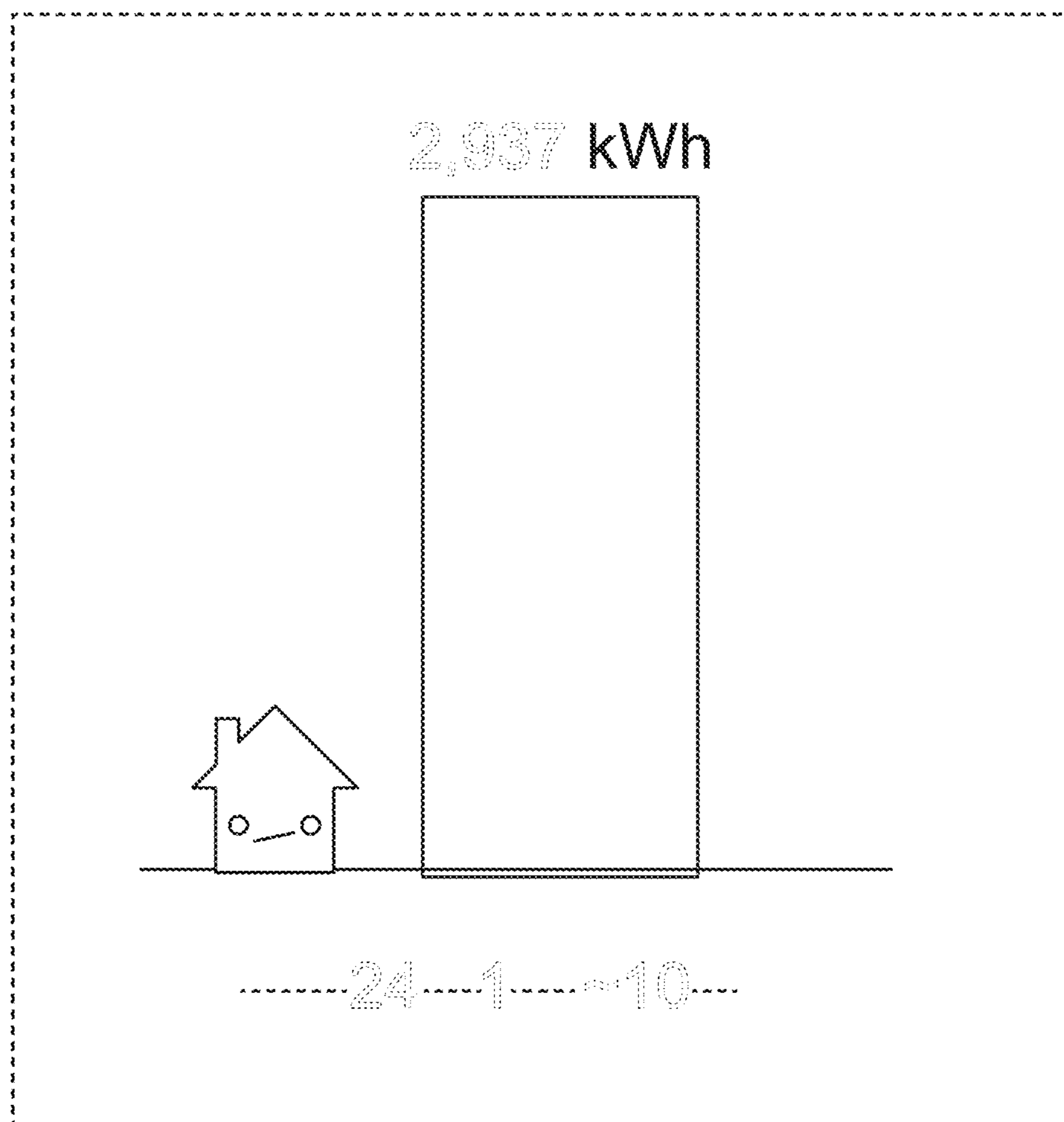
